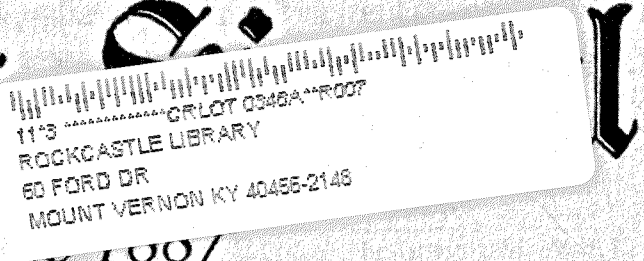

Rockcastle County is now in the RED zone, which is the highest risk, as of Monday, August 2.

With a new incident rating of 25.67 Rockcastle has risen dramatically each week for four weeks. The Cumberland Valley District Health Department says there are four new confirmed cases and 26 additional probable cases in the past seven days. A new audit says there were nine COVID deaths in Rockcastle in the past year that had never been reported bringing the total local COVID deaths to 27

## Little World's Fair

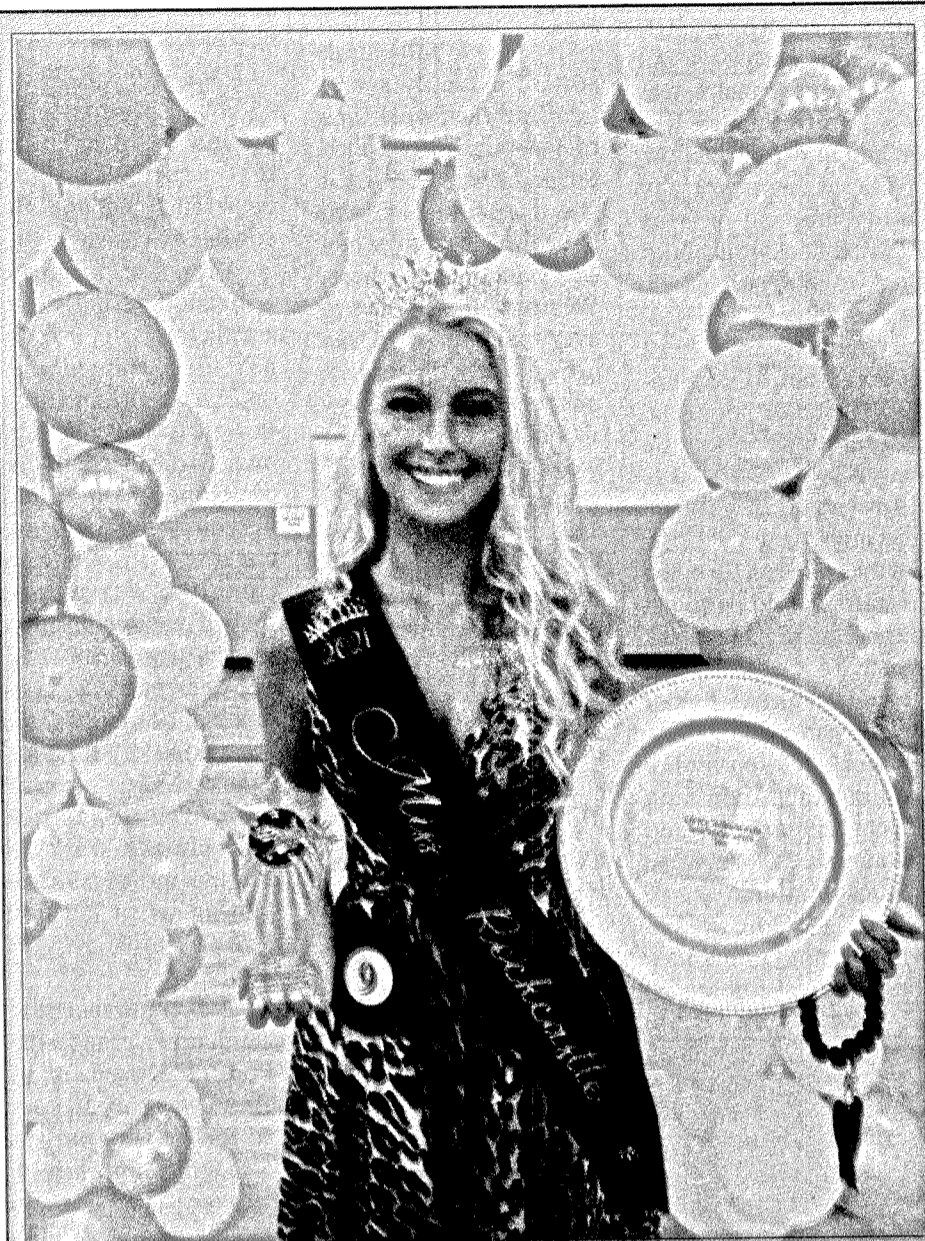

## RCIDA discusses projects and plans

Members of the Rockcastle County Industrial Development Authority held their regular monthly meeting Tuesday morning with several items on the agenda.

After approving the financial statements and monthly budget, Executive Director Jeff VanHook reported on the progress of the new Farmers Market on Richmond Street.

"Everything has gone very smoothly on the project," he said. "We are 35.19% complete on the construction phase and we expect the windows in

six weeks." Board member Doctor George Griffith asked when the expected completion date may be on the project. VanHook said he expects the building to be completed in

mid-September but then final work, such as black-topping, will depend upon weather and some other issues.

"The contract allows for sometime in March of 2022," said VanHook.

## Masks in schools to be parent choice

Students in the Rockcastle County School system will be able to decide for themselves if they wish to wear a mask in school.

The highly-debated and controversial subject of wearing masks has been a thorn in the side of most school districts since COVID began. But, Superintendent Carrie Ballinger and the Rockcastle County School Board have come up with a plan that they believe will make the majority of

parents happy, while maintaining their first priority of student and staff safety.

According to the district's 2021-22 Safe Return to School Plan, students will be allowed to decide for themselves if they want to wear a mask inside the school buildings.

"It is the recommendation of the CDC, the Kentucky Department of Education, and the Kentucky Department of Public Health that all individuals wear masks while (See "Mask" on A11)

## Three held on kidnapping charge

According to complaint warrants from Kentucky State Police Detective Ryan Loudermilk, two Mount Vernon resi-

dents, and a Berea woman, have been arrested on kidnapping and assault charges.

The warrants say James Hellard, 40, Donna Hellard, 57, both of Richmond Street in Mount Vernon, and Alexis Chasteen, 27, of Berea, were arrested last week, after the complaint warrants were executed.

According to the warrants, police received a call from the Berea Hospital on June 23, claiming that John Newland had been dropped off at the emergency room with multiple injuries, including lacerations. Newland told police he had been awakened by Chasteen at a residence on Flat Gap Road in Rockcastle County.

The warrant says Newland reported being approached from behind by James Hellard, who was armed with a knife attached to a stick, while

I have been adamant that I will not take the

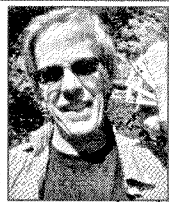

There was always a big meal and afterwards the men played horseshoes while the women did something else (I never really knew what) and the kids played.

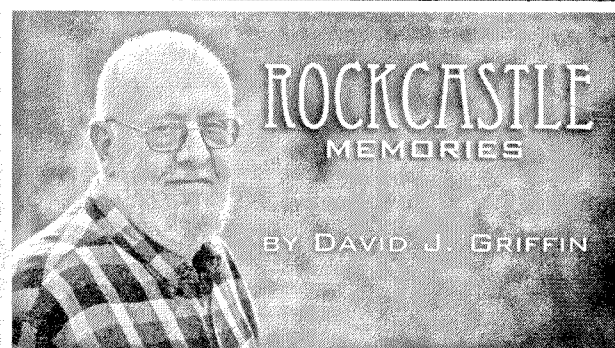

Somehow, there was a lot of sitting around and talking. I still picture my dad sitting on the old wooden porch talking to mom's brothers. Me, and those around my age, were playing on the old well or climbing in the barn. "Stuff kids can't do anymore."

## Squirrel Season

When August rolls around, I am reminded that squirrel season is near. This year the season begins on August 15.

A few weeks ago, my wife and I casually took a walk through the forest next to our former house on Furnace Mountain in Powell County. We still own two lots there. We developed a nice path that circles through our woods, with benches along the way to sit a spell if we decide to do so. It is always about fifteen degrees cooler in the shade of our woods, so I was taking my time as I watched the squirrels jump from tree to tree. This simple walk reminded me of squirrel hunting when I was in high school in Mt. Vernon.

My favorite shotgun is one that my grandfather (Pop) purchased for me when I was only 10 years old for the very purpose of teaching me how to hunt squirrels in the woods behind our house. It is a 20-gauge, single-shot Stevens.

Squirrels prefer older hardwood trees which have cavities just suited for their nests. The work these furry animals do in the fall is absolutely astonishing. Their feverish pace is something to see. Up and down the tree trunk they scamper, watching for natural predators in the vicinity of their nests; including: hawks, owls, snakes, foxes, and domesticated cats and dogs.

My favorite time to get into the woods when hunting squirrels was just before sunrise. Squirrel activity is in full swing at that time of the morning. I found a spot in the woods along KY 461 in Rockcastle County in the early '60's when Howard Coffee introduced me to it one Saturday morning, and it became one of my favorite places to hunt. We sat next to a large oak tree and waited for the animals to appear, and they always did.

Another place that I loved hunting squirrels was on the Brindle Ridge farm owned by Sherman and Mary Hansel. Their daughter, Mary Ellen, was a close friend of mine, and they never refused me the privilege of hunting on the wooded section of their farm. Sometimes, when I pulled into the driveway early on a fall morning, Mary Ellen would accompany me to the woods to see how successful I was going to be that day. Sherman and my grandfather, Eugene Stokes, were very good friends—in part because both families attended the First Baptist Church together for many years.

When I returned home from one of my squirrel hunts, Pop would meet me in the yard to see how successful I had been. He always assisted me in the task of cleaning. He would have accompanied me into the

He wondered if I'd like one of each. I told him that I didn't have to have really fancy popcorn. A little butter and salt will do fine. I don't think they sold one bag of it the whole time we were there.

I sure hope there will be some Mid-Fall Night events before the Delta Variant gets worse and the weather gets bad. I can save up and get some gourmet popcorn by then.

# A Call to Action: COVID-19 Vaccination

If you're like me, you have probably enjoyed this summer and the relative lack of news related to COVID-19, at least compared to last year. We are all ready to move on and get back to our lives as they were before this virus was unleashed on the world by the corrupt and careless actions of the Chinese Communist Party. However, the fact of the matter is that COVID is not yet over and there is still a part that we all have to play in defeating this virus once and for all.

If you watch the news much at all, you have probably heard about the new strain of COVID-19 called the Delta variant. This is a mutated form of the virus that we know for a fact to be more contagious than other strains and is suspected to cause more severe disease in patients of all ages. All current versions of vaccine that are available, including Pfizer, Moderna, and Johnson and Johnson, offer great protection against this variant. It is uncommon for any vaccinated individual to become infected by the Delta variant, but even rarer for individuals that do get infected to become severely ill. My personal preference is Pfizer or Moderna, both of which have shown greater effectiveness against the Delta variant than the Johnson and Johnson version. However, if only receiving one shot instead of two will affect your decision, Johnson and Johnson will still provide some protec-

tion, which is far better than none at all.

The problem at hand is that communities with low vaccination rates are at such greater risk of widespread transmission of the Delta variant. When fewer people are vaccinated, it makes it much easier for the virus to spread. It then becomes more probable that the virus will reach our friends and family who are at higher risk for severe disease, or even death. Simply do a quick google search on the Delta variant in Missouri to see how it has ravaged our neighbors to the West. Even here in our home state, we are beginning to see a sharp increase in new COVID cases that are attributable to the Delta variant. Meanwhile, our county-wide vaccination rate among all residents 12 and older stands at a discouraging 32%. This is simply not enough to provide our community as a whole with much meaningful protection, should the Delta variant begin to spread in our homes, churches, and places of work.

I am continually annoyed and confused at how the issue of vaccination has become so political. Getting vaccinated should in no way be connected with how conservative or liberal you are. It is simply a matter of common sense. Those that know me know that I am about as conservative as you can be, and yet I was thrilled to receive my doses of the vaccine when they were first available earlier this year. Concerns about

safety and side effects are completely understandable, but I would again advise anyone with concerns about getting vaccinated to address this with your physician or pharmacist. Facebook is rarely a good source for anything close to factual medical information, and there is a lot of fake news out there. I always like to put it this way: would you rather spend a day or two with a sore arm and maybe a low fever, or 1-2 weeks in a hospital bed, or worse? It also warrants mentioning that even though President Biden likes to brag that he deserves all of the credit for the United States' largely successful vaccine campaign, that it was actually President Trump who made these very safe and effective vaccines possible through Operation Warp Speed.

In closing, I would urge each and every person reading this to thoughtfully reconsider your decision on COVID-19 vaccination. The vaccines that we have are incredibly safe and effective, but they can do absolutely nothing to help you or your loved one once infected. This is a team effort, and we all must take action now to protect our family, friends, and community before it is too late. Our community is fortunate to have an amazing hospital system that is capable of providing each of the three available vaccines to anyone that would like to receive it, free of charge. ### Eligibility for Nominations for the 2021 County Committee Elections

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) county committees are a critical component of the day-to-day operations of FSA and allow grassroots input and local administration of federal farm programs.

Committees are comprised of locally elected agricultural producers responsible for the fair and equitable administration of FSA farm programs in their counties. Committee members are accountable to the Secretary of Agriculture. If elected, members become part of a local decision making and farm program delivery process.

A county committee is composed of three to 11 elected members from local administrative areas (LAA). Each member serves a three-year term. To be eligible for nomination and hold office as a committee member or alternate, a person must fulfill each of the following requirements: (1) be a producer with an interest in farming or ranching operations, (2) participate or cooperate in any FSA program provided for by law, (3) be a U.S. citizen, (4) be of legal voting age, (5) meet the basic eligibility requirements, and (6) reside in the county or multi-county jurisdiction in which they will be serving. A cooperating producer is someone who has provided information about their farming or ranching operation(s) but may not have applied or received FSA program benefits.

All nomination forms for the 2021 election must be postmarked or received in the local USDA Service Center by Aug. 2, 2021. For more information on FSA county committee elections and appointments, refer to the FSA fact sheet: Eligibil-

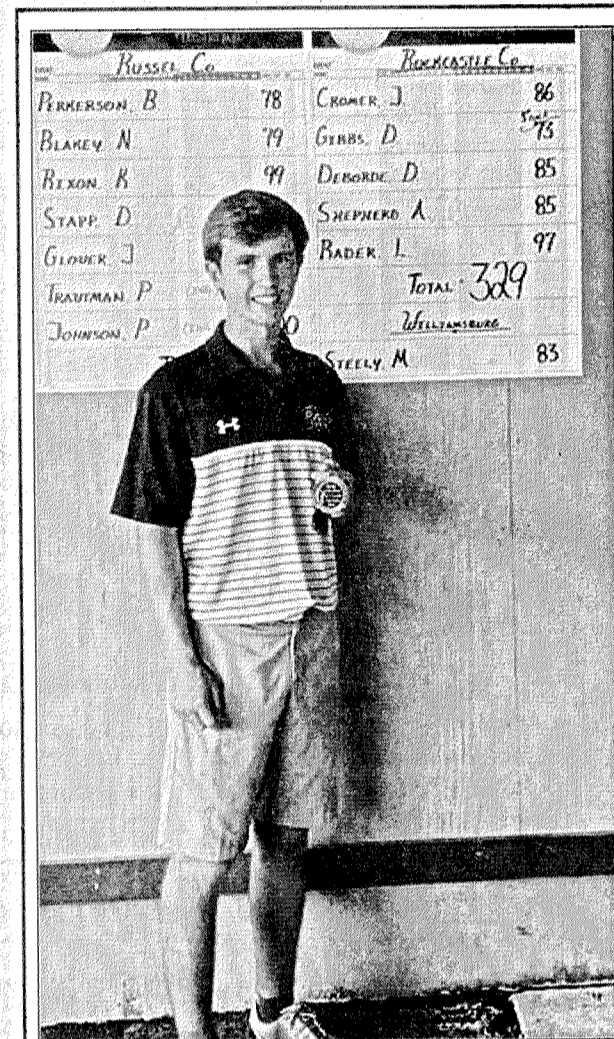

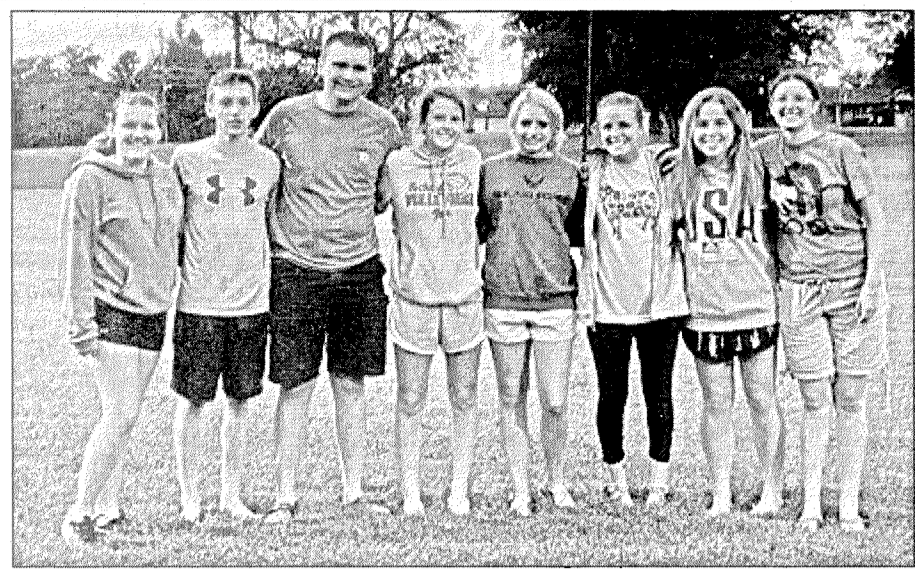

"A 2016 study (<https://www.ncbi.nlm.nih.gov/pubmed/27015718>) of 10,000 adolescents

found that two-thirds of those who developed alcohol or substance use disorders had experienced at least one mental health disorder." (Child Mind Institute)

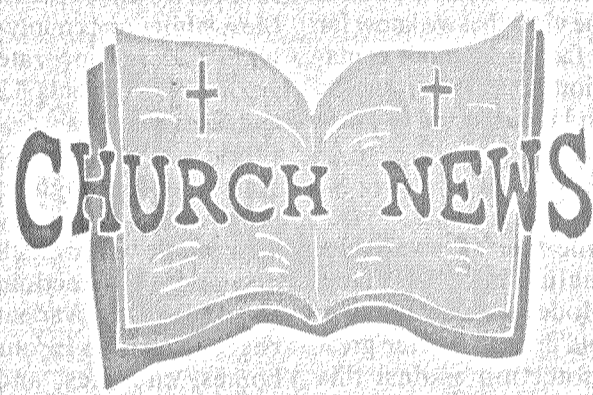
**RED WINE VINAIGRETTE:**







(Continued from front) indoors in all classrooms,” Ballinger said

However, this public health recommendation has met with great disagreement among many parents and students alike. Some officials agree there is also some evidence that masks may cause some health risks to younger students both physically and mentally.

So, Ballinger, and the board, have agreed to a compromise. “In following this guidance, Rockcastle County Schools highly recommends that all students and staff wear a mask indoors,” said Ballinger. **“However, parents and/or guardians of students and staff members have the choice of deciding whether to mask or not mask while in schools buildings and on school grounds.** This choice is available regardless of vaccination status.”

However, the CDC and other health entities do not give the school board the ability to allow such a choice on public transportation. **Masks are required on all school buses at all times for anyone two and older,** according to CDC requirements.

The district will observe COVID-19 safeguards throughout the district. This year, however, there will only be a three-foot distance requirement instead of the six that was required last year.

There are also some instances where the distancing requirement may be waived, depending on the size of a classroom or circumstances involved in each situation, according to Ballinger.

The district will continue contact tracing but those who are vaccinated will not be required to quarantine unless symptoms appear, Ballinger said.

The local district is currently installing a new bipolar ionization system which is expected to mitigate the effects of COVID-19 and improve overall air quality, the superintendent added.

According to the return to school plan, visitors will be limited this year and officials say buildings will only be open to essential personnel and to direct access providers/vendors.

However, in order to provide the mask choice to parents and guardians, the district asks for help that is essential to keeping COVID at a minimum. “Parents are requested to screen students before allowing them to leave for school and/or get on the bus,” said Ballinger. “It is essential that parents understand the necessity of screening students for COVID symptoms before allowing them to attend school.”

The first day of school for students will be Wednesday, August 25 and students will attend all day.

There are some other changes to the local district calendar, causing many parents to express agreement.

NTI Non Traditional Instruction (NTI) days are now apparently allowed to be used for missed days due to inclement weather. In the past, missed snow days were added to the end of the school calendar. However, students may now use their Chromebooks for their lessons to make up for days missed from bad weather.

Also, there are two full weeks of vacation on the next calendar which also

hasn't been done in several years. According to the 2021-22 calendar, the fall break will be from October 4 through 8. A professional development day for teachers teachers will be Friday, October 1, giving students ten consecutive days out of class.

Also, the Spring Break is scheduled for April 4 through 8, 2022.

Ballinger and board members say they are pleased with the new calendar and will continue to place student safety and learning as their top priority.

“Rockcastle County Schools is focused on ensuring the health and well being of our students while ensuring that there is an intentional emphasis on the education of the whole child,” said Ballinger.

“It is my understanding that some of the design is complete but that nothing is happening,” said Craig. “What can we as a community do to help move this project along,” he asked.

Holbrook and VanHook explained that the Kentucky Transportation Cabinet has postponed the project several times. “It just keeps getting kicked down the road,” said Holbrook. “We meet with the department regularly but nothing seems to move this project up on their priority list.”

Craig said the project is crucial to Rockcastle County. “It is vital that this project move up on the priority list,” Craig said. “There are a lot of major projects and plans for growth and development that really can't move ahead until that project is at least on the radar.”

Craig said the development of the area below Wendy's and to Renfro Valley is basically on hold until the 461 widening project moves ahead. “No business has trouble building a structure or how to make it look nice,” he said. “What they worry about is can customers get in here and can we get them out.”

VanHook said the Kentucky legislature will have to move the project higher on their priority list before more can be done.

Griffith had a useful suggestion. “Set up a meeting with those who make that decision and hold that meeting at the high school at 5 p.m. on a Friday afternoon,” said Griffith. “I bet it would become more important to them after they try to get there.”

Craig asked all present to “keep your ear to the ground on this subject. Encourage, promote, suggest and keep this project on the tip of our tongues when we are talking with anyone who could help move this project along.”

In other action, the board voted to defer their authority to VanHook to approve minor construction that has been requested at the Source HOV Building, after engineering has been done on the requested construction.

The board then entered closed session to discuss contract negotiations.

The next regular meeting is scheduled for Tuesday, September 7 at 8:30 a.m. at the courthouse. The public is invited to attend.

## Hero passes through Rockcastle 80 years after Pearl Harbor

"A part of America's Greatest Generation came through Rockcastle County last week and words cannot describe how honored we were to be a part of it," said Rockcastle County Sheriff Shannon Franklin. "We all had a glimpse into the true American heart last week."

Franklin was referring to the final trip made by Navy Seaman, 2nd Class Floyd Dee Helton, 80 years after his death.

Helton was one of 429 crew members killed on the USS Oklahoma when Japanese war planes attacked Pearl Harbor on December 7, 1941. Helton was 18.

Government officials recovered the remains of those 429 who lost their lives when the battleship sank, but only 35 of them had been identified, until last year.

For nearly 80 years, officials searched for ways to identify the other crew members. After contacting Helton's family in Pulaski County, near Somerset, they were able to identify Helton's remains through DNA testing of living relatives. Once those remains were identified, Helton began the journey from Halawa Cemetery in Hawaii, to the Cincinnati Airport.

Once in Lexington, the remains were transported to Pulaski County. On the way, the procession travelled through several towns and cities, including Rockcastle County.

"It was something I will never forget," said Franklin. "People lined the highway for miles and saluted and cried and contemplated America in silence until this great American hero was through our county."

The Mount Vernon Fire Department took their ladder truck and displayed a huge American flag, which has two additional stars since Helton was killed. The flag in 1941 had only 48 stars. The Mount Vernon Police Department and Kentucky State Police also joined with the Sheriff's Department to honor Helton, and all he stood for, as he passed through Rockcastle County.

The local American Legion and VFW joined motorcycle clubs and countless civilian groups to honor Helton as he passed the local high school.

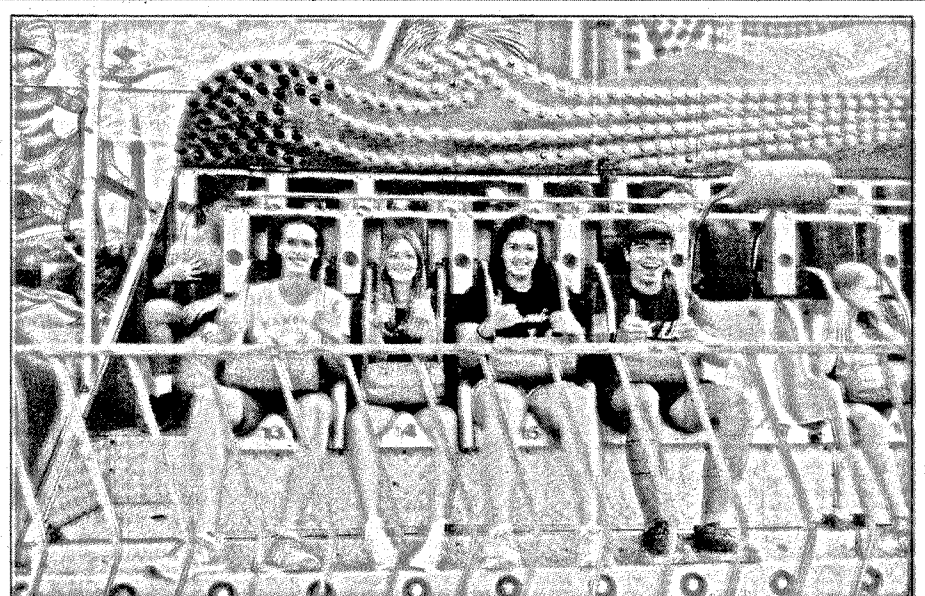
As the hearse approached the county, a hush fell over a crowd of officials and civilians that lined the streets as far as one could see. Hundreds of local residents and vehicles that were passing through the county stopped in total silence and stood at attention as the fallen hero passed them.

Even after Helton had disappeared over the horizon, the crowd remained still and quiet until finally, the sound of a closing car door broke the silence. Cars and trucks began to start and countless Americans from all walks of life silently drove away, taking Helton's memory and their thoughts of December 7, 1941 with them.

Helton was taken to a cemetery in Pulaski County where the remains were placed beside his father.

As Helton's car passed out of sight, and citizens stood in silence, there were no rich or poor people. There were no Democrats or Republicans and there were no shades of skin color. There were American

citizens who had just paid their respects to the best of us.
