

## I-75 closed for 4 hours Saturday

Firefighters - "It wasn't our call"

There may have never been a more fitting phrase concerning I-75 in Rockcastle County than "when it rains, it pours!"

Reports indicate a four-hour closure on I-75 in Rockcastle County Saturday, caused traffic jams in most cities from Berea to Corbin, with about 30 miles of backed up traffic and countless clogged exit ramps as motorists grew angry at the closure.

Once again this weekend, just after rain started falling in the area, the Mount Vernon Fire Department, assisted by the Brodhead, Livingston and Brindle Ridge fire eepartments, responded to 15 vehicle accidents in two days. But the massive traffic jam, causing social media tirades and angry motorists for countless miles, came when a truck pulling a trailer filled with PVC piping, caught fire due to faulty brakes Saturday.

Officials from the Kentucky Transportation Cabinet (KYTC)

made the call to keep two northbound lanes of I-75 closed due to road damage, after the intense fire, but first responders received the brunt of the ire from motorists upset over the excessively long closure. Social media posts, as well as

angry motorists on the highway, expressed outrage over the fourhour road closure stating concerns over motorists on their way to the hospital, pregnant motorists, no restrooms

## A giving heart **Rockcastle County** volunteers playing big part in Eastern **Kentucky rescues**

"I know people talk about the world heading in the wrong direction

and about all the bad things going on. But when there are those in need, people still step up to help. And nowhere anymore than in Rockcastle County. These were the proud words of the county's highest elected official, Judge/Executive Howell Holbrook, Jr. "It is a good feeling to see the countless number of people who have stepped up to help those in need in Eastern Kentucky. And you know what? Not one of them that I know of were asked. They just did it,"

Fire Department volunteers, churches, individuals, groups, clubs and businesses in Rockcastle County have made many trips to Eastern Kentucky after the massive flooding event two weeks ago that caused 37 deaths and over 16,000 residents to be homeless. Stories about the devastation have circulated across the nation but, though the national news media has generally stopped or slowed down on reporting on the destruction in the area, Rockcastle County residents are still heavily involved in rescue efforts and humanitarian relief every day. "It is wonderful to see how many people are willing to jump into the efforts to help those who are suffering," said Holbrook. "We have teams still making trips to Eastern Kentucky every day."

Members of the Mount Vernon Fire Department, who have made several trips already, is taking do-

If I got hungry, I would just go home with old Ricky Flannery at about noon and his mom would make sure I had a place at the table. When my mom was home, she did the same for him.

But it is difficult to explain how all us kids would act when we first heard the jingle. It was always in the distance and it took us a minute to figure out what that noise

Soon, the jingle would get just a little louder. "Oh yes! It is coming this way!" We would look at each other and then run to the nearest adult. "Can I have a nickel please?"

Whatever unfortunate parent was home that day had to reach in their pocket and pull out a hand full of change. If it was Old Tom or my friend's parents, they usually had a tiny little rubber change purse in their pocket, shaped like a very small football. You squeezed the side of it and the opening in the center would get wider and display all


the change inside. They would stand there handing out nickels to each of us one at a time.

By that time the jingle was louder and we were having to hurry before we missed it. Still, we were taught common courtesy. We didn't grab our nickel and run. We always waited until the last one of us kids got their nickel before we ran off. If we all didn't have a nickel, none of us would go.

By the time we got outside the jingle was very loud and we could see lights flashing as we sang along with the familiar tune.

Just about the time we got to the road, there it came. Bright colors shining through the fence

would breathe.



-- Always call 8-1-1 first and know what's below --



#### NOTIFY

Call 8-1-1 or make a request online two to three days before your work begins. The operator will notify the utilities affected by your project.

#### 2. WAIT

Wait two to three days for affected utilities to respond to your request. They will send a locator to mark any underground utility lines.

#### 3. CONFIRM

Confirm that all affected utilities have responded to your request by comparing the marks to the list of utilities the 8-1-1 call center notified.



#### 4. RESPECT

Respect the markers provided by the affected utilities. The markers are your guide for the duration of your project.

#### 5. DIG CAREFULLY

If you can't avoid digging near the markers (within 18-24 inches on all sides, depending on state laws), consider moving your project location.

When I left home for UK in May of 1962, my majors were to be in Chemistry and Biology. I quickly determined that I, too, was not bad at math. After receiving my degree, I taught high school chemistry for 38 years. Math skills are necessary for good chemistry teach-

One final way that Pop and I were alike was in our dedication to the field of education. Pop and I both served as members of the local boards of education.

After I retired from teaching in 2005, many teachers talked me into running for the local school board. I was successful for two terms (8 years) and decided not to run for a third term. I also served as chairman of the board for two years.

I loved my grandfather, and I am proud that we were a lot alike. He went to be with the Lord in 1974. He was 83. I still miss him terribly.







The intense training involves conversations that most never have and training that many never learn. But, according to Reppert, and Superintendent Carrie Ballinger, the local school system will stop at no lengths to keep Rockcastle County students safe.

"We have done preventive training and such situations as this should never come around. But just as an extra precaution, we are taking this extra training to know how to deal with the situation should anyone get inside with a weapon," said Reppert.

KSP professionals even fired guns inside the school to acclimate teachers and staff to the sound as well as make certain the sound of a shot fired could be recognized, according to Reppert. "It is very intense training," he said.

Teachers and staff were taught many aspects of emergency situations that could arise including how to deal with injured parties as well as different life saving techniques..

One teacher at the training said she was glad to be a part of the training. "I would rather be trained to deal with such things and not need it, than to need it and be unprepared," she said.

department's call. We didn't unnecessarily close the interstate," answered one fire department social media post.

The incident began Saturday when first responders were called to mile marker 72 northbound after a tractor trailer, hauling PVC piping caught fire. Upon arrival, firefighters found a massive fire since PVC piping can be an accelerant. The excessive heat from the fire forced firefighters to approach the fire cautiously, with the use of much more water than normal and some foam used for extinguishment. First responders say trucks were forced to bring extra water down I-75 from Berea by driving south in the northbound lanes.

Eventually, the fire was controlled but the extensive heat from the burning PVC, destroyed parts of the slow lane and severely damaged the center lane, causing officials to be concerned about the safety of motorists. First responders then contacted the KYTC by sending photos of the

damage and seeking guidance. Officials with the fire department say they were instructed to keep I-75 closed until engineers from KYTC could arrive, from two counties away, and assess the damage.

Once on the scene, KYTC officials decided to close both lanes until they can be repaved. Firefighters were then asked by KYTC to keep the lanes closed until KYTC workers could place signs, barrels and cones, directing traffic to the only remaining open lane.

Seeing firefighters keeping the lanes closed, sparked rants and tirades on social media blaming fire officials for the "unnecessarily long closures." However, local firefighters hastened to inform the public that "fire departments do not have the authority or the jurisdiction" to close I-75 for that length of time and they were "simply doing our jobs."

The Mount Vernon, Brindle Ridge and Brodhead fire departments continued to clean the roadway but since roads were still wet, Livingston was forced to respond to a separate accident on I-75 at the same time.

Members of the Kentucky State Police and the Brindle Ridge Fire Department were forced to close Exit 62 onto the interstate and reroute that traffic in an effort to ease the I-75 backup but this caused US-25 between Mount Vernon and Berea to also backup for many miles.

After the four-hour closure, the fast lane of I-75 northbound was reopened and the other two lanes remained closed until crews could repave the damaged area.

Officials say I-75 was still backed-up over 15 miles Sunday evening.

No injuries were reported in the accident and the truck was not damaged, since the driver detached from the trailer when the fire began, according to reports.

Assisting at the scene was the Mount Version, Brindle Ridge and Brodhead Fire Departments, the Kentucky State Police, the KYTC, Kentucky Energy and Environmental Cabinet and Thoroughtrucking Towing Company.

lar monthly City Commission meeting, the agenda called for time for visitors to speak or voice concerns about the city. However, according to City Clerk Amanda Thomas, no resident visitors attended the meeting.

The commissioners did approve a Letter of Intent to hire Shad Allen CPA to conduct the latest city audit

The City of Livingston has not had an audit since 2009, according to Thomas. However, city officials have spent the past several months, even closing City Hall for two weeks, gathering and preparing financial paperwork that had not been completed in many years.

Now that the city paperwork is "caught up" the latest fiscal year audit can be completed.

Thomas said the audit will cost the city \$12,000 but will bring the city into compliance with the Department of Local Government and will meet requirements that places the city in line for potential grant funding.

"We have worked really hard catching the city up on the paperwork that hasn't been done for many years," said Thomas. "There are forms and reports and financial statements and budgets that are required by the state for all cities and they have not been done in Livingston since 2009. This administration has spent a lot of time working all day and through the night to get the city in compliance and this audit should have us caught up."

The audit will deal with all financial reports over the past fiscal year beginning July 1 of 2020 through June 30 of 2021.

One of the biggest benefits to being in compliance with state requirements is having access to available grant money. "We did all the paperwork over the past several months and now this audit should make the city eligible for grant funding," said Thomas."

Thomas and Mayor Dwane King say they have more than one state grant in their sights once the audit is complete.

"There are grants that we should be eligible for that can make a huge impact in our city, our water and sewer and general operations," said Thomas. "We will apply for every grant we find that we are eligible for once this audit is complete."

Having no further business, the commissioners adjourned the meeting. The next regular monthly meeting of the Livingston City Commission is scheduled for Monday, September 12 at 6 p.m. in City Hall. The public is invited to attend.

The Climax Fire Department requested the use of a county truck to deliver items but, instead, Holbrook took his personal truck filled with donated items, along with the Cimax volunteers, to Letcher County.

The Pongo Fire Department has also made trips to deliver items and help with rescue efforts.

The Brindle Ridge Fire Department has provided donation information and suggest monetary donations, since items donated can do more harm than good, according to officials at the Brindle Ridge Fire Department.

The American Red Cross agrees saying unsolicited donated items can cause disruption and turn

into piled up unused trash, as well as causing volunteers on site to have to be used to manage the unused items. Officials say those resources could have been used for rescue efforts instead of stacking, organizing and storing unsolicited items. Officials say in many natural disasters, resources are taxed in attempts to deal with unsolicited donated items causing more disruption and can slow recovery and rescue times.

Holbrook agreed. "I spent 13 years with the federal government dealing with natural disasters and I can tell you people should not send items unless they have a contact for delivery and a staging area," said Holbrook. "Unless the effort is organized, you can end up with piles of unused, unneeded items that causes even more disruption."

Still, with a contact and a well organized plan, Rockcastle Countians are giving every day through requested items or rescue efforts as well as volunteer labor to clean up and rebuild.

Rockcastle Regional Hospital is also helping in several ways, including a partnership with Magic Monograms to sell shirts, sweatshirts and hats to help those in need. All proceeds will be donated to the Appalachian Regional Healthcare (ARH) to directly help. Anyone interested should go to rockcastlecares.item order.com/shop/home. Those interested in donating may also go to

relieffund.ky.gov.

As usual, there are also those who are attempting to take advantage of the disaster to make money.

"There are already scams out there going around," said Holbrook. "It is a shame but it always happens and people should be alert and never give their personal information over the phone."

"No one that I have met during these efforts is helping for the recognition or to help themselves in any way," said Holbrook.. "I have seen it first hand and we have a lot of good, caring people in our county who have stepped up for no other reason than to help those in need."

(4) They were all given different answers to the same question, because they were at different places on the road to salvation. The Bible does not contradict itself!



The proposed updated Ordinance is available for public inspection beginning August 11th, 2022 at the following locations during their normal business hours:



Any person wishing to comment on the Ordinance update may do so by providing comments no later than close of business on September 12th, 2022 to the Rockcastle County Fiscal Court at 205 East Main St. #14; Mt. Vernon, Kentucky 40456. Any person wishing to be heard at a public hearing must make a request via telephone, fax, email, or written communication, to the governing body identified above, no later than close of business (COB) on the 30th day.

A public hearing is scheduled on September 13th, 2022 at 10 am to receive public comments on the Ordinance update. The hearing will be held at the Rockcastle County Judge Executives Office at the Rockcastle County Courthouse. However, if no request for a public hearing has been received by close of business on September 12th, 2022, the hearing may not be held.

The governing body will respond to written public comments within 15 days of the close of the public comment period, and will consider the Ordinance update for passage at the September 13thFiscal Court meeting. The Ordinance update, if approved, will be submitted into the Rockcastle County Solid Waste Management Plan Update.

The Subsidy component helps households offset electric costs by providing a onetime benefit ranging from \$100 to \$400 depending on income levels and housing

The Crisis component can assist households who are demonstrate a home energy crisis situation, with the minimum needed to alleviate the crisis not to exceed \$600. Households can reapply each time they experience a crisis situation until they have reached their maximum benefit. Applicants must provide at least one of the following: disconnect notice; an eviction notice for non-payment of rent (if electric costs are included as an undesignated portion of rent); demonstrate a late amount, overdue amount or that they are within 10 days of running out of pre-paid electric; or demonstrate that they would be disconnected or evicted if not for a moratorium due to a local, state or federal state of emergency.

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the prior month.
- Most current heating bill, statement from your landlord if heating expenses are included in your rent, statement from utility company if you participate in a Pre-Pay Electric Program.
- The account number and name on the account for main heating fuel sources and electric hill
