

#### Daylight to not so dark

Students waited patiently for the eclipse to reach totality Monday afternoon at MVES after teachers provided glasses for each student. Some surrounding counties closed school for the day for the event which last happened in 1918. However, Superintendent David Pensol and school board members agreed that this total eclipse event "provided one of the best educational days in 100 years" and did not cancel classes so that students could observe the event with trained teachers at hand to answer questions and provide information about the solar system. The next solar eclipse is expected in 2024 and will be visible from Texas to New England.

#### High speed chase starts in Rockcastle County

Suspect rams police cruiser

A high speed chase through Rockcastle County late Wednesday morning ended in the arrest of two suspects, after the driver rammed the Mount Vernon police cruiser of officer Ryan Messenger.

Mount Vernon Police spotted the vehicle of Charles, E. Allen, of Central

City, this morning after being alerted that the driver was wanted in Madison County for burglary.

When Mount Vernon police attempted to pull the vehicle over as he came through Mt. Vernon, police say Allen then sped off south bound on I-75, at the 49 entrance, as police gave chase. At speeds in excess of 90

mph, police say Allen's vehicle was throwing sparks as the vehicle was on rims only and the vehicle was darting towards police cruisers.

As the Kentucky State Police joined in on the chase in Rockcastle, the car continued to head south into Laurel County where offic-



Turn Your Radio On On Sunday, while driving to church, my wife and I were once again listening

to one of our favorite gospel albums. We have several of these, but this particular one contains a very familiar song of my youth.

I well remember, when I was a young boy, seeing my grandfather (Pop) sitting in front of his wooden, floormodel radio listening to the song, "Turn Your Radio On." He loved the lyrics of that great gospel recording. It is one of those splendid toe-tappers.

The song was written by a most prolific artist by the name of Albert Edward Brumley. He lived in Powell, Missouri, and over the course of his lifetime, he penned over 800 gospel songs. The one with which most people are acquainted is "I'll Fly Away." Others include "If We Never Meet Again," "I'll Meet You In the Morning," and "He Set Me Free."

"Turn Your Radio On" was first published in a book called Guiding Star in 1938. It has been released by many recording artists over the years, including Randy Travis, whose version we were listening to in the car.

While we were listening to the lyrics, my wife, who was familiar with the chorus, had a sudden realization. She was astonished to realize that she had never actually "gotten" what the song is really about. She had always thought that it was an instruction to turn on your radio and listen to good ole gospel music and preaching. She related to me that one reason for her affection for the tune was that it reminded her of being in her own grandparents' home in Bath County, where the radio was always on-and it was always tuned to gospel music or preaching.



I am not a white supremacist because I want our constitution to be adhered to, especially our guarantee of freedom of speech. I am not a white supremacist because I have a different ideology than liberals. 



(Continued from front) problem is continuing to grow.

More money is involved, more drugs are involved and more drug-users are involved in the culture every day, according to these officials, and efforts against the epidemic are only slowing the growth rate instead of stopping the growth. In fact, reversing the growth rate is only a dream that has not yet been answered anywhere in the state.

However, many of those, who have been affected by the drug epidemic or have worked closely fighting the problem, are starting to get involved and trying to make a difference.

Such is the case with Kentucky State Police Trooper Ryan Loudermilk.

The officer has been involved in many local drug arrests and investigations and has seen the damage drugs do to otherwise innocent bystanders.

"We have some exciting news," said Loudermilk. "We are in the beginning stages of establishing a nonprofit, Christ-centered, adult men's substance abuse rehab facility here in Rockcastle County."

Loudermilk said the drug culture has affected most people in the community and this is one more avenue for help. "Very few people in our community and the state have not been affected themselves or have family members affected by substance abuse."

Loudermilk says My Brother's Keepers, Inc. will be opening an office here in the county to battle the problem. "The new establishment will open new opportunities for treatment sources in this epidemic that we face on a daily basis," he said.

Though a location for an office is being looked at, the group is not yet able to release that information until plans are finalized. But Loudermilk is not waiting until that time to get started on the programs that will help so many.

Though some details, such as an exact title or exact location may not be ready for announcements, Loudermilk is hosting an information-gathering event this week to start the ball rolling.

"Everyone is invited to come join us at the Rock-castle County Middle School Cafeteria Thursday, (tonight, August 24) at 7 p.m. to obtain more information about what we are doing," he said. "We are looking for partners in this goal to help us be keepers of our brothers."

Loudermilk hopes to gather information as well as provide information at tonight's event and be ready when the time comes to open the new facility and be ready to immediately help those who face the issues of drug abuse.

Loudermilk's goal is to have the new office up and

running by March of 2018.. There is a Facebook Page where some information is available and a Go Fund Me Account set up and information about those pages will be given out at tonight's meeting.

Loudermilk says he is excited about the possibilities and hopes the community will fully support his plans to help anyone who may be affected by drugs in our community.

"We are ready and committed to doing our part.....are you?" Loudermilk asked.

"People really have no idea how many hours and how much work the volunteers give to make the fair safe and clean and fun for citizens," said Bullock. "Some of us take our vacation time for the full week of the fair and give up our summer vacation to make sure people are safe and the environment provides a good, clean, family atmosphere for all who come.

There is more to it than most people can imagine."

In fact, many may not be aware that BFD members and volunteers begin planning and working on next year's fair in November. "We typically get about 4 to 5 hours of sleep a night during the fair because we are working to keep the areas clean and safe. It's a constant effort and though we are proud to do it for our citizens, our volunteers give up a lot to make it happen," Bullock said.

In fact, the BFD sends people to Louisville each year to the fair convention to get ideas and contracts for events in Brodhead during the week.

'We ask a lot of our volunteers just to train to fight fires, do rescues and be firemen," said Bullock. "It pains us to ask more of them but we have fish fry fundraisers and softball fundraisers as well as anything else we can think of to be able to provide the service we do. If we didn't raise money throughout the year, we couldn't provide the level of service that we have for the citizens of Brodhead"

Bullock, along with Dallas Todd, serve on both the fire department and the Brodhead City Council.

According to Bullock, volunteers are still giving their time on things related to the fair such as picking up trash, gathering signage, returning trailers and many other duties that many never consider.

"We are proud of our fair and our community and we are pleased to provide the fair for everyone. But we are also pleased and proud of the unbelievable work, time and effort given by fire department volunteers who make it happen" said Bullock.

According to Bullock, the volunteers do not give up their vacation time or work the uncalculated hours for a "thank you" but instead give of themselves for the same reason they became firemen. For the good of their community.

Still, the next time you see a Brodhead Volunteer Fireman, you may want to offer a "thank you" or better yet, offer a few extra dollars to help keep the level of service that Brodhead residents enjoy year round even when the fair is not in town.

time we are making a move ahead," said Mayor Mike Bryant. "It's not like we are trying to do anything against the law and we make every attempt to follow state regulations and obey code restrictions."

The restriction the Mayor is referring to is that a full time, licensed plumber must be on-site during all construction of the splash pad, according to state officials.

"We were unaware of that and we have a plumber on site during all decisions but we didn't budget to pay a licensed plumber to stand there while we are digging a hole throughout the entire project," he said. "That could become very expensive."

Mayor and The councilmembers said this is the third year the city has tried to install the splash pad but something has hindered construction each year. "We aren't giving up," said Mayor Bryant. "It's very frustrating to run into so many obstacles but we will not stop. We believe the splash pad will be a great addition to the park along with all the other improve-

ments we are doing there."

The council also addressed the new police cruisers that are usually purchased at this time of year. However, there was good news from Brian Carter, Chief of the Mount Vernon Police Department. Carter said that this year, instead of buying four Dodge Charg-

ers, the department plans to purchase one Charger and three Dodge Durangos. "The Durangos will give us four SUVs for winter and difficult terrain. Yes, it's more expensive but thanks to drug busts and gambling arrests, we have the funds to make up the difference from forfeitures," said Carter.

In fact, over \$20,000 was confiscated this year by the department and will be used toward the purchase.

Mayor Bryant said this will put the police department fleet in the best condition it has ever been in,

The city also discussed water quality in Mount Vernon and some complaints recently placed concerning the taste of water. "We are aware of the problem," said Mayor Bryant. "We are doing everything we can to fix it. We have greatly improved our water plant but all we can do to avoid the problem completely would be a new lake and a new multi-million dollar water plant."

The city had received many calls concerning the water recently and this week the fire department flushed all 198 hydrants in an effort to clear the water system.

In other action, council members voted to accept the bid of ATS Construction for the city's blacktop work. Though ATS Construction was the only company to submit a bid for the project, the bid is \$5 less per ton of blacktop than it was last year.

The council also discussed the possibility of moving to the new offices in the attached building by the September meeting. Plans are to have the council chambers finished by then.

Chief Carter also told the council that the department made 609 total calls for service in July which is nearly 50% higher than the typical July.

The department made 94 arrests and worked 25 accidents. There were 52 traffic violations and 57 warrants served with 5 grand jury indictments.

The All American Club reported picking up 15 bags of trash in the city. The club also reported taking down yard sale signs and the need for some additional All-American Club signs to replace those that have been damaged or torn down. The NAMI and All American Club conference in Somerset is planned for August 26 and 27.

The Mount Vernon Fire Department reported 217-runs through July 31 with 41 of those in July.

The department worked 12 accidents and 17 fires.

The next council meeting is scheduled for Thursday, September 21 at City Hall.

Such may be the case with Rockcastle County's Youth and Family Resource Service Coordinators.

Headed by Becky Isaacs, Student Service Coordinator for Rockcastle

County Schools, these five dedicated workers are not teachers in their own classroom, they rarely get their name in headlines and they do not seek the spotlight.

Instead, their goal is simple. "Remove any and all barriers that may get in the way of a student's success in Rockcastle County," said Isaacs.

Youth Service Centers and Family Resource Centers came into existence in

the 1980s with the new KERA (Kentucky Education Reform Act) which changed the educational process in many ways.

The act was met with statewide criticism and many of its functions have been abandoned since its inception. However, the student resource elements of the act have been a huge as-

set across the state and Rockcastle is no exception.

"Our Youth Service Coordinators and Family Resource Coordinators provide constant help to students

and parents and guardians beginning well before school begins each year," said Isaacs. "They are trying to help place students in the best possible atmosphere to take full advantage of our programs, educational process and become successful students in school and successful adults in life."

In Rockcastle County, the students service coordinators are Satica Morgan at Brodhead, Regina HullBrown at MVES, Sandy Bullen at Roundstone, Angie Payne at RCMS and Jesse Mahaffey at RCHS.

"These five people work diligently with parents and students to make sure the child gets the best possible education," said Isaacs.

The school board provides a working budget each year and allocates funds to provide services throughout the school system as well as plan projects and programs that will benefit each student. Many decisions are made at every school board meeting that will affect each student in some way.


But without Isaacs and the five coordinators throughout the system, students and parents may never know what these programs and policies can provide for each student or how to access them.

About ten parents have attended school board meetings over the past year. Yet at each monthly meeting, dozens of decisions are made that will affect students. These coordinators provide the link between day-to-day activities of each



Money Tip for Students

#### Students should take care when signing contracts

At some point, students will have to sign a contract. When they do, they should keep in mind these tips from the Kentucky Higher Education Assistance Authority (KHEAA).

A contract is a written legal document between two or more parties in which an offer is made and accepted. An apartment lease, an insurance policy or a cell phone plan are all examples of contracts. Read all contracts thoroughly and ask questions before you sign. Complete everything and keep a copy for yourself.

Consumer protection laws let you change your mind and cancel some contracts within three days of signing. Before you sign any contract, find out if you have that option. If later you

find it's necessary to cancel the contract, you may have to pay a big penalty or continue to pay what the contract calls for.

Never sign a contract unless you read and understand the terms of the agreement. If you feel pressured, walk away.

since his freshman year, playing vital roles in some huge games. He is also a leader on and off the field. Brent's experience, under fire, ultimately won him the job for this season. We expect him to be able to make good decisions and be a threat in both the running and passing aspects of our offense," Parkey said.

Speaking of offense, during the off season, assistant coach Izak McQueary was moved to the position of co-offensive coordinator. Parkey said of McQueary, "His new ideas, new approaches and new eyes have been great for us, thus far. He will be calling the bulk of the plays in games. We will continue to rely on our stable of running backs following behind a big, experienced offensive line for our running game. Brent has a super strong arm and a very quick release of the football. That should make our running game that much better."

Some players moved around a little bit on both the offensive and defensive lines. Amyx was moved from guard to tight end, JD Hamilton was moved from tight end to center on offense and from linebacker to defensive lineman on defense. Stewart moved from center to guard.

"One of the strengths of this year's team is our big, strong, experienced linemen on both sides of the ball, as well as our running game," according to Parkey.

Parkey said, "Even though we are looking to replace a couple of graduates, we are returning a great nucleus. Plus, the guys battling for the spots have created more depth than we expected to have. Guys like Clifton Boone, Harley Northern, Phillip Cope, Blaine Rumsey and Zack Baker have really emerged as 'next up' type guys and will be ready to play at any time."

Parkey's biggest area of concern for his team is their ability to handle adversity that inevitably comes throughout the course of any and all games. Parkey feels the players had a bad habit of not wanting to mess up this spring and

this caused some indecision and slow reactions which usually leads to errors.

"We have worked really hard on changing our body language and being accepting when things don't go as drawn up The guys played great in the first scrimmage, focusing on the things they can control," Parkey said.

The Rockets' district is once again loaded and will likely be the toughest district in all 4A, as in past years.

The coach gave some thoughts on the district teams the Rockets will face this season.

Wayne County returns their quarterback, who is one of the best in the area. They are going to be athletic, physical and fundamentally sound. "The key to this one is how we will respond to adversity on the road," Parkey said.

Knox Central has a new coach this year. He was on staff last season, so Coach Parkey is expecting much of the same schemes. They will be really big on the line, with some good skill guys to make plays on both sides. Key to this game will be stopping their running game.

Clay County will be improved from a year ago. They will be big, as usual. How the Rockets respond to their size will be key.

Russell County is poised to surprise some people this year. They were very young last year, returning most of their team. Experience is vital in district play, according to Parkey.

But even as he plans for the upcoming season, Parkey is keeping the future in mind as well with his 14 freshmen on the team who are expected to make a difference in the squad.

When asked about looking for younger guys to step up, Parkey said, "We have several guys who are seeing their first real varsity action and I couldn't be more pleased with their progress, thus far. Our receivers and defensive backs are a little green, but we couldn't be happier with the way they are playing. Mathew Tomlinson, Blake King, Jarred Brown, Jacob Hansel and Hunter Sargent have taken their roles, embraced them and stepped up to be fine players."

The players and coaches all agree on their goals. They want to win one game a week by focusing on getting better from where they are at the present time. "We don't look forward or back, we simply look beside us at each other, then down at where our feet are--then do something to improve now. District championships and more will come when all team members share that mindset," Parkey said.

The Rockets will begin their season this Friday night as they host Lincoln County in the annual Jamboree Bowl. Game time is 7:30 p.m.

#### Game 4 - Sept. 17 Harrison County Class 4A, District 7



Game 5 - Sept. 22 Somerset Class 2A, District 7

The Somerset Briar Jumpers face a very tough schedule this year and RCHS is among those expected to thwart their quest to improve their 7-5 record.

Though the game will be held in Somerset, the force of the Rockets will be difficult to handle even with the Briar Jumpers' experience on the defensive field.

Game 6 - Sept. 29 Wayne County Class 4A, District 7

The Wayne County Cardinals will host the Rockets and they bring a 11-3 2016 record to this year's season.

Searching for their third consecutive regional title, the Cardinals will be led by senior quarterback Lorenzo Linsey and Grant Shoemaker, who had 33 catches last year.

Panthers senior running back, Donovan Arthur, has been a strong force for the team with two straight 1,000-yard seasons.


Knox will have the advantage of homefield this season against the Rockets but will have to perform strongly on offense and defense to handle Rockcastle County.



#### RCHS girls' cross-country seeks ninth regional championship


The RCHS girls' cross-country team recently began practice in their quest for their 9th regional title and a berth in the Class 2A State Championships in November. With several new additions to the team and the improvement of others, the team is expected to have one of its best seasons ever.

In 2016, the girls' varsity team finished as runner-up in Class 2A Region 5. At the Class 2A State Cross-Country Championships, they had an exceptional team performance, finishing 9th overall while averaging a solid 5,000-meter time of 21:21. At the start of this season, the girls are once again one of the favorites for the regional title, as well as a strong contender for the state title. The team will miss last year's lone senior, Taylor Bullock, who has already begun cross-country practice at Alice Lloyd College.

The varsity team will be led by sophomore Tori Dotson, an all-state competitor in both cross-country and track, who finished as state runner-up in 2016. She also won the Class 2A Region 5 championship title in October. After another great track season culminating in a Class 2A state championship title in the 800-meter run, Tori should begin the cross-country season as the number one ranked girl in Class 2A. 




