The Mount Vernon Fire Department was called to this structure fire on Countryside Circle Estates Road near Mount Vernon just after 11:00 Monday night. Upon arrival, crews found the home and a vehicle in the driveway fully engulfed in flames as the Brodhead Fire Department arrived as automatic aid. The Western Rockcastle Fire Department also rushed to the scene for additional assistance. The occupants of the home were able to escape the blaze but reports indicate one resident of the home received burns while escaping the fire and was transported to the UK Medical Center. Though no official cause has been established, officials suspect an electric heater may have been the cause. Firefighters were able to extinguish the blaze but the home and its contents are considered a total loss.




I am praying every person who reads this column has the most Merry Christmas ever. Unless vou are very young, that lot. It was the Christmas is very unlikely, isn't it?


# Jan Ivan Stevens

(Continued from front) derway by Deputy Sam Brock. He was assisted at the scene by Sheriff Shannon Franklin, the Kentucky State Police (KSP), 2nd District Constable Steve Griffin, the Brindle Ridge Fire Department and Rockcastle EMS.

Later the same week, an unidentified woman, was reported killed after being hit by a train about half a mile south of Livingston.

The coroner was called to the scene, along with local first responders and representatives of CSX Railway.

The female is believed to be from another county. She was pronounced dead at the scene.

The name of the victim is being withheld pending family notification. Brock is also investigating this incident. He was assisted by KSP, the sheriff's office, Constable Griffin, Livingston Fire and Rescue, the Rockcastle County Coroner and Rockcastle County EMS.

The cause of neither incident was known at press time but separate investigations are underway.

"Parade"

(Continued from front) the very cold temperatures, the annual City of Livingston's Christmas parade began at 6 p.m. last Saturday and was over soon after. But the evening was just beginning as visitors covered in heavy coats, toboggans and mittens, made their way to the old school cafeteria, where tables, filled with foods prepared by volunteers, filled the belfies of the many visitors. After enjoying the hot coffee and countless food items and over a dozen dessert choices, the crowd made their way to the old school gymnapartments and sheriff's department to become short handed, since many districts can afford higher salaries than some cities or counties. In fact, the neighboring Laurel County School System, created their own private police department, pulling at least three officers from Rockcastle County agencies to their force.

However, the Rockcastle County School District has found a way around both of those issues.

Needing five full time officers (since the mandate requires one at each campus and not one at each school) the school system entered into an agreement with the City of Mount Vernon and the Mount Vernon Police Department. The agreement allows police officers with the MVPD to serve as full time SROs during school hours and as police officers on the streets of the city when school is not in session. MVPD supplies all equipment but the school system will pay their salary and benefits while on duty with the school system.

Thus far, the plan is working well and the school system has three full time SROs and the MVPD has not lost any officers to the school system. According to Director of Student Services Marcus Reppert, the best part of the plan is that "our students are safer."

The local district currently has Tom Atkins as head of the force located at RCHS, Shay Helton at RCMS and the Rockcastle Academy for Academic Achievement (RAAA), formerly locally known as the vocational school. Officer Dylan Hensley has now been hired and will rotate between the elementary schools, beginning in January of 2023. an interim measure until an officer can be hired for each elementary school.

But that isn't the only good news, according to Reppert.

Through a collaboration between the school system and the MVPD, \$125,000 was received through the Department of Justice's COPS (Community Oriented Policing Service) Grant program. Reppert said the \$125,000 grant will be used over a five year period to help pay the salaries of the three SROs and the money will be split between the school system and the MVPD. Reppert says the local school system intends to hire more SROs to have one officer at each school full time but until that happens, all Rockcastle County schools will have an SRO designated to spend time on campus. "Rockcastle County Schools are safer now than they have ever been," said Reppert. "There is always room for improvement and we continue to look at better methods and strategies every day. But we are very pleased with these officers who are well trained and prepared for the job. We will never stop trying to make our schools the safest place a child can be."

proved the change to the requirements.

Some expected new cost estimates, from the architectural firm designing the new middle school building, but there were no new reports given at the meeting. There has been discussion with board members that the estimated \$34 million cost of the project will rise due to inflation and design requirements. But those new estimates were not provided in the December meeting. Ballinger said architects are still working on the design and the calculations and she expects new cost estimates at the January meeting.

The board also discussed the upcoming 2023-24 school calendar and said the calendar committee will schedule meetings and bring back a draft of the calendar in January.

Ballinger also presented the Superintendent's Personnel Action report which was lengthy this month. "We are seeing more shifting and moving," she said. "Times are different than when we begin in our profession. This younger generation doesn't mind new challenges and changing jobs. Gone are the days of someone being a second grade teacher for 20 years. We have to change our mindest to meet this younger generation's goals and aspirations."

earlier in the year but when a bid was received it was well over \$100,000. causing the court to agree to consider other construction options or look for other bids. "I can tell you that if you wait for more bids they are going to be about the same. That's what it costs. But something needs to get done. There are businesses willing to give and people interested in helping but I'm not going to ask that of them. That's why they pay taxes. They shouldn't pay taxes for things like ball fields and then have to build the ball fields themselves," said Hensley.

There was then some discussion about the Parks and Recreation board that was formed several years ago but once again, no new development came from that attempt. "That board was formed and then some property that was supposed to be donated to the city didn't happen and the board just went away," said Magistrate Shannon Bishop.

**RCIDA** Director Jeff VanHook said he agrees new fields are needed. "The occupational tax was promoted with a percentage supposed to go to the Parks and Rec Board. But after it was passed, the previous administration rescinded that idea and none of it went to Parks," said VanHook. "So now it is like anything else, all the talk in the world gets nothing done. It takes action and leadership. But quality of life is a big part of economic development. I'll help you and if it can be done, we will make it happen."

VanHook, who submitted a document showing well over \$35 million in investment brought to Rockcastle County since he was hired as executive director of the Rockcastle County Industrial Development Authority five years ago, said in a later interview that he already has a plan and will help find a way for new ball fields in the Brodhead Park. "If it can be done, we will find a way. We will look for grants and other funding outlets until we find a way to create whatever is needed at the park." Hensley expressed his passion that the project move forward. "I know you can hear the disappointment in my voice. We are all just tired of the years of talk and it's the same thing every year. Nothing happens. It is frustrating that we get close over and over and then it gets pushed down the road." with However, VanHook's commitment, several magistrates expressed their confidence that the project, in one form or another, will now begin to move forward. In other action, both the County Clerk and the Rockcastle County Sheriff and Deputy Dale McNew, submitted updated budgets that reflect a five percent raise for their employees, following suit with a recent agreement by the court that all county employees will receive the raise. Both budgets were passed unanimously (see more detailed story in this week's paper). The court also dealt with the Rockcastle County Administrative Code for all county employees. Judge/Executive Howell Holbrook, Jr. said there were three specific areas of the 2023 code that needed to be addressed. First, the court agreed the COVID section would not be changed and employees who test positive will still have time off. "It looks like COVID will alwavs be with us. I don't

know if you (the court) want to change anything but right now a positive COVID test and you are off work for a certain time with pay, but a positive test for the flu and you get nothing," Holbrook said. However, the court agreed to leave that part of the code the same as the previous year.

Secondly, the court agreed to allow 80 hours per year of time off without pay if requested. Previously, Holbrook said there was no maximum time off. "Currently, people can take off without pay every Friday of the year if they call in. Should we set a limit to how much they can take off per year?" he asked. After discussion, the court agreed to 80 hours per year. More than 80 hours would cause disciplinary action against the employee.

Lastly, the court dealt with CBD Oils. A recent trend across the country, CBD oils apparently can reduce some pain and is used for dietary supplements. However, taking CBD oils causes the user to test positive for marijuana which would void the county's zero-tolerance insurance policy. Magistrates agreed to maintain the current policy and suggest employees use some of the many alternate options available for such treatments. "We perform random testing and anyone who tests positive will not pass the drug screen," said Holbrook. The court agreed employees may not take CBD oils and maintain employment with the county.

The new administrative code passed unanimously. The court also agreed to a special called meeting on January 2 to adopt the code and start business for 2023. "We basically have to rehire everyone at the beginning of each year to maintain insurance" and enact the administrative code," said Holbrook.

VanHook presented the RCIDA reports which listed millions in investments in Rockcastle continue as they are, we may see an investment in Rockcastle County that will be the biggest project in the history of southeastern Kentucky," he said. "Of course we cannot address details at this time but there are some phenomenal possibilities in the works right now."

There were also visitors complaining that the local animal shelter may not be operating up to their standards. However, Holbrook indicated the local shelter meets or exceeds all state and federal guidelines and complies with all laws and local ordinances.

The City of Livingston also reimbursed the court \$2,500 for safety and security money that was not used since the Livingston police officer had not worked in recent months. The county provides \$1,000 per month for security when an officer is on duty.

Also related to Livingston, Holbrook asked County Attorney Jeremy Rowe to organize a report concerning all property in the city of Livingston owned by the county. "That list of properties and agreements between the county and the city hasn't been updated in many years and we need to know the status and all the agreements made concerning the school, the gym, city hall and all other property that the county owns," the judge/executive said. Rowe said he would submit the report soon.

Holbrook also presented the court with a letter from the Sheltowee Trace organization which has now severed ties with the City of Livingston and say they will no longer lease the county-owned building in Livingston.

Lastly, County Treasurer Joe Clontz asked to transfer \$266,000 from the occupational tax fund to the general fund and then \$156,000 from the general fund to the jail fund.

Having no further business the meeting was adjourned. The next regular meeting is scheduled for

# **RCIDA Executive Director position now at \$110,000**

After a peer review, and meetings with other economic development districts, the Rockcastle County Industrial Development Authority has voted to increase the director's salary to \$110,000 annually plus benefits.

Five years ago, Jeff VanHook became the RCIDA director and, in that time, the board points to well over \$35 million in local development brought to the county, including a natural gas line on its way to Rockcastle with no expended funds from the county.

The board then realized the rate of pay for the position that VanHook holds is much less than similar director positions in the state, according to **RCIDA Chairman Corey** Craig. "We are so fortunate to have him (VanHook) that it is difficult to describe," he said. "His contributions to our community are immeasurable because we don't know the future. We have potential that can't be measured because of his work. And he is currently working on a project that could transform the entire state of Kentucky from

right here in Rockcastle County. It is a project that could affect many generations to come and would be one of the biggest projects in Kentucky history. But in my opinion, five years ago, before Jeff started this momentum, such an idea would never have even occurred to us."

Craig said VanHook's work has not only created over \$125,000 in occupational tax revenue alone to the City of Mount Vernon, but has brought millions of dollars in development to Rockcastle County. "If you had said five years ago that Chapin Industries would be here, our Farmers Market would be the envy of the state and that natural gas would be on its way to Rockcastle County with zero investment, I would have said you were crazy," said Craig. "But now, even if this new project never happens, the fact that such a project is even possible in Rockcastle County and could happen here now, is an amazing thing. We have to keep this momentum and we have to stay competitive and there is no one better than Jeff VanHook for (Continued on A6)

Keelee King dominated the boards for her team, pulling down seven rebounds; H. King got six; Shearer five; T. King and Spivey four each and Cash and Smith one each.




Tuesday, January 3, they will resume regular season action when they host Somerset for a doubleheader district game with the Rockets.











SWEET POTATO CASSEROLE 3 cups cooked sweet potatoes, mashed 1 cup sugar 1/2 cup butter, melted 2 eggs, slightly beaten 1/2 cup milk 1 teaspoon vanilla Butter a 2 quart ovenproof dish. Preheat oven to 350°. Mix above and pour into prepared dish. **TOPPING:** 1 and 1/2 cups brown sugar, packed 1 cup chopped nuts 2/3 cup flour 1 stick butter, softened Mix with fork and sprinkle on top of sweet potato mixture. Bake for 30 minutes.

SWEET POTATO CROQUETTES 2 cups cooked sweet potatoes 1 tablespoon butter 1 teaspoon salt 1 tablespoon sugar 1 egg white breadcrumbs Mash sweet potatoes and add salt, sugar, and melted butter. Shape into patties and chill in the refrigerator for half an hour. Heat oven to 400°. Grease cookie sheet. Lightly beat the egg whites.

Roll croquettes or patties in breadcrumbs, dip in beaten egg whites, and in the crumbs again. Place on prepared cookie sheet. Bake for 20 minutes. For a modern variation of this old recipe, place a marshmallow in the center of each with the potato mixture coating it completely.

SWEET POTATO SALAD 2 large sweet potatoes 2 tablespoons light mayonnaise 1 tablespoon Dijon mustardinal surrow taken and oRockets 37 (Fr) 1/2 teaspoon salt 1/4 teaspoon coarsely ground black pepper

2 large celery stalks,

coarsely chopped

Add sweet potato chunks, celery, red pepper, pineapple, pecans, and green onion to mayonnaise mixture. Toss gently until evenly coated. Canned pineapple chunks, drained, can be substituted for the fresh pineapple. Regular mayonnaise or Miracle Whip can be used instead of the light mayonnaise.

# By Max Phelps Fire in the Yard: Fireplaces, Firepits, etc. People have found it natural to gather around a fire since our first recorded histories.

A firepit of some type is the most economical, and the most common, way of adding the element of fire to a backyard. These range from some boulders arranged in a circle on the ground, fueled by firewood and logs (a campfire, basically), to metal and brick ones you'd purchase as a kit to assemble. Perhaps you might desire a light weight one you could easily move around for various occasions.

A gas-fired firepit or fireplace is certainly more convenient than one that requires you to start and tend a fire. Adding gas or electric obviously costs more to install, usually requiring a licensed trades person. Propane or natural gas are typically the options here. Or one of electric having simulated flames.


Fireplaces are typically a special and top shelf item on the menu for having fire in your backyard.

They can be rustic, or modern in appearance. Fueled by logs, by gas, or by electric, they can offer options for cooking, heat, and a cozy place to hang out by. There are kits to buy and install, or there's the option of hiring a stone or brick mason to construct one from scratch.

Fire features may lead to needing a better patio, to extra seating, a privacy screen, and other landscape features, depending on the need of the famijly and the situation and the layout of your space.


Outdoor entertaining frequently goes along, but a backyard fire can be a private experience if that is preferred.


A chimenea may be a quick and economical substitute for the grandeur of a real fireplace. Infrared electric stoves and fireplaces have come a long way in recent years, and some immitate real fire rather impressively. They may compare favorably to the wood-burning fireplace, and typically be safer and more convenient as well. They can be a quick option to have "fire" in the yard, too. Still, there's something about that flaming log or the glow of real embers as the wood burns up that can only come from burning some firewood. The smell of smoke from the wooden logs cannot be immitated by gas or electric. Finally, I suggest considering the real fire option in case there is a power outage. 

# *To keep Kentuckians moving safely* **Transportation Cabinet crews prepped for winter weather**

In keeping with their priorities to promote safety in the commonwealth, the Beshear administration is taking extra measures this year to prepare for winter weather. November is traditionally the Kentucky Transportation Cabinets (KYTC) snow and ice season launch, where more than 2,000 staff and crew members stand ready to keep roads passable for the safe movement of people and goods throughout the state.

Our crews have been on high alert, monitoring weather conditions to keep Kentuckians safe when snow and ice strike. Crews were dispatched Saturday for the first time this season in Western and Central Kentucky, Gov. Andy Beshear said. As fall transitions to winter, were thankful for their work to keep Kentucky drivers and their families safe, especially during the unusually harsh winter conditions weve seen in recent vears.

For months, crews have been trained, salt and road treatment supplies have been restocked, plow trucks have been serviced and route plans have been updated. A fleet of 1,365 state-owned and con-

them room on the roads, you can help some of our most essential public servants make it home safely at the end of their shift.

Kentuckys fleet of snow-clearing vehicles includes nine tow plows in different parts of the state. Tow plows have a trailermounted rear plow that swings out to resemble a jackknifed truck. It allows one driver and a truck to clear two driving lanes in one pass. Two of the plows are housed in Frankfort for deployment wherever severe weather creates a need for increased support on wide, high-priority routes. Seven others are based in Graves, Grayson, Hardin, Lyon and McCracken counties.

KYTC maintains most roads, streets and bridges that are part of the State Highway System. Examples include interstates, parkways, and U.S. route designations.

Driver Tips this Winter Season Safe roadways are a shared responsibility, especially during inclement weather when risks increase. KYTC also encourages motorists to prepare for winter and remain safe by following these tips:

tracted plow trucks is on deck to be deployed when needed. View a short video here.

Our crews are essential to keeping citizens and commerce moving in Kentucky, said KYTC Secretary Jim Gray. While the severity and frequency of snow events are unknown, we are ready to act and do our best with the resources we have.

The cabinet has stockpiled over 300,000 tons of salt, nearly 1 million gallons of brine for anti-icing efforts and more than 1 million gallons of calcium chloride an additive to salt for deicing.

KYTC uses a three-tier system to prioritize treatment and snow clearing on state-maintained routes. Route designations are based on factors such as traffic volume and connectivity to critical services like hospitals. During routine snow and ice events, crews operate using snow and ice priority route maps for maximum equipment and materials usage efficiency. The cabinet has established a snow emergency plan for severe winter storm events to deploy resources within each county to cover the highest priority routes.

State Highway Engineer James Ballinger described what motorists can expect when plows are out.

Like commercial trucks, our snow trucks have blind spots and tend to travel between 25 and 35 mph for optimal salting and plowing results, said Ballinger. Plows are not immune to the same dangers motorists face. By driving where the plow operator can see you, being patient and giving • Stock vehicles with ice scrapers, jumper cables, blankets, a flashlight, a cell phone charger, non-perishable snacks and a first aid kit should you get stranded on the road.

• Winterize your vehicle. Check your car battery, tire pressure and brakes. Ensure your heater, defroster, headlights and windshield wipers are working properly.

• When snow and/or ice are on roadways, drive slowly no matter what type of vehicle you drive. It takes more time and distance to stop your vehicle in poor weather, so brake early and slowly.

• Pay attention to weather advisories and allow more time to travel for routine commutes.

• Slow down when approaching intersections, off-ramps, bridges or shaded areas. These are all candidates for developing black ice a thin coating of clear ice that can form on the pavement surface that may be difficult to see.

• Maintain a safe distance from snowplows and other heavy highway equipment, and do not pass snowplows on the shoulder.

• Know before you go. Download the free WAZE app or visit ky.gov to check traffic conditions before you travel. The map also offers access to select traffic cameras on interstates and parkways.

• Eliminate distractions while driving, such as using a phone and or eating.













# DAR presents students with essay awards






National winners will be awarded at Continental Congress and presented a medal, certificate, and monetary award.



During the season of giving, two women across state lines are working together to ensure those who gave it all are never forgotten. A sister from Pennsylvania and a mother from Kentucky both lost a law enforcement family member in the line of duty. They connected four years ago and continue the honorable tradition of providing Christmas wreaths for the Kentucky State Police (KSP) fallen unit's gravesites. KSP has 37 fallen officers who have died in the line of duty since 1948.

"During the holiday season, the National Christmas Wreath Program allows us to take a moment to honor those who gave everything protect to the commonweath," saidGov. Andy Beshear. "My family and I will never forget the officers who dedicated their

lives to service." The Fallen Heroes Wreath Program was started by the family of Philadelphia police officer

John Pawlowski, who was killed in the line of duty on February 13, 2009 when responding to a dispute. His sister-in-law, Michelle Pawlowski, was inspired by the national 'Wreaths Across America' program that places wreaths on military gravesites. The Pawlowski family created a similar program to place Christmas wreaths on law enforcement officer gravesites during the holiday season.

"I never expected this program to expand as it has," saidMichelle Pawlowski. "Each year, I am touched to see the honor and reverence with which KSP carries it out. It is truly a privilege to be a small part of that."


Several years ago, Ms. Pawlowski made a social media post about the wreaths in a Facebook group for fallen families. Brenda Tiffany, the mother of fallen KSP Trooper Cameron Ponder, saw it and connected with Pawlowski. Since then, they have worked together to provide Christmas wreaths for every KSP fallen officer. This is the fourth year the agency has received the Christmas wreaths through the national program.

# To Chair Legislative Oversight and Investigations Senator Brandon Storm to continue as **Transportation Committee Vice Chair**

Senate President Robert Stivers and Senate Leadership announced 2023-24 Senate Majority Caucus member committee assignments on Monday. Senator Brandon Storm, R-London, will serve as Senate chair of the Legislative Oversight and Investigations Committee and remain vice chair of the Senate **Transportation Commit**tee. He will also serve as a member of the Economic Development Tourism and Labor Committee, Judiciary Committee, State and Local Government Committee, and Banking and Insurance Committee. "I am pleased with the diversity of thought and professional intellect we have in the Senate Majority Caucus," Senate President Robert Stivers said following committee roster announcements. "We have physicians, lawyers, educators, small businesses owners and more prepared to stay the course of good policy this chamber has prioritized and championed for two decades. I have the utmost faith in our chamber's committee leadership."

Senate Transportation Committee vice-chair since 2021.

"I am honored to have been reappointed as vice-chair of the transportation committee for the 2023 and 2024 sessions. Topics related to the roads and transportation infrastructure are some of the most consequential that the legislature addresses for the good of the commonwealth," said Storm. "I look forward to continuing to work with Senator Jimmy Higdon, contributing my perspective to the committee, and making the transportation systems in Kentucky safer and more efficient for our residents." Legislative matters relating to the construction and maintenance of the state highway system, the Transportation Cabinet, state aid for local roads and streets, the state police, airports, driver's licensing, training and motor vehicles sales, and much more must go through the Senate Transportation Committee. The committee's significance cannot be understated. The 2023-24 state road plan passed the House and Senate Transportation committee last session,

allocating nearly \$2.93 billion over the next two years, providing \$371 million for rehabilitation and [construction of bridges and \$250 million for a federal match for potential mega projects such as the Brent Spence Bridge, widening of the Mountain Parkway, and the Interstate 69 Ohio River crossing project.

Storm has also been newly appointed as the Senate chair of the joint Legislative Oversight and Investigations Coma di **M**alak mittee. "The Legislative Oversight and Investigations Committee is incredibly important, as it monitors the efficiency and security of the state government as a whole," Storm said. "I am once again honored that Senate leadership has entrusted me with chairing this committee for the Senate, and I will lend my legal and investigative expertise to the discussions to the best of my ability. " The Legislative Oversight and Investigations Committee is a 16-member joint committee serving as the main investigative body within the General Assembly. It has the authority to investigate the subjects within the committee's legislative jurisdiction and within the jurisdiction of other standing or statutory committees of the General Assembly. With discretionary power to review the operations of state agencies and programs, the committee can determine whether funds are being spent for the purposes for which they were appropriated, evaluate the efficiency of program operations, and evaluate the impact of state government reorganizations. Standing committee assignments are not final until the Senate Committee on Committees makes a formal vote. The Committee on Committees membership comprises both Senate majority and minority caucus members. Committee appointments are subject to change.


