Local man killed in Berea car crash

Austin Stewart, 21, of Rockcastle County was killed in a single vehicle accident Sunday around 2 p.m.

Kentucky State Police Trooper Adam Hensley led the investigation Wednesday morning after a 17-month old boy was hit and killed by a driver on Old State Road in northern Rockcastle County. The driver of the vehicle, whose name has not been released, told authorities that they felt the thud as they were headed east and thought they had run over an animal. However, the driver turned around and returned to the scene to find the body of the child lying near the center of the road. Police at the scene say it is suspected that the child appeared from the shadows and onto the roadway. The coroner pronounced the child dead at the scene. Officials say there is no alcohol or drug suspected in the accident and the driver of the vehicle is cooperating fully with investigators.

Want to get even with all those people who have been forcing you to take bags and baskets full of summer squash and cucumbers off their hands over the last couple of weeks and will continue to do so until mid August?

If so, then get up early one morning this week and plant some yourself so you can "pay them back" in early October. And I can practically guarantee that they will be more appreciative of your gift than you were of theirs because, most likely, you'll be the only person in your neighborhood with a good supply of fresh veggies.

I realize that, almost every year, around the end of July or early August I devote a column to touting fall gardening. I also realize that the column falls mostly on deaf ears because most of my close friends and relatives have already stored their tillers and gardening tools in their sheds or garages and they won't be using them again until April or May of 2018.

But just last week a friend called to check on me and asked what I was doing and I told him I was getting ready to take a shower because I was wet with sweat after planting a couple rows of corn and beans.

Dead silence for about 10 seconds as the caller let my news sink in.

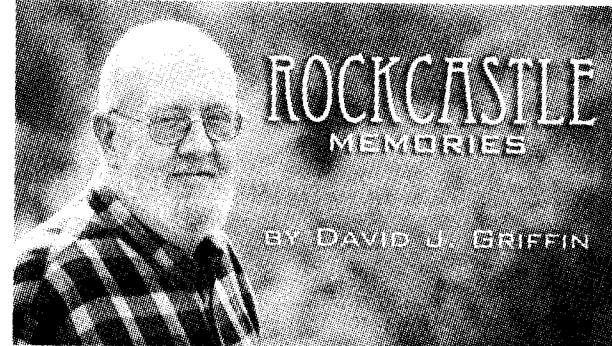
"You said 'planting' sweet corn but you meant picking, didn't you," he asked, while trying not to laugh at what he probably thought was a Parkinson's slip-up?

"Nope. You heard right," I told him. "Right now's the

time to be planting corn and beans if you want them to make anything before frost." I told him, knowing full well that his head was shaking.

I have planted Bodacious sweet corn as late as August 14 and had marvelous results but only because we didn't get a frost that year until mid-October. I don't know about other varieties but Bodacious grows much faster when it's planted this

My Mother's Bible

My mother (Bee) went home to be with the Lord on October 13, 2002, at the age of ninety-one. For several years, toward the end of her life, she had been living with my brother, Al, and my sister-in-law, Eva. Bee lived upstairs in an area where she had her own bedroom, a sitting area, a small kitchen, and a private bathroom. She seemed quite comfortable there and enjoyed the daily fellowship with her family.

For some time, she was able to entertain personal friends as well as family from out of town.

Following her death, when the family went through her belongings, I found a large-print Bible that my wife and I had presented to her at Christmas in 1995. (We also found information indicating that she had read the Bible from cover to cover at least twenty-three times during her lifetime.) I never knew anyone who loved reading the Bible more than Bee.

Her Bible is filled with notes written in the margins of the pages. For example, on the title page, she had written, "He keeps me in safety (Psalms 4:8)."

I will both lay me down in peace, and sleep: for thou,

Lord, only makest me dwell in safety.

That particular verse was exactly how she felt about her relationship with her Lord. Not only did she feel that way personally, she made sure that she taught me those valuable convictions when I was a child.

My dear mother also loved to purchase Bibles for her loved ones. In 1992, she bought me a new Bible, inscribing it on the first page: From Bee, in honor of your grandparents, Eugene and Katie Stokes. She had written these words at the bottom of the page.

Wisdom is knowing what to do

Skill is knowing how to do it

Virtue is doing it well.

(Read Psalms 121)
Bee loved that Kathy and I lived on a mountain top in eastern Kentucky -- much like the location of our family's old home in Rockcastle County. Knowing that my wife felt much the

To a Faded Rose of Long Ago

Dear Journal, I've often heard it said that in the flower family, there is none that compares to the beauty of a rose. It is the flower given to Miss America, worn as a garland around the Kentucky Derby winner, is the choice of some brides-to-be to carry down the aisle, and are given on Valentine's Day. Over the years, the rose has endeared itself to many around the world.

Back in the mid-1940s, about 1944 or 1945, my maternal grandparents, the Nortons, finally came to settle just west of London in Laurel County. They had moved about three or four times in Tennessee and Kentucky after marrying in 1919, but this was their hope until they died and had raised a few generations

there. As it was her custom, my great-grandmother Vestie Otey-Price, being a widow, came to visit my grandma Evelyn Norton and stay for

a few weeks. On one visit, she brought a rose bush for Grandma to plant in the yard. I don't know if she had bought it or if it was a "start" from her yard. If I had to guess, it was one she had in her own yard back home in Tennessee.

Anyway, the rose was planted in my Grandma's back yard. It was said to be a Doctor Kildare rose. It had the most delicate pink center fading into a lovely shade of ivory petals. One or the other in the family had gotten starts from it over the years and those starts grew adorning their yards with the original rose bush being gone for many years now. It was evidently a very old and rare rose type as all of the starts in the family have died and we are looking for one like it to plant, but unable to find. It was a sad day indeed when all of the roses were gone.

Two springs ago in 2016, I found a rose at Lowe's that looked amazingly like Grandma's Doctor Kildare.

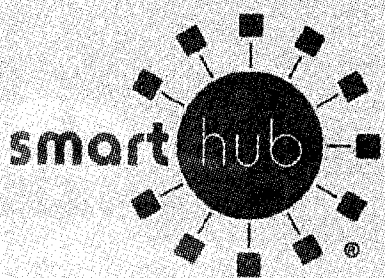

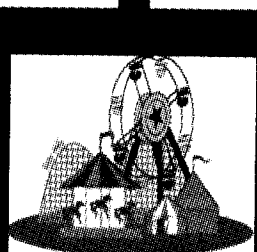

late than it does in spring planting. Spring planting will not mature for at least 75 days. A fall crop will

mature in 65 to 70 days after planting because it germinates more quickly and, for whatever reason, it grows faster in August than it does in June. I'm nearly sure that heat and humidity play a role.

The two rows of corn I was telling my friend about are already up and nearly ready to hoe after only 6 days. I'm guessing it's about 10 days, growth-wise, ahead of the same variety's time frame when I planted it in May. Ditto for the Big John and Babe Campbell beans I planted with it. I actually have more confidence in both, right now, than I did in my spring planting. I intend to plant another row on August 1 because I've been doing that for over 20 years and only one time has it failed to mature before frost got it.

Admittedly, the devil is in the details when it comes to fall gardening. If, for example, you decide to run out right now and plant a row of sweet corn make sure you soak the furrow with water as soon as you finish covering the seed. Soak bean, squash, cucumber and pea seeds overnight before you plant them. And make sure the ground is soaked well as soon as you finish planting. Try to always plant just before dark and not in the morning.

I will wait until mid August to plant a row or two of Oregon Sugar Pod II snow peas. I've been told, all my life, that fall peas won't grow in KY. The aforementioned variety may not always perform as well in autumn as it does in spring but I've had enough success over the last 30 years to feel like it's worth way more than the time and effort. And it doesn't take much effort after you finish planting because fall gardens are virtually weed-free.

Fall vegetables are far better, in my opinion, than the ones most of us are harvesting right now because they are much more crispy/crunchy and their taste is more intense. Tomatoes may be an exception to that general rule because it's arguably impossible to beat the taste of that first homegrown Molly Helton Sunburst or Giant Syrian picked in July.

In the meantime, if The Good Lord's willing and I don't get rained out I expect to be planting something every day up to and including Labor Day.

While I was in the process of writing this column, I turned her Bible to that particular passage and found it to be underlined.

Bee was a "prayer warrior." And I can testify that she was good at it, because I have no doubt that she prayed me out of many unhappy circumstances when I was a young man. But, you see, she was a warrior who was well-prepared for battle. She knew the Word of the Lord intimately, and it enabled her to rely upon it. Bee's bible tells her own story.

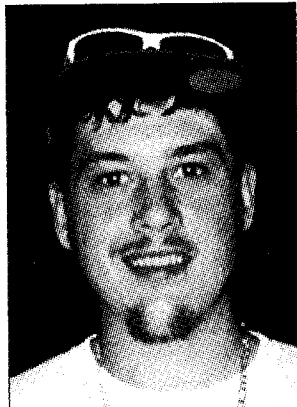

not raise the rates on our customers and use their huge resources for our customers.”

Barron said the company has paid on the debt for building the water system for 20 years and is unable to maintain operations unless something is changed. “We had tried to sell to several other water companies but no one was interested until American Water came along. This will be a wonderful thing for our customers and service will be so much better for everyone involved. If we have a line break, or some other problem with service, we just have one man who has to take care of everything and it’s impossible for one man to keep up with the issues that arise at such a company. I take my truck and go help when ever I can. But it’s just two of us searching for a leak and attempting to repair it with no equipment and we simply can’t keep up.”

Barron said Eastern Water is a non-profit company but Kentucky American Water is a for profit organization. “I don’t know how they are going to make any money but they have offered to do this and it will be a big help to our customers.”

Barron said the new company has the equipment and manpower to find a water leak and repair it much faster as well as bring the current system up to date and improve the existing infrastructure to better serve all customers.

Part of the deal with the new company is to retain the current employees. “We have really dedicated people here whose goal is nothing more than serving people.”

Barron said the fiscal court has been very supportive and helped throughout the process.

Judge Bishop said the takeover will solve many problems with the current company and he and Congressman Hal Rogers worked very hard to make this takeover happen. “The company still owes \$770,000 in debt service and, serving a little over 600 customers, it’s too hard to dissolve that debt.”

Bishop said he and the fiscal court have been searching for a solution for a very long time and he is excited about the takeover. “We offered the company to many other companies but no one was interested. We had to do something. Eastern doesn’t have the resources they need. It was just last Christmas that many customers went 17 days without water and that is simply unacceptable. Kentucky American Water is a much bigger company and has operations in many other states as well. They have been in business for 125 years and will greatly improve the service and quality of water to the people of Eastern Rockcastle County.”

According to Barron, the takeover should be completed before winter but the board must vote to approve the deal before it is official. Ballots have been mailed to all board members and all it takes is a simple majority to approve the sale.

“I feel very confident that once everyone under-

stands how Kentucky American Water can help our customers and resolve our debt, the board members will vote to approve the deal,” said Barron.

The current board will dissolve and operations will be handled by the Kentucky American Water Association.

“I’m a customer too,” said Barron. “If we had not made this move, there would have to be a significant rate increase and we just can’t do that to our customers.”

Bishop agreed that the move was inevitable. “We needed upgrades that Kentucky American Water can do that and they have agreed that rates will not go up and could possibly go down a little. Once this is done, customers will see a greatly improved water service and that’s what we all want.”

based on information from surveys taken between July 2015 and June 2016. The survey, known as the Hospital Consumer Assessment of Healthcare Providers and Systems Survey (HCAHPS), collects feedback from patients after their stay in the hospital.

“We have been using feedback from the HCAHPS surveys since 2006,” said Tammy Brock, RN, MSN, CPHRM, director of quality and patient safety at Rockcastle Regional. “This information helps us identify areas where we excel so we can further enhance that high level of service. If it reflects an aspect of care that needs development, we implement a change process to improve it.”

In Kentucky, Rockcastle Regional is the only five-star rated hospital. Forty-five percent of hospitals in the state received four stars, while another forty-five percent received three stars. Eight percent of hospitals received a two-star rating and there were no facilities rated one star.

Of the 3,436 hospitals included in the rating nationally, only five percent received a five-star rating. About a third of hospitals received a four-star rating. Forty-three percent received a three-star rating, while 16 percent received two stars, and two percent received one star.

Rockcastle Regional Hospital and Respiratory Care Center is a not-for-profit community healthcare system that operates an emergency department, a 20-bed acute care hospital, outpatient services, a 127-bed long-term care program for residents dependent upon mechanical ventilation and three rural health clinics.

Rockcastle Regional Hospital was established in 1956 and is accredited by the Joint Commission. currently underway in the city hall building. It was agreed that the police department administrative offices will be located in the renovated structure as well as a chamber for council meetings and other business.

David Bales, Chief of the Mount Vernon Fire Department informed the council that the department made 24 runs in June using 4,100 gallons of water.

The runs included two structure fires, three vehicle fires, one vegetation fire, three controlled burns, nine vehicle accidents one rescue and four service calls.

The department also performed mutual aid calls.

Chief of Police Brian Carter informed the council that the department made 458 calls for service in the month of June.

Among the calls were 30 for non-injury accidents and seven for injury accidents. There were 49 total arrests in the city in June with 15 drug charges and 26 traffic violations. The department served 40 warrants and four grand jury indictments.

The All American Club, headed by councilman Wayne Bullock, reported picking up 35 large trash bags filled with trash from around the city.

Eighteen of those bags came from trash around MVES after some recent flooding.

Two bags were from Davis Street, five bags from Spring Hill, one bag from US 25, four bags from Paul Street, two bags from Renfro Valley, one bag from Comp Care Road, and from the wooded area behind Snack Shack, workers found old clothes, some trash and a used needle.

Club workers also removed two yard sale signs and picked up two more bags around the MVES ditch line.

Bullock informed the council that yard sale signs are “a mess again.” Though it has not been discussed by councilmembers as a subject on the agenda, a penalty

ating the curve, and hit a large tree so hard that the impact caused the vehicle to flip onto its side.

The roads were dry and no gravel or other debris was in the road at the time of the accident but Cornelison said the car was so damaged that the extrication of the driver took an unusually long time.

“I don’t know the driver’s name but he suffered life threatening injuries so extensive that he was flown to the UK Medical Center and that is very unusual for us in Madison County,” said Cornelison. “We can usually handle most anything in our county but these were very extensive injuries and the extrication was very complex.”

The Madison County Sheriff’s office, Madison County EMS, Berea Fire and Rescue and other local agencies responded to the scene according to Cornelison.

we find new ways to stop it.”

The Rockcastle County Detentions Center has a low rate of contraband, compared to most county jails, but McClure’s staff still continues to find drugs on prisoners or in a cell very often.

“It’s a continuing fight. Almost everyday we find some kind of drug inside our center. We confiscate it immediately and find out how it got in and then we can implement strategies to stop that too,” he said.

In fact, the local jail has many preventative measures in place to keep drugs and other contraband out of the jail.

“Every prisoner brought to the jail is stripped, showered and searched and their clothes are searched as they shower,” said McClure.

But after that, McClure and his staff are not through.

“We also do constant random cell searches and prisoner searches. We also bring in our local drug sniffing dog and set him loose in here. We also have absolutely no physical contact between prisoners and anyone visiting them. We also are trying to get the state drug force team to come here. They are trained and specialize in searching for drugs throughout the facility. They even search under floors and over ceilings and between walls and every part of the building.”

Still, McClure is not finished. “If we have the slightest suspicion or have received some kind of tip, which happens a lot, and we can’t find anything on them, we take the prisoner to the local hospital and have an x-ray performed to make sure there is nothing inside them.”

According to McClure, the most popular way that drugs are smuggled into the building is that a new prisoner, that is not suspected to be involved with drugs, sometimes tapes up drugs into a ball and then inserts it into their anus. Then once in the cell, they pass the drugs and use them inside the cell.

According to McClure, some females with large breasts, tape drugs under their breasts and they are not found in the search.

McClure and his staff are working on ways to put a stop to this method of entry as well but currently, he said, the only way to do that is to x-ray every prisoner which may be cost prohibitive.

“You wouldn’t believe what we find inside people’s anus when we x-ray them. I can’t even talk about some of the stuff we find,” he said.

McClure said part of the local jail’s success in keeping inside drugs to a minimum is the hard work and dedication of his staff. He also said the support of the fiscal court has been a help with his staff and the center’s ability to fight the problem.

“As long as there are drug addicts, there will be people finding ways to sneak drugs into jails. But as long as there are staffs like mine, there will be people fighting it and putting a stop to it,” said McClure.

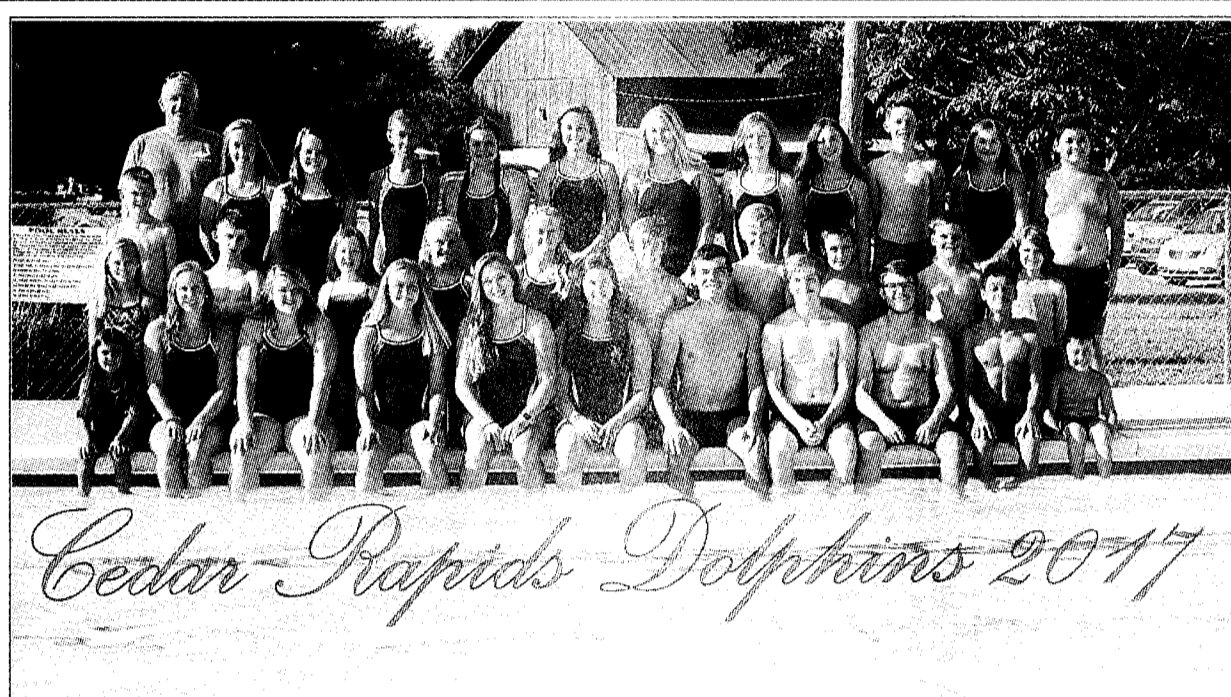



Drug problem still growing in county

Though the sheriff's department, county attorney's office and the Mount Vernon Police Department have greatly increased their attack on the drug problem in Rockcastle County, officials at all three agencies say the problem is still growing.

"I would estimate that 85% of every arrest made in the county is somehow related to drugs," said Assistant County Attorney William Leger. "Some say it is over 90% and I couldn't say they are inaccurate."

Though one of the largest meth dealer busts in the state was made this year by the Mount Vernon Police Department, more and more drug users and drug dealers are in our county every month, according to Leger. "Our attack on the problem is making a difference I'm sure," said Leger. "But we are a long way from solving the problem. It's growing at an alarming rate."

Leger said Rockcastle is not alone. "It's all over the nation and our surrounding counties face the same problem we do."

Leger said there are some measures that agencies could take, including a theory called "Time Displacement," but, in his opinion, this still does not solve the issues.

"The Theory of Time Displacement is a plan that is very tough on drug arrests. But all it does is move the users and the dealers to the surrounding counties," he said. "It really doesn't stop anything. It simply makes our problems, other people's problems."

Sheriff Mike Peters said he believes that if the arrests were traced back far enough, drugs would be related in well over 90% of the arrests in the county.

"85% to 90% of the people in jail now are there because of a drug related crime," said Peters. "But if you trace it back, even the thefts and domestic cases would be somehow related to drugs. The arrest record just shows theft but if you trace it back, they were stealing something in order to get money to buy drugs. And many reports will say simply 'domestic violence' but in truth, it was a fight over a drug deal."

Peters and his deputies are frustrated with the growth of the drug culture in

the county and the nation. "Remember the 'War on Drugs' that started back in the 70s? Well, we lost."

Peters says the calls his office receives are almost always somehow drug-related. "What we are doing is not working at all," he said. Some say incarceration is the answer and some say treatment. But the truth is, treatment will only work if they want to quit. You can lead a horse to water but you can't make him drink."

Peters says there is only one way to help the problem. "It's really out of our hands. It's up to the legislature to actually give drug dealers and users real punishment instead of a slap on the wrist and let them go." The only way to stop it is to make the punishment so bad that people are afraid to do it. A couple days in jail is not a deterrent."

Peters said there is so much money involved in the fight against drugs that he wonders if the federal government is serious about the effort. "Over \$20 million in the budget to fight drugs and nothing gets done. I sometimes wonder if they don't want to keep that money in the budget."

Peters also said the new drugs are much different than those available when the war on drug began.

"This meth and flakka and bath salts make people crazy. Brian (MVPD Brian Carter) will tell you it took three or four men to get a guy down last week. This new stuff makes a person crazy and they don't feel pain. I'm not too worried about a guy sitting there smoking a joint (marijuana) because they are calm and usually don't cause any trouble. But these people on these new drugs are completely unpredictable."

"It used to be that if you broke the law, you got punished," said Peters. "These days it's against human rights to punish criminals."

Local officials all seem to agree that the many arrests in the county are not keeping the drug problem from growing, they are simply slowing the growth. But, Peters and Leger agree that authorities can't stop the fight. "We aren't stopping the growth of drugs in our community. But we have to do something and we have to keep trying," the sheriff said.

Police ask that if anyone sees suspicious activity, call 911 and inform authorities.

Rockcastle County Highway Department employees are finding drug paraphernalia throughout the county.

Just this week, while mowing alongside the Scaffold Cane Road in Rockcastle County, many used needles and other drug paraphernalia were found.

The items were taken to Rockcastle County Jailer Carlos McClure who turned them over to Rockcastle County Sheriff Mike Peters for proper disposal.

Sheriff Peters said no one should ever touch a needle found along a

roadside. "Without proper protection and precautions the chance of getting stuck and infected, or worse, is very high if anyone handles these discarded items."

Peters asks that anyone who may dispose of needles, use a "Sharps" container so that the needle cannot stick anyone.

Peters also asks that all parents teach their children not to handle or touch a needle found along a roadside. "One tiny accidental stick from these discarded needles could potentially be fatal," he said.
