Single car crash



Along with several forest fire calls, local fire departments have responded to several vehicle crashes including this single car crash last week on Highway 70 at milepoint 0 at the Pulaski County Line. Western Rockcastle Fire Department personnel, assisted by the Brodhead Fire Department, were forced to brace the vehicle while rescue workers extricated the victim who was trapped the car. Crews closed the roadway and created a landing zone for the PHI Medical Helicopter. Rockcastle EMS crews transported the victim to the Rockcastle Regional Hospital. The cause of the accident has not been determined. The road was closed again later for accident reconstruction but reopened shortly after.

Forest Fires

Outdoor fires abound in county

departments across Rockcastle County have been dealing with several forest, grass and brush fires over the past two weeks. According to officials at several departments, the recent high winds caused outdoor fires to easily escape burn areas and move into brush or forest areas.

The Mount Vernon Fire Department battled a 10-acre fire while the



Brodhead Fire Department and Western Rockcastle Fire Department were called to outdoor fires at the same time this past weekend.

Officials at each department agree that the recent outdoor fires have been accidental and most have been caused when controlled burns escaped the burn area due to high winds.

'Unfortunately, this is nothing new," said Brodhead Fire Chief John

Dyehouse. 'We have this problem every ear. People need to stop violatthe burn ban

rules and regulations."

According to Dyehouse, the Kentucky Division of Forestry can impose hefty fines upon anyone who causes damage from a fire that gets out of control due to negligence. Disobeying any burn ban regulations, is considered negligence, according to Dyehouse. "I would strongly encourage

Anthony Dattilo, 32, of Livingston, faces six charges including promoting contraband and possession of methamphetamine, after his arrest Sunday March

According to the Uniform Citation, Livingston Police Chief Mikie Ashurst heard

Upon approaching Dattilo, the citation says the officer noticed Dattilo carrying a large stick and two long hunting knives around his chest.

When Ashurst ordered Dattilo to show his hands and get on the ground, Dattilo reportedly responded "Why are you pointing a gun at me?" the report said.

According to Ashurst, the officer had to physically restrain Dattilo and transport him to the Rockcastle County Detention Center, where he was charged with disorderly conduct, resisting arrest and menacing.

Staff at the jail located a plastic baggie with a white crystal substance believed to be meth and an orange pill in Dittilo's mouth believed to be

Suboxone. Chief Ashurst returned to the jail and collected the evidence and added the charges of promoting contraband, possession of meth and possession of a controlled substance.

Dattilo is being held on a \$5,000 cash or property bond.

What I didn't know was there was another mile marker coming up


that would make 40 feel like I had only pricked my finger.

Zippo Recollections

This past week, I was looking for something in my office desk and came across my cache of souvenir Zippo lighters. Over the years, I acquired several Zippos, and I cherish each of them.

I began smoking Lucky Strikes when I was fifteen-years-old and continued to smoke until I reached my 40th birthday. Some of my memories from that time involve Zippo lighters.

One weekend in 1962, while I was attending the University of Kentucky, I noticed a rash on my leg just under my right pocket. I self-medicated the red area for several days with no improvement. Finally, I decided to check with our family physician, Dr. Griffith, while on a weekend visit with my mother.

On Saturday morning I drove down to his office and patiently awaited my turn to be seen. Finally, I was told to go into his examination room and wait for the doctor. When he came in, he asked, "David Joe, what is wrong with you today?" I explained and showed him the rash.

After carefully examining my leg, he asked, "Do you smoke?" I was puzzled with his question but answered yes. He followed up with "And do you carry a lighter?" Again, I replied, yes. Now I was totally confused with his questioning.

He then enlightened me by saying, "If you will quit filling your lighter so full, your rash will disappear." He was right; the rash was a result of the lighter fuel and, just as he said, it went away in a few days.

Over the years, many people have given me Zippo lighters for various occasions, and I have loved everyone. One outstanding feature of the lighter is its guarantee. Since the first lighter was made in 1932, the company has had a policy that it will repair any model ever sold. The idea was the "brainchild" of George Blaisdell, who originated the company. He said, "I want our lighters to have a free, lifetime warranty." The concept began with the first Zippo and has remained the same to the present day. Zippo repairs all types of defects without charging a cent.

For most of my teenage years and throughout my adult life, I had a Zippo in my pocket. I even developed the trick of opening my lighter and producing a flame


Coming Out of Hibernation Dear Journal,

- NEVER attempt to move a downed power line or anything in contact with it using an object such as a broom or stick.
- Don't step in water near downed power lines.
- Never drive over a downed power line.
- If your vehicle comes in contact with a downed power line while you're in the vehicle - stay inside the car. Call 911 - but tell those rendering aid to stay away from the vehicle.
- If you must exit the vehicle for life-threatening reasons jump out and away from it, making sure to land with your feet together and touching - then shuffle away with your feet touching until you are at least 40 feet from the vehicle.

to have a stelllar basketball career at Marshall University) and her teammates in the mid 1990s, the Lady Rockets became a threat in the 49th District and 13th Region.

The 1996-1997 Lady Rocket team was the first to break through the post season barrier, finishing as runner-ups in the district tournament and advancing into the 13th Region Tournament for the first time under Coach Noble. Just making the regional tournament was a huge accomplishment, but the Lady Rockets went on to not only win the first two games of the tournament at Bell County High School, but captured the school's first ever 13th Region Girls Basketball championship and move onto the KHSAA Girls Sweet Sixteen Tournament in Frankfort.

The school's first trip to the Sweet Sixteen in 1997 would be a huge accomplishment in its self, but from 1997-2011 the Lady Rockets, under Coach Nobles tutelage, would go on to capture seven Regional championships, three of those (1997, 2004, and 2005) happened in the 13th Region. Her 2005 Lady Rockets had three Kentucky All-State players. Johnna Abney (Middle Tennessee and University of The Cumberlands), Tara Rowe (had several D1 scholarship offers) and Heather Hammond (All Sunbelt Track and Field athlete at Western Kentucky). After winning a major tournament in Georgia the 2005 team would be the first Rockcastle team to be nationally ranked, #24 in a National high school poll. The other four (2006, 2008, 2010, and 2011) took place in the 12th Region, following the KHSAA realignment in 2005 that moved all the Rocket sports programs from the 13th back to the

12th Region.

The first five trips to the KHSAA Sweet Sixteen ended with first round losses to Assumption, Christian County, Lexington Catholic, Letcher Central, and Ohio County. Then in 2010, the Lady Rockets captured the 12th Region and advanced again to the Sweet Sixteen at Western

Kentucky University in Bowling Green. There they would win the school's first ever state tournament game defeating Murray, then George Rogers Clark in quarterfinals before falling in the semifinal game to Scott County. The Lady Rocket team was led in 2010 by Jackie Alexander, who went on to attend and play basketball at Westpoint (United States Military Academy)before transferring and ending her stellar career at The University of

Cumberlands.

The trip to the 2010

would serve to set the

stage for the best season ever in Lady Rocket Basketball program history, at least up until this point in time. After going 27-1 and undefeated in the state of Kentucky during the 2010-2011 regular season, (the only loss to perennial power Mt Juliet in Tennessee)the Lady Rockets would go on to capture the 49th District Tournament, the 12th Region Tournament, and advance on to the 2012 Sweet Sixteen in Bowling Green. Their first two games in the Sweet Sixteen were against two opponents from their regular season schedule, Madison Central and Clay County. After a close call (55-52) against Madison Central in the opening game, the Lady Rockets went on to defeat Clay County (47-30). Their next opponent, Calloway County saw the Rockets capture the semifinal contest, 57-38. That win set up the school's first ever appearance in the State Championship where they would face Louisville's DuPont Manual. Manual was ranked #1 and Rockcastle #2 in the season's final poll. The game was a back and forth affair, eventually leading to an overtime period. During that overtime period, Lady Rocket Angie Lawrence hit the game winning bucket with 00:5 seconds remaining. Manual's heave at the end of the game fell short, giving the Lady Rockets the KHSAA State Championship and an overall 36-1 record. The team that season was lead by a tremendous group of seniors, Kristen Abney, Ella McQueary, Shanlee Burton, Angie Lawrence, Sydney Arvin, and Sara Hammond, and a super Sophomore, Michaela Hunter (stellar career at EKU, once scoring 40 points in a game). Hammond was selected as the Tournament's MVP, Kentucky's Miss Basketball, Kentucky's first ever girls

McDonald's All Ameri-

can, a Parade All-Ameri-

can and went on to star

at the University of Louisville for her next four years.

Coach Noble has had other great teams that fell just short of the sweet 16. The 2009 team that lost in the 12th Regional semifinals was ranked the #1 in Kentucky for part of the season (led by University of Kentucky walk-on Sara Rowe) and most recently the 2020 team lost a heartbreaker in the Regional final. A season that ended with the sweet 16 being canceled due to COVID.

Coach Noble received the Kentucky Basketball Coach of the Year twice during her a career, was selected as the 2005 coach of the Kentucky Allstars, and was placed in the Kentucky High School Basketball Coaches Court of Honor in 2017. She was also selected as the KABC Regional Coach of the Year four times during her career. She is currently #7 in wins all time in Kentucky girls basketball and is close to reaching 600 wins. In 32 years at the Rock, 590-352 overall, 6-6 in State Tournament

play
Coach Noble will retire from teaching this summer. Her plans at this time are to continue to do what she loves best-coaching the Lady Rockets Basketball team.

"Thank you Ms.Roxanne. It is me who has been truly blessed by all my girls! I am so proud of the women they have become! It is all about the girls! I sure appreciate everyone's support."





paper (needs to be bagged), books, phone books (paper products cannot be plastic lined or coated), cardboard (both corrugated and slick), plastics #1 Pet or Pete, plastics #2 HDPE, (no sheet plastics or plastic bags of any kind; no buckets or totes, no matter what number is on it), metal cans, aerosol cans, aluminum cans, aluminum foil, aluminum pie plates, glass bottles and glass jars (lids must be removed and discarded), old cell phones, car batteries, empty printer and toner cartridges, old computers (no monitors of any kind) and computer accessories, telephones, radios, digital clocks, (no televisions of any kind), rechargeable batteries (if the battery says rechargeable on it, then it is recyclable), and large bulky metal items.

Clean used motor oil may also be dropped off at the Rockcastle County Road Department.

for the first time in over 12 months.

Many are beginning to ask if COVID is finally going away. However, according to health officials throughout the state. the answer is "No, Definitely not." But, many agree, the situation is greatly improved since the pandemic reached the area in early 2020.

"COVID-19 never be completely gone," said Jana Bray, Rockcastle Regional Director of Community Relations. "But it is certainly much better now than it has been in a very long time. Hospital patients with COVID are greatly reduced and continue to decrease. Things are looking much better now"

Bray wishes to remind citizens that part of the reasons for the decreases in COVID-19, may be the number of people doing their part to help. "We can continue this decline by following CDC guidelines and taking advantage of the tools we didn't have when the pandemic began," she said. "We expect vaccines and boosters and even masks when appropriate, will help keep the numbers down and continue this decline

in COVID cases." Bray also said everyone should pay close attention to their general health. "Everyone should maintain general good health practices just in case they catch COVID," she said. "This will help them fight off any symptoms that may appear."

But in general, COVID is not the concern that it has been. "I can say without hesitation, As for positive COVID cases, and severity of those cases, things are much better right now than they have been in many months," said Bray. "As long as we stay on top of this and don't throw caution to the wind, we may be over the hard part now."

The Cumberland Valley District Health Department report shows Rockcastle still in the Red Zone by 1.5 points (26.5) in a press release Tuesday.


From the free throw line, the Rockets hit eight of 13 and Lincoln canned 13 of 22.

Rockcastle ended with a 20-12 record and a 47th District Tournament runner-up.








Drew Hopkins puts on defensive pressure for the Rockets' in their 12th Region Tournament first round loss. Hopkins had 10 points in the loss.





Frankfort Update

By: Josh Bray State Representative Legislators act on pro-life and tax modernization legislation, address access to health care and other issues

We are now over halfway through the 2022 General Assembly and this week there was no slowing down. March 1 was the last day to file new bills, so we were quick to file the rest



of our bills for this session. More than 700 bills have been filed this year, but only a fraction will pass into law. This week,

the House passed key pieces of legislation ranging from an omnibus pro-life bill to tax modernization legislation that would leave an estimated \$1 billion in the pockets of Kentuckians across the state.

Another important event that happened this week was the Supreme Court ruling on HB 454 from the 2018 Regular Session. In an 8-1 decision, the Supreme Court ruled that Kentucky Attorney General Daniel Cameron has the right to continue defending HB 454 against legal challenges. Known as the Human Rights of a Child Act, the measure specifically states that "no person shall intentionally perform or induce or attempt to perform or induce an abortion on a pregnant woman: that will result in the bodily dismemberment, crushing, or human vivisection of the unborn child; and when the probably post-fertilization age of the unborn child is eleven (11) weeks or greater; except in the case of a medical emergency." Members of the pro-life caucus joined Cameron in a press conference on Thursday to deliver

the news. Pro-Life Omnibus Bill: This week was a big week for the pro-life movement in the state of Kentucky. Not only did the Supreme Court uphold HB 454, the House passed HB 3, a prolife omnibus bill. This bill, also known as Humanity in Healthcare, has 5 key components. It addresses abortion on minors, medical/chemical abortions, dignified disposal of fetal remains, public funding, and complications. It requires a medical provider to examine the patient in-person before the woman takes the chemical abortion pill, and physicians must schedule a follow-up ap-

pointment. Doctors must also inform the patient about the side-effects and complications that could arise from the abortion pill. It also calls for the Kentucky Board of Pharmacy to create the Kentucky Abortion-Inducing Drug Certification Program, which would focus on ensuring that physicians who prescribe medication to induce a chemical abortion have proper credentials and a signed contract with another physician who can handle any medical complications that arise. It also includes a requirement that physicians must attempt to contact both parents, if the woman is still a minor, and it raises the standard to acquire judicial bypass. Parents would also have a say in how the remains of an aborted child are handled. Lastly, HB 3 includes language that essentially creates a state version of the Hyde Amendment and would prevent state dollars or federal bypass funds from being

fund abortions. Tax Modernization: This week the House passed an extremely important piece of legislation that would modernize Kentucky's outdated tax laws. HB 8 would reduce the personal income tax from 5% to 4% as of January 1, 2023. While the first decrease is paid for with money we reserved in this year's budget, revenue forecasts show that there is enough growth in our future to sustain this 1% cut, but HB 8 also includes provisions that make it possible to grow revenue in other areas without an increase in any taxes. The bill broadens the tax base to include services like pleasure watercraft docking, transportation services like Uber and Lvft. non-medically essential cosmetic surgeries, and legislative and executive branch lobbying.

Expanding Access to Quality Health Care: HB 525 helps to expand the Community Health Worker program to create a statewide system. Community Health Workers (CHW) are public health workers who help patients navigate health care systems and public health services. They are key healthcare employees, and it is important to expand the CHW program so more people can become certified CHWs. The measure creates a certification for CHWs to standardize care, and it would direct the Department of Medicaid Services to partner with the Kentucky Community and Technical College System to allow CHWs to be certified.

Limiting Charitable Bail Organizations: Maddy's Law honors the life and tragic death of Madelynn Troutt, who died after being hit by a stolen vehicle driven under the influence by an individual who was released from jail after a \$5,000 bond was posted by a charitable organization. HB 313 would limit charitable organizations from providing bond assistance in cases where the bail is set to over \$5,000. It also prohibits charitable bail organizations from providing funds for domestic violence/dating violence cases or when the individual charged is held under a court order. The measure requires photo identification when posting bail or bond on behalf of an organization, and any bond made by these organizations that is forfeited due to the commission of a new offense shall be given to the victim of the new offense. Lastly, it would require charitable bail organizations to make annual reports to the Interim Joint Committee on Judiciary.

Protecting Religious Freedom: During the COVID-19 pandemic, we saw restrictions put in place that stopped people from attending in-person worship services. HB 43 addresses this exact issue stating that in a state of emergency, places of worship will not be deemed unessential. It recognizes that religious freedom is essential to our commonwealth and prevents state and local governments from prohibiting religious services during a state of emergency.

Strengthening the Penalties for Violations of Protective Orders: HB 488 increases the penalty for a second or subsequent violation of an order of protection. It is meant to protect those who are victims of domestic abuse and have a restraining order on their abuser. The first violation would be a Class A misdemeanor and the second or any following violation would be a Class D felony. It also states that any following violations would not have to involve the same person as the first viola-

MVES Celebrates Academic Achievement


On Friday, March 18, Mt. Vernon Elementary held a school-wide program to recognize some of therecent academic accomplishments by the student body.



Chapin payoff may be delayed

Members of the Rockcastle County Industrial Development Authority (RCIDA) entered into closed session after their regular meeting last week to discuss a delay in the Chapin Manufacturing payoff that was expected in March.

According to the minutes of the meeting, members discussed a request from Chapin Manufacturing to possibly delay the planned \$1.8 million payment, after the company announced they would pay the property off over one year early.

The company purchased the property for \$2.6 million last year. Upon the purchase, Chapin paid \$800,000 at closing, according to Judge/Executive Howell Holbrook, Jr. and were scheduled to pay \$900,000 in January of 2022 and another \$900,000 payment in January of 2023 as final payment.


Donations are also accepted at all departments.

However, officials say the company has experienced growth and success while in Mount Vernon and planned to pay the total amount due much earlier than expected. It was announced last month that instead of the two \$900,000 payments over two years, Chapin would pay the entire remaining \$1.8 million in one payment this March.

And according to Holbrook, this may still happen. "They asked for an extension on that payoff just in case it is a little after March before we receive that payment," he said. "They may still pay the property off before the end of March, but the RCIDA agreed to give Jeff (VanHook RCIDA Executive Director) permission to delay that payment for a short while if they need it."

According Holbrook, the possible delay comes as the company is involved in environmental studies, at all their plant locations, which may have interrupted their plan to make the final payment in March. "They just asked that we have this delay request ready just in case they may need it. I doubt they will need it but it is there if Chapin needs to delay that \$1.8 million payoff." Holbrook said no timeline was set on the extension.

Back in open session, the board voted to allow the payment delay if required, according to the minutes.

Lamb charges increased to attempted murder

Donnie Lamb, 57, of Mount Vernon, now faces an attempted murder charge and up to 15 years in prison, according to County Attorney Jeremy Rowe.

According to police reports, Lamb was involved in an altercation on Three Oaks Road where he allegedly shot his neighbor, George Davis. Davis was flown to the University of Kentucky Medical Center where he was treated for non-life threatening injuries. Lamb was transported to the Rockcastle County Detention Center where he was charged with Assault in the first degree and held on a \$25,000 bond.

However, two weeks ago, Assistant County Attorney William Leger made a motion to raise Lamb's bond to \$75,000

during Lamb's arraignment. District Court Judge Scott Lawless granted the motion.

On March 2, County Attorney Jeremy Rowe attended Lamb's Preliminary Hearing, with Trooper Corey Jones testifying, and continued Leger's previous motion to change the charge of Assault to Attempted Murder. Judge Katie Slone granted that motion as well.

Lamb will now face up to 15 years in prison since the charge was raised and will remain on the \$75,000 bond.

Kentucky families feeling the impact of rising costs

January's freezing temperatures, rising natural gas prices and wholesale power costs have all resulted in higher than usual utility bills for families across Kentucky. The average temperature for December 2021 was 47degrees compared to this January's 29-degree average. Daily temperatures did not go above freezing for 22 of the 31 days in January - with six of those days remaining in the single digits. The members' kilowatt-hour usage will be higher in January due to these much colder tempera-

Another factor affecting utility bills is the fuel adjustment clause (FAC) that is passed on from Jackson Energy's wholesale power provider. The FAC is a pass-through cost based upon the price of fuel to generate electricity and this cost fluc-

tuates monthly. Most of 2021, the FAC was a credit on utility bills; however, due to the rising power costs, the FAC was a charge for January 2022 and will likely continue to be a larger line item on members' bills through spring.

spring. The FAC is billed in direct proportion to the amount of electricity consumed and the cost Jackson Energy pays for the fuel (coal or natural gas) to generate that amount of electricity. The FAC is regulated by the Kentucky Public Service Commission, a separate government agency, which regulates all aspects of public utilities. Jackson Energy does not earn a profit on the FAC.

Jackson Energy understands and recognizes the hardship that these factors have on its members. As a not-for-profit cooperative, it is Jackson

Energy's mission to provide safe and reliable service and to keep costs as low as possible.

Jackson Energy encourage its members to reach out to their local Community Action Agency to see if they qualify for LIHEAP's Crisis Component in Kentucky, that is in effect through March 31, 2022, or until funds are depleted. Another option is enrolling in Jackson Energy's Levelized Billing Program - which is a rolling average of their most recent 12 months' usage and varies slightly each month. Members also have the option to track and monitor their daily and monthly usage Jackson through Energy's SmartHub app.




