# Local bicyclist hit by two vehicles on 461

Wreck also closes I-75

One death, and several injuries, were reported over the past week in the county, causing a busy

in Rockcastle County. Two vehicle accidents caused the closure of US-461 and I-75 and special equipment was needed at a structure fire in the past

County Sheriff Shannon Franklin called a "very tragic situation," Wesley Mullins, 49, of Mount Vernon, was killed after his bicycle was struck by an SUV driven by Kent

In what Rockcastle by a car driven by Jenna Rogers, of Stanton last Thursday.

According to the report, Mullins entered US-461 near Highway 150 and was struck by the SUV, which knocked him into the path of the oncoming passenger car. Mullins was transported to Rockcastle Regional Hospital where he was pronounced dead.

The accident is being investigated Rockcastle Sheriff's Deputy Sam Brock using newly acquired accident reconstruction technology. Brock was assisted by other members of the de-

partment as well as the Mount Vernon Police Department, Kentucky State Police, Rockcastle EMS, the Mount Vernon Fire Department and constables from District 2 and District 5.

The accident caused closure of the roadway while the accident scene was cleared and recon-

## Leash Law soon to be updated in Livingston

Holiday event dates set

Members of the Livingston City Commission had some questions about city ordinances during Monday night's regular monthly meeting.

After accepting the minutes and financial statements and setting the times and dates for upcoming holiday events, Commissioner Clyde Carpenter brought up the issue of dangerous dogs in the area. "I am being told about people getting bitten or almost bitten by dogs that are not leashed here in town," he said.

Members of the commission and Mayor Dwane King discussed the issue for several minutes. King said he is familiar with the issue but thus far, when the local animal shelter arrives, "they can't find the dogs," he said. Members of the commission agree the city has a leash law ordinance but they couldn't recall the details of the order since it was apparently established

many years ago. Discussion migrated to an ordinance making it illegal to discharge a firearm inside the city limits so that citizens can protect themselves from a potential dog attack but this too would have been an old ordinance if one exists

at all. Commissioners and City Clerk Amanda Thomas said they were not certain an ordinance exists forbidding the discharging of a fire arm, but most commissioners agreed there is a leash law on the books. Thomas said she will

Voting for the November General mid-term election will begin in 12

Once again this year, many of the changes that started with the COVID pandemic will still be in

effect for all voters beginning on Tuesday, October 25 when the first vote for the 2022 general election may be cast.

Ballots by mail-in voting may be returned to the county clerk's office or dropped in the drop box at the Rockcastle County

Courthouse at the US-25 entrance, on Tuesday, October 25 through November 8. Those needing a mail-in ballot should immediately call 606-256-2831.

On Wednesday, October 26, excused absentee early in-person voting will begin. An ID WILL be required. This method of voting is available only for those who qualify through KRS 117.085. The early in-person voting lasts through November 2 and will be available

In Rockcastle County, this mid-term election provides some important issues for local voters. In fact Brodhead, Livingston and Mount Vernon are all chosing a mayor. At least two of those mayors will be firsttime, new mayors.

In Livingston, the only city where an incumbent mayor can be reelected,

there are three candidates. They are incumbent Dwane King, Donna Durham and Larry Davidson. Also in the city of Livingston, there are seven candidates run-

activities are disappearing. As for me and my family, we were so disappointed in the big US-25 Yard Sale this weekend.







I imagined all of the fancy soirees that were held, the delicious food that was prepared, all of the people who have come and gone from there and all of the good old-time living that had gone on under that roof. The outside was made of stone and was so beautiful. It is a testament of the original builders, inside and out. The floors appeared to be original. We are also experiencing, for only the second time in our country's history (the other time was during WWII), a national debt larger than our gross domestic product (129%).

I sincerely hope the mid-terms will go a long ways in curbing the ram-

pant craziness going on in our country. I'm not sure they will because I'm not sure that this election will be any more honest than the one held in 2020.

I am an admirer of our other Senator Rand Paul. He, I believe, has our best interests at heart and, in my opinion, would make an excellent Presidential candidate, along with Governor Ron DeSantis.

He recently said, and it's true, "The founders never intended for Americans to trust their government. Our entire Constitution was predicated on the notion that government was a necessary evil, to be restrained and minimized as much as possible."

(Continued from front) struction efforts were completed.

Another accident on I-75 the following day caused the closure of the north and southbound lanes for over an hour, after a southbound tractor trailer hit the concrete lane dividers spilling its load of lumber onto the northbound roadway. The debris then caused another tractor trailer headed north to leave the roadway and strike a tree.

Crews closed the interstate at exits 62 and 76 and rerouted traffic onto US-25 to Berea. The clean-up of the roadway caused the closure of all lanes for some time as accident reconstruction technicians investigated the incident.

Several local first responders also assisted in this accident and the lengthy clean-up efforts. including Candino's Towing.

On Friday, October 7, the Brindle Ridge Fire Department was called to a structure fire on Madison View Road in Rockcastle County. But, according to the report, the roadway was blocked by downed trees and utility lines delaying access to the fire.

Once on the scene, officials say the structure was fully engulfed in flames and two residents had escaped the home. However, one resident suffered injuries during the escape and a special rescue basket was crafted to move the citizen through the wooded area to a waiting ambulance.

The Brodhead and Mount Vernon Fire Departments were also on the scene. The cause of the fire is unknown at press time.

First responders with the Brindle Ridge Department also assisted with a brush fire in Garrard County last week.

holding the dog owner responsible for the dog's actions," said King. "Everyone needs to keep their dog put up, especially through trick or treat and other city events. Citizens will be responsible for their dog's actions,"

There was also discussion of four wheelers and dirt bikes "ripping through town" and the commission also agreed to enforce laws concerning those vehicles, especially during the trick or treat and holiday celebration events.

Thomas plans to comb through meeting minutes and older ordinances concerning the use of fourwheelers and dirt bikes, the discharging of firearms, dog owner regulations and the nuisance ordinance so that commissioners may update each of them if needed, she said.

The city set the date for trick or treat for October 31 from 6-8 p.m. (The same as the cities of Mount Vernon and Brodhead). Anyone participating is asked to leave the front porch light on during trick or treat times. Also, the annual Thanksgiving Dinner was set for November 19 from 11 a.m. to 1 p.m. in the school cafeteria. "We will feed the whole city and those who can't make it to the cafeteria, we will take their Thanksgiving dinner to them," said King.

The Christmas Parade is planned for December 17 beginning at 7 p.m. and Santa will be in the school gym with presents for the children attending immediately after the parade. "We have nice presents for the kids and Santa will be there to hand them out," said King. Also, anyone willing to donate new toys or money for any of the events is encouraged to contact city hall in Livingston.

Those planning to attend the Thanksgiving Dinner are encouraged to bring a covered dish and the City of Livingston will furnish hams and the turkeys, according to King. "It is our chance to feed everyone in Livingston a good hot Thanksgiving dinner," he

Commissioners agreed there are about 60 households in the City of Livingston and King said he expects the Thanksgiving Dinner to cost the city about \$500.

In other action, the commissioners approved a resolution relating to the Cumberland Valley Multi-Jurisdictional Multi-Hazard Mitigation Plan. Thomas said the 715-page plan gives FEMA the ability to disburse emergency funds to all participating cities. "Every city has to approve this resolution to be eligible for these emergency monies. According to the resolution, "under the Disaster Mitigation Act of 2000, the United States Federal **Emergency Management** Agency requires that local jurisdictions have in place a FEMA approved Hazard Mitigation Plan as a condition of receipt of certain future federal mitigation funding." The resolution was unanimously approved and the 715-page plan adopted.

The commissioners also heard the monthly water report which indithere 1,180,400 gallons of water purchased but only 910,424 gallons of water sold, leaving 269,976 gallons of water unsold. After considering known leaks, flushing and treatment water used, there are about 215,000 unaccounted for which is an 18.2% loss.

Having no further business the meeting was adjourned. The next regular meeting is scheduled for Monday, November 14 at 6 p.m. in City Hall.

elections, there were 9,408 registered Republican voters. By the 2020 General Election there were 9,928 registered Republican voters, and now, for the 2022 midterm election, there are 10,017 registered Republican voters.

As for registered Democrats, their numbers have fallen each year. In the 2016 General Write-in Election, there were 3,206 registered Democrat voters but by the 2020 general election, there were only 2,105 and now in the 2022 midterm elections, there are only 1,978 registered

Democrats. As for other party affiliation, those numbers too have dropped. In 2016 there were 376 voters registered to other parties but by the 2020 election, there were only 335. For the 2022 elections, there are about 300 other registered voters.

On the Mount Vernon City Council James Bowman, recently appointed to the seat to replace Matt Chaliff after his resignation, Wayne Bullock and Shelly Lewis are running for reelection, leaving two seats not filed for.

In the three Rockcastle County School Board races, all three candidates, Angela Stallsworth Mink, Anna Stevens-Goff and Matt Chaliff, are the incumbents and unchallenged.

In the race for Rockcastle County Magistrates, all five candidates are running unopposed. In District One, Lee Adams (R) is the only candidate and he will replace incumbent Shannon Bishop, who chose not to run for reelection. In District Two, incumbent William Denny (R) is the only candidate, in District Three, incumbent Doug Prewitt (R) is the only candidate, in District Four, incumbent Wendell Thacker (R) is the only candidate and in District Five, incumbent Michael McGuire (R) is unopposed.

In the races for Rockcastle County Constable, all five district candidates are also running unopposed. They are Rodney Adams (R) in District One, Steve Griffin (R) in District Two. Rick Brummett (R) in District Three, Donnie Cope (R) in District Four and Brian Wynn (R) in District Five.

There are also two Constitutional Amendments on the ballot in November.

Amendment 1 deals with details of the function, time lines and schedules of the Kentucky legislature and Amendment 2 deals with abortion.

In Rockcastle County there are 10,017 registered Republican voters and only 1,978 registered Democrat voters. Of the candidates running for office locally, all are Republican.

Allen said she and her staff have worked hard to prepare for this year's election and she plans to speed up the vote-counting process while maintaining accuracy.

#### **CONSTITUTIONAL AMENDMENT 1**

"Are you in favor of amending the present Constitution of Kentucky to repeal sections 36, 42, and 55 and replace those sections with new sections of the Constitution of Kentucky to allow the General Assembly to meet in regular session for thirty legislative days in odd-numbered years, for sixty legislative days in even-numbered years, and for no more than twelve additional days during any calendar year if convened by a Joint Proclamation of the President of the Senate and the Speaker of the House of Representatives, with no session of the General Assembly to extend beyond December 31; and to provide that any act passed by the General Assembly shall become law on July 1 of the year in which it was passed, or ninety days after passage and signature of the Governor, whichever occurs later, or in cases of emergency when approved by the Governor or when it otherwise becomes law under Section 88 of the Constitution? Proposed New Section

(1) The General Assembly, in odd-numbered years, shall convene in regular session on the first Tuesday following the first Monday in January for the purpose of electing legislative leaders, adopting rules of procedure, organizing committees, and introducing and considering legislation.

(2) No regular session of the General Assembly occurring in odd-numbered years shall continue beyond thirty legislative days.

(3) No bill raising revenue or appropriating funds shall be passed by the General Assembly in a regular session in an odd numbered year unless it shall be agreed upon by three-fifths of all the members elected to each House.

(4) The General Assembly, in even-numbered years, shall convene in regular session on the first Tuesday following the first Monday in January, and no regular session of the General Assembly in even-numbered years shall extend beyond sixty legislative days. (5) Except as otherwise provided in this Constitution, the General Assembly shall establish by general law or joint resolution the date the regular session shall

end. No bill establishing a later date shall be passed by the General Assembly unless it shall be agreed upon by three-fifths of all the members elected to each House. No session of the General Assembly shall extend beyond December 31.

(6) In addition to a regular session, the General Assembly may be convened by Joint Proclamation of the President of the Senate and the Speaker of the House of Representatives for no more than twelve legislative days annually, during which the General Assembly may recess from time to time as it determines necessary. Should a vacancy occur in the office of the President of the Senate or the Speaker of the House of Representatives, the Joint Proclamation for the House with the vacancy may be issued by the Senate President Pro Tempore or the Speaker Pro Tempore of the House of Representatives.

(7) All sessions of the General Assembly shall be held at the seat of government, except in the case of war, insurrection, or pestilence, when it may, by Joint Proclamation of the President of the Senate and the Speaker of the House of Representatives, assemble, for the time being, elsewhere. Should a vacancy occur in the office of the President of the Senate or the Speaker of the House of Representatives, the Joint Proclamation for the House with the vacancy may be issued by the Senate President Pro Tempore or the Speaker Pro Tempore of the House of Representa-

(8) Limitations as to the length of any session of the General Assembly shall not apply to any extraordinary session under Section 80 of this Constitution or in the Senate when sitting as a court of impeachment. (9) A legislative day shall be construed to mean a calendar day, exclusive of Sundays, legal holidays, or any day on which neither House meets.

Proposed New Section

No act, except general appropriation bills, shall become a law until July 1 of the year in which it was passed, or until ninety days after it becomes law under Section 88 of this Constitution, whichever occurs later, except in cases of emergency, when, by the concurrence of a majority of the members elected to

Excused absentee early in-person voters must meet one or more of the requirements of the statute to be eligible for early in-person voting.

For those who do not have a valid excuse to vote early, you may still vote before election day and an ID WILL still be required.

Early in-person voting will be available to all registered voters at the courthouse, regardless of your precinct. Early in-person voting will be Thursday through Saturday, November 3-5. On Thursday, November 3, anyone may vote from 10 a.m. to 6 p.m.. On Friday, November 4, anyone may vote between the hours of 6 a.m. and 2 p.m. On Saturday, November 5, anyone may vote from 8 a.m. to 4 p.m. All early voters must go to the courthouse to vote before Election Day.

On Election Day, Tuesday, November 8, there will be four locations for any registered voter. No voter must go to any specific precinct. All voters may go to any of the four locations to cast their ballot. "Voters in Rockcastle County may use whichever of the four voting location works best for them on Election Day," said Rockcastle County Clerk Danette Ford Allen.

The four locations are the Rockcastle County Courthouse at 205 East Main Street in Mount Vernon, Roundstone Elementary School, 6701 North Wilderness Road,

Brodhead Elementary School at 27 School Street in Brodhead and the Livingston Volunteer Fire Department at 9254 Main Street in Livingston.

In essence, the amendment, if passed, would repeal some sections of the Constitution of Kentucky and replace them with new sections as related in the amendment.

The amendment deals primarily with the General Assembly meeting in odd or even numbered years and what the General Assembly's duties and requirements are in each of the two situations. For example, in odd numbered years. the General Assembly could not pass a bill to raise revenue or appropriate funds and in even numbered years the General Assembly may not hold a regular session beyond sixty days.

Most of the orders in the amendment also provide exceptions by which the new rules simply do not apply but most of the amendment deals with the lengths and times of regular sessions. The complex amendment simply leaves a space for voters to vote "Yes" or "No" to approve the amendment or not.

Amendment Two deals directly with abortion regulations in Kentucky. If passed, the amendment would add a new section to the Kentucky Constitution (26A) to protect human life. The amendment goes on to say "nothing in this Constitution shall be construed to secure or protect a right to abortion or require the funding of abortion."


In essence, voting "yes" on Amendment Two would nullify future campaigns to secure or protect the right to abortion or require the State of Kentucky to pay for abortions.

**CORN PUDDING SOUARES** 

These two dishes are almost a "must" for our family Thanksgiving and Christmas meals. Our whole family loves this. If you want it a little spicy, just add some chopped up jalapeño or green chil-

1 can (15 ounce) whole kernel corn, undrained 1 can (14 ounce) cream style corn

1 cup sour cream 1/2 cup butter or margarine, melted

1 box (8 ounce) Jiffy® cornbread/muffin mix 2 eggs

Preheat oven to 350°. In a large mixing bowl, combine all ingredients; stir just until combined. Pour into greased 9 x 13 baking dish. Bake at 350° for 40 to 45 minutes or until wooden toothpick inserted near the center comes out clean. Cool for 15 minutes on wire racks before cutting. Serve warm.

**MICHIGAN** BROCCOLI CASSEROLE

Will and I introduced this recipe to the family before broccoli was common in the South. The vegetable was served in the dining room at Boone Tavern Hotel in Kentucky where Will and I had both worked while we attended Berea College.

Being students at the time, we couldn't afford to eat there. After Will's graduation from Berea in 1973, we moved to Ann Arbor, Michigan. Because it was always available there, we discovered the wonderful taste of broccoli.

2 packages (10 ounces each) frozen broccoli OR 2 bunches fresh broccoli

1/2 cup mayonnaise or Miracle Whip®

2 eggs, slightly beaten 1 can cream of mushroom soup

1 cup sharp cheddar cheese, shredded

1 stack Ritz® crackers, crushed

1 stick butter

# RCIDA plans to look to the future and be prepared for opportunities

Members of the Rockcastle County Industrial Development Authority (RCIDA) held their regular monthly meeting last week with a short agenda.

Executive Director Jeff VanHook reminded the board that all their efforts must be focused on "selling ourselves, our board, our county and our region to potential site selectors and families who may move to the area."

VanHook said, "There are so many things that we all need to be thinking about every day. One of the biggest subjects is water and sewer capacity in the area. The City of Mount Vernon is working on plans for a new sewer plant but, if all our plans for 30 and 40 years down the road come to fruition, we will have massive needs for more water, sewer, gas, utilities, public services, entertainment and so much more. Every step we take must be looking forward to the long term."

VanHook said the potential exists for a single company to be interested in locating here that would use almost the entire capacity of the current water/sewer plant. "We need to be planning hard concerning water capacity for our area," he said.

VanHook continued to say there are many aspects of economic development that must be considered if the county is going to move into the future successfully. "The highest priority must be on relationships," he said.

"Relationships with businesses, with the State of Kentucky, with elected officials locally and statewide, with surrounding counties, the Department of Transportation, and so many more. We all have to build relationships to be able to get things done as new needs and twists and turns arise. We have to be ready for every possible roadblock and for every opportunity."

VanHook told the board he is continuing his work with Lincoln County in regard to the natural gas pipeline and said construction is expected to begin in early 2023. He said he is working daily on local infrastructure priorities, including the exit 62 and KY-461 widening projects

projects. Discussing local immediate development, VanHook said he is continuing to work on the potential KDPI (Kentucky Product Development Initiative) grant and the application has been submitted. He also reported that the Farmers Market is continuing to grow and develop as the space is currently fully rented for October and November and nearly all of December. VanHook also informed the board of a \$700,000 investment in local business expected soon by the EST Tool company as owners of the company, as well as other local company owners, are expecting growth.

VanHook also addressed questions concerning the progress of the Microfoodery plant, which has not produced the jobs that were promised when the county and the city agreed to provide loans for the company. Owners have postponed a promise to create new jobs for several years as many local officials and citizens have expressed concern about the company's intentions. However, VanHook has defended the company on several occasions saying he "feels confident they are working in good faith" and will eventually provide the jobs that are required that would release funds to the county.

The RCIDA/Fiscal Court and the City of Mount Vernon loaned funds to the company through a grant that required the plant to create 50 jobs within two years in order for the city and the county to keep and use nearly \$1 million, as it is paid back, for other economic development projects. The two year period came and went and the jobs were not created. However, officials were able to receive extensions on the requirement, giving the company more time to create the jobs. But, over a year later, they are still not created. Recently officials are also working on an exception from the state. If approved, only 35 jobs will be required to release the funds to the city and to the county for local use. "We are just waiting on them (Microfoodery owners) to create the 35 jobs so that we can move forward and those funds will be available," said VanHook.

However, this may be a moot discussion since finding workers locally has presented a problem for many local businesses. The Exela Plant, for example, has been searching to fill nearly 400 job openings but have not been able to locate willing employees. Some officials say even if the jobs already existed at the Microfoodery plant, they are not confident 35 workers could be found locally.

VanHook also presented the financial report to the board, showing an ending RCIDA balance of \$1,052,965 on October 1. However, VanHook said \$450,000 of that is already slated for the natural gas project once it begins.

The budget summary shows a September surplus of \$3,398.

The board then entered closed session to discuss contract negotiations.

The next regular monthly meeting is scheduled for Tuesday, November 1 at 8:30 a.m. in the third floor conference room of the courthouse. The public is invited to attend.

from the costume to


operating the candy bowl and handing candy out to others.



Applicants must also bring current Food Stamp

Award letter listing all family members and eligibility qualifications as well as proof of all household income such as pay stubs, SSI, Disability, Child Support, KTAP, etc.

Applicants must also provide proof of all household expenses including a copy of the lease or proof of mortgage, electric bill, gas bill, water bill, cable bill, internet bill, phone bill, car payment, car and health insurance, storage, rent-to-own documents, personal loans and any other monthly expenses.


According to the press release, official paper copies will be accepted only and Social Security cards cannot be used as an ID.




