After an intensive eight-month search, police have captured Woodrow Lamb, 45, of Mount Vernon.

# Stolen car found in local lake

A stolen car was located in Mount Vernon last week, in the waters of Lake Linville, according to Rockcastle County Sheriff Shannon Franklin.

Police received a call about a stolen car in the area and, while investigating the incident, police received a call Thursday that a vehicle had been spotted in the local lake. Police arrived at the scene amid heavy fog to find the stolen vehicle partially submerged. Tracks were found leading off the road into the lake but the water was not deep enough in that area to completely submerge the vehicle.

With the assistance of the Mount Vernon Fire Department, police began a search in the lake for a victim but there was no sign of anyone.


The City of Brodhead Police Department was cut in half this week after Assistant Chief Kirk Mays resigned his post.

Chief Richard Reynolds said the resignation will have an obvious effect on the department since he is now the only Brodhead police officer once again. "It is go-

ing to hurt. There is no doubt," Reynolds said. "But I will continue to patrol the city and we are actively searching for an officer beginning immediately."

Following Mays resignation, Reynolds informed the commissioners during Monday's regular monthly meeting.

A single vehicle apparently left the roadway and rolled over a 300-foot embankment on I-75 last week near mile marker 57 in Rockcastle County. 
Once we resign ourselves to the idea that government knows better than our Creator and that Biblical teachings are "old fashioned" then there is no fixing any-

Glenn Bell opened the first Taco Bell restaurant in Downey, California, that same year. The menu, at that time, consisted of only five items: tacos, frijoles, burritos, tostadas, and chili burgers. Each and every item on the menu was priced at 19 cents.

Then there was Johnny Carson. Carson followed Jack Parr as the host of The Tonight Show. His friend, Ed McMahon makes the TV sidekick a spotlight role.

I continued to follow Johnny throughout my college days and beyond. It was normal for me to sit up late and watch The Tonight Show throughout Johnny's tenure. I thought the show was very entertaining for many years. After Johnny decided to retire, I lost interest in the late-night television show.

There were also some events in 1962 that were world-wide news. First was the Cuban missile crisis. When USSR planned to deploy missiles in Cuba, President Kennedy called its bluff by threatening war if the missiles were not removed. The threat worked.

Also, that year,

Marilyn Monroe was found dead on August 5, after apparently overdosing on sleeping pills.

Finally, I should not fail to mention that an oral polio vaccine was developed by Albert Sabin.







(Continued from front) \$100 on real property. According to City Clerk Amanda Thomas, the city

expects to raise \$14,453 from the property tax and \$2,192 from the personal property for an estimated tax revenue of \$16,645. The rates will remain the same as last year but the city expects more revenue mainly because the Family Dollar store is now part of the tax base and increased property valuation. In 2021, the city received \$11,712 from personal and property taxes,

according to Thomas. The second, and final, reading of the ordinance is expected at the next regular meeting on Monday, October 10

Rockcastle County Judge/Executive Howell Holbrook then presented the commission with the annual county waste water management agreement since the city does not have their own. The agreement was signed.

Mayor Dwane King then gave the floor to Davidson for three minutes as the candidate for Mayor had asked to be placed on the agenda ear-

Davidson began his time challenging Mayor King and candidate mayoral Donna Durham to a public debate. "I think rather than all this Facebook battle back and forth and rumors spreading, we should hold a public debate and let the voters know exactly what we each believe and want for the community," said Daivdson. Durham and King both said they would have to consider the idea and would let Davidson know later. However, after the meeting King said he does not plan to be involved in a debate. Davidson said he plans to hold a Town Hall style meeting for the citizens of Livingston if the candidates refuse the debate challenge.

Davidson continued to ask questions concerning money the city has spent and what those funds were used for. Davidson said he has documentation of money spent for fuel reimbursements and pointed out that over \$400 in fuel was put into King's personal vehicle. Davidson also listed gas reimbursements for City Attorney John Ashurst suggesting the amounts are very high and saying he would like an explanation.

Davidson further questioned the city hiring contractors with no insurance and listed two specific contractors who apparently have no insurance. "If a contractor gets hurt and sues the city are you prepared for that?" he asked. Davidson also suggested city employees have not signed a 1099 tax form and suggested the city may not be paying proper taxes on employ-

City Clerk Amanda Thomas said taxes are included in some of the checks the city has written for payroll. Davidson asked if the police officer is on 1099 status. Commissioner Durham spoke up. "We don't have a police officer," she said. "At least I have never seen one here."

King said that Police Chief, Mikie Ashurst, works 20 hours per week and sets his own hours. Durham asked if any records are kept concerning when Ashurst works. "I'm not going to write down what minute of the day he got here and what minute he left. He comes 20 hours per week," said

King. end

Davidson's questions, there was no direct response and the meeting was adjourned. But before anyone in the room stood, past City Commissioner Katha Carpenter stood and spoke up. "Wait. I want to say, I was a commissioner for 25 years and I have never been embarrassed by my town," she said. "All this fighting and arguing is all that people talk about. We have always had disagreements but they stayed in this room and then out in public we treated each other with respect."

Carpenter continued to say she is concerned about the future of Livingston. "I'm worried. We degrade each other and all these little battles keep going on and on," she said. "The whole county is talking about Livingston. We don't have a policeman here, at least you can't find one, and people are laughing. You are going to have to straighten up and stop all this fighting and do better."

King reiterated that Police Chief Mikie Ashurst works 20 hours per week and since he is part time, he cannot effectively work specific hours.

King also said he agrees with Carpenter's comments. "I agree this arguing needs to stop. We need to be respectful of each other and put the city first," he said.

The next regular meeting is scheduled for Monday, October 10 at 6 p.m. at City Hall.

City Clerk Becky Bussell said the resignation led to the search for an officer to bring the force back to two full time police officers. "We are already advertising for Kirk's replacement," said Bussell. "You can't blame anyone for taking a much higher paying position and thinking of their family first."

Mays, who has been with the force about one year, reportedly accepted a position as SRO (School Resource Officer) in the

London area. According to Reynolds, unless a certified officer is hired for the position, it may take as much as a full year to replace Mays. "The course to become a certified officer takes 22 weeks and it takes several months to even get into the course," he said. "With training and classes and all things considered, it takes at least a year to get a new

officer on the streets..." Bussell said the Kentucky State Police and the Rockcastle County Sheriff's office are expected to help the city while a new officer is being located. "We have been here before and we keep the streets patrolled." she said.

In other action the commission thanked the fire department for the hard work on the Little World's Fair. Officials report a strong turnout for the fire department's biggest fund raising event.

The next regular monthly meeting is scheduled for Monday, October 10 at 7 p.m. in City Hall.

Police suspect the driver abandoned the car and fled the scene. No injuries were reported but police do not have any substantial leads as to who may have stolen the vehicle.


Mount Vernon Fire De-



The Rockets rushed Larkey picking up 150 of those yards on 24 carries,


including two touchdowns.







Mount Vernon police officer 21 years earlier and served 10 years in prison for that incident.

Once police began investigating the burglary and shooting, it was discovered that Lamb is believed to have been involved in several other local robberies and burglaries, as well as assaults. However, police indicated some of the break-ins were at the home of suspected drug dealers so they were not reported to police in a timely manner.

Reports of burglaries and robberies around the county continued for several months with police searching the homes of Lamb's family members and many other areas looking for the suspect.

Over the past eight months, police acted on many tips and information gathered from interviews and eventually arrested Lamb's girlfriend, Lindsey Ballou, on burglary charges. Over the course of the investigation, police had listed Lamb as armed and dangerous and he was suspected of more burglaries. The public continued to keep an eye out for Lamb, according to police, while officers continued the investigation.

Police had been watching several homes closely over the past few months, according to Loudermilk, and had continued to follow up on tips. However, one of the stakeouts on Stallsworth Branch paid off when Trooper Ben Allen and

Trooper Brian Maupin spotted Lamb near the home and made the arrest without incident.

"It really took everyone working together," said Loudermilk. "Tips from the community, information to the public in the newspaper, and our officers staying on top of every location gave the result we were looking for... Now we just let the

court deal with it from here."

Lamb was taken into custody by Kentucky State Police Trooper Allen and transported to the Rockcastte County Detention Center where he faced 13 immediate charges.

Current charges include: five counts of robbery, first degree; assault, first degree; two counts of assault, second degree; four counts of possession of a handgun by a convicted felon; two counts of burglary, first degree, intimidating a participant in the legal process; possession of methamphetamine and prescription medication not in a proper container.

Lamb is being held on a \$100,000 cash or property bond for burglary and a \$250,000 cash or property bond for assault.

"This is the way this is supposed to go," said Loudermilk. "We appreciate everyone who called in information about the suspect and we appreciate the newspaper getting the information out there for everyone and we are thankful that we have the results we were hoping for. No one was hurt and everyone worked together to help the entire community."







But this wasn't the first time they had done such giving. "We do this a few times every year," said Robert. "I don't want to go into detail or talk about the people we try to help. But since you are doing

the story, I can say that Amberly and I do several things throughout the year to help people in need or to help the city or county."

Amberly also admitted to some of the "anonymous" gifts that have been showing up around the city in the past few years. "We have been truly blessed over the past few years and we have helped out around the holidays and paid random people's bills that had gotten behind," she finally admitted.

Amberly said this time, she and Robert chose the splash pad for a more personal reason. "The splash pad and city park are my two children's absolute favorite things to do," she said. "I would love to see the city cleaned up a bit and in my opinion a good place for that to start is with the parks so that

Some businesses along Main Street were forced to close for a day while the concrete was drying.


