

Retired KSP Sergeant is new SRO



Tom Atkin (left) was officially sworn-in by Mount Vernon Mayor Mike Bryant on Thursday, September 23 as the Rockcastle County School District SRO (School Resource Officer) and Mount Vernon Police officer. Atkin will serve in both roles. The City of Mount Vernon will provide Atkin's equipment and cruiser and he will serve as a police officer when school is not in session.

One of the many changes in school systems, since COVID began, has been the creation of a School Resource Officer. Since the position would cause extra financial strain on the school system, and the City of Mount Vernon has been hoping for an additional police officer, the two entities have joined hands to jointly hire an experienced police veteran for both jobs.

Retired Kentucky State Police Sergeant, Tom Atkin, has been named School Resource Officer (SRO) for Rockcastle County Schools and also the newest Mount Vernon Police Of-

Along with other experience, Atkin was an investigation sergeant with the Kentucky State Police, a member of the Kentucky State Police Special Response team a United State Army veteran and a member of the Rockcastle County Sheriff's Department.

The arrangement began last year when Rockcastle County Schools Superintendent Carrie Ballinger, Mt. Vernon Mayor Mike Bryant and the City of Mount Vernon decided to create one new position that could help with both needs.

Attempted murder/ suicide arrest made in Mount Vernon

Derrick Mullins, 39, of Mount Vernon was arrested and charged with attempted murder and wanton endangerment Friday, September 24, according to a Kentucky State Police report.

The report says Kentucky State Trooper Corey Jones and Rockcastle County Sheriff's Deputy Tom Atkin were at the scene on Tremont Drive, Mt. Vernon where the incident occurred where they spoke with Stacie Smith, who claimed she had attempted to end a relationship with Mullins, causing a two day argument between the two.

On the second day, according to Smith, Mullins said "If I can't have you,

Local man charged with rape/sodomy of 11 year-old girl

James D. Irvin, 52, of Brodhead, was arrested Monday, September 27 and charged with first degree rape and first degree sodomy with a minor under 12 years old, according to a uniform citation.

The citation goes on to give explicit details that cannot be published here but reports that Rockcastle Sheriff's Deputy Sam Brock was called to the Department for Community Based Services after an 11 year-old female had reported that Irvin had performed sexual acts against her.

The citation says the activity began when the victim was five years old and lasted until this week when she reported the situation to a school counselor.

The citation continued to list several separate incidents and mentions a camcorder that was allegedly used during some of the incidents.

According to the citation, the camcorder was retrieved by police. Another item considered to be evidence was also retrieved by police.

Irvin was taken to the Rockcastle County Detention Center where his bond was set at \$250,000 cash.

The county incident rate dropped to 109 with 54 confirmed and 74 probable new cases last week, a notable reduction from last week. COVID-19 is blamed for 29 deaths in the county.

King resigns as Livingston Mayor

For the second time in two years, the Mayor of Livingston has resigned his post.

After Jason Medley resigned in August of 2020, popular local citizen Dwane King was nominated and appointed to fill Meldey's position at the September, 2020 meeting when Medley's resignation was approved.

During his reign King, 77, at the time, had two City Commissioners resign and had trouble filling the two open seats. In fact, only one resident openly vied for the job and the other remained empty long enough that the Governor appointed the other position.

But now, King, who celebrated his 78th birthday last week, has

citing medical reasons. "His doctors basically

resigned his post as well from the stress," said Melissa Hahn, King's daughter and City Commission member. "He has

had a pacemaker and several other health problems for years and (See "King" on A6)


As a long-time fighter against ANY form of government control over my own personal decisions, I was one of the millions who didn't trust the vaccine and I don't believe masks help anything at

I am writing this letter to let parents, caregivers, grandparents and everyone in the general public in on an interesting fact that just got brought to



the stress involved in the office of Mayor was just too much pressure for anyone with those kinds of health problems."

However, if things go as Hahn plans, King's ideas for the city will continue in minute detail. "I intend to do everything I can to fill the seat as Mayor of Livingston and continue the good work my father has begun," she said.

But there is a lot to consider before Hahn makes her official run for the position of Mayor, she said. "We are going to cross every "T" and dot every "I."

Hahn is in the process of gathering information about mayoral requirements. "Since we have a Vice Mayor (Commissioner Leroy Lamb) he will serve for 30 days and then I would have to be nominated and elected by the commissioners. But if it is possible, I want to serve the city of Livingston and continue my dad's work." Commissioners can vote for themselves.

Hahn says she, and the rest of the commission, is in touch with the Kentucky League of Cities and the city's attorney John Hackley making certain everything is done according to statute and ordinance.

In the meantime, Hahn says she wants to assure the citizens of Livingston that "the city wont miss a beat," and she and the rest of the commission is on duty. "The Commissioners and City Clerk are working hard every day to make sure business is taken care of until the new mayor is in place," she said. "We are going to work together and handle everything by the book and leave no room for error. But if it turns out that I am eligible for the position, I will run for Mayor."

Still, Hahn asks family and friends as well as the citizens of Livingston to continue to send well wishes to her father.

King's resignation came in a special called meeting Tuesday night of last week.

In announcing his resignation, King told the commissions, and those towns people gathered for the meeting that "It's been fun and I've en-

joyed it but because of the stress of the job it is no longer in my best interest to continue in this office." King said his doctors had advised him to step down for medical reasons.

Several citizens spoke up to voice their appreciation for King's efforts. Commissioner Clyde Carpenter told King that he had "been good mayor." Livingston resident Nina Jones also commended King on his work in the city. "I never asked him to help me do anything that he didn't say, 'Yes, Mam, I'll get to it as soon as I can." "Jones also noted that she had seen some pretty hard work from King.

King's resignation will be officially accepted at the commission's regular meeting in October and the commissioners will then have 30 days to select his replacement. That replacement will serve until the general election in 2022.

All candidates must be 21 or older, be a qualified Livingston registered voter and have resided in Livingston for one year or more.

no one can," causing Smith to stand and say "then shoot me big boy."

The report says Smith told police Mullins then raised a hand gun he had retrieved from the bedroom and fired a shot in Smith's direction. Then, according to the report, Mullins turned the gun on himself and shot himself in the head.

Mullins was airlifted to the University of Kentucky Medical Center where police later interviewed him. The report says Mullins admits shooting himself but said he fired the first shot into the wall and was not shooting at Smith.

Mullins was released from the hospital Friday and County Attorney Jeremy Rowe immediately filed an arrest warrant.

Mullins was then transported to the Rock-castle County Detention Center where he was charged and held on a \$250,000 cash bond. A preliminary hearing is scheduled for next week.

ORDINANCE #21-09-22 SETTING 2021 CITY OF LIVINGSTON

TAX RATES ON

REAL AND PERSONAL PROPERTY

WHEREAS, the City of Livingston must set tax rate prior to September 8th 2021 for the 2021 tax year.

WHEREAS, the City of Livingston must ensure that is it able to meet the rising cost associated with the operation of the city.

WHEREAS, KRS 83A.060 states the procedure for the amendment and/or enactment of ordinances:
BE IT ORDAINED BY THE CITY OF LIVINGSTON MAYOR AND COMMISSIONERS AS FOLLOWS:
Section 1

The real property tax rate for the 2021 tax year shall be set at a rate of .25 (25 cents) per \$100.00 (one hundred dollars) of the assessed value of said real property with an anticipated revenue of \$10.972.81.

Section 2
The personal property tax rate for the 2021 tax year shall be set at the compensating rate of .45 (45 cents) per \$100.00 (one hundred dollars) of the assessed value of said real property with an anticipated revenue of \$7,061.90.

Section 3
A penalty for all taxes paid after December 31st 2021.
Section 4

That the tax rate from the preceding year for real property was set at .25 (25 cents) per \$100.00 (one hundred dollars) with an anticipated revenues of \$9,841.81.

That the tax rate from the preceding year for personal property was set at .45 per \$100.00 (one hundred dollars) with an anticipated revenues of \$5,711.80.

This ordinance shall take effect on this 30th day of September, 2021.

(Continued from front) with the school district two years ago as a security consultant.

While school is in session, Atkin will serve as the Resource Officer, based at the Rockcastle County Middle School but he will be working at all six school buildings throughout the week.

Teachers and staff have had training in several possible emergency scenarios, but officials say having a dedicated officer trained in special detection techniques provides a much safer environment for teachers, staff and students. Atkin will also provide more training to teachers and staff.

While school is not in session, such as holidays or summer break, Atkin will serve as a Mount Vernon City Police officer. Mayor Bryant says the arrangement will be beneficial to everyone in the community. "The City of Mount Vernon has sorely needed an additional police officer and the school is required to have the resource officer," he said. "This way neither entity is out the full expense of the position but both entities have the benefit of a very helpful safety officer."

The City of Mount Vernon will provide basic equipment such as a police cruiser, uniforms and other equipment, Bryant said.

Currently, the arrangement is only for this

school year but Mayor Bryant says he and Ballinger are both committed to the effort to continue the position after the school year.

According to Kentucky Revised Statute 158.411, the SRO is defined as a "sworn law enforcement officer who has specialized training to work with youth at a school site." The statute also requires the SRO will be employed through a contract between a local law enforcement agency and the school system.

In Kentucky, there are 456 SROs at 152 school districts.

Ballinger, and several school board members, expressed a desire for the SRO to be a positive role model for the students and may greatly help the general relationship between police and community.

Atkin's duties will range from traffic control to serving as a liason between the district and law enforcement agencies.

Another of the many duties of an SRO is to complete a school safety development plan throughout the school system, working with all other agencies and conducting drills, including active shooter drills at the schools.

"It is a privilege to have a local officer with Mr. Atkin's experience to assist our efforts to make Rockcastle County Schools one of the best districts in the state," said Ballinger.



Census shows 1,019 less people In Rockcastle Co.

According to the 2020 Census, the population in Rockcastle County has apparently fallen by over 1,000 residents, in the last ten years, which could affect local districts, magistrates and constables as well as over \$2,000,000 in unavailable federal grants, according to Rockcastle County Judge/Executive Howell Holbrook, Jr., "It equals out to about \$2,000 per person in federal grants available," he said.

For over a year, most Rockcastle County residents have heard officials encourage everyone to participate in the 2020 census. Participation is required by the United States Code Title 13, Chapter 7, subchapter II.

But local officials say the biggest reason to participate is that the census numbers determine how much grant funding Rockcastle County will received from the federal government and a change in numbers can change district lines.

Holbrook has led the fight to encourage citizens to fill out the census but, according to the report released last week, 1,019 less people filled out the 2020 census than did in the 2010 census.

Many deadlines and planned methods of completing the census were postponed or cancelled due to the COVID-19 pandemic last year, causing some local officials to question the accuracy of the 2020 census results. Since Rockcastle's population is listed as smaller, some fear federal funding may be reduced but Holbrook is not blaming residents alone for the smaller numbers. "I was told census workers were going around to knock on doors throughout the county because not everyone has internet or would have found the proper site. But I never saw anyone from the census bureau knocking on anyone's door and I don't really know anyone who had anyone come to their door," said Holbrook.

The report says in 2019, the population of Rockcastle County was 17,056. In 2020 the population is listed at 16,037, which is 1,019 less. Of those, 5.4% is less than 5 years old, 21.2% is under 18 years old and 18.8% is over 65.

The census also noted that 50.9% of the local population is female and that 97.8% of the population is white. Only 0.5% is African American. Native Americans are listed at 0.4%.

Many other categories, including veterans, farmers and more, are

available in the census report but the 2020 numbers have not yet been reported and 2019 figures are still listed.

Still, Holbrook says even the numbers listed on the Census Bureau website may not be final. "We are supposed to receive official notification from the Census Bureau and we haven't received anything from them yet," he said. "I see the same updated numbers for 2020 on the site that everyone can see. The site lists the 2020 numbers but I have not received official notification."

Holbrook is hoping the website is incomplete. "Some of the numbers aren't complete yet so they may still change a little. But according to the official website, Rockcastle County has over 1,000 less residents," he said.

If the numbers are accurate, Holbrook, and other local officials, fear this could cause several changes in the county. "Each of our five districts in Rockcastle County must be within 10% population of each other," Holbrook said. "In 2010 we had to change the lines for districts to meet that requirements and we may have to change them again, if these numbers are final."

The number of people in a district must be within 10% population of any other district and it is possible that an elected constable would suddenly live in a different district, if the county has to adjust lines to accommodate that requirement. They would allow the constable to finish their term but then they would have to run in a different district," said Holbrook.

When a county begins moving district lines, it may also affect voting precincts. according to Holbrook. "It just has a far reaching effect when our population drops," he said.

Holbrook, and members of the Rockcastle County Industrial Development Authority, have several concerns about the apparent fall in population but Holbrook suspects the actual number of residents may not have dropped by 1,000. "I just think with COVID and people without internet and some who feel like it isn't the government's business, I just think a lot of people didn't get a chance to fill the census out this time," Holbrook said. "I doubt we are losing residents. I think circumstances just made it harder for some to fill out the census."

However, in some ways, that situation would cause even more problems for the county. For example, with less

funding and less residents to serve, some things stay the same. But if there is the same number or more people, but less funding, that is less dollars per citizen, Holbrook explained.

Holbrook and other officials are waiting for the official results of the census and says if the current numbers are correct, he will have until May to form the board that must oversee the redistricting process. "We will keep our eyes on the results and will inform the public as soon as everything is official," said Holbrook.

Livingston keeps 2021 tax rates the same as 2020

The City of Livingston tax rates for 2021 will remain the same as the 2020 rates, according to City Clerk Amanda Thomas. However, due to additional local businesses, this tax rate will produce more revenue for the city.

The real property tax rate for 2021 shall be 0.25 or 25 cents per \$100 of assessed value. This rate is expected to provide \$10,972.81 for the city.

The personal property tax rate will be the same, 45 cents per \$100 of assessed value. This tax is expected to provide \$7,061.90 in revenue.

In 2020 the total tax revenue from the real and personal tax provided \$15,553.61 while the 2021 taxes are expected to provide \$18,034.71 for an increase in tax revenue of \$2,481.10.

According to Thomas, the cost of running the City of Livingston has increased along with inflation. Therefore, the extra revenue is not expected to provide additional services but to simply keep up the current services.

"We were proud that we were able to keep our tax rate the same once again and avoid an extra burden to the residents of Livingston," said Thomas.

Rockets begin district play with 24-14 win

RCHS football derailed the Estill County Engineers to open district play Friday night, at home, with a 24-14 win.

Rockcastle County (4-2, 1-0) could only muster 137 yards of total offense after Matthew Chasteen injured his shoulder on the second play of the game and the bulk of the carries had to be spread out among the rest of the backfield unit against the Engineers (4-1, 0-1).

Neither team was able to crack the scoreboard in the first quarter and it wasn't until the 5:54 mark in the second stanza that Rockcastle County was able to put the game's first points on the scoreboard.

Faced with a fourthand-nine from the Estill County 10-yard line, Rockcastle quarterback

Cameron Wright found Landon Dillingham in the end zone.

The nine-play scoring drive was set up by an outstanding defensive stand from the Rockets on the previous series that was highlighted by Reese Coguer's interception on the Estill County 38-yard

It was another outstanding defensive play from the Rockets that set the offense up with a short distance to pay dirt when a punt attempt by Estill County on fourthand-six from their own 46 turned into a blocked punt that the Rockets recovered and returned the ball to the six-yard line.

Chasteen was able to return in the second half from his first quarter injury, albeit in a limited capacity, to make his presence felt when he extend Rockcastle's adtook the handoff from Wright and scored from two-yards out with 6:19 left in the third quarter to give the Rockets a 12-0

Chasteen's touchdown was the first of four touchdowns scored by both teams in the third quarter.

Estill County answered with an eight-play, 67yard drive that was capped off by a Ty Niece touchdown run from seven yards out. The extra point was good to cut the Rockcastle lead to 12-7 with 1:37 left in the quarter.

Caleb Moore gave the Rockets the spark they needed when he fielded the ensuing kickoff deep inside Rockcastle territory and weaved his way through the Engineers for a 92-yard kickoff return to vantage to 18-7 just 0:16 later.

Niece, Estill County's quarterback, went out of the game on the following series with an ankle injury, but Caleb Witt stepped up big for the Engineers in his backup quarterback role and led his team down the field on a scoring drive that was capped of by a 27yard passing touchdown.

The score would remain 18-14 in favor of Rockcastle until the 6:40 mark of the fourth quarter when Chasteen appeared to pick up a fumble out of midair on a bang-bang play and was off to the races for an 80yard scoop and score for the game's final score.

Offensively, Rockcastle's rushing attack was led by Wright's 45 yards on seven carries.

Landen Broaddus had the most rushes with 11 for 39 yards while Chasteen had eight carries for 21 yards and Ethan Medley totaled six yards on six attempts.

Wright was 4/8 passing for 26 yards with one touchdown and one interception, while Dillingham's only pass attempt on a wide receiver reverse pass attempt was dropped in the end zone in the second quarter.

Dillingham had three receptions for 23 yards and one touchdown and Coguer notched the other reception for the Rockets for three yards.

The defense for Rockcastle was outstanding, even without Chasteen who is the vocal leader on the field, for most of the game.

Neither Niece nor Witt were ever able to get comfortable in the pocket as the Rockets were constantly putting pressure on the offensive line earning a tackle for loss on 25 percent of the plays the Engineers ran; 10 tackles for loss in 40 plays.

Anthony Goodin once again led the defense with nine tackles with two being for negative yardage.

Dillingham tallied eight tackles and an interception from his defensive back position.

Isaiah Dehart and Jake Sanders both notched seven tackles and two tackles for loss each.

Marion Farthing, Ethan Tyree and Kaden Kidwell earned five tackles each with Farthing earning a tackle for loss.


Coguer and Jayvon Bowden notched four tackles each with Coguer tallying an interception and a tackle for loss while Bowden had two tackles for loss.

Medley and Broaddus had three tackles each while Wright Chasteen rounded out the tackling with one each.



lar-season contest before loss to the Bobcats in the playoffs.










Southern Pulaski scored with 1:21 to go in the first half, but Parkey's fumble recovery on the conversion attempt kept the score at 16-14.
