

## BOERS' DEFEAT.

Gen. French Drove the Boers Out of Colongberg and Occupied the Place.

The Boers Were Effectively Surprised and Finding That Their Retreat Was Threatened Fled in a Haphazard Manner.

London, Jan. 2.—The success of Gen. French in driving the Boers from Colongberg has shot a welcome ray of light through the gloom of the campaign in South Africa. Everywhere it is commented upon as an example of sound tactics and as an illustration of what may be done when the right methods are employed with the Boers. The government is urged to take the lesson to heart, and to see that no stone is left unturned in the endeavor to get the largest possible forces of cavalry and mounted infantry to the front.

Now that Gen. French has the Boers on the run the hope is expressed that he will give them no rest, but will harass them until they have fled from their way across the Orange river, which is 12 miles distant. The old wagon route to the Free State traverses Colongberg and crosses the river by a fine bridge 1,300 feet long. It is believed that the Boers retreated toward Kruger's post, further east, and the question is whether the Boers will be able to secure these two bridges before the Boers destroy them.

One important effect of the success of Gen. French is that it will probably have a deterrent influence upon Dutch desertion. There is some disposition here to exaggerate the importance of small skirmishes and engagements. It should be borne in mind that Gen. French has only 2,000 men, and so far as the important points of the campaign are concerned the situation is virtually unchanged. At Modder river the Boers appear to be modifying somewhat their line of defense. Gen. Buller's scouts have discovered a Boer camp established in the vicinity of Springfield, some 10 miles west of Colongberg, by a Free State commando. A similar movement has been made at Modder river, and the forces of Boers, it is reported, has formed a new laager about 15 miles down the stream at Kamnetook.

The Daily Mail has the following dispatch dated January 1 from Durban:

"Yesterday afternoon a big force of cavalry and infantry, with 10 guns under the personal command of Gen. French, moving by detour, occupied some hills three miles from Colongberg, where the Boers were in strength, confident in the natural aid afforded them by the hills around. The Boer camp was extended six miles around the entire village. At daybreak our artillery opened the battle. The Boers were taken by surprise, and replied vigorously with their artillery, but were effective for two hours. Then a Boer Hotchkiss collapsed and was captured. We captured it. A Boer big gun was also captured. But this and the other Boers were withdrawn to the northward whither we followed them. The Boer retreat by a damaging shell fire."

Colongberg is in our hands and the few remaining localities in the distance. We have captured many wagons and a considerable quantity of stores.

"Our losses are quite slight, but the Boers' must be very heavy. They may stop at Aeltering or cross the river altogether at Norval's point, where the bridge is still intact."

Bensburg, Cap Colony, Jan. 2.—Gen. French has completely defeated the Boers and occupied Colongberg.

The British continued to keep the Boers on the move and pressed them closely Saturday and Sunday, giving them no time to make a prolonged stand and when day broke he was within striking distance of the army. Sunday night all the cavalry, artillery and infantry, the latter riding in wagons to increase the general momentum, started upon a night march, with the object of surprising the Boers' right flank. The flank operation was successful. The infantry and field batteries immediately made a feint attack upon the Boers' front and while this was proceeding the main force of the cavalry and artillery moved completely around the enemy's right flank as arranged. The programme was worked without a hitch. The Boers were utterly surprised and finding their retreat threatened fled in disorder to the southwest, leaving Colongberg in Gen. French's hands.

Tucson, Wash., Jan. 2.—The best timber threatens the Klondike. Lumber from Dawson state that by the end of December there would be no fresh wood left. The Klondike is suffering at a dollar a pound only in January, with little to be had.

## DISPUTE SETTLED.

Controversy Over Extension of Concessions in China Between Great Britain, France and the U. S.

Washington, Jan. 1.—The announcement of an extension of the foreign concessions at Shanghai, China, has been finally approved, brings to a close a diplomatic controversy between Great Britain, the United States and France, which has at times become rather acute, France taking the position at one stage of the negotiations that the American participation with the British in opposing the French plan of extension was an unfriendly act toward France. This and other differences have been happily adjusted, according to a announcement from China, which he brings out by the information of the press here.

The controversy centered in international scope when the three powers at Shanghai—Britain, France and America—sought to extend their limits. The concessions are just outside of the old native city, and along the river Wang Poo, near the point where it joins the Yang-Tze-Kiang. ## THE FEMANS ACTIVE.

They Are Engaged in Storing Large Quantities of Explosives and Provisions in the Forests.

Burlington, Vt., Jan. 2.—It is reported that the Femans are engaged in storing large quantities of dynamite, lyddite ammunition and supplies in a few selected repositories in remote districts of Vermont and Maine near the Canadian boundary line. The information comes from persons who claim to have knowledge of the purchases of some of the supplies, and others who learned of their transportation by railroad disguised as groceries. Dynamite and other explosives have been secured in surprising quantities and stored under the ground on the Vermont border, while quantities of canned meats have been hidden in some large barns of sympathizing farmers on the Maine line near New Hampshire.

It is said that an efficient ambulance corps is being organized under the supervision of a few loyal Irish women, and surgeons who were in the Red Cross work in Cuba. They are also preparing a large number of "first aid" packages for the landing force.

## WIFE OF GEN. AGUIINALDAS.

She With Her Sisters and 10 Filipino Soldiers Have Surrendered to the U. S. Army.

Manila, Jan. 2.—The first movement of a general south advance occurred Sunday morning, when two battalions of the 7th Infantry landed and occupied Cubayan, on the south side of Iguana Bay. Two Americans were killed and four were wounded. There were 40 of the army's dead and 100 in one house. One hundred and fifty prisoners and four six-pounder, and six guns were captured.

Gov. TAYLOR has filed the plans on the State Board of Election Commissioners made vacant by the resignation of Judge Pryor and Capt. Ellis. The 156th Section of the election law says in plain language that one remaining member can fill a vacancy and that the two can fill a second vacancy. Section 152 of the Constitution says that all vacancies in offices for the State-at-large or for districts larger than a county shall be filled by appointment of the Governor. Section No. 156 in conflict with the 156th section of the Constitution? An injunction suit has been brought to test this question as to who has that right. Many able lawyers contend that the office of Commissioners is not an elective one and therefore does not conflict with above Section of the Constitution.

Gov. Taylor's message to the legislature recommends the repeal of the Goetz law. Some enlargement and revision of the revenue law, legislation enabling counties to supplement school funds by local taxation, a dormitory for young women students of the State College; a provision for female convicts. 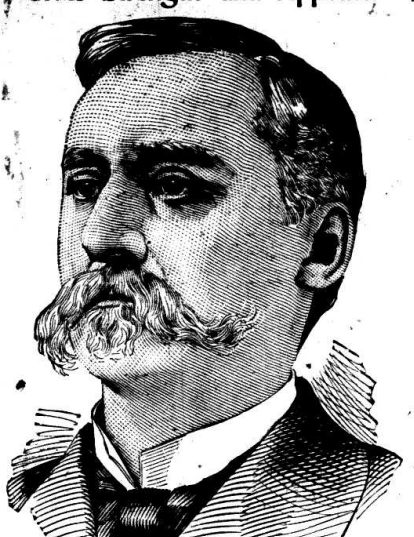
