NEWS ITEMS

It is announced in St. Petersburg that Vice Admiral Birfield is going to Vladivostok to assume command of military and naval operations.

James Skinner, one of the most prominent citizens of Cumberland county, was murdered near Burksville.

Justice Harlan's plan for the erection of a Presbyterian cathedral in Washington is encountering considerable opposition.

A repetition of the scenes witnessed in the House of Commons Monday night was avoided Tuesday by premier Balfour's promise that a day would be appointed for debating the vote of censure on the Ministry.

The State Railroad Commission in session Tuesday at Shelbyville dismissed several complaints against railroads. It heard evidence in complaints against the express companies and reserved its decision.

At the opening of the Breckitt Circuit Court at Jackson Monday Judge Riddle said he would be glad to hear expressions from all citizens in determining the question of having troops present at this term of court.

All efforts to bring about a settlement of the teamster's strike in Chicago have been failed and the outlook is that the strike movement will spread. Sheriff Barrett says he will call for troops at the first outbreak of rioting.

Johann Hotch was convicted in Chicago of the murder of Marie Welcher-Hoch, his last known wife. The jury in their verdict recommended the death penalty. The prisoner declared after hearing the finding of the jury that he did not wish a motion for a new trial made.

A general engagement is believed to be eminent in Manchuria. Oyama is developing heavy forces against Liuevitch's left wing and is contracting his troops along the center.

The Russian army occupies a line forty-two miles in length and is strongly entrenched. The War office at St. Petersburg has no doubt that Oyama is preparing to attack and that Liuevitch will accept battle in his present position.

There is no definite report of the whereabouts of the Russian or Japanese naval fleet.

Moses B. Felner has requested Gov. Beckham to furnish him with a guard when he goes to Jackson to appear at his trial for the killing of Jesse Fields.
