Bureau of Soils, U. S. Department of Agriculture, announces that, under the new and limited appropriation for soil surveys, made the last congress, it will be impossible to undertake any considerable amount of new work during the ensuing two years; that in the state of Kentucky only one new county will be taken up and that county is Rockcastle. Our county owes this important distinction and probable benefit to the Hon. Harvey Helm, congressman from this district, when the subject of this appropriation was broached last spring. Mr. Helm went to the chief of the Bureau of Soils and got his promise that all any new work was done in Kentucky, a part of it should be in his district. The Chief has kept his promise, and announces that the beginning of the soil survey of Rockcastle will be on April 1st, next. When he found that, he as well as the state, was limited to one county Mr. Helm chose Rockcastle for the reason that its topography made its survey more interesting, more likely of good results, and more

important of early accomplishment than any others of the district, which have not been surveyed.

Navy Department the nominations of Messrs Henry Poynter Burnett, of Shelbyville and David Powlan Lee, of Danville, for admission as cadets at Annapolis. Their examinations will take place next Spring, and they will succeed in passing the very rigid mental and physical tests, now required, they will become the Eighth District's embryonic naval officers and representatives during four years of training at Annapolis and two years at sea. Both of Mr. Helm's appointees are representative sons of representative families and are very popular boys in their respective counties.

Each of these principals must have three alternates to take the place of the principal or of each other, if for any reason, one or more should fail to qualify. Mr. Helm has not finished selecting the alternates for either vacancy.

Mr. Helm informs us that while it is very easy to find more than enough ambitious young men in the district who want to serve the Government in the army and navy, it is impressed with the fact that few, if any home boys, in this day of the specialist, are taking advantage of the opportunities offered for the education of our future diplomats, consuls and needed heads of the government departments. Few seem to know that a principal part of the Georgetown Washington University is the "College of Political Sciences", where all such specialties are taught, and in which special inducements in the way of cheap tuition, board etc., are made for ambitious young men. Mr. Helm will gladly pay any sum in communication with the proper officers of the college mentioned.

NEWS ITEMS

Count Zeppelin has given orders for the construction of two new airships.

Wilson Law, a well-known oil operator of Cleveland, Okla., died from the effects of a stroke at Muskogee.

Hugh S. Gibson, of Los Angeles Cal., has been appointed secretary of the American Legion at Henderson, to fill a vacancy.

Harry Thaw, through his attorney, Charles Morcheuse, has filed a petition in bankruptcy in the Federal Court at Pittsburg.

When the second "army show" opened at Fort Sheridan Friday beams from four divisions of the United States and from Cook and the Philippines are expected. The comments are the picked elements of the United States army.

The Grand Aerie of the Fraternal Order of Eagles will convene in Seattle, Wash., next Tuesday. Dispatches to Dun's Review indicate further progress in the right direction, although improvement is slow.

Not more than \$500 will spent by the local committee at Lincoln on August 15 when W. J. Bryan is formally notified of his nomination. After burning for a week the forest fires in Calaveras county Cal. are under control. Thousands of dollars worth of property has been destroyed.

The Commercial Travelers' Interstate Prosperity Congress will be held in New York City today under auspices of the Travelers' Protective Association and the United Commercial Travelers.

Without waiting for the Republican politicians of New York to decide who they want as Governor the friends of Gov. Hughes have begun strategizing for a meet-meeting to boost his candidacy.

A St. Petersburg newspaper prints a special from Tcherashvili says the Shah of Persia has obtained a loan of \$250,000 from the Russian Bank, having deposited the crown jewels as security.

President Roosevelt conferred Friday with Secretary Wright and Col. Scott in regard to the West Point cadets found guilty of hazing. No statement was made as to the result of the discussion.

The statement of the New York clearing-house banks for the past show that the banks held \$59,224,272 more than the requirements of the 25 per cent reserve rule. This increase of \$140,700 in the proportionate cash reserve as compared with the previous week.

Governor Wilson openly denounced the County Judge and County Attorney of Bracken county. He accused them of a most shameful disregard of their oaths to perform their duty to the people in relation to the recent disorders in Bracken county growing out of recent night rider outrages.

Even if the Louisville syndicate succeeds in raising the money necessary to exercise its option on the majority of the stock of the Prudent Savings Life Assurance Society, it is not believed in New York that the deal will go through. Money, as policyholders opposed to the transfer will probably appeal to the courts.

Mr. Bryan gave out for publication Thursday his reply to a circular letter sent business men of country by James W. Van Cleave, president of the Manufacturers' Association. Mr. Bryan accuses Mr. Van Cleave of having a narrow idea of what constitutes a business man, and enters into an elaborate defense of his policies.

Captain Gano Kelley, proprietor of the Wellington Hotel at Georgetown, has started a hotel-keepers fund for the Democratic campaign. He has sent his check for \$5 to the treasurer of the Democratic National Committee with the hope that every other Democratic hotelkeeper in the United States will forward a similar amount.

Capt. Kelley believes that if the papers of the country will attach a contribution from every Democratic hotelkeeper in the United States, enormous sum can be raised for disseminating Democratic doctrines, and he is confident that no hotelkeeper who is a Democrat and receives his patronage from his Democratic friends, would decline to give so modest a sum as \$5.

The following special from Frankfort dated Aug. 11 says— "The Farmers' State Bank, having discovered that several small State banks were operating branch banks without any separate or additional capital stock, and that these branch banks were not making any quarterly reports to the State, wrote a letter to Attorney General Breathitt asking if a State bank has the legal right to establish a branch bank in another town or another county. The Attorney General rendered his opinion today and holds that it is absolutely unlawful for a State bank to conduct a branch bank.

The principal complaint came from William Owens, whose one branch with only \$100,000 capital stock has been conducting several branches that had no capital stock. Several complaints from other counties were also received. The branch banks will have to discontinue or be protected. The opinion will create a sensation in banking circles.

Since the Peoples Bank of Mt. Vernon is a branch, it will of course be affected by the ruling. When asked by a Signal representative what the course of procedure would be, Cashier M. B. Sain said "The Peoples Bank will be capitalized first of all, as movements are being made for the Peoples Bank. There is some talk of making it a National Bank.

THE EAST AND THE WEST.

The difference between the old view of the East and the new one should be noted. Formerly the East was Wall Street. It was the chair of the money power, whose tentacles stretched west and embraced the nation. It was the hiding place of parasite financial kings who took the Western farmer by the throat. It brought up Western Legislatures and ruled the states through the railroads. It gambled and the rest of the country had to pay.

But that state of affairs is now over. The West no longer fears Wall Street, though part of the West distrust it. We have been suffering panic, but the Mississippi Valley farmer declares that he doesn't know what financial panic means. He is independent of the Stock Exchange. He has taken the control of the railroads into his own hands. He can regard us dispassionately, and when he delivers judgement against us it is not because of the harm we do him, but of our failure to live up to his idea of good citizenship. We are a drag on the wheel of progress.

The West has been radical in two ways a bad way and a better way. The West sees it. The East has been conservative in two ways, a bad way and a much worse way, as the West sees it. There is in the West the radicalism which we may call economic. It wanted free silver in 1896; it has pursued the trust since then; it has tamed the money it has tamed after the joys of physical valuations and bank deposit guarantees. But there is also the equally potent radicalism of the "idea" which is mainly political—the cleaning out of the houses of Legislature, the elimination of the boss, the denunciation of the party feild through primary reform and the principal of direct nominations; in a word, the movement toward more and more democracy.

Against this what has the East to show? The West might forgive us our conservatism of the market—our insistence on rigid financial standards, our more lenient continuance to the railroad and the corporation, our patience under a tariff system in which theoretically we have all ceased to believe. But it is that worse conservatism which patiently accept the old abuses of party and boss the resultant public corruption that stirs the West to contempt. And if it is true that to aspire in the right direction is to be justified, how far wrong is Western radicalism in vaunting itself above us—New York Evening Post.
