GOMPERS MAKES LABOR'S DUTY CLEAR!

Columbus, Ohio, Sept. 15, 1908. The Buffalo Republic.

The Executive Council of the American Federation of Labor greatly appreciate the intelligent and loyal service which The Buffalo Republic is rendering the cause of labor.

In response to your telegram of September 14th, I desire to say through the Republic, to the workmen of America what I conceive to be the duty of Labor in the impending political campaign.

What the working men need now, more than at any other time in their lives, is that measures which CANNOT be carried out, but LEGISLATION which CAN and WILL be secured in the new future, if the toilers and their friends make wise use of their ballots next November.

The Republican party and its candidate for the presidency, ex-Judge Taft, have spoken; and where they did not IGNORE LABOR altogether, they administered either an insult or disclosed boldly their aim to riev the chains of injustice, more firmly upon the working masses.

The Democratic party and its candidate for the presidency, Mr. Bryan, have also gone on record. They have given us ABSOLUTE ASSURANCE that they will carry out to the full their declarations with regard to Labor, which means that they will in the event of Mr. Bryan's election, see that Labor gets ALL it asked for.

The working people and their friends—those friends whose material success depends in great measure upon the success of the toilers—and that part of the public which delights in a square deal, CAN AND OUGHT to elect the candidate of the party which has made Labor's contentions for justice, its own.

Will the working classes vote for that party and that candidate which is honored and insulted labor through labor's accredited representatives? Or will they cast their ballots for that party and that candidate which

cordially and sympathetically listened to labor's appeal, recognized the justice of labor's contentions, their own?

Within a year the Supreme Court has so interpreted the Sherman anti-trust law as to make it apply to the voluntary associations of workmen. This law was enacted to protect the people from aggression at the hands of trusts and illegal corporations. It was never intended by its author and those who supported it to restrict the constitutional rights and liberties of the working classes.

Under the Supreme Courts ruling on the Sherman Law Labor Unions are declared trusts, conspiracies, unlawful combinations in restraint of trade! Every OFFICER and every MEMBER of EVERY ORGANIZATION of LABOR is under this decision, liable to prosecution by federal authority, and to a fine of \$5,000 or imprisonment for one year, or both, at the discretion of the court.

And this is not all! We are liable for treble damages in cases where we exercise the right of voluntary association effort to promote our personal rights and liberties.

The Democratic party pledges itself to enact remedial legislation that will restore to Labor those rights and liberties which are being taken from us by the action of the Constitution.

The Republican party inserted in its platform a plank which gives statutory authority for the very worst abuses of the writ of injunction—an authority which does not exist.

The Democratic party, after hearing Messrs. Gompers, Duncan and Mitchell, of the American Federation of Labor Executive Council, and Mr. Fuller, representing the railroad brotherhood, constructed a platform to conform to Labor's demands.

It is silly for anyone to pretend to say that the American Federation of Labor has harbored Labor's vote pledged it or attempted to dictate what the toilers shall do in the exercise of their franchise.

Neither individuals nor collectively are the workers annexed to any political party, nor is the labor movement annexed. The men and movement propose to be as independent after the coming election as they are today or ever have been.

But we would be reluctant to our trust and fail in our duty to our fellow workers and our fellow citizens did we not support the Democratic party and candidate to triumph in this election!

Last October, when our toilers were faced up to the keenest energy, ready and willing, as usual, to perform their great service, a monstrous, unnecessary and purely artificial panic was thrust upon our people, through the manipulations of the prices of public securities, to the amount of 2,000,000 of our wealth producers have been in idleness.

It is to remedy these conditions as well as all conditions in which Labor is interested, that we call upon all workers, their friends and sympathizers and an enlightened public sentiment, without regard to party affiliation to:

POLITICS AND POLITICIANS

William J. Bryan Tuesday delivered a number of addresses in Iowa towns. Mr. Bryan was greeted by large crowds and his speeches were said to have been delivered with exceptional vigor.

Word has been received at Fairview that President Roosevelt had finally determined to take the ship and intend to make a six-day tour across continent, clothed with a speech at San Francisco.

John E. Howes has withdrawn from the race for Judge of the Court of Appeals in the Sixth judicial district, and Judge E. C. O'Keefe will be re-elected without opposition.

Gov. A. E. Wilson spoke to a large audience at Hopkinsville Monday. The Governor evoked his usual and declared that the lawless bands were broken up.

The Atlantic battleship Bellerophon is a terrific hatter in Manila Bay harbor, none of the vessels being injured. The storm struck so suddenly that there was even time to raise the launches.

Democratic speakers were on the stump in many counties of the State Monday. In every instance good crowds listened to the speeches and great enthusiasm for the national Democratic ticket was shown.

In a speech at Lexington last night Senator-elect W. O. Bradley said that President Roosevelt did wrong in the Browns case, but that Secretary of War Taft was in no way responsible for what the President did.

Registration throughout the State Tuesday shows that the Democrats were thoroughly active. Gains were made at Richmond, Mt. Sterling and Owenboro. Lexington showed a falling off from year to the number registered.

The Democrats have a majority over the Republicans and Independent candidates in 1,059 in Louisville the registration fell about 2,000 below that of last year for the first day. The net Republican loss was 1,472 while the Democrats only a loss of 493, and the Independents fell 609. Last year the first day showed approximately 29,000 registered, while this year there were over 27,000 that had their names recorded. The Republicans were active among the negroes and got out the full registration in the Tet's ward and other large negro precincts. Many negroes registered as Independents.

BROKE ALL RECORDS

Recent Bahama Hurricane Exceeded Great Storm of 1866.

Nassau, Bahama, Sept. 30.—Only fragmentary reports have yet reached the seat of government here as to the damage done to the outlying islands of the dependency which are swept by a hurricane from the 11th to the 14th inst. but such news as has arrived is sufficiently bad. The storm appears to have originated near Turks Island and swept with increasing fury up the long arch of islands running southeast from here. Inagua, Acklin, Crooked, Ragged Fortuna, Long, Walling, Fox, Fox, Fox, and the south part of Andros islands, all appear to have suffered. On Long Island the gale blew for two days and the settlements are practically obliterated from end to end, the principal place, Christmas, having only five houses left standing. The inhabitants were forced to find shelter in caves, and food and water were almost unobtainable.

The government schooner Douglas was blown from her anchorage at Long Bay and was driven ashore on Long Island. Many other boats were lost, but it will not be weeks before the full account will reach Nassau. There is no doubt that the loss of life is heavy. The whole country, even the capital, St. John's, is scathed and burnt as if with fire, from the terrible fury of the great storm across the bay. The actual money loss is insignificant, the houses destroyed, for the most part being mere shanties, nevertheless the loss to the owners is severe, representing, it is felt, practically everything that they possessed.

The government has taken relief measures and schooners are being hastily dispatched laden with food stuffs, lumber and nails.
