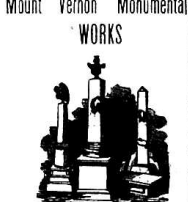

### MEN'S BAD DAYS.

The critical days of man which the Viennese scientist has discovered have their interest for the layman as well as for the investigator of the mysteries of existence. That the law of recurrence comes into play so active a part in the comfort of human life few persons would have believed. Dr. Swoboda's theories are still too new to have stood the test of investigation, but they are of vital interest. In the opinion of the discoverer of these laws no man escapes them. The Viennese professor begins the exposition of his theory with the general statement that physical conditions occur at stated periods, not from external causes but with mathematical regularity, in accordance with a law of the physical nature of man.

The manifestations of the law in the so-called critical days of man are sometimes trivial, sometimes more serious, but their outcome is always favorable. They have no final bad effect. These symptoms of the critical period never occur more frequently than at intervals of twenty-three or twenty-eight days apart. The human organism is too complicated to allow its workings to be made clear even by means of this key. The same symptoms may be caused by the human being's own actions. Any excessive expenditure of energy is attended by a diminution in force which causes a recurrence of the critical days. These irregular appearances of the symptoms that mark a critical day in human life may also be caused by emotional strain. Professor Swoboda cites as an instance of such phenomena the smartness or pain following the death of a beloved relative, which becomes poignant twenty-three days after death, endures for the same number of days and then subsides. There are other cases in which the effect of the critical day shows itself recurring at short intervals, which are in fact fractions of parts of the regular period of twenty-three or twenty-eight days.

This view of the importance of periods in human affairs reverses many medical ideas. One of its results is the theory that man is gamboling.

subject to disease only when the constitution has not the strength to combat them. These evidences of the critical days are, it might be explained, commonly mistakes for evidence of ill health, since they show themselves in such forms as cold, inflammation, an eruption on the skin, weakness of heart, faintness, dizziness, irritability, indigestion. At these times the will is weakened and the subject is irritable and depressed. Men have been known at this time to expose themselves to danger without directly attempting suicide. The theory not only shows the growth of life, it also shows its decline. In the view of the periodic illness death is no single sudden event. It is the last of the critical days.—New York Sun.

McGray, "I would simply say, 'I give you this orange,' but should the transaction be entrusted to a lawyer to be put in writing he would adopt this form: 'I hereby give, grant, and convey to you all my interest, right and title and advantage of and in said orange, together with its rind, skin, juice, pulp and pits, and all rights and advantage therein, with full power to bite, slice or otherwise eat the same, or give away without the rind, skin, juice, pulp or pits anything, herebefore, or to be hereafter, or deed, instrument, of any nature or kind, whatsoever, to the contrary in anywise notwithstanding.'"—E.
