Gov Wilson has issued a proclamation convening the sheep-breeders, County Judges and County Attorneys of the different counties of the state, in Convention at the State Fair grounds Louisville, on Wednesday Sept. 15th, for the purpose of taking steps to stamp out the disease "scab" so prevalent among sheep in Kentucky and lift if possible the quarantine against Kentucky sheep, made by the Department of Agriculture at Washington. Judge Bethurum has named the following gentlemen as representatives from this county: Judge S. D. Lewis, G. S. Griffin, Gus Stivers, W. B. Walden, J. W. Moore and Chas. Lear. The success of this convention means much for the sheep industry in Kentucky.

Tomorrow is the day when the Democrats are to meet and make some action in nominating tickets for county offices to be voted for at the November election. Dr. Cook is returning on the steamer Hans Eggede, due at Copenhagen Saturday in his final dash for the pole. Dr. Cook was not accompanied by a white man, four Eskimoes being his only companions. The news of his success is generally credited by scientific men.

SUES FOR DIVORCE

A special from Winchester says: Mrs. Sarah C. Youtsey, through her attorney, Hon. J. M. Sevenson has filed a petition in the Clark Circuit Court for absolute divorce from her husband, Henry E. Youtsey, who is now confined in the penitentiary serving a life sentence for the murder of Governor Goebel.

The plaintiff in her petition states that she has been a resident of Clark county for the last nine years past and that the defendant has resided in Franklin county for more than a year last past. The grounds upon which she is asking for divorce are condemnation as a felon and separation for five years. The petition states that the plaintiff and the defendant were married in the year 1897 and lived together as husband and wife until March 1900; that in the year 1900, by judgment rendered in the Scott Circuit court plaintiff was sentenced to the penitentiary for five years and that there-after he was imprisoned in the State Penitentiary at Frankfort pursuant to said judgment and is still confined there. Plaintiff prays for divorce and that she be allowed to assume her former name, Miss Sarah C. French. Mrs. Youtsey is a daughter of the late Stephen French and is now living in this city.
