Under the present constitution of Kentucky, the State is prohibited from bidding in the building of public roads. The last legislature by a practically unanimous vote decided to submit to the voters of the State a constitutional amendment to section 157 so that the State could aid in the construction of public roads. That question is to be voted November 2nd and by failing to vote you will at least cast your half vote against the amendment. It is of vital importance that this section be amended and every good citizen who wishes to uphold the State should vote for the amendment and see that his neighbors and the voters of his precinct do likewise. Under the old system prior to the adoption of the present constitution all the good roads that we now have were built with State aid; the State becoming a stockholder in all new pikes erected. Nothing so advanced the interest and prosperity of a community as good roads. By doing your duty on November 2nd you can make it possible for the State again take up the question of road construction in Kentucky. Under such a system the roads of Rockcastle could be made into turquois. The rich automobile owners residing in the cities under the State

aid plan would be forced to join in keeping the roads up to a high standard. Vote "yes" for the amendment.

At the November election the voters will be given an opportunity to cast their ballots in favor of a "Good Roads" amendment to the Constitution. Nothing so adds to the value of farming land as for it to be accessible to good roads; nothing adds so much to the town as the good roads that lead to it. A community is built up accordingly as it is accessible. Therefore it behooves both town people and country people to support the amendment. Vote "yes" for the amendment.

Some day the great Salt Peter cave in the eastern part of Rockcastle will furnish material for millions of tons of commercial fertilizer.

CITIZENS MEET:—Do not forget the good roads meeting at Soiro tomorrow. The candidates will be there; the farmers along both routes and the people generally will attend and urge alongside the good cause.

Good roads in this county would not only cause great development to farming lands but would push to the front vast interest in the following lines: Fire clay, pottery, clay, sand, cement, lime, building stone such as sandstone, fire stone, limestone, haligrit etc., asphalt, salt-peter for fertilizer; lumber in cluding chestnut, oakwood for tanneries, coal lands, especially the coal fields of Staggs Creek valley which is rich in the quality of black diamond.

It is claimed that a good road runs on a lower level has been found at Pine Hill that is virtually free of sulphur which is a suitable article for burning cement. A movement is on foot for the establishment of a big cement plant at that point. Some three years ago an organization was formed for the erection of a \$200,000 enterprise of this nature at Pine Hill but owing to the death of one of the principal stockholder the proposition fell through. The matter has been revived.
