MISS MCCORD ON THE SCHOOL QUESTION.

Mt. Vernon, Ky.,
Dec. 1st 1909.

Mr. Editor:—
As the time is drawing near when we must decide as to the nature of the work of Brown Memorial School for another year, and in order to provoke such discussions of the question as will result in that course of action which will best further the cause of education in Rockcastle county not only for the present, but as we look to the future, it may not be out of place that we should state to people generally what we have from time to time, during the first year, stated to the County Superintendent and others concerning our attitude toward the Public Schools.

We are in full sympathy with every movement which tends to improve the public schools of the state, and wish to cooperate in every effort to bring Rockcastle County to the front in educational matters.

We believe that whatever may have been the demand for the school at the time Brown Memorial was founded, and during the years it has been carrying on graded school work, there seems to be now no reason why any private school should be doing this work.

We do not say this from any desire to shift the responsibility we have been carrying, nor from any

lack of appreciation of the cordial support and co-operation you have given us, nor from any feeling of disappointment in the school itself, which has steadily grown in numbers and interest during the past year, having now a much larger attendance than ever before at this time of year, and good prospects for the coming term; but we feel that Mt. Vernon is abundantly able and ought to maintain a good, graded public school, with a sufficient number of teachers to take care of the grades through the first twelve years of the general school system, which includes the four year of High School work. This is just the work Brown Memorial is doing.

It has not been our intention to continue High School work after such a course has been provided for by a County or City High School, but rather to devote our attention—especially if we continue graded school work at all—to preparing students for the High School. Comparatively few in the rural districts are at present ready for it. Our first and greatest need it seems to us, is to strengthen the work of the elementary schools throughout the county, supplying them with teachers who are able to take their pupils through the eighth grade, and who will inspire in them a desire to pursue their studies further. We are glad to say that this need is more and more being realized in the teachers of the county schools.

The relation of a graded Public School in Mt. Vernon, to the County High School is a subject which will need to be discussed but which we can not take up here and now.

Often during the past year this remark has been made to us "We do not think the New High School will hurt your school," but that, it seems to us, is not the question at issue, but rather, does the fact that Brown Memorial is doing graded school work hinder Mt. Vernon from having the kind of Public School it ought to have? Would it not be better that we give up the day school work, turning our building on Richwood St. over to the public school?

This we are ready and anxious to do just as soon as proper steps can be taken to establish such a graded school as will adequately meet the educational needs of the community.

This will mean a special tax. It will cost the community more than the present arrangement. It costs money, says, though earnest effort and putting aside of selfish interests to run a good school, but money invested in schools is the best investment which can possibly be made.

Mt. Vernon has the means and responsibility to maintain a good school, can we not insure the necessary steps to insure having the school in operation next fall?

We do the more freely urge this action upon you, realizing that possibly many of you may feel as we do, that such action should be taken, but have hesitated to advocate it from a sense of loyalty to Brown Memorial School. While, if such feeling exists we appreciate it, we wish to say that it must not stand in the way. "Not what we want but what we ought" must be our standard.

As to whether we continue our work here along other lines is a question apart from this of our relation to the Public School, and one which we will be glad to discuss at some other time.

"Nothing is ever settled until it is settled right." Let us with determined, united effort settle this question of a graded Public School in Mt. Vernon in such a way as will result in the "greatest good to the greatest number."
