My Dear Albright,

Knowing your interest in the Boone Highway, I am below furnishing you a chapter in connection with it. If you have already been made cognizant of this it will be useless, otherwise I think worth publishing.

In 1844 Hon. Ben Hardin was appointed secretary of State by Gov. Owsley. In speaking of this Hardin says "When Gov. Owsley was preparing his message in that year to be communicated to the General Assembly he pointed out to him—that the turnpike road be extended from Crab Orchard to Cumberland Gap—and that the state dividends be the turnpike road from Louisville to Crab Orchard be appropriated to extend the pike to Cumberland Gap."

Mr. Hardin was a whig and in favor of internal improvements state and national; and besides being a far sighted man must have held the view that the extension would be a valuable connecting link between Louisville and the South, and as the mountains, without receiving any benefit had been taxed to build a number of pikes in more favored parts of the state that something should be done for it. There is nothing to show that any sentimentally as to Boone played any part in the making of the suggestion that it is by no means an improbability. This might be used with effect in inducing the legislature to give aid based on what in former times had been done for the blue grass regions.

The State has never given justice to the inhabitants of its South Eastern domains. It should have had constructed many years ago a turnpike over the old "Wilderness Road". As stated in Judge Morrow's admirable letter, above the mountains were taxed to assist in the building of pikes in more favored parts of the state, which were enjoyed and profited by the citizens of the blue grass whose territory was encircled with these good roads, mainly built by the state, yet at this late day when our people of the hills make an effort and appeal for justice what does the press of Louisville do but deride our movement and treat the whole thing as child's play; ever objecting to our asking the National government for aid in the proposed work of constructing

an improved highway over the route which the state miserably failed to do, as it was in duty bound. The newspapers, whose city the mountaineers have patronized away beyond its deserts go further and advise us to "dig roads if you want them, you lap sided sons of guns; we object to the government donating anything toward building highways in the Mountains. We object on "principle" we don't see that you sang diggers deserve anything anyway. Go along make your roads and spend your money in Louisville the city that has no time or money to waste upon you, not even fifty cents toward postage fund in your Boone Way Movement" yet this same city boasts of being the "gateway" to the South". It is justified in the "gateway" claim part of it all right when it comes to state appropriations for improvements "of any kind within Jefferson county, notable the state fair but when the mountains would ask for aid to good roads it is as if you were to ask up a bowl from their selfish and grasping newspapers. The majority of the professional and business men of that city have given the movement no better treatment than its papers and this part of the moral vineyard has transferred a larger portion of its trade to more appreciative cities that display a friendly interest in our affairs.

The talk of Louisville papers having "principles" is too laughable. Judge Morrow's suggestion that the legislature should give aid is a correct one. The more favored portions of the state "got theirs" long ago. The question is will the mountains ever get anything except injustice, with a big I?

HOME COMING celebrations are pleasurable and commendable affairs. They keep alive that spirit of hospitality which has so long been considered characteristic of Kentucky, but which is somewhat prone to languish as the village advances to a town and the town grows into a city.—Courier Journal.

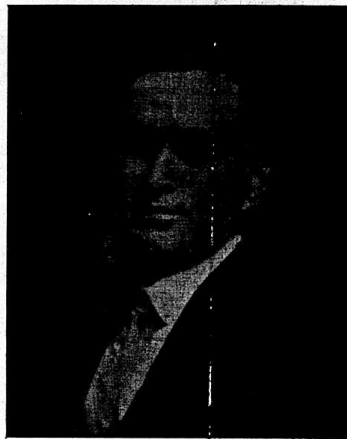
