"Will you kindly grant me a little space to give 'the boys' a sermon from life?"

"I was born of honest, respectable parents, in the State of New Jersey. At an early age we removed to Western city. At this time I laid the foundation for what I have become—an inmate of a county jail, awaiting trial upon a charge liable to send me to State's prison for fifteen years by my own fault."

## Dixie Highway Routed Through Mt. Vernon

The decision of the fourteen Dixie Highway Commissioner's at the Chattanooga meeting May 20 to 22nd makes a loop between Chattanooga and Indianapolis. The Eastern route passing thru Knoxville, Cumberland Gap, London, Mt. Vernon, Berea, Richmond, Lexington and Cincinnati to Indianapolis. The west loop runs from Chattanooga thru Nashville and Louisville to Indianapolis converging there with Eastern loop thence to Chicago. South of Chattanooga there are two or three loops between that point and Miami the Southern terminus.

It was the biggest road meeting ever held in this country. Delegates were in attendance from nearly every county between Chicago and Miami.

The Eastern route advocates were ably led by Senator Joe F. Bowditch, Middlesboro; R. E. Sanford, Knoxville; R. E. Turley, Richmond; assisted by delegates from Mt. Vernon, Berea, Lexington, Barbourville, Pineville, Middleboro, Cumberland Gap and points thru Knoxville to Chattanooga. The Richmond delegation included R. E. Turley and Chas. F. Higgins; H. P. Herndon and Prof. F. O. Clark, Berea; W. J. Sparks and James Maret, Mt. Vernon; John Henry Wilson, Barbourville; Judge F. R. Patterson, Pineville; Sen. Joe F. Bowditch, Middleboro, and Cumberland Gap's good booster J. Frank White.

Some of the names of delegates in attendance from along Boone Way, to the north of us, that we remember, were Congressman Harvey Helm, Stauffer; John M. Gill and W. T. Elkins, Lexington; E. R. Dillshay, H. T. Nichols, Ed. W. J. Mills, Nicholasville; Edwin L. Quarles, Lexington; Ruggie Curry, Shelbyville; N. L. Curry, Harrodsburg; Robert W. Brown, Secretary of the Times and Eugene Stratford, Louisville. Some of the best speakers of our country presented the claims of their various routes. Mr. O'Hair, who last year uncle Joe Casper of Danville Illinois, 43 votes for congress and was in turn defeated by uncle Joe by 3,000 votes presented the claims of the Eastern Illinois route on which would have been a target of a hundred miles without a curve. One county he had appropriated \$100,000 for road purposes within his borders. Mr. Mayor Book Water, of Indianapolis represented Kentucky. The Governor, James Cox, Ohio, with the driving, Cincinnati delegates

of more than 100 people. Peter Lee Atherton was the leader of the Louisville delegation which appeared almost as large as that of Cincinnati.

All the delegations from Richmond and eastern points to Chattanooga marked with Cincinnati, pulling for Eastern route.

Lexington was almost neutral for some time, but a leading for Central route via Lancaster, Somerset, etc., but about ten o'clock, Saturday, when it was rumored that Cincinnati was likely to loose out of the game then Lexington walked up to the importance of the Eastern route. It was also rumored that someone had reported to the Commissioners that no bond issue had been officially reported as having been voted upon in S. E. Kentucky. Things lived up in hurry. Lexington, Richmond, Mt. Vernon, Barbourville and Knoxville delegates (others having gone home) hurriedly got their remaining official documents together and rushed upon a typewritten statement of what had been done and was being done in S. E. Kentucky on Boone Way. This Statement was signed by President of Boone Way and Ex-Congressman John Henry Wilson of Barbourville. The latter two were sent to the Commissioners room where documents were presented to Commissioner Hagan and retired to await the result.

Not far from noon the report was made known that a loop was agreed upon. Then a rush was made to hotel local telegraph office to send the glad tidings to the friends of the Eastern route.

Joe F. Bowditch knows his business when it comes to speaking "out in meeting" if there is anything comes up on the road question.

A. F. Sanford, Knoxville's live wire deserves the hearty thanks of Eastern Tennessee, Eastern Kentucky, Cincinnati and East Indiana for his masterly presentation of facts, figures and maps of the Eastern route. We had the goods here and in East Tennessee, but it took just such a man as Sanford to collect the right information, data and get it into a presentable and understandable shape. All honor to Mr. Sanford, the worker.

We ask Ex-Congressman J. H. Wilson, some hours before a decision was given by the Commissioners, who he expected to come home. He remarked, "when I get on the battlefield I remain until the last corpse is buried. There are many above ground yet."
