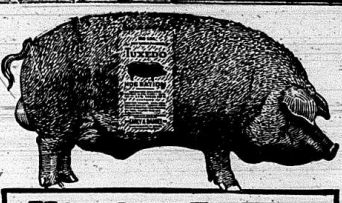

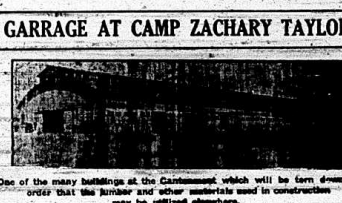

**GARRAGE AT CAMP ZACHARY TAYLOR**

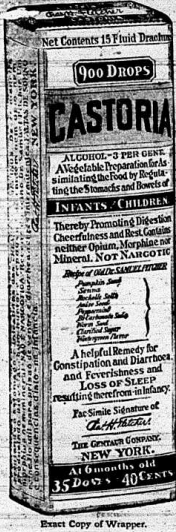

**COMMON SENSE**

It is urged by those opposing Judge Bethurum for re-election that he has been in office long enough, and has drawn so much money as salary for his services. The argument against the judge is unsound. Common sense is all that is necessary to see the fallacy of this argument. The fathers who fashioned our form of government, and lived to see the splendid success that it met with, placed in the Federal Constitution a provision that has proved the wisdom of this provision, and has fully vindicated the statesmanship of the men who framed our Federal Constitution. As a result of this policy in the selection of the Federal judges, the United States today stands head of any country in the world for the strength and efficiency of its judiciary. This is true because the judge who goes upon the Federal bench is permitted to serve for life and the service is not impaired, or crippled, by a change in the personnel of the judge and the people are assured of a judge of experience all the time. The State Constitution does not provide for life service of its judges, but requires the payment of a salary to the judge only. It is possible, however, for the people to have the same efficiency, ability and experience in the State Courts as we have upon the Federal bench. This is possible by continuing to elect the old, and tried, judge as long as he is willing to serve. What the country needs, and demands, is experienced judges. In fact experience is necessary in every kind of business. It is necessary in the selection of a judge of this country. The circuit judge is the one officer that holds more power in his hands than does any other officer in the State. He passes upon all questions that affect the life, liberty and property of the people. This is a sacred trust, and the power should be cautiously conferred. If this power should be exercised by the judge unwisely, as in the case of an incompetent or inexperienced judge, or corruptly, as in the case of a designing and corrupt judge, there is no fault to the evil that would result. Hence the importance of caution and care by the voter in the coming August primary election. If the present judge is proving satisfactory, which is conceded by the vast majority of the voters, there is no reason why he should prove a bad one, the district magistrate for six years. There would be no escape from it. More law suits result from fasty, ill considered horse trades, than later prove unsatisfactory, than over any other one thing. You would not trade of a true, trusty, reliable family horse, that works well, and never balks, for an inflated, inexperienced horse that is inclined to be fractious and frisky, although he may be a beauty to look at. You would probably lose a crop if you should make the exchange. These are simple, everyday illustrations that cause people to think, and when the people think, they always do the right thing.

Other districts of the State are electing their judges as long as they will agree to serve. Judge Morrow was elected in this district for three consecutive terms, and the district profited by his experience. Judge Carter, of the adjoining district, who lives at Tompkinsville is a candidate for the third term, and is unopposed. Many districts of the State are presided over by judges who have served more than three terms. Besides, people the world over place great stress upon experience in the selection of their employees. The local banks would not think of giving up their officers, although some of the cashiers have served in capacity for more than 20 years. Business people recognize the value of experience. It is true that Judge Bethurum has drawn a salary for his services. He has earned every dollar of it and more. He could have earned more in the practice of law, but has served the district because the district desired his services, and he was unwilling to retire him. The people will not retire him at the end of the term. When they get ready for him to quit this office, they will call a Republican to take his place. This is a Republican district, the majority being something like 10,000, and it proposes to keep a Republican, a real Republican, on the bench. The Commonwealth predicts the re-election of Judge Bethurum by not less than 5,000 majority. This is indicated by all the reports that we get.

**CONGRESS HEARS  
DRAMATIC PLEA

Washington. "I have the heart of a patriot for the freedom of Ireland, of Poland, of Bohemia, of the Czechs, Slovaks, and not for the independence of the Philippine Islands?"

That was the question-poser of the Philippine Commission, a long and interesting session of the House of Representatives on the subject of the Philippine Islands.

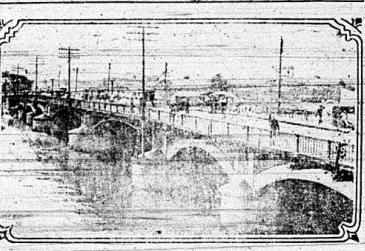

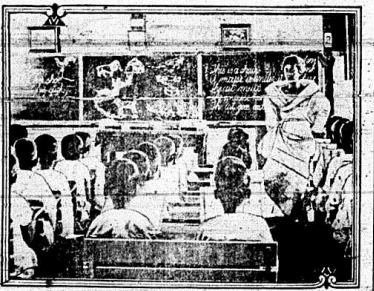

## FARM IN FERTILIZER.

Fertilizer has been our big question up until now. Thanks be to the farming interests and all those who stock for a lower price on fertilizer this year. We are now getting it for \$20 and possibly will get it cheaper before crop planting time. It's now at a price where a farmer can afford to use it. Fertilizer should be used broadcast, with at least 250 pounds per acre. Or 200 pounds broadcast and 50 to 100 pounds used in drill at the time of planting. 75 to 125 pound is too little to use. It doesn't pay unless we use enough to get some results. Grow more. If we expect to keep up the fertility of our soil. Crop rotation should be practiced by the farmer in order to save money by crop production and grazing more live stock.

Mr. W. T. Hicks of Wildie has 8 yearling bulls for sale, ranging from \$75 to \$150 each. These bulls should stay in Rockcastle instead of being shipped to Louisville and sold at the ball sale in June. He says he will sell on time or trade for other stock in order to keep the bulls in the county.

## RESOLUTION AUTHORIZING OILING OF THE STREET OF THE TOWN OF MT. VERNON

At a regular meeting of the Board of Trustees of the town of Mt. Vernon, Ky., held at Peoples' Bank building, Thursday, April 14, 1921, a full board being present, unanimously passed the following resolution:

WHEREAS it is deemed to be to the best interest and welfare of the general public and whereas more than fifty (50) percent of the property owners along said streets to be oiled have petitioned said Board to pass such a resolution, therefore,

Be it resolved: That Main street beginning at the east corner of the lot owned by W. H. Levison, on East Main street and extending Westward to the corner of the lot owned by R. A. Parks and beginning at the intersection of Richmond and Main street and running North, on Richmond street to the intersection of Newcomb street said street to be oiled as provided in chapter 106 of the Kentucky Statutes, an act of the general Assembly of 1920.

Be it further resolved: That all abutting property owners along said streets be required to pay the cost of oiling, that said streets shall be oiled twelve (12) feet wide, except that portion of Main street between the railroad crossing and the corner of 18th St. to be oiled twenty (20) feet wide, and that and that said oiling shall be done between the 1st and 15th of June 1921 and that the cost for such oiling will be approximately 50¢ per square yard, to be paid equally by all abutting property owners.

The actual population of the Philippines is 10,500,000, of which 8,400,000 are Christians and civilized, and have been so for 300 years, possessing a culture and refinement of which compare favorably with that of other countries. The number of non-Christians is 2,100,000, and only a small percentage of them are uncivilized. They are fast becoming educated, and will ultimately make good citizens. Seventy per cent of the inhabitants of the Philippines over ten years of age, according to the last census are literate. This is a higher percentage of literacy than that of any South American country, higher than that of Spain, and higher than that of any of the New Republics of Europe whose independence is being guaranteed by the Allies.
