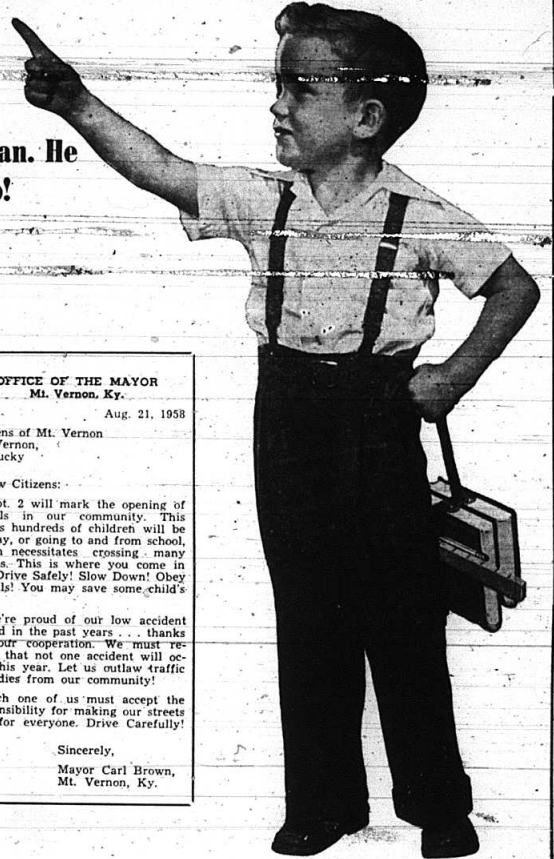

## Observe The Following Safety Rules!

1. Always walk on sidewalks, or well away from the path of cars.
2. Cross streets carefully, stopping at the curb and looking both ways.
3. Never step into the street from behind parked cars.
4. Be especially alert for traffic when streets are wet or when carrying umbrellas.
5. Walk on the left side of the highway, facing traffic, when there are no sidewalks.
6. Obey police and school safety patrolmen and respect traffic signals.
7. Always play on playgrounds and never in the streets.
1. Adhere to all speed restrictions in school zones.
2. Watch and obey the school safety patrolmen.
3. Be sure you can stop quickly in wet and slippery weather.
4. Never pass a school bus unloading children.

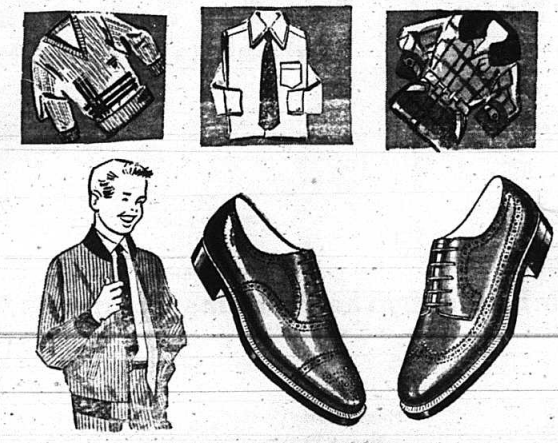

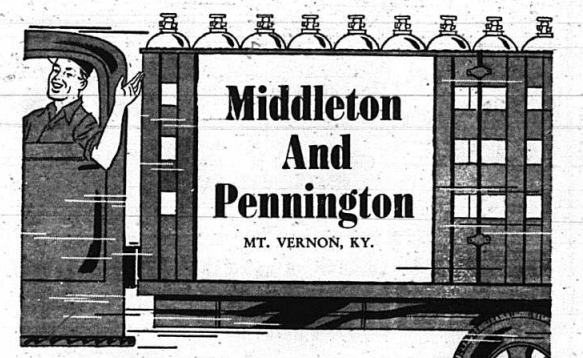

#### 102-Year-Old Man Eats Three Squares

PAINTSVILLE, Aug. 19—Aaron Meek of the Boons Camp area was still receiving congratulations this week although he celebrated it Aug. 8. He is 102 years old.  
Ten of his 12 children are still living, including 78-year-old twins.  
His formula for a long life: No tobacco, no alcohol, and no between-meal snacks. Just three squares a day.

#### Ex-Gov. A. O. Stanley Dies In Washington

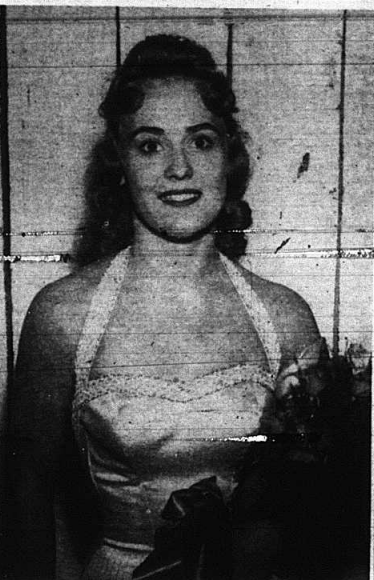
FRANKFORT, Aug. 15—The body of former Kentucky Gov. Augustus Owsley Stanley, 91, arrived in the capital Friday after he died at Midnight Tuesday at his home in Washington. Stanley was known as one of the old-school colorful Kentucky orators.  
His body lay in state in the rotunda of the Capitol. This honor was accorded to only one other Kentuckian—U. S. Senator J. C. S. Blackburn, Versailles, who died in 1918.

#### 100-Mile Skyline Drive Is Studied

FRANKFORT, Aug. 19—The prospect of building a 100-mile long skyline drive in Eastern Kentucky from Elkhorn City to Pineville is being explored by the Eastern Kentucky Regional Planning Commission this week.  
The drive would reach along the top of the ridge of Pine Mountain and would offer an alternate, straight route to tourists in the area.

### Too Much For One Man

## John Lair Sells Part Of Property At Renfro Valley

John Lair, widely known promoter of the Renfro Valley Barn Dance, announced today that he has sold part of his property in the one-time buzzing tourist area of Renfro Valley.  
His only hint as to the sum he received for the Renfro Lodge restaurant and cabins was that it was "well up into five figures."  
The undisclosed price was paid by Oscar Yates of Catlettsburg and the deal was handled by Brooks Wells, Ashland realtor.  
Lair will retain ownership and operation of the service station and all entertainment facilities on the other side of U. S. 25.

The Renfro Valley community has declined in attendance in recent years since it became more of a local and less of a national network production.  
It was built by Lair some 20 years ago and has been under his direction since that time.  
His reason for selling part of it: "It was just too much for me to handle. A man can't do too many things and do them all right."  
At the time that he made announcement of the sale, Lair said that he will be the "active" man for radio and television in his bids for supremacy as entertainment media.  
If radio is the victor, Lair says it is possible that there would again be a Renfro Valley network hookup.  
In former years, when Renfro Valley's entertainment was heard across the nation, the number of tourists who visited this area to see the show in person was so great that many times private homes had to be opened in order to rent sleeping accommodations to them.  
Since that time, however, the number of visitors has declined steadily.  
"Stations are getting away from live entertainment," Lair said. "The live ones can't afford it, and the big ones have been competing hard with television."  
"This year should tell the story, though," he said.

## Judge Keeps Promise; Closes Gambling Spots At Little World's Fair

### Says He Will "Keep Watching" For The Remainder Of The Week

## Can An Alcoholic Be Helped?

### Ways Told To Aid Alcoholics

By J. Collis Ringo, Executive Director  
 Kentucky Commission on Alcoholism

The Kentucky Commission on Alcoholism receives many inquiries from families of alcoholics. Without exception they ask, "How can an alcoholic be helped?" It is assumed that most of these cases have reached the stage of needing help and do not know what to do or where to turn.

A pamphlet by Ernest Shepherd, director of the Florida Alcohol Rehabilitation Program, cites six steps pertinent to the behavior and attitudes of the family which can be helpful.

First, recognition by the family that the individual is an alcoholic. As long as doubt remains in their minds it is improbable that they can accept it as a disease or be able to take the second step.

Second, try to help the alcoholic accept his disease. Make literature on the subject available. Suggest a talk with an informed outsider (a physician, minister or a member of the church). Avoid threats. Threats

only raise the alcoholic's defense mechanisms.

Third, the "home" treatment should be avoided. This usually consists of lecturing, begging, or trying to manage his life by keeping liquor out of the house or locking it up. The alcoholic will not listen to talk, he will find liquor, he will protect his supply under any circumstances. He will resent what he considers interference with his life.

Fourth, drinking should be discussed openly and it should be made clear to the alcoholic that his alcoholism is a disease, a disease, is not acceptable to his family or friends.

Fifth, the family must realize that rehabilitation is a long-time process. A long time for an alcoholic to become aware of his condition to the extent he will seek help. No matter how pressing the desire of his family, the alcoholic himself must desire help before any real good can be accomplished.

Six, the alcoholic must be allowed to take the consequences of his drinking, regardless of embarrassment to his family. Coddling and covering up a family's alcoholism is the possibility of his realizing the need for help.

## Foresters Named For Southeast Ky.

Appointment of a district and a service forester for southeastern Kentucky including Rockcastle County, with headquarters in Paducah, announced by Director Gene L. Claude of the Division of Forestry.

Elmore C. Grim of Paducah was named district forester in charge of the state forestry activities for the southeastern section. Grim has a degree in forestry from Pennsylvania State College. He was with the U. S. Forest Service for two years and for 13 years worked in various capacities with forest industries. Since 1949 he has been employed by the Paducah Box and Basket Co.

Owen H. Robinson, a recent graduate of Purdue University Forestry School, was appointed service forester to give technical aid to woodland owners in management, harvesting, and marketing. He worked with the Division on a part-time basis as a student forester during last year.

Counties in the heavily forested southeastern district are: Bell, Clay, Harlan, Jackson, Knox, Laurel, Leslie, McCreary, Rockcastle and Whitley.

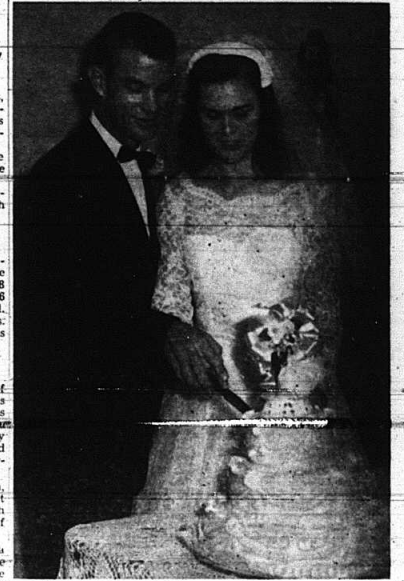

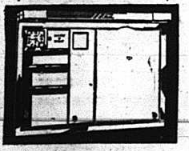

yield the best crops, but if a compromise is necessary, a good site should take preference over fertility. A poor soil can be improved.

Planting: The best times for planting are November and late March when the trees are fully dormant. In the fall, a small mound around the base of the trunk of newly set trees will give protection for heating of the soil by freezing. Probably the chief cause for failure of trees to live is due to late spring planting when the trees begin to expand. Of course, exposure of roots or failure to plant promptly with soil pressed firmly around the roots are other causes.

In any case, do not use commercial fertilizer when planting young trees. Plant trees as soon as received from the nursery or heel-in promptly to keep the roots cool and moist.

Nursery stock: Healthy nursery trees of good moderate growth are preferred to either jumbo or small sizes. Usually one-year old trees grow best.

Order **ahead** of size and quantity wanted.

Pollination: Most kinds of fruit trees should have good pollination for the production of fruit. Some kinds will bear fruit with self-pollen, while others require pollen from another variety. Apples are mostly self-sterile and must be cross-pollinated. Some varieties of pears and plums will pollinate themselves but some sweet cherries are practically self-sterile but sour cherries will bear by themselves.

**Soil Judging Contest Is Set At State Fair:**  
Every one of Kentucky's 120 counties is eligible to send a soils-judging team to the State Fair, September 4-13.

This is the first year such a contest — for youngsters less than 21 years old — has been scheduled at the fair, says Lyle Leonard, Kentucky Agr. Extension Service conservationist.

Any number of persons can compete from any one of the state's counties, he said; and 50 cash prizes are offered to the contestants.

The time for the contest: Farm Bureau day, Wednesday, September 10. Entrants will judge soils close to the fairgrounds area, Leonard said;

Along with prompt attention goes careful, patient workmanship, she says.

Here are suggested methods for removal of some common stains:

Canned or fresh berry and fruit stains should be treated before they dry if possible. Warm or boiling water is usually effective. For peach, pear, cherry or plum stains, sponge stain with cool water, then work glycerine or a soapless shampoo into it. Let stand several hours, then apply a few drops of vinegar for a minute or so, and rinse thoroughly in water.

Soft drinks may cause tannin stains, which should be removed while fresh. Sponge the stain with water, then rub in glycerine, let stand a half hour, and rinse with water.

Chewing gum on fabrics that dont watershed may be removed easily after the area is rubbed from the wrong side with a piece of ice.

Grass and fresh garden-foliage stains on washable materials usually may be removed with water and soap if you rub the stain well. A chlorine bleach may be used to remove any remaining stains on white materials.

Grease spots on fine materials may be absorbed by dusting cornstarch or white talcum powder on the spot, letting it stand until he grease is absorbed before brushing it off. Or place the greased spot between clean blotting papers and press lightly with a warm iron.
