A Summary of the Proposed Kentucky Constitution Revision as it affects LOCAL GOVERNMENT

A key sentence in the Constitution Revision says: "Units of local government may create any democratic form of government and perform any functions not denied to them by their own charters, the Constitution or general law." Local governments, would be able to do what was not specifically denied to them, Now, local governments have only the powers specifically granted to them.

LOCAL ELECTIONS Under the Revision, local voters would continue to select their own elected officers, voting for them at the same time they chose their Representatives and Senators for the General Assembly. Present elective offices would continue until changed by general law.

TERMS OF OFFICE The chief executive and the members of all units of local government would be elected by local voters for terms of no longer than four years.

RELATIONSHIP OF LEGISLATURE The State Legislature could exercise authority in providing forms and functions of local gov-ernment. It would continue to have the power to make classifications of cities.



stitution Revision would prohibit any county from being merged or abolished without ap-proval of the voters residing in that county. Under the present Constitution a county may be abolished by the General Assembly.

TAXATION AND REVENUES Under the present Constitution, county tax rates are limited to fifty cents per hundred. The Constitution Revision permits rate and limitation to be set by general law. The Revision would permit the State to share a portion of state tax revenue with cities and counties. Also, local units of government, as well as school districts, could finance schools and other public buildings with general obligation bonds.

This is a personal message to you from your school superintendent. First, I want to tell you that I have nothing base' to say about our opponents. I do not believe in that. As far as I know they are filme postpondarial do not know what they would do if elected.

But, what do know is how your present Board of Education works, what they stand for, and what they plan to do in the future. Your present Board of Education has your child at heart. They have provided for your children safe, comfortable transportation; good warm clean classrooms; good library facilities; materials and equipment to teach with and good teachers to teach; all without raising your taxes.

¹ We have capable, qualified teachers sincerely dedicated to the profession and doing a fine job. The schools are well organized and with good discipline. Our high school graduates are ac-cepted in superior colleges. All four consolidated schools are rated highly by the State Depart-ment of Education.

Our new Federal Program has also been rated highly. Hundreds of needy children have been helped by this program with shoes, clothing, additional transportation, glasses and many physi-cal detects have been corrected. Our school nurse and social worker are helping children each day in some way. The reading meachers are giving the children who need it extra help in reading so they can be successful students. Approximately 2000 of our dear children have been helped already in some way by this program. Of course, we needed this money for buildings but that wasn't what it was allocated for so we had to take it and use it the way the guidelines from Washington excited. Washington specified.

We have consolidated fast. A few short years ago, we had over 75 one-room schools and now we have only 7. We know that further consolidation will take place in the future. We know that a central high school will come sooner or later but this Board wants to build it with State and Fede-ral funds and not over tax the people of Rocksatile County. That project will cost approximately 1¹ million dollars and would nore than double our taxes to pay off the bonds. We have been pro-mised a Vocational School which will be paid for mostly by Federal funds and that is the way we want to pay for the high school.

we want to pay for the high school. Your school account has never gone in the red any year since I have been your superintendent. Not many school systems in the State of Kentucky can say this. Your Béard of Education and I believe in sound financial dealings. Your school account has been in the Bank of Mt. Vernon all these years. You may call the President of the Bank of Mt. Vernon (Mr. H. M. Smock) in re-gard to these heats if you like. Our bookkeeper (Mr. Lloyd G. Shutts) will be glad to show you his books and audit reports at any time.

If you wish to continue to have your schools operated in this business-like manner; to stay, within the budget; and not raise your taxes then keep Mr. Preston P. Nunnelley and Mrs. Vashti Mullins on your Board of Education.

I wish to thank each of you for your wonderful support in the past and I wish to say that I have enjoyed working for you. Trusting that you will make it possible for me to continue serving you in the same efficient manner, I am,


