Avoid Too Much Fat, Saturated Fat, and Cholesterol

If you have a high blood cholesterol level, you have a greater chance of having a heart attack. Other factors can also increase your risk of heart at-tack - high blood pressure and cigarette smoking, for example-but high blood cholesterol is clearly a major dietary risk indicator.

clearly a major dietary risk indicator. Populations like ours with diet in saturated fats and cho-lesterol tend to have high blood cholesterol levels. Individuals within these populations usual-ly have greater risks of having heart attacks than people eating low-fat, low-cholesterol diets. Eating extra saturated fat and cholesterol levels in most people. However, there are wide variations among people -related to heredity fand the way each person's uses cholesterol. Some people can consume

Some people can consume diets high in saturated fats and

diets high in saturated fats and cholesterol and still keep nor-mal blood cholesterol levels. Other people unfortunately, have high blood cholesterol levels. Use the seven if they eat low-fat, low-cholesterol diets. There is controversy about what recommendation are ap-propriate for healthy Ameri-cans. But for the U.S. popula-tion, as a whole, reduction in our current intake of total fat, saturated fat, and cholesterol is sensible.
