





That com-bination will enable us to provide the highly skilled techincal care for the additional platients," Stewart said: "Our ventilator care program is traly one of a kind," Stewart com-mented. retevision in the nation's classrooms is not a new idea, it's been done for nearly forty years. Showing com-mercials in the classroom is a new idea, and it's certainly generating lots of heat. Where's the light? Whether Whitle Communications will succeed in its plan to put a 12-minute.

or near, where's the tight? Whether Whitle Communications will succeed in its plan to put a 12-minute news program with commer-cials into the schools will altimately be decided by educators, to whom the decision should be formed by some perspective on what's already being dong with levision in the classroom. Thefe are also growing numbers of public-private partnerships working for education that do not involve commercializing the educational experience, and these should be en-couraged.

experience, and these should be en-couraged. Instructional television without commercials how reaches some 20 million elementary and secondary school children every day. These programs are curriculum-based, and their instructional design has been screened and approved by culcutors. These noncommercial programs are made available to classrooms around the country primarily by the broad-cast signals of this nations; 335 pub-cast signals of this nations; 335 pub-cast differ, several public broadcast ing organizations are distributing over 1,500 hours a year of instruc-tional programming. In addition, hundreds of hours of broadcast series such as "Segame

are being used to supplement and rein-force classroom teaching. Public television is also working to build nev pathways to the schools. The South Carolina Educational Television Network provides an educational service for its citizens from pre-school to post-retirent through a system of broad-cast, satellite, cable, and Instructional Television Fixed Service (ITFS)tech-nologies that is unequaled in the nologies that is unequaled in the world. Public television station WTVS in Detroit is making a major commitment to help solve the prob-lems of drugs, drop-outs and violence among young people in its community

community. As for business-education partner-ships, concern over the nation's edu-cational crisis is prompting mote corporations to pitch in. As <u>The New</u> <u>York Times</u> reported last December, corporate America is starting to shift more of its philanthropic support from higher education to elementary/sec-

The 1990 Budget: **Smoke and Mirrors Again**

The budget passed by the House last week proves again that Congress needs budget reform. Once again, Congress has relied on smoke and mirrors to come up with a budget that lowers the estimated deficit only on paper and fails to adequately address America's most pressing problems.

As a member of the House Budget Committee that drafted this bill, I wanted to be able to support the final version on the floor. However, because it so blatantly papered over the real deficit while misspending our resources, I simply could not swallow it and voted "Nay".

The noted Gramm-Rudman law requires Congress to reduce the deficit from about \$147 billion in 1989 to \$100 billion in the 1990 budget. To achieve that \$47 billion savings, President Bush proposed a "flexible freeze" and indeed won his election on that evenhanded approach.

How did Congress shandle if by trying to fudge the numbers, by smoke and mirrors designed to fool the American people so as to avoid the seponsibility of cutting spending to match reveaue. Congress counted the annual \$70 hillion surplus in the Social Security Tras Fundé ai general revenue, even though they are est asile for the delery and disabled. Ditto for Airport and Highway Trast funds. At the same time, Congress hid the huge Savings and Loan losses of about \$50 hillion in 1990 by not counting it in the budget, as well as the \$18 billion loss expected in the Postal Service next veat. year

Congress further said it would "cut" \$1.8 billion in Agriculture programs. How? By making farm payments in 1989 instead of 1990! That is a savings?

How? By making larm payments in 1989 instead of 1990? That is a surgis? In order to avoid the necessary but difficult spending cuts. Congress grossly overestimated expected revenue by predicting a 7.5% prime interest rate; and tremendous economic growth. The budget also called for 55.4 billion in new taxes (which won'to be enacted). 52.7 billion in new "user fees" (which won'to e macted). 55. billion "awed" by counting unused food samps (which could be cashed in any day by holder). 55.7 billion from the onetime sale of government assets (this has been talked about for years and has never happened)

But the sham attempt to realize real deficit cuts is only one side of the ledger.

reager. Congress also failed to address America's foremost problems in deciding how to spend 1990 funds. Defense would be frozen. That migh be accept-able if all others were required to sacrifice. However, liberal, social spending is increased by \$3.5 billion, not counting the increase sutomatically occur-ring in entidement programs like Medicaid, Food Stamps, Aid to Families with Dependent Children, etc. Much of this new \$9.5 billion is even set aside for programs not yet even enacted.

In the meantime, America's worst problem, the scourge of drugs, con-tinues to soar because Congress failed to fully fund the "War on Drugs" which it promised last year.

And as America flounders against the new high-tech economic competi-tion from new global powers, Congress starved our science and technology budget: We will likely not be able to fund the Space Station and Super Conducting Supercollider; two vital programs to boost America's leader-

So in the 1990 budget, Congress has not changed—it hides the truth from Americans and shirks responsibility for making the hard decisions on spending.

In the war on the deficit, Congress has surrendered. In the war on drugs, congress has fled to Canada. In the war with words, Congress is betting you Congress man won't catch on.

History of Extension Service in Rockcastle County

Frank Montgomery, first County Agent in Kentucky, was appointed Sept. 1, 1912 to begin work in South-em Madison and Rockcastle Coun-ties. The funds for this and seven ties. The funds for this and seven other appointments through April 1, 1913 were furnished by the office of farm Management of the United States Department of Agriculture and the county in which the work is done on an approximate half-and-half basis Mr. Montgomery was called Spe-cial Investigator and Demonstrator, He was working under an agreemen between Berea College and the United States Department of Agriculture, made in 1912. (This really was the start of county agent work, two years before the Smith-Lever Act in Con-gress started the present program, and an early sign of the poncerning work Berea College has done through the years in connection with county agent work.) The Extension Service was offi-cially esablished in 1914 by the federal Smith-Lever Act for the most part, it is financed coopera-

After passage of the Smith-Lever Act, Robert F. Spence was employed July 1, 1914 as county agent of Rock-castle-and South Madison countes, and served in this capacity for 40 years. Upder this set-up Berea Col-lege cooperated with the Extension work with the University of Ken-tucky, Rockcastle County and the United States Department of Agri-culture.

During the forty year period. Mr. Spence served as county agent, ap-proximately forty assistant county agents received a part of their train-ing in South Madison and Rockcastle

County. In 1913, county extension work economics was begun in Kentucky. Miss Eila Carson was appointed Home Demonstration Agent for Rockcastle County February 1, 1914, Rockcastle, Madison and Magoffin inties were the first counties served

counties were the first counties served by home agents in Kentucky. Many of the first appointments of County Home Demonstration work, ers were for sumplier months only. This was due to the popularity canning work carried on with girls. Counay funds were obtained to ap-



point women for the summer months to give instruction in camning. The first full-odged home dem-onstration agent started work in Madison and Rockcastle Coduties in 1928. The work was sponsyled by Berea College who finaßecd the county appropriation. Homemukers Clubs were first organized in communities of South Madison around Berea in 1929, with one club in central Madison near Richmond called the Pond Club. The Pond Club grew rapidly and soon women from five communities were enrolled in the club. The agent in Rockcastle and South Madison terri-Rockcastle and South Madison terri-tory was allowed this one club out of the territory, and could not divide the club. The women of Central Madison saw the need for a Home Demonstra-tion Agent stationed at Richmond. Because of their enthusiasm for the work the women of the Pond Club convinced the Fiscal Court of Madiconvinced the Fiscal Court of Madi-son County of this need and they appropriated for a Home Demonstra-tion Agent in February of 1930. The club withdrew from the Rockcastle Amona South Madison County Home-maker's Association at the Annual Homemaker's meeting. August 5, 1930 and was divided into five Homemaker's Club's – into a Madi-sen County Homemaker's Associa-tion.

By 1931 the Homemaker's Clubs By 1931 the Homemaker's Clubs of Rockcastle and South Madison were united into a County Home-maker's Organization. There were eight communities organized and carrying a fullprogram of work. There were seven communities organized in special groups and carrying on activities suited to the community needs.

In special section sector activities suited to the community sector, According to records, the clubs lecated in Rockcastle County were: Livingston and Wildle, with others in Southern Madison. Effective July 1, 1957 the South-ern Madison Area was absorbed into the Northern Madison County pro-tee Northern Madison County area. as a single county unit. The change in

FLEXIBILITY AND COMPETITIVENESS

ILEXIBILITY AND COMPTENDERCESS IN THE NEW PARM BILL When the debate began on the 1985 farm bill three common themes emerged: a defined effort to make U.S. agricultural products more competitive in world markets, an emphasis on reducing stocks to more manageable levels, and a committement to maintain farm-ers' income. Based on these three criteria the 1985 Food Security Act has done a very good job seeing our farmers through some very difficult times. I believe the 1985 legislation has provided a solid foundation to write an even better farm bill. After five years, problems have arisen that could not have been anticipated when the original bill was signed mto law. As we draft a new farm bill which will be im-plemented in 1990, it is virial that we provide more flexibility in the legislation to allow for inevitable changes in market and agriculture conditions. These ingredients will allow farmers to increase their com-petitive advantage which is critical in world frade. Agriculture is now more global than at any other time in histo-ry. Total world grain production set a record during the 1986-1987. Torop year and world grain spreulture did contribute a large share to he record stocks: other countries such ag China, Argentina, Brazil, and the European economic community were increasing acreage dur-ing a period when U.S. agricultural policy was limiting planted acreage. International trade is oneof the keystones of U.S. agricultural

ing a period when U.S. agricultural policy was limiting planted acreage. International trade is ongof the keystones of U.S. agricultural policy. In order to maintain our status as the world's largest agricul-tural exporter, it is essential that the next farm bill be streamlined to reduce bureaucrait; red tape. For example, Kentucky has many small farmers, but they are required to fill out as many forms and are burdened with the same compliance procedures as farms many times larger. This is not to say that they should be given special privileges, but it should be recognized that our small family farms have special needs. By building more flexibility into the 1990 farm bill, farmers will be able to react more quickly to market signals and avoide being indicate soybearis are more profitable than corn, the opportunity to sore opportunity costs or government interference. I realize that there will be no shortage of opinions or lack of suggestions on how to improve on the current bill, will use my po-sition on the Sante Agriculture Committee to defend Kentucky's agricultural interests while working to continue the trend of more strength and compentiveness for American agricultural products

Farm Credit Services returns 95 million

Farmers who are members of Farm Credit Services may soon be receiv-ing a check as part of the coopera-tive's 395 million stock retigement. From the London Farm Credit Serv-to e office, some 3497-300 will be re-turned to farmers in Bell, Clay, Har-tan, Jackson, Knox, Laurel, Leslie, Owsley, Rockcastle, and Whitley counties.

Owsley, Rockcastle, and write-counties. The retirement is the result of the consolidation of the Production Credit Association (PCA) and Federal Land Bank Association (PEBA). The consolidation combined the strongly capitalized PCA with the high volume of the FLBA. Because of the resulting financial strength of the new oreanization, Farm Credit the new organization, Farm Credit Services of Mid-America, ACA, new capitalization bylaws could be estab-lished. As a result, stock requirements for

taking out a loan dropped from 8 percent or 5 percent down to just 3 percent.




