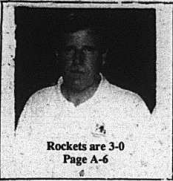

Junie Kirby arrested on drug charges

A Rockcastle County man who shot and killed his pregnant girlfriend in 1995 has been arrested on drug charges.

Wally "Junie" Kirby, 44, of Castle Village Apartments Broadhead was arrested on Monday and charged with manufacturing methamphetamine.

Kirby and his current girlfriend Juanita McCormick Watkins, 30, also of Castle Village Apartments, were arrested on Monday by Broadhead City Police Officer William Harris.

Harris arrested the two after the Rockcastle 911 dispatch received a complaint.

Harris said that when he arrived at Castle Village, Kirby and Watkins were apparently making the illegal drug methamphetamine in a wooded area behind the apartment complex and that they had several of the ingredients used to make the illegal drug in their car.

While Harris was searching Kirby's vehicle he came across a milk jug that Kirby told Harris had milk in it.

Harris said that when he opened the jug it actually was a type of ammonia used to make the illegal drugs and that Harris was overcome by the fumes.

Harris was admitted to the Rockcastle Hospital, where he was treated for the affects of the ammonia. Harris was kept overnight at the hospital and will not return to work until this Friday.

When Kirby appeared in court on Wednesday he was found in contempt of court by District Judge Mike Henry for disrupting court and his case on the charges of manufacturing meth were not heard.

He is due back in court on September 12th and is being held on a \$50,000 cash bond.

Kirby pled guilty in 1998 to second degree manslaughter and received a sentence of five years in prison for the February 24th, 1995 shooting death of Tracy Caudill, 22, of Orlando.

Caudill was carrying the couple's second child when she was shot. Kirby pled not guilty and claimed self-de-

Fiscal Court takes over ownership of former school

The Rockcastle County Fiscal Court voted last week to take over ownership of the former Livingston School property and to begin the necessary steps to put it back in condition for public use.

The school was closed in 1994 by the Rockcastle County Board of Education and has deteriorated and been heavily vandalized.

Daniel Boone Development Corporation bought the property in 1996 thanks to a \$42,000 state grant, but no work has been done on either structure.

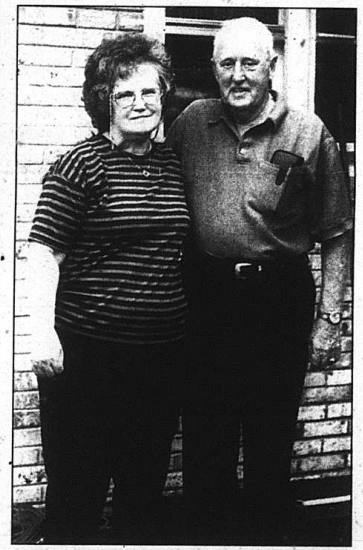
Following is a time line of events surrounding the Livingston School: 1994: Rockcastle Board of Education close the Livingston School.

1994-1996: Livingston School property continues under ownership of the Board of Education. Board of Education becomes concerned about the future use of the structures and the property's vandalism.

1996: Daniel Boone Development Board, Inc., with main office in Manchester, looks over the buildings and seeks ownership of the property. By state law, the School Board cannot hand over the property without just compensation.

July 1996: State Representative Danny Ford provides \$42,500 state funding to Daniel Boone Development Council, Inc., to purchase the Livingston School property from School Board. Transaction is completed.

I also thought of the one, "You can't teach an old dog new tricks." I would see for myself which was true.

I did go back to sleep. If the sun came up and tried to get in my win-

dow, it did a good deed and put the bright lights out. So, with the coffee ready, the paper on the porch, eyes opened, exercises to limber aching joints and strengthen stiff knees over with, I am pecking on typewriter keys

so, come Thursday, you will have something to read about. Every coin has two sides, and every coin has an ending. Also above every cloud, the sun is shining. So I am depending on some of them to become a reality in my life.

The very next day after I began this continuation of last week's Sweet and Sour column, a new chapter of the story began.

Big signs advertising the opening of The Berea Bank, the positioning of it blocking my view and use of the public pass way adjoining my drive has caused problems. So, when two of the receptionists, David and Tina came to give me a personal invitation to attend, I was quite adamant in my refusal to accept their invitation. It didn't mean a thing to me. I was not going. The black fence on top of the beautifully laid blocks beneath,

was not the white picket fence of my dreams, where I could plant and little with flowers and cut blooms from them to fill the vases I have tucked away. The bright lights shining in the windows all night long and the mantic candle light. The drive around the building to the drive thru windows was not a gravel driveway to my front door where a welcome mat greeting friends and kinfolk at any time of day or night. I was still upset about the public ally they used enough of that blocked my use, as well as anyone else that needed to get from Travis Street. I was invited to attend it ended. Yep! wears me out and Friday was one of those days. My shoes were already kicked off and feet ready for the lounge chair when I looked up to see David and three young women with arms full of a big tray filled with snags, goodies and one carrying a large gorgeous big live plant as a gift from the bank, standing in the door. David had kept his word and treated me as if I had been an absent guest by delivering it himself, accompanied by three attractive assistants. Now I had met five of the six bank employees and, as it turned out, would be meeting others before the night was over.

Again, I must say, we had better wear carefully how we word our answers, for once in a while, we may have to retreat and eat the words. I hadn't said maybe, or perhaps if you coax a little I'll change my mind. I

had said emphatically, I am not going. Those words didn't taste too bad when, after David supported by the help he had brought along, insisted I put on my shoes and got the few steps to the bank where a few of the kids of the celebration was over and he would take me on a personal tour of what I had missed. Now who could deny such a nice young man and three pretty girls an invitation to accompany them the few steps it would take to go see and brag about the place they had watch being built from scratch, were the first to be hired to manage and take care of it and would have been spending most of their future life in. Of course, I put on my bedroom slippers, took up with David's arm with a pretty girl holding the other, and proudly marched down to see the new bank. I must say the inside of the bank is beautiful, well planned and decorated with good taste. The conference room formal enough for the board to be comfortable. I found out David was for growth or plain enough for the comfort of staff during a break. The young women I met were attractive, pleasant and a staff anyone would be pleased to do business with. One last look around before I was ready to leave revealed a scene outside the big triple that brought a gasp to my throat, for there was the well kept lawn and whole scene I had watched change from spring to summer, then autumn, and finally winter covered with a layer of snow. The only thing missing was the beautiful trees that announced what season it was by changing to the appropriate color. The architects or lawn care designers had stolen "my scenery" and left in its place the backside of a brick building with blinding lights attached at intervals overhead pointed in such a way as to be in a direct line with my windows facing the bank. I am sure this wasn't done purposefully or for malice, it just happens to be one of the misfortunes that has been hounding me for the past few years and good fortune are a beautiful location in a quiet residential neighborhood for modern expansion and development to take hold. What better business venture could fill that street corner than a brand new bank.

Thanks to David, and one of the girls, I was escorted home safely. The words (of refusal to the invitation), I ate, weren't so bitter after all. David promised I could watch out the big window anytime I was gone for me, and they might find a better way to dim the lights.

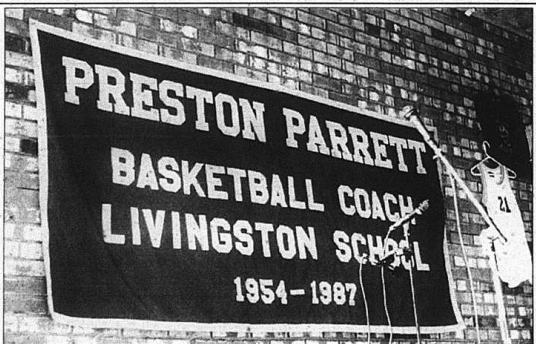

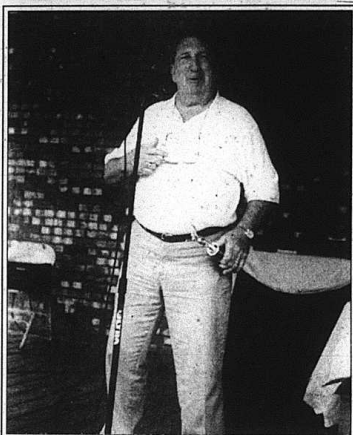

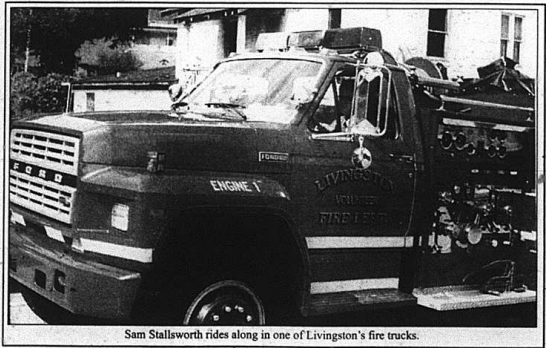

Rockets take Honey Bowl in big way 47-6

The Rockcastle County Rockets used a high octane offense, and a smothering defense to win their third straight game of the season on Friday night, over Breathitt County in the Honey Bowl.

The Rockets traveled to Jackson where they came away with a 47-6 win over the two time state champions.

Quarterback Aaron Anderkin was named most valuable player of the contest after he threw for five touchdowns and ran one in from 67 yards.

He had no interceptions. All told the junior had 236 yards on eight of 15 passing and he had 67 yards on the ground.

As a unit the Rockets racked up 438 yards of offense with senior Josh Hale catching four touchdown passes, and accumulating 142 yards through the air. Hale was named offensive M.V.P. for the Rockets.

Senior P.J. Rowe also turned in a stellar performance on the defensive side of the ball with eleven tackles and assists and four quarterback sacks.

Rowe was named defensive M.V.P. for the Rockets.

The Rocket defense gave up only 123 yards to Breathitt County, who had been picked to be the best team in the mountains.

The turning point of the game was probably just before half-time when Breathitt fumbled on the ten yard line with 27 seconds on the clock, thanks to a huge hit by Rowe.

After the Rockets took over, Anderkin hit Josh Hale in the end zone and the Rockets took a 21-6 lead into half-time.

"I thought that was really big for our team - it sort of took the wind out their sails," said head coach Tom Larkey, who coached Rockcastle to its 143rd win while head coach.

Head assistant Tony Saylor, who is well known for his preparation and who has been with Larkey each of the 17 years he has been at the ROCK,

said his defensive unit played well.

"They have a really good team and one of the best offenses in the state and our kids were up to the challenge," Saylor said.

Breathitt County was the first team to gain positive yardage on the ROCK.

Larkey and Saylor both had nothing but praise for the offensive and defensive lines.

"We made a few mistakes on both sides of the ball, but our line-men have played extremely well early in the season - we had time to throw-and holes to run in on offense and we understand what is going on," Larkey said.

The Rocket offensive line consists of juniors Tanner Abney, Michael Brummett, seniors William Blair and Adam Childress, and sophomore Jason Leger. Junior Stephen Boreing plays tight end and senior Jason Ranney plays center when Blair moves to the end position.

"Defensively the line has also been up to the task - they are a hard nosed bunch of kids who accept the challenge they are faced with each week," he said.

Defensive linemen for the Rockets are Steve Blair, Adam Childress, Tanner Abney and Jason Leger.

The Rockets scoring went as follows: Third play of the game, Anderkin hits Hale on a 64 yard streak down the middle.

Jens Strietzel made the extra point and it was 7-0.

Also in first period Anderkin takes off on a quarterback sneak, which results in a 67 yard touchdown run.

In the second period Anderkin hits Hale on a ten yard pass as time expires and the ROCK takes a 21-6 lead into half-time after another good kick.

Rockcastle did the real damage to Breathitt in the third period when they scored three times.

First Anderkin hit Hale on a 40

yard touchdown pass and then he found him again on a 24 yard touchdown pass.

To cap off the period and seal the Bobcats fate, Anderkin hit junior Marty Reagan on a 76 yard pass.

Sophomore Devin Taylor finished off the scoring with a 23 yard run.

Offensively Reagan had 95 yards on 15 carries and caught three passes for 84 yards.

Junior Cletl Swinney had six rushes for 24 yards.

Senior Josh Taylor and junior James Bussell each had three rushes.

Junior Stephen Boreing caught one ball for ten yards.

Strietzel was five for seven in extra point attempts.

Besides Rowe, middle linebacker William Blair had ten tackles and assists and recovered a fumble.

Leger also recovered a fumble and had six tackles and assists.

Reagan had seven tackles and assists and senior Clay Dooley, who was nursing an extremely sore ankle had five tackles and assists.

Dooley who usually starts at half-back on offense did not play on that side of the ball because of his injury.

Steve Blair, Bussell, Abney, Boreing and Hale each had four tackles and assists.

Childress had two tackles and Michael Hayes, Matt McClure, Brad Wesley, Chris Croucher and Swinney all had a tackle.

The Rockets will face Lincoln County at home on Friday night.

The 11th annual Renfro Valley Jamboree Bowl will be a re-staff from last year, which saw the Rockets defeat Lincoln in the Death Valley Bowl.

"Our biggest concern is their speed, especially that of junior Jesse Smith, we have to try and keep the ball away from them," Coach Saylor said.

Game time at the ROCK is 7:30 p.m. on Friday night.



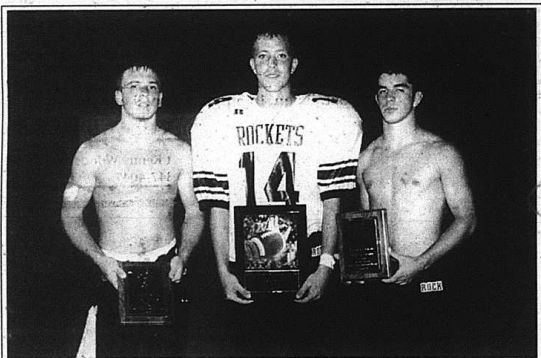

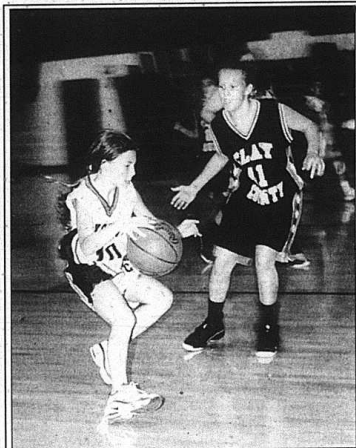

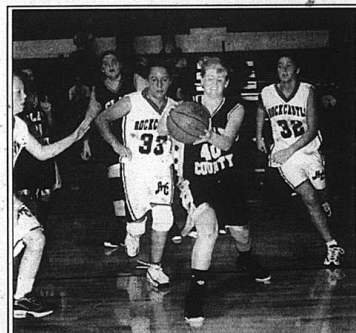

Ward Burton wins Southern 500 in Dodge

Ward Burton, driver of the No. 22 CAT Dodge of Bill Davis Racing gave Dodge its second win in three weeks as he took the checkered flag, Sunday, in the 52nd Southern 500 at Darlington Raceway.

Burton passed last year's Southern 500 winner Bobby Labonte for the lead on lap 360 of the 367-lap race just as a five-car wreck happened behind them.

After a red flag period, while speedway crews cleaned up the track, he then held off Labonte and Jeremy Mayfield on a restart with just four laps remaining.

"I was just the driver," said Burton. "It was the guys in the pits that did all the work. But it ended up pretty good."

"I don't know if I'm the best driver, but I sure had the best race car."

The win was his first of the sea-

son and third of his career. He started race from the 37th position.

Polesitter, Kurt Busch, driver of the No. 97 Rubbermaid Ford finished 39th.

"The alternator went dead; so I had to shut off all the switches," he said. "When I shut off the brake switch, the brakes filled and I went into the fence and knocked the toe-out. It was just a matter of getting tires back on it, but the toe-out was so bad we blew another right-front and went into the fence again."

Robin Pemberton, crew chief for the No. 2 Miller Lite Taurus driven by Rusty Wallace, found himself in the wrong place at the wrong time earlier today in the garage area before the race. Pemberton was inadvertently hit in the left eye with a ball of tape (about the size of a baseball) that was thrown by a member of another race team. Pemberton suffered a cut on the cornea and had a patch put over the eye by the infield care center staff to protect it during the race. Plans call for Pemberton to have the eye examined further after returning home to Charlotte.

1996-2001: Daniel Boone Development Council's board of directors seeks special state funding for the Livingston School. Among the scope of work sought were assisted living apartment center for adult education and small retail shops. In addition, the gymnasium would have been rehabilitated for use as a community center.

Representative Danny Ford and County Judge-Executive Buzz Carlolitis met with Development for Local Government officials seeking additional funding for the Livingston School property. Daniel Boone Development Council's proposals. Requests for funding were denied by funding agencies as outlined by DBDC.

Carlolitis and magistrates toured the renovated Midway School in an effort to interest Holly Wiedemann Associates in Livingston School property. Mrs. Wiedemann said she was especially impressed by the structure of the main building and would initiate funding contacts.

An entrepreneur approached the County and the Rockcastle County Development Board concerning the school property. Carlolitis explained that the property was still in the hands of DBDC, but that the County would be very interested in having an employer come to Livingston. The entrepreneur, however, insisted that if he came to the Livingston School, he would have to have the entire property - including the gymnasium that would be used for lumber storage. A Rockcastle Development Board committee and Judge Carlolitis met with the entrepreneur and the state's Economic Development Cabinet officials to help spur interest in the Livingston property.

August 2001: Judge Carlolitis receives word from Holly Wiedemann that proposals for the Livingston property are, in all reality, not eligible for any future funding by the state because the City of Livingston's city council does not participate in the state's Renaissance Kentucky program. (Mt. Vernon is the only town in Rockcastle that does participate, making it eligible for greater consideration by the governor's office during funding cycles.)

Faced with the further deterioration and vandalism of the property, along with the news that state funding would be not available for envisioned projects, Judge Carlolitis asked the fiscal court's magistrates to assume ownership which Carlolitis outlined his goals for the property. Squire Jack Bradley made the motion (seconded by Squire Donald Bullock) to give the judge permission to sign all documents to secure the property for the county and sign all documents with the Department for Local Government to secure the \$100,000 special state grant set aside by the legislature and the governor's office for the property.

"I want to thank Rep. Danny Ford for making this limited grant available for the Livingston School property. Unfortunately, the county could not spend it on the property while it was in private hands, and other funding activities were being looked into. Finally, everything came into focus for us on the fiscal court this month," he said.

"The Livingston School's main building is, architecturally speaking, one of the most pleasingly designed buildings in Rockcastle County. As long as it is standing it can be of use to Livingston and the county. I know that several people have advocated tearing it down. If that were to happen, it would be just another vacant lot. The building can be of use, and only last week I toured a small manufacturing facility located in an old school building that was nothing near the quality of building as the Livingston school. I know there are future uses of the property that can

bring good paying jobs to Livingston. While our doors are not being knocked down by employers looking for abandoned school buildings, I know they do exist. One I recently visited paid their employees well and provided top quality medical insurance. With the county's new ownership of the property, we can now renew our efforts to see that this property is utilized in a manner that will be beneficial to our Livingston community," he said.

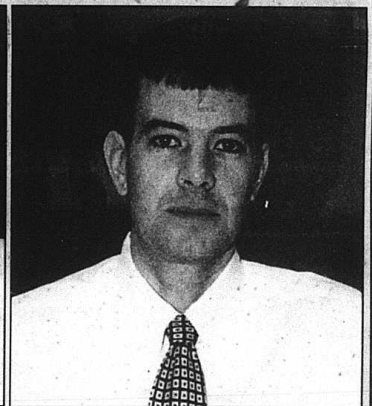

Gardening & Landscaping Tips

Large, Fast Growing Shade Trees That Bloom

Though waterfeatures and stone work are "hot" landscape projects currently, trees will remain an important fixture in most yards. Let us suppose you want a tree that grows fast, becomes a large shade tree and also blooms.

Each tree in this category has positive attributes (but also some negatives). Let's begin with a beautiful large shade tree that is a good timber tree and used to be the Kentucky State Tree. That would be the tulip poplar.

Tulip trees grow fast, and in ideal conditions reach over 100 feet tall in 25 years. The yellowish tulip flowers in May are large as a saucer. The big leaves are attractive and turn a lemon yellow in the fall. Earlier in drought years. The only real drawback is some limbs may be blown out in high winds (but not as much as Bradford Pears). Large trees are nursery grown, but if you have a couple years patience, small ones can be attained free in the wild in Kentucky in fall or winter.

Next, the catalpa tree. This tree grows fast into a very specimen, somewhat 'gangly' looking specimen. When in bloom in May or June the catalpa's white bloom clusters exceed the impact and beauty of a

Bradford Pear any old day. The trunks are decay resistant and can make good posts and beams. Drybacks include mess from the large brown bean seed pods, no fall color, and worms eating the leaves dragged in some years.

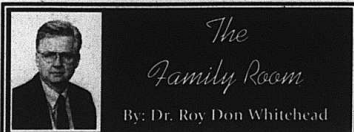
The Paulownia or Empress Tree (named for royalty prior to Communist conquering Russia) is an extremely fast growing tree. I have witnessed growth from a 5-foot whip one year old and big around as my thumb turn into a tree with the size of a 1-pound coffee can in just three years! Japanese paper companies grow plantations of them for pulp wood. The leaves are dinner plate size and bigger. The candlebars of bluish purple flowers in late spring are awesome to behold. Limitations are no fall color, young trees often frostbite badly in spring, large seed pods will eventually clutter the lawn, and a 'rough' appearance as an older tree.

The light tree (Ilex pedunculata) is a zone 6 hardy, which includes our community. I am experimenting with growing this tree from seedlings in containers; it is not commercially available. (I have seen these trees near Myrtle Beach.) They look similar to catalpa. Large leaves. No fall color - but beautiful red berries hang on female trees. The biggest draw-

back I can think of is that no nurseries to my knowledge propagate this species. One would have to plant several, as both male and female would be required for the fruits to set. A large lot, to accommodate several of these large trees would be necessary to insure likelihood of the red fruit clusters. Might get a couple neighbors to cooperate if you have room for but one tree.) Unusual.

Some other trees that meet at least two of the three criteria of the title include fruit trees, magnolias, Bradford pears, mimosa, linden, crab apples.

Additional articles will follow this fall on selecting trees for your needs as you continue turning your yard into paradise.

Bishop Armstrong Kamau Cheggeh was born in the Kiambu District of Kenya, East Africa. He came to know Christ as Savior at a very early age. He began preaching at the tender age of sixteen. He has now preached for 31 years.

Bishop Cheggeh first came to the USA in 1982 and enrolled at the Rosedal Bible Institute in Irwin, Ohio.

After his graduation he again enrolled at the Central Bible College in Springfield, Missouri where he completed his undergraduate studies in 1984. He took his graduate studies at the Vanguard University of Southern California and earned his Masters in Religion. After his return to Kenya in 1987 he established a congregation that now has a membership of five

hundred people.

In 1991 Armstrong went back to Seminary again, this time he enrolled at the Nairobi International School of Theology. Here he earned a Masters degree in Christian Ministries (MACM). After seven years he now is enrolling at the Asbury Theological Seminary in Wilmore, Kentucky, where he will do Doctor of Ministry program. He will be a full time student for one year, after which he will return to Kenya to continue with his studies for two more years. He will graduate in May 2004.

Bishop Armstrong will be available for ministry while he goes to school. He will accept invitations in Kentucky and any state that borders Kentucky. He will be glad to do Revival meetings, marriage enrichment seminars, spiritual warfare conferences or seminars and general Sunday morning preaching.

Ministry needs include Missionaries: need both short term and long term missionaries, two four wheel drive vehicles for ministry in Africa, a good vehicle for the Cheggehs to use while in the USA, floor carpets (old or new), musical instruments: drums, guitars, pianos, etc., good computers, printers and scanners (old and new), Christian books and Bibles, good video projector, over head projector, monthly financial support for all the ministries we are involved in, one time large financial gifts to assist in the building of churches or the

purchasing of land, funds to sponsor Bible school students.

Several churches have already been built. Two of these churches are not only large, but are also built of stone. This is the best way to build in

Kenya. To build the less permanent tin churches we need only fifteen hundred dollars for each church. However, when we build a larger and permanent church, our people in Africa raise six thousand dollars, while our American friends raise the twenty-two thousand dollars.

Friends, please consider assisting us in building at least one church, whether permanent or not. Right now we are in the process of purchasing twenty plots on which to build churches. We will need to raise \$40,000 to pay off all those pieces of land. Would you please consider assisting us in this very worthy endeavor.

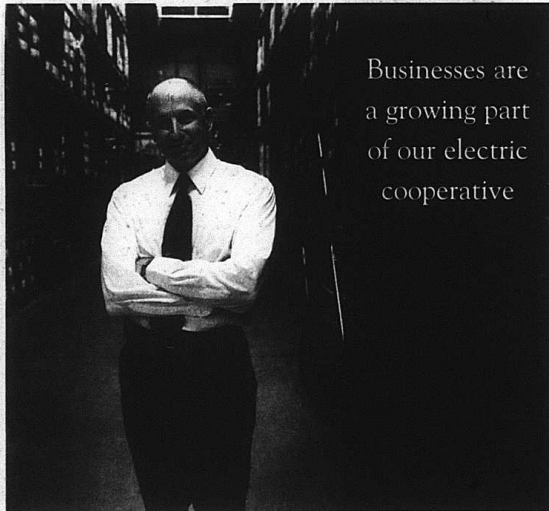

Yummy Cream Soups

When you were a child, what was your favorite cream soup? Many people would probably answer potato soup. Potato soup was and probably still is a standby in most homes. It is easy to make and can be seasoned to your taste.

Cream soups contain milk or cheese and are often good sources of calcium. Most of the time, the cream soup has a thick, creamy consistency. Using low fat milk products will lower both the calories and fat in the soup.

Have you ever tried pumpkin soup? What about a squash soup or broccoli soup or cauliflower soup? There are many cream-type soups and the sky is the limit. Look in your favorite cookbook for cream soups.

When making homemade cream soups, the soup must be stirred often. Milk products will stick to the bottom of the pan or "scorch" if it is not stirred often or if the heat is too high. When milk boils it often will

"boil-over" the pot. Be very careful when cooking milk products.

You may have a favorite potato soup recipe, however, here is a recipe with a twist. Instead of using fresh potatoes, it uses frozen hash browns. Shredded hash browns make a thicker soup, while southern-style (cubed) hash browns make a chunkier soup.

No Fat Potato Soup
1 32-oz pkg frozen hash brown potatoes
1 medium onion, chopped
1 1/4 1/2 oz can chicken broth
2 cups water
1 can cream of celery soup, undiluted
12 fl. oz. low-fat evaporated milk
Wash hands and surfaces. Combine first four ingredients in large soup pan. Bring to boil. Cover and reduce heat. Simmer for 30 minutes. Stir in soup and milk. Heat through. Makes 8 servings. Per serving: 138 calories; Fat 3 g; Total Carbohydrates 23g; Sodium 476 mg.

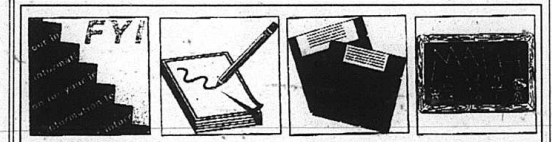
"What Saith the Scriptures"
