Rockcastle County and Mt. Vernon gets grants

The county and the City of Mt. Vernon were recipients recently of a total of \$312,090 in Kentucky Transportation Cabinet bond funds.

County officials and Mt. Vernon Mayor Clarice Kirby received ceremonial checks at an event held last Wednesday afternoon at the courthouse.

The county will eventually get actual checks for \$292,090 for two specific projects involving guardrails along Copper Creek Road (\$25,695) and

Fairview Road (\$16,395) for .476 miles east to .585 east of U.S. 25 junction and \$250,000 will be used for resurfacing various county roads. These roads must be formulated by the court and magistrates and presented to the state for their approval before the money will be given the county.

The city of Mt. Vernon will get a check for \$20,000 for rehabilitation of Rose Hill Road.

Transportation Cabinet Secretary Bill Nighbert spoke at the

ceremony saying, "I want to commend Governor Fletcher for his leadership. The improvements we make to our local transportation system allow people to travel more safely and enjoy a higher quality of life."

Nighbert also introduced Secretary of the Executive Cabinet Robbie Rudolph, and Fletcher's running mate in the upcoming gubernatorial election. Rudolph told those assembled that "Through government efficiencies and better

Court gets more information about detention facility

Calling it "dabbling in the waters," County Judge Executive Buzz Carloftis and magistrates met with Harold Fletcher, Jr. of Kenar Architectural last Wednesday to get more information about the possibility of building a larger detention facility in the county.

The matter was brought before the court at their last regular meeting by County Attorney Billy Reynolds who urged the court to consider building a larger facility so that if, and when, the state goes to the regional jail concept the county would have a much better chance of being approved as a regional jail site.

Carloftis pointed out during the meeting that the county ac-

tually had other options such as building a larger "county" jail and entering into an inter-local agreement with other counties, such as Jackson to house their prisoners. Carloftis said that a regional jail would entail forming a jail committee, with members on the committee from counties which house prisoners in the jail, while a county jail would be completely under the control of the county and jailer.

Fletcher pointed out that only 8 to 10 jails in the state show a profit and that, thanks to the administration of Rockcastle County Jailer James Miller, the county is in the "top 2% of jails in the state."

Eleven indicted by local Grand Jury

The Rockcastle County Grand Jury handed down eleven indictments on September 14th, five for alleged drug related crimes, four for flagrant non-support and one for theft by unlawful taking over \$300.

Delbert Wayne Leger, 31, of Rt. 5 Mt. Vernon and his wife Patti, 33 were named in a six count indictment.

The couple is accused of trafficking in a controlled substance by selling Methamphetamine (Meth) to a confidential informant on April 9th.

The mercury in Rockcastle County has climbed to 90 degrees or higher seven of the 25 days in July, according to local

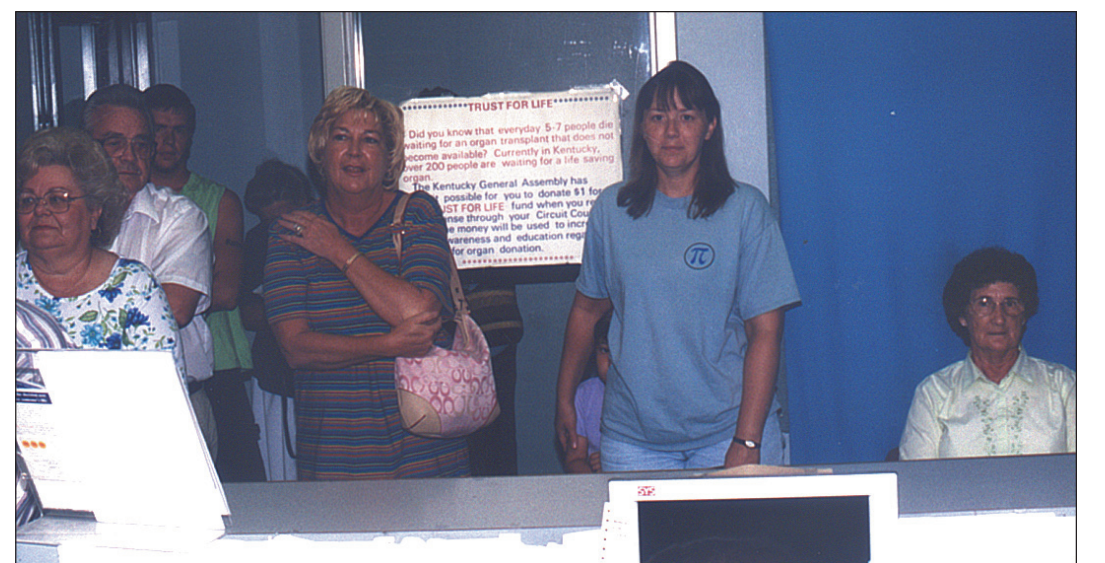

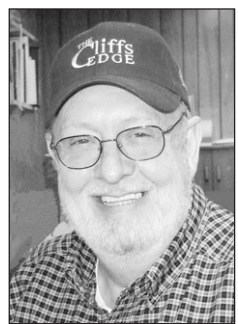

Last week I stopped at the farmers market and noticed that peaches were available. I bought a \$4 bag and went back to work. I was sitting at my desk busy completing an assignment when the smell of fresh peaches filled the room. I decided to "sample" one that I had just purchased. To my delight, it was one of the most delicious and juicy peaches that I have ever tasted.

I was immediately reminded of my grandfather's peach trees on our farm when I was young. I still remember them as being the best peaches you could find. Pop cared for his trees and would even prop up the limbs with tall, forked sticks to keep the fruit from damaging the tree. He always knew exactly when to harvest these delicacies. The process was a two-person job. Pop climbed up to the top of his step ladder, filled buckets, and handed them to me standing on the ground. I kept handing him buckets until he thought we had enough for Mommie Katie to do her magic.

Mommie Katie thought that

peaches were delicious, and she prepared them in a variety of ways. The fresh fruit was a hit with the entire family when she made her highly prized peach cobbler. Of course, she started from scratch and made the crust from her own recipe. Now I am a cobbler aficionado, and hers was the world's blue ribbon champion (in my opinion). She made it in a 9" by 12" glass baking dish, and it was quickly consumed by her brood. I can see her now sitting in her favorite rocking chair watching TV with a bowl in her hand. She covered it with a scoop of vanilla ice cream and had her very black coffee by her side.

Mommie Katie was my kind of parent. She thought that everyone had to have a late night snack before going to bed. That is why her cobbler disappeared so quickly. To this day, I have to top off my cobbler with coffee.

Another dish that Mommie Katie felt compelled to prepare with Pop's peaches was her delicious preserves. The walls of

I am advised by telephone from several more urgent contacts that AOL has screwed up yet again and they are not getting email from me but that's another story altogether. And not one that I can write about without using language unfit for family newspapers.

"ARGGGGGGGHHHHH!!!!!!", is as polite as I can get and that is a vast understatement.

Anyway, the subject this week is something best described as "favorite cars in your life."

So let's talk about "rides." The first car I ever owned that didn't have my Dad named as a co-owner was a '68 Camaro convertible that I purchased, used, in 71 at Boone Motor Company in Whitesburg, KY. Midnight blue (dark-navy

with mucho metal flakes) rocket spoke mag wheels, 327 cubic inch with three deuces on top of the motor and rated at 140 mph. It would actually go faster than that, but when I got to about 100, it more or less left the ground and flew low.

Gasoline was like 21 cents a gallon and it would get probably eight miles to the gallon if I was going down hill at an idle and had the clutch pushed in. If we needed something from the grocery, I'd borrow Dad's truck to save on gas.

I bought a top of the line Pioneer 8-track stereo with six speakers and when I put the top down it was at least as good as the largest public address system in eastern Kentucky at the time.

I could hit Highway 7 at the mouth of Blair Branch, turn up the volume full blast and they could have heard Steppinwolf "Born to be Wild" on the Virginia border seventeen miles

T.J.'s Journal

As I sit here this Monday morning, I find it quite different than any other Monday morning that I have experienced for a long time. Another chapter in my life has closed, and another is in its infancy. At this point, I'm not sure where it will lead and what adventures lie ahead.

The thing that brought the prior chapter of my life to a close was the passing of someone whom I will simply refer to as "Miss Sue." I was the companion and caregiver to Miss Sue for almost two years during the twilight of her life.

Miss Sue had been born, raised, lived, and died for the most of her life in Rockcastle County. I was new to the county, and had only been here about a year or a little over when I first came to stay with Miss Sue. Through her, I have become acquainted with quite a few local citizens, and have made friends with the better part of them.

The first few days we were together was more or less a "getting to know you session." Right away I learned that she was a woman that had a passion. She had a great passion for her family, her teaching career, and her church. She often chuckled that she had literally attended the First Baptist Church all of her life. Her mother attended First Baptist Church while she was pregnant with her. She was also very fond of getting her hair done, going shopping, eating out, and talking on the phone to her girlfriends. I can still hear her calling them up most every morning, and about the first thing she said was, "Tell me a

little news." She was, due to her health, rather isolated; however, her friends and family were very faithful to visit. I remember taking her to the beauty shop almost every week for a long time, as well as a few shopping sprees and eating out. These, unfortunately, had to end as her health declined.

Miss Sue had been a widow for many years. She missed her husband very much, and grieved for him until her death. She loved to tell stories about her family, growing up in Mount Vernon, as well as stories about her husband. One day she was relating a story about a trip that she and her husband had taken when she stopped cold right in the middle of a sentence. She leaned over a little closer to me, and with a gleam in her eye and a half-cocked smile, she said in a whispered voice, "You know, Robert was awfully good-looking."

One of the funniest stories I ever remember Miss Sue telling was that of her wedding day to Robert. (If anything can go wrong, it will on the wedding day. My cake fell into the back floor of my folks' car during the transportation of the cake to the wedding. Mom was trying to save a twenty-dollar delivery charge; she thought we had already paid enough. But that is another story.) It was a hot, sultry day in August down at the First Baptist Church, she related. It was in the early '60s about mid-afternoon. The church had no air conditioning, and the windows were left open in hopes of catching a breeze.

Exercise to Keep Your Back Strong

Good posture and proper lifting are things we seldom think about until it is too late. We develop poor work habits, improper posture when sitting and standing, and we get overweight.

These things put a strain on our backs and, sooner or later, the back begins to ache. Here are a number of exercises and habits you can use to help the pain go away and keep your back healthy.



1.) The "pelvic tilt" exercise strengthens the pelvic and stomach muscles by drawing the stomach in and tilting the hips forward while lying on the floor.

2.) Knee-chest exercises are done by lying on your back and drawing a knee up towards your chest and holding it 3-5 seconds. Alternate the knees, and later, both knees can be brought up at once.

3.) Partial sit-ups - just bringing your head and shoulders off the floor for 3-5 seconds. Alternate the knees, and later, both knees can be brought up at once.

4.) Lying on your abdomen, lift your head and shoulders off the floor for 3-5 seconds. This strengthens the posterior spine muscles.

5.) Sleep on a firm mattress and put a pillow under your knees if you lie on your back, or between your knees if you lie on your side.

6.) If you are standing for a long periods, you should put one foot on a stool or ledge, or bend both knees intermittently.

7.) Sit in firm straight-backed chairs and keep the knees level with the hips or slightly higher than the hips.

8.) When lifting, bend at the knees keeping the back straight. You should be careful not to twist while lifting which is often what brings on an acute back strain.

Missing and Exploited Children

Few circumstances are as frightening as the realization that a loved one is missing, particularly if that person is child or elderly parent. Our minds conjure terrible circumstances and we panic.

Yet, the reality is that individuals can be missing for a variety of reasons not all of which are sinister. When the missing person is an adult, as opposed to a young child, benign explanations for their absence are far more likely.

In these circumstances, the missing person is in no peril whatsoever. The Kentucky State Police Missing and Exploited Children's Unit tracks missing adults as well as children. In 2005, over 2100 missing adults were reported statewide. These reports include those who because of senility or mental disability have wandered from home and family, those who remain missing after a natural calamity, or those who have simply vanished and there is a reasonable concern for their safety.

Reports of missing juveniles are far more frequent. Nearly 5,000 children were reported missing in Kentucky last year, including nearly 90 who were under the age of 5 at the time of their disappearance. Nationally, about 1.5 million children are reported missing each year. Nearly half of all missing children are runaways, and another twenty to thirty percent are missing for a benign reason, i.e., a scheduling misunderstanding or some other non-dangerous circumstance. Still, over 50,000 non-family abductions and over 200,000 family abductions occur annually nationwide.

While these numbers present a scary picture, a 1997 report

indicates that the murder of an abducted child remains a very rare event, less than 100 annually. The sexual exploitation of a missing child is far more prevalent.

Despite the rarity of these tragedies, parents perceive their children to be at greater risks than ever before. In a new

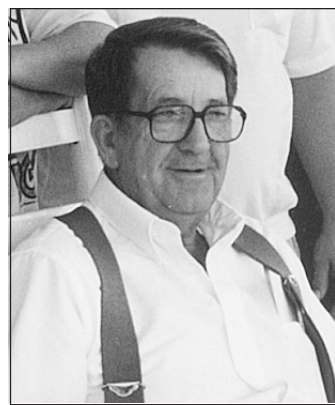

Someone sold or gave our names to these companies, how else would they get my new address? If you know, please tell

me and I will tell the Livingston post office because they don't know either. There is something rotten somewhere.

My family has asked me to write, most don't live on this road, but they don't like it any more than I do. If no one agrees with me, that is their privilege. Everything we believe in is going. We have no say in anything. The officials think they know more than all the common people but they don't. We're made to do things, whether we want to or not, right or wrong.

Some history of cemetery...

Dear Editor:

If I may, I would like to share with your readers a bit of the land history of the Negro Creek Cemetery (KY Hwy 3245, West Brodhead) and publicly acknowledge the folks that have made contributions to its upkeep thus far this year.

According to official court documents, the cemetery in its present land form came about like this: James W and Elizabeth (Farris) Johnson owned the original plot of cemetery land that covered approximately 1/2 acre, (where the three cedar trees are now with graves dating from the Civil War, possibly earlier). In January 1900 Mr. and Mrs. Johnson sold 188 acres which encompassed the cemetery. In that deed, Mr. Johnson excepted the original 1/2 acre cemetery plot and donated an additional plot which squared the cemetery up to the roadway.

This remained as deeded until September 1954, at which time two brothers, Edgar and Lewis Bowling bought a 20 X 185 foot strip that bordered the cemetery on the west side, which they promptly designated for "burial purposes only".

On April 27, 1968, the cemetery acquired an adjoining "about one acre", tract on the east side of the property which was freely given by Nathan and Sallie Ann Brummett. Thus, we have the cemetery in its present-day land form.

Although, there are a couple of folks in the county that claim their ancestor, none of which are listed above, gave the land for the cemetery, court documents prove otherwise. A comment was made around Memorial Day of this year by one local resident stating that she did not feel obligated to contribute funds to the upkeep of the cemetery, (never mind that her parents, siblings, nieces, nephews etc. are interred there), because her grandfather donated the land. He did not. That is simply a tall tale.

I would just like to say to her and anyone else that uses such excuses to put the financial burden of the cemetery upkeep onto others - my father fought

in World War II - that certainly DOES NOT make ME a veteran.

I personally know where two graveyards are that can be found only by tripping over the tombstones amidst thick head-high undergrowth and huge trees. The Negro Creek Cemetery has always been one of the best supported and maintained in the area thanks to the literally hundreds of contributions that have been given over the years and will remain so due to the foresight of the folks that organized the trust fund. The interest from the trust fund monies has been paying for all of the maintenance at the cemetery for several years now and will continue to do so long after we are all gone. The money in the fund simply CAN NOT be used for anything else.

If you received a letter from the trust fund board this year and did not contribute, please reconsider. If you have folks buried at the cemetery and did not receive a letter from the board soliciting a contribution, that simply means they did not have your mailing address. Contributions, (tax deductible!), can be mailed at anytime to the treasurer: David Bowling - Treasurer, NCC Trust Fund Board, 5362 Augspurger Road, Hamilton, OH 45011.

A full yearly report from the trust fund of contributors, amounts given, and each dollar spent on maintenance is always available at the cemetery on "Decoration", (first Sunday in June).

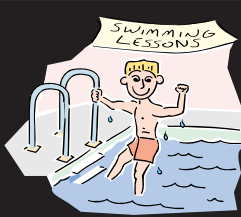

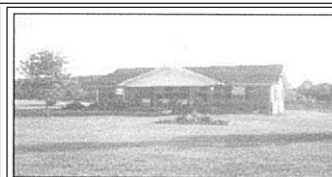

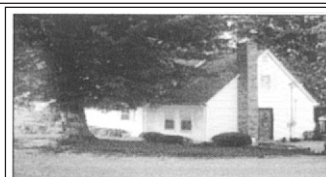

Florida poll, forty-five percent of the survey participants believed that their children were at greater risk than five years previously.

In response, concerned parents undertake many measures to keep children safer. Most parents monitor the location of their children at all times, and most closely monitor their children's Internet use. Still many parents are unaware of warning signs, such as the Internet query coded “A/S/L?” which stands for Age/Sex/Location, or are unaware that most abductions are perpetrated by other family members or acquaintances rather than strangers according to the National Center for Children.

And many of us remain blind to the frequency of human trafficking within our own borders. Legal and illegal immigrants, mostly women and children, are frequently used in illegal criminal syndicates within the United States.

Much progress continues to be made to provide relief for those cursed with the sorrow of a missing or exploited child.

Federal and state law enforcement maintain databases on all missing persons. Numerous laws encouraging interstate and international cooperation in locating missing or exploited children and the prosecution of those involved in abductions and human trafficking. And the U.S. Department of Health and Human Services is taking affirmative steps to help adult trafficking victims qualify as refugees.

Ultimately though, faith may be the only recourse for a distraught parent. Without faith in the safe return of our children, we have nothing at all.

Mommie Katie's vanilla cream combined with Pop's peaches made a backyard snack that drew neighbors from all around. I love Bryers' ice cream, but Pop had them beat – hands down! He used huge hunks of fresh peaches in his cream, and I could not get enough.

After arriving home on the day I had made my recent peach discovery, I placed them in a bowl in our kitchen. That night, while watching TV with my wife, I ate my second peach. I told her that there has to be a God because only He could make something that tastes this good. She laughed at me as the juice ran down my bearded chin.

I am so pleased to have the services of local farmer's markets. This summer, I have sampled half-runner green beans, cucumbers, corn, tomatoes, and the peaches. Fresh fruit and vegetables cannot be any better than when purchased from local farmers. Not only is the taste wonderful, but the memories of my boyhood linger throughout every bite.

The guests were beginning to swoon from the heat. The flower girl, one of her nieces, was being uncooperative. At some point in the whole process, a bumblebee had flown under Miss Sue's lovely, long, flowing, bridal gown. I understand it was quite an experience.

She really loved her family. They were a very small but closely-knit group. Having no children of her own, she relied heavily on her nieces and nephews during her latter months.

One of her happiest experiences was a birthday celebration they had for her last February. She was very close with her last remaining sister, Barbara and brother-in-law, Billy. Sadly enough, this sister preceded Sue in death by only a few months. Miss Sue missed her beyond words. Her double first cousin, Jean, has played an important role in her life acting almost as a sister. Miss Sue especially looked forward to holidays with her relatives. She often reminisced about Christmas here or there at various homes, or Thanksgiving at Aunt Lorene's and Uncle Clarence's.

Unfortunately, she had to endure quite a bit of ill health most of her life and other misfortunes. Arthritis plagued her life since she was in her late 20s yet she forged ahead, and had taught school locally for about thirty years. She had always regretted not having written a book about her teaching experiences. She and her husband once lost everything they had in a horrible house fire several years ago, but she was able to overcome this obstacle, as well.

Her chief characteristics were probably a strong will and determination. Those who knew her well may say that she was too strong-willed, but those who knew her also know that without this, she would not have survived and overcome all of the various obstacles that had challenged her and came out victorious.

I often paralleled my life with Miss Sue's. Through her, I projected my own situation for the future to some degree or the other. I, too, had been diagnosed with arthritis at about the same age, and found a youthful and willing mind trapped within a stiff and painful, deteriorating body. I know what pain she suffered in doing the most simple daily tasks. I forged ahead as she did as long as I could. My job, a certified med-tech, was very physically demanding compared to teaching, and I was forced to retire early.

I also married rather late in

life. In my case I had been married previously. Neither of us had any children, but have a small but close family. I'll probably be relying a lot on my nieces and nephews in my later years, as well.

My Miss Sue was laid to rest yesterday following a very beautiful service; one in which she would have been very pleased. All of her closest family and friends were in attendance. She would have liked that. Miss Sue and her family have been outstandingly cordial to me and have made me to feel a part of this special family.

I followed the funeral procession through the middle of town in route to the cemetery. Miss Sue passed through the town of her heritage; past familiar stores and places of business, and past familiar streets and landmarks for the final time. A favorite daughter of the county was about to be “gathered unto her people” in Biblical terms who had been awaiting her arrival a long time. She would have liked that, too.

The ultimate babe magnet (again I can't use the language of that day) but I didn't have any problem getting dates with girls who had fathers who didn't know me.

I called that car “Spook” because it really was scary fast. My best Buddy, Don Miller had a little Datsun that he had named “Sylvester”. We'd go out on double dates to the dives in Pound and Wise and Norton, Virginia and drive Sylvester which, conveniently, had bench as opposed to bucket seats. We'd promise them a ride in “The Spook” before the night was over if it wasn't raining and we'd convince them that we didn't want to get wet.

Four people couldn't really fit comfortably in Spook unless the top was down and besides that, she leaked if you were

driving very fast in wet weather.

Early one morning in January of 74, I was headed to Frankfort, some 170 miles away from Blair Branch and running late. Sleet and freezing rain were coming down just about daybreak when I hit the good stretch of Highway 15 just outside of Hazard and put ole Spook into the low flying mode.

On a long curved bridge across the KY River between Jackson and Campton, Spook spun out.

I woke up in an out patient clinic in Campton. To this day I'm not sure how I got there, but some of my coworkers from Knott and Breathitt Counties were there because they'd been just behind me when the wreck happened and I convinced them that I was able go on to Frankfort.

Two days later, brother Keeter and Dad met me in Jackson where a coworker had dropped me off on the way home. The first thing I asked about was ole Spook and Keeter said, “Well there's pieces of that car at three different salvage lots between here and Hazard and the state says you may owe them for a bridge.”

We stopped at a car lot there on Highway 15 just south of Hazard and Mike Adams, (no close relation but an old high school buddy) was in the Chrysler business and those ridiculously huge, ten-gallon, white, cowboy hats were a (good guys wore em) trademark. Mike was wearing one and I fell for the ruse.

He tried to sell me a New Yorker, but what really caught my eye was the ultimate VW Super Beetle, cream colored with all sorts of flames painted down the sides and a Porsche engine, ultimate sound system, that someone had traded in for a Dodge Charger.

I later figured out why they traded but that's another story. Suffice to say, that by the time I got on Blair Branch that car had a name----Spook II.

Gear Up

New approaches help prepare students for life after graduation

Although students don't want to start thinking about the new school year until late in their summer vacation, state leaders began planning for the 2006-2007 school year months ago. In a continuing effort to improve education for Kentucky students, the Kentucky Department of Education and the Kentucky School Board have enacted changes that students, parents and teachers will see in the upcoming school year. For the GEAR UP audience, Kentucky Education Commissioner Gene Wilhoit recently noted three changes that he believes are especially important.

The first is new graduation requirements passed by the Kentucky Board of Education. "There are new minimum graduation requirements for the year 2012, which seems far away but schools will begin making changes now to meet those requirements," Commissioner Wilhoit said - this year's seventh-grade students will graduate in 2012.

The new requirements call for a more rigorous curriculum to prepare students for the future. Most of the changes are in mathematics where schools will increase the depth of the content and the number of required math courses. Everyone will take Algebra I, Algebra II and Geometry in high school; therefore, middle schools will deepen their math curriculum to lay the groundwork students need to succeed with high school Algebra.

Science classes will become

more lab-based and hands on. In addition, students will be required to be competent with technology. There has also been discussion about increasing the requirements for proficiency in a second language.

Commissioner Wilhoit believes parents play an important role in supporting this new approach. "Parents should encourage more rigorous study for their students," he said.

The second action Commissioner Wilhoit highlighted is the continuing effort to refine the assessment process with new testing design and the infusion of ACT testing. While tests will still assess knowledge of core content, some of the testing flaws will be corrected.

The ACT test system will begin in the eighth grade with all students taking the "Explore" assessment. In the 10th grade students will take the "Plan" test. Both Explore and Plan are preparatory tests that identify the areas students will need to work on in order to do well on the ACT in their junior year.

Third, schools are working on developing web-enabled Individual Learning Plans (ILP). These new electronic plans will eventually replace the paper Individual Graduation Plans (IGP). Since they will be available online (with access codes), families who have a computer, or access to one in the community, will be able to check their student's plans periodically to see how their son or daughter is progressing toward established goals. Commissioner Wilhoit said schools will explain the process to families, starting this year, at the sixth-grade level so they will understand how to use it.

The system that houses the Individual Learning Plans will also link to higher education sites, scholarship opportunities, and other tools that allow students to explore their interests and post-high school graduation options conveniently and at an earlier age. Commissioner Wilhoit concluded by saying that with all of these new approaches: "We are removing all the barriers to students becoming successful."

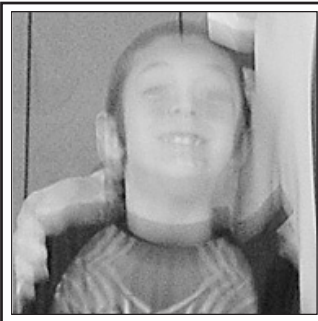

Smith Wins Gold at Bluegrass State Games

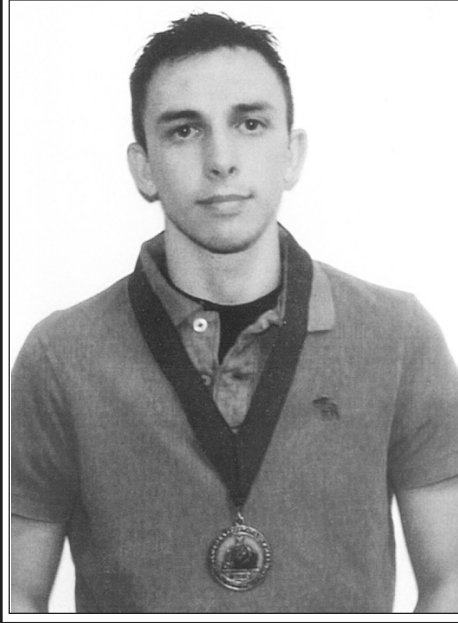

opment Board / Industrial Authority's property.

Last year the local board purchased the 4 acre tract for \$74,000 when it was sold at an estate auction.

Chairman Corey Craig told the eleven board members in attendance on Monday that there would be a walk through on Wednesday of the Northside Apartments property, on Richmond Street in Mt. Vernon, which the board recently bought for \$175,000 with coal severance funds.

Part of Wednesday's walk through was to get the keys to the property. The tour was also to determine salvage value of the materials in the building and what to do with the mobile homes on the site. Craig mentioned salvaging brick and metal and he also said the group should be thinking about how to contract the salvage and/or demolition of buildings on the property.

All tenants at Northside have relocated.

Craig also mentioned that negotiations, for the possible purchase of the Roger Isaacs' property, located adjacent to the Northside Apartment, are underway. He said money from the sale of the 461/150 property would be used if the property is bought.

"If we decide to do this it will

give us more land for the proposed new county library," Craig said.

Craig said Tuesday that money for the library building itself would likely come from state grants and possibly some monies from the state's budget. "It will be a five to seven year project," Craig said. He is also a member of the Rockcastle County Library board.

Economic Development Project Coordinator Lynn Gilbert told board members she had spent at least an hour making a powerpoint presentation to the Cabinet for Economic Development in Frankfort on July 10th where Commissioner John McCarty was in attendance.

Gilbert told board members she focused on the positives of Rockcastle County and emphasized the quality of life in the county.

She gave a slide presentation featuring Renfro Valley, the Lake Linville Park, Rockcastle Hospital, the two industrial parks in the county, the Kentucky Music Hall of Fame, the school system in general, the proposed new library, the upgrading of Main Street in Mt. Vernon and she also pointed out the railroad spur at Alcoa-Reynolds Food Packaging.

Gilbert also attended a Southeast Kentucky Economic Advisory Council meeting to discuss natural gas. "Some said it was something you needed and others said it was too expensive and said some places were turning to geo-thermo en-

ergy," Gilbert told board members. Gilbert will soon be a member of the council at the request of the current council.

The coordinator also attended a Main Street Meeting in Glasgow the second week of July where she learned that a grant opportunity would open up August 1st, which could be used for the Jones Building on Main Street in Mt. Vernon. The maximum grant amount would be \$150,000.

Gilbert said she was working with Kentucky Highlands to market the former Rockcastle Manufacturing building.

Craig said that the board had kicked around the idea of extending the present railroad spur at Alcoa-Reynolds to the former manufacturing building.

Gilbert said California and Detroit industrial parks would be the first targeted.

"We are going to show them we are cleaner, more accessible, more safety conscious and have a lower cost of living," she said.

Gilbert said that she, and Elmer Parlier of Highlands, were currently preparing a mailer to be sent out showing all of the advantages to locating in Rockcastle County. Last year Cintas, the county's oldest production plant which had been in operation since 1978 and was county's third largest employer, shut down.

A financial statement was presented to the members present at Monday's meeting showing a balance of \$141,985 in the Development Board/Industrial Authority's four accounts.

The next regular meeting of the board will be at 11:30 on the third floor of the courthouse, on August 28th.

management practices, Governor Fletcher has turned a billion dollar state deficit into a two hundred million dollar surplus. These projects in Mt. vernon and Rockcastle County are examples of how our administration is working to build stronger communities across Kentucky."

Rudolph also noted that there would be a \$377 million surplus this year and state government did not have to raise taxes to do this but actually lower taxes. Rudolph said there were 500,000 low income family members taken off the tax rolls, 74,000 new jobs created

under the Fletcher administration and also pointed out that Kentucky is leading the nation in Medicaid reform. The reform is projected to save \$1 billion dollars over seven years without sacrificing care or cutting off health care services, Rudolph said.

Rudolph also took credit for changing the change order process on construction projects and saving approximately \$70 million dollars the first year, when he was Finance Cabinet Secretary.

Nighbert came in for his share of kudos during Rudolph speech. Rudolph said that during the present administration, over \$700 million had been invested in Kentucky's roads and that the largest and most ambitious road and bridge construction/rehabilitation program in any biennial periods in state history had been put in place. Rudolph said the state was putting more money into the road system and back into counties for road projects than ever before; saving more than \$66 million per year as a result of personnel efficiency savings (through attrition) and mentioned the \$150 million in bonds sold to be used for county and municipal roads and bridges.

“New Jail”

Since building a 200 bed jail, Clay County cleared \$300,000 last year on their jail operation, going from a \$500,000 deficit which had to be covered by a payroll tax. Carloftis added that Rockcastle sent \$30,000 a month to Boyle County when prisoners had to be shipped there because of renovations to the present jail.

The state's population continues to grow, Fletcher said, and pointed out that the jail population will increase proportionately. He also noted that Rockcastle's nearness to Interstate 75 generated some prison population besides the fact that the public continues to demand jail time for crimes that once offenders saw little or no prison time for such as bad checks, non-support and DUI. Of course, Fletcher added, drugs continue to be the number one issue in Kentucky and across the state.

Counties without jail facilities see a large portion of their general fund going to house prisoners in other counties, such as Knox County which closed

their jail and now uses 40% of their general fund to pay other counties to house their prisoners, Fletcher said. Carloftis added that Casey County had to put a payroll tax on their citizens in order to house their inmates in other counties and Jackson County, which has only a life safety jail (can only house county prisoners), had to put a 10% insurance tax on just to house their prisoners in other counties. "A lot of rural counties will have to shut down their jails in the next five years," Fletcher added.

Fletcher also told the court that a 250 bed jail could be staffed by about the same number of personnel as a 180 bed jail but the profit margin would increase greatly with the larger jail.

Jailer James Miller also pointed out that there was a scarcity of facilities in the state for female prisoners and that the current jail could be used to house female prisoners with all female staffing which would gross over \$800,000 yearly.

On question, Fletcher said, in his opinion, he did not foresee the mandatory regional jail concept being put in place by the

state.

Carloftis thanked Fletcher for his time and noted that he had given the court "lots of things to think about." Carloftis also said, "This court does not ever want to put citizens of this county in the position of having their tax money taken to another county to support our prisoners."

If the court should decide to commit to the project, they are looking at having to acquire three to five acres and floating a bond issue of upwards of \$6 million.

resentation for it to be a controlled substance, on April 10th. Delbert Wayne Leger was indicted on another charge of selling a controlled substance to another confidential informant and both were indicted for being persistent felony offenders.

Circuit Judge Jeffery T. Burdette set the Legers' bond at \$50,000 cash each. Neither Leger had been arrested as of Tuesday night.

Christopher M. McClure, 21, of Raymond Todd Road, Crab Orchard, was indicted on a charge of selling Meth to a confidential informant on September 4th of last year. His bond was set at \$25,000 cash or property, but he is being held in Lincoln County where he faces other charges.

Donnie Lunsford, 31, of Joyce Street, Mt. Vernon was named in a four count indictment.

He is accused of selling Oxycodone, a scheduled II controlled substance, to a confidential informant on April 15 and April 18. He was also indicted on two counts of being a persistent felony offender.

His bond was set at \$40,000, cash or property.

His district court bond of \$200 cash was extended to the Circuit Court indictment by Burdette.

Amy Louise Willis, 35, of Valley View Apartments, on Old US 25 in Mt. Vernon, was indicted for theft by unlawful taking over \$300 from Save-a-Lot in Mt. Vernon. She is accused of using a fraudulent credit card from September of last year to March of this year. Her bond was set at \$10,000 cash or property.

Scottie D. Berryman, 33, of Red Hill was indicted for flagrant non-support in the amount of \$6,056. Burdette set his bond at \$6,000 cash, which Burdette ruled would be subject to being used for payment on the back child support.

Jackie W. McHone, 31, of Lake Linville Road, Mt. Vernon was also indicted for flagrant non-support of minor child/children in the amount of \$6,775. Burdette set his bond at \$6,700 cash. Burdette put the same restriction on McHone's bond as he did on Berryman.

Samuel Dewayne Lawson, 43, of Mt. Vernon was indicted for not paying child support in the amount of \$4,962. His bond was set at \$5,000 cash with the same restrictions as Berryman and McHone. However Lawson, 44, is currently being held by federal authorities.

Gregory S. King, 30, of Junction City was indicted for not paying child support in the amount of \$1,262. His bond was set at \$1,200 cash with the same restrictions as the other three involved in child support cases.

Burdette sentenced Anthony to twelve months on the resisting arrest charge to run concurrent with the four year sentence he received for fleeing/evading police.

Anthony, 27, will serve two years of the four year sentence and the final two years will be probated.

Nelson and Kim McFerron were at the meeting to ask why there was such a difference in the time span of when water meters were read. Mr. McFerron said that in June it was the 29th before meters were read and this month it was around the 18th, making for a large July bill for customers.

During the next few weeks, Jackson Energy Cooperative will be pruning or removing trees that interfere with or have a potential for interfering with existing JEC lines. Jackson Energy prunes tree limbs away from overhead power lines in order to achieve two critical objectives: public safety and reliability of electric service.

Many service outages and interruptions are caused by tree limbs that fall into power lines causing damage to wires, short circuits and other problems. That creates potential danger for co-op members and their property - danger that be avoided by not planting tall-growing trees under or near electric wires, and by routine tree pruning.

Jackson Energy Cooperative adheres to the American National Standards Institute (ANSI) A300, Standard Practices for Trees, Shrubs and Other Woody Plant Maintenance. This standard, endorsed by the International Society of Arboriculture, the National Arbor Day Foundation and the National Arborist Association, requires tree workers to cut branches back to the "parent limb."

This practice allows the pruning cuts to "heal" more rapidly, reducing the chances of insect and disease damage, and

promotes a healthier regrowth of branches that are directed away from the power lines. This practice, termed "natural pruning," is healthier than tree "topping," which is the indiscriminate cutting back of tree branches to reduce the size of the tree crown. Although topping generally leaves the tree with a more uniform or balanced appearance, the International Society of Arboriculture calls topping "perhaps the most harmful pruning practice known."

According to the Society, topping stresses trees, makes them more vulnerable to insect and disease infections and causes decay. Topping further causes unsafe structural weakness within trees that lead to significantly unsafe conditions.

Tree pruning of the following electrical circuits and locations will be ongoing for the next few weeks. These circuits will be pruned for clearance on shade trees, or trees that normally exist in yards and maintained areas -

East Bernstadt Feeder 3 - which includes the areas of Old Somerset Road, Grimes Road, KY 241, Helvetia Road, Wood Creek Road, Chaney Ridge Road, Laurel Cove Road, Lake Road, Mt. Moriah Road and Vaughn Ridge Road.

East Bernstadt Feeder 1 - which includes the areas or portions of KY 3434, KY 490, KY 1376, KY 1394, Little Arthur Ridge, Hensley Road, Reynolds Road, Farris Jones Road, Patton Road and Dolly Miller Road.

Brodhead Feeder 1 - which includes portions of KY 1505, Copper Creek Road, Conway-Sweetwater Road, Lake Linville Road, US 25, Clear Creek Road, Green Hill Road and Chestnut Grove Ridge.
