Local woman pleads guilty in drug case

Lorena Bostic, 51, of Mt. Vernon pled guilty to three drug charges at a hearing Friday in Rockcastle Circuit Court, according to Eddy F. Montgomery, Commonwealth's Attorney for Rockcastle, Lincoln, and Pulaski counties.

Bostic had been the subject of a 2005 investigation by Operation UNITE and was in court for pretrial conference. However, instead of setting a trial date, Bostic entered a plea of

Nearly \$130,000 awarded for dump cleanups

Rockcastle County will receive \$129,248.22 as part of \$2.8 million in grants awarded from Kentucky PRIDE fund for cleanup of 475 illegal open dumps in 56 counties.

Senate Bill 50, passed by the 2006 General Assembly converted the illegal open dump reimbursement program to a grant program.

Participating counties agree to provide a 25 percent match for dump cleanups costing less than \$50,000. The environmental and public protection cabinet (EPPC) may waive the match if costs are higher.

Rockcastle fared well in getting their share of the \$2.8 million, getting the fourth largest grant which will be used for the clean-up of dumps on the Bryant Ridge Road and one at the end of the Floyd Renner Road which is at the very end

Livingston changes date for meetings

For Quail Park

County gets "unofficial" notification of \$50K grant

The Rockcastle County Fiscal Court will receive a \$50,000 matching grant, toward construction of a new community center at Quail Park, according to Jodie McDonald with the Governor's Office of Local Development (GOLD). The center will be available for family reunions, receptions, etc., County Judge/Executive Buzz Carloftis said.

Carloftis said he was notified in a phone call from Ms. McDonald that the county's application for a matching \$75,000 grant, from Land and Water Conservation, had been reduced to \$50,000 and had been approved. The county will have to provide \$50,000 in matching in-kind contributions.

Carloftis said he did not know why the amount of the grant was reduced from \$75,000 to \$50,000 but that the county did not want to take a chance on jeopardizing the \$50,000 award by trying to get

the additional \$25,000.

"This won't get us all the bells and whistles we wanted for the building but it will probably get the essentials," said Carloftis, who emphasized that "official" notification of the grant had not been received as of Tuesday.

Word has not been received yet of the fate of an additional \$60,000 grant, also for Quail Park from coal severance tax

monies, Carloftis added. He said he felt the grant would be received because it was from monies the county has available from the coal severance fund. However, Carloftis said, receiving the additional \$60,000 is "essential" to the entire Quail project since it will also be used on construction of the building, along with a septic system,

County schools get good report

Four of the five schools in Rockcastle County made Adequate Yearly Progress, (AYP) last school year with RCHS being the only school not to meet the requirements of the federally mandated program, "No Child Left Behind," (NCLB).

That program was pushed through Congress by President George Bush and took effect in January of 2001.

Only reading and math scores from the state's CATS test are used in the formula to find out if a school is making the grade.

Last year all of the county's schools met their target goals.

In Circuit Court

Six probations revoked, three others sentenced

It has been a very busy time in Rockcastle Circuit Court, with several probations being revoked and other defendants being sentenced during the last two rule days.

Last Friday, Rockcastle, Lincoln and Pulaski Circuit Judge Jeffery T. Burdette, imposed a five year sentence for a March 23, 2005 indictment against Billie Jo Lunceford, 37, of Mt. Vernon for facilitation to Manufacturing Methamphetamine (Meth).

Assistant Commonwealth Attorney Jeremy Bartley said Lunceford's original five year sentence was probated in exchange for her testimony against co-defendants in the same drug case. In the case in which Lunceford agreed to testify, one co-defendant, Bobby

Moore, 31, was sentenced to 15 years in the state penitentiary for manufacturing meth.

But on Friday Lunceford was back in court for a hearing to determine whether she had violated her probation by having methamphetamine precursors in her possession, testing positive for meth and possession of a deadly weapon.

Bartley questioned Lunceford's probation officer Mike Coomer as to the items found at Lunceford's home on July 12th Coomer testified that he had found several items needed to make meth and that Lunceford had also tested positive for meth. Coomer also testified that he found a "Billy Club" in Lunceford's bedroom.

Lunceford however testified

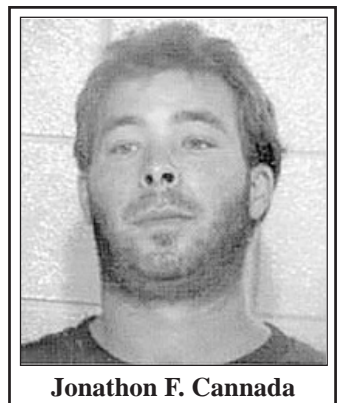
Somerset man threatens life of Judge Lambert

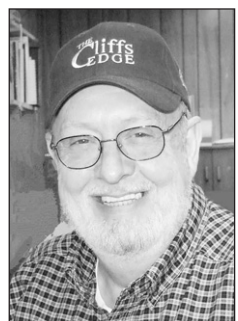

Durham, a stand out on the offensive and defensive line, has committed to the University of Louisville.



Construction could begin as early as this fall on the new 50,000 square foot Area Technology Center, which will be built next to the Rockcastle County High School. The two schools will be connected by a corridor. Last week the local board of education approved the finance application for the \$9.5 million school. Of the \$9.5 million, \$550,000 is budgeted for site development, \$4,750,000 for general construction, \$1,225,000 for the heating, ventilation and air conditioning, \$657,000 for the plumbing, which also includes the sprinkler system, \$1,076,000 for electrical work, \$464,156 for the architect and engineering fee and \$332,919 for equipment, computers and furnishings. \$414,425 has been set aside for any contingencies on the project. The \$9.5 million calculates to \$23,750 per student, based on an enrollment of 400 students. The enrollment at Area Technology Center is currently 417. The local vocational school was opened in 1969 and the new Area Technology Center is tentatively scheduled to open in January of 2008. Above is an architect's concept of the new center.

Rockcastle Memories

My heroes have always been cowboys. And they still are, it seems.

When I was a small boy, my world often revolved around pretending to be a cowboy with two six-shooters in leather holsters strapped on my side. I perched on the end of the couch, watching my heroes capture the bad guys on television. From that spot I could ride with my favorite "cow punchers" in their conquest of evil in the old west. I assisted Gene Autry, Hopalong Cassidy, Johnny MacBrown, and Lash LaRue in a variety of western adventures. I occasionally was shot out of the saddle and fell to the floor in my living room. Being a living room cowboy was dangerous business!

It was easy to determine who the bad guys were on television because of their black hats. Good cowpokes dressed in white hats and always won over evil. They could kill 40-50 bandits or Indians without even reloading their six shooters. By watching these adventures on TV, we learned to be courteous and how to fight for what was right.

Most of the heroes were loners, with relationships only with their horses -- or possibly a sidekick (such as Walter Brennan, Fuzzy St. John, or Gabby Hayes). They slept on the ground with a trusty horse watching over them. A good fire and a pot of coffee were all they required to feel comfortable while on the job in the Wild West.

One of my favorites was a character named Lash LaRue. His special talent was the use of a "bullwhip" in his pursuit of outlaws. I talked my grandfather (Pop) into letting me get a whip of my own. I practiced the art of "lashing" a pistol out of

the hand of bad guys. I wasn't too bad! Lash was also different in how he dressed. He opted for the black outfit to go along with his black horse, aptly named Black Diamond. He played alongside a very funny side-kick named Fuzzy Q. Jones.

All of the young cowboys in my neighborhood rode the range on their "tobacco stick" horses. Because of my fondness for Lash, I painted mine black like Black Diamond and tied a white scarf around his neck to resemble the white mane. We were quite a sight!

Several of the boys in my neck of the woods gathered on Saturday to ride our "horses" into the woods in search of outlaws. We often used up several boxes of caps in our six-shooters as we tamed the frontier.

A neighbor gentleman who used Bull Durham smoking tobacco would save the small white pouches so that we could fill them with sand and pretend that we were transporting gold through the woods. Once we found a small wooden box, filled it with the bags of "gold," and buried it in the woods. To my knowledge, it was never retrieved. (Can you imagine the look on the face of a treasure hunter who eventually finds the "gold"?)

Pop also loved western movies. Almost every weekend, he took me to the Saturday matinee at the Vernon Theatre. Those were the days when the wheels of the wagons spun backward in the old black and white cowboy thrillers.

We usually sat through a Western double-feature. Pop loved the singing cowboys, such as Roy Rogers and Gene Autry, and knew most of the lyrics to the "fireside" songs. One of the reasons that he may have loved

Who Are We?: U.S. Values in the Military

It has been said that in violence, we forget who we are. Recent allegations of atrocities emerging from Iraq by U.S. forces suggest that some soldiers

have abandoned their training, the rules of war, and a basic respect for humanity.

Steven D. Green

awaits trial in the U.S. District Court for the Western District Kentucky on charges of raping and murdering an Iraqi woman after murdering three members of her family. Because the allegations did not surface against Green until after he was discharged from the U.S. Army's 101st Airborne Division, he will be tried in the civilian courts rather than in a U.S. military tribunal. Five other members of Green's unit are charged in the same case. The allegations are disturbing. Witnesses claim that Green

spotted the woman at a military checkpoint and later followed her to her home where he killed her husband and children, and then raped and murdered her with a weapon seized from her residence. Numerous allegations of similar misconduct plague U.S. forces. These incidents raise an intriguing question. Have the moral lessons of Vietnam been forgotten?

In Michael Sallah and Mitch Weiss' book Tiger Force, the authors chronicle the brutal murders and atrocities committed by an irregular U.S. infantry unit in the Song Te valley. Aside from murdering hundreds of unarmed farmers, these soldiers routinely mutilated the bodies of their victims, hacking off ears and in one instance, beheading an infant. The disturbing reality is not that atrocities occurred, but that they occurred because of a lax command structure and the acceptance of individuals within the armed forces who could have been ex-

Are You Getting Too Much UV-A

You have probably never heard of UV-A, but you are exposed to it every day. It is a part of the spectrum of ultraviolet light. It is different from the UV-B light, which is the wave length that causes skin cancers.

While UV-A light does not contribute significantly to skin cancers, it is the cause of most of the rest of damage sunlight does to the skin.



There is 1000 times as much UV-A as UV-B and it is always around. In contrast to UV-B, it is present early in the morning and later in the day, it is present throughout the year (UV-B is primarily in the summer months), and it penetrates glass so you still get some exposure when you are indoors or in your car.

Why is UV-A exposure so important? It is the wavelength of sunlight that causes the aging changes of skin. It penetrates deeper into the skin and damages the collagen and elastic fibers. As these supportive fibers are damaged and lost, your skin will wrinkle and sag. These are changes that cannot be reversed. Sagging in particular is hard to reverse. Basically, once your skin is old, it stays old forever.

UV-A is also the spectrum of light that causes the majority of drug reactions that are induced by light. Tetracycline's, water pills and many other medicines are much more likely to cause a skin reaction if exposed to this spectrum of light.

Many sun screens do not protect against UV-A, but there are some that do. Check with your pharmacist to be sure you get one with avobenzone or some other UV-A blocker.

pected to demonstrate behavior inconsistent with rules of engagement and the Geneva conventions.

Unlike the war crimes depicted in Tiger Force, it appears that current military and civilian leaders are actively investigating and prosecuting war crimes committed by U.S. soldiers. As Sallah and Weiss point out, "[p]art of the culture of any military institution is what it has learned from prior mistakes, providing an institutional memory with clear-cut rules and guidance. Covering up war-crimes cases such as those of Tiger Force may save the institution from being embarrassed but does little to prevent such cases in the future."

Ironically, Donald Rumsfeld, now the Secretary of Defense confronted with the latest allegations of atrocities served as White House Chief-of-Staff during the period in which Tiger Force was running amok. Hopefully, our generals, the Secretary of Defense, and the President will heed the lessons of Vietnam and require the

continued disclosure of all war-crimes.

There is one other lesson from Viet Nam which bears repeating. As the military is stretched by regional conflict, there is an understandable desire to ease obstacles to enlistment. A good example is the army's recent decision to increase the maximum age for enlistment. In past conflicts, when the military needed to boost enlistment, recruiters would ignore a potential recruit's minor skirmishes with the law or behavior which might indicate the presence of a mental illness or behavioral issues. History instructs that this too can have disastrous results.

Soldiers who have been unable to conform to societal expectations may perform adequately during regimented training or even during normal unit operations. But when not adequately supervised, such as in small units, these individuals may not show the restraint and good judgment expected of United States service members.

The Courier Journal recently reported that Green may have been discharged from the army due to a severe personality disorder. If true, and if responsible for the crimes with which he has been charged, perhaps this incident should serve as a reminder that lax recruiting standards cannot produce the quality of armed forces which are consistent with the self-image of America. We can ill afford to field an army whose members have forgotten who we are.

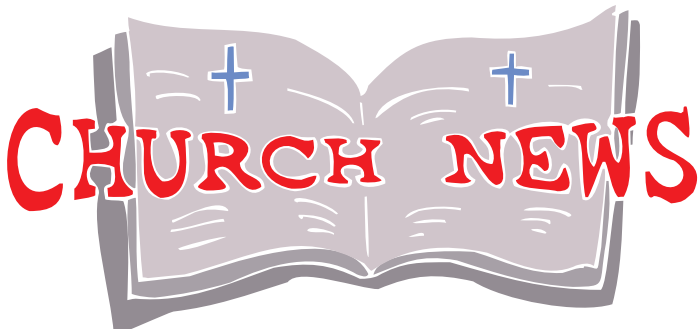

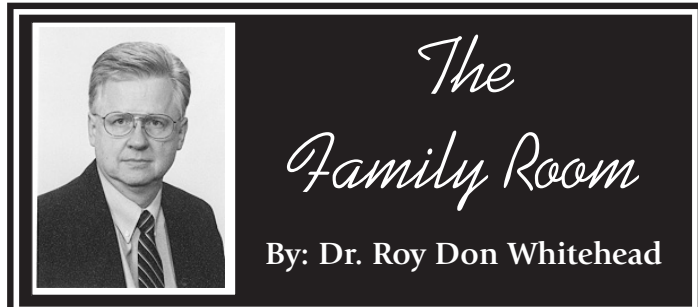

Is going through a divorce harder emotionally than going through the death of a spouse? Both are tragedies, but are there some ways in which the divorce is more difficult?

I consider one friend to be an expert on this subject. She became an expert by going through both. She and her first husband divorced, and her second husband died after a long marriage. She said the divorce was harder on her than the death. She is not the only one that I have heard voice this opinion.

Both divorce and death lead into the grief process. Grief is what human beings feel when something or someone important is lost, and the loss of a spouse is a major loss. Working through the grief can take a long time.

What is it about a divorce that may make it harder? One difference is that the divorced spouse is alive, walking around and still must be dealt with.

A wound heals best when it is left alone. A wound that is continually irritated heals more slowly, if at all. When the spouse is deceased, there is no more contact. A divorced spouse, though, must be dealt with throughout the divorce process and even afterward if children are involved.

Another reason divorce may be harder is that there is an extensive social support system for dealing with a death, but there is not as much help for dealing with a divorce. The visitation, funeral and support of family and friends are valuable resources in dealing with a death. In the event of a divorce, there is usually not this kind of support available. Friends and family may not know what to say. There is no public time for grieving comparable to the funeral for the deceased. There is no formal visitation to provide comfort. There may be only solitude.

Divorce may also be more difficult because of the financial situation. Most everyone who goes through a divorce comes out in worse shape financially than before. The pot of financial resources is only so big and must be divided two ways, so no one has as much as she did. A widow or widower may be left in a bad financial situation, but, if there is insurance, a retirement account and other resources, the survivor may have enough. She will almost certainly end up with more than she would if there had been a divorce.

Losing a spouse by death does not bring down the judgment of society upon the survivor, while someone who is divorced may be treated differently and harshly judged by family, friends or church. Friends who rally around the widower may shun the divorcee. The one who is divorced may be blamed for what has happened. Some who are divorced have told me that they feel as if they have a giant "D" on their foreheads and that everyone treats them differently. Judgment from others may make the recovery process more difficult for the one who is divorced.

Anger may exist following either death or divorce. The survivor may even be angry at the one who died for leaving her. The anger that comes with divorce, however, is often stronger and harder to work through, especially if the other spouse keeps doing things that add to the anger. Difficulty over the settlement, child custody and child support can fuel the fires of anger. This makes the grief process longer and more difficult.

Both death and divorce are tragedies that can lead to grief, anger and depression. In both situations the support of family and friends is crucial to recovery.

The process uses smoke to reveal sources of sewer odors in your neighborhood, as well as places where storm and other surface waters are entering the sanitary system.

A special nontoxic smoke will be used in these tests. This smoke is manufactured for this purpose, leaves no residuals or stains and has no effects on plant and animal life. The smoke has a distinctive, but not unpleasant, odor. Visibility and odor last only a few minutes where there is adequate ventilation.

Because the plumbing appliances in your house or building are connected to the sanitary sewer system, some of the smoke may enter your home if the:

- Vents connected to your building's sewer pipes are inadequate, defective or improperly installed.
- Traps under sinks, tubs, basins, showers and other drains are dry, defective, improperly installed or missing.
- Pipes, connection and seals of the wastewater drain system in and under your building are damaged, defective, have plugs missing or are improperly installed.

All residents are advised that if traces of this smoke or its odor enter your house or building, it is an indication that gases and odors from the sewer may also enter. These can be both unpleasant and dangerous as well as a health hazard to the occupants. Location, identification and correction of the source of smoke that enters your house is urgently advised. If you know anyone who is home bound within the test area, please notify them and make arrangements for their well being if necessary.

While the city will render all possible cooperation, the correction of any defects in the pipes and sewer on private property is the responsibility of the owner. The services of a professional plumber are advised.

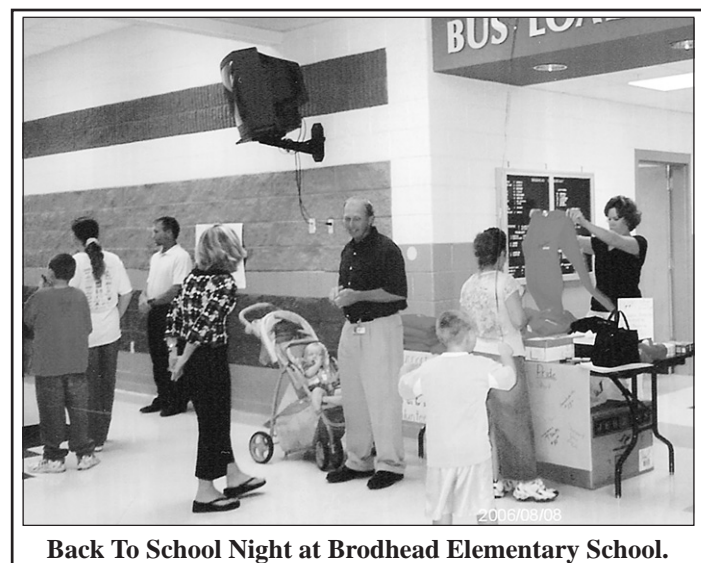

Drive Smart

School is back in session

It's back to school time for hundreds of thousands of students, parents, educators and school staff! The Kentucky Transportation Cabinet and the Drive Smart Program remind drivers to be alert and "drive smart!"

"Traffic is increasing in and around school zones and school buses are on the road again," said Transportation Cabinet Secretary Bill Nighbert. "Safety on our highways and in school zones is the responsibility of every driver. We all need to be especially aware of the extra road and pedestrian traffic that comes with the start of school. The importance of highway safety cannot be overstated. Please buckle up, slow down and drive smart."

"As adults, we must remember how exciting it was to start school each year when we were children," added Education Cabinet Secretary Virginia G. Fox. "If we can keep that thought in front of our minds, we will all be better prepared to be especially cautious in school zones and whenever we are driving near a school bus." Driving safety tips include:

•Allow yourself enough time to get to school or to work. Leave earlier to avoid the potential "to speed" getting to your destination on time.

•When entering a school zone, obey all of the signs. Know that the flashing yellow lights are there to remind you that you need to reduce your speed. Fines for speeding in a school zone when lights are flashing may be doubled.

•Pay extra attention at crosswalks. Take an extra look to be sure that no students are crossing.

•Obey all signs, safety patrol and officers in your school zone. They are there to make the drop-offs and pick-ups run smoother.

•When you approach a school bus picking up a child, it is the law to stop. When the flashing lights come on and the red stop sign extends that means

STOP. When you are on a four or five lane highway and you are approaching a bus that is coming to a stop to pick up a child, motorists that are in the same two lanes as the bus must stop. If you are a vehicle in the opposing lanes, you may continue. Motorists must take extra precautions at bus stops even after the bus completes its stop. Some children might run out into the roadway.

•Make sure that your child is in their safety seat or restrained properly when you are taking them to school.

•Slow Down. Watch for children walking in the street, especially where there are no sidewalks. Watch for children playing and gathering near bus stops.

•Be Alert and ready to stop. Children arriving late for the bus may dart into the street without looking for traffic.

"We want everyone to get to school and back safely," said Commissioner of the Department of Transportation Safety Tim Hazlette. "Our department is working cooperatively with safety advocates to enhance our highway safety education and awareness campaigns to reduce preventable tragedies on Kentucky's roadways."

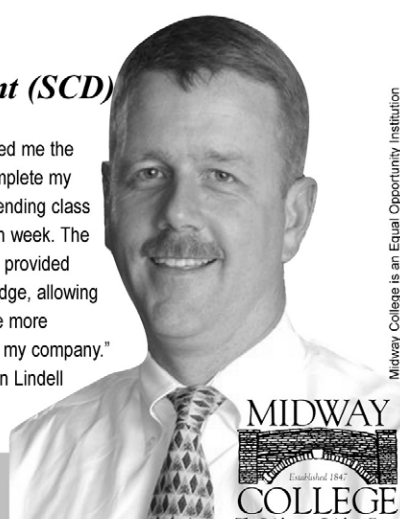

One Year ago this week

David Durham, 26, of Livingston was arrested for an armed robbery at the local Movie Warehouse.

The robbery happened on a Sunday evening and Durham was arrested later that evening, after he was positively identified by other customers in the store.

Durham told employees he had a gun in his pocket, but it was later learned that he only had an object that made it look like a gun inside his jacket.

Durham would later plead guilty to the robbery.

A Hummel man's \$100,000 cash bond stayed the same after a preliminary hearing on sexual abuse charges. Matthew Polly was charged with having sex with minors in July of last year.

Polly is still being held in the Rockcastle County Detention Center under the same bond and he has a September 17th court date for a preliminary hearing.

The mercury in the county climbed to 95 degrees.

Five Years ago this week

School in Rockcastle County began on August 15th for the county's nearly 2,800 students, except for those who attended Brodhead Elementary.

Those students did not report to school until August 27th because of construction delays on their new school. The days missed by the Brodhead students were made up during the year.

Rockcastle County Judge/Executive Buzz Carloftis announced that the county would offer a health insurance plan to county employees and county officials.

A Mt. Vernon man, who traveled by a motorized wheel chair, was lodged in the Rockcastle County jail after threatening a local citizen and then Kentucky Governor Paul Patton, who was visiting the county at the time. The disabled man was released from jail after the Governor's visit. Rockcastle County Public Librarian Kristiana Burk announced she would leave her position after 13 months on the job and the county learned that federal money would be available to help eliminate the use of straight line pipes for sewage disposal.

15 Years ago this week

A Mt. Vernon woman was gunned down in a Family Dollar Store in London as she stocked shelves.

Margaret Alcorn of Mt. Vernon was shot six times with a .25 caliber handgun by a man she did not know. A 22-year-old London man was arrested and later pled guilty to the murder.

Nearly 34,000 GTE phone customers in a five county area were without power, some as long as an hour and a half on a busy Monday morning. Rockcastle County was one of the counties affected.

Seven local girl's, Robin Mullins, Tiffany Carter, Jennifer Noe, Robynne Harris, Rebecca Albright, Angie Stallsworth and Teresa Burdette were busy preparing for the

Miss Rockcastle U.S.A. pageant, which would be captured the next week by Robin Mullins.

20 Years ago this week

RCHS senior Natalie Pybas was crowned Miss Rockcastle County. She won her title over 12 other candidates.

The Rockcastle County Fiscal Court was talking about mandatory garbage collection and using plans drawn up by the local area development district and working with Frankfort to make it mandatory.

However 20 years later there is still no mandatory garbage collection in the county and the subject has not been talked about for quite sometime.

Willaila Feed and Supply burned to the ground and the Mt. Vernon City Council voted to give their 15 full and part-time employees a five percent raise.

25 Years ago this week

The Mt. Vernon City Council discussed the need for more police protection. At the time the council had only three police officers, after policeman Frank DeBorde resigned to campaign full-time for the office of County Judge-Executive. A seat he would lose to Bob Jasper in the fall.

At the same council meeting, then councilman Tom Welch pushed for a city-wide midnight curfew because of the number of people on the streets after midnight.

Police Chief Jimmy Durham agreed that more police officers were needed but at that council meeting no action was taken.

Patricia Rowe, Debbie Wallin, Jennifer Gentry and Kim Hiatt were donating their time as candy strippers at the Rockcastle Hospital and a young Danny Ford, who was running for State Representative, told local Kiwanis members he would be against collective bargaining for state employees.

Incumbent State Representative Harold DeMarcus, of Stanford, who had been in the State House for 18 years, endorsed Ford the same week.

United States' Senator Walter "Dee" Huddleston visited the county as did Ford's opponent Andy Colburn of Stanford. Ford would defeat Colburn in November of that year.

40 Years ago this week

Rockcastle County's own Daniel Boone, a fifth generation descendant of frontiersman and explorer Daniel Boone, turned 95 at his home in Ottawa. The story said, Rockcastle County, "Where the Booneway Meets the Dixie." Other descendants of Daniel Boone, both sixth and seventh generation still live in the county.

Rockcastle County School's reading program, designed by the local system, was chosen as one of the best ten reading programs in the entire nation. The reading program was funded by Title I funds, which are administered by the federal government and is still in existence.

Bill Norton, Harris Burton, Kenny Burton and Andrew Cox

took off to Indiana for their annual 100 mile horseback ride.

Johnnie King of Rt. 3, Mt. Vernon won \$304 in a fishing contest at Mason's Lake near Berea for catching a three and a half pound Carp.

The district meeting for the 21 county area 4-H councils was scheduled for August 24th at J.M. Feltner 4-H Camp in London. A "Gas War" broke out in the county when some stations dropped gas to 30.9 cents per gallon and local residents were warned not to park along Hwy. 150 between the city limits of Brodhead and the intersection with Negro Creek Road.

The Rockcastle Hospital Auxiliary held a canned food drive, collecting 827 cans of food, which were canned at the Mt. Vernon cannery. The program was spearheaded by Mrs. Pauline Mullins of Livingston and Mrs. Arthur Johnson of Brodhead.

100 Years ago this week

There wasn't much news the week of August 17th, 1906, but there were a lot of Sales. F. Krueger and Sons were selling Hamilton - Brown Shoes at low, low prices, A. C. Hiatt had all of his summer goods priced at cost during his summer close out sale in his store at Hiatt and Willis Griffin ran an advertisement notifying people he was the principal undertaker and funeral director and to call him at phone number 63.

Jonas McKinney was also having a sale on his clothes and dry goods and notified customers to call phone number 83.

J.G. Baker, "The King of Low Prices in 1906", that according to his advertisement, was giving customers a 20 to 50 percent discount on clothing, boots, shoes, hats, caps, furnishing goods, groceries, Queensware and hardware.

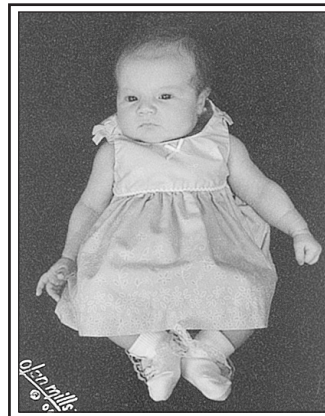

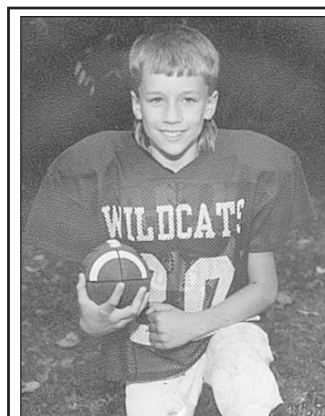
playground equipment and a new fence around the ballfield which will be used for girls softball in the county.

The county's original application for the Quail project, money for the fire department, for Eastern Water Assn., for a sidewalk project in the city of Mt. 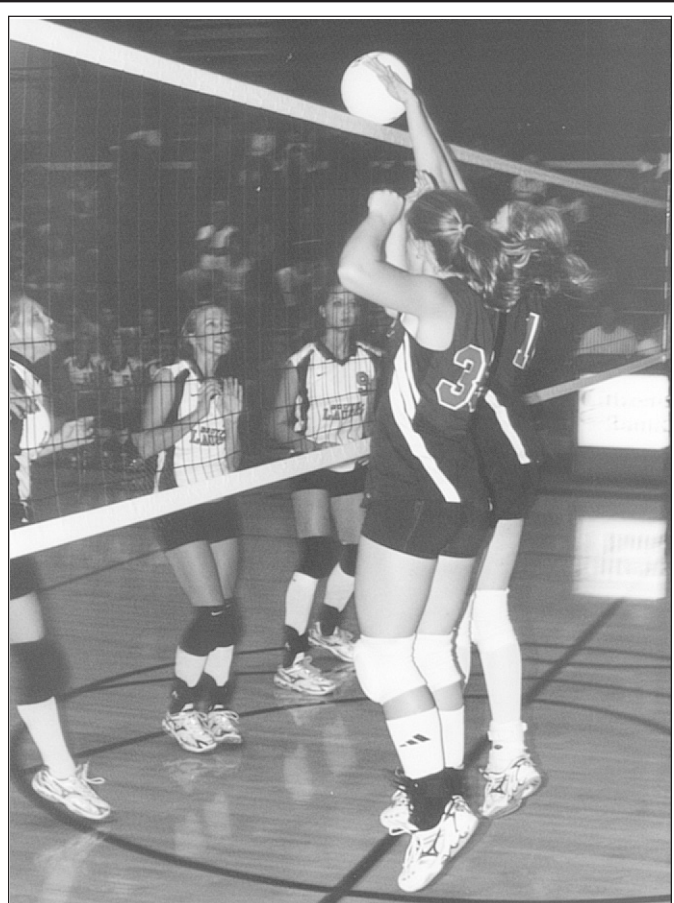

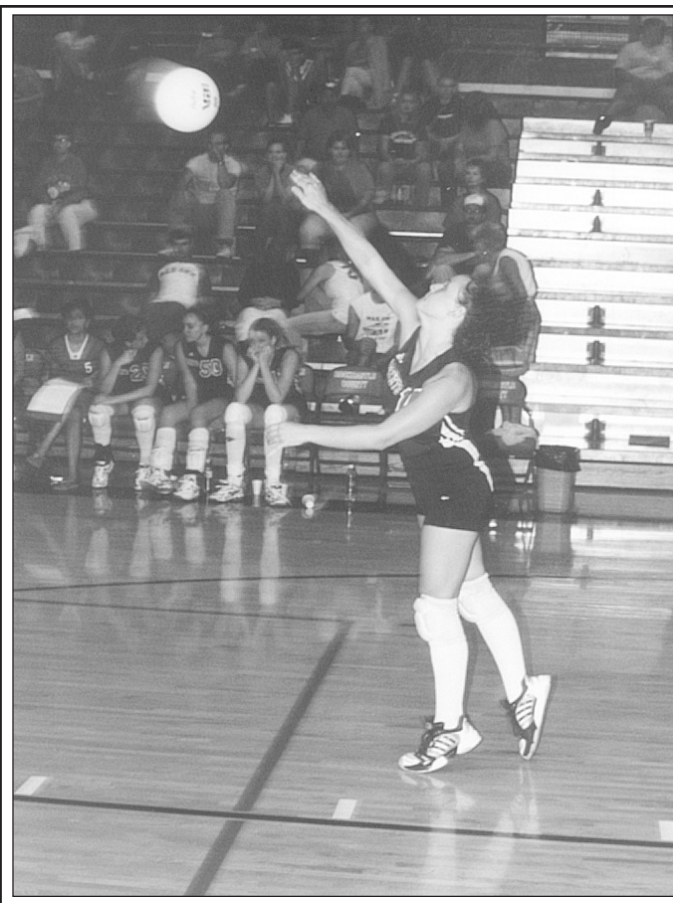

ber of NCLB goals to meet in order to reach the standard.

The Adequate Yearly Progress Report was released on August 9th by the Kentucky Department of Education.

Because the Rockcastle County High School does not receive federal funding, the school system as a whole will not be penalized and will receive their Title One funding.

This year that amounts to \$932,435 which is used mostly on the salaries of instructional assistants and teachers at the three grade schools, according to Rockcastle County School Superintendent Larry Hammond. The middle school does not receive Title One funds either.

If any of the county's three elementary schools, or the middle school, failed to meet the requirements of NCLB, the schools would be subject to consequences, such as being required to allow a student to transfer to his or her school of choice because of the low scores. However the local school system has not had any school not meet their goals for two years in a row and only the middle school in 2002-03 and the high school last year have failed to meet their goals.

For the middle school it was only one year and the high school will have a year to meet their goals. However because they do not receive any federal funding there will be no consequences even if they don't.

"We are pleased with the efforts of everyone," said Superintendent Hammond.

"All of our employees work hard to give our students a very well rounded education and we have no intentions of letting up," Hammond added.

In grades third through eighth, over 66 percent of the district's students scored proficient in reading while just less than 50 percent scored proficient in math.

Although the district's math scores were lower than the reading scores, the 49.49 percent in math and 66.59 percent in reading showed an improvement in both subject areas. Math scores were up ten percent and reading scores up two percent.

The percentages were taken from the last two years of test results from the CATS tests and not just based on the results from the 2005-06 school year, according to District Assessment Coordinator, Rebecca Isaacs, who will present the results of NCLB at the next school board meeting on September 12th.

Roundstone Elementary School had the largest gain of approximately 18 percent in math. "Our improvements are due to the desire of staff and family members working together so that our goals can be achieved and our students realize success," RES principal Patty Renner said. Renner was guidance counselor at the school for many years before being hired as principal beginning this school year.

"I think our school system has maintained and continues to maintain literacy as a long-term priority," said school board Chairman Terry Burton. "Professional development efforts and, more recently, instructional efforts have strengthened the successes of mathematical application in the classroom," Burton said.

"Our schools have merged the accountability requirements at the local, state and national levels while establishing a needs-based academic environment resulting in more and more students reaching the proficient level," Hammond said.

At all five county schools, the best scores were in reading and the lowest were in math.

Brodhead had to best two year average scores in both reading and math, with scores of 98.25 in reading and 90.16 in math.

At the county's largest elementary school, MVES students scored 81.57 in reading and 63.3 in math. At Roundstone Elementary School the reading score was 73.57 and the math score was 71.13.

Students at the middle school scored 73.57 in reading and 39.88 in math. Reading scores at the high school were 40.89 and 35.77 in math. The high school did not reach their goal in the students with disabil-

ity category in reading, but those students did reach their goal in math.

The best score any school can reach is 100 percent and by the year 2013-14, all county schools must reach 100 percent, according to the NCLB formula.

Last year, Brodhead Elementary students had a perfect score of 100 in reading, but they dropped off about three percentage points this year.

that the items used to make meth must have belonged to her son's girlfriend.

Lunceford is currently being held in the Rockcastle Detention Center and she likely faces other charges from the July 12th search of her home. The case will be presented to the Rockcastle County Grand Jury, according to Bartley.

Also on Friday, Mitchell Durham, 32, of Berea was sentenced to jail for five years after breaking the terms of a pretrial diversion for the offense of criminal mischief, on two different occasions.

In March, Durham's diversion was revoked by Burdette after he did not complete his community service work, but in May, Burdette granted shock probation for Durham on strict terms and he was again released from jail.

Friday, Durham admitted to being charged with driving under the influence, second offense and having an open alcohol beverage container in his vehicle. Bartley strongly urged that Durham's probation be revoked. He is currently being held in the Rockcastle County Detention Center.

A Crab Orchard man, who had been indicted in September of last year for Trafficking in a Controlled substance, was sentenced to seven years in prison, after violating the terms of his probation, which were set forth in April.

According to Bartley, Brian Killen, 26, failed to report to his probation officer and had several drug screens come back positive. Killen was taken to Lincoln County where he faces other charges.

Also in Circuit Court on July 28th, Circuit Judge David Tapp sentenced three defendants and revoked three probations.

Shelly Looney, 29, of Red Hill, was originally sentenced to five years probation and ordered to complete a drug rehabilitation program for the charge of reckless homicide.

Looney's 16-month-old son died in a mobile home fire on June 23rd. Looney left the infant alone while she ran for help. Blood tests on Looney, taken the day of the child's death, showed that she was intoxicated at the time of the fire.

According to police records, Looney apparently started the fire in the trailer when she dropped a burning cigarette on the couch while passed out.

On the 28th, Bartley presented testimony from probation officer Coomer that, while Looney was on probation, she would be out of the area of supervision to attend a funeral in Florida.

However, Coomer testified he had received a call that Looney had also gone to Indiana where she attempted to pick up her other child.

Testimony revealed that police were called to the scene in Indiana.

Judge Tapp found that Looney had violated the terms of her probation in what he said, "isn't even a close call."

Looney was indicted in July of last year and pled guilty on December 22.

Looney, who is being held in the Rockcastle Detention Center, was remanded to the Department of Corrections, to serve her five year sentence, by Judge Tapp.

Mary Jane Helton, 39, of Conway Village Trailer Park, was sentenced to six years in the penitentiary on a charge of sodomy, second degree. She had also originally been indicted for sexual abuse in the case.

Her male victim was under the age of 12.

Bartley noted that Helton, who pled guilty to the charge, is not eligible for probation and will be required to register as a sex offender for the remainder of her life, once she is released from the penitentiary.

Jason Poindexter, 41, of Dayton, OH, pled guilty to possession of a handgun by a convicted felon and possession of a controlled substance. He was indicted in April. Judge Tapp sentenced him to six years in the penitentiary.

Michael Cromer, 23, of Berea, who had originally received a three year probated sentence for two counts of possession of a controlled substance, is behind bars again.

Cromer was ordered to serve his sentence after he absconded "ran away" from supervision. He had been indicted in September of last year.

Tommy Scott, 27, of Mt. Vernon also had his three year probation revoked for receiving a DUI conviction. He was ordered to serve a three year sentence for cultivating marijuana. He was originally indicted in November of 2004.

An August 25th sentencing date was set for Steve Napier, 23, of Mt. Vernon, who pled guilty to receiving stolen property. Bartley has recommended a one year jail sentence.

Helton, Poindexter, Cromer, Scott and Napier are all being held in the Rockcastle Detention Center.

Commonwealth Attorney Eddy Montgomery said this week that these cases demonstrate that probation is no cake walk.

"A probated sentence in front of our judges is serious business. While our office may recommend a sentence be probated to give the offenders an opportunity to make right, we will not tolerate any violations of the strict terms that are given," he said.

According to James Renner, Rockcastle County Solid Waste Coordinator, also said the county is receiving a \$150,000 Super Pride Grant for clean-up of a dump on the Brunt Ridge Road.

Renner said he and his crew are presently cleaning up a dump site on Copper Creek Hill, one on Ky. 1250 (Spiro Road) and one on U.S. 490, south of Livingston, with state grants.

"Significant progress has been made in addressing the illegal dump issue, due in large part to a statewide cleanup and an education campaign by local, state and federal agencies," said R. Bruce Scott, director of the EPPC Division of Waste Management, which administers the fund.

State funding for the illegal dump grant program is from a \$1.75 environmental remediation fee for each ton of garbage disposed of at a Kentucky municipal solid waste disposal facility. The "tipping fee," authorized by the 2002 General Assembly, is collected quarterly and placed in the Kentucky Pride Fund to help combat illegal dumping and finance the closure of old landfills. The Pride Fund is the first legislated and ongoing source of state funding for this work.

Illegal open dump cleanup has been a continuing project in Kentucky for several years, primarily using county and federal money.

Senate Bill 50 also expanded the scope of the Kentucky Pride Fund to address household hazardous waste collection and recycling infrastructure.

guilty to all charges, according to UNITE Prosecutor David L. Dalton.

In August 2005, Operation UNITE purchased pills from Bostic at a residence in Rainbow Ridge in Rockcastle County. Bostic told the informant that she was selling four Vicoden pills for \$20. Lab reports later revealed that the pills were not Vicoden, but a non-controlled substance - methocarbamol. Methocarbamol is a pain relaxer much different and less addictive than Vicoden.

In October 2005 and again in December 2005 Bostic sold 2 Hydrocodone pills for \$20 to UNITE. Both of these sales occurred at Bostic's residence.

Dalton indicated that he would recommend 2 years imprisonment upon Bostic's plea of guilty. He further indicated that he would oppose probation, shock probation, or conditional discharge - based mainly upon the fact that on three separate occasions, Bostic had sold or fraudulently attempted to sell controlled substances.

Rockcastle Circuit Judge Jeffrey T. Burdette set final sentencing for October 13, 2006.

formal arraignment and pleaded innocent before Pulaski and Rockcastle District Judge Katie Wood.

Wood set Cannada's bond at \$250,000 cash, and also assigned a public defender to Cannada, per his request. Cannada had been jailed without bond pending his arraignment.

Cannada was arrested last Thursday and charged with two counts of retaliating against a participant in a legal process.

Pulaski County Sheriff Todd Wood said Cannada threatened the lives of Lambert and case worker Shan Swanner during a phone conversation with Curt DeLoache, a clinical social worker.

"Count 1 stems from (Cannada) saying to (DeLoache), 'I'm going to shoot that b**ch' in reference to Judge Lambert," said Wood. "Count 2 stems from (Cannada) saying that he was going to blow (Swanner) away."

Wood said his department recently served a warrant on Cannada for failure to appear in Lambert's court to show that he had completed counseling the judge had ordered.

Cannada is being held in the Pulaski County Detention Center.

Wood set a preliminary hearing in the case for this Thursday (today).

CKBC Blood supply emergency update

The blood supply for Central and Eastern Kentucky remains critically low, leaving 67 hospitals in this half of the state with a limited supply of blood. CKBC collected 498 pints of blood Tuesday of last week but the region is still not "out of the woods" as far as rebuilding the blood supply.

"We are dodging a real threat to our community's blood supply," said Susan Berry-Buckley, CKBC president and CEO. "The current supply in Central and Eastern Kentucky is not adequate to respond to a disaster, whether natural or man made. For example, a storm-related catastrophe could wipe out the area's remaining blood, leaving our hospital patients vulnerable." The blood needed for such an emergency would already have to be on the shelves at every hospital in our area, added Berry-Buckley. The serious shortfall won't be solved in just one or two days, CKBC needs two solid weeks of giving to rebuild the supply.

A less than two day supply of blood for the 59-county region on Monday, prompted CKBC to announce an emergency appeal for blood donors. Currently, the area's blood supply is 445 pints or 46% below what is needed to protect the region. The inventory of type O blood, the most commonly

transfused type, is 227 pints low. Type O-positive is 58% below normal while type O-negative is 30% below normal.

CKBC attributes the shortage to lower turnouts at blood centers and mobile drives this summer and near-record blood transfusions at area hospitals.

CKBC asks health donors who have not given blood in the past 56 days to donate blood immediately. People who have never made a donation are needed to step up and join the surge of donors rebuilding the community blood supply. Donors need to bring a photo ID with them. A list of upcoming blood community blood drives and donation locations is attached.

Donors must be at least 17 years of age, weigh a minimum of 110 pounds and be in good physical health. Please note, the Food and Drug Administration (FDA) changes blood donor eligibility guidelines periodically. Individuals with eligibility questions may email info@ckbc.org or call 888-775-2522.

REPORT ADDRESSES WATER QUALITY PROBLEMS IN BRUSH CREEK AND CROOKED CREEK

A draft report addressing water quality problems related to pathogens is available for public comment. The report, Total Maximum Daily Load for E. coli in Brush Creek and Crooked Creek of Roundstone Creek, Rockcastle County has been prepared as required by the federal Clean Water Act.

A section of the Clean Water Act requires each state to periodically identify specific waters where water quality problems exist. The state is also required to prioritize the list of impaired waters, to calculate an allowable amount of pollutants for those waters (TMDL) and to devise alternative implementation plans to remedy the impairment. These reports are part of the process to improve water quality in these streams.

The Division of Water is asking for comments on this draft report. Revisions to the reports may be made based on public comment. The revised reports will then be sent to the U.S. Environmental Protection Agency for review, comment and approval.

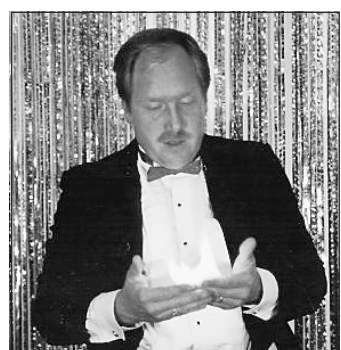
"I love to go out and share the good news of Christ with every person I come in contact with," Greg writes on a Web site. "That's why I am so ex-

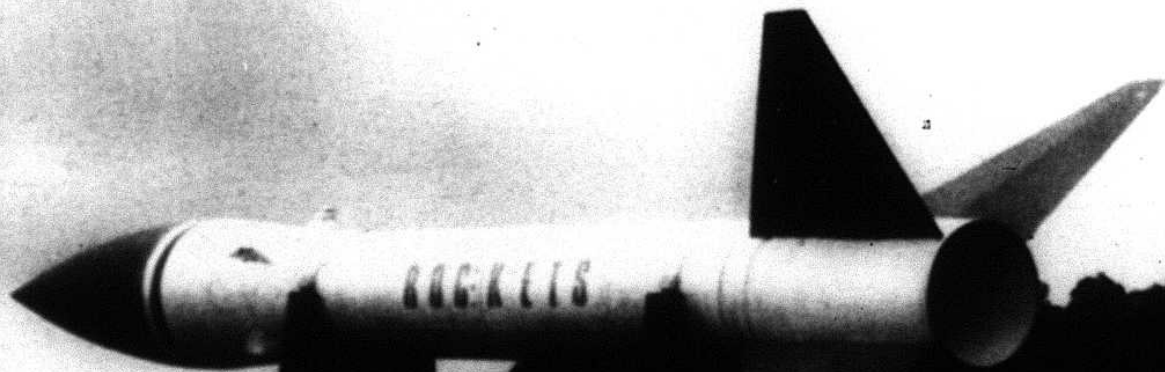

Larkey optimistic about '06 season

With seven starters back on offense and six returning on defense, it is hard for Rockcastle County High School football coach Tom Larkey not to be optimistic about his team's chances for 2006.

In 2005, the Rockets won the region for the fourth time in six

years when they shutout the Bobcats of Bell County in a road game, 21-0.

"We are all keeping our fingers crossed this year because of the number of injuries we had last year," Larkey said.

"We were pretty beaten up when we played Catholic in the state semi-finals," he said.

Offensively, Larkey and his coaching staff are going to be depending a lot this year on their offensive line and "they should be able to get it done, they have the experience, size and the desire," Larkey said.

Across the front line will be center Adam Mink, guards Donovan Pigg and Scott

Daughtery, tackles Brad Durham and David Robbins. Shawn Childress, Lynn Miracle, Zach Burkhardt, Nick Nolan in the various formations Larkey will present. Childress and Miracle will be senior first year quarterback Izak McQueary's main targets. Both men may also see some tightend play with

Burkhart and Nolan.

Joining McQueary in the backfield, will be fullback Adam Hensley and tailback Dusty Miller.

Larkey said several young players were being groomed for playing time so the team would have more depth. "Nothing is ever set in stone in this program and we will know a whole lot more after camp," he said.

Defensive Coordinator Adam Coleman, who is heading into his fourth season in that role, said he too was optimistic about the Rockets chances this season, but "It is not going to get done without a lot of hard work and a little luck with our injuries," he said.

Coleman too said he and other coaches, such as head assistant Tony Saylor, would know more about their defensive and offensive units after camp and many days in between that on the ROCK's own practice field.

"We are going to try and go 17 or 18 deep because, when late October and November rolls around, you have no guarantee the personnel you started the season with, will still be there," Coleman said. Coleman said Josh Garrison, who had off season shoulder surgery, should be released pretty soon for contact," he said.

Defensive end Donovan Pigg will call defensive signals and "Brad Durham will be a force to reckon with from the noseguard position" Coleman said. "We will have a lot of schemes on defense, adjusting to whatever our opponents are running on offense," he said.

Eight of the eleven starters on defense and offense will play both ways. "We certainly are trying our best to get them in the best condition they have ever been in their lives," Saylor said.

"Shawn Childress will do the punting, but the place kicking job is certainly up for grabs," special teams coach Chris Larkey said.

Jill Owens, who had a great season a year ago, will be the setter once again. Kayla Stewart will be the Libero and Bethany French will be the defensive specialist.

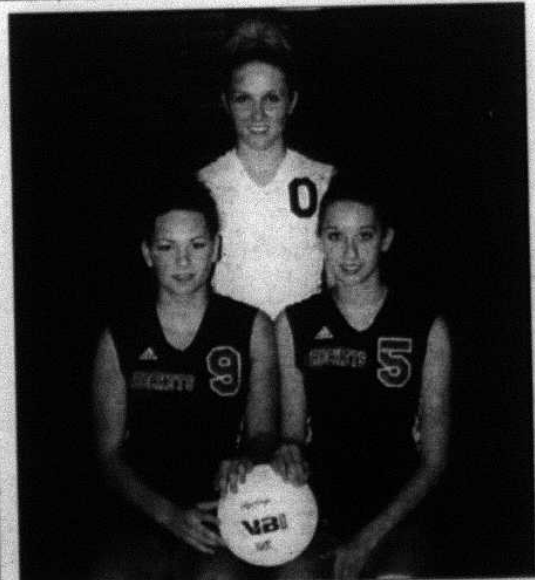
Lee said he probably was only going to dress ten or so on the varsity. "We will just have to wait and see how it goes throughout the season," he said.

ROCK opens season Saturday at Pigskin Classic

When The Rockets take the field in Danville on Saturday they won't be playing the Danville Admirals but they will be playing another one of Kentucky's most storied and honored high school football teams.

The Rockets open the 2006 season against the Corbin Redhounds, a team that finished five and five last year. Corbin lost to Louisville DeSales in triple overtime in the second round of the playoffs last season.

The Rockets last faced Corbin at Corbin in 2004 and came away with a 42-22 loss. The Redhounds and the Rockets have met ten times since 1991 and the Rockets hold a 6-4 edge. "It will no doubt be one of the toughest games on our schedule. No one wants to open with a team like Corbin," said head coach Tom Larkey, who has a new quarterback, senior Izak McQueary, a three year starter and many returning starters from a year ago. When the Rockets kick it off in the opening game of this year's Bob Allen Pigskin Classic, it will be the Rockets fourth trip to Danville to play in the prestigious bowl game. The Rockets are 1 and 2 with a win over Washington County and losses to Mason County and to Danville last

year 34-0.

However, after being shut-out by the Admirals, the Rockets would go on to win 11 football games and a Class 3A, Region Four title.

Last year, the Rockets traveled to Cawood, the second week of the season and came away with a 49-3 win. But Cawood will not be on the ROCK's schedule this season. Cawood bought their contract out and the Rockets picked up Bourbon County for week two. It will be the ROCK's home opener and also the Renfro Valley Jamboree Bowl. Bourbon County, who has not won a game in two years, has a new coach in Rick Massey, a former University of Kentucky player. "They are no doubt in a rebuilding mode," said Larkey.

In game three, the Rockets will face an always tough Harrison County team at the ROCK. The Rockets defeated Harrison County on Harrison's field a year ago, 32-14.

Harrison County ended the season with a 6-5 mark, losing to Covington Catholic 17-14 in the first round of the state play-offs in Class 3A, region three.

In week four, the Rockets will travel to Stanford to take on the Lincoln County Patriots. The Rockets defeated them 31-8 in the Renfro Valley Jamboree Bowl last year. The Patriots finished the season five and five and did not make the play-offs. "They were young last year and they finished the season winning two of the last three and three of the last five, they'll be ready for us," said head assistant coach Tony Saylor.

The next week the ROCK gets a week off before heading into district play.

On Friday, September 22nd, the Rockets will face Letcher County Central and it will also be homecoming at the ROCK. Last year, the Rockets defeated Letcher 62-0. Letcher County Central will be one of the teams the Rockets will lose from their district in 2007.

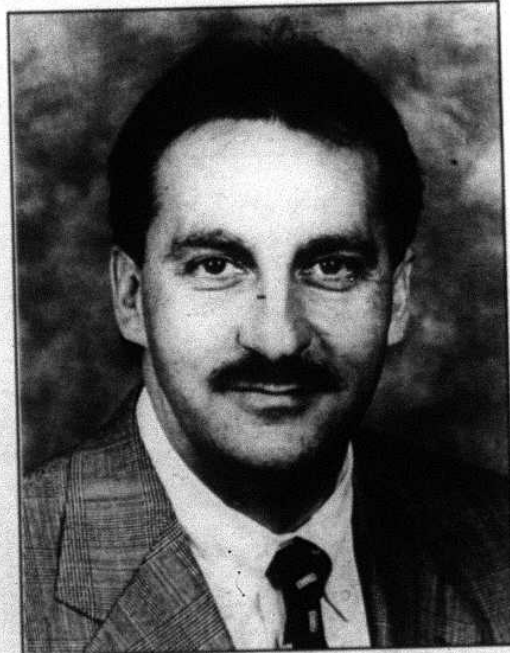

Clay County will also be one of those teams who will not return to the Rockets' district next season.

In week seven, the Bell County Bobcats come to town and have been scheduled for Little League night.

Last year, the Rockets and Bobcats split one and one on the year with the Rockets winning the most important contest, the regional championship game. In the regional championship game, the Rockets traveled to Log Mountain, where they had lost earlier in the year 33-29 in the final seconds of the game, after leading the entire way.

But on that cold November night, the Rockets sent the 2005 district seven, region four champions to the house 21-0. "It was a great victory, a total team effort," head coach Tom Larkey would say after the win.

In week eight, the Rockets go to Berea to face the Madison Southern Eagles. The Rockets defeated the Eagles 35-7 last year. The Eagles would end their season with a 9-3 record, losing to Bell County 38-7 in the second round of the playoffs. "They were pine and three a year ago and we have to go to their place," Larkey said. Madison Southern has never beaten the Rockets.

Week nine finds the Rockets in

Hazard where they will take on Perry County Central, another team moving from the Rockets' district next season. The Rockets easily defeated Perry County Central 48-7 last year.

Last year, Perry County Central won only one game, defeating East Ridge 41-14. Next season, Perry County Central will move to Class 5A.

The Knox Central Panthers will round out the Rockets' regular season schedule when the Rockets host them on Senior night.

Last year, the much improved Panthers were five and five, but four of those losses were in district play causing them not to make the playoffs.

The Rockets will likely host at least one round of the regional playoffs when they begin the first week of November, just as they did last season.

Last year the Rockets trip to the state semi-finals started in Mt. Vernon with a one point win over Mason County, then onto Ashland for a 32-14 win over Paul Blazer and then back to Log Mountain, between Pineville and Middlesboro, where the ROCK handed Dudley Hilton's squad a 21-0 defeat. The Rockets did not win the district a year ago, but picked up their fourth regional title in the past six years. The ROCK would eventually lose to Lexington Catholic in the state semi-finals 48-20 in a game played on the Knight's field in Lexington. Catholic would eventually go on to win the Class 3A state championship.

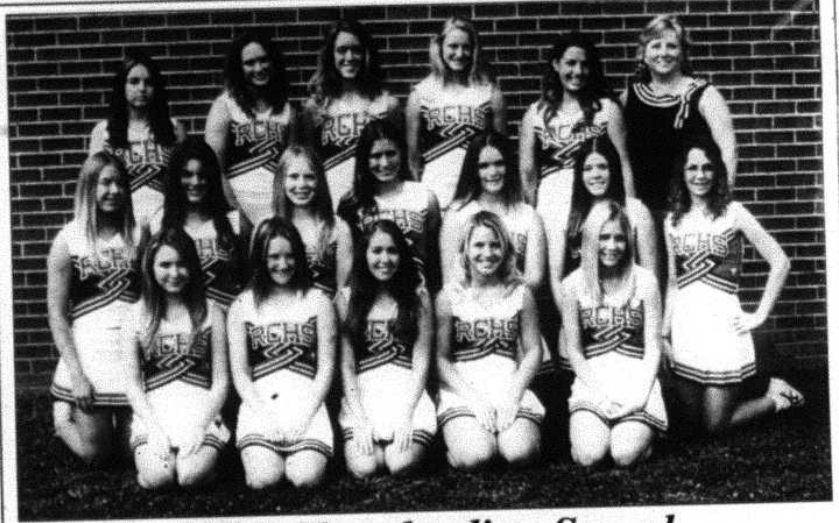

Cross-country is open to any school-aged child that likes to run and wants to participate. Workouts are

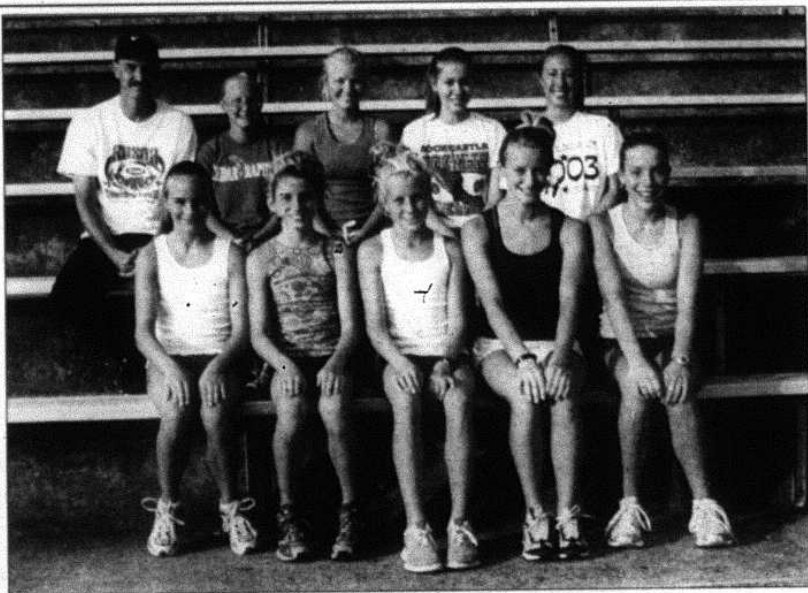

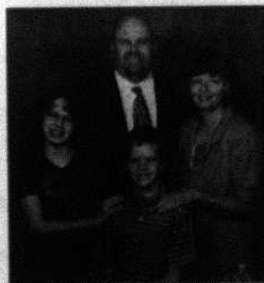

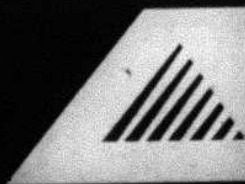

Rockets moving to new 4A district for seasons 2007-2010

The Kentucky High School Athletic Association is up to their shenanigans once again.

Beginning next year there will be six classes in football.

The Rockets will be moved from Class 3A to 4A and will lose three of their current district opponents and pick up only one new one.

According to the KHSAA web-site, the Rockets will lose district foes Letcher Central, Perry Central and Clay County. They will pick up only McCreary Central, leaving them with just four district games.

Four of the five teams in the ROCK's seventh district will make the state playoffs.

The format is the same as always. It will take three playoff victories in districts seven and eight to reach the state semi-

nals.

The only good news is that one the ROCK's nemises in the past won't be waiting for them if they make the semi-finals.

Boyle County was moved into district six along with Lexington Catholic.

The Rebels defeated the Rockets in the state championship two years straight in 2001 and 2002 and the Knights beat the Rockets in the state semi-finals a year ago. Also in districts five and six are, in district six: East Jessamine, Franklin County, West Jessamine, Boyle and Catholic. In district five you will find Bourbon County, Covington Catholic (a team the Rockets defeated in the state semi-finals in 2001), Harrison County, a team the Rockets play this season and a team they defeated a year ago and Pendleton

County, Highlands, who the ROCK absolutely destroyed in 2002, but who also defeated the ROCK handily in 2000, stayed in 3A.

Besides possibly playing their own district foes from the regular season, they will face Boyd County, Greenup County, Lawrence County or Rowan County, all from district 8 in the first round and all of whom are guaranteed spots in the playoffs, even if they don't win a district game. After the first round the Rockets could face one of the teams in their own district in round two and in the regional championship game, as they did last year, when they defeated Bell County on Log Mountain to win the region.

"We will figure out some way to fill the opening left by the loss of Letcher Central, Perry Cen-

tral and Clay, of course, McCreary Central will take one spot on the schedule and we may even schedule a team or two who were in our district, during the regular season," head coach Tom Larkey said.

The new format will start next season and run through the season of 2010. The only notable teams gone from the Rockets' current region are Mason County and Ashland Paul Blazer.

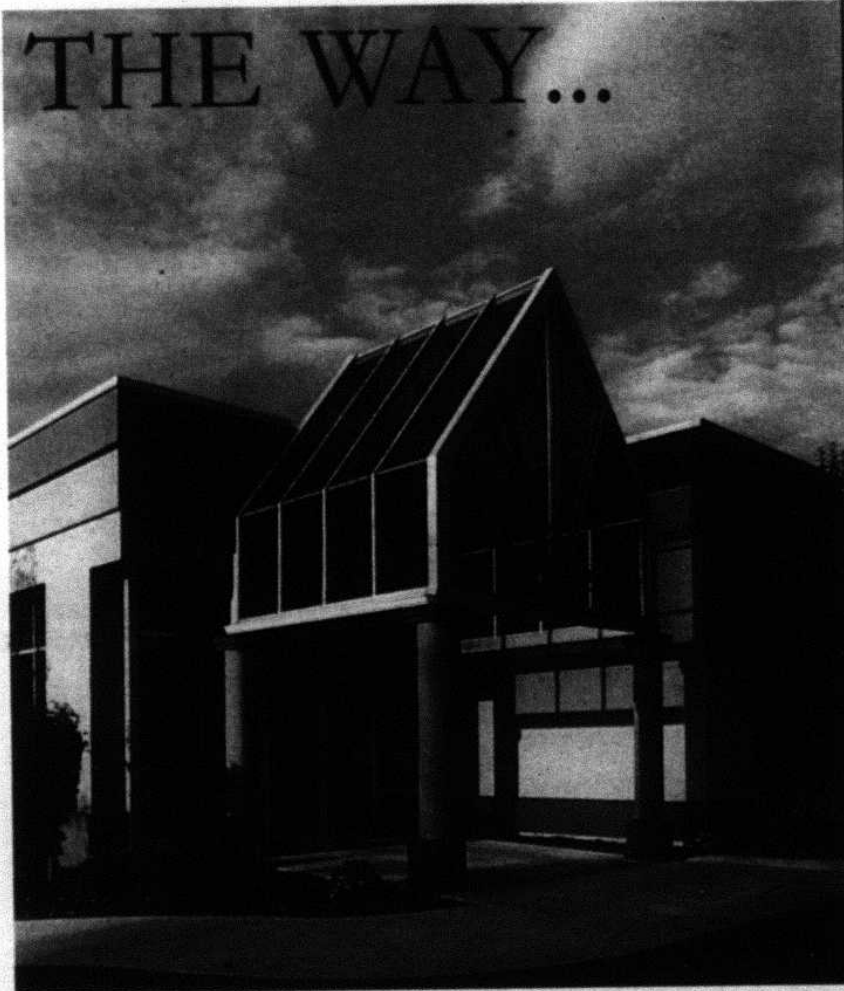
