## Livingston water system, Quail Community Park

# Governor brings money for numerous projects

Tuesday, Kentucky Governor Ernie Fletcher passed out more than \$750,000 in community development funding for Rockcastle County to rehabilitate water infrastructure, renovate the Quail Community Park and improve operations at several local fire departments.

The Governor presented ceremonial checks to local officials for the projects after speaking to the Rockcastle County Chamber of Commerce during their regular monthly meeting, held at Community Trust Bank's Hwy. 461 office.

One of the monetary awards was a \$507,000 Community Development Block Grant (CDBG) to the City of Livingston for improvements to their water system's infrastructure. The funding will rehabilitate waterlines throughout the city and replace an existing concrete ground storage tank with a 128,000 gallon standpipe tank.

"Rehabilitating water infrastructure is an important step toward future growth for Livingston," said Governor Fletcher.

"The city was losing money because of water loss and pres-

sure issues associated with antiquated lines and equipment. These upgrades will enable the city to achieve greater fiscal efficiency and provide better services to residents."

Constructed in the 1950s, the aging water system has been plagued by leaks. The city purchases its water from the Wood Creek Water District but loses approximately 48 percent of it thru leaks, costing the city more than \$22,000 a year in charges from their supplier. Recently, measures have been taken by

water department employees at the city which have reduced this figure dramatically, city officials told the Signal.

"This project is long over due," said Sen. Ed Worley (D-Richmond), who represents Rockcastle County in the State Senate.

"Aging water systems have been a significant financial burden for the city and renovations will help to relieve that financial hardship."

# Feds take control of Miracle case

Raymond Miracle, 39, of Lawrence Lane, Mt. Vernon appeared in Rockcastle District Court on Monday for a preliminary hearing, after being charged with 56 counts of criminal possession of a forged instrument.

Miracle had \$1,600 in counterfeit \$20 and \$100 bills on him when he was stopped for driving erratically, by a member of the Kentucky State Police Spe-

cial Response Team last Tuesday in Mt. Vernon.

Miracle told State Police Detective Gary Lane the bills were his and he knew they were counterfeit.

Judge Katie Wood set Miracle's bond at \$250,000 cash or property but, on Monday, a federal warrant was presented against Miracle for a fed-

## During remarks at Chamber

# Fletcher talks about accomplishments in his administration

Kentucky Governor Ernie Fletcher was all smiles Tuesday when he talked to a capacity crowd at the Rockcastle County Chamber of Commerce's annual monthly meeting.

Fletcher talked about his administration's accomplishments in education, the attraction of high technology jobs, agricultural diversification, road improvements, improvements in the health care field and general overall operation of state government.

Fletcher said that when his administration came into office, he immediately took over a multi-million dollar debt.

The Governor pointed to streamlining the 14 cabinet positions into nine, cutting state jobs, especially in transportation where 1,000 jobs were eliminated, creating a tax that would make individuals responsible for paying their taxes in Kentucky if they owned part of a company in Kentucky and collecting delinquent taxes. Fletcher said his administration had also changed the tax code in the state which reduced the tax on 75 percent of all small businesses and completely took thousands off the tax rolls.

The Governor said his administration had awarded \$1 billion dollars in road projects, built ten recovery centers for drug and alcohol rehabilitation, reduced meth labs in the state by 57 percent and put 25 percent more money in education than any previous administration.

The Governor pointed to the new Rockcastle County Area Technology Center, at a cost of \$9.5 million, as an example.

"The demand for high tech workers is going to be even greater in the future and out of

state and overseas companies are finding that "Kentucky is a great place to live."

The Governor said everything any employer would need can be found in Kentucky.

He pointed to trained workers, low cost of living, great educational opportunities and the best health care system anywhere.

The Governor pointed to the accomplishments at Rockcastle Hospital and called the respiratory care unit at the hospital "one of the best in the nation."

"You have so many things to build on and you will have the

education facilities right here to help you train your workforce," he said.

The Governor also said the county had not even begun to tap into the potential at Renfro Valley.

"There is going to have to be a collaboration between the private and public sectors and there is going to have to be more for families to do when they arrive," he said.

"We all know that thousands of families travel past Renfro Valley on I-75 everyday, but we

# New Hwy. 150 project from Crab Orchard to Brodhead to begin soon

Kentucky Transportation Cabinet Bill Nighbert told the Signal and WRVK radio listeners Tuesday that construction on the new Hwy. 150 between Crab Orchard and Brodhead would be getting underway in the next several months.

Nighbert's comments during an interview with him and Kentucky Governor Ernie Fletcher, after a meeting with the Rockcastle Chamber of Com-

merce.

Joe Cox, an engineer with the Kentucky Highway Department in Somerset, said bid letting for the project between Brodhead and Crab Orchard had been scheduled for September but, because water permits from the Corp of Engineers took anywhere from six to eight months to get approved, "the

# Anne Northup visits Rockcastle Friday morning

Kentucky Republican gubernatorial candidate Anne Northup of Louisville brought her campaign to the county on Friday, as part of a short tour of Southern Kentucky.

The former United States Congresswoman and Kentucky State Legislature said she was in town to visit with some local supporters, including Jailer James Miller and Circuit Clerk Teresa Vanzant, who have offered to help in her campaign in the county.

The two local officials were among about 16 who met with her at Kastle Inn Restaurant.

The veteran lawmaker said she loved the Republican party and simply wanted Kentucky Republicans to have a choice, "an alternative to Fletcher," in the May Primary.

"I have never run against a Republican in my life but, directly after last fall's election, which I lost, I started receiving phone calls from all over the state asking me to run for Governor," she said.

"And, according to polls, I'm running neck-and-neck with the

Governor," she said.

"I think Jeff Hoover (the Lt. Governor candidate on her ticket) and I are a viable team with a great vision for Kentucky and we don't have the baggage that the Fletcher administration has," she said during an interview at the Signal office.

"We don't think Republicans want to see \$10 million in negative ads concerning illegal hiring practices, indictments, subpoenas, pardons, etc.," Northup said.

"The Governor has misrepresented some of his accomplishments while on the campaign trail," Northup alleged.

On Friday, and in an e-mail to members of the Rockcastle County Chamber of Commerce on Monday night, Northup outlined some of her accusations that Fletcher was not telling the truth about his administration's performance.

In her e-mail, Northup claims the Fletcher administration has created only 56,600 seasonal jobs.

Northup says Fletcher

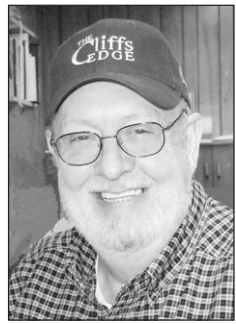

## Rockcastle Memories

My mother (Bee) and I boarded the majestic train called the George Washington Special to Washington D.C. when I was 14 years old. The year was 1958. We left from Lexington on vacation to visit my older brother and his wife. They had recently moved to Manassas, VA, where he was pastor of the Woodbine Baptist Church. The George did not unload passengers in Manassas so Al and Eva would meet us at Union Station in D.C., approximately 30 miles from their house.

At its inaugural on April 30, 1932, the George Washington was C&O's top-notch train. It was one of only two all air-conditioned, long-distance trains operating in America. Just before we decided to take the ride, it was completely refurbished by Pullman and by C&O. Tracks Magazine reported, "The newly redesigned George is a sizeable train with its engine, three baggage cars, a diner, three coaches, and four Pullman cars."

I was thrilled to take an excursion on such a special train. When we boarded, Bee and I stashed our bags, settled down, and tried to contain our excitement

when we felt the engine pull out of the L & N Depot. It was late afternoon, and we watched the familiar scenery through our window as we headed east.

After a few miles, I decided to take a walk. My first stop was the diner where I ordered some fries and a Coke. If my recollection is correct, my bill was nearly \$6. Bee's response to this was, "We can just wait until we get to Albert's before we eat again." However, she got hungry the next morning and settled for ordering what I recall was a "skimpy" breakfast for the two of us on the train.

After dark overtook our view, we settled down into the comfortable seats and were lulled to sleep by the sound of the wheels on the track. After a short nap, it was difficult for me to stay in one place while on board this exciting ride. With Bee sleeping, I quietly got up and walked to the back of the last car where you could go outside and see the tracks disappear into the darkness. I stood there for a long time just feeling the train as it rocked gently from

## Testing for Blood in the Stool

Cancers are not always easy to detect early, but there are some exceptions. There is an excellent screening test for cancer of the colon. And it can be done at home at your convenience.

The test is a set of cardboard slides that have patches where you apply a tiny smear of the stool. This is done on three consecutive days. These slides can be mailed to your doctor in an envelope, which is provided. The slides are then developed and read.

The test determines if there has been any loss of blood in the stool. Even microscopic amounts of blood far too small to be seen with the naked eye can be detected. In fact, the test is so sensitive that you must follow the dietary restrictions noted in the instructions and avoid most pain pills prior to the test.

Polyps and early tumors tend to lose a small amount of blood, even when they are quite small. Thus, this test can detect polyps while they are still small enough to be cured. Polyps grow at a fairly slow rate and it is only when they get to a certain size--an inch across--that they are likely to contain cancerous cells.

When you complete this test, you have screened for one of the most common cancers. It is also one of the most preventable and curable cancers when you help catch it at an early stage.

If the test is positive, you should discuss the results with your doctor. He will recommend the appropriate procedures to evaluate the finding, usually a look inside the colon with a fiberoptic scope to look for polyps or tumors. Biopsies will be done if necessary.

## VIEW FROM THE BENCH

### Alimony: The Devil's Ransom

Tongue-in-cheek, it can be said that for some conditions, the remedy is far worse than the disease. For some, seemingly pledged forever in matrimony, the only cure for what plagues them is divorce. To-

day, let's talk about maintenance--otherwise known by some as the devil's ransom.

Kentucky does not use the term alimony. "Maintenance" describes the financial support of a husband or wife by the other spouse following a dissolution of marriage or during the pendency of divorce proceedings. This is not the same as child support. Child support is intended for the benefit of the children of a marriage, not the spouse, and involves a completely separate body of law.

Laws which restrict an award of maintenance to women only are unconstitutional. Nevertheless, for purposes of discussion only, we will refer to the obligee spouse (the one receiving maintenance) as "her", and the obligor spouse (the one paying maintenance) as "him." The use of these terms in this manner is not intended to be sexist, but rather is intended to be reflective of the majority of maintenance claims in this immediate geographic area.

Kentucky law provides that a trial court may award maintenance only if it finds that the spouse seeking maintenance lacks sufficient property, including marital property apportioned to her, to provide for her reasonable needs and that the spouse is unable to support herself through appropriate employment. And while a perception exists that an award of maintenance is common following a divorce, reality is that permanent maintenance awards are rare. Our statutes are stringent. The burden of proof is upon the party seeking maintenance, and

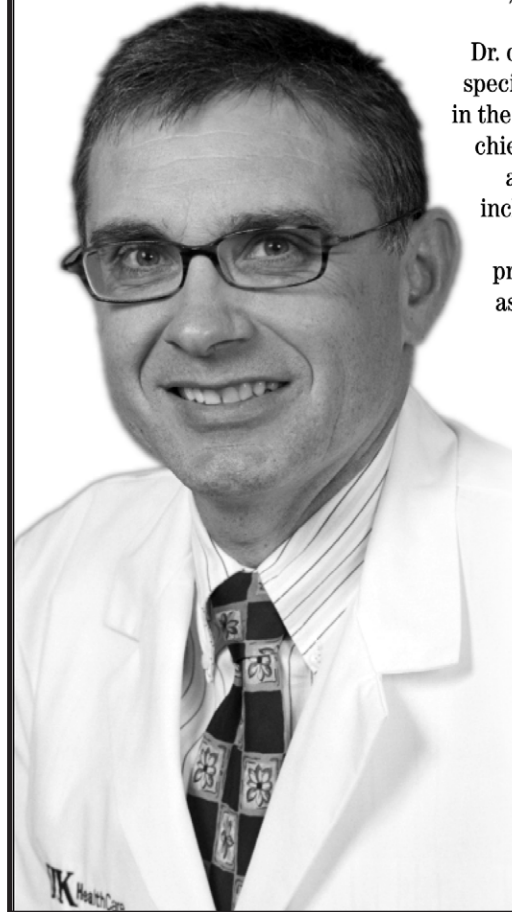

side to side. Occasionally, I could get a glimpse of the engine as traveled through a curve.

During the night, the George carried us through parts of the famous Shenandoah Valley and the Blue Ridge Mountains. We also passed through the 4,263-foot Blue Ridge Tunnel, which was one of the longest tunnels in the world (at that time). I could hear the moan of the whistle as we passed through small towns in West Virginia and Virginia. We only stopped at major cities on the way.

The next morning we visited the washrooms in order to freshen up before meeting Al and Eva. We took our seats next to the window to see the famous monuments in Washington. We passed by several, and both of us were thrilled to see them for the first time. The Conductor finally announced "Union Station." It was simply magnificent!

Union Station is considered to be an historic example of the finest architecture. At that time, the Station covered more ground than any other building in the United States and was the largest train station in the world. It was a city within a city. Even today, Union Station's marble floors echo with the footsteps of over 29 million people each year, making it the most visited site in all of Washington, D.C.

before I painted the rest of the house. I'm told that one of the older busybodies had to be taken to the hospital. But I'm off the point.

And the point is that appliance makers don't make stuff like they used to. I am absolutely convinced that if you purchase a new appliance without paying an extra hundred bucks for the extended warranty, they put a time bomb in it that causes it to break beyond repair two days after the factory warranty expires.

Everytime we've had one die beyond resuscitation on us, we've had to temporarily store stuff in the old Philco which, I will bet a hefty sum, was made before I was born.

Last night I caught three or four dozen crawlers in the drizzling rain and headed to the garage. The old fridge had been empty and unplugged all winter but the instant her plug hit the socket she commenced humming like she'd had nice, long, dreamless sleep.

I opened her door gingerly to make sure that it didn't fall off on my foot. I touched the aluminum around her freezer compartment and it was already getting cold. Oh my, isn't dependability is such a wonderful thing?

consequently, maintenance is awarded in only a small percentage of cases.

The amount and duration of maintenance is determined according to statutory provisions. Courts may only award maintenance in such amounts and for such periods of time as the court deems just, and after considering all relevant factors.

There are many relevant factors. Courts look to the independent financial resources of the party seeking maintenance, including property apportioned to her in the divorce, and her ability to meet her needs without maintenance. Courts will also consider the time necessary to acquire sufficient education or training to enable the party seeking maintenance to find appropriate employment, the duration of the marriage, and each party's age and physical condition.

The ability of the spouse from whom maintenance is sought to meet his needs while meeting those of the spouse seeking maintenance is also relevant. It would make little sense to destitute the obligor at the expense of the obligee.

The standard of living established during the marriage is also particularly relevant. Where man and wife lived an extravagant lifestyle during the marriage, it is less likely that the courts will require the obligee spouse to live at a standard far less than that to which she has

become accustomed. Justice Palmore, formerly of the Kentucky Supreme Court, noted that Kentucky's maintenance laws "recognizes that what might be ample for a scullery maid is not necessarily sufficient for one accustomed to the lifestyle of a duchess. . . ."

One other unusual factor deserves mention. Kentucky is a "no-fault" divorce state. A spouse desiring a divorce need not prove adultery, abandonment or any of the other reasons which used to be required. Under current law, a divorce is legally justified anytime that "irreconcilable differences" exist between spouses. Fault is also not relevant in determining whether an award of maintenance is proper, but may be considered in some limited cases to determine the amount of maintenance awarded.

Though maintenance is rarely granted, it is frequently mentioned in the context of divorces. Trial courts must weigh a variety of factors, and no two cases have the same result. But most any award of maintenance, despite its legal propriety, generates some criticism, sometimes because the award is perceived as too little by the obligee, or most often, as excessive from the obligor's point of view.

The obligor's perspective can best be illustrated by P. G. Woodenhouse's quip: "[j]udges, as a class, display . . . that reckless generosity that is found only in men who are giving away somebody else's cash." Ouch . . . that hurts.

then be applied to the chest. She usually put a generous amount of Soltice Chest Rub on first, unheated.

This sounded a lot more forgiving than my mom's and grandma's remedy, although they were very similar. Laura Cook's poultice was probably pretty tasty, as well, sautéed onions prepared in old-fashioned cow's butter. If she had only added a few fresh mushrooms and green peppers, getting sick would have almost been worth it. So, the onion poultice was her method of scorching an unsuspecting kid's chest.

As I've noted before, my mom and grandma lived next door to each other, which made a lot of aspects of daily life easy for us all. They weren't into poultices, but practiced other methods of cures for the cold and flu season.

I remember it so well. I was young, maybe not even school-age or possibly just a little past. It would be a cold, wintery night, snow falling, and north winds whipping around the house. My temperature would be one hundred and two or three, and I would be pretty sick with the flu. Mom would take me over to grandma's house so she would be on-hand to help "doctor" me. The first thing they'd do is put me in bed under at least three or four of those old-fashioned handmade quilts, and turn up the heat on top of that. It seemed that they thought enough heat would cure anything.

The next thing that they'd do is to get a jar of Vick's Chest Rub. They swore by Vick's whereas Stanley's mother preferred Soltice. Then they'd heat it on the stove in a big, red, Greer peach can...jar and all, that grandma kept for just such purposes. They'd fill it about half-full of water, add the jar, and they were set to go.

While this was heating, "the flannel" was hunted out. This wasn't any ordinary "flannel." It had a history. My grandpa was in World War I, and had fought all over Europe. The winters were cold and harsh on the front lines where he served. The government had issued each soldier a pair of Army-green, extra-heavy, pure-wool underwear, tops and bottoms. This was in 1917 and -18.

My grandpa was a collector, or I guess you could say, a "saver" of memorabilia, so he had brought his World War I uniform and all kinds of war paraphernalia home with him.

After the war, he married grandma in 1919, making her the inheritor of the underwear she used to "cure" generations of kids and grandkids with. She had been taught that pure wool was the best material for making "flannels." She had taken the underwear top and had cut out about a foot square from the top

chest and a foot square from the back, so she could have two nice "flannels" and kept all of the scraps, just in case. Then she had cut a hole in the top two corners of each, carefully darned the inner edges of the hole so they wouldn't ravel, and tied a string to each hole and corner. Thusly, the "flannel" could be tied around the neck of the sick family member that she was treating. It was kind of "one-size-fits-all." She liked wool for "flannels" also because it was noted to last a long time. Evidently it was true, as I was still wearing my grandpa's Army-green, government-issued underwear well into the 1960s that had been all over Europe.

After the famous "flannel" had been located, it was heated on the top rack of the stove oven, just short of being singed. Mom would keep an eye on the "flannel" while grandma applied the Vick's, which seemed almost boiling-hot by now. She'd cup her hand, and pour out a handful, and rub it into my chest. Sometimes my back and feet were included, depending on how "bad off" I was. Then just when I thought I couldn't stand any more, here would come mom with that scalding-hot, scratchy, well-traveled, wool "flannel" to put on my now almost-blistered chest. You talk about "adding insult to injury."

Kids today complain about a little occasional spanking. Spankings today don't even compare to an old-fashioned flu or pneumonia cure. By today's standards, the mothers of a generation or so back would be in jail for child abuse for their "medical cures" alone, much less the "whippin's" they dished out.

During the "greasing and flanneling" process, grandma would tell about how her mother did the same thing to her. Grandma got a hot brick put on her greased feet, as well, that had been heated in the embers of the fireplace. Thankfully, grandma didn't have a one...a brick, or a fireplace, either. The "feet-greasin'" served dual purposes, I suppose. It was not only a cure, but it deterred the children from running away. Just think of it. You're already sick, weak, can't breathe, tired, and too little to defend yourself. Then have all of this to happen. It was enough to make a kid want to run away, if you were able.

There were aspects of the "cure" that weren't too bad. Mom and grandma could make some pretty good chicken broth, and I could eat all of the Jell-o that I wanted.

My grandma also had a purple, pure-silk, thread that she would tie around your neck like a choker necklace. She said that the thread had to be pure silk for the best results. (It seemed that they had this "thing" going about purity.) It couldn't be taken off until you were one hundred percent well. I don't know the exact purpose of this, and she probably didn't either, as I'm sure it had been handed down for generations, and the purpose long-forgotten. Of course, it didn't have any medical properties in the least, and it probably had its roots in superstition.

Stanley got over his cold without the benefit of a poultice, a "greasin'" and "flanneling," a hot brick, or even a silk thread. Years ago, he'd sure have been a "goner." The next time I go to see Doctor Arvin, I'll have to see if he has any pure silk thread, and any Army-issue, pure-wool underwear for "flannels."

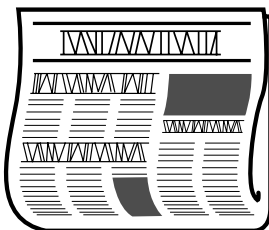

## Farm and Home News

#### Taking Soil Test

Recent increases in fertilizer prices have farmers concerned about managing the amounts of fertilizer applied to crops this year. Through soil testing, an estimate of the phosphorus and potassium available for plant growth as well as the lime needed to adjust pH can be calculated. University research on most crops has developed fertilizer recommendations based on the soil test results. Only Nitrogen is not included on the soil test. However research has developed recommendations for Kentucky crops.

When taking a soil test, keep the old adage in mind "Garbage in garbage out". The results of the test depend on the sample taken. Starting with depth, soil samples for hay and pasture fields should be down to 4 inches. For plowed fields, sample down as deep as you plow. The second important step is to randomly sample from many places in the field. A minimum of 20 places being sure to avoid old tobacco

patches, places where the fertilizer buggy turns and the ends of fields. When properly sampling a field, at least a quart of soil will be collected. Mix the soil and dry over night. When dry, mix again and bring in about 1 pint to the Extension Office. Samples are mailed to the University of Kentucky Soils Lab and cost \$5.25 for analysis.

# Agricultural News

## USDA announces re-enrolling and extension of CRP

Agriculture Secretary Mike Johanns has announced new results of the recent opportunity given to Conservation Reserve Program (CRP) participants to re-enroll or extend their contracts, which are set to expire between 2007 and 2010. An estimated 23.2 million acres out of 27.8 million acres of eligible CRP contracts are expected to be re-enrolled. An estimated 4.6 million acres in CRP contracts will exit CRP between 2007 and 2010. Of the 4.6 million acres, approximately 1.4 million acres are located in major corn producing states.

The 4.6 million-acre estimate includes all general sign-up expiring contracts that were not extended or re-enrolled under last year's offer. It does not include acres under expiring continuous sign-up contracts, which will be eligible to be re-enrolled during the final contract year.

Before approving re-enrolled or extended contracts, FSA must ensure that the required cover is maintained and that other contract provisions are met. In addition, participants must demonstrate show that they meet eligibility requirements for the new enrollment period. In the case of re-enrollments, updated rental rates will apply.

USDA does not plan to conduct a general sign-up for Fiscal Year 2007 or 2008. However, continuous sign-up of high-priority buffers, wetlands and other initiatives, as well as Conservation Reserve Enhancement Program, will continue. USDA encourages farmers and ranchers to consider these opportunities.

# Adopt-a-Highway Week is March 25th thru 31st

"Let's 'Spring Clean' the Bluegrass!" The Kentucky Transportation Cabinet announced today that the Adopt-a-Highway Spring Clean Week will be held March 25th - 31st.

More than 1,196 groups now participate in Kentucky's program, cleaning approximately 8,548 miles annually. Participating groups demonstrate the importance of a clean environment by spreading the word and setting the example that littering is unacceptable behavior. The Kentucky Transportation Cabinet began the Adopt-A-Highway Program in 1988.

"The Kentucky Transportation Cabinet appreciates the effort put forth by all Adopt-A-Highway groups in keeping our highways and communities litter-free," said Secretary Bill Nighbert. "The continual increase in group enrollment in the program highlights the importance that citizens place on maintaining and improving the scenic beauty of our state. Through their participation they are sending a message that littering is unacceptable in the Commonwealth of Kentucky."

The program increases public environmental awareness, reduces littering, expands tourism, creates a partnership be-

tween citizens, community and government, and establishes a sense of pride in our Bluegrass State. The Transportation Cabinet salutes each and every participant, and thanks them for their tireless efforts to educate others.

Each year, the Transportation Cabinet's highway workers spend approximately 200,000 hours removing litter from Kentucky's roadways, collecting over 96,000 bags of litter. The total yearly cost of litter removal averages \$4 - 5 million.

### GET INVOLVED!

How can you contribute to your community, make a difference, send a message and educate others, and have fun with friends and family all at the same time? Join Kentucky's Adopt-A-Highway Program. By taking personal responsibility for one of your area roadways, you will be setting an example for your community.

The environment is everyone's responsibility. Adopt-A-Highway provides the opportunity to be a part of the solution. As a volunteer, you will save thousands in taxpayer dollars and demonstrate to others the importance of a clean environment.

Any permanently estab-

lished business, association, community or public organization, or government entity can adopt a stretch of highway. A wide range of groups throughout Kentucky now participate, including homemaker clubs, Boy Scout and Girl Scout troops, high school organizations, Rotary clubs, veterans, college fraternities and sororities, sports teams and Kiwanis clubs. (Sorry, those entities established for the sole purpose of pursuing legislative or regulatory changes are not eligible.)

Two-mile sections of highway are adopted for a period of two years. Groups sign a contract with the Transportation Cabinet, which recognizes the need and desirability of a clean environment and permits the group to contribute toward that effort. Volunteer groups may renew the contract at the end of the two years.

Adopt-A-Highway Coordinators can explain the fundamentals of the program to your group, work with group members in locating an available highway, and notify you of news and upcoming events.

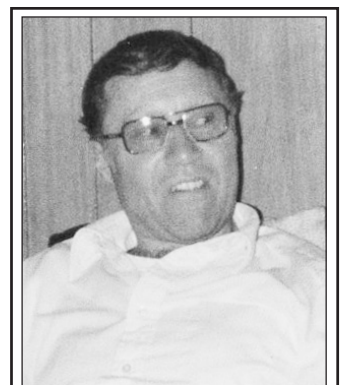

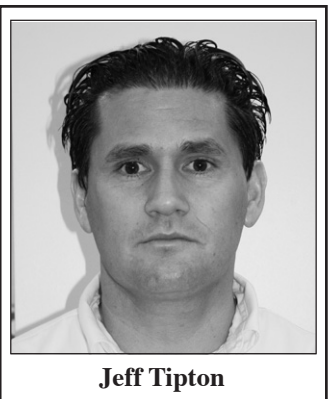


# Tiger Pause

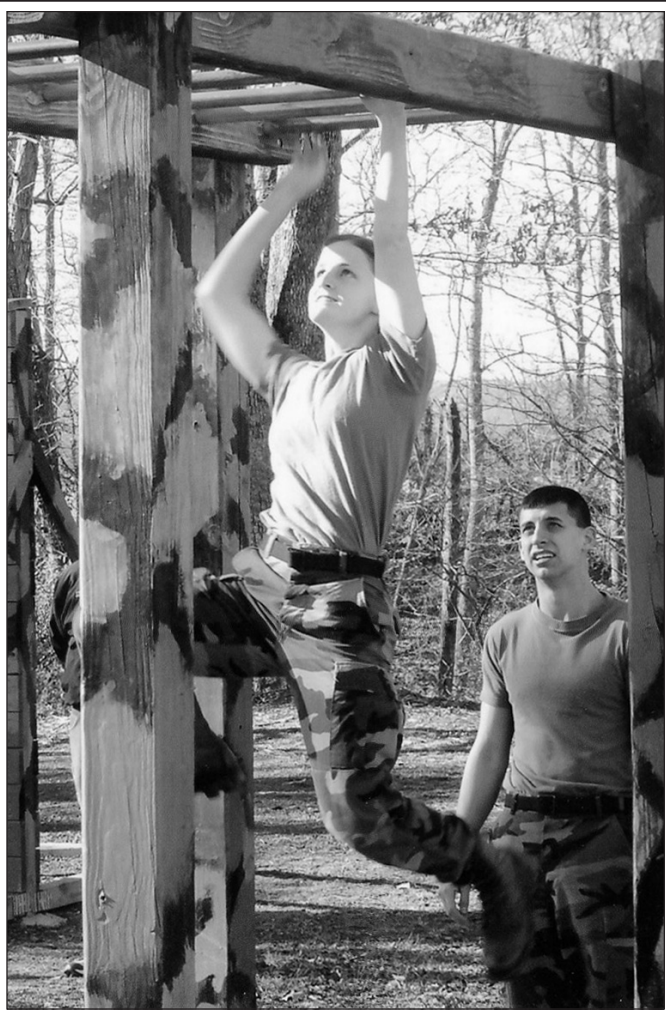

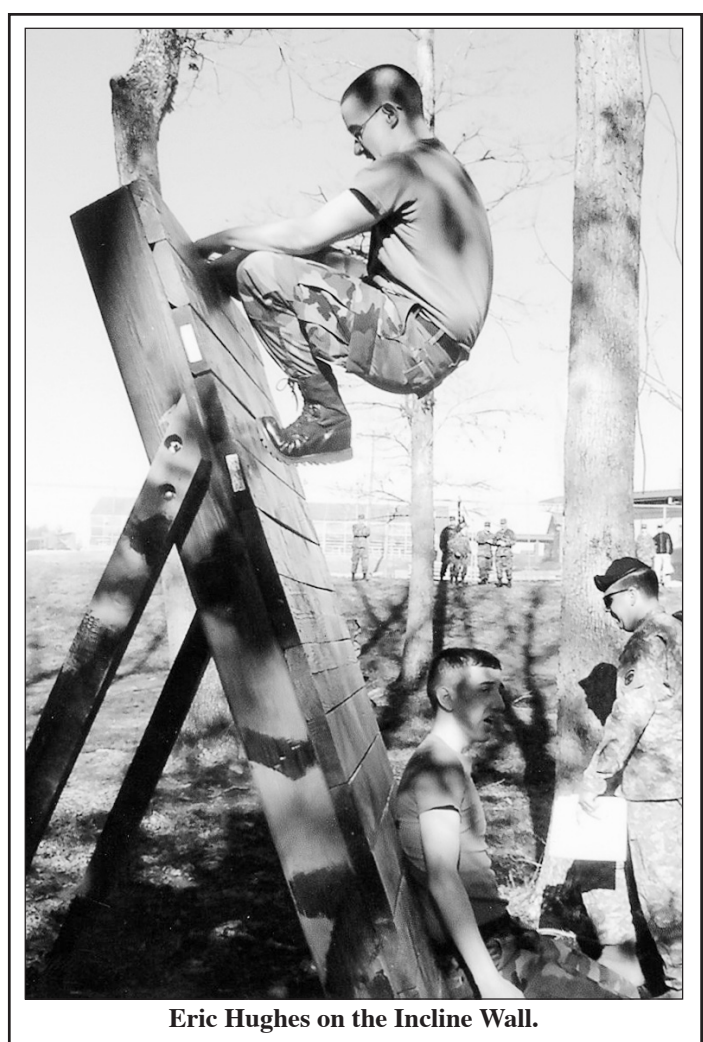

eral probation violation and carried no bond. Miracle is presently on federal probation.

Rockcastle County Attorney Billy Reynolds said the U.S. Attorney had advocated issuing a no bond warrant for Miracle, based on his past history as a career offender and his recent conduct.

Reynolds said that, besides the counterfeit bills, information concerning other illegal activities had also been divulged to him (Reynolds).

Reynolds, in a statement given to the Signal, said, "federal court penalties are much harsher for crimes Miracle has committed and since he will be classified as a career offender, I honored the federal court warrant by recommending to Judge Wood that charges in Rockcastle District Court be dismissed with leave on condition that I can bring them back at any time."

Reynolds went on to say that if there was a glitch in the federal court charges, he wanted the ability to retain jurisdiction over Miracle.

Reynolds said the investigation by the Secret Service, DEA, KSP, Rockcastle Sheriff's office and Mt. Vernon Police Department is continuing and more arrests are imminent.

Reynolds also cautioned merchants to carefully examine \$20 and \$100 bills.

Her running mate is State Representative Jeff Hoover, who represents Russell and Clinton Counties and a portion of Pulaski in the state house. He is currently in his sixth term and is the House Minority Leader, a position he had held since 2001.

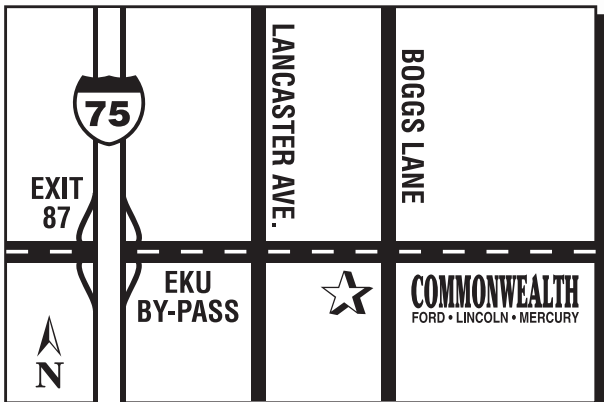

## Funding

Kentucky's congressional leaders' continued support of the CDBG program has made the funding available nationally and within the commonwealth. The U.S. Department of Housing and Urban Development makes these funds available through the Governor's Office for Local Development (GOLD), which administers the CDBG Small Cities program in Kentucky.

The Governor also had good news for supporters and caretakers of Quail Community Park.

Governor Fletcher presented a ceremonial check for \$110,000 in state grant funds to local officials for renovations to the Park. The Governor announced that \$60,000 in Local Government Economic Development Funds (LGEDF) will be used to construct an enclosed building on the grounds and \$50,000 in Land Water Conservation Funds (LWCF) will be used for several park improvement projects. Those improvements include restrooms, playground equipment, fencing, lighting and a septic system upgrade.

"The park improvements are a win-win for everyone," said longtime State Rep. Danny Ford. "The Quail Community Park is a great place for families to go to enjoy the outdoors and each other. The improvements will only enable it to better serve our community."

Rockcastle Judge-Executive Buzz Carloftis said a meeting between himself, third district magistrate Billy McKinney and Quail homemakers was being planned to decide what type of building to construct on the site.

The LWCF is a federal grant program that provides funds to local governments to protect important natural areas and develop outdoor recreation facilities such as campgrounds, picnic areas, sports and play fields, swimming, boating and fishing facilities, trails and passive parks. The LWCF is funded by the National Park Service.

GOLD is the agency responsible for administering LGEDF and LWCF grants. The county will be responsible for kicking in an additional 25% on the project in in-kind contributions, such as labor and use of equipment.

Governor Fletcher also presented a ceremonial check representing \$90,000 in LGEDF to local officials for projects at several local fire departments. The project descriptions and grant allotments are:

- \$15,000 to the Livingston Volunteer Fire Department for building renovations.
- \$15,000 to the Brodhead VFD for a building remodeling project.

- \$15,000 to the Western Rockcastle Fire Department to rebuild a pumper truck.
- \$15,000 to Brindle-Ridge VFD to purchase equipment.
- \$30,000 total to the Mount Vernon VFD and Rescue Squad to help with costs associated with constructing a new building, in partnership with the Chemical Stockpile Emergency Preparedness Program, (CSEPP), which will accommodate their vehicles and the city's emergency vehicles at the new site on Old U.S. 25.

Checks totaling nearly \$80,000 for installation of guardrails along KY 1326, KY 1004, KY 70 and a stretch of Old Gauley Road were also presented.

"Highway safety is a top priority in my administration, and I am committed to protecting the lives of all Kentuckians," Fletcher said. "This funding has allowed for the purchase of new guardrails along stretches of these highways. We appreciate the willingness of the Rockcastle County Fiscal Court to take the lead on this effort."

The Transportation Cabinet will install new guardrails on Mt. Vernon-Brodhead Road, which is KY 1386. The project will begin from .0564 mile east of Purr Rigsby Road extending easterly to 0.488 mile west of Little Creek Culvert. The estimated cost of the project is \$37,430.

Work crews will soon install new guardrail on KY 1004 along mile post 3.566 to 3.665. This project starts from the east end of Roundstone Creek Bridge extending to Briarfield Cemetery Road for a length of approximately 0.1 miles. The estimated cost of the project is \$14,625.

The third guardrail project will begin on Brodhead-Eubank Road, which is KY 70. This project will begin approximately 150 feet east of Brushy Creek Bridge extending easterly 5.067 miles. Estimated cost of the project is \$10,902.

The last project will take place on a stretch of Old Gauley Road near the KY 1955 intersection for approximately 0.105 miles. Estimated cost of the project is \$13,688.

In sum, the guardrail projects are a \$76,645 investment that is being paid for by state construction funds.

"These projects are prime examples of the Governor's efforts to work cooperatively with local leaders to build stronger communities across the state," concluded Transportation Cabinet Secretary Bill Nighbert. "We are enhancing the quality of life for people across the state by improving safety and paving the way toward improved economic opportunities."

During the Governor's remarks to the Chamber, he said 73 fewer Kentuckians died on Kentucky highways in 2006 than in 2005 and, so far in 2007, 10 fewer people have died than had this time in 2006.

Secretary's time frame estimate was probably right on track."

"There is just so much paper work, so many different permits to obtain, it takes time," he said.

Cox said that all right-of-ways between Crab Orchard and Brodhead had been purchased, for a total price of \$7.3 million, and that once the bids are let in January, construction would likely begin as soon as weather permits in 2008.

The cost of the project between Crab Orchard and Brodhead is \$23.5 million.

The cost of the project between Brodhead and Hwy. 461 is almost \$25 million and the money for right of way purchases is in place.

Cox said no time line on the final phase of the new Hwy. 150 was currently in place.

"When the Governor took office he made it clear we were going to keep promises that were made by other administrations, especially in the Transportation Cabinet. Completion of Hwy. 150 had languished long enough," he said.

State Representative Danny Ford of Mt. Vernon, who represents Rockcastle and Lincoln Counties in the state legislature and who has worked for many years on the construction of the new road, was pleased.

"It is a long time coming. Let's just keep our fingers crossed and keep asking for help with the final phase between Brodhead and Mt. Vernon," Ford said.

also know there has to be things for families to do when they visit the valley," he said.

"Our tourism cabinet is ready to help in any way we can - tourism was up 16.1 percent in Kentucky last year, but I think we can do better and the success of Renfro Valley is not only important to Rockcastle County, but the entire area," he said.

"The human capital is here, we just have to work together to use its full potential," he noted.

The Governor said the state was now ranked 7th nationally in cost effectiveness when before his administration took office the state was ranked near the bottom.

"When we came in they were kicking patients out of nursing homes and letting prisoners out of jail, because the state was broke. That is not the case now," he said.

As for the loss of jobs in the Rockcastle Industrial Park, the Governor called it tragic but said that, with proper training in other areas, jobs could be brought back to the county.

The Governor said Kentucky would always have difficulty competing with countries south of the border because of the low cost of doing business in those counties, especially in manufacturing and the state is going to have to take a new approach and train our people in other areas.

Fletcher told the group that more Kentuckians are getting up and going to work now than ever before, saying his administration has created 129,000 new jobs.

The fighter pilot, doctor, engineer and lay minister closed by accepting a petition from Pongo resident Bob Fields which had hundreds of signatures requesting help with funding for a new fire department in the area.

Pongo residents are in the process of organizing their own volunteer fire department.

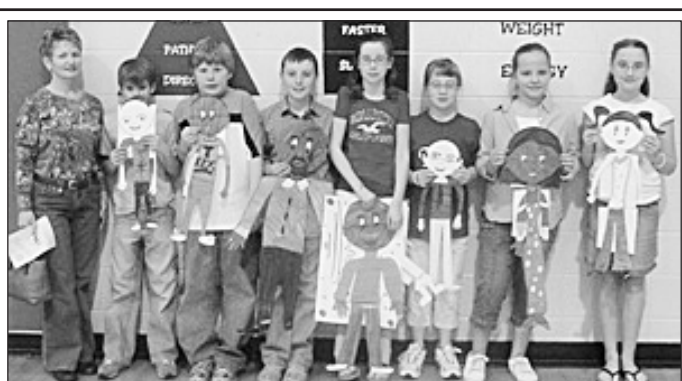

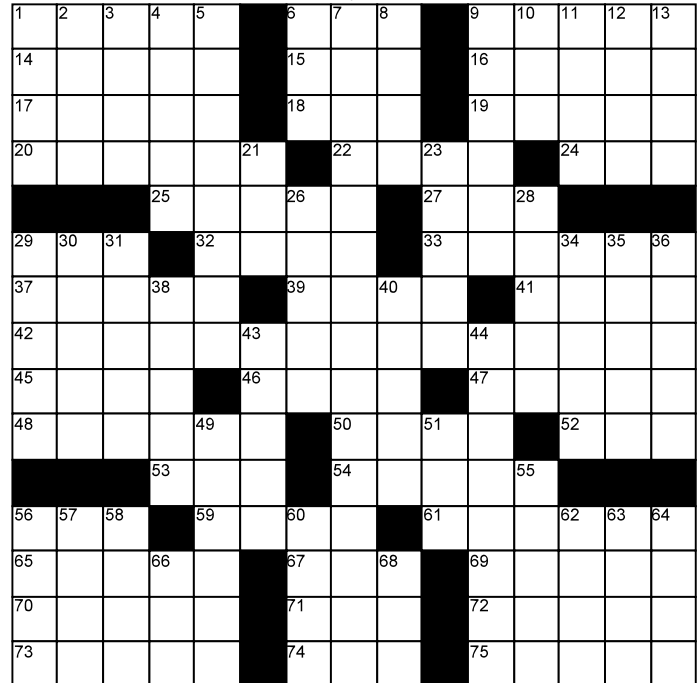


