Fiscal court votes Friday to pay tax bill for tourism commission

At a called meeting of the Rockcastle Fiscal Court last Friday, the court voted to pay a \$5,800 tax bill for the Rockcastle County Tourism Commission.

The action came at the request of Susan Laws, Director of the commission and Jerry Pensol, a member of the board.

However, late Monday, Pensol reported to the Signal that the commission had just received notification from the IRS that the bill had been waived.

The bill involved an information form that should have been filed with the Internal Revenue Service in 2004 for the non-profit corporation and "fell through the cracks." The Tourism Commission had asked for the waiver and had enlisted the help of Congressman Harold Rogers' office but had not heard back from their requests until

During the discussion, Laws and Pensol enumerated for the court the financial woes of the tourism commission, saying that failing revenues from the Bingo Parlor, which once amounted to \$50,000 a year and was now down to about \$8,000.

accounted for a lot of the problem. Laws said that it was very expensive to advertise with flyers, brochures and information packets and at travel shows, for which the commission splits the expense with Renfro Valley and the Kentucky Music Hall of Fame. Laws pointed out that it cost \$9,000 last year just to advertise in the state's official travel guide and added that two employees have been cut in an effort to pare expenses. Laws also told the court that there was a huge expense involved in maintaining the four Bitter-

Laws and Pensol also proposed to the court that they purchase a bench for the "Stroll of Fame." Laws said that several Renfro Valley celebrities have already paid for a bench, at a cost of \$600, along with other businesses and civic organizations, including WRVK, the City of Mt. Vernon and the

Two adults, juvenile charged in recent road sign vandalism

Two Rockcastle men and one juvenile have been charged with felonies in connection with the theft of road signs and posts on Lilac Circle in the Chestnut Ridge area on March 23rd.

Ronnie W. Vanzant, 27, of Rt. 5, Mt. Vernon and Clint W. Daugherty, 20, of Orlando were both charged with theft by unlawful taking over \$300 and have been released on \$5,000/ 10% bond.

According to Rockcastle County Attorney Bill Reynolds, nine signs were recovered, at the time of the arrests, by State Trooper Tom Atkin and Mt. Vernon City Policeman Brian Carter, who were tipped to the vandalism by private citizens. The signs were reportedly taken from both county and city road-

"I'm very grateful to these private citizens for reporting this," Reynolds said. "They could very well have saved a life if an emergency vehicle couldn't find someone in need because of a missing road sign."

Both men will be arraigned on April 16th.

The levying of a restaurant tax, to benefit tourism, was brought up. City governments are the only ones empowered to levy a restaurant tax and, when proposed by the city of Mt. Vernon some years ago, the tax met with opposition from restaurant owners inside the city limits. However, Pensol said that a 3% restaurant tax would furnish the tourism commission with between \$225,000 and \$250,000 a year in revenue, according to state estimates.



Clifford Collins has been busy in the past week leveling the lot at the old county garage, where the new Mt. Vernon Volunteer Fire Department will call home. The city will be sharing a new six bay, 100x70 square foot building with the county, in which all three of the city's fire trucks and rescue vehicle, along with the CSEPP program will be housed. The new building is currently being bid. The current building below will be used for training and office space, and other activities sponsored by the fire department. Fire department public affairs officer Steve Griffin said the building on the site will have to be rewired and a new heating and cooling system will have to be put in. That expense will be the city's. Emergency traffic lights will be placed at both ends of Old U.S. 25, where the new department is located, to alert motorists when the emergency vehicles are coming. Firefighters will do most of the renovation of the current building themselves at no cost to the city.

Only ten of Western Rockcastle Water Association's 4,174 member customers turned out for Wednesday's annual meeting, where board of directors for the coming year were elected.

Julie Pigg and Albert "Brownie" Martin were elected to three year terms on the board and Raymond Brown was elected to a two year term. All three were elected by acclima-

The three join Eddie Hamm and James Purcell on the five member board. Purcell's term expires in 2008 and Hamm's in

Western Water manager Paula DeBorde said she had received 800 proxy votes, which had been verified and all of them were votes for the three who were elected.

Western's attorney Jerry Cox chaired the annual meeting and told the small crowd that he knew many rumors were circu-

The Kentucky Public Service Commission has granted an immediate rate increase to East Kentucky Power Cooperative saying the increase is needed to maintain the utility's financial and operational viabil-

Since suffering an unplanned outage in 2004 at one of its electrical generating facilities, "East Kentucky's financial condition has steadily and consistently deteriorated and shows no immediate sings of improvement," a news release from the PSC said.

discrepancies, bills were paid and money was in the bank. The long-time attorney for Western said the association had indebtedness to Rural Water for the expansion and upgrade of

lines and payments on those debts were current. Cox added that the most recent annual audit would be completed in two to three weeks.

"We are simply working to expand lines, reading meters and answering complaints," Cox said. The local attorney also noted that the only function of an annual meeting is to elect board members.

Member Chris Craig said he had heard a lot of complaints from customers but added that unless he was involved in something and knew all of the facts he did not make a judgement. Craig said he would like to be more involved and said he thought many of the people he had talked with felt uncomfortable about approaching the board with their complaints.

"I just think they want to know they have a place to go and gripe and complain if they want to," he said.

Cox told Craig that Western's monthly board meeting was the second Tuesday of each month at 1 p.m. at Western's office on Hwy. 150 in Mt. Vernon and was open to

Member Doug Brock asked for a new copy of the bylaws and a financial statement.

Cox told Brock the same bylaws, which were adopted in the 70's, were still in affect, with the exception of several amendments and that he would get Brock a copy of them.

Cox said he would also get Brock a copy of the association's completed audit.

DeBorde said Craig Butler, a CPA from Danville, has audited Western's books for several years and each year the audit is made available at Western's office.

"Members can stop by and get a copy anytime," DeBorde

Brock also said he too had received many complaints about Western's service and about people not reading meters. He also said office personnel at Western should be more careful about keying in numbers they receive from customers. "My mom got a bill for \$135, when it should have been about \$30 but, of course, you all straightened it out, but it upset her for a little while. They should just be more careful," he

Cox said the association was moving toward radio read meters, which will be read by Western technicians.

DeBorde said plans are for all 4,174 meters to be replaced.

"Our people will be able to drive by a meter and use a device to send the readings to a satellite, which will then send

Rockcastle Memories

Last Saturday the redbud blooms suddenly appeared on Furnace Mountain, and I was reminded that the earth was about to come alive again. We had lots of redbud trees on our small farm in Rockcastle County when I was young and my grandfather (Pop) usually had his garden plowed by the time the blossoms were visible.

Soon the dogwood trees will join the redbuds, and the entire mountain will be covered with white and pink flowered trees. I absolutely love spring and fall colors. A few days ago, I traveled up to my woods and drove to the back of the 21 acres to sit quietly watching and listening as spring unfolded in front of my eyes. A few yards in front of my perch, I could see yellow jonquils swaying gently in the mountain breeze. They are left over from an old home site.

Birds of many varieties sang to me as I watched their flight in and out of the trees. From my vantage point, several trees were showing their pastel colored buds waiting to spring forth forming the leaves of the new season. Robins, cardinals, chickadees and wrens ignored me as they seemed to absorb the feel of spring in the air.

I walked down a path that leads to the limestone cliff on the back of our property looking for signs of life in the woods. About 50 yards from the cliff, there is a large white oak tree that is probably 200 years old. Because of its location and massive size, I always stop and gaze at the tree thinking about what it has witnessed during its lifetime. Is it possible that Daniel Boone stood under its shade while walking through the woods? Did Indians gather under its branches to build a fire and share a meal? Oh, how I wish that massive tree could talk!

Along my way I also stood along a small pond and checked out the tracks of animals that have recently stopped for a cool drink. This spot seems to be a gathering place for lots of fauna in my woods. The largest tracks were from deer that often visit the pond. Approximately three other animal tracks were also visible (probably raccoon-possum-

Farther down the path I watched grey squirrels scampering through the trees. Occasionally they would "talk" to each other and climb out of sight. They reminded me of the woods behind our home in Rockcastle County, where Pop often took me to hunt for squirrels. When we hunted together, I knew we were going to have squirrel for dinner because his philosophy was to only kill what you were going to eat.

On the back of our woods is an area that most likely is the oldest part of the forest. The trees are basically oak, walnut, poplar, and hickory. Not much undergrowth is found in this area. It is evident that wild turkeys have been scratching though the leaves looking for morsels of food to sustain them until new life springs forth. At another time, I saw 13 turkeys

I love spending time in the woods witnessing the Lord's handiwork. It is exciting to watch the earth renew itself in the spring as living things ready themselves for the growing season to come. I am thankful that I have this area to visit when ever I need a dose of new life and the hope that it pro-

The birth of a child, divorce, or transfer of property, may defeat the will's original intent. Add this to the perception that the preparation of a will is complicated and expensive, and you begin to understand why so few have a will.

It is possible to prepare and properly execute a valid will without an attorney's assistance, but inadvisable to do so. Though the requirements of a valid will are few, those requirements must be met, and the fail-

Letting Your Baby Learn to Sleep

It may be hard to get some infants to go to sleep when you want them to. They cry and squirm and eventually get the mother or father to come back and rock them to sleep.

This can occur every one to two hours during the night for some infants. How do you train a baby to go to sleep?

Learning to comfort himself and fall asleep is one of the big lessons a small infant has to learn. Yes, it is a learned pro-

Your child needs to be given time to learn this skill. Parents should let their infant cry for a period of time before checking on him and comforting him. The child must even-

tually learn to make himself comfortable to prepare for sleep. Of course, if it is time for a feeding or he needs a diaper change, there is no reason to delay.

One of the important reasons for learning this skill well is that the sleep cycle of an infant only lasts an hour, so he will arouse every 60 minutes. If he is unable to comfort himself and go back to sleep, he will cry until a parent comes to rock him back to sleep.

Parents should not feel guilty over rocking their baby to sleep, but by returning too soon, they do not allow an infant the time needed to learn to comfort himself for sleep. Returning too soon can train the infant to cry until he gets the parents' atten-

After 20-30 minutes of crying, however, it is wise to check on the baby, change diapers if necessary, try feeding the baby, and if everything is well, settle him down and put him back in the crib to go to sleep.





nation as a teaching tool. If you don't recognize the name, that's because Ms. Marshall was publicly known as Anna Nicole Smith. Anna Nicole's will comprises 16 pages, far more than the wills commonly admitted to probate in Kentucky, yet still lacks critical information regarding her intent.

Like many other wills, Anna Nicole's will had not been updated. Executed in 2001, the will contains a specific provision reflecting that she only had one child, Daniel, now deceased, and that she "intentionally omitted to provide for" other heirs, including children "hereafter born or adopted . . .

." Given that a second child, Daniellynn, was born to Anna Nicole only a few weeks prior to her death, her will may have little effect.

Anna Nicole amassed millions during her brief career, and had a well-publicized stake in billionaire J. Howard Marshall's estate. Despite an estate far larger than most of us can dream, Anna Nicole's sole surviving daughter, baby Daniellynn, may get only a portion of what she would have received had Anna Nicole had the foresight to revise her will. This will have to be determined in the courts.

The requirements for a will in Kentucky are fairly simple. You must be 18 years old to execute a will, and it must be written, not oral. If not written entirely in your own handwriting, the will must be acknowledged in the presence of at least two credible witnesses, who must also sign the will in your presence and the presence of each other. The will can make specific gifts, or generally divide your property among those you desire. And like Anna Nicole's,

certain heirs, certain to some legal exceptions. Your will can also nominate the person to be appointed as guardian for your children, and in most cases, courts will honor your expressed wishes. For example, Anna Nicole's will nominated Howard Stern as Daniels's guardian.

A will may also designate what law is to be applied. Anna Nicole specified that the will was to be construed according to California law. This can be important, given variations in state law and taxes, and for people who relocate from one state to another.

We all assume (or hope) that

ous life. The reality is that for some, an untimely death--such as Anna Nicole's--makes orderly disposition of an estate difficult. That difficulty increases the burden on surviving family and friends.

Creating a will can be uncomfortable. Thinking of our inevitable demise is rarely pleasant. But you owe it to your loved ones to ensure your death does not create any unnecessary stress in at already difficult time. And you owe it to your self to ensure your final wishes are carried out. Consult with an attorney regarding your needs. Preferably, sooner rather than later

Kentucky Caregiver Support Program

Grandparents in Kentucky who are providing primary care for a grandchild under the age of 18 may be eligible for assistance through the Kentucky Caregiver Support Program. Grandparents of any age who meet financial guidelines and are not receiving Kinship Care can receive financial assistance or supportive services that may include: information about services that are available, assistance in gaining access to services, individual counseling, support group and caregiver training.

Financial assistance could be used to buy clothing, respite assistance, educational supplies or assistance, required legal services, medical and dental services and other expenses as authorized by the Cabinet for Health and Family Services.

To qualify, grandparents must be related by blood, through marriage or adoption and must be the primary caregiver of the child. The child's parent may not live in the home.

The Kentucky Caregiver Support Program is a state-funded program and is one of the services offered through Kentucky's Department of Aging and Independent Living. It is administered by the regional Area Agencies on Aging. During the month of April, the Cumberland Valley Area Agency on Aging will be taking applications for the program at a site within your county. 

The first "class" of GDL drivers to take the wheel

April 1st was much more than April Fools' Day in Kentucky this year. On April 1, 2007 the first "class" of teenage drivers in Kentucky, who are subject to the terms of the state's new Graduated Driver's License Law (GDL), will begin to enter the Intermediate License Phase.

If a teenager's driving permit was issued on or after October 1, 2006, that teen should check the date when he or she will be eligible to take the driving skills test required for an intermediate license. To check on their eligibility teen drivers visit https:// eligibility.gdl.kytc.ky.gov

Teen drivers must also visit the same web site in order to gain access to the Graduated Driver's License Verification Letter, which must be presented to the Kentucky State Police License Examiner in order to be permitted to take the skills test.

The goal of the GDL, which became effective October 1st, is to curb the number of crashes involving teen drivers, especially the high number of deadly crashes including teenagers.

Kentucky has had one of the highest teen crash rates in the nation. Teenage drivers account for only 6% of the state's driving population, yet they have been involved in about 18 percent of fatal crashes in Kentucky.

"The six month intermediate period mandated by Kentucky's GDL allows more time to expose young drivers to progressively more difficult driving situations," said Transportation Cabinet Secretary Bill Nighbert. "Studies from other states have shown us that after passing a GDL those states witnessed as much as a 25% reduction in the teen crash rate. We're striving for the same kind of results here in Kentucky."

Under the provisions of the law, after a violation-free six month permit period, teens must maintain a clean driving record for another six months during the Intermediate Phase. Afterwards the teen drivers will be eligible to obtain a Full Unrestricted Driver's License.

"If a teenager obtained a permit on or after October 1, 2006, we want to make sure that young person and the parents are aware that the time has arrived to take the next big step,' said Commissioner of Vehicle Regulation, Roy Mundy. "Our GDL web site not only allows teens to check on the dates when they will be eligible to take a driving test, it provides everything they will need to prepare for that significant milestone. April 1st is a very big day for teens all across Kentucky.'

To help teens successfully navigate the entire process of acquiring their permits and licenses the Kentucky Transportation Cabinet (KYTC) GDL website guides young drivers every step of the way toward the goal of becoming a fully licensed driver.

The web site http:// gdl.kytc.ky.gov includes various teaching tools, resources and related links, all designed to fully explain the provisions of Kentucky's GDL and promote safe driving habits for teenagers.

"April 1st marks a very important milestone for highway safety in Kentucky," concluded Secretary Nighbert.




JROTC competes at North Harden







In a single day more than 1,000 adults and children received services from domestic violence shelters in Kentucky. The research was done by the National Network to End Domestic Violence and Harvard University researchers.

one twenty-four hour period, from 8:00 a.m. on November 2, 2006 to 7:59 a.m. on November 3 and designated it Domestic Violence Counts Day. The survey was also completed nationwide by more than 1200 domestic violence agencies. In Kentucky all fifteen of the domestic violence shelters participated, including Bethany House Abuse Shelter (Somerset) and Family Life Abuse Center (Mt. Vernon 1-800-755-5348).

During this twenty-four hour period in Kentucky, 375 adults and children found refuge in emergency domestic violence shelters. More than 85 adults and children were living in transitional housing programs designed specifically for domestic violence survivors. Almost 600 adults and children sought non-residential advocacy and services such as individual counseling, legal advocacy and children's support groups.

Although there are a wide variety of services offered by the fifteen Kentucky shelters, there were still 81 requests for services that went unmet on November 2-3 because of a lack of resources. Fifty-eight of these were requests for emergency shelter. If one shelter is full, another shelter will step in to provide refuge for the victim and children. This does mean traveling to a location farther from home and sometimes

victim. During this same twentyfour hour period 323 hotline calls were answered at Kentucky shelters, or more than 13 calls every hour. Hotlines are answered by trained domestic violence advocates who provide information and support to victims of violence.

Local domestic violence programs teach classes in schools and provide training in the workplace and in the broader community. On November 2, more than 380 people received training through one of the local shelters.

Most of the work is done by shelters that employ only a small paid staff. Approximately 62% of Kentucky's shelters have a staff of 20 or less, including Bethany House Abuse Shelter. Almost the same percentage (62%) of Kentucky shelters will be found in primarily rural ar-

On Domestic Violence Counts Day staff members from local shelters had the following comments: "Today I had a client that had a weapon pulled on her when I was talking to her on the phone so she had to hang up. When I called back, all phones had been disconnected."

An advocate working in a rural shelter said, "Transportation issues for our victims of domestic abuse who are living in the rural areas of a rural state make for a challenge."

An advocate from an urban area had this to say, "The complexity of the issues is very diverse – the lives we touch on a daily basis. How does one capture the joy of a woman finding a job? How does one capture in one day the numerous systems we interact with, to advocate, to seek change? And how we do that today is different than how it will look tomorrow."

The domestic violence shelters of Kentucky stand ready to help victims and their children -- on November 2, 2006 and any other day of the year.

It has come to my attention that illegal dumpster use is a growing problem in Rockcastle County. When a business or apartment complex, or even a household, pays for the use of a dumpster, then that business or homeowner, or the tenant in that particular apartment complex, are the only ones allowed to use that dumpster. Rockcastle County Ordinance 90-3 Section 8 states: It


shall be unlawful for any person to deposit solid waste in any solid waste container other than his own, without the written consent of the owner of such container and/ or with the intent of avoiding payment of the service charge hereinafter provided for solid waste collection and disposal.

This does **not** mean that a resident of an apartment complex can give a nonresident of said apartment complex permission to use their dumpster!

Rockcastle County Ordinance 90-3 Section 11 states: Any person violating any of the provisions of this ordinance, or any lawful rules or regulations promulgated pursuant thereto, upon conviction shall be punished by a fine of not less than twenty-five (\$25) dollar, nor more than five hundred (\$500) dollar. Violators of this ordinance may be issued a citation by the Solid Waste Coordinator.

Using a dumpster illegally can be considered theft of services. Any person that is caught illegally using a dumpster may also be taken to small claims court by the persons or business entity that is paying for the dumpster

Kiwanis Club, which paid for a bench in honor of Old Joe Clark. The court approved the \$600 expense.

However, the court split 50-50 over a bill presented by Coroner Bill Dowell. The \$2,126 bill was for nine months of expenses for Dowell's office and included \$1,350 for transporting bodies to the medical examiners office (9 trips at \$150 each), his cell phone and body bags. Some of the magistrates questioned the trips to the medical examiners' office, saying they felt that should be covered by the \$500 monthly salary of the coroner or from the \$300 monthly expense account. Magistrate William Denny, who voted against the motion, along Magistrates Bill McKinney and Ralph Allen, said his vote was "nothing against anybody it's just our job to keep an eye on expenses."

A second motion, by Magistrate John Holbrook and seconded by Denny, to pay all of the bill except the part for transporting bodies carried unanimously.

However, Wednesday, Carloftis forwarded a copy of KRS 72.435 which deals with the cost of transporting or exhuming a body by the coroner.

According to the statute, "In the event it is necessary for the coroner to order a body to be transported or exhumed, payment shall be made by the fiscal court ... upon certification by the coroner that the services were rendered."

Carloftis said he hoped this would clear up the matter for the magistrates who "were only doing their job by questioning expenses they did not feel the county owed."

In other business, the court postponed action on a proposal by the City of Livingston Fire Department to finance a 1996 pumper/tanker fire truck for the department. The fire department submitted two options to the court, one that would donate the city's 1972 pumper and 1968 tanker, both in working order, to the group working on establishing a fire station at Pongo, and the other that the two older vehicles be traded in on the new 1996 model. Without the trade-ins, the price for the 96 would be \$69,000 and with the trade-ins, the cost would be \$63,000.

In their proposal, the fire department asked the county to pay half of the monthly payment for the newer truck. Carloftis presented the court with financing information that he had obtained from the Kentucky Association of Counties Leasing Trust. The figures from KACO showed an interest rate of 4.75% variable rate, for both 5 years and 10 years repayment, and a 4.30% estimated fixed interest rate for a repayment of 5 years and 4.37% for a repayment over 10 years. The payment on \$70,000 for 10 years, with the variable rate, would be \$733.93 a month and \$721.09 with the 4.37% fixed rate for the same period.

Carloftis gave the court the figures and action was delayed until the court's regular meeting April 10th.

The court did approve the gift of a fire truck to the group at Pongo, by a Northern Kentucky fire department. The county will have to insure the vehicle and house it and there will have to be a county employee involved in transporting the vehicle from Northern Kentucky.

Concerning the formation of the Pongo fire station, Magistrate Bill McKinney said that members of the community were undergoing training sessions "as many as three nights a week." McKinney added, "I feel they're (the Pongo group) going to make it because they're committed and working hard."

The main reason for calling the meeting was for the court to look over the jailer's preliminary budget. Jailer James Miller's 2007-08 budget shows total receipts of \$858,400, mainly from housing state inmates (\$687,003) and the jail's bed allotment, also from the state, of \$75,679.

state, of \$75,679.

The budget shows expenditures of \$460,950 for jail personnel, including Miller's \$71,118 salary; \$198,150 for operating expenses and

\$110,500 for debt service. HB 187, which would have given much-needed financial help to jails across the state, failed to get to the floor for a vote in the recent legislative session. Miller said he had spoken to the governor recently and that Fletcher had promised help, to what extent or when Miller didn't know.

The court also voted to sell at public auction, on the courthouse steps, five used vehicles from the Sheriff's Department.

They also discussed, but did not take action, on purchasing one or two tractor/mowers for the road department. Magistrate Ralph Allen was particularly interested in this matter since he reported that "I got my district mowed two days before school started last year." According to Carloftis, there are 1,000 miles of right-of way to be mowed in the county (both sides of the 500 miles of county roads) and mowing is usually done in tandem. "We can't send one man out by himself," Carloftis said.

Magistrate William Denny said he felt the county should just "get two more mowers and be done with it."

It was decided that more information, as to cost and type of mower to purchase, will be obtained by Carloftis and action taken at the regular meeting in April.

the numbers to us," DeBorde said.

"Members will eventually not have to read their own meters," DeBorde added.

DeBorde said it will take approximately three years to completely change out all the meters but that in the next three months about 250 of the new meters were going to be placed in the Scaffold Cane area of the county.

DeBorde said the entire project would cost approximately a half a million dollars and that Western had already applied for a grant from the federal government's Division of Rural Development to help pay for the cost of the project.

DeBorde said customers not reading their meters properly on purpose was a problem and Western has tried every way possible to keep up with any customer reading their meter

too low.

Also during the meeting,
Brownie Martin told Brock he
too had received a lot of complaints and that those complaints were turned into the
board.

DeBorde said all complaints received were turned over and talked about at each board meeting but that had not been the case in the past.

"We didn't turn all the complaints over to board before, but we do now," she said.

Martin said one of this biggest complaints was the smell of the water. Cox reminded those present that Western bought its water from the City of Mt. Vernon and there was nothing they could do about the smell. "Until the city does something about the smell the smell is going to be there," he said.

liability of service to the 16 distribution cooperatives to which it provides electricity, the PSC said.

Jackson Energy is one of those 16 cooperatives which serves about 500,000 customers in 89 counties.

Andrew Melnykovych, a spokesperson with the PSC, said Jackson Energy customers in Rockcastle County should expect about a two percent increase in their monthly statement.

The rate increase should take place in the next ten days to two weeks and would generate approximately \$19 million in additional annual income.

Legislative Week in Review

The 2007 regular session of the Kentucky General Assembly adjourned for good Tuesday, with handful of high-profile bills still unacted upon, a special session to deal with at least one of those unresolved issues possible, but more than a hundred other bills passed in 30 days of work in Frankfort.

Among the unresolved: A Senate plan to bail out the state's troubled pension fund, and restoration of bonded funding for numerous projects statewide vetoed by the governor in 2006. The House said it needed more time to thoroughly study the pension proposal; the Senate in turn felt it couldn't approve more than \$300 million in bonded indebtedness for those projects unless the multi-billion dollar unfunded liability in the retirement system was addressed.

The governor has said he will call a special session to pass a pension fix, but has given no timetable. Legislative leaders say any such call should only come after some agreement is reached between the chambers on a course of action.

The retirement-plan impasse between the House and Senate hung over the session's final days, and some high-profile pieces of legislation died in conference committees as the chambers negotiated --although the so-called Boni Frederick Bill aimed at improving job safety for social workers did survive and pass in an amended form after an agreement was reached on the session's last day.

Named for a Western Kentucky social services aide killed last fall during a routine home visit, the measure includes \$2.5 million to hire more social workers and \$3.5 million for social worker safety and office renovation. It will also create a state commission to study and recommend ways to better meet the safety and funding needs of state social workers.

Beyond the Boni Bill, this year's short session can boast a number of major pieces of legislation among the 100-plus bills that passed both chambers to become law, including the first boost in Kentucky's minimum wage in a decade and a significant minesafety initiative aimed at preventing tragedy in the coalfields.

House Bill 305 will increase the state minimum wage from the current \$5.15 an hour to \$7.25 an hour in stages over the next two years. The first increase of 70 cents per hour will take effect this summer, followed by a jump to \$6.55 an hour in 2008. By 2009, minimum wage workers will make \$7.25 -40 percent more than they are making now.

HB 207, the much-discussed mine-safety measure, comes after a year in which 16 Kentucky miners died in mine accidents.

It imposes several new requirements on underground mines, including flame-resistant construction of "lifeline cords" that direct miners out of mines during emergencies, criminal background checks for mine inspectors, staffing of trained medics at mine sites, adequate transport of miners out of mines during emergencies, certification of mine seals that trap explosive mine gases, six underground mine inspections annually (including two electrical inspections) and at least two surface mine inspections annually.

It also creates a full-time state liaison to work with mine families involved in accidents.

One successful bill likely to be popular with many Kentucky motorists is Senate Bill 83 which allows the state Transportation Cabinet to increase the speed limit to 70 mph on most of Kentucky's interstates and parkways -- if Cabinet officials determine that vehicles can travel safely on those roadways at that speed. Many surrounding states already have a 70 mph speed limit on their Interstates.

Also signed into law was HB 280, a bill that gives protection to grieving military families by clarifying provisions in a 2006 state law that was suspended by a federal judge last fall. The judge ruled that the law, which banned protests within 300 feet of funerals and memorial services, could infringe on the free speech rights of those who live or even pass by the area.

Lawmakers hope HB 280 will restore the protections in the original law by clarifying what constitutes disorderly conduct in the first degree at funerals and memorial services, and defining the crime of interference with a funeral. This bill came in response to protests by a fringe religious group which travels around the country protesting at military funerals.

SB 65 addresses a true "crime of the 21st Century" by requiring registered sex offenders to now include their e-mail, instant message, chat and other Internet identities in the information they list with the state sex offender registry. Parents and law enforcement could utilize that information in checking out who a child has been chatting with on the Internet.

HB 549 creates a new funding mechanism to cover over one-fourth of the cost of the \$465 million Museum Plaza project planned for downtown Louisville. It will allow a local portion of the lodging taxes expected from a hotel planned as part of the Plaza to cover part of the public infrastructure improvements needed for the project.

The Legislature also approved an incentive package aimed at keeping Ford Motor Co in Kentucky. Ford employs more than 8,000 workers at its two Louisville plants, with a combined \$4-billiona-year impact on Kentucky's economy.



The Rockcastle County Farm Service Committee (COC) will hold its monthly meeting Thursday beginning at 8:00 a.m. The meeting will be held at the FSA office located in the USDA County Service Center on Hwy 150 in Mt. Vernon, KY.

The COC members are vital to the day-to-day operations of FSA. The COC members help FSA at the local level by deciding the kind of program their county will have and how they will operate. FSA committees operate within official regulations designed to carry out Federal laws and applying their judgment and knowledge and knowledge to make decisions.

Direct and Counter-Cyclical

Program deadline extended USDA's Farm Service Agency has announced to extend the sign-up deadline for the 2007 Direct and Counter-Cyclical Payment Program (DCP) to

August 3, 2007. Problems with the FSA's web-based computer system caused agency officials to extend the deadline in order to ensure adequate opportunity for all producers to participate in the sign-up. While the sign-up is extended, the cut-off for participation remains Sept. 30, 2007. Those producers failing to sign up by August 3, 2007, but before September 30th, will pay a late file fee of \$100.00.

DCP provides payments to eligible producers on farms enrolled for the 2002 through 2007 crop years. There are two types of DCP payments-direct payments and counter-cyclical payments. Both are computed using the base acres and payment yields established for the farm.

Power of Attorney

The National Office has advised that handbook regulations pertaining to the Power of Attorney for the execution of CCC-526, Adjusted Gross Income Certification, be amended as follows: An individual may execute CCC-526 on behalf of another only when the grantor provides both of the following:

•Grantor selects item 7, "Other" under Section B, Transactions for FSA and CCC Programs, of FSA -211, Power of Attorney

•Item 7, "Other", specifies 'Executing CCC-526'

Therefore; persons having signed a FSA-211 on March 18, 2003 or later should review the Power of Attorney to verify if the above items are marked as necessary. If not, the grantor shall sign a new FSA-211.


