Carnival at Brodhead shut down

The Brodhead Homecoming Committee contracted a carnival company to provide entertainment for last weekend's festival, but things did not quite work out as planned.

According to homecoming committee member Brian Bussell, while the carnival was setting up, safety issues came to light but, after necessary repairs were completed, the carnival opened as planned.

Bussell said a follow-up check was then made and additional issues surfaced, including the alteration of installed safety barriers which had been altered by carnival workers and which reduced their integrity.

Other committee members said they had received several complaints about the atmosphere of the carnival not being child-friendly.

Bussell said the committee decided to terminate the carnival because it did not meet the intended purpose of the committee.

During the time the committee was deciding whether or not to send the carnival home, an incident involving a 11-year-old boy was also brought to their attention.

Rockcastle County Attorney Billy Reynolds said he was called to Brodhead after 11 p.m. Friday night to investigate the

At Middle School

12-year-old pleads guilty to setting fire

The 12-year-old RCMS student, who was one of three charged with setting fire to the Rockcastle Middle School on April 27th, has pled guilty to the crime.

During a hearing before District Judge Katie Wood on Tuesday morning, the 12-year-old student admitted his guilt and a hearing was set for next Tuesday to determine his punishment, according to Rockcastle County Attorney Billy Reynolds.

Reynolds said that once a juvenile is declared delinquent he or she is committed to the Department of Juvenile Justice.

"They will conduct an investigation and conduct interviews before making a recommendation," Reynolds said. "Once the sentencing is handed down, the case is turned completely over to them," he added.

Also on Tuesday, Reynolds turned over all of the evidence he has gathered in the case against the juveniles to the court for lawyers who are defending the juveniles.

Reynolds said the defense attorneys for the other two ju-

veniles did not show up for court as scheduled and Judge Wood ordered the evidence to be picked up at Reynolds office.

The 13 and 14-year-old students, who are also charged in the case are still being held in the juvenile detention center in Adair County, along with the 12-year-old.

Reynolds said he is seeking to have the 14-year-old certified

Steve Isaacs indicted on 17 counts of mail fraud

A former Rockcastle County Fish and Wildlife officer, who was the subject of much controversy during his time on the job, has been indicted on 17 counts of mail fraud, after he allegedly pocketed poaching fines that were supposed to go to the state's coffers.

Steve Isaacs, 44, of Mt. Vernon was indicted by a federal grand jury last week on evidence that he pocketed \$9,500 in fines from Michael and Jonathan McKinney.

The McKinney brothers were fined \$12,500 each in Rockcastle Circuit Court after their September 2002 arrests for illegally poaching deer and turkeys.

A search of the McKinney's property at Sand Springs in 2002 turned up 49 deer antlers and 37 turkey beards, none of which had been properly checked.

The brothers were ordered to make periodic payments to the Kentucky Department of Fish and Wildlife with the money to be used in Rockcastle County

at the discretion of the department.

But, the brothers got behind in their payments and were ordered to appear in Rockcastle Circuit Court in March of 2005.

According to the federal indictment, after the hearing, Isaacs approached the brothers and directed them to send the

money for the fines to a post office box that he controlled, allegedly in another county.

Isaacs told the McKinney brothers to mark the payments to his attention.

The money was sent by the McKinney's mother from a post

Thompson sentenced to just 30 months in death of Enita Bradley

A Rockcastle County man was sentenced to 30 months in prison on Friday, after pleading guilty on April 27th to Reckless homicide.

Kelly Doyle Thompson, Jr., 37, of Orlando was indicted in January for the death of Enita Bradley, 34, of Mt. Vernon who died on October 3rd of last year at the University of Kentucky Medical Center.

According to court records,

Thompson was driving drunk on September 29th when he lost control of the car he was driving on U.S. 25 south and struck an embankment. The impact of the crash resulted in the death of Bradley, who was Thompson's passenger.

Police found a cooler full of beer and an open beer container at the scene.

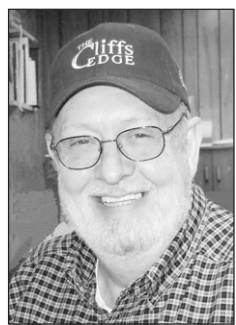

Rockcastle Memories

It was a time of babies booming and cars zooming. The mid 50's and early 60's in America: we remember it as a time of innocence – and automobile fever. I recently discovered the following anonymous poem, Cars, which recalled my former fascination with them as a child of the era.

There was a time when just one glance was all that it would take, And you would know the kind of car, the model and the make.

I grew up knowing everything about virtually every car that drove the streets of my hometown. Most of my friends and I could name the brand, year, and model of each automobile that roared by. Makes of cars were distinct and classy – and we learned to identify them early on. We could even tell you the type of engine a car had under its hood.

TV revealed the latest shapes of automobiles, and the radio was filled with musical jingles about them. Who doesn't remember Dinah Shore singing, "See the USA in your Chevrolet"?

In the early 50's, without realizing how it would affect future automobile sales, Oldsmobile began a "horsepower race" with its short-stroke, overhead-cam, Rocket V-8 engine. Chevy and Ford quickly joined the race. Chevy introduced its V-8 in 1955. Shiny chrome made a dazzling frame around most cars, and the tail fins continued to grow.

Hot Rodders were in heaven! Ford battled Chevy tooth and nail – and finally hit pay dirt with the '65 Mustang, which became the decade's signature automobile.

My friends owned a variety of cool cars. My best friend, Bud Cox, had three that I remember fondly. He had a 1960 Valiant that was "customized" by placing black tape on sections of the grill (due largely to a shortage of funds). The second was a silver '58 Bonneville Convertible. But the car of his that we most enjoyed was his 1931 Ford Model A Deluxe Coupe. Bud once remarked, "I could beat anyone in a drag race with that car if the finish line was ten feet in front of the bumper."

Charles Hensley owned several hot cars, but the one that I admired most was his 1951 Chevrolet. That baby had more chrome on the engine than any car I ever saw. Charles was a lot like me when it came to keeping his car clean – he washed it almost every day. He was a master mechanic and kept his Chevy in tip-top shape.

Penny Nunnelley graced the streets of Mt. Vernon in his 1952 Chevy Convertible. We also double dated in his "clean" Studebaker. Some nights he actually let me drive.

Two fine '57 Chevys also come to mind. My brother had a black and white Bel Air. He took pity on his younger brother and allowed me to drive it in the

I've never actually taken the time to start in the basement and end up in the attic of our house with the sole purpose of counting all the light fixtures and lamps that require anywhere from one to as many as half a dozen bulbs to be operating at full capacity.

Doing so would require more effort than performing year-end inventory at a hardware store where every nail, bolt, nut and washer had to be accounted for by size shape and color.

I'm not talking about Christmas lights or decorations, just stuff that's either plugged in or permanently affixed or in the case of the attic and part of the basement, simply dangling.

We've lived here for well over a decade and I can promise you faithfully that there has never been a time when more than ninety percent of the light bulbs in this house would all illuminate at the same time.

Three or four years ago some school kids or maybe it was a Scout Troop came around selling light bulbs guaranteed to last a lifetime and only consume about half the electricity of a normal bulb.

Of course they were very pricey – something like three bucks each compared to the normal three for a dollar that you could get at Big Lots, but the kids seemed honest enough so I broke down and bought two dozen in various wattage ratings.

The way this deal worked was that you paid the kids up front and the bulbs would come in the mail. Sure enough there was a life-time warranty certificate in the package which I promptly stashed in my desk just in case I ever had to use it.

I proceeded to install four bulbs in the basement. When I hit the switch, one of them flashed like lightning and blew out on the spot. To make a long story short the rest didn't last a month. I pulled out the warranty intending to get my money back but that's not the way it worked.

If I would mail the blown bulbs back to New Jersey and include \$2.00 per bulb for shipping and handling, they would replace them for free. Yeah buddy. I still have a dozen of these bulbs that I have never installed because the threefers

Risks of Artificial Tanning

Do you like to keep your tan all winter, or get an early start on summer by going to tanning booths or using other tanning aids? Many do, but perhaps they shouldn't.

There are a number of reasons why tanning booths can be harmful.

Although the wavelengths of the lights used in these booths do not cause skin cancer, as sunlight does, they are still harmful. They damage the skin in different ways.

These rays penetrate deeper into the skin and do more damage to the collagen and elastic fibers. This will cause the skin to develop wrinkles sooner and sag much more. Once these collagen and elastic fibers are damaged, they are damaged forever. The body cannot repair or replace these fibers.

Another bad effect is that the tan that results from tanning booths does not protect like a real tan does. It is only about half as effective as the same degree of tan from the sun. Having this less protective tan allows a person to sunburn more easily than he expects when he goes out in the sun. And sunburns are more than an annoyance—they greatly increase the chance of developing skin cancers, including melanomas. Melanomas are the deadly form of skin cancer that grow rapidly and spread easily.

Tanning aids have also been found to cause side effects and even liver damage.

Another risk occurs if the tanning booths are not completely cleaned after each use. A person may contract viral or fungal infections of the skin. These can include herpes viruses, wart viruses, or other infections.

If you want to keep your skin youthful and free from wrinkles longer, think twice before getting a tan, even an artificial tan.

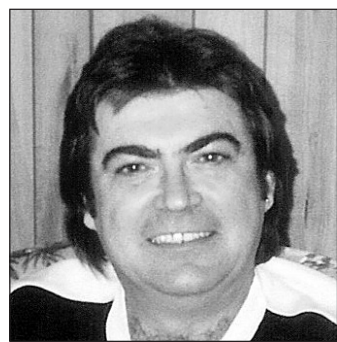


Irene Smith Campbell

from Big Lots or the Dollar Store last much longer.

Anyway, only about half the bulbs in our house are what you would call normal. Some are candelabra types that require special threads. The bathroom vanity takes five that are roughly the size of cantaloupes. Normally I wait until three are blown and when I replace them we will sometimes have all five lit up at the same time for two or three days.

We use yellow bulbs on the outside fixtures because they are not supposed to attract bugs. Of course they do but Loretta insists there's not as many. The only difference I've noticed is that they cost about as much as the life-time warranty jobs, but they do seem to last longer.

Anyway, we were at a yard-sale a few weeks back and a fellow had a large cardboard box full of light bulbs of all shapes and sizes and he swore that they were all burning or unused when he put them in the box. He wanted a dollar for the whole thing and there were like ten of the vanity bulbs that normally cost over a buck each. You never saw a dollar bill and a box of light bulbs change hands so fast in your life.

Then, after I got them in the car, I asked him why he was selling them, figuring that he was going to tell me about the school kids or Scout Troops and what a deal he'd gotten from them but he said he had gone fluorescent throughout the house.

He had it all figured out as to how much money he would be saving and, like me, he could only make a rough estimate as to how many bulbs were actually in his house. He said a 15 watt fluorescent put out more light than a 60 watt regular bulb and would last seven years compared to an average of about 300

hours for a normal bulb. He was figuring on saving well over a hundred dollars a year.

You've probably seen these things. They look like a sawed-off suspension coil spring for the front wheel of a motorcycle but you can buy covers to put over them if you want to use them on your vanity.

I've put one in the overhead bathroom light and now have several knots on my forehead from bumping into the door frame. When I flip the switch there's a full second delay before the light comes on so I'm learning to slow down when nature calls.

The price on these things is really dropping. I bought a six pack for less than six bucks and the 15 watts really do put out a lot of light.

I'm going back to Lowe's one night this week and get a case and I'm going to spend half a day replacing every incandescent bulb in the house including the attic and the basement with fluorescent.

If you are planning to visit me after dark and can't find the house, just look for the house on Charlie Brown Road that's all lit up. That'll be my place.

In the meantime, Granddaughter Amber is having a yard sale to raise money for the Lincoln County High School Cheerleading Squad in a week or two and she has asked me to contribute something she can sell. She will have a huge box of light bulbs in good working condition that you can probably get for less than five dollars.

poaching certainly will. And big business it is.

A surprisingly lucrative black market exists for animal parts. Black bears are frequently poached in North America including in states surrounding Kentucky. In the 1990s, hundreds of felony charges were brought in Virginia and West Virginia for illegally trafficking in bear parts. As Kentucky's population of black bears increases, it can be expected that some will succumb to the lure of black market profits which promise thousands of dollars for a single bear gallbladder, long revered in Asian culture for its' supposed

medicinal qualities. DNA comparisons permit criminal investigators to "match" a particular gall bladder to an illegal carcass and thus complete the evidentiary chain necessary to sustain a conviction.

Illegally taken bird feathers are also a hot black market item. A single feather from a golden eagle can fetch \$100.00 or more, and aninga feathers—a coastal bird which strongly resembles the cormorant—bring enormous profits. These feathers are components of authentic Native American items and are sold illegally throughout the United States and abroad. The mere possession of such items is a violation of the Migratory Bird Act and, in some cases, the Endangered Species Act, all of which carry stiff penalties. Forensic scientists maintain data bases which permit state and federal law enforcement to identify suspected contraband items when they are encountered in the field or recovered during an undercover transaction.

The forensic sciences are also used to ensure that legitimate consumers are not being ripped off by disreputable marketing practices involving legal products. A good example is the caviar market. While I'm more accustomed to bologna on salines than fish eggs on toasted crisps, this is apparently an important issue for many connoisseurs. Sight and taste alone are not sufficient to verify whether

customers are receiving the species of roe they expect. Sampling of some caviar brands indicate that inferior eggs are added to higher quality (and thus higher priced) eggs. By maintaining a DNA database of all sturgeon species, forensic scientists can use genetic variations to identify individual species and thus ensure that consumers who pay for beluga caviar are actually getting beluga roe and not some other species.

The National Fish and Wildlife Forensic Laboratory located in Ashland, Oregon is the world's foremost full-service crime laboratory devoted to the enforcement of fish and wildlife laws. In 2005, the lab assisted with over 600 cases involving the analysis of over 3,000 evidence samples obtained in criminal investigations. The Firearms Unit maintains a database of recovered bullets and cartridge cases which can be used for comparative purposes in cases involving future wildlife crimes.

While Kentucky conservation officers routinely utilize the forensic services available through the Kentucky State Police laboratory in Frankfort, we also benefit from the existence of the national laboratory and other state forensic labs. The increasing prevalence of these labs means that sophisticated fish and wildlife violators are far more likely to be brought to justice for their crimes.

tions don't seem to understand or care to participate. My eleven-year-old nephew asked his mother, "Why are we here?" when they went to the cemetery to place the Memorial Day flowers this year. A niece who is twenty-one came along, too. It was one of only a handful of times she had been to the family plot, even including funerals.

The "Decoration Day" at Skaggs' Creek was always held the following week. This meant the whole process was to be repeated; a meal prepared and flowers taken. Of course, back then, we took those thick plastic-petaled flowers that were so waxy-looking that you could tell that they were artificial from across the room. However, they were a step ahead of the paper flowers that my great-grandma Melvina and her daughters spent the winter making so that they would have something nice to put on the graves of family and friends when the much-anticipated "Decoration Day" came.

I'm looking especially forward to going to the Skaggs' Creek event this year. It is the first year that my aunt will have a permanent monument of her own.

Her name was Sula Lucille, named after each of my grandpa and grandma's sisters. She was their first child, and died after only a few hours. My grandparents lived in Tennessee at the time, and hadn't been married long. Grandpa Norton, being from Mount Vernon, boarded the train back to Mount Vernon the next day after her death with the baby for burial. My grandma wasn't able to travel yet, so she was unable to make the trip. Of course, that was during the days when a woman was on bed-rest for at least two or three weeks following giving birth, providing every thing went well. For whatever reason, my grandma's family who lived near them in Tennessee, weren't able to make the trip either, but said their good-byes to the baby there.

Grandpa arrived back in Mount Vernon, March 4th, 1920, and was met at the depot by some of his family who had been told of the tragedy. The

funeral was the following day. Grandpa was offered a temporary headstone by some relatives who were erecting a new stone for their loved one, Maggie Norton.

I'm sure that in the beginning, my grandpa and grandma didn't have extra money for a headstone, as they were just starting out in life, and money was scarce. As the years passed, getting a headstone was always on the "to-do" list, but never seemed to get accomplished, even after they moved to Kentucky and finally got ahead.

Sometime along the way, my great-grandma Melvina planted a rosebush on the grave, but it has long ago died. As far as I know, Sula Lucille was her first grandchild. My great-grandma, along with all of the generation that was on hand that cold wintery day, in March of 1920 for the passing and burial of Sula Lucille have long ago departed this life. No one alive today remembers the baby, as she only exists in hand-me-down stories. In doing recent family research, we've been unable to find a birth certificate for her, so for all practical purposes, she never even existed. I, along with a few of my generation, know that she did exist. I've heard aunts, uncles, and grandparents speak of her too many times.

So, finally, after eighty-seven years this child will have her own headstone. Our family has decided that Sula Lucille has waited long enough. We've chipped in a little money, and the stone will be erected this next week. I'll be very excited to see it. This Memorial Day season will be a very memorable one for our family.

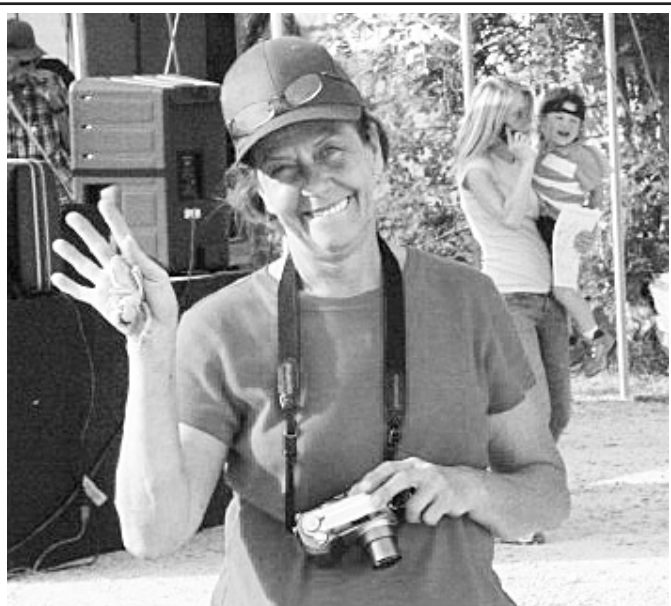

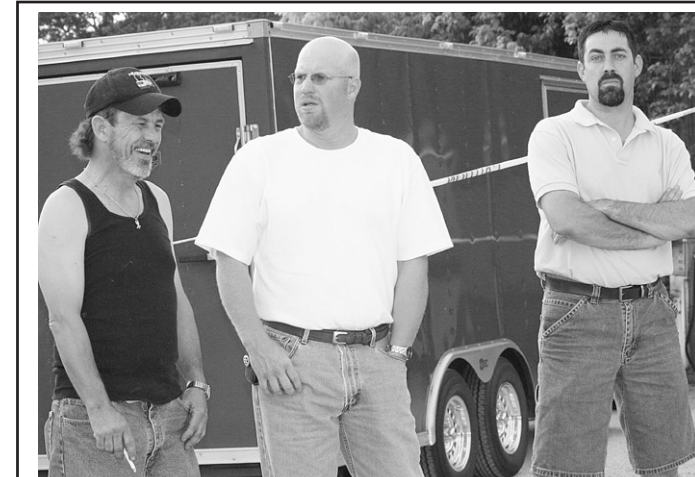

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Tests Showed Coliform Bacteria in Mt. Vernon Water Works

Our water system recently violated a drinking water standard. Although this incident was not an emergency, as our customers, you have a right to know what happened, and what we did to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Standards require that no more than 1 sample per month may show the presence of coliform bacteria.

During the month of **MAY**, we took **8** samples for coliform bacteria. **2** of our samples showed the presence of coliform bacteria.

What should I do?

You do not need to boil your water or take other corrective actions. However, if you have specific health concerns, consult your doctor.

People with severely compromised immune systems, infants, and some elderly may be at increased risk. These people should seek advice about drinking water from their health care providers. General guidelines on ways to lessen the risk of infection by microbes are available from EPA's Safe Drinking Water Hotline at 1 (800) 426-4791.

What does this mean?

This is not an emergency. If it had been you would have been notified immediately. Total coliform bacteria are generally not harmful themselves. *Coliforms are bacteria which are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems.*

Usually, coliforms are a sign that there could be a problem with the treatment or distribution system (pipes). Whenever we detect coliform bacteria in any sample, we do follow-up testing to see if other bacteria of greater concern, such as fecal coliform or *E. coli*, are present. **We did not find any of these bacteria in our subsequent testing, and further testing shows that this problem has been resolved.**

What happened? What was done?

Mt. Vernon routinely checks for Coliform Bacteria, at least 8 times each month. On 5-15-07, we were notified that 2 samples were positive for Coliform Bacteria. That same day we recheck the same site for Coliform Bacteria, and they came back negative of any Bacteria.

Do You Know?

Small boats and wind, lightning and safety

In an effort to promote safe boating practices of the recreational small boater, NOAA's National Weather Service wishes to emphasize the importance of weather awareness and planning whenever you decide to take to the water.

Eastern Kentucky is home to some of the most beautiful, and the largest of lakes east of the Mississippi River (not counting the Great Lakes). Buckhorn Lake, Cave Run Lake, Paintsville Lake, Carr Creek, Laurel Lake, and of course Lake Cumberland, the largest of these Kentucky jewels which covers over 50,000 acres. These lakes have a superb reputation for excellent fishing and water recreation that draws residents and visitors alike each year. To get to those fish, many fishermen choose to use a boat. The lakes of eastern Kentucky are large, but they are not an ocean. Every boat plying the lakes of east Kentucky is classified as a small boat, even though they range from a fairly large-looking houseboat, to the sleek bass boat.

Weather can pose a serious threat to any boater, but especially to those who are unprepared. As a small boat operator, it is sometimes easy to overlook the obvious. You can easily be beyond a half hour from any marina, and oftentimes, the distance is even greater. Weather can be both friend and foe to the recreational boater. Calm winds and seas make for enjoyable power boating, waterskiing, and fishing. A fresh breeze and a light chop provide an invigorating sailing or wind surfing experience. But the sudden emer-

gence of dark clouds, shifting and gusty winds, torrential downpours and lightning can turn a day's pleasure into a nightmare of distress.

Wind is tricky because it can vary widely over just a few feet. The best example is to look at tornado damage where one house is blown apart, and the house next door has a few shingles blown off - or no damage at all. There have been many studies of wind effect on various structures in wind tunnels. The NWS uses wind gusts of 58 MPH as a basis of warnings with thunderstorm wind because a 58 MPH gust will start to blow shingles off a normal house. It can uproot a tree if the ground is fairly wet. And a trailer that is not properly tied down can roll over. Aged or poorly constructed sheds can also be toppled if the wind hits broadside.

But a boat on open water is much different than anything based on solid ground. Winds can make boating difficult at much lower speeds than are required to produce hazardous conditions on land. The National Weather Service takes this into account, and will issue a "Lake Wind Advisory" whenever winds will create a hazard to boating conditions on the area lakes.

Between April 1st and October 31st of each year which is the peak boating season for east Kentucky, a Lake wind advisory will be issued when the sustained wind speeds are between 20 to 29 mph for at least one hour, or wind gust of 35 to 44 mph for any duration. Higher wind speeds will require a Wind Advisory or High Wind Warning which will also have an impact over the land. The Lake Wind Advisory will be issued for winds that are not associated with thunderstorms.

In addition to creating choppy water conditions, winds in the range of 20 to 29 mph can

create hazards for small boat operators in maneuvering on the open water, or in trying to dock safely at the local marina. Wind gusts of 34 knots or more can easily capsize a small boat, especially if the boater is unprepared.

Lightning also presents a serious danger to boaters. The best course of action a vessel operator can take to reduce the risk from a lightning strike is to return to safe harbor and seek shelter inside a sturdy, enclosed building. If caught on the open water, remember that one does not have to be struck directly by a lightning bolt while on deck to receive severe injuries or be killed. Tall masts, antenna booms and fly decks are all high profile targets for a lightning strike, and frequently strikes to vessels produce extensive damages to navigational and communications equipment. All on board should stay away from all ungrounded metal objects. But most importantly, the boat owner should have their boat properly grounded. That evolves having a special cable running through to the boat's bottom, allowing a path for the lightning strike to travel directly through the boat and discharge into the water, without the electric charge traveling over most of the boat surfaces.

Perhaps the boat operator's most important tool would be NOAA Weather Radio. In addition to the forecast and current weather conditions in the area, NOAA Weather Radio will give the greatest advance warning strong winds approaching the area. You can purchase a NOAA Weather Radio at a local electronic dealer or at most major retailers. Knowing what to expect will allow everyone to enjoy the resources offered by the area lakes, and also allow for important decision making that can save your life, and the lives of your family.

Attention Students

Health Services

All new students enrolling into the Rockcastle County Schools are required to provide a physical and up-to-date immunization certificate. These records are to be brought to the Board of Education on Richmond Street in Mt. Vernon during the summer or given to the teacher on the first day of school.

Food Service

Research has shown that children perform better academically if they eat breakfast. Encourage your children to eat a nutritious breakfast every morning.

Both breakfast and lunch are served at all five schools. Breakfast costs \$.75 and lunch costs \$1.00 at the elementary schools and \$1.25 at the middle and high schools. Breakfast includes an entree, fruit or fruit juice and milk. Lunch includes an entree, one fruit and vegetable, bread and milk. Both meals follow the federal and state nutritional guidelines. Nutritious meals are served at a very affordable price.

Meal applications will be mailed at the end of June. All students in the family are to be put on one application. Only one application needs to be returned to the Board of Education. A self-addressed, stamped envelope has been provided for the family's convenience in returning the application. All families have an equal opportunity to apply for free or reduced-price meals. Be sure to return your completed application as soon as possible to see if your student qualifies. Parents are responsible for meal charges until they are informed that their child(ren) qualified for free or reduced meals. We are requesting that all families return the applications with their children's names on it so that we will know that every family has received an application.

Parents can put money into their child's meal account. As funds are used, the parent(s) will be notified of the need to add money to the account. Parents are encouraged to pre-pay meals rather than the child creating meal charges.

RCHS defeated runner-up and host West Jessamine 150-122. This marked the tenth straight season that the RCHS girls have either won the regional title or been regional runner-up. The team qualified nine girls in twelve events for the Class 2A State Championships.

The RCHS girls' 3200-meter relay team got region off to a great start last Wednesday with an unbelievable record-setting performance. The team of sixth grader Michaela Hunter, eighth grader Jessica Albright, eighth grader Ella McQueary, and eighth grader Sara Hammond blazed their way to a regional championship win in the event with a new RCHS record time of 10:14.15, shattering the old mark by six seconds.

RCHS sophomore Sarah McKinney won the 100-meter hurdles and totally dominated the competition winning with a time of 16.4 seconds. Sara is currently ranked 1st in Class 2A and is the favorite for the state title at this weekend's state championship meet. Sarah also ran a great 300-meter hurdle race, finishing 3rd overall with an exceptional effort of 51.65 seconds. Sarah had been ranked as high as second in the state in the event, but just missed qualifying for the state championships.

RCHS freshman Samantha Smith qualified for state in three individual events. Samantha finished as regional runner-up in the 200-meter dash with a spectacular race. She finished with an awesome time of 27.14 seconds and is ranked 9th in the event going into the state championships. Samantha also finished as regional runner-up in the triple jump competition with a phenomenal personal best effort of 33'11.5", her best by 4.5". Samantha ranks 5th in the event entering state championship competition. Samantha also met the qualifying mark in long jump with a 3rd place finish overall. Her amazing leap of 16'1" tied her personal best in the event. She also ranks 5th entering the state meet. Samantha will be among the favorites for the state title in each of her events.

RCHS junior Morgan Thacker had a great regional meet despite having missed almost two weeks at the end of the season due to illness. Even with the time off, Morgan performed exceptionally well in the jumping events, but had lost enough endurance in her sprint races to make an impact. In long jump, Morgan dominated the competition, leaping an incredible 17'2.5" to take her second regional crown in the event. Morgan is the defending Class 2A state champion in long jump and goes into the event as the favorite once again. In the triple jump competition, Morgan was up to the task as well. Morgan won the regional title for the second year in a row with an outstanding season's best effort of 34'0.5". She enters state competition ranked 3rd and has an excellent chance of winning the event at state. Morgan also ran very well in the 100 and 200-meter dashes, despite having to miss two weeks to recover from her illness. In the 100, she finished 4th with an excellent effort of 13.52 seconds. In the 200, Morgan also finished 4th in a solid 27.87. Before her illness, Morgan had been ranked 3rd in the state in the 200 and 7th in the 100.

RCMS eighth grader Sara Hammond and RCHS senior Morgan Kincer took part in what shaped up to be the most exciting sprint event of the day. Five of the top six 400-meter sprinters in the state are in Class 2A region IV. Both Sara and Morgan ran personal bests in the preliminaries and came into

Saturday's finals as the favorites for the regional crown. The girls certainly did not disappoint. Sara won the regional title with an awesome new personal best time of 1:00.54. Sara is currently ranked 2nd in Class 2A in the event and will be a favorite for the state title. After decimating most of the field with her blazing fast start, Morgan finished as regional runner-up with a phenomenal new personal best time of 1:00.79. Morgan is currently ranked 3rd in the state in Class 2A and will be a favorite to take home the state title.

Sara Hammond also qualified for state with an outstanding performance in the high jump competition. Sara leaped her way to a regional runner-up finish in the event with a terrific effort of 4'10". Going into the state finals, Sara is ranked 6th in the event and has a great chance at the state title.

RCMS eighth grader Jessica Albright won the 300-meter hurdles at the regional championships with an incredible performance. Jessica ran an awesome personal best time of 49.88 seconds and currently ranks 6th in the state in Class 2A. Jessica will be among the favorites for the state title in the event this weekend. RCMS sixth grader Michaela Hunter won the 1600 and 3200-meter runs at the regional championships. Michaela won the 1600 for the second straight season with an exceptional time of 5:38 and currently ranks 5th in the state in the event. For most of the season, Michaela had been ranked 1st in Class 2A. She also dominated the 3200-meter run, cruising to an easy 1st place regional win in a time of 13:05. Michaela will be among the favorites for the state title in both events this Saturday and will be a key factor in the Lady Rockets run for the team state title. She also finished 8th in the 800-meter run with a great effort of 2:42.71.

The 800-meter relay team of Samantha Smith, seventh grader Chelsea Payne, Jessica Albright, and Morgan Kincer ran an incredible race. The team finished a close 3rd overall with a new season's best time of 1:50.9. The team easily qualified for the state championships having met the qualifying standard. With some work on their baton exchanges and the possible addition of Morgan Thacker to the mix, the team has an excellent chance of winning the state title. For most of the season, the girls have been ranked 3rd in the event.

The 400-meter relay team of Sarah McKinney, eighth grader Ashley Partin, Kayla Howard, and Chelsea Payne blazed their way to a 6th place regional finish with a superb effort of 56.09 seconds.

The 1600-meter relay team of Morgan Kincer, Jessica Albright, Ella McQueary, and Sara Hammond came into the event ranked 2nd in the state and looked to win the regional title. Standing in their way was 3rd ranked Casey County. Morgan gave RCHS a huge lead after the first leg and the team never looked back, taking the regional title in a state best 4:13.1. Going into this weekend's state finals, RCHS will be the favorite for the state title in the event, but will face many other talented teams capable of taking the title themselves.

RCMS eighth grader Ella McQueary contributed in the individual scoring for RCHS. After coming off an illness, earlier in the week, Ella bounced back to finish 6th in the 800-meter run with an exceptional effort of 2:38.21.

RCMS eighth grader Kayla Howard finished 7th in the 100-meter dash with an exceptional effort of 13.99 seconds. Kayla has quickly established herself as a future force to be reckoned with in the sprints for RCHS.

RCMS eighth grader Amber Hines was the sole RCHS competitor in the shot put and discus competitions. In shot put, Amber threw exceptionally well placing 12th overall with an effort of 23'5.75". In discus, Amber's best event, she finished 12th as well with an awesome effort of 65'8".

RCHS freshman Deana Gabbard has been nursing a stress fracture for the last few weeks, but has been resilient in her desire to compete. She finished 6th in the 1600-meter run

with a great effort of 6:19.06 and 7th in the 3200-meter run. At full strength earlier this season, Deana consistently ran in the 5:40 range for the mile and in the 12:40 range for the two-mile. She also posted a 2:29 split in the 3200-meter relay. Her scoring ability will definitely be missed at the state competition.

RCHS is also without the services of sprinter Katie Burdette who suffered a season-ending fall at the conference championship meet that left her with a sprained arm. Sophomore sprinter Katy Mattingly has also missed the entire season due to illness. Last season, Katy was the second fastest sprinter on the girls' team and was a constant fixture among the region's best short sprinters. Both girls will be sorely missed at the state championships, having been key components of many all-state relay teams.

The RCHS boys' team finished 10th overall despite having only three runners compete in the regional championships.

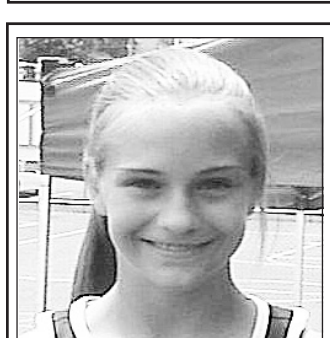
RCHS senior Josh Blair had several outstanding performances. In the 100-meter dash preliminaries, Josh ran a 12.6 and just missed qualifying for the regional finals in the event. Josh performed even better in the 200, qualifying for the finals with a spectacular effort of 24.83 seconds. 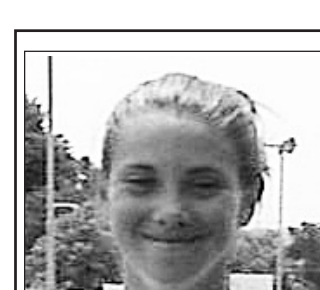

Jake Riddle had two hits and

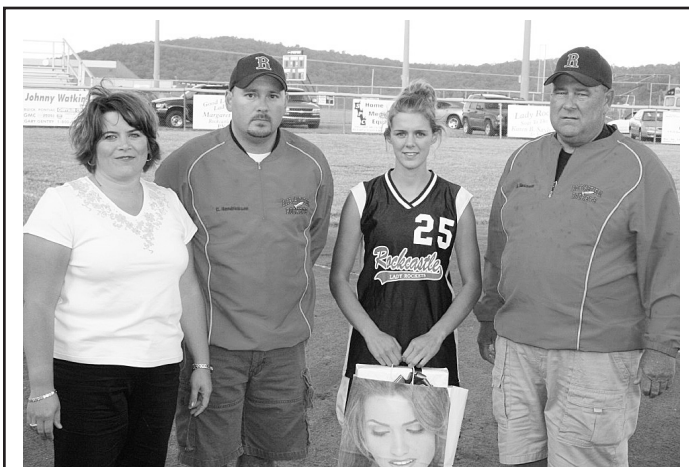
two RBI. Izak McQueary was two for four with three runs scored and John L. Saylor was two for three with one RBI.

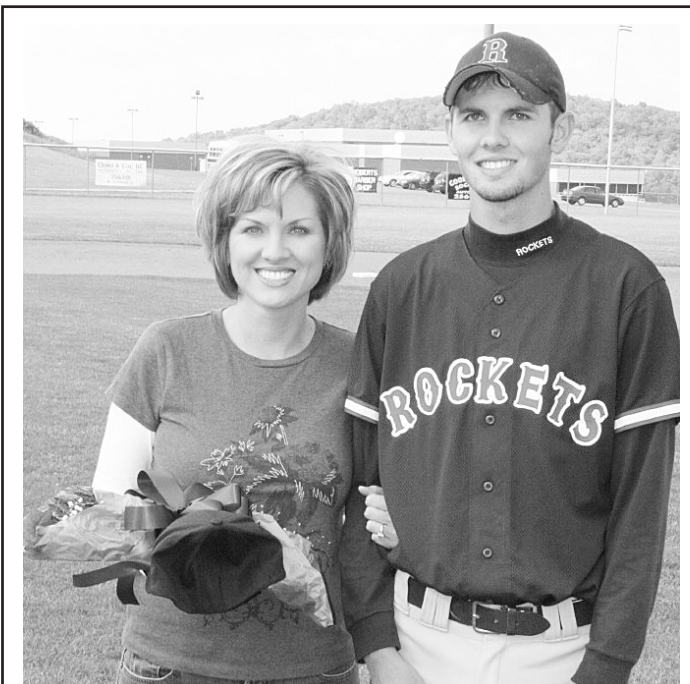
But, on Tuesday night, the Rockets dropped their 10th game of the season with a 7-3 loss to West Jessamine in the second round of the region.

McQueary and Perkins were named to the 12th region all tournament team.

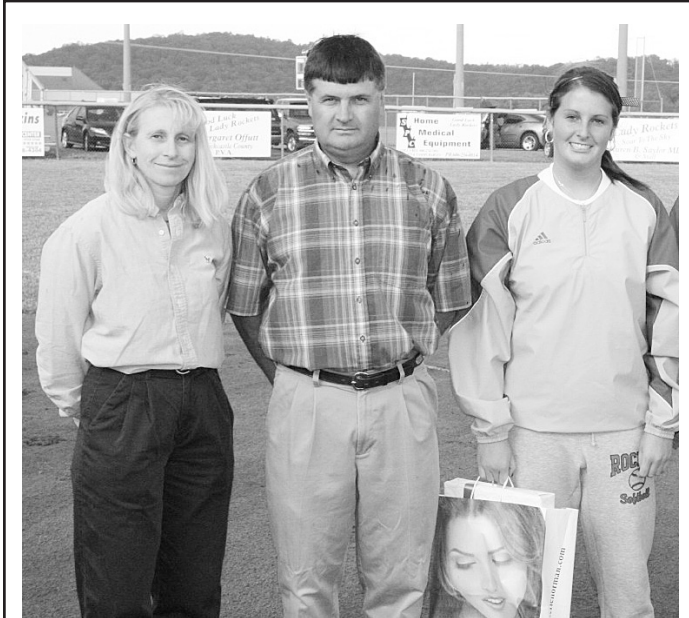

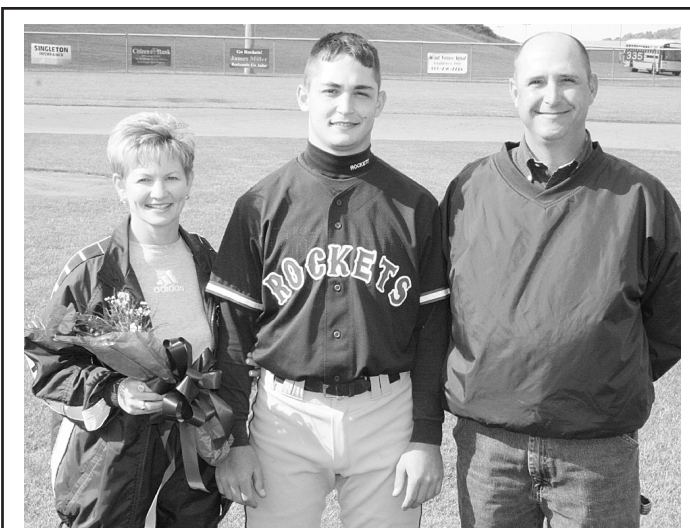

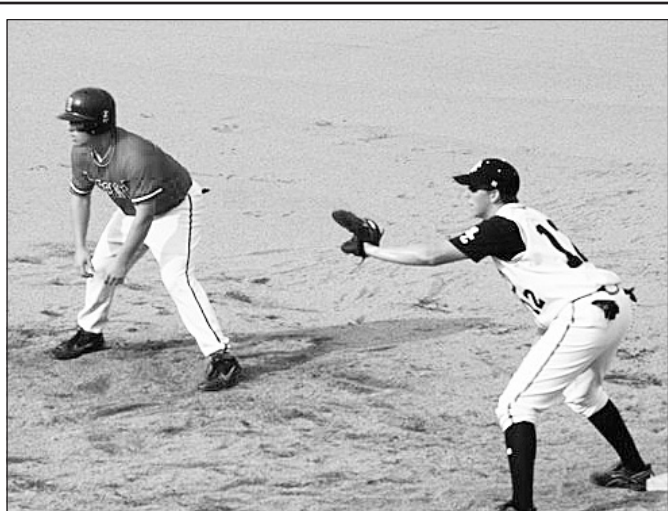

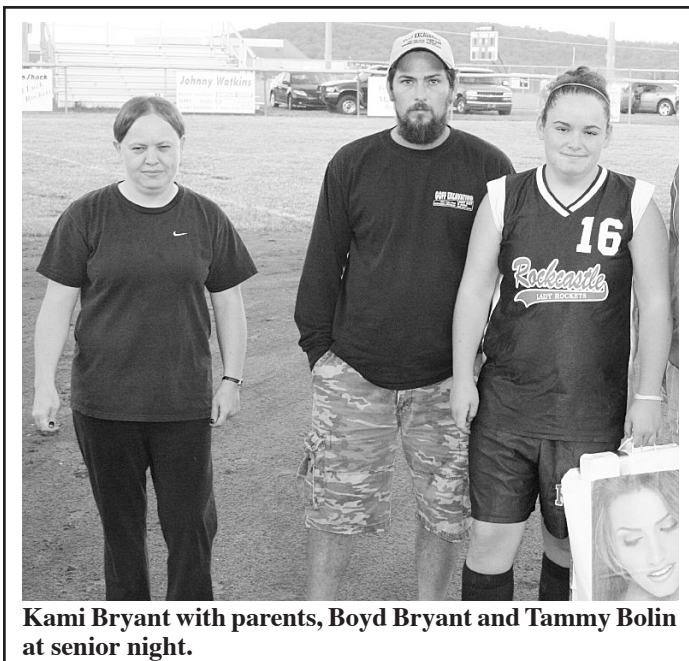

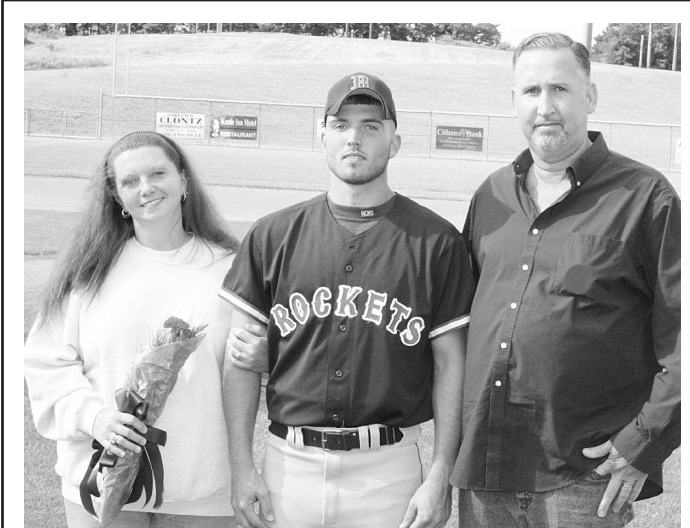

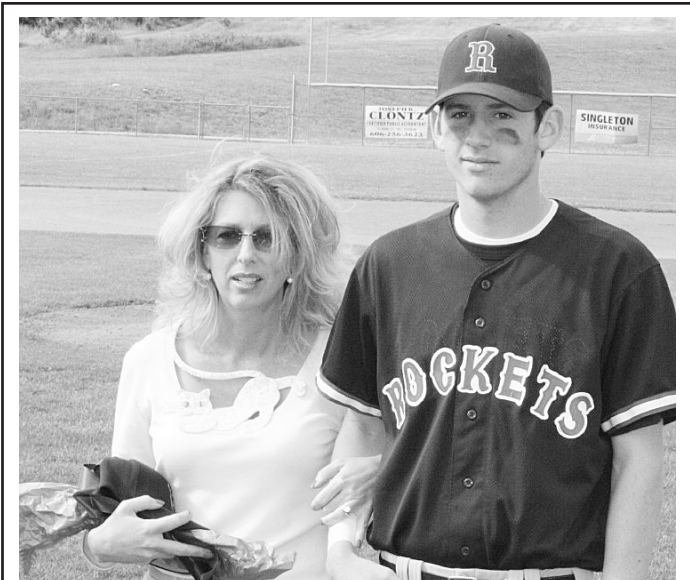

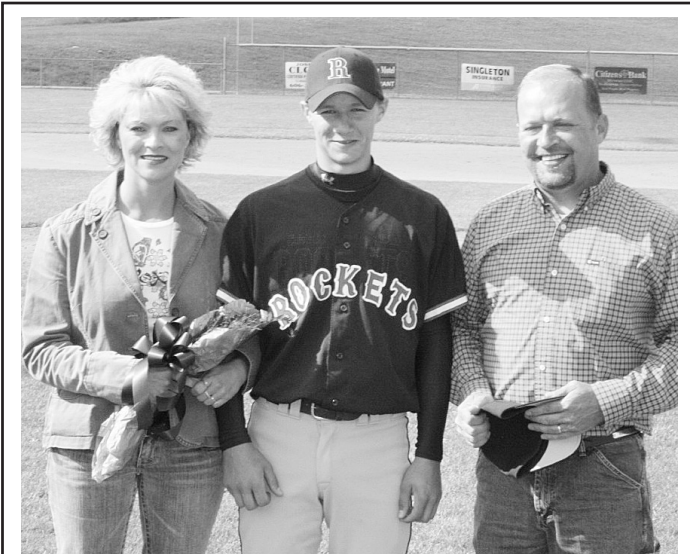

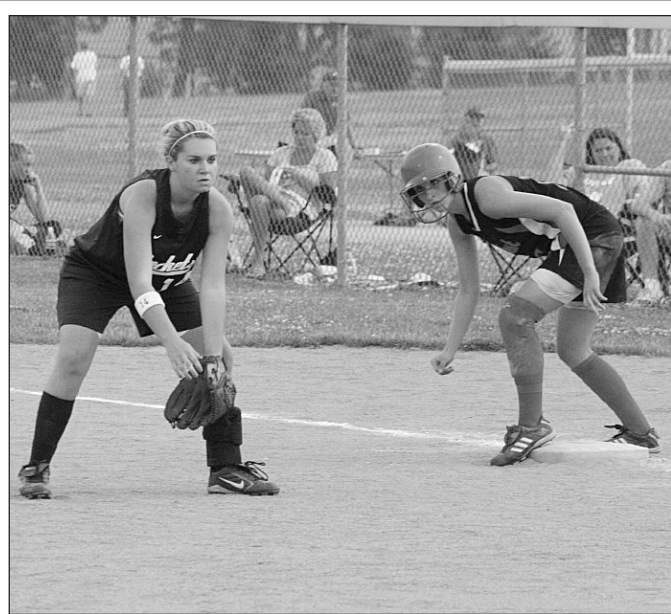

The Family Room

Lori Morgan was only thirty-seven when she died last week. It was a tragic loss for her family and all of those who knew and respected her.

Officially she died of a blood clot, but that is not the whole truth. Two years ago in April, 2005, she was shot four times at close range by her boyfriend. The blood clot probably came from the damage done by those bullets. Officially a blood clot killed her. Unofficially she was murdered.

Before she was shot, Lori had discovered that her boyfriend had had a Domestic Violence Order filed against him by his ex-wife. This had come as a surprise to Lori and, when he

came to her house, she confronted him about it. He became enraged and shot her.

The shooting left Lori paralyzed from the waist down, and she endured months of rehabilitation and surgery. She came home in a wheelchair where she would remain for the rest of her life. She also dealt with the physical pain, which never stopped. She became depressed and despaired of ever having anything like a normal life. She did not think it was fair that the man who shot her only had to serve fifteen years in prison, while she was paralyzed for the rest of her life.

Lori was also very concerned about her son. He was

in the other room and called 911 when she was shot. The effect of that trauma on a twelve-year-old is hard to imagine, and now he has to deal with the shock of losing his mother. Loving family members will take him in, but that does not erase the effects of losing Mom.

When she came home from the hospital, Lori and her son lived with her sister and her brother-in-law. Their basement was remodeled and a handicap ramp was constructed. Friends and community businesses helped. Her sister became her caregiver.

The last time I saw Lori was a week before her death. She told me, "For the first time I have some hope." She was beginning to see that a life might be possible.

She desperately wanted to go to Washington, D.C. earlier this spring for the Christopher Reeve conference on stem-cell research. Lori held out hope that this research might produce a way out for her and millions of others who were paralyzed. She was unable to secure the funds to make the trip but looked forward to the possibility of going next year.

Lori was bright, attractive and gracious. Her life was changed in one horrible moment two years ago, and now her life is over. It is the kind of tragedy that neither woman nor child should have to endure. She told me that she did not believe her boyfriend would ever shoot her. "If I had, I certainly wouldn't have asked him about that DVO!" she said.

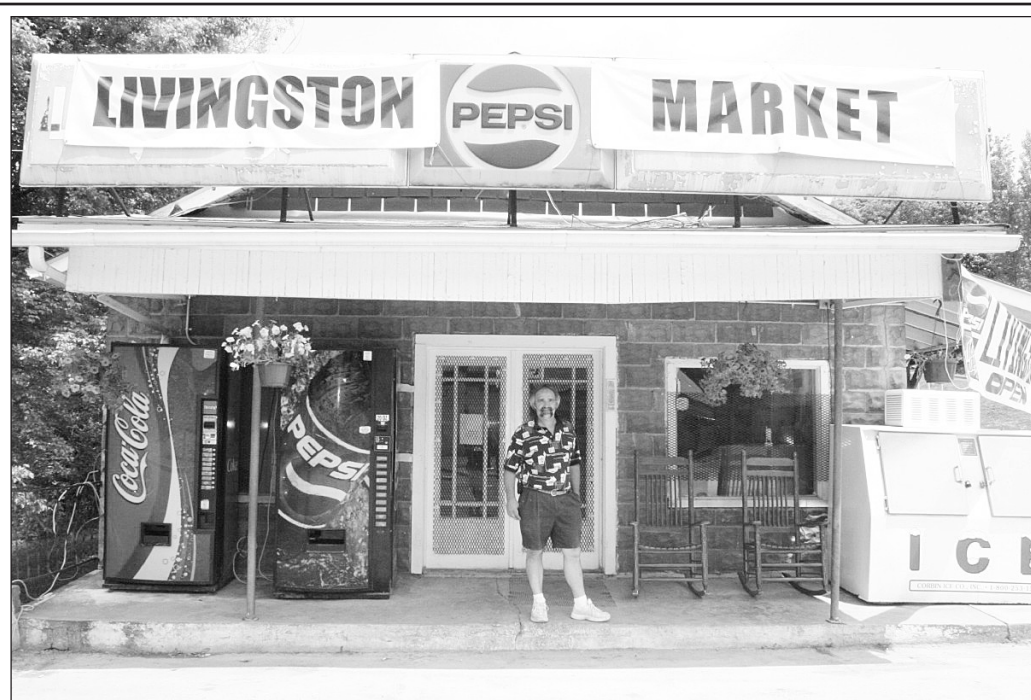
Most abusers are not killers, but a few of them are. It is difficult, if not impossible, to predict ahead of time which ones will kill and which ones will not. Even a professional who deals with abusers all the time has difficulty making this prediction. This means that anyone who has a relationship with a violent person is in danger.

Lori is lost to her family and friends and especially to her son. She told me she wanted to warn other women to be careful. She and I were going to write a newspaper article about her life. Unfortunately, that article has to be written after her death.

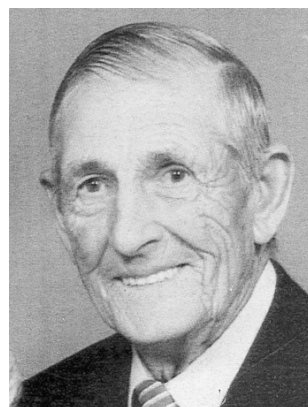

Fiscal Court ok's financial help for purchase of new Livingston fire truck

At a special called meeting last Thursday, the Rockcastle County Fiscal Court approval a request by the Livingston Volunteer Fire Department to help them acquire a new fire truck.

The truck, a 1995 International tanker, will cost \$65,000 with the city's two trade-ins and the payment will be around \$700 a month for 10 years. The city will pay half the payment and the county half.

Magistrate Ralph Allen made the motion and Magistrate William Denny seconded the motion with all voting yes.

The city also approved a contract with the state for resurfacing of old 25, from Elmwood Cemetery to U.S. 25, a total of 6/10ths of a mile.

Magistrate Ralph Allen said he thought the slippage on the road had stopped and that he had been trying to get the road repaired for some time.

\$70,000 has been allotted by the state for the project.

Also during the meeting, the court had to amend Sheriff Mike Peters' 2007 budget in order for him to get an interest-free advance from the state for operation of his office, until tax receipts begin to come in the latter part of the year.

The county's preliminary budget for 2007-08 was also

presented to the court by County Treasurer Joe Clontz.

Although the budget will require tweaking before final passage, preliminary figures show expected revenue in the general fund of \$1,279,995, including an estimated \$75,000 carryover from 2006-07; \$1,170,450 for the road fund, with a \$125,000 carryover; \$895,204 in expected revenue for the jail and \$231,250 for the Local Government Economic Assistance Fund. Other expected revenues include: Forestry fund, \$1,920; fairground, \$19,500; Economic, \$3,150; 911, \$188,10; CERT fund, \$1,665; LEPC, \$1,950 and \$200,280 in the CSEPP fund for a total county budget of \$3,993,464.

Estimated expenditures in the general fund include \$739,522 for payroll, insurance, election expense and courthouse and annex maintenance. Debt service for 2007-08 is estimated at \$71,550 and there is included \$105,413 as contingency fund for transfers.

The road fund's expenditures include: \$625,500 for payroll, equipment, road maintenance materials, etc. County Judge/Executive Buzz Carloftis commented during the discussion that the road department was having to do less maintenance because the road department was getting the road system in much better shape. "We are just now beginning to see the fruits of our labors over the last 10 years in getting our roads and buildings in much better shape," Carloftis said.

The road department's budget also includes \$207,855 for debt service for bridge construction and road improvements.

Included in the road department's budget is \$208,845 as a contingency fund for transfers.

Jail fund expenditures includes \$444,228 for payroll, training and medical personnel; \$168,000 for food and \$105,863 for debt service.

All five Rockcastle County Schools have site based councils in place for the next school year, including the Rockcastle County Middle School, where a fire occurred in April before elections were scheduled to be held.

At Rockcastle County High School, teacher members for next school year are Roy Reynolds, Glenna Carter and Janet Wells. Parent members are Susan Jordison and Jeff Laswell.

The council at RCHS meets the fourth Wednesday of each month at 3:30 p.m.

At the middle school, teacher members are Pam Martin, Tammy Gabbard and Marquita Mink. Parent members are Diane Walker and Susan Jordison, who also was elected to the high's school council.

The council meeting at RCMS is the first Wednesday of each month at 3:30 p.m.

The new council at Roundstone Elementary School is comprised of teachers, Michelle Adkin, April Hudson and Renee Burdett. Parent members are Rebecca Neely and Twila Burdette.

The SBDM meeting at Roundstone is held on the first Tuesday of each month at 4 p.m.

The regular monthly meeting is the third Thursday at 3:30 p.m.

"I told the parents I would file charges if they wanted to but, after the carnival worker apologized to the child, parents and committee, no charges were brought," he said.

All advance tickets which had been purchased for the carnival are also being refunded.

Those with tickets should take them to city hall for a full refund between 10 and noon and 1 to 3 p.m., Monday through Friday.

Children and parents who showed up for the free rides for kids 10 years and under on Saturday at 11 a.m. were given a full day pass for the Little World's Fair in August on Kid's Day to make up for closure of the carnival.

"We hate that we had to shut the carnival down but we all thought it was in the best interests of everyone and we hope people understand," Bussell said.

79-year-old earns bachelor's degree in industrial arts

Local man graduates from Berea College after 43 years

79-year-old Bill Cass received his industrial arts degree during the 135th commencement ceremonies at Berea College last Sunday. He left Berea College 42 years ago, one class short. He had failed accounting. But this spring, 79-year-old Cass took accounting again, and this time, he passed it.

Cass graduated Sunday and received his degree along with classmates that were a little more than a quarter of his age. Unlike the other graduates, he doesn't plan to do much with his degree, besides hang it on a wall. When he returned to school this spring, he said he found accounting to be harder than his first attempt. He's blind in one eye and has a hard time reading. His hearing is bad, and he's had three strokes. Cass said he couldn't have completed the class without the encouragement he got from others. "Everyone has done everything they could to help me," Cass said.

Once out of high school, Cass went straight to work and was involved in many different industries over the years: truck driving, tobacco and soybean farming, teaching welding and machining at various area schools and colleges and

timber cutting. He also served overseas in the Air Force as an airplane technician and welder. In 1964, Cass was one class short of earning his degree after starting college in 1958 at the age of 30.

Unable to receive his degree, Cass went back to work and started his own machine and welding company in Brodhead, Cass Metal Products, Inc. After many successful years in the business, he sold the shop, ventured into other business endeavors and in the late 1980s, moved to Florida.

After returning to Kentucky in 2003, Cass noticed a sign in Mt. Vernon that read, "free computer classes." He contacted the Christian Appalachian Project, the organization that was offering the classes, and before he knew it he became part of the "Over 65 Computer Club" and was blogging, e-mailing, and trading stocks online. "There's so much a person can do on a computer—I want to learn more," said Cass.

Christian Appalachian Project's adult education computer teacher, Keith Gilbertson, encouraged Cass to go back to college. "What's so interesting about Bill is not just his return to college, it's his old ties to CAP," explained Gilbertson. "He helped CAP when he became friends with our founder, Fr. Beiting, while helping him build a church in Mt. Vernon and working together to secure jobs in for Rockcastle County residents. Things have come full circle and it's now CAP's turn to help Bill."

Cromer says summer trips can also be education. "Check a bookstore or the internet for fun educational games for traveling," she says. "Even if your family cannot afford a big trip, you can visit the nearby state parks for educational fun, such as hikes or nature walks."

Families can take advantage of the more relaxed summer pace and spend time together. It's an opportunity that will bring benefits for many years to come.

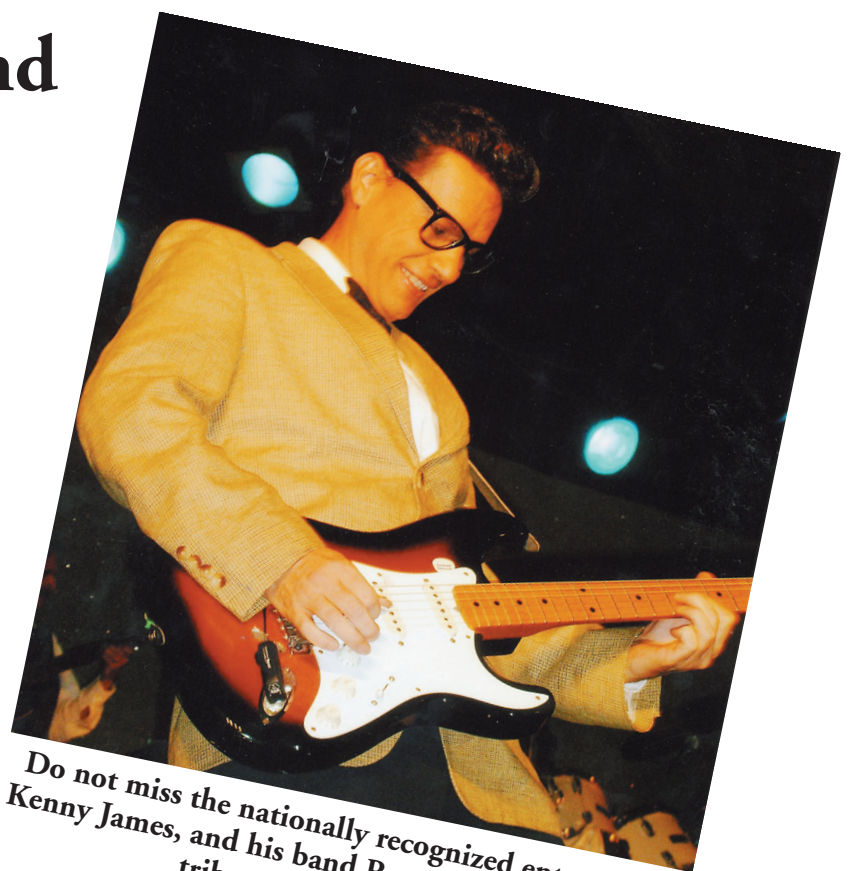

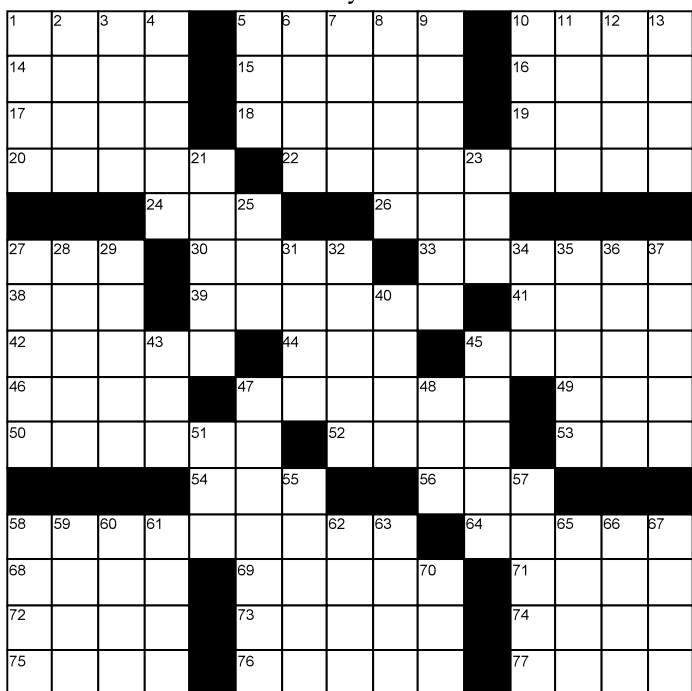

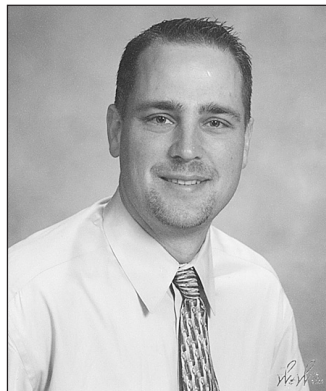
