When Roundstone Elementary School students return to school on August 9th, they will find a new gymnasium at the rear of the school, which completes a \$3 million renovation and building project at the county's oldest elementary school. The project, which began in June of 2006, included the complete renovation of the school's heating and cooling system at a cost of \$1.2 million and gymnasium at a cost of \$1.8 million. Superintendent Larry Hammond said Wednesday that renovation work, after the fire, at the Rockcastle County Middle School is still on track and he expects to be able to start school on the 9th of August. Hammond said there was still a tremendous amount of work and cleaning to be done, but he has been told it was "doable".

Two charged with stealing military grave markers

Two Brodhead residents are behind bars this week after they apparently stole military grave markers from Piney Grove Cemetery.

According to Rockcastle Sheriff Mike Peters, Timmy Whiteshell, 35, and Janet Michelle Duncan, 37, both of Wallin Street were charged with stealing five bronze/brass grave markers and selling them on June 30th.

Peters said his office received a complaint on July 2nd, that five grave markers, belonging to U.S. veterans, had been stolen from the cemetery.

The Sheriff said that after

At Tuesday's Fiscal Court meeting

Some happy, some upset over roads

Two groups were before the Rockcastle Fiscal Court Tuesday requesting road work -- one went away relatively happy while the other went away not so happy.

The first group, from the Believers House of Prayer on the Scenic View Road, asked the court that the road be blacktopped since gravel wouldn't stay on the road land cars would bottom out while traveling on it.

The group said they had been asking for blacktop for seven years to no avail. Magistrate Jan Stevens, in whose district the road is located and who took office in January of this year, said "I was asked to choose three projects and your road was first on the list, now we just have to get the blacktop out of the judge."

County Judge/Executive Buzz Carloftis quickly re-

sponded, "and I have to get the money from the state." Carloftis went on to explain that after the magistrates submit their lists of projects, the state reviews them and then decides which projects are funded. Even once this is done, "We are at the mercy of the contractor, who has twelve months to do the work," Carloftis added.

Since the project is on the list to be submitted to the state, the group went away relatively happy. Such was not the case with Robert Smith and Cecil Clark who have a blacktopped road, Anglin Falls Road, but the blacktop has broken up and needs repair badly, Smith told the court.

However, Smith has been asking for the road to be repaired since October of last year and couldn't understand why it has not been done. That

is where Judge Carloftis's explanation of "at the mercy of the contractor" came into play again.

Carloftis told the men that "there has not been a blacktop truck in the county since last October and the county has no control over when there will be one."

"Greer, who has the contract

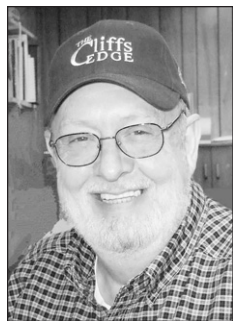

Rockcastle Memories

My brother Al recently sent me a photograph of our grandparents' house that was probably taken in the late 20's. The picture reminded me of the porch swings that were strategically placed on the corners of the old home place. Some of my fondest memories as a youngster involve sitting on one of the swings.

The swings were hung suspended from large hooks mounted into the ceiling rafters. The floor of our porch was painted battleship gray with assorted potted plants adorning the area. On one end, Morning Glory vines formed a wall of sweet smelling flowers that also served to shade the swing.

A porch swing has a certain charm that cannot be duplicated by any other place in or around the house. My grandparents had swings for as long as I can remember. The porch was the gathering place for the entire family.

My grandmother (Mommie Katie) and my mother spent countless hours in the swings while breaking beans, shucking corn, and preparing apples for drying. They also gathered with other ladies of the community to prepare quilt squares and to discuss the news of the area. I can remember Mommie Katie's friends Charity Barnes, Studie Carter, and Ollie Helton spending time together on that wonderful porch.

In those days we had no air conditioning, and on hot, muggy summer nights we migrated to the swing for relief. Mommie Katie served glasses of cool iced tea to us. We sat together listening to the bullfrogs, the crickets, and the whippoorwills in the distance. On some nights, when it was extremely hot, I remember seeing Pop sitting alone on the swing in his underwear.

Because children of the community gathered in our

yard to play at night after supper, their parents sat on the porch in rockers near the swing and supervised our play. The men talked as they whittled and piled up shavings for my grandfather to sweep up the next morning. The women discussed their favorite recipes and talked about their flower gardens.

And good ole Mommie Katie -- she kept an eye out to determine when the children were working up a sweat. Without a word, she would slip away from the group and go into the house to prepare iced-cold Kool Aid for us to drink in the yard. Nothing better to a hot kid than a refreshing glass of sugared water!

When I was a little older (probably about 10), my friends and I became somewhat bolder in our time in the swing. We concluded that if we could swing higher and faster, we could actually jump from the swing into the yard -- which was about four feet from the ground. Pop only had to see us attempting this dangerous feat one time, and he promptly put a stop to our antics.

As a teenager in the late 50's, I spent lots of hours sitting in the swing with my transistor radio. If it was cool outdoors, I took the pillow from my bed and reclined in the swing while listening to WAKY radio and the sounds of Elvis, Roy Orbison, or Johnny Mathis.

In the 60's, when I started to drive, I remember sitting with a "special" girl on her front porch. There was something unique about spending time with a girl on her front porch. And it seems to me that parents must have thought that the porch was a safe place for their daughter to be with a boy. But I can assure you that occasional kisses could be stolen in

Precautions Prevent Drownings

Having fun can be more dangerous than you think. Swimming, fishing, and cooling off in pools is great relaxation, but drowning is the fourth most common cause of accidental deaths, and in children under five it is the third most common.

Many drownings can be prevented since 90% occur within ten yards of safety. Most occur in swimming pools, but in younger children, drownings can occur in bath tubs, hot tubs, and even children's wading pools and partially filled pails.

There are several factors that contribute to drownings. In younger children, lack of supervision is a major problem. The time spent on such minor distractions as phone calls, checking on meals, or visiting with neighbors, is all it takes for a young child to get in trouble.

In older children and adolescents, lack of judgment is a primary factor. Many are overconfident of their abilities or endurance, dive carelessly, and attempt to do more than they are able to do. Peer pressure often plays a role in risk taking. Another dangerous practice is to hyperventilate to allow longer breath-holding under water. This can cause a person to pass out before there is a stimulus to breathe again.

In adults, alcohol plays a major role. About a third of drownings involve alcohol. Alcohol and water sports simply do not mix.

Everyone involved in water sports should be trained in life-saving and basic cardiopulmonary resuscitation in case of emergencies. These courses are available through most hospitals, educational facilities and other organizations.

Win or Lose, You Still Pay

A vexing issue for many litigants is often one of the simplest to answer: "Who pays my legal bills?" Well, you do, generally speaking, even if you

win and even if the other side didn't have a leg to stand on. So if you prevail in litigation and receive a \$2,500

judgement, and owe your attorney \$500, that's great . . . a \$2,000 net award. But, if your lawsuit nets you \$2,500 in damages, and you owe \$3,000 in fees to your attorney, that's a net loss of \$500, even though you were right to begin with. The explanation for why this is so is much harder to explain.

In 1993, prolific legal author and associate professor of law John Vargo recounted the story of William Hughes, a patient who died following gall bladder surgery. Hughes' widow filed suit for malpractice, prevailed at trial and was awarded \$396,000, but then lost on appeal. The appellate court reversed the trial judg-

ment and ordered Ms. Hughes' to pay the physician's legal fees of \$144,000. Coupled with her own legal bill of \$146,000, poor William Hughes' widow was stuck with a \$290,000 legal debt in addition to losing her husband and the \$396,000 in damages.

The "American Rule" first described above, provides that each party, with a few exceptions, bear their own costs. Poor widow Hughes, however, lived in London, and the "English Rule" provides that the losing party is usually responsible for the prevailing party's legal fees.

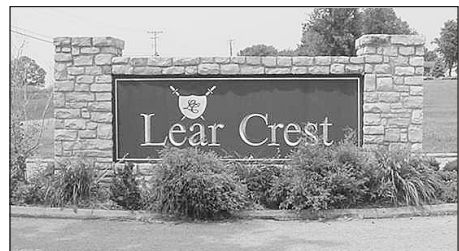

"All of the inductees into the Hall will tell you they are honored, but it was obvious how much it meant to him to be inducted," Lawson added.

Randolph last performed in Rockcastle County in 2005 when he was the keynote speaker at the Rockcastle Farmers-Business Banquet.

Before that he performed at the Hall of Fame's grand opening in 2002 and then again at Renfro Valley in 2004 and 2005.

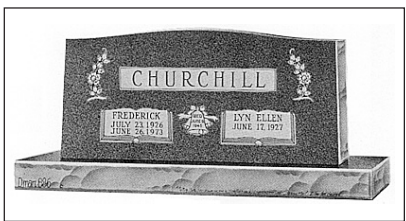

veloped in colonial times. Attorneys in early America were subject to strict controls on their fees and in many cases were prohibited from receiving any payment for their services. As Professor Vargo explains, as attorneys began to free themselves from legislative constraints regarding legal fees, they began to adopt the same free market approach which was developing in other economic contexts. At the same time, the law continued to limit the amount of legal costs which could be recovered by the victorious litigant.

Proponents of the American Rule suggest that imposing a “loser pays” rule would severely limit access to justice. Potential litigants might be discouraged from pursuing meritorious claims simply because of the possibility of losing always exists, and the result could be a crippling judgment requiring satisfaction of the winner’s entire legal bill. Wealthy litigants would always be at an advantage over the “little man” because they can afford not only the best attorneys, but they can afford to absorb a loss. Moreover, it can be difficult to determine just what the unsuccessful litigant should pay for. Did the winner really need two lawyers, or only one? And what about those cases where no one really wins? Sometimes a party may prevail on a principal claim, but lose a counter or cross claim.

Those who object to the American Rule point to congested court dockets which are sometimes overflowing with frivolous claims. They contend that the American Rule encourages litigation by not creating an incentive to terminate non-meritorious litigation. After all, if you lose and only have to be responsible for your own costs, you might be more likely to continue or extend litigation which has little or no chance of success. Requiring these litigants to pay the prevailing party’s costs would discourage abusive litigation. In addition, allowing the winner to recover expended legal costs truly makes him or her “whole” af-

ter suffering a cognizable injury occasioned by the fault of the losing party.

The American Rule does have some exceptions. Certain statutes authorize the recovery of attorney fees (such as divorce cases or civil rights violations); some contractual obligations authorize an award of fees for the prevailing party; and in some extremely unusual cases where bad faith exists, courts may award attorney fees as a sanction.

The Kentucky Court of Appeals just recently affirmed the validity of the American Rule in a case involving a \$8,000 award of attorney fees arising from an estate case. By limiting the recovery of these fees to the monetary judgment obtained against the party who wrongfully used funds from the estate, a mere \$3,800, this case emphasizes the seemingly harsh result that can sometimes result from application of the rule.

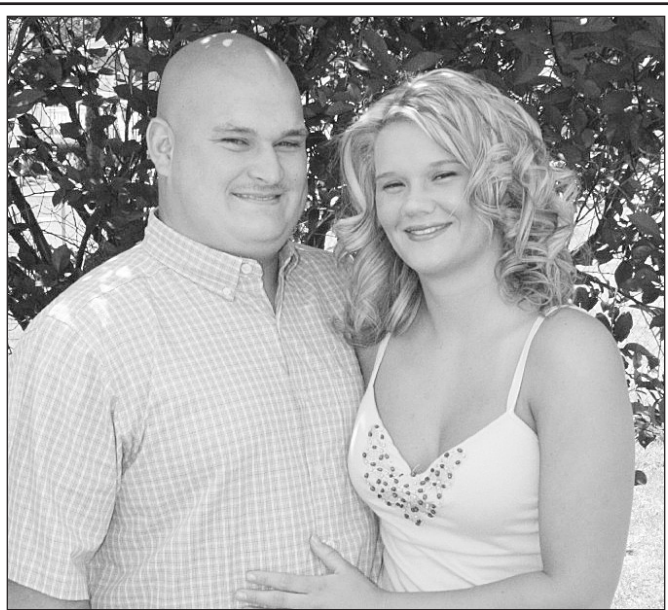

Agricultural News

July 16th Final Acreage Reporting Date

Farm Service Agency (FSA) reminds agricultural producers of the acreage reporting requirements that must be met prior to receiving program benefits. Filing an accurate acreage report for all crops and land uses, including failed acreage and prevented planting acreage, can prevent the loss of benefits for a variety of programs. July 16th is the final date to certify all crops, except small grains.

Producers must report acreages to maintain eligibility for Price Support Programs, Noninsured Crop Assistance Program (NAP), Conservation Reserve Program (CRP) and Direct and Counter-Cyclical Program (DCP). All cropland on all farms must be certified to remain eligible.

Additional information is available at your local county FSA office.

2007 COC election

On June 15th the 2007 COC nomination period began. Nomination forms will be available to nominate a person for the COC in Rockcastle County in LAA #1. LAA 1 area includes the western section of Rockcastle County bound by Pulaski, Lincoln and Garrard County. Highway boundaries are Hwy 70, Hwy 150, I-75 and Hurricane School Road.

This area is currently represented by Gary Burdette. So get your thinking caps on—maybe you're interested in running for the office or maybe you know someone you wish to nominate. COC terms are for 3 years and a total of 9 years may be served pending re-election.

Committee members are critical to the operations of FSA. Members apply their judgment and knowledge to provide local input on Commodity price support loans and payments, Conservation programs, Incentive, indemnity and disaster payments for some commodities and Emergency programs.

FSA needs 2 or more people to be nominated for placement on the ballot. The one receiving the most votes will serve as the COC member and the second person will serve as the alternate. The USDA issued guidelines for ensuring that FSA committees

fairly represent the agricultural producers of a county are designed to increase participation by minorities and women.

August 1, 2007 is the last day to file nomination forms at the local USDA Service Center.

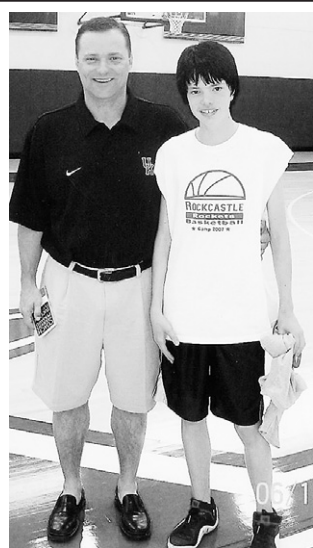
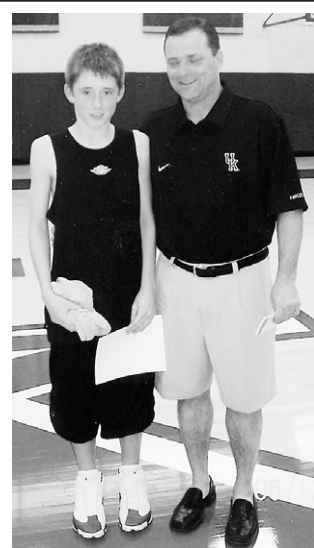

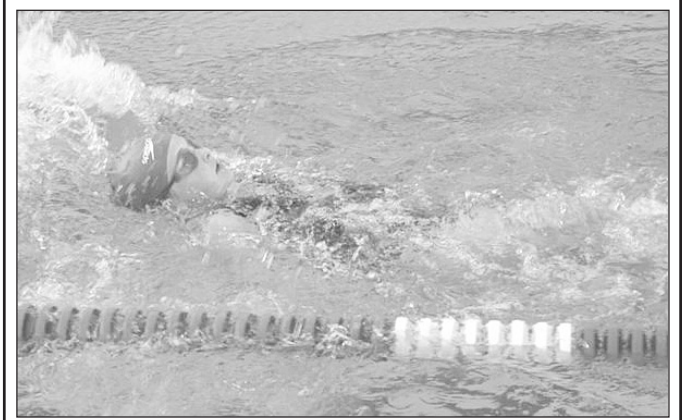

Special Session Week in Review

A special session of the Kentucky General Assembly called by Gov. Ernie Fletcher was in limbo at week's end, with one chamber of the Legislature adjourning and the other chamber continuing with its work.

The House of Representatives convened for the session's first day Thursday afternoon as scheduled, but adjourned in short order without taking up any of the 67 items -- including tax incentives for coal-conversion plants and other alternative-energy initiatives -- that the governor had included on his special session call.

House leaders contended the session was unnecessary, saying none of the governor's issues represented an emergency justifying the expense of an extraordinary session, and action on the package could easily wait until the next regular session convenes in six months.

Senate leaders, however, urged the House to reconsider their action, which they called unconstitutional. They vowed to continue working, saying they would proceed with committee hearings on proposed legislation in hopes the House would reverse itself and return to Frankfort by Monday -- at which time the Senate would decide what approach it will take in regard to the remainder of the session.

In fact, the Senate Agriculture and Natural Resources Committee began discussions Friday on Senate Bill 1, legislation that would provide tax incentives to coal-to-liquid, coal gasification, biofuel, and renewable energy facilities, as well as carbon dioxide pipelines. Such projects, now in the planning stages by several national energy companies, could bring significant jobs and economic development to Kentucky if the companies choose to locate here, supporters say.

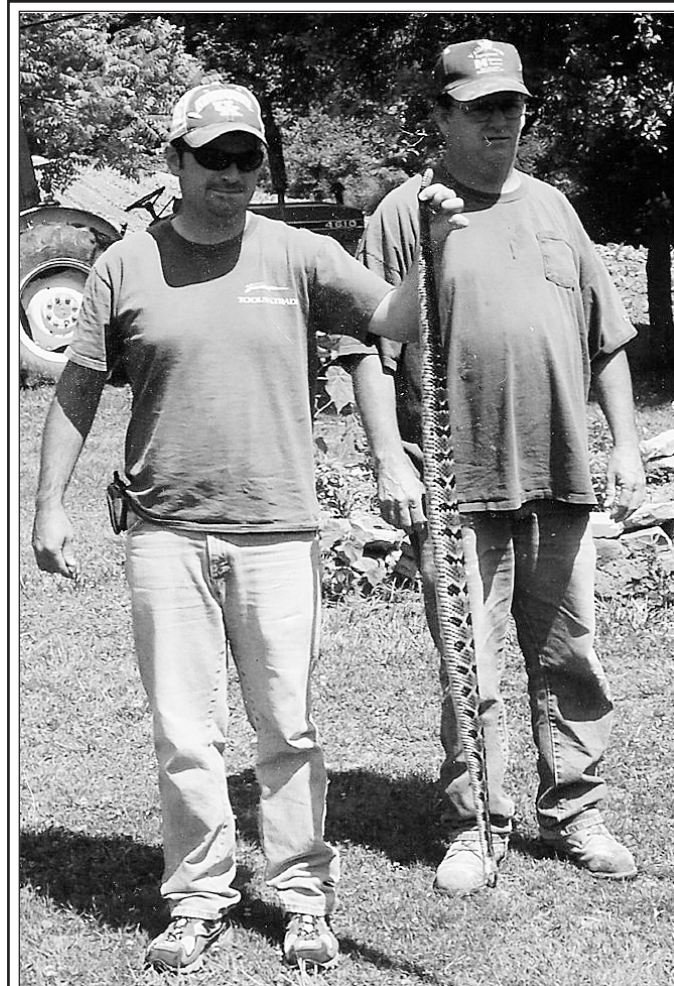
The governor spoke at the committee meeting in support of the energy bill, considered the centerpiece of his session agenda. That agenda also includes bonding authorization for dozens of capital construction projects statewide, a tax

Other items on the session agenda include \$360 million in bonds for projects the governor had previously vetoed, authorization for seven state-funded universities to construct 16 buildings, and renovations to locks and dams on the Kentucky River.

The governor has also called for \$67.5 million in additional bonding for projects such as a new outdoor stadium at the Kentucky Horse Park to host the 2010 World Equestrian Games, expansion of a runway at Blue Grass Airport where 49 people lost their lives in a passenger jet crash last year, and funding to help Centre College in Danville secure a presidential debate next year.

On Friday, Senate committees with jurisdiction over items on the session call announced meetings for Monday, and the full Senate will convene at 2 p.m. that day. For a complete schedule, go to http://www.lrc.ky.gov/legislative_calendar/index.aspx

The Family Room

Domestic violence is, unfortunately, not a rare occurrence. Travel with me to Bethany House Abuse Shelter today, and you will find twelve women, one man and several children who have sought shelter from their abusers. There are many more who are receiving some kind of aid from Bethany House but do not reside there. There are many victims who are sheltered by family members, and some who have not sought help because they do not know it is available. One statistic was shocking to me: each day in the United States three women are killed by a boyfriend or spouse. That adds up to more than 1300 for the year. A woman is in more danger of being hurt by her boyfriend or spouse than she is by a stranger!

One myth about domestic violence is that it is rare. There are other myths.

1. ADomestic violence only happens to women in poverty. This is simply not the case. Women of all economic levels are victims of violence. Women with financial resources may seek help in different places than women in poverty, but all experience the same problem.
2. ADomestic violence only happens to women. Not true. Men are also victims of violence by a spouse or girlfriend. Probably about 5% of all violence is by females. Men are very reluctant to seek help for this problem because they think it makes them look less of a man to admit to being a victim of violence.
3. AWomen who stay in abusive situations like the abuse. Women who stay do so for many reasons, but I have yet to meet one who likes being abused. They stay because of fear, lack of financial resources, desire for a two-parent home, a belief that divorce is never the right thing to do

and other reasons.

4. AA woman must do whatever the husband demands because he is the head of the house. Some abusers quote Scripture to their mates to back up their controlling behavior. In no way does God desire for his children to live in abuse. No Scripture commands that a woman give in to all her husband=s demands.
5. AChildren who grow up in abusive families become abusers. This is simply not true for everyone. Yes, some children from abusive homes do become abusers when they reach adulthood. Others become victims of abuse, and others become neither. Children are affected by the abuse they see and hear, but not every child is affected in the same way.
6. AAbusers can change just because they want to. The promises of an abuser to change should be greeted with skepticism. They are human like the rest of us, and when was the last time you made a major behavioral change in three weeks? Most change takes much longer. Abusers who want to change should seek counseling and medical help, and they should expect to work at changing for several years.
7. AEveryone knows who the abusers are, because they have such bad reputations. Some abusers are considered upstanding citizens by those who know them. They may be doctors, ministers, lawyers, businessmen and leaders in their churches and communities. Both the abuser and his spouse hide the abuse. One may live in your neighborhood.

How to stop illegal immigration

By U.S. Rep. Hal Rogers

With regard to our nation's illegal immigration problem – it's pretty simple – stop them at the border! The solution is not to give amnesty to those who broke our laws by crashing the gate.

That's why I joined 113 of my fellow colleagues last week in voting for a resolution opposing the Senate Immigration Bill that would have given such amnesty to 12 million illegals. Before we can reform immigration in a real way that protects our citizens, the government needs to prove to the American people that it can get the basics right, starting with securing our borders.

The American people and the House resolution sent a clear message to the Senate that their immigration proposal was wrong for America. Late last week, the Senate finally voted to scuttle the immigration bill after three weeks of debate. Voting this amnesty bill down was the right move and will now focus the government's attention and resources on confronting the real problem.

Securing the borders is one of the main reasons we created the U.S. Department of Homeland Security. Stopping Illegal immigration is about much more than maintaining law and order; it's a national security issue.

Terrorists plotting future attacks in the remote places in the world are counting on our porous border to get into our country to launch future attacks. The least we can do is reduce, if not eliminate, the ease with which potential terrorists can sneak into the country. The first line of defense needs to be at the border.

And there is some good news. Launched almost two years ago, the U.S. strategic border strategy is starting to make real progress. We have ended the practice of catch and release, where illegal immigrants attempting to cross the border were let go pending a court date for which 90% fail to show. Not surprisingly, untold thousands of them disappeared within our country. Many of these people would have been allowed to stay here under the Senate bill.

While the Senate debated amnesty, our government was hard at work protecting U.S. citizens. We've cracked down on 4,300 employers who hired knowingly illegals, arresting over 1,700 people who overstayed their visas, and removed almost 190,000 illegal immigrants. These results are long overdue but remind us how much further we need to go.

Much of the credit for our recent success at the border should be given to the thousands of National Guard troops now guarding the border, many of them our neighbors in the Kentucky National Guard.

As the top member of my party in charge of border security funding, I've supported the largest investment in border control in our nation's history, allocating over \$2.5 billion on technology and infrastructure to stop illegal immigration at the border. This includes building over 700 miles of double-layered fencing along the Mexican border, but also surveillance cameras, radar, helicopters, airplanes and other such detection machinery. We've also hired, trained and placed thousands more Border Patrol Agents.

Yet, the majority party in Congress has created serious obstacles to these efforts by putting tons of red tape in place to delay or prevent these highly successful efforts. It makes you wonder whether they want amnesty for 12 million gate crashers more than stopping another 12 million from violating our laws and stealing across our border.

We are a nation of immigrants -- hard-working people who came to our country in search of a better life -- but the difference is they came here legally. They patiently waited their turn in line. If we can't control who enters our country by securing our borders, then you have to ask yourself if you truly have a sovereign nation. As we saw yet again last week with the attempted bombings in Great Britain, there are crazy people with a warped ideology who are trying desperately to get into free countries to bomb and murder innocent civilians.

Immigration reform must start with sealing our border. Perhaps then, the American people will trust their government to fix the other problems with our immigration system. Until then, the Congress did the right thing by stopping this immigration amnesty measure in its tracks.

Do you know? Heat and humidity

Summertime is here, and with that summer sun heat is something that we must deal with. Eastern Kentucky with the mountains, abundance of trees, and large lakes does not usually face the same sweltering heat of the western portion of the state, but as the old saying goes, "It's not the heat but the humidity". At times, we have our share of both.

Humidity combined with excessive heat makes the effect much more dangerous to the body. On average, about 175 Americans succumb to the taxing demands of heat every year. Our bodies dissipate heat by varying the rate and depth of blood circulation, by losing water through the skin and sweat glands, and as a last resort, by panting, when blood is heated above 98.6°F. Sweating cools the body through evaporation. However, high relative humidity retards evaporation, robbing the body of its ability to cool itself.

When heat gain exceeds the level the body can remove, body temperature begins to rise, and heat related illnesses and disorders may develop. This includes heat stress, heat exhaustion, and the very dangerous and potentially fatal heat stroke. You need to be aware of when you are beginning to approach trouble in dealing with the heat. Often, as heat stress begins to affect the body, there is a noticeable lack of energy. The air feels hot and heavy to breathe. Your face will often feel very hot; sometimes a pulse is noticeable through your forehead and temples. Your body is trying to tell you to cool off now, before core body temperatures climb higher. Ignoring these initial symptoms will lead to nausea, impaired judgment, dizziness, skin becoming cool and moist to the touch, weak and rapid pulse -- all signs of heat exhaustion. Without intervention and cooling the body, progression to heat stroke, with a very high death rate, will follow.

Anyone can suffer from heat related illnesses, but by taking a few simple precautions, they can be prevented. First, keep informed with the forecast, including information about the expected heat index. Condition yourself for working in hot environments; start slowly and build slowly to more physical work. Drink lots of liquids, but avoid caffeine and alcohol. Take frequent breaks, and if you start feeling overheated or getting a headache, cool off. Wear light-weight, light colored clothing when working in the sun, and take advantage of air conditioners.

The National Weather Service uses a "Heat-Index" to show the combined effects of heat and humidity on the human body. Similar to winter's wind chill equivalent temperature, the heat index is an indication of what the air actually feels like to exposed skin.

As a general rule, when the heat index is: 80 to 90 degrees: Fatigue possible with prolonged exposure and physical activity. 90 to 105 degrees: Sunstroke, heat cramps and heat exhaustion possible. 105 to 130 degrees: Sunstroke, heat cramps, and heat exhaustion likely, and heat stroke possible. 130 degrees or greater: Heatstroke becomes likely with continued exposure.

The National Weather Service in Jackson will issue a Heat Advisory when the heat index reaches 105 or higher that will maintain at least 3 hours during the day...with a minimum heat index of 75 at night. An Excessive Heat Warning will be issued when the heat index is 110 degrees or higher during the day with a minimum heat index at night of 75.

for the deed for the property on which the present water tank sits, about an acre. Griffin said the deed could not be located nor could it be found at the courthouse where the deed had ever been recorded.

The site will now have to be surveyed, Griffin said, and a quit claim deed prepared. The new water tank will be erected on the same site, “as close to the wood line as we can get it.”

Griffin also reported that he had been informed that the sewer plant has been under an order by the Environmental Protection Agency (EPA) to get the plant brought up to standards. He said that the plant had been inspected and he was told that it was in the “best shape it had ever been in.” Except, Griffin said, the plant must acquire a “sludge giveaway permit.” This permit will allow the plant to give away the sludge it generates and can be obtained by sending a sludge sample to a lab. Then, anyone taking the sludge, will be given a report showing what is in the sludge. There will probably be only about one load of sludge to give away the Mayor said.

Griffin also reported that the city will be mowed and cleaned, in preparation for Homecoming on Labor Day Week End, and that new American Flags will be bought for the streets from Cox Hardware.

Financially, Griffin told the commissioners that the “money is slowly coming up.” City Clerk Tammie Martin was unable to be at the meeting but left copies of the city’s bank statements showing around \$26,000 in all accounts as of the meeting date. The mayor told the commissioners that he wanted to rebuild the sewer system’s lift station as soon as he was comfortable with spending the money to do it.

Griffin said the city’s insurance went into effect the first of July but that a 15 passenger van, donated to the city by RTEC, would have to be added when the van was received.

Simpson says she thinks Cromer’s father, Carlos and others set fire to her house, which was left to her by her late mother.

However, no charges were ever filed against anyone in the fire and Simpson has taken no action to clean up the property, since the fire.

Simpson says she is financially unable to clean up the property and that she shouldn’t be required to do so because her home was burned.

Mayor Cash said he has had complaints about other properties in the city besides Simpson and believes Monday night’s action is needed.

“We need a tougher ordinance that will stand up in court,” Cash said.

Ford said he would draft an ordinance that clearly defined what a nuisance is and what will happen if a landowner is in violation of the city’s ordinance.

“The ordinance will be detailed and clear as to what should be cleaned up and what will take place if the council decides the landowner is in violation of the ordinance,” Ford said.

“It will be left up solely to the discretion of the council to determine when a property has become a nuisance. Once that determination has been made the landowner will be given notice and an opportunity to clean up their property,” Ford said.

“If the property owner does not comply with the ordinance the city will either clean up the property themselves or hire an independent contractor to do the work,” he said.

“The property owner will be required to pay for the cost of cleaning up the property and if they do not pay the bill for the clean-up, the city will take them to court and put a lien on their property,” he said.

“Once that happens the property could be sold at the courthouse steps to satisfy the debt to the city,” Ford added.

Ford said he hoped to have to ordinance ready to go into effect in late August.

Before the city can adopt the ordinance they must have a first reading, publish it in the Signal and then have another reading.

Ford said he would ask the council to call special meetings to speed up the process.

Peters said Sarah Miracle positively identified Duncan and Whitesell.

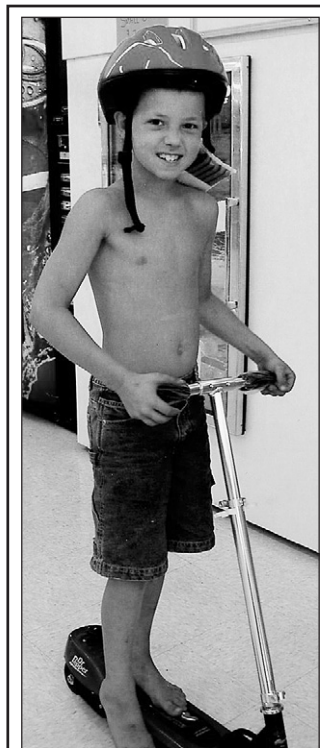

Greer has been good enough to wait some time for their money until the state gets around to paying us,” Carloftis added.

The two men were assured by Carloftis and Magistrate Jan Stevens that they would do everything in their power, short of taking from other districts, to resolve the problem.

Carloftis gave a report to the court from Jim Holton, representing the Rockcastle County

Industrial Development Authority. Bro. Chad Burdette receives Pastor's Excellence in Evangelism Award

Sweet Lord, Great Messiah/ He'll take your addictions away from you," sang the Northside Baptist Church Praise Band at the 4th annual "Freedom Celebration" at the Brodhead Fairgrounds July 1. Church members handed out free hot dogs and hamburgers to approximately 1,000 people. Just before fireworks cascaded through the evening sky, Bro. Chad Burdette preached a gospel message.

Taking church to the people is not a new concept for Northsiders who are watching their non-traditional efforts reach lost souls. At a recent Southern Baptist Convention Annual Meeting in San Antonio, Texas, Bro. Chad Burdette was presented a "Pastor's Excellence in Evangelism" award. Among 43,000 SBC churches, Northside Baptist Church in Mt. Vernon, Ky. (pop. 2,500) placed in the top 100 in baptisms. Since 2,000, the church, which began as a mission in 1959, has baptized 586 converts.

"Evangelism-telling others about Jesus-is the primary focus behind every activity of the church," said Burdette, who was called to preach while he was a patient in a drug treat-

ment facility. When he assumed his first pastorate at Northside in 2,000, the church membership had dwindled to 33. "The members expected the doors to be closed," he said. One night, he preached from the book of Numbers about how the Israelites feared taking the Promised Land because of the giants. After the sermon, 30 of 33 people present went to the altar to seek God's will. "The Holy Spirit changed the church that night," he said. "I knew God was going to do something great."

The church began to grow so rapidly that he had to preach with both doors open to accommodate the people crowded into the foyer. Soon the congregation purchased eight acres on a hill, "Faith Mountain" and built a 20,000 sq. ft. church building with a seating capacity of 800.

Northside church members recall many stories of how God has moved in unusual ways during the services. For example, a young man came forward to accept Christ one Sunday morning before Bro. Chad had reached his second sermon point. Another young man under conviction jumped the pew in front of him and ran to the

front altar to accept Christ. One Sunday morning, an older woman sat down in the church parking lot and said, "I am lost and need to be saved." But perhaps the most memorable day was a 2003 "Friend Harvest" when a former addict brought 174 of his friends to church.

If they are breathing, they are in our target area," Bro. Chad often tells the congregation. As a result, the entire congregation is involved in evangelism. On Sunday afternoon, former addicts preach at the local jail. Prisoners who accept Christ are brought to the church in chains for baptism. On their release, the prisoners are encouraged to attend church services and weekly SWAT (Servants With A Testimony) meetings for recovering addicts and alcoholics. Their families are invited to HOPE (Hearts of Peaceful Expectations). Church services are televised weekly into 38 counties in Kentucky and broadcast three times a day, three days a week within the county via closed circuit television.

The church's evangelistic focus also includes "Christian Sportsmen Fellowship," a men's outreach group that holds day-long hunting competitions. Hunting entry fees helped send over 100 children to church camp this year. Church meals also support evangelism since members a small fee for the meals that is used to fund missions. This year, the church sent 10 men to Brazil and a youth mission team to Michigan.

Facing the outreach giants may cause fear in the hearts of many church members, but Northsiders seem ready to accept any challenge. For example, in 2005 the church sponsored a huge three-ring circus, complete with elephants, giraffes and clowns. The event drew appx. 2,000 people who listened to Bro.

Chad present a gospel message before the circus acts began.
