## Parent criticizes football coaches

Alicia Davis, a mother of a former Rockcastle County High School football player and her mother, Mildred Smith, were at the Rockcastle County Board of Education meeting on Tuesday night to complain about a situation they say occurred on July 12th.

Davis told board members and Superintendent Larry Hammond that her son, a senior on the football team, had gone with the team to a passing camp in Breathitt County last month and that because other players were drinking and making loud noises he could not sleep and wanted to come home.

Davis said her son called her from Breathitt County and asked her to come and get him

Cash will replace Ernie Moberly, who was appointed to fill the unexpired term of Marvin Owens.

Owens was elected last November, but could not serve because he was already Rockcastle County Deputy Coroner.

County Clerk Norma Houk said Cash would take over for Moberly in November as soon as she certified the election.

## Tax rate would more than double

## 3,000 signatures needed so library board can obtain additional funds

The Rockcastle County Public Library Board of Trustees has organized a petition drive, which, if successful, will

generate tens of thousands of dollars of additional funding.

According to board chairman Becky Isaacs, the local library has the lowest library tax rate in the state, which has hindered the local board in providing the best possible services to the citizens of Rockcastle County.

The library board is asking for an increase of 2.6 cents per \$100 of assessed value from the current 2.2 cents, for a total tax of 4.8 on both real estate and personal property.

The 2.2 real estate and personal tax rate currently gener-

ates just over \$85,000 a year and the increase will add an additional \$82,000 a year to their coffers.

After receiving their tax money for tangible property and the tax on motor vehicles, the library receives about \$98,000 in tax money annually.

If all goes according to the board's plans the library board will have about \$180,000 per year to operate on.

Isaacs said the additional funding does not guarantee a new building but it is essential

## Rockcastle man killed in traffic accident in IN

A Rockcastle County man died after a train smashed into the side of a tractor-trailer he was driving Friday morning near Terre Haute, IN.

Jeffrey Allen Pennington, 35, of Mt. Vernon was traveling north on Indiana 63 when he attempted to cross a set of railroad tracks and was struck by a northbound train around 10:30 a.m., according to a published story from the Terre

Haute, *Star Tribune*.

Upon impact, the saddle tanks on the tractor-trailer exploded.

Police said they did not know how fast the train was traveling when the accident occurred, but it was unable to stop

## Barbara Bishop found Tuesday in LaFollette TN

A Rockcastle County woman was found Tuesday afternoon in a rural area near LaFollette, Tennessee after she had been missing for two days.

According to family members, Barbara Ellen Bishop, 64, was found by CSX Railroad employees around 3 p.m. Tuesday, lying near a railroad track in a rugged area close to a strip mine, just off U.S. 25.

Angie Bishop, Barbara's daughter-in-law, said her mother-in-law was barefooted, scratched up and was extremely dehydrated when Sheriff and EMS units arrived at the scene.

Angie Bishop said the CSX employees had seen her mother-in-law sitting by the tracks when they went down the track on their morning run and that, when they returned for the afternoon run, Barbara Bishop was lying on the ground and that is when they notified authorities.

Barbara Bishop was taken to the St. Mary's Medical Center in LaFollette where she was treated and where she remembered a phone number. Barbara Bishop suffers from episodes of Alzheimers.

Angie Bishop said her mother-in-law told authorities she was Barbara Lake and that she had finally remembered her home phone number.

"They called the house and

Chris, one of Barbara's sons answered the phone," Angie Bishop said. About 90 minutes later the family arrived in LaFollette.

Angie Bishop said when they arrived they learned that Barbara's purse was missing, along with her 1999 Oldsmobile Intrigue.

"We searched the area where they found her, but we didn't find anything - of course the police are still looking for the vehicle, but we haven't heard anything," she said.

The ordeal for the Bishop family began Sunday afternoon after Barbara did not show up at the home at her son Shannon, said Angie, who is Shannon's wife.

Angie said her mother-in-law had been visiting a grandson with her two daughters and, after they returned to a

It will take more than an Act of Congress, possibly an Act of God to elect a woman or an African American as President of this great country.

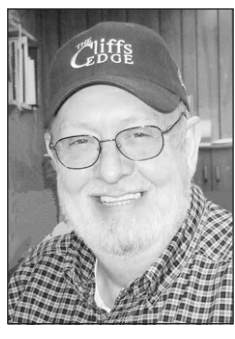
The Republican polls may be even more out of the ordinary. Even at times when their policies were under national criticism, Republicans have run on a platform of values and they have been successful in doing so.

# Rockcastle Memories

A few weeks ago, my wife and I spent a Sunday afternoon enjoying a picnic at Calk Lake in Montgomery County. The private lake is located just over the Powell County line off KY 213. We spread our lunch on a picnic table under a large oak tree overlooking the lake. As I tasted the Colonel's chicken, mashed potatoes, and biscuits, my memories carried me back to my youth and my first recollection of being on a public lake.

When I was just a boy, my brother (Al) took me and several of his teenage friends to Gwynn Island to spend the afternoon swimming in the pool. In those days, we had three choices for public swimming pools - driving to the city pool in Somerset, the Sunnyside Pool in Danville, or Gwynn Island on Herrington Lake.

There is a direct connection between Mt. Vernon and Herrington Lake. The Dix River originates in Rockcastle County and flows northward through Lincoln County, where it is impounded to form Herrington Lake along the Garrard-Boyle County line. The lake is a 2,335-acre artificial lake located in Boyle, Mer-

cer, and Garrard counties. It was created in 1925 by Kentucky Utilities to generate electric power. With a depth of approximately 250 feet, the lake is the deepest in Kentucky.

One of the exciting things about swimming in the pool at Gwynn Island had to do with how it was constructed. The pool was part of the lake. It was built out of wood, and the boards were spaced far enough apart to allow small fish to enter the swimming area. The pools were created by large floating barrels and huge pieces of Styrofoam. There were three of them positioned side by side - two for diving and adult swimming and one for the children.

A concession stand near the pool sold candy, chips, sandwiches, and a variety of soft drinks. After a few hours of jumping in and out of the water, Al took me to the counter and fed me hotdogs and chips for my lunch. I thought I was something special spending time with the teenagers. The girls paid me lots of attention, and you know I loved that.

When I became old enough to drive, my friends and I trav-

# Preventing Constipation

Constipation is a common nuisance affecting millions of Americans. Preventing constipation is also important for medical reasons. Studies show that a person can decrease the risk of colon cancer by having regular bowel movements with fiber or bulk-forming laxatives, probably by more quickly eliminating any cancer-causing chemicals.

There are numerous methods of preventing and treating constipation. The first is by developing good bowel habits and a routine time to use the bathroom. Another simple measure is to increase the amount of water you drink. Physical activity is also helpful. Try to walk routinely or develop some other sports interests.

Good dietary habits are especially important. By eating foods high in fiber, a person will help keep his body healthy in many ways. First, fiber makes the stool larger and softer and bowel movements will be more frequent. Bulkier stools will also decrease the chance of developing diverticulitis which is a common problem as a person grows older. Other advantages of fiber include a lowering of cholesterol, a decrease in the risk of colon cancer, and a more steady rate of absorption of nutrients from the bowel. This is especially important in diabetes.

If other measures are needed, there are a variety to choose from. Some medicines, such as milk of magnesia, help draw extra water into the gut to keep the stool softer. There are "stool-softeners" and lubricants, such as mineral oil. Laxatives work by stimulating the colon to empty but they can harm the colon if used on a long term basis.

If constipation is a new symptom, you must also consider bowel cancer or other illnesses and consult your doctor.

# VIEW FROM THE BENCH

## Kentucky Lacks Critical Domestic Violence Statute

An estimated 15% of all domestic violence incidents involve the use of weapons. Research also suggests the mere presence of firearms dramatically increases the risk that a death will occur. Yet Kentucky is one of

a few jurisdictions which has yet to criminalize the possession of firearms by individuals against whom a qualifying domestic violence order has been issued, despite the oftentimes deadly results produced when batterers possess guns.

One Atlanta study indicated assaults were twelve times more likely to result in death when a firearm was present. And in a 1997 study involving homicides killed by intimates, published in the Archives of International Medicine, "such murders were 14.6 times more likely to occur in a household with a history of domestic violence and 7.2 times more likely to occur in a household where firearms were present."

Most telling, the United States Department of Justice estimates that firearms are used in 59% of all domestic violence homicides of women and 51% of all domestic violence homicides of men.

The federal government and several states prohibit the possession of firearms by those

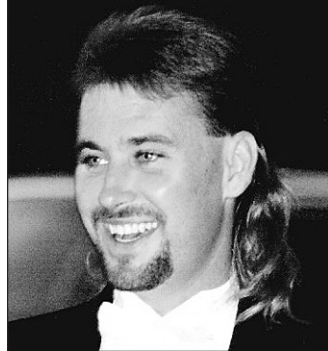

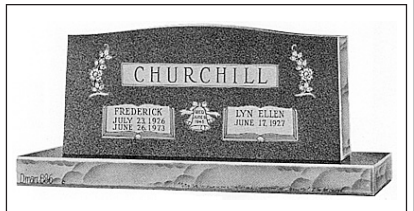

subject to a qualifying domestic violence order. Federal law makes it unlawful for any person who is subject to a qualifying court order, issued after an adversarial hearing, which restrains such person from harassing, stalking, or threatening an intimate partner, or their child, and by its terms explicitly prohibits the use, or threatened use of physical force against such intimate partner or child that would reasonably be expected to cause bodily injury, from possessing any firearm or ammunition.

West Virginia closely tracks the language of the federal prohibition. Other states adopt different language, but with the same effect. In California, persons subject to a qualifying protective order "shall not own, possess, purchase, or receive a firearm while that protective order is in effect." Delaware adopted an even more stringent approach, prohibiting possession, purchase, ownership or control of not only firearms, but all "deadly weapons" by prohibited persons. Punishment for violation of these statutes varies widely, some as misdemeanors, others as felonies.

Yet, unlike the federal government, and many states, no effective method exists under Kentucky law to enforce the terms of protective orders restraining domestic violence perpetrators from possessing firearms. While a judge may, through the exercise of its contempt powers, enforce such a prohibition, this method is infrequent, cumbersome, and severely handicaps law enforcement.

Several arguments exist in favor of the passage of analogous legislation in Kentucky, including: (1) the underlying conduct represents a violation of a state court order, issued by a state court judge; (2) state courts are better situated to fashion appropriate punishments given the inherent inflexibility of federal sentencing guidelines and taking into account the relative seriousness of the violation; and (3) federal prosecutions under existing laws are unlikely to adequately address the extent of the underlying problem. This last argument is the most troubling.

Some commentators have criticized federal authorities for not doing enough despite the tough federal statute. One domestic violence advocate concluded that "[f]ederal prosecutors have not pursued these cases aggressively. . . ." One report noted that "from 1995 through 2001, only 187 federal prosecutions were filed under [the federal statute], or about one percent of all federal firearm possession charges. Id. These few prosecutions have not come close to reaching the number of actual offenses which one respected federal judge estimated at 40,000 annually, and that estimate occurring some nine years ago. Federal prosecutors in Kentucky have done much better and deserve credit for many successful prosecutions, but violations still go undetected and unpunished.

Any legislation affecting the right of the people to possess firearms should be carefully scrutinized. This deficiency, however, is one which begs to be remedied. Notably, the National Rifle Association did not object to the federal statute earlier this year in a Texas case so

long as a judicial finding exists that past domestic violence had occurred and there was a likelihood that it would occur again in the future. With careful drafting by the General Assembly, such a statute could significantly decrease the likelihood that more Kentucky men and women will die needlessly.

A lot of things have changed since those days, even the fair. The horses have gone their way, and yielded to horses of another sort. Now there are mudslings, truck pulls, or even demolition derbies.

There were several years I didn't get to attend the fair in my adult life, but now that I've married Stanley and moved to Rockcastle County almost five years ago, we've gone most every year. Last year I even had the honor of judging two beauty pageants that were held at the fair.

I'm the Queen Mother of a Red Hat Society group, the Steel Magnolias, who meet semi-regularly. Most of us have been chasing the dream of having a scholarship pageant for the girls who live in Rockcastle County who are pursuing careers in the fields of social work, medicine, law enforcement, or education. We've had this desire for about two years or longer. This scholarship would help a local girl get a good education, and hopefully return to this area after graduation to enrich this county with her skills.

I had thought that this would be the year that we would get to give the first of what we had hoped to be an annual scholarship, but we got shot down before we even got started. We had wanted to combine the scholarship pageant with the Miss Rockcastle County Pageant, but only a local girl would be eligible for the scholarship. Girls from all over the state can and do enter the local pageant in this county. Girls go all over the state entering pageants. After a couple of years, we had hoped that it would become an independent pageant, itself. We had prior approval from the Red Hat Society, and were at the point of beginning to

solicit donations for the scholarship. It was at this point that I learned, through the pageant coordinator, we needed to get approval from not only the local pageant board, but also some group or board over them, as well. I've since been told by a very informed source that none of that was true. The pageant coordinator said that she would get "right back with me" concerning the presentation of the scholarship almost two months before the pageant date. She never did call back, or would return any of my calls after leaving numerous messages on her personal cell phone, and workplace phone. This, by anyone's standards, was not only extremely rude but also very unprofessional on a business level. I finally decided to give up, but I'm not the one who got hurt or the girls in my group. There is at least one young lady here in the county that could have had a little financial relief, had our group been allowed to help.

I do hope that, if this is the case, they will at least give us credit for the idea. I've always detested people who would jump in and claim someone else's idea for their own. They said that I'd probably never fit in here, and would always be the outsider... something having to do with people being "clannish," as they said. I can't really say if this is really true or not, but if it is there is probably a lot of pretty good folks anxious to share a friendship and waiting to be accepted. There may even be a few willing to help the community, as I was, who are being ignored.

As I said earlier, a lot of things have changed... maybe sometime, in some cases, they need to. Now I'll put away the "poison pen" and quit with the sour grapes.

# Points East

I learned, long ago, that the best way unstop a clogged up kitchen sink does not involve a commode plunger. I have resorted to such means in fits of desperation a few times and later found my self at Bluegrass Hardware purchasing new pipes and traps and such because it doesn't take much pressure to demolish the plumbing under a kitchen sink.

Nor, at least in my experience, are chemicals of much utility. The only thing I've ever seen name your favorite brand of liquid pipe opener do is make matters worse and create awful odors.

Actually, I did once use some stuff called liquid fire that lived up to it's name. This is a fine situation as far as I am concerned. I don't care who makes it as long as they make plenty of it because I keep a jar open in the refrigerator 365 days a year and my favorite way to eat it is cold, straight out of the jar. I even drink the juice it's canned in.

I messed around outside for an hour doing yard work until the sun started getting hot and when I came back in the kitchen the kitchen table was covered with quart jars of the prettiest kraut you ever saw but Loretta was fussing over the sink. Both sides were stopped up tight as a drum and I figured my day was ruined. I figured I was going to be on my back taking out the plumbing because it was obvious that much chopped cabbage had gotten into the drain.

You could have pushed me over with your little finger. There was absolutely nothing I could say so I wordlessly slinked out of the kitchen like an egg sucking dog caught with his head in the nest.

But the next time I'm in the grocery store I aim see if they will cut me a deal on a case of Arm & Hammer and several gallons of white vinegar.



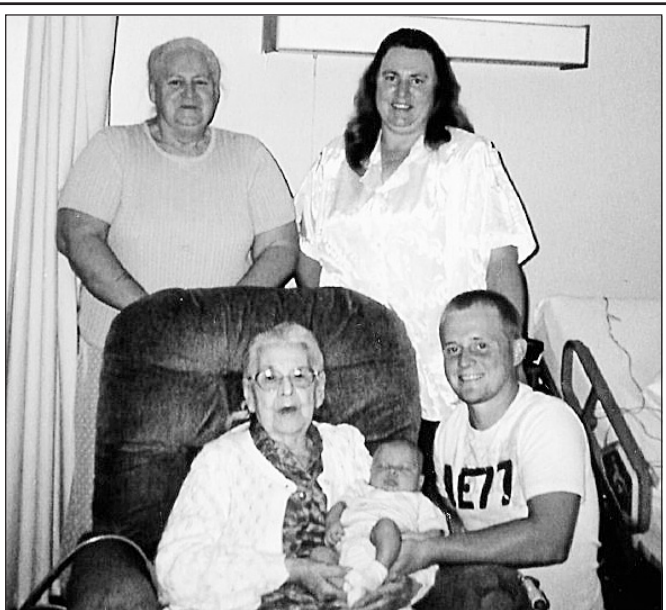

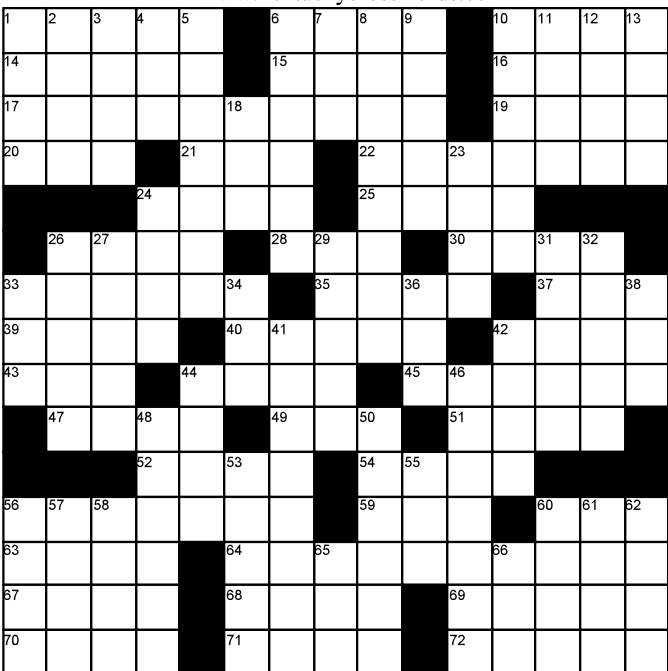

# Wildie Christian has been vital part of community since 1880s

The Wildie Christian Church traces its roots to the mid 1880's when the Kentucky Central Railroad purchased right-of-way through the Roundstone valley and local families began meeting in an abandoned railroad commissary know as Shattahan's.

Older residents remembered attending some preaching at the old Cedar Hill School on Proctor Hill and having Sunday School lessons with Mrs. Wade Jones in her home.

Land for the first church building was given by Issac and Nancy Ann Phillips in 1893, and Brother Jim Lunceford from Jackson County was credited with doing most of the building with help from volunteers. Other early preachers included Brother Green Fish, Brother

Combs, Brother Masters and Brother Belew.

Around 1910, two women from the congregation heard a young preacher in a revival in another town and like his preaching so much they invited him to come to Wildie.

Apparently both the congregation and the young man were satisfied with the arrangement and for the next 35 years Brother Willie Peal rode the train to Wildie to preach once a month for \$17.30.

Many of the older members recalled the two week long revivals held by the likes Bro. Shropshire in 1928 when 47 additions were made to the church and later on into the early 50's with Bro .E. Roy Gentry's fervent messages when 20 people at a time would

line up at the creek to be baptized.

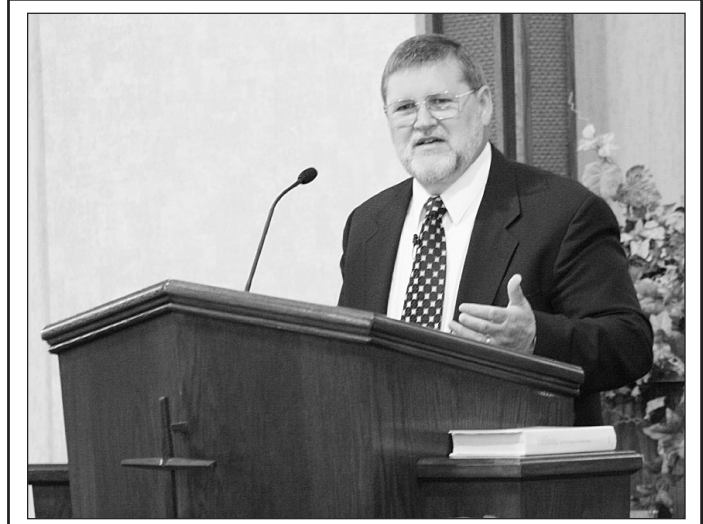
The first full time minister, Ed Simon was hired in 1952 and a parsonage was completed near the end of 1956. The congregation continued to grow under the leadership of Brothers Dean Davis, Larry Johnson and David Woods. In 1972, Kenton Parkey was called and in September will complete 35 years of ministry to the Wildie congregation.

The old building had Sunday School rooms added on to the side and later a full basement was built underneath; but as the community grew and the church expanded its need for relocation was realized and in January, 1975, ground was broken for a new building just a short walk away and still in the confines of

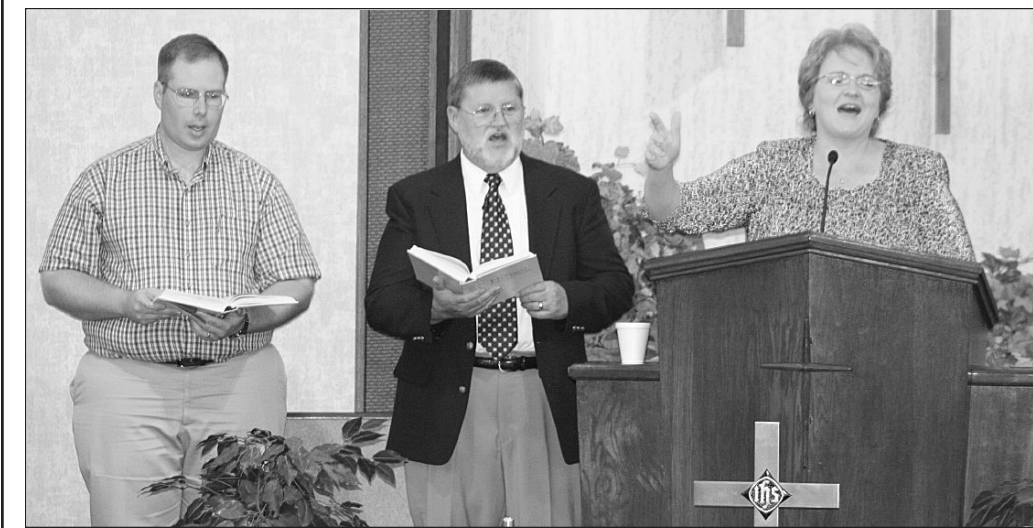
the Wildie community.

Many good and faithful workers have been part of the Wildie Christian Church throughout the years and through their hard work, sacrifice and faithful service, the church has been a light to hundreds of souls around the world. As we reflect on their legacy we are reminded of Hebrews 12:1, "Therefore, since we are surrounded by such a great cloud of witnesses, let us throw off everything that hinders and the sin that so easily entangles, and let us run with perseverance the race marked out for us. Let us set our eye on Jesus the author

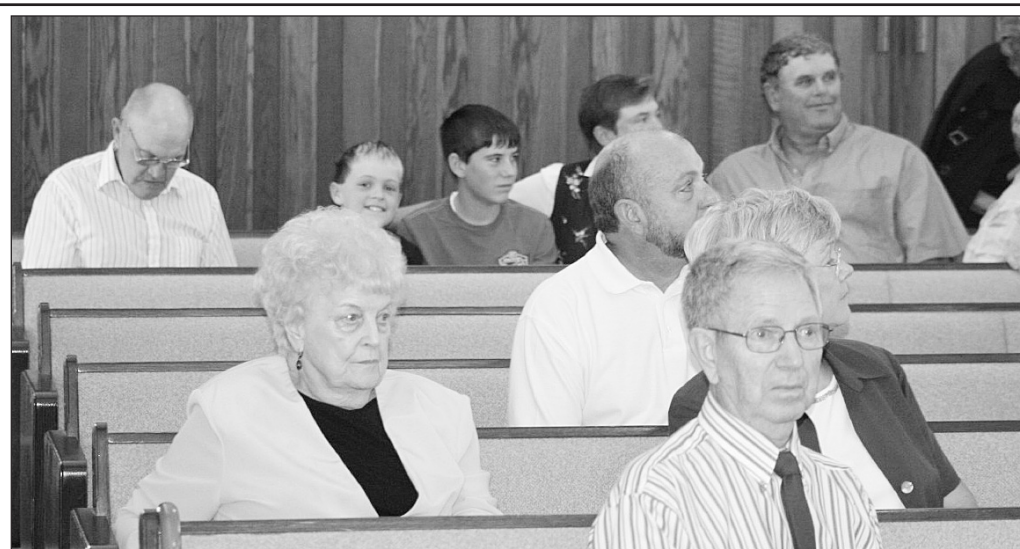

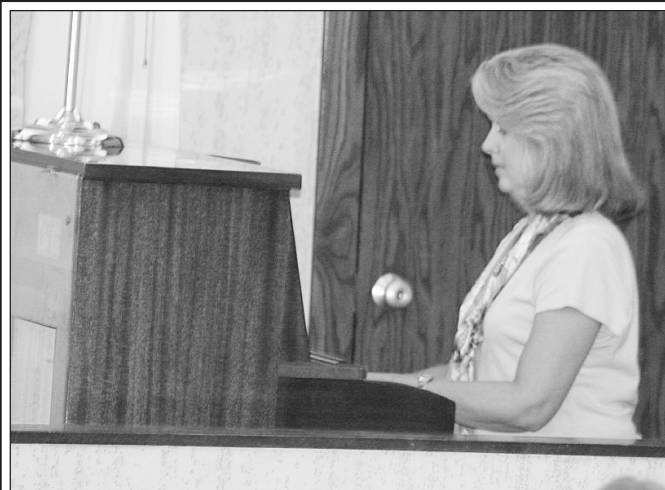

eled to Gwynn Island on a regular basis. However, by that time the attraction was more than the pool. In those days, a sunbathing deck had been created on the roof of the concession stand, and most of the girls spent their time lying on towels “soaking up the rays.”

Hanging across the adult pool was a series of chains with rings for the guys to show off their “manly” talents by swinging across the pool and dropping into the deep end. Of course, there was also a diving board to show off on.

It was common to leave home early on Saturday morning and drive to the Herrington Lake pool to spend the entire day with our friends. I remember one weekend when several cars filled with teenagers from Mt. Vernon traveled to Gwynn Island to swim away the afternoon. Included in the group were Buddy Cox, Penny Nunnelley, Howard Coffey, Gary Coffey, Bobby Sweeney, and several others that I do not recall by name.

One thing that I do remember is the trip home after the

swimming party. All of the guys put their swimming trunks in the windows of their cars with the glass rolled up so the trunks would blow dry by the time we got back to Mt. Vernon. It was a sight to see several cars driving down US 150 with a variety of swimming trunks blowing in the wind.

By the time I was a junior in high school, the routine for spending time at Gwynn Island was on Sunday afternoons. Several of my friends and I “doubled dated” at the pool. After spending the afternoon swimming, we took our dates to one of the restaurants in Danville for a nice meal to cap off a great day at the lake.

Even after moving to Lexington to attend UK, I still traveled to Herrington Lake for recreational activities with my girlfriends. The atmosphere there was very satisfying, and everyone that ever went with me loved the area.

I haven’t visited the lake in years. I guess it is too much to hope that the same atmosphere exists, but I hope that it is just the same as it was in the ‘60’s. If not, then the memories become that much more valuable.

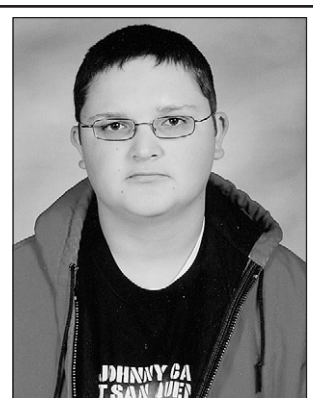

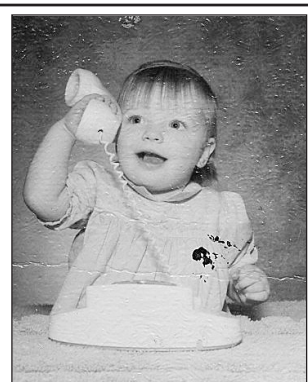

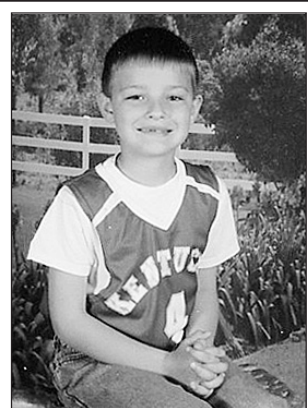

You know, the former U.S. Senator, turned actor, who managed to land a trophy wife.

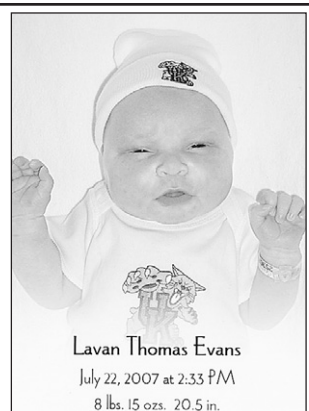
At least that is how some of the national news media refer to her. Thompson obviously doesn't like that label for his much younger wife.

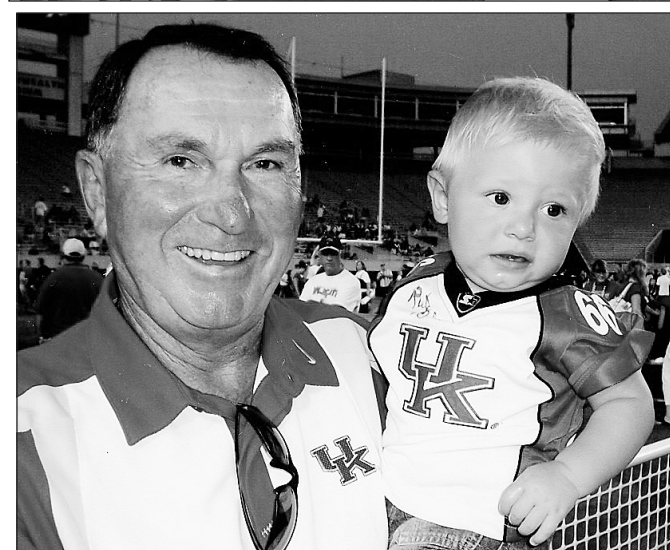
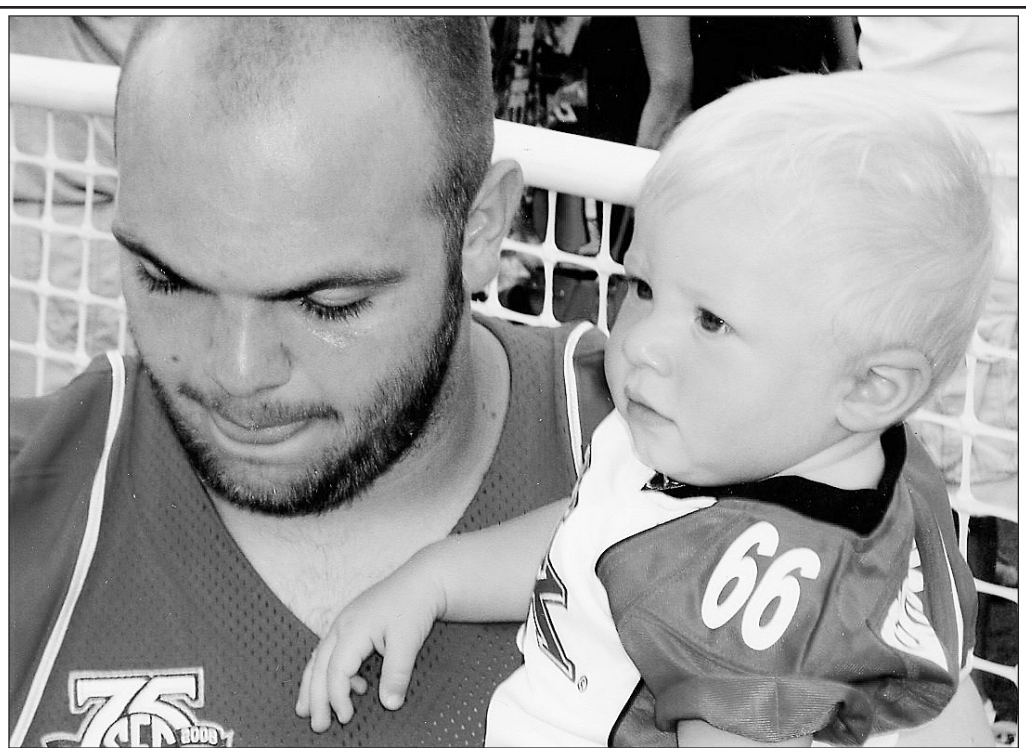

around 12:30 in the morning but, because her son had left the family's only vehicle at the high school and because she did not know where Breathitt County was she was unable to make the trip.

Davis said her son told her he had seen teammates with a fifth of vodka and that after they drank it they wanted more and began calling around to other rooms to try and find more.

Davis said her son told her the boys had brought the vodka to the passing camp in their bags.

But, Hammond told Davis that he and RCHS principal Jennifer Mattingly, along with assistant principal Barry Noble, had been made aware of the situation shortly after it happened and that they had interviewed the 24 players and coaches on the trip and no one knew anything about the alleged incident.

“We would treat a situation like this the same as they would in a court of law and we have come up with no evidence,” Hammond said.

Davis said her son had quit the team over the alleged incident because of the way he was afraid he would be treated by the other boys and coaches.

Davis told the board she thought lies were told by the coaching staff to cover up the incident.

Davis said she was not blaming any of the board members or Hammond, but she was blaming some of the coaches.

“I blame the coaches, I entrusted my son to them and it was their job to protect him. What if one of them had gotten in the pool and drowned or overdosed on alcohol,” she asked.

Hammond said school officials had even gone so far as to contact the hotel where the team was staying and that the hotel reported that nothing out of the ordinary happened there, that night.

Davis said someone had given her the name of an employee at the hotel who had found liquor bottles in the trash the next morning, but Hammond said the hotel manager said no such person worked at the hotel.

Davis said her son was a straight A student and that he had been taught not to lie.

“We tell our kids to stand up to stuff they know is wrong and then adults lie their way out of it,” she said.

Hammond told Davis that because of her complaint, administrators had ordered a surprise search of the bags of all the football players, before they left for football camp at Jabez in early August.

“We had a drug dog check all the bags for drugs and alcohol and they found nothing except some prescribed medication,” Hammond said.

Hammond said school officials take allegations, such as the one leveled by Davis' son, very seriously but “there simply

is no evidence,” he said.

Head coach Tom Larkey said Wednesday he was aware of the allegations and that he had thoroughly investigated the matter and found nothing to warrant such a complaint.

“There is simply nothing to it,” he said.

“Those boys were very well supervised by myself and the five other coaches who were there. We were up very late in the night discussing football and no one left the motel, I can guarantee that,” the coach said.

“The fact that our entire team was searched and nothing was found before they went to Jabez should dispel any rumors about alcohol or drugs being taken to camps by our players,” Larkey said.

“Myself, nor any of the other coaches or players knew anything about that surprise search, which is the way it should be,” he added.

As Davis and Smith left the meeting, both women agreed that the response they got on Tuesday night was the one they knew they would get when they decided to attend the meeting.

if the county is to ever have a new facility.

Besides a possible new facility, the additional funding means more specialized programs to fit the needs of all Rockcastle countians, according to a flyer being circulated by the local board.

For the board to be able to raise their tax rate, state law says the board must collect 3,000 signatures from registered voters in Rockcastle County in the next 90 days. The 90 day period runs from the time the first signature was collected, which was Wednesday, August 8th.

Isaacs said that around 2,600 signatures is all that is required, which is 51 percent of the number of people who voted in the last general election but that library board members wanted to make sure that when signatures were verified, they would have enough.

If there are enough signatures, the rate increase will become effective in 2008.

Rockcastle County Judge-Executive Buzz Carloftis said that if Rockcastle Countians

ever want a new facility for the library, they should sign the petition.

“As it stands now there isn't enough money to afford a new facility and I'm satisfied that the library board cannot afford to provide the services people expect them to provide these days, simply because their (the library's) tax rate isn't high enough,” Carloftis said.

If enough signatures are collected and certified by County Clerk Norma Houk the increased tax rate will automati-

cally go into effect without any action by the fiscal court.

“It is probably going to be hard, but with enough foot soldiers, I think we can get it done,” Isaacs said Tuesday.

A graph provided by the library board, which is running in this week's Signal shows property owners in the county with \$100,000 in property will pay \$26.00 more a year in taxes with the increase.

The current library building, which is owned by the county was built in 1973.

At their regular meeting Monday night, Livingston Mayor J.C. Griffin reported to the city commissioners that quit-claim deeds had been obtained for the site of the new water tank and that he hoped the project would be completed before winter. Griffin said that all four property owners, involved in obtaining the deeds, were "very cooperative."

The project includes a new 132,000 gallon standpipe tank and new distribution lines for water lines that presently have asbestos in them. The city's present tank has a 72,000 gallon capacity.

One more hurdle remains and that is a geological technical analysis of the soil at the tank's site. Griffin said the analysis was required and that it would cost the city \$8,000. However, the city has money in the project, given to them by the Cumberland Valley Area Development District, to pay for the analysis.

The city also approved a number of resolutions that will be a part of their Fair Housing Manual. The resolutions were prepared by Cumberland Valley Area Development District and Whitney Chestnut, from CVADD, was at the meeting to explain each resolu-

tion.

Besides a personnel policy, which CVADD will prepare for the city, the resolutions passed by the commission dealt with disability access, drug testing of employees, non-discrimination against lower-income residents, OSHA compliance notices, equal opportunity and a fair housing non-discrimination ordinance.

These are all required because the last part of the city's funding for the project came from a federal Community Development Block Grant.

Chestnut told the commission that wage rates were still to be determined as one of the last items before bids could be advertised for.

Griffin also reported to the commission that the sludge analysis had been returned and the city could now give away the sludge from the sewer plant. He also reported that sections of Hill Street, Mahaffey Hill and Bullock Street had been blacktopped at a cost of over \$3,000, depleting the city's municipal road fund. However, Griffin said he expected to receive more money from the state. The city didn't receive any municipal road aid funds this year because the previous commission did not submit their budget for 06-07 to the state.

According to reports to the commission by city clerk Tammi Martin, all the city's bank accounts had positive balances as of August 13th. The water revenue fund's balance was \$7,671.49; Operation and Management, \$196.25; the road fund is down to \$42.60; the general fund has \$8,357.19 and the water project fund has \$11,385. This is the fund that the \$8,000 will be paid from for the geological analysis. Griffin also reported to the council that all bills had been paid for August.

Main Street. However, Griffin said that if he could not get matching funds for the \$5,000 through Cumberland Valley Area Development District, he would like for the money not to be restricted to the court to sidewalks which would allow him to use it where it would most enhance the city. The court agreed to not place any restrictions on the money. County Judge Executive Buzz Carloftis told the court that one of the main reasons the county should make these donations was to show cooperations between county and city governments. This show of cooperation is a big plus when the cities apply for grants, Carloftis said. The money will be taken from the county's Local Government Economic Assistance fund which had a balance of almost \$100,000 at the end of July.

Also being paid from that account were two claims, approved by the court, totaling over \$31,000 for the replacement of the cooling tower and 45-year-old compressor for the air conditioning system.

Albert and Carolyn Carpenter were before the court to request compensation for damage to their 1995 Jeep, caused, the Carpenters said, when county workers left a section of Old Gauley Road without gravel, causing Mrs. Carpenter to skid out of control and wreck. Luckily, Mrs. Carpenter was not injured.

All but about 70 yards of the road was not graveled, Carpen-

ter said but roads signs warning motorists were taken up and his wife was not aware that the gravel ran out and hit loose gravel on mud, causing the accident.

Carpenter's estimate of \$619.60 for repairs was taken by the court who told Carpenter that they would contact their insurer, KACO, and have an answer for him within the next few days.

The court was also brought up-to-date by Jim Holton, a consultant for the Rockcastle Industrial Authority who said that much work had been done on preparing information on the two industrial sites and that a contour map would be available soon when an aerial survey of the parks was completed. Holton said that core drillings at the sites had been completed, along with preliminary mapping.

Holton also said that Plasticware LLC was "up and running" since about a week ago and that 79 workers had been hired, including some former workers and members of the management team. However, Holton said that substantially more workers would be added when new equipment was installed. "They (Plasticware) are not by any stretch of the imagination at capacity," Holton said.

Holton also told the court that the county's new web site had been operational since August 2nd and that new information was being added all the time.

The court also discussed what action would be taken over the failure of Elswick Construction to fulfill their obligation to clean up a dump on

490. The work was to have been completed by August 1st but Elswick, who bid \$17,000 on the job, has not even started. The court decided to see if there is any legal action that can be taken against Elswick and to see if they can award the contract to the next low bidder, Keaton Excavating (\$38,00) without the bid process having to be gone through again.

The court also approved a contributions to the City of Livingston for their Homecoming and Mt. Vernon for the Bittersweet Festival of \$200 each and a \$100 donation to the Kentucky Kids Wish Network.

# Yards to Paradise

Blue—Cool Summer Landscape Color

Color is a property of light, as Sir Isaac Newton proved with the prism in the 1600's. White, full spectrum, light comes from the sun (and a few artificial bulbs). Some colors produce hotter and more attention-getting responses from people, and some colors are relaxing. Blue is a primary color on the color wheel, and it is the most relaxing color.

To landscape a yard well, many things need to be considered besides just color. Things such as function, form, line, scale, texture. Then, there are terms like unity, focal points, balance and rhythm that are important.

Color is also important, but should be considered in context.

Color needs to blend well with, not clash with, the existing home and hardscape. (Unless you want to paint and otherwise change the hardscape of your place also!)

Speaking of color, it is a hue of the rainbow, or refracted light. Tints of blue, would be lighter blues.

Shades technically are darker blues. (Same for which-

ever color you might want...but today, let's create something blue.) And, a perfect relaxing spot to call your home paradise.

Greens, especially darker shades....and purple and lilac are also cool colors.

Blue is frequently considered a rare color for flowers, but you might be surprised when we just do a little looking what we can come up with to "plant our yard blue".

For blue color in the landscape, consider some blue stones, some blue foliage and also some blue blossoms.

Be sure not to forget bloom times. Crocus and hyacinths are blue, but they bloom in the spring, so are not valid options for summer blues.

Here is a random listing of some plant species that bloom blue, or at least have some cultivars or hybrids that are obtainable in blue shades and tints.

Scilla, delphinium, larkspurs, agapanthus, periwinkle groundcover, iris, hardy geranium, globe thistle (Echinops), scabiosa, clematis vines, wisteria vines, veronica, sage (salvia), onion (allium), aconitum, althea, spiderwort, tulips, morning glories, violas and pansies, borage and a number of mint plants, magnolias, hydrangeas, argeratum, bluebeard shrub (caryopteris), blue tropical water lily, cornflower (bachelors buttons), baptisia, pulmonaria (lungwort), and cone flower and beebalm. Some shrubs that have blue tints to leaves, or blue fruits or berries, might include blueberries, elderberries, arrowwood viburnum, white fringe tree, sassafras and serviceberries. Blueish foliage might be added with rabbiteye blueberries, fothergilia, blue leaved hosta, and there are a number of tropical and desert

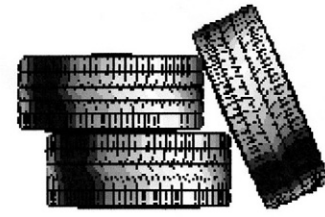
