At Mt. Vernon Council meeting

City accepts bids for new sewer line around lake

Ten bids were submitted for the sewer line around Lake Linville and the Mt. Vernon City Council accepted the low bid, from Aikens Excavating of Corbin, for \$501,156.60.

Mayor Clarice Kirby told the council, at their regular monthly meeting Monday night, which was moved up this month because of the Martin Luther King Holiday next Monday, that Aikens was a well-known company and she was pleased that the bid came in lower than the \$698,000 estimated by engineers. The council also discussed the new fire station but passed on signing an agreement with Rockcastle Co. CSEPP, opting instead to have their lawyer look it over and to discuss with the county sharing insurance costs and the county picking up their share of maintenance costs.

To date, the city has paid out over \$155,000 and still has additional work to do such as pav-

ing the area in front of the building, more plumbing costs, etc. Plus there will be an additional \$84,000 due the contractors when the six-bay building is completed. The building will not have a cooling system at first nor bathrooms, although the rough plumbing will be in place.

The city borrowed \$50,000 from UDAG funds they had on hand plus used \$30,000 they got from coal severance funds, for the fire department and rescue squad, from the county and the rest, over \$75,000, has come from their own funds. The final \$84,000 will be paid with money, \$85,000, pledged by Rockcastle County CSEPP for their share of the building which the city will receive upon signing the agreement between the two entities.

The new firehouse is located on Old U.S. 25, where the county road garage was located

Fiscal Court approves \$436,000 budget for Sheriff's office for 2008

Rockcastle County Sheriff Mike Peters presented his budget for 2008 to the Fiscal Court, at a special called meeting Tuesday. Peters' budget of

\$436,300 is deceiving in that it includes \$95,000 in money advanced by the state (\$60,000) and a bank loan obtained by Peters (\$35,000) to

run the office until fees are collected.

Actual revenue expected by Peters for 2008 is \$341,300 and includes \$124,000 from commissions on taxes collected and \$104,600 for reimbursement for Barry Adam's salary plus overtime, reimbursement for bailiffs' salaries and money received from KLEFFP for overtime for officers.

The sheriff will also receive a \$15,000 grant from the Department of Justice and the money will be used for one-half for overtime for officers and one-half for dash cameras in patrol cars.

Peters said the only problem with this grant was that the money must first be paid out and the department will then be reimbursed by the state. Peters also received a \$1,000 grant

from the state last year and said he was told by state officials that that was the first time that a sheriff's department in Rockcastle County had ever applied for a grant.

On the expenditure side, the department's biggest expense, naturally, is for salaries with a total of \$285,905, including Peters' salary of \$68,000.

LIHEAP program out of money in Rockcastle County

The Daniel Boone Community Action Agency began administering the "Crisis" portion of the Low-Income Home Energy Assistance Program (LIHEAP) that assists households in a heating crisis on January 7th.

By noon on January 10th they were out of funds.

Local Daniel Boone coordinator Tammy Cox said Daniel Boone served 375 families, spending a total of \$91,530 over the five day period.

State grant will cleanup illegal Boone Gap dump

Democrat State Senator Ed Worley, of Richmond announced Tuesday that the Division of Waste Management has awarded Rockcastle County \$165,000 for the cleanup of illegal dumps.

"Significant progress has been made in addressing the illegal dump issue in our state, but we need to do more," said Worley. "These illegal dump sites send the wrong message to individuals and groups looking to call Kentucky home."

Rockcastle County Solid Waste Coordinator James

Renner said the money would be used to clean up the illegal dump at Boone Gap on the Rockcastle-Madison County line. The illegal dump has been an eyesore in the county for over 30 years and Renner said the entire \$165,000 will be used for clean-up of the Boone Gap Dump only.

The funding for Rockcastle County is part of the \$2.9 million in state grants to be dispersed throughout 52 counties. These funds will clean up 293

Fire causes heavy damage at medical supply store on Sunday

Fire heavily damaged the Appalachian Medical Equipment store in Mt. Vernon on Sunday morning.

Mt. Vernon volunteer firefighters were called to the scene around 3 a.m., after a passing motorist saw smoke coming from the building on Newcomb Avenue.

Mt. Vernon Fire Captain Bryan Hansel said investigators had determined the fire started around the furnace. Hansel said it took firefighters about four hours to bring the fire under control.

Workers with ServePro had already begun cleanup of the fire on Tuesday. Owner Kendall Kilburn could not be reached for comment as to the amount of loss sustained in the fire.

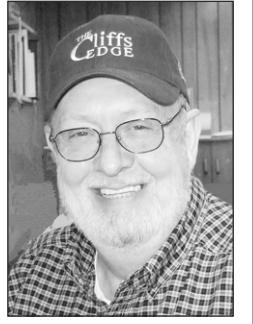

Rockcastle Memories

As I revealed when I told the story of riding the George Washington Special rail system to visit my brother in Manassas, Virginia, I have been fascinated with trains since I was a very young boy living in Mt. Vernon.

From our small farm at the top of old US25 in Rockcastle County, we could hear the lone-some sound of the L&N coal-burning engine as it climbed the steep grade toward the depot in Mt. Vernon. I often walked through the woods and sat on a rock bank to watch as the trains slowly crept up the hill toward their scheduled destination. My recollection of the forlorn moan of the whistle still remains.

The L&N system, sometimes dubbed as The Old Reliable, operated from 1850 until its consolidation with CSX in 1982. Its headquarters was in Louisville, and the tracks stretched over 180-odd miles to its second namesake city of Nashville. "The L&N shrewdly guaranteed its fuel and a steady revenue by pushing its lines into the difficult but coal-rich terrain of eastern Kentucky," according to Wikipedia.

It was normal for the trains to be very long and filled with coal. On many occasions, I could count a couple hundred cars being pulled by more than one engine. (I read on the internet recently that the record train was 4.5 miles long and contained 682 cars being pulled by 8 locomotives.)

Even the songs of the day told the story of trains and the people that rode them. Such songs that played on WRVK in Rockcastle County were: Rock Island Line, Death of John Henry, Midnight Special, Nine Hundred Miles, and Wabash Cannonball. Anyone remember them?

My grandfather (Pop) was a traveling salesman for Aubrey "Red-A" feed in Louisville. He gathered orders from grocery and feed stores in a four-county area near Rockcastle County. On Wednesday nights, the orders were mailed on the L&N mid-night train to Louisville. When there was no school (or in the summer), Pop allowed me to go with him to the depot to see his orders off.

We usually arrived at the station before the train appeared and walked around watching for the train. Upon its arrival, we handed the package to the conductor and waited for the train to depart. It was a thrilling experience for a boy.

Trains passed through my hometown on a regular basis in the 50's and 60's. Several of my friends and I often walked down the tracks to a tunnel used by the L&N trains before they reached town. Sometimes we walked those tracks at night when we had nothing better to do. It was probably a mile or so from the city limits.

I remember one night when Buddy Cox, Howard Coffey, Lloyd Fain, and others whom I cannot recall, were in the area of Big Fill Cave when we heard the train coming our way. One of the older guys said, "Let's get in the tunnel and watch the train pass." I had never experienced lining the walls of the tunnel as a train went through. So, of course, we all ran toward the tunnel and took positions along the stone walls near the tracks.

Sure enough the train crept through the tunnel with such a loud noise that I thought my ears would explode. I was uncomfortable to say the least, but I would never admit my fear.

Points East

Before my dad finally figured out that it was cheaper, not to mention far less trouble, to buy milk at 25 cents or swap a dozen eggs for a gallon from Lydia Caudill than it was to keep a cow back in the late fifties and early sixties, somebody had to milk ole Betsy twice a day, every morning, every night, seven days a week.

Milk cows do not take any time off unless they're pregnant or in the mood to become that way. In which case, Dad either lead the cow or hired Shade Blair, who had a pick-up with a stock rack, to haul her from the head of Blair Branch out to the Isom "stock sale" where he traded up to one that was giving milk.

I can remember walking cows to and from the stockyard when I was in grade school and I can also remember riding in the cab with Shade while Dad followed us in whatever car he owned at the time after he had traded cows.

We'd usually get the dry cow to the stockyard late in the day on Friday but Dad would be back before daybreak on Saturday morning to tout the one he was selling and to watch the ones for sale being milked. The goal, of course, was to get a cow that gave more milk than any other cow on the face of earth.

Dad was a pretty good stock trader and he enjoyed it tremendously. Truth be known, the biggest reason we kept a cow in the first place was because it gave him an excuse to trade animals. He did the same thing with mules and horses.

However, unlike draft animals that had an array of names and never the same one twice, every cow that we ever owned was named ole Betsy as were several automobiles that he kept long enough to form an attachment.

I can remember him saying, "Ole Betsy's gotta go," and Mom would ask whether he was talking about the car or the cow.

Anyway, he'd often wind up with a new milk cow, almost always a Gurnsey or Jersey and he'd make money in

the trade. The reason for this had to do with the fact that most people buying cows were at least as interested in how gentle they were as in how much milk they gave.

Dad would look for ill-tempered cows that pawed the ground and kicked the bucket when they were being milked. If they had exceptionally large udders, an indication that they'd produce more milk than your ordinary cow, he figured he could tame them down in the milk shed.

Both he and my mother could usually gentle a cow within a few short days of them coming on the place so that when trading time rolled around again he could make a profit by swapping a reformed attitude to another bad one.

Still, owning a cow meant that we never went anywhere to take the night with relatives when I was a lad. They all came to see us and, because we lived on the old home place, we had "company" or house guests nearly every week-end. Our relatives usually brought empty gallon jugs or jars so they could take home buttermilk and cakes of snow white butter.

I can't remember ever dreading helping out with milking chores, but churning butter is easily the most despicable task that I can remember from my early years.

Dad finally bought a cow he couldn't get to settle down. She was always kicking at him or the milk bucket and he wouldn't let Mom or me try to milk her for fear that we'd get injured. He was working 10 and 12 hours a day in the coal mines at the time and had to do the milking before and after long shifts of shoveling coal.

He resorted to using "kicker's" on this particular Betsy. This device consisted of two steel cuffs that fit around the cow's rear ankles, joined together by a couple links of chain which meant that the cow couldn't move one foot without moving the other.

But she tried to anyway, resulting in a loss of footing altogether and came crashing down on top of Dad, crushing his stool and milk bucket and bruising him up pretty badly in the process.

The next day ole Betsy went to market and Dad came home without another cow. We doubled up on laying hens so we could swap eggs for milk. The beauty of this arrangement was that eggs could be gathered any old time of day.

I can't recall my Mom ever complaining about not having a cow. And to this day, I'm sure that I would rather gather eggs all day than churn butter for thirty minutes.

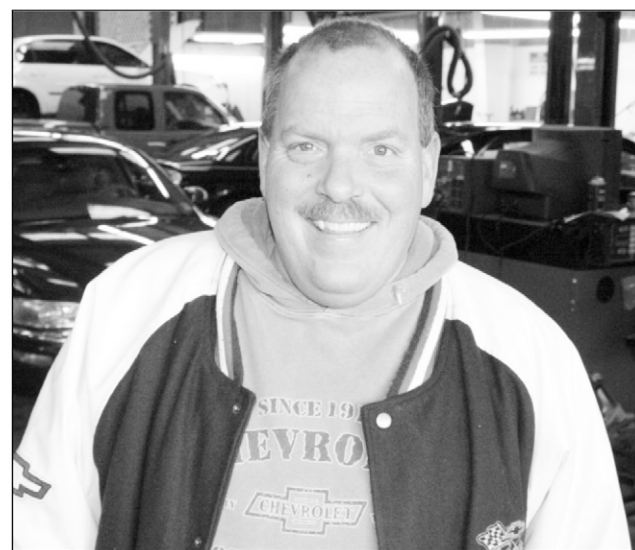

Take time to fill out agricultural census

Farm and Home News

Rockcastle County Extension Office

The Census of Agriculture, taken every five years, is a complete count of U.S. farms and ranches and the people who operate them. The census looks at land use and ownership, operator characteristics, production practices, income and expenditures and many more areas.

Census forms were mailed December 28th and should now be in the hands of farm owners and operators. Don't delay in filling out the data. Federal law requires all who receive a census report form to respond even if you didn't operate a farm or ranch in 2007.

For census purposes, a farm is any place from which \$1000 or more of agricultural products were produced and sold or normally would have been sold during 2007. Completed forms are due by February 4th. Producers can return their forms by mail or via a secure Web site.

The Census of Agriculture provides information that is not available anywhere else - infor-

mation that benefits agricultural producers and their communities.

Another important piece of information compiled and published from the 2007 Census of Agriculture will be the count of farms by different categories: size, type, operator characteristics and value of sales. This count is made for each county in Kentucky. Many of the extension programs administered in Kentucky receive funds for these projects based on the census farm counts by county.

Individual information is confidential. NASS uses the in-

formation only for statistical purposes and publishes data only in tabulated totals. The report cannot be used for purposes of taxation, investigation or regulation. The privacy of individual census records is also protected from disclosure through the Freedom of Information Act.

The National Agricultural Statistics Service will release census data, in both electronic and print formats, beginning February 2009. Detailed reports will be published for all counties, states and the nation.

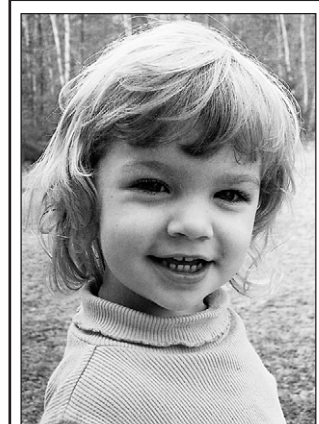

Livingston Pentecostal Church began in 1908-10

From Church Minutes
Pentecostal Worship is very old in the Livingston area of Rockcastle County. Church members had the honor of visiting the home of Asa and Ruby Mink who remembered when Pentecostal worship started in 1908 or 1910. The first worship service of

the Livingston Pentecostal Church was held in the homes of Elizabeth Witt and J.M. Ford. Then a congregation was formed which used the old Livingston Coal Company Commissary Building for a place of worship. The congregation also met in an old store building and the old Presby-

terian Church building, which had been abandoned. In 1919, a building was erected in town on a very steep hill and worship was carried on there for nearly 60 years. The first trustees of the Old Livingston Holiness Church were: T.F. Jones, Tommy Jones and Cleo McClure. The first ministers were: Gil Disney, Garrett White and Pete Smith.

It is believed that Rev. George Murphy was saved in the Livingston Church. Sister Ruby Mink remembered hearing Bro. Murphy say "He was baptized in the Holy Ghost in the church there." Brother Murphy was a great supporter of the Holiness Church and a great blessing to many. Brother Murphy was a crippled man most of his life, but he never allowed it to hinder his work. He never used it as an excuse or neglected his work for God. Murphy was Circuit Clerk in Rockcastle County for many years and helped pay off the debt on the first church in Livingston. Later he became

deeply involved in the Mt. Vernon Pentecostal Church and was faithful there until his death. Pentecostal worship is carried on now just north of Livingston in a lovely new church building. With only 14 members and the pastor of the Livingston Pentecostal Church, and only \$256 in the treasury, the congregation decided they wanted a new church. The first thing they had to do was find a good location and, with God's help, the lots were bought in November of 1973. In June of 1974, construction started on the new lots where the church sits now. In April of 1975, dedication service was held and members moved into the new church. God was there for every need we had. He met them all. To help pay for the new building, we rented a building downtown and had rummage sales. Some of the sisters made quilts and sold them. As we worked, money came in many different ways. We

baked cakes and had bake sales and people donated money. In April of 1980, we had our Mortgage Burning Ceremony. We had spent \$112,500. Sunday School is held each Sunday morning at 10 a.m., followed by worship service at 11 a.m. Sunday night service is at 6 p.m. and Wednesday night service is at 7 p.m. Children's Church is offered

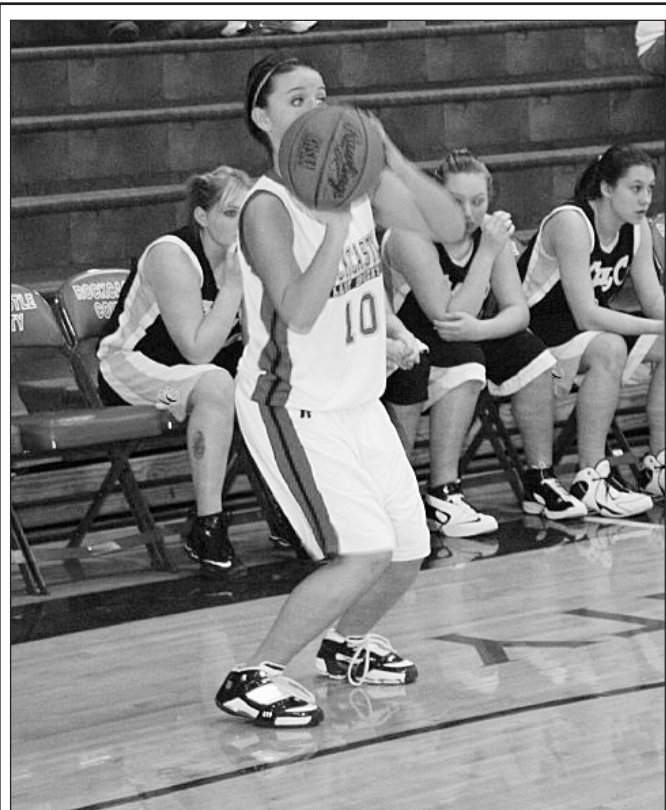

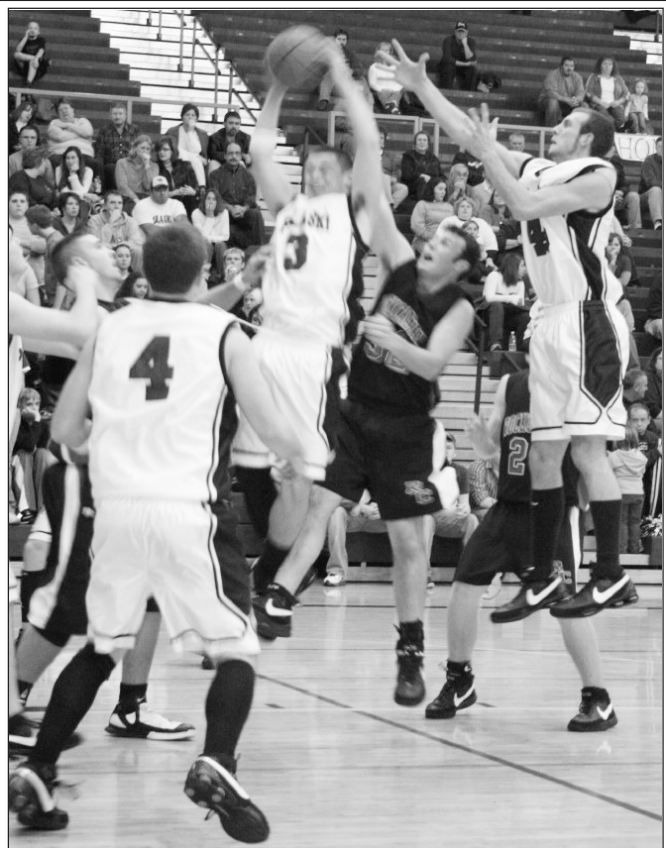

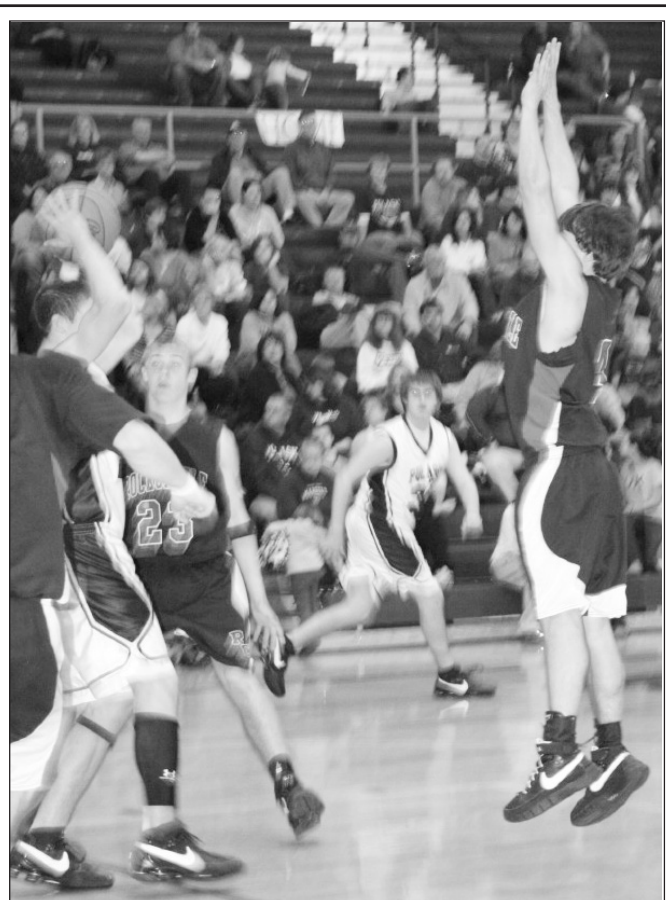

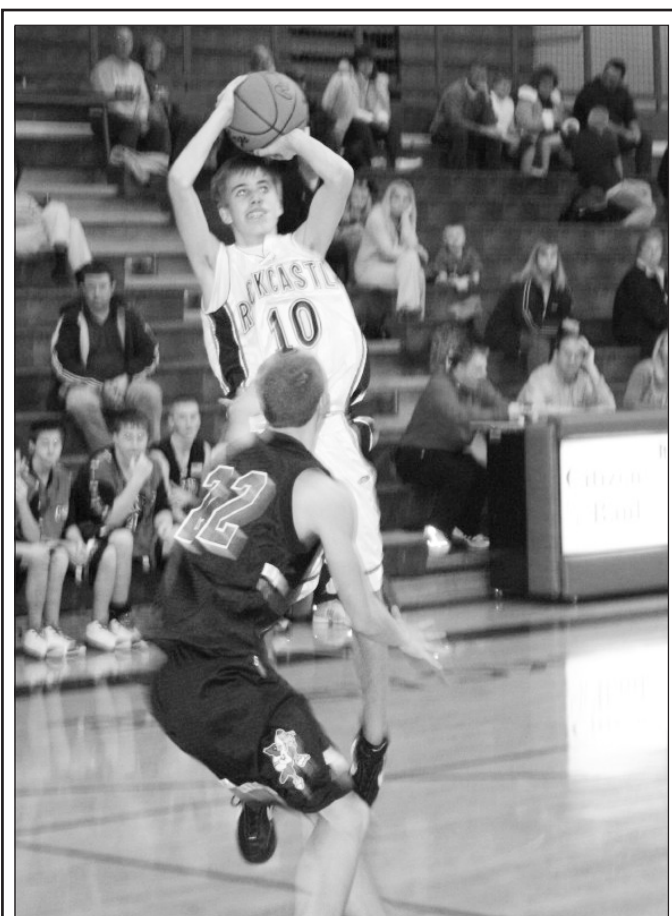

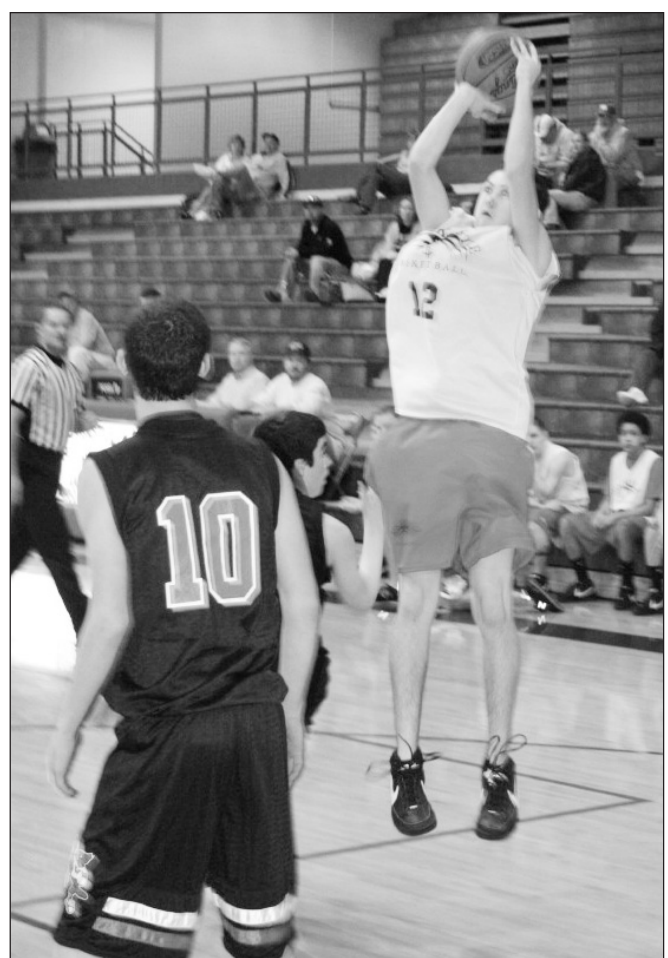

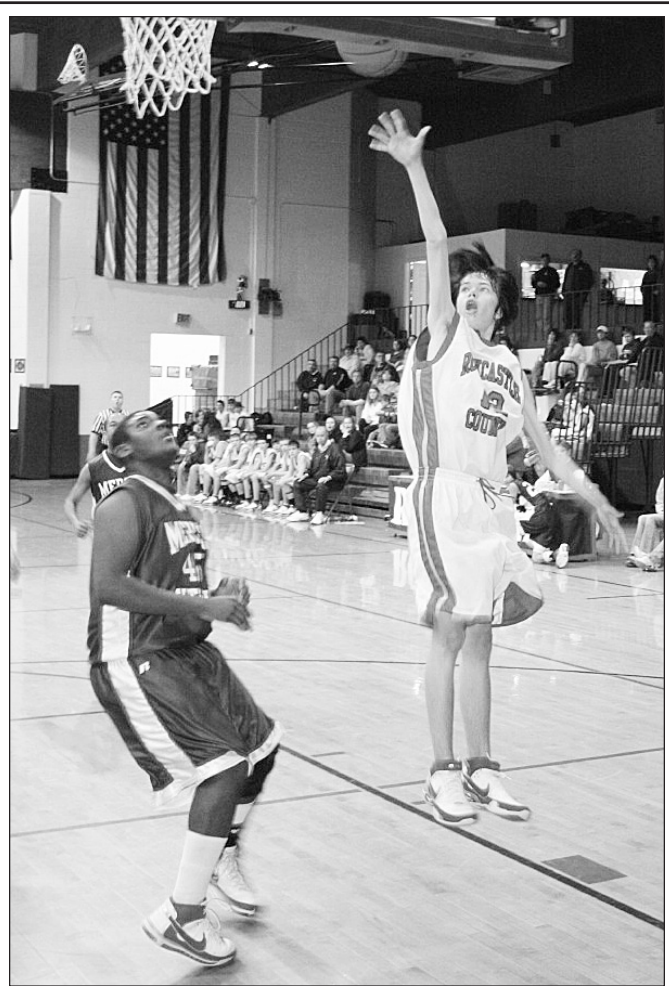

New water lines are being laid in City of Livingston

Livingston Mayor J.C. Griffin told City Commission members, at their regular meeting Monday night, that 800 feet of new water line had been laid.

All old water lines will be replaced under the project which is being funded by a state grant. The city also received a grant to replace their water tank with a bigger one, and, Griffin said, the new tanks is supposed to be set February 11th after new water lines are laid to the site.

Contractors laid the first 800 feet of the new lines beginning in front of the old jail, up the hill to Mullins Street, then to the lift station, then to the residence of Beverly Howard. Griffin said that blow off and cut off valves were being added to the lines and that nine new fire hydrants would be installed.

The mayor said he hoped to be able to add a hydrant between the fire house and the adjacent building, although this hydrant is not figured in the original bid.

The commissioners also received a financial report from City Clerk Tammy Martin which showed the city in relatively good shape, financially.

Martin's report showed positive balances in all accounts with the general fund showing a balance of \$11,871 as of Monday, the water works revenue fund with a balance of \$6,834.19 and the water works operation and maintenance with a \$1,012.46 balance. Martin also said that all the city's bills had been paid for January.

The city is presently having to pay the state for utility taxes which should have been paid in past years. Once this is paid, the financial condition of the general fund will improve considerably, since in December, almost \$2,600 was paid to the state in an effort to catch up on that particular tax.

Revenue in December, according to the city clerk's report, showed the city collecting \$7,945.62 in water revenue.

However, the city will have to pay for an audit of city finances, which will be a rather large bill. The mayor told the commission Monday that Gary Williams of London had agreed to do the audit when all information is collected by the city.

Griffin also said that he was hopeful of being able to use money left over from the million dollar grant, the city got to install new water lines and the new water tank, to lay a water line across to Wildcat Mountain and pick up seven new customers in that area. At present, these residences do not have access to city water.

budget as presented and also approved an order setting the maximum amount that can be paid for deputies and assistants at \$220,000.

The sheriff's department currently has five full-time deputies, four part-time (bailiffs) and five volunteers.

Peters said the number of deputies he can have is determined by the county's population.

In other action, the court approved an agreement between the Rockcastle County Jail and other jails in the area to house each others prisoners in case of an emergency in which the jail would have to be shut down.

The court also approved several interfund transfers, as presented by County Treasurer Joe Clontz. One of the items, for which a transfer had to be made, was for \$2,500 for road signs.

County Judge/Executive Buzz Carloftis noted that there had been a flurry of vandalism to signs in the Sand Springs area recently and that destruction of signs was "criminal activity."

"We did prosecute one case successfully," Carloftis said. "This is not just a prank, it can land you in jail," he added.

Magistrate Bill McKinney also pointed out that it could also cause a family member to not be able to get an ambulance when needed if ambulance drivers are not able to locate a sick person because a road sign has been torn down."

"We are concerned that the budget shortfall will increase the burden on the elderly, disabled and families with children who are trying to make ends meet to the point where they are faced with impossible choices," Buckles said.

for years.

The council also approved a proposal to hire a surveying team to go forward with mapping city limits for growth and expansion.

The proposal, which was approved, is needed for the city to determine what route they will take to square up the city limits.

Kirby said that someone from City Engineer Luther Galloway's office would probably be hired and part of their job would be to go door-to-door to take to businesses and residents to get a consensus of their feeling about being annexed to the city.

Kirby pointed out that it would be an expensive proposition for the city since they would be taking in a lot of streets not previously main-

tained by the city and would have to pay to extend services to the area before they would see any revenue from service fees.

The council also approved selling the "gravel pit" on Main Street to the county for \$75,000 if the county decides to purchase the property. Kirby told the council that, if the deal went through, the money should be earmarked for a special project such as a skateboard park, rather than just put into the general fund and used for general expenses.

weeks, there will be no more funding for the program, according to a news release from Daniel Boone's home office.

According to the news release, Community Action Agencies across Kentucky have received only about one-third of the funding it received in the past two years.

Besides Rockcastle, many other agencies in Kentucky have also run out of funds. The deepening cold winter weather, combined with rising utility costs, leaves many households unable to meet heating bills or purchase sufficient bulk fuel to keep their families safe and warm.

"This is a strong indicator of economic hardship which will only get worse as colder weather approaches" said Mike Buckles Executive Director of Daniel Boone.

"These indicators are a strong message that the General Assembly needs to act on HB 153 which would provide \$10 million in emergency benefits to Kentucky's LIHEAP program," said Buckles.

Last year over 959 residents in Rockcastle County received financial assistance and emergency services from the LIHEAP Crisis program.

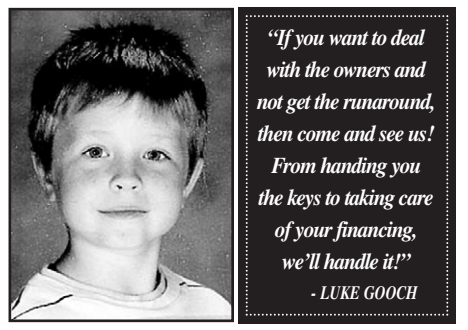

Rebels Take Mount Vernon

By: Bill Kelsey

The following letter from major A (Alfred) Smith, son of General William Smith (war of 1812 fame) to his son-in-law M. J. Miller (Milton Jefferson) who was the great grandfather of the late Mrs. Dorothy Craig, addresses some of the events that occurred in and around Mt. Vernon in August of 1862. Metcalf was Colonel Leonidas Metcalf of the Seventh Kentucky Cavalry Regiment, Union Army.

Headquarters
Mt. Sterling
24th August 1862

Dear Milton,

I have heard of the lamentable circumstances of the Rebels taking Mt. Vernon on Tuesday last. M. J. Miller is here and is 1st Lt. of Capt. Craig's Company. Well the boys seem satisfied-no rebel soldiers here as yet. I am well. Let me know soon how you all came out before the soldiers left your town. What was done and all about it tell ??? and the children to not be uneasy. I am well and making my way the best I can for them. Is all well? Metcalf was cut into pieces in Madison County, Kentucky last week - it is said Metcalf is

a prisoner- I hope he made his escape. Write soon to me at this place also in Maysville. I want to hear badly how you all came out. ??? is doing well.

It was decided in early 1862, by the Confederate High Command and President Jefferson Davis, that Kentucky was to be invaded and a Confederate government be established.

The main Confederate force in East Tennessee, under the Command of General Edmund Kirby Smith invaded through Rogers Gap, West of the Cumberland Gap. The infantry entered Barboursville on August 20th 1862. Ahead of them was the Confederate Cavalry. Colonel John S. Scott's and Colonel James Morrison's Cavalry regiment were sent ahead of Smith's infantry and artillery. Colonel Scott's regiment moved on to London, Kentucky and took it on August 17th, 1862. Only a few shots were exchanged between his regiment and the Union forces who quickly fled the short engagement.

This left the Confederates with an open road to Mt. Vernon. Colonel Scott, in overall command of the Cavalry, then sent Colonel Morrison, with his Cavalry regiment ahead to occupy Crab Orchard and Mt. Vernon. Colonel Scott intended for his Cavalry to move fast because of the hostility of the people in the surrounding countryside.

The majority of the people were strong Union supporters and he could expect no help from them. Colonel Scott's regiment was the First Louisiana and had experienced battle before coming to Kentucky. Colonel Morrison's Cavalry was the First Georgia and they too had "seen the elephant", a Civil War term, meaning that men had been in Combat before. Their Cavalry Regiments were well mounted and were accustomed to moving quickly to their objectives.

Colonel Morrison, as ordered had moved on Mt. Vernon and had taken it on the 19th of August. They met little resistance and then took Crab Orchard by the 20th of August.

While there, events were occurring, the Union was putting together a force to oppose the Confederates. Their forces were mostly raw recruits under the unified command of General William Nelson, headquartered in Lexington and Richmond, Kentucky. None of their men had seen combat and were composed of Kentucky men.

Colonel Scott's regiment, wherever it had roamed after taking London was in Mt. Vernon by the 22nd of August. Somehow on the evening of the 22nd Colonel Scott learned that there was a Union wagon train on the Richmond-London Road heading East towards Cumberland Gap. By now he had both Cavalry regiments in Mt. Vernon and decided to attack the wagon train the next morning.

It is believed he went north through Wildie towards Big

Hill. As he neared Big Hill, Union scouts reported his presence to Richmond headquarters. A Union force under the Command of Colonel Leonidas Metcalf's Seventh Kentucky Cavalry along with a battalion of the Third Tennessee Regiment (Union) was sent to Big Hill. Colonel Metcalf attacked, but after a few exchanged shots his men deserted and he was nearly captured. He and his second in Command managed to escape. The outcome of this battle was not unexpected as his men were poorly trained and had never experienced combat.

Colonel Scott's Cavalry was worn out by the ride from Mt. Vernon and the brief engagement with Colonel Metcalf's forces. Colonel Scott then fell back beyond Big Hill to a place between there and the

Rockcastle River. This action took place on the 23rd of August and Scott's force took a few days to rest his men and mounts.

On the 28th in a small engagement around Mt. Vernon, Colonel Scott's force took a small number of prisoners without losing a man. In addition Colonel Morrison's regiment captured "about 137 wagons," most of them loaded with military goods and corn. Also taken were over a hundred mules and horses, which were much needed as replacements for the Cavalry's horses. By the time General Kirby Smith's main force had moved around Mt. Vernon and was advancing towards Big Hill and Richmond. Part of Colonel Scott's Cavalry provided cover on Smith's flank.

At Big Hill and Richmond

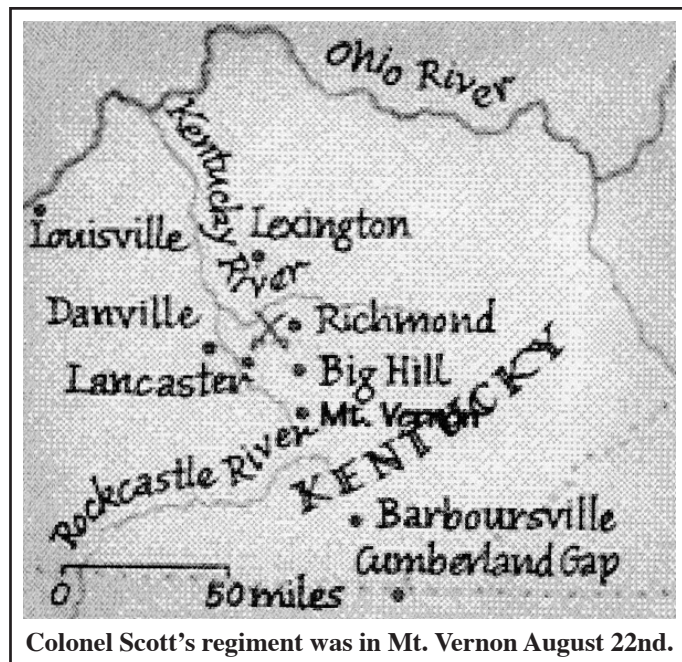
General William Nelson's army of some 7,000 men were waiting for General Smith's army of between 13,000 and 19,000 men. The Battle of Richmond took place on the 29th and 30th of August 1862.

The official records show General Nelson's loss of 206 killed, 844 wounded and 4, 303 missing or captured. General Kirby Smith's loss was 98 killed, 492 wounded and approximately 10 missing.

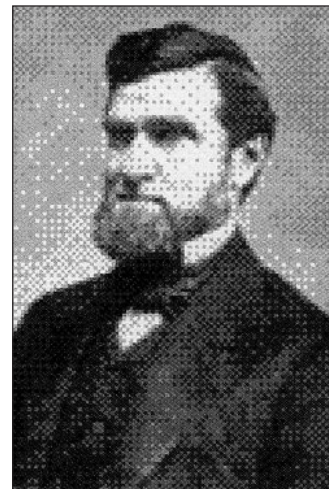
After the battle General Smith's men marched into Lexington and Frankfort. Sometime afterwards General Braxton Bragg, Western Kentucky, assumed overall command and on October 8th the Confederates won a tactical victory at Perryville, but soon afterwards all Confederate forces left Kentucky never to return in such force again.

Soon matters were getting back to normal in Rockcastle County. Throughout the remainder of the war there were

Call 811 before you dig

Planning a home improvement job? Working on landscape, or maybe installing a fence? Be sure to call 811 before you dig.

Jackson Energy has partnered with the 811 service, and any co-op member who needs to locate underground electric service should call 811, which is the national "Call before U Dig" call center.

The center provides information 24 hours a day, seven days a week for excavators, contractors, utilities and the general public, said Jackson Energy Director of Public Relations Karen Combs. 811 is a toll-free number.

"Bush- Whackers" from both sides of the conflict that would conduct small raids in the Country taking whatever they could carry with them.

For years after the war those families who favored the Union were registered Republican and those for the South were Democrats. To some extent this is still true today.

Major Alfred Smith was not involved in the fighting in 1862. He served with Company K, 14th Kentucky Cavalry and was discharged at Camp Nelson March 24th, 1864. He is buried in Elmwood Cemetery. His brother, Elisha Smith, was a large land owner

and owned several slaves. A document from the Kentucky Military Affairs showed that two and probably the third black men buried in a small cemetery were owned by Elisha Smith. These men belonged to the 119th U.S. Colored Infantry, and are buried in a small cemetery located near

the present-day car wash on Richmond Street.

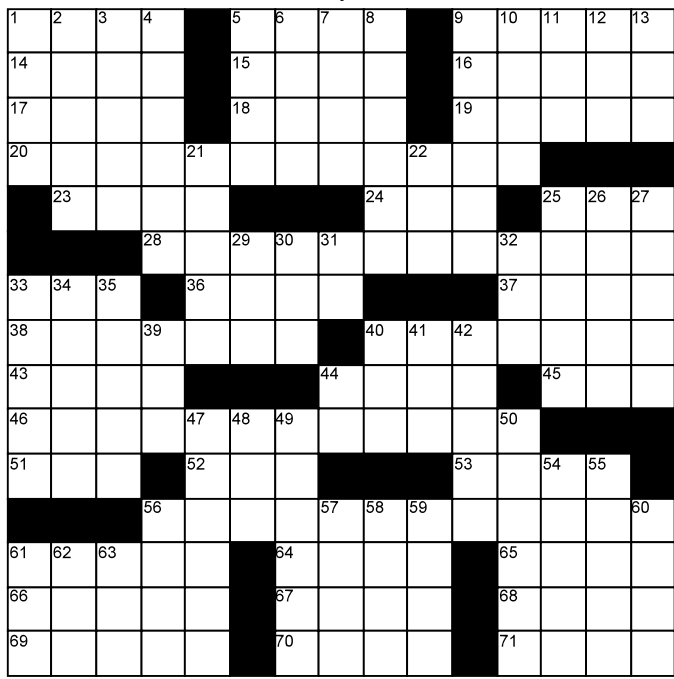
Milton Jefferson Miller prospered as a businessman and he and his descendants lived in the house later known as the Floyd Miller house located on the corner of Main and Richmond Streets. This house was built around 1860 and was

torn down in the 1970s. This site today is a parking lot.
