Tuesday is filing deadline for November election

Even though there are several races and a question about a tax increase for the Soil Conservation District on the November 4th ballot, very few people have filed to run for public office.

The question voters will say yes or no to is a tax rate of 3.5 cents per \$100 assessed value of property, set by the local Soil Conservation Board on August 17th of last year.

The tax increase by the board was stayed last October, after petitions with over 643 signatures of registered voters were collected, asking that the issue be put on this November's General Election ballot.

And, as of Wednesday a total of only eight people had filed to run for either school board, city council or the Soil Conservation Board.

Incumbent Rockcastle School Board Chairman Martin Vanzant has already filed for re-election in division four, which includes the voting precincts of Climax and Orlando. He is seeking his third four-year term on the board. He has currently served a total of ten years on the board.

Incumbent division five board member Mike Burdette has also filed for a third term. Burdette represents the voting precincts of Roundstone, Conway and East Mt. Vernon.

In division two school board, Jeff Vanhook has filed for the seat he was recently appointed to. Vanhook is filling the unexpired term of longtime board member Terry Burton who had to resign in May.

Division two is comprised of Brown, West Brodhead and North Brodhead precincts. It is the first time Vanhook has ran for a school board seat.

Incumbent Mt. Vernon City Council members Clark "Joe" Mullins and Wayne Bullock are the only two people in the city to file for council seats. Both have served several terms with three different Mayors on the Mt. Vernon council.

Incumbent Soil Conservation District Board members Jack Dailey, Roy Reynolds and Mike Barron have filed for re-election. The other incumbent, Joe Bullen, whose seat is up for re-election this year, has yet to file. If no more than four people file for the seven member board, there will no race on the ballot.

Besides the tax question and local races, contested statewide races on the ballot in November include those for President and United States Senator. There is also a race for the vacant Supreme Court seat in the third district, which includes Rockcastle. That race will attract several candidates including current Family Court Circuit Judge Walter Maguire and former Circuit Judge Dan Venters.

Venters and Hyden Attorney

Leonard Brashear have already filed for the seat and Venters has also been nominated to the fill the vacancy left by the retirement of Chief Justice Joseph Lambert.

Longtime State Representative Danny Ford and incumbent U.S. Representative Hal Rogers are both running unop-

posed.

Those interested in running in the November 4th General Election have until Tuesday afternoon, August 12th at 4 p.m. to file in County Clerk Norma Houk's office.

The last day to register to vote in the General Election is Monday, October 6th.

Saved by work release prisoner Live puppies left for dead at local animal shelter

Two mixed Beagle pups, which Rockcastle Animal Shelter Director James Kidwell, said he thought were dead when he placed them in a bag containing dead puppies a couple of weeks ago, were actually alive.

The puppy story received regional coverage from at least two Lexington television stations and raised a lot of questions as to how such a mistake could have been made.

Kidwell said Wednesday the incident that led to the mistake started during the night after he had closed the shelter, a couple of weeks ago. At that time, some pups, including the two beagles found alive, managed to get from one cage to another, that was housing a part Pit Bull.

Kidwell said when he arrived the next morning, blood was everywhere and it looked as if the pit bull had killed all

of the pups. "I put all of them in a bag and it sure didn't look like any of them were breathing," Kidwell said. "I sure wouldn't put live pups in with dead ones, if I thought they were alive," Kidwell said.

Kidwell said that about ten minutes after the bag was placed in the walk-in freezer at the shelter, where dead animals are kept before being transferred to a landfill or incinerator - work release prisoners from the jail came to transfer the dogs.

"When we walked into the freezer I heard yelping coming from where the bags were," said work release prisoner Shane Hopkins.

Hopkins said Wednesday that he told Kidwell that he thought there were live animals in the bags. "I told those guys the noises had to be coming from the last bag I had put in

Venters among nominees to fill Lambert's unexpired term

The Judicial Nominating Commission, led by Chief Justice John D. Minton Jr., today announced the three nominees to fill the vacant Supreme Court seat for the 3rd District, which is comprised of 27 counties in southcentral Kentucky.

The Supreme Court seat was left vacant by former Chief Justice Joseph E. Lambert, of Mt. Vernon, who retired June 27th.

The three attorneys named as nominees to fill this vacancy are Robert W. Dycbe III of London, Eddie C. Lovelace of Albany and former Rockcastle and Pulaski Circuit Judge, Daniel J. Venters of Somerset.

The 3rd Supreme Court District is comprised of Rockcastle, Adair, Bell, Casey, Clay, Clinton, Cumberland, Estill, Garrard, Green, Jackson, Knox, Laurel, Lee, Leslie, Lincoln, Marion, McCreary, Metcalfe, Monroe, Nelson, Pulaski, Russell, Taylor, Wash-

ington, Wayne and Whitley counties.

All schools, except RCHS, meet goals of No Child Left Behind

According to test results released on Tuesday, four of the five county schools in Rockcastle met the goals of the No Child Left Behind program, which was adopted in 2001 by the federal government.

The only school that didn't make the grade was Rockcastle

County High School, where students met only 9 of 13 performance goals, or scored 69.2% of the required 100%. The 69.2% is down from 92.3% a year ago when RCHS met 12 of 13 goals.

No drought this year

During the month of July, 4.02 inches of rain was recorded at the Cox Funeral Home Weather Station in Mt. Vernon, bringing the total amount of recorded precipitation in the county for the first seven months of the year to 29.57 inches.

That total is only ten inches shy of what fell the entire year of 2007 and nearly ten inches ahead of what fell during the same seven month period a year ago.

The high recorded temperature for July was 91 on the 20th and the low recorded temperature was 52 on the first.

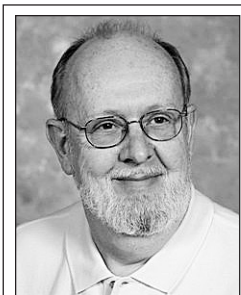
The recorded high for the year was 92 on June 6th.

Rockcastle Memories

"Flashback to 1961"

A few days ago, someone asked me if I could choose a year out of my past that was my favorite. I had to give the question some serious consideration before answering. After careful reflection, I replied that the year of 1961 was a significant and special year in my background. It was the year that I acquired my '58 Chevy and finally gained some independence as a teenager.

There were several other reasons that '61 was fundamentally important to a young man from Rockcastle County. A loaf of bread was 21 cents; a gallon of gasoline was 25 cents; a gallon of milk was \$1.05; and a new automobile cost approximately \$2,275. We could never have imagined that gasoline would escalate to over \$4 per gallon. The very idea was preposterous.

Worldwide, historic events also were taking place. Some of the major headlines included: U.S. severs diplomatic ties with Cuba; the "Bay of Pigs" invasion of Cuba; the Berlin Wall goes up; the USSR sends the first person into space; OPEC is formed to regulate oil prices; Alan Shepherd becomes the first American in space; and President John F. Kennedy sends 18,000 military advisors to South Vietnam.

Because of my penchant for rock and roll music, I took special note of the Top 40 songs that were popular in my junior year of high school. The following list is not in any particular order, they were all special to me for one reason or another. I remember most of these songs playing at nearly full volume in my teenager-filled Chevy as we cruised around Mt. Vernon.

 Where The Boys Are – Connie Francis
 Travelin' Man – Ricky Nelson

A typical date in 1961 included visiting the local "hamburger joints" and cruising the streets of Mt. Vernon, Brodhead, Livingston, and, on occasion, Berea. Many of us spent a considerable amount of time driving the 18 miles up US25 to the Skating Rink in Berea.

One night in particular, I remember having 13 teenagers in my Chevy making the trip to Berea. Of course, we were singing along to the music playing on my AM radio. I distinctly recall singing to the top of our lungs with Ray Charles on his hit song, Hit the Road, Jack.

Several new recording artists came upon the scene in '61. Among them were: Aretha Franklin, Gladys Knight and the Pips, Glenn Campbell, The Lettermen, Gene Pitney, Paul

Revere and the Raiders, The Spinners, The Tokens, and The Marvelettes with their top selling hit, Please, Mr. Postman.

Elvis Presley had another big year with the movie Blue Hawaii, which also produced a best-selling album of the same name. The Beatles were making their first live appearance at the Cavern Club in Liverpool, England. Bob Dylan made his debut in New York's Greenwich Village. And the movie musical West Side Story opened in theatres across the country.

Westerns were the most popular shows on American television. I am sure most of

An itch for an inch could earn cereal killers land in Alaska

When it comes to investing in real estate, THAT Donald has nothing on this Donald.

Points East

Unlike the kids of this day and time, I couldn't wait for classes to start back when I was a schoolboy back in the fifties and early sixties. And I used to pray for snow, not so much to get a day off in mid-winter as to make the school year last as long as possible into warm weather.

Summer was not a vacation when I was growing up there in the head of Blair Branch back in the fifties and early sixties.

Anything but! Labor Camp would be a more accurate description.

Summers meant hoeing several acres of vegetable gardens and field corn, picking strawberries, picking blackberries, picking beans, and canning, canning, canning from daylight until dark. You don't know what hard work is unless you've spent all day chopping cabbage with an empty tin can turned upside with the top edges sharpened where it had been opened. And I'm talking washtubs full of said chopped cabbage, carrots, beans and whatnot. Try sitting on the edge of the porch and spending the day stringing and breaking up a couple bushels of beans if you really want to learn about work. I have arthritis in both hands now and I blame it on the beans of my youth.

My Mom must have had at least a dozen recipes for canned relish that she put up in lots of seven quarts at a time because that's how many jars the canner held. And she figured we ought to have at least 100 quarts each of kraut, tomatoes, strawberries, blackberries, corn, pickles, apples and peaches. At least 200 quarts of beans and a like number of mixed veggies for soup mix. And then there was blackberry, rasp-

berry, and strawberry jams, apple butter and peach preserves and jellies out the kahooty. We dried beans and apples by the bushels and there's no room in the column to describe that process.

We stored at least 25 bushels of potatoes in a "tater hole" lined with straw and corn stalks and put another 20 or so bushels in an upstairs room where they wouldn't freeze so we could eat on them all winter. Two bushels or so of onions were kept in the same room along with sweet potatoes and pears.

The orchard was over a quarter mile from the house, way up on the side of a steep mountain and the blackberries and raspberries were more than half a mile up. And we didn't have just one garden. We had at least eight in any given growing season, and the largest one, (4 acres) was a mile and a half away. And they all had names. Nan's garden, Jim's garden, Ted's Garden, Stevie's place, The Big Rock Garden, The Little Rock Garden, The Creed Place, Mander's Place and Ike's Bottom; the latter of which was the aforementioned mile and a half away and consisted of 4 big acres. And everything that grew in them had to be picked and packed to the house.

Guess who did most of the gathering and packing. I do have three younger brothers and they did help—some--.

When Dad went to the grocery store during the summer he bought sugar and salt in 50 pound bags and usually 2 of each this time of year. Baking soda, gallons of vinegar, pickling spice, and quart jar caps by the gross. Lard, meal and flour

What a miracle it is to see and hold newborn life in your arms! This is my case in visiting with my new great-great nephew last week. Stanley and I had gone to Lexington to see him, as we had said last week, and even did a little shopping, visiting with friends, and celebrating our "going out" anniversary.

After fighting the traffic, the miserable heat, doing the shopping, and all that we had said, we had a very good trip back home. Stanley had bought a new piano instrumental CD that was very beautiful and relaxing; just the thing to relax you after fighting traffic all day.

While at the hospital earlier, I had laughed and joked about being a great-great aunt, and that people who didn't know better would think that I was at least eighty years old to have accomplished this.

While listening to the new CD on the way home as we drove through the night, I was discussing with Stanley my unique situation. I felt like a coin I saw in a book once. It had the face of Noah on it looking forward and backward, for he had seen time before the flood, and after. I can remember well two generations before me, and have been told stories about two or three generations before that, so I feel almost like I know them, too. Since I've been born, there have come along three new generations. I have information of at least six or seven generations stored somewhere in my mind.

One day soon, when I get the chance, I want to begin a book of remembrance for the younger generations. I know I should leave a legacy for these younger generations, and even the ones to follow them. Not only me, but others who are in this unique position, should seriously think about leaving something for the future generations.

I would hope that it would be interesting reading, to hear

about some real history and how it played out in our own family on a few occasions. My grandpa, Roscoe, who was raised right here in Rockcastle County in the Wabd community, was born at only seven months over at Hazel Patch in Laurel County. Of course he was brought into the world by a midwife, and spent the first two or three months of his life incubating between two big featherbed mattresses. He was always a small-framed individual, and quite often sickly for the most of his life. He always took pride in serving his country in World War I, often telling of his experiences to anyone who would listen. He served all over Europe, and his outfit played a vital part in breaking the Hindenberg Line, a battle that turned the course of events in Germany.

Later, his son, Junior was in World War II, and served all over Europe, as well, and saw many world-famous sights. He often laughed about his boot camp days in Texas where he was marched over seventeen hundred miles, only to serve guard duty in Germany where it was below zero, and the wind was so strong, he said it snowed sideways.

My mom, Inez, worked at Oak Ridge, Tennessee, during the time of the manufacturing of the bombs dropped on

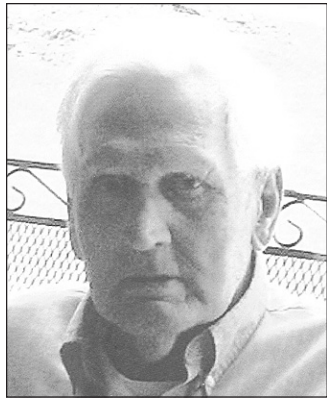

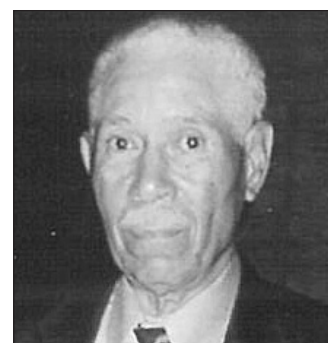

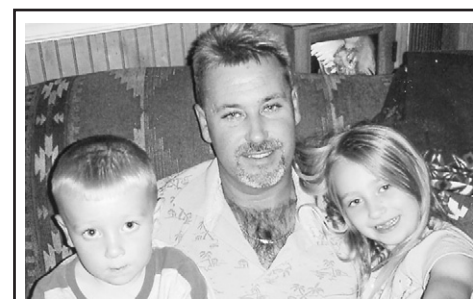

you remember Gunsmoke, Wagon Train, Have Gun Will Travel, Rawhide, and Bonanza. Other well-liked TV shows were: The Andy Griffith Show, The Real McCoys, Candid Camera, The Red Skelton Show, Perry Mason, Dr. Kildare, and Ben Casey.

In sports, Roger Maris set a major-league record by slamming 61 home runs in a single season, erasing Babe Ruth's record. In college hoops, Cincinnati won the national championship by beating Ohio State, 70-65. Floyd Patterson defended his heavy-weight boxing title twice that year. A.J. Foyt won his first Indianapolis 500. Alabama won the national championship in college football.

On a personal level, that was the summer when I was dating a blond Florida girl named Sandy. Then she announced that she had to return home from her summer visit with relatives in Mt. Vernon. On our last date, I gave her a copy of Roy Orbison's new album, Lonely and Blue. As all teenagers in similar situations, we wrote to each other faithfully for several months. But it got old, of course, and we finally decided that we were too young for a long-distance romance. I have never seen her since.

Just reminiscing about my high school days brings back very fond memories. I did not realize at the time how privileged I was and how my close friends were such an important part of my young life. I am fortunate to still call many of these "Baby Boomers" my friends today. I have been and continue to be truly blessed.

were often on the list in 25 lb quantities. He'd buy half a gallon of ice cream, a carton of Kool-aid mix, a can of Eight O'Clock coffee and a pack of Kerns cinnamon rolls if any money was left over. And that was about it for the weekly run to the A&P or to Basil Hall's Grocery in Whitesburg. Actually, now that I think about it, most of the time he would trade produce for all those staples and leave the store with cash in his pocket. There were other bills to be paid.

On Saturdays we would load his pick up with mostly bean, tomatoes and sweet corn and maybe cabbage and go peddling, door-to-door. It wasn't unusual to make three or four hauls in one day to town folk or retirees along the way who wanted to can beans or whatever but didn't have room or the get-up-and-go to grow their own gardens. I must admit that I loved those peddling trips because Dad's customers loved to see him coming and, invariably, they'd offer us a soda pop or some other refreshment or sweet delicacy and I'd come home all sugared up.

But come early August and I'd be counting the days until school started. Christmas in August and maybe even better than Christmas was what I thought about school starting back.

I especially remember a very special teacher from 6th Grade whose name was Willie J. Back. He'd bring in little paper Funeral Home fans with those little tongue-depressor handles and he'd pass them out there at Blair Branch Grade School so that he and we could fan ourselves. The school was shaded by two huge sycamores but it was wired such that you couldn't run an electric fan and have the lights on at the same time without blowing a fuse. And it still got terribly hot in August and September with oiled pine floors and a hot tin roof.

Mr. Back always wore a white shirt and he would be sweating until his shirt was wet as went from blackboard to blackboard doing arithmetic for grades 6, 7 and 8 all at the same time. I might mention here that we only had 25 students in the three combined grades and Mr. Back was a genius at keeping us all on the same learning curve.

But on afternoons in August he'd find some excuse to take us all outside to sit in the shade on the merry-go-round or lean against the sycamore trees or even perch up in their lower limbs to talk about geography or history or anything else he believed it important that adolescents figure out.

And he'd say, "I'm sorry that it's so hot, Children, but we have to press on."

And I'd stick up my hand and he'd call on me and I'd say, "It ain't nearly as hot here as it is down in that bottom where we could be picking beans."

Mr. Back would laugh out loud and slap his leg and shake his head. He knew for sure that most of us were more than glad to be back in school.

Nagasaki and Hiroshima, Japan. She was the secretary for Colonel Paul Tibbits, who flew the plane that dropped the first bomb. They dated on several occasions, and to her, he was known as "Tib."

Then there is my grandma Evelyn, who single-handedly kept numbers of people from starving and going without during the Great Depression. She fed them on her porch, at what has become known as "the beggars' table" and even gave out

feed-sack clothes to the women and children.

There are the stories about my great-great grandparents, the Slagles, or "Von Slagles," as they were known before dropping the "Von" who came to this country from Hamburg, Germany. They were German Jews. Had they not left when

they did, their descendants would probably have been killed by Hitler.

Our family is brimming full of various characters, their lives, and on a few occasions, played a small part coinciding with history. Now, to just get it all on paper before I forget it.

Marching Rockets begin regular practice

The Marching Rockets took a well-deserved break and rested last week. This week, with the start of the school year, and the Sunday evening notes from Mr. Greg Daugherty, the band began their regular practice schedule - Tuesday afternoon from 2:30 to 5 and Thursday 3 to 6. The Fall calendar is just beginning to fill and the first event to watch for is the Livingston Parade. This year it is being held on August 30th. Later that Saturday, after the parade, from about noon til 4 the band will hold a carwash and bake sale at the IGA in Mount Vernon. This will be a great opportunity for the community to show its support for these hardworking young men and women.

Football fans are familiar with the band as halftime entertainment and as the providers of what is called "stand music". At home games the "stand music" adds to the excitement and enjoyment. Apart from parades and football games however, marching bands have a season and contests of their own. Marching season happens to coincide with football season and usually the band has to perform on the day after a home football game. That means the band gets up early that post-game morn to practice and then travel to their own competition. Saturdays in autumn are long, long days.

High School Marching Band Competitions are held on a sponsoring high school's football field. Why a football field? Precise lines and spacing are essential to the performance of the band. At each competition there will be several schools represented in each of 5 classifications. The categories are A, AA, AAA, AAAA, and AAAAA. Bands compete within their classification. These classifications are determined by a 2 year average school census and not band size. Last year we competed as

AAA with 45 members in the band, counting colorguard. One school we competed against had a band size of 26 and another had a band size of 100. It doesn't appear fair, but it is how it is and it's the same rules for all.

The news has just been announced that this year the Rockcastle Marching Rockets will be competing in the AAAA classification. The census range for AAAA is from 902 to 1200. Our 2 year school population average is 915. The schools we will be up against this season are: Boyle County, Calloway County, Paul G. Blazer, Marion County, Allen County-Scottsville, Mercer County, Harrison County, Rowan County Senior, Knox Central, West Jessamine, Madisonville N Hopkins, Madison Southern, Owensboro, East Jessamine, Perry County Central, Hopkins County Central, Logan County, Pulaski County, South Oldham, Warren Central, Lincoln County, Grant County, Bullitt East, Ohio County, and Anderson County. At each competition we will most likely face 4-6 of the AAAA bands from Central or Eastern Kentucky. We will meet the AAAA bands from West Kentucky at the Semifinals.

In future columns I will attempt to explain the judging of a Marching Band Competition. It is very complicated and will be easier to explain when I have specific details and score sheets. In the meantime, it's marching time again.

The first congregation consisted of some members who came by letter and a few by baptism. One of the early baptisms was Rebecca York Burdette,

who remained a member of the church until she died in 1990.

The first pastor was Sherdan Overbay, who served the church until 1919. During the early years of Brindle Ridge Baptist Church, services were held the fourth Saturday and Sunday of each month.

Brindle Ridge United Baptist Church of Christ was the original name of what is now called Brindle Ridge Baptist. Through the years the name

evolved to Brindle Ridge Missionary Baptist and then to Brindle Ridge.

The church became a member of the Rockcastle Baptist Association in August of 1915. A letter was presented to the association, along with three messengers from the church. A few years later, the association was called the Rockcastle River Association.

During the 1940s and 50s, church services were held

Wednesday night, Saturday night and Sunday morning. Revivals lasted two weeks, with additional services during the day. The 1960s saw the beginning of the present service format of Wednesday night, Sunday morning and Sunday evening.

In the late 1960s, construction of I-75 began to crowd the church. A new church building was built at the present site on land donated by Charlie York. The new church was dedicated in 1969.

Bro. Ron Roberts and wife Jan began their ministry at Brindle Ridge Church in December of 1986.

Bro. Ron said, "This was a loving church when I came and, after all of these years, it is still the same. The church people welcome all new faces and care for each person."

A statement was made about Bro. Ron, when he first became pastor, by an older member of the church who has now passed on, Hazel Ramsey, who said "He is a small man but he is full of fire." That still holds true today. He is a loyal and dedicated pastor, according to Bill Cameron, chairman of deacons at the church. "The Lord has really blessed our church," Cameron added.

Besides Cameron, Deacons at Brindle Ridge Baptist are: Gary Burdette, Kenneth Adams, Tommy Harold Mink and Everett Thomas. Besides being

chairman of the deacons, Cameron is also the church clerk. Burdette is the treasurer and Lora Lee Mink is the church secretary.

Lewis Coffey is the Sunday School Superintendent, Mike Sowder is Youth Leader, Billy Cameron Jr., is the song leader and Marcia Coffey is the piano player. The oldest member of the church is Virgie Mink, who is 93.

Brindle Ridge Baptist

Church has approximately 150 members on the church roll and an average Sunday worship service attendance of between 75 and 80.

Sunday School at Brindle Ridge is at 10 a.m. and Sunday morning worship is at 11 a.m. Sunday night services are at 7 p.m. and Wednesday night services are also at 7 p.m. The church phone number is 256-9204.

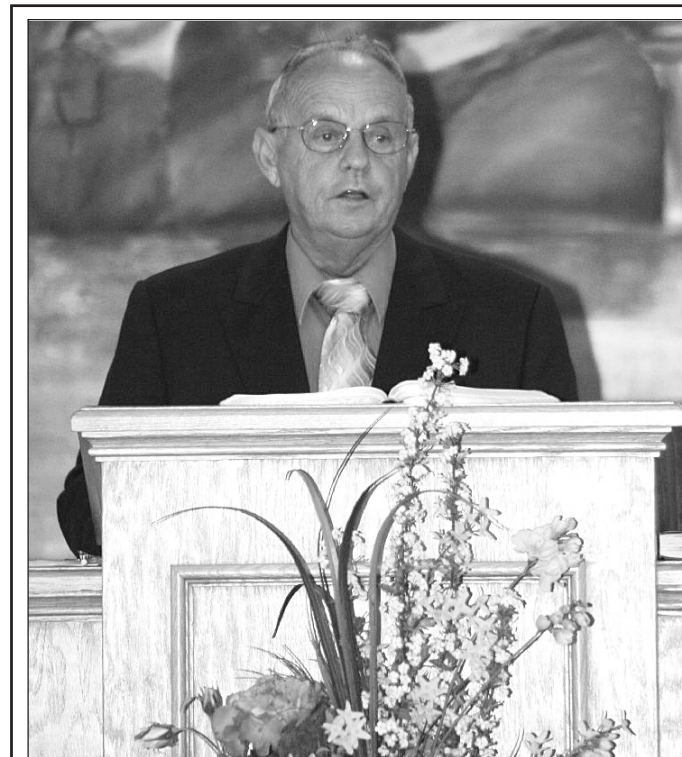

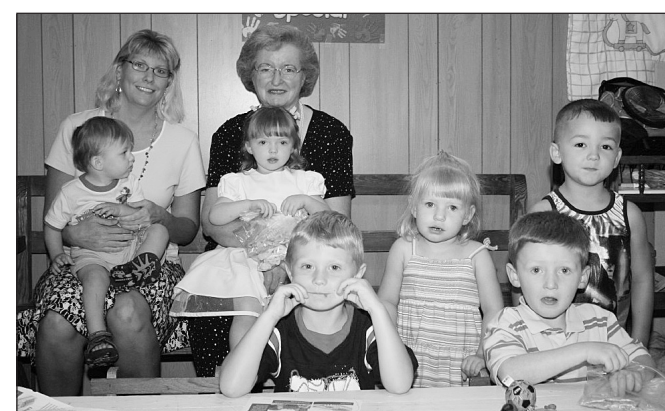

Now it's possible for you to come to the classroom after you've pulled an all-nighter working third shift or after your children have boarded the school bus in the mornings. Maybe you're a late sleeper or you work during the day and would prefer afternoon or evening classes. The expanded hours are designed to fit a variety of busy schedules. The classroom now opens at 7AM Monday through Friday and stays open until 8pm on Monday, Tuesday and Thursday. It closes at noon on Wednesday and Friday.

In addition to expanding their hours, the center is also offering individual tutoring appointments. 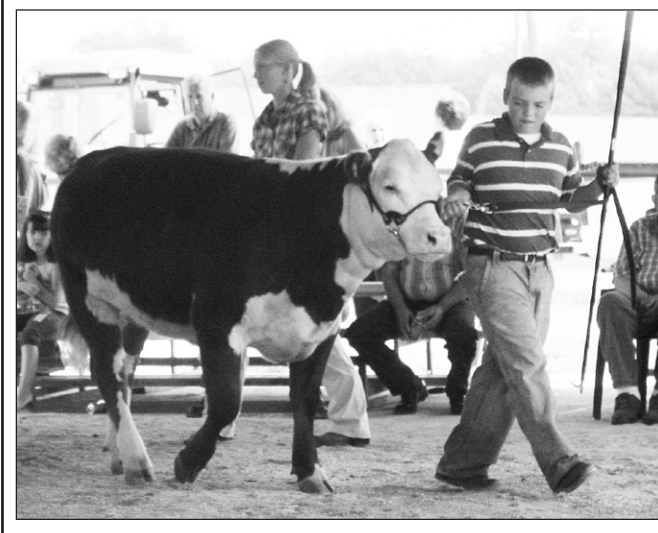

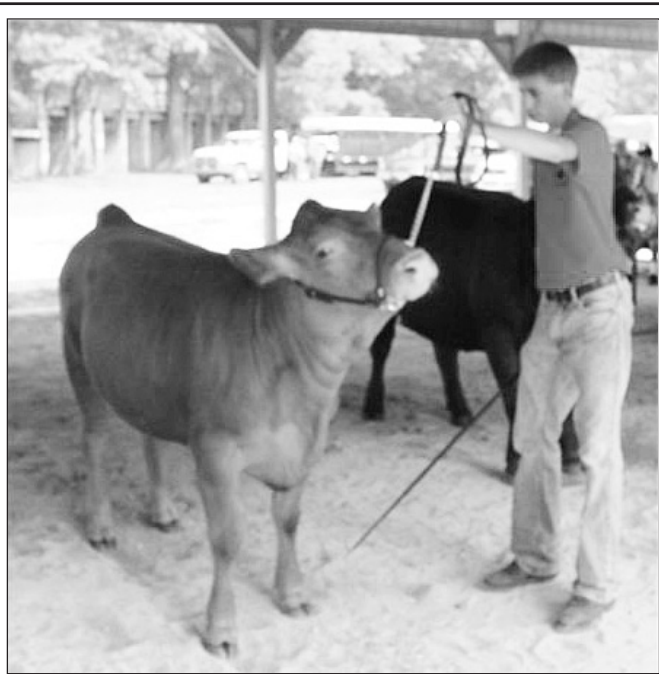

Gear Up

Make the transition year a successful one

"Ninth grade can be a make it or break it transition," says Sharon Johnston, Academic Education Program Consultant with the Kentucky Department of Education. The Southern Regional Education Board reports that four percent of all ninth-graders in Kentucky dropout during their freshman year. Kentucky also has a freshman "bulge" of 113 percent, meaning there are 13 percent more ninth-graders than there were eighth-graders because students were held back.

Johnston says so many students find the transition year difficult because it's like playing a board game where the board might be basically the same but the players, rules and outcome are all different. While the situation around them is shifting, she says, students are going through big physical and emotional changes at different rates. One freshman might look like a sixth-grader and another like a senior. "There's a lot of insecurity that can erupt if this transition is not smooth," she says.

As these changes are happening, students also face choices they didn't have before. They'll have the opportunity to ride in cars with other students, go on dates, attend parties. They might also face a different kind of peer pressure

and bullying in the high school halls than they've previously encountered.

In the midst of all of this, parents are likely to be unaware of exactly what their child is experiencing. "Middle school students are inherently pushing away from parents, which is normal and healthy," Johnston says. She remembers going through that experience with her own children and learning that more than ever before, she couldn't rely on her children to bring home information from school to keep her informed about school events and academic progress. So Johnston learned to make her own connections with the school so she could stay up-to-date with what was happening.

She advises parents not to wait until their child is in trouble, socially or academically, to visit the school and the teacher for the first time. When Johnston told her daughter she planned to volunteer in her classroom, Johnston heard the typical, "Oh, Mom!" response. No child really wants their parent at school looking over their shoulder. But then Johnston explained to her daughter that when there is a problem at the school, she will already have a better relationship with those involved so it will be much easier to raise her questions and concerns.

When moving to high school, it's not only the social scene with older teens and new classmates from other schools that confounds students. The school and academic rules and routines are also new. For some, it's their first experience of being responsible for moving from one class to another and arriving on time. They will be assigned homework that the teacher expects to be completed, but the teacher won't always collect it or follow up on it. Overall, the student is expected to take more responsibility for his or her own learning.

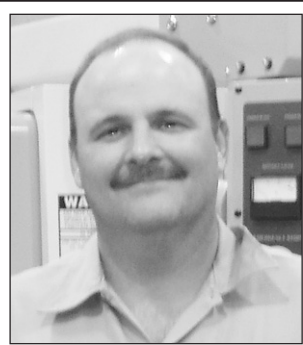
"All of those choices and

decisions are relatively new for most kids," Johnston says. "I think the key is for them to have a toolbox to go to."

Parents and other caring adults can help students prepare their "tools" by talking about situations that might come up. For example, if someone offers you a cigarette, what will you say? If someone wants you to skip school with them, how will you respond? If another student wants to copy your homework, what will you do? Discussing the situations beforehand helps the students prepare an appropriate response.

Providing that support is important to helping the student succeed during the transition year and moving forward with an eye on graduation. "It can be life changing if the outcome is not a positive one, especially if the student drops out," Johnston says. So prepare now for the transition that might go on for months into the school year and you and your child will be well equipped for all of the new challenges that await.

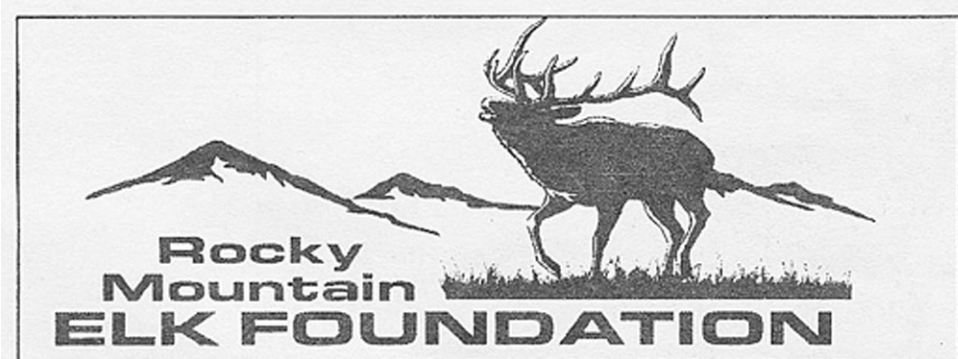

He served as assistant commonwealth's attorney for Rockcastle, Lincoln, Pulaski and counties from 1975 to

1979. He was admitted to practice by the Kentucky Bar in 1975, the U.S. District Court - Eastern District - in 1977, the U.S. Supreme Court in 2001 and the U.S. District Court - Western District - in 2004.

Robert W. Dyche III is a former Kentucky Court of Appeals judge who practices law in London. He was a Court of Appeals judge from 1986 to 2006 and a District Court judge for the 27th Judicial District, which consists of Laurel and Knox counties, from 1978 to 1986.

Eddie C. Lovelace has been a Circuit Court judge for the 40th Judicial Circuit since 1992. He was previously the Commonwealth's Attorney for

Clinton, Russell and Wayne counties from 1969 to 1992, county attorney for Clinton County from 1965 to 1969 and attorney for the city of Albany from 1961 to 1965.

Judicial Nominating Process
When a judicial vacancy occurs, the executive secretary of the Judicial Nominating Commission publishes a notice of vacancy in the judicial circuit or the judicial district affected. Attorneys can recommend someone or nominate themselves. The names of the applicants are not released. Once nominations occur, the individuals interested in the position return a questionnaire to the Office of the Chief Justice. Chief Justice Minton then meets with the Judicial Nominating Commission to choose three nominees. Because the Kentucky Constitution requires that three names be submitted to the governor, in some cases the commission submits an attorney's name even though the attorney did not apply. A letter naming the three nominees is sent to Gov. Steve Beshear for review. The governor has 60 days to appoint a replacement, and his office makes the announcement.

Whoever is appointed by the Governor will only serve on the high court until the November 4th election. The winner of that election will then serve the remainder of Lambert's term, which runs through 2010.

the freezer and after we got it open, there was two of them alive - we got them out and I cleaned them up - but they sure didn't show any signs of life when I put them in the bag," Kidwell said.

Kidwell said he fixed the faulty cage which allowed the pups to get out of their cage and into the other one, the next day.

A few days after the pups were found alive, Hopkins' fiancée, Jessica Lawrence, adopted the dogs from the animal shelter.

"They almost died once and I didn't want them to have to be put down after all of that," Lawrence said.

"I think more attention should have been paid and when I took them to the Vet he said the pups didn't have any signs consistent with being attacked. Me and Shane both love animals and I hope this doesn't happen again," she said.

Lawrence, who is 17 and lives on Strawberry Lane, said she was going to give the puppies to someone who could provide a good home for them. "I've got someone coming Thursday to look at them," she said.

The Rockcastle Animal Shelter is located on Deep Hollow Road, off Old Sigmon Road in the Roundstone area of the county.

There is no charge to drop off animals at the shelter, which is open Monday through Friday 8 a.m. to 4 p.m.

Kidwell encourages the public to stop by the shelter during business hours and to possibly adopt a pet. "We've always got a lot to choose from and the fee is only \$20 to adopt and we sure would rather them be adopted rather than have to be put down," Kidwell said.

The animal shelter director said the number of animals at the shelter at any given day varies, but on Wednesday there were 68, although local veterinarian Dr. James Chism was scheduled to euthanize several of them some time this week.

"We usually have a lot to choose from and I hope people will help us find homes for all of them" Kidwell said.

Before attempting to make the right turn onto Main Street, the driver apparently locked up his brakes, causing him to lose control and drop off of the pavement and make contact with the rock wall. Rebecca Isaacs, assessment coordinator for the local school system, said NCLB goals were harder this year as targets for the percentage of proficient math and science increased by about 10 percent.

However, it was the third year in a row, the high school didn't meet the requirements of NCLB.

Isaacs said that even though the high school did not achieve their goals, the test results will not effect them in any way because they do not receive Title I funds.

"Schools that receive federal funds for a high number of low-income students are held accountable by law in Kentucky. But, since no Title I funds are spent at the high school, these test scores really do not effect them," she said.

RCHS failed to meet their goals in all areas of math, according to Isaacs.

"Because of the success of the other schools in the county, the district, as a whole, got a passing grade," Isaacs said.

According to the U.S. Department of Education, **No Child Left Behind** is a federal law adopted in 2001 that measures achievement in public schools based on state test scores in reading and math.

The goal is to make sure all students, regardless of socioeconomic status, racial classification or mental capability, reach "proficiency" by 2014.

Results for NCLB come from the annual tests taken each year under CATS, or the Commonwealth Accountability Testing System.

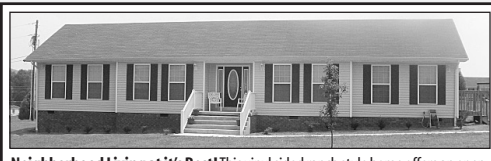

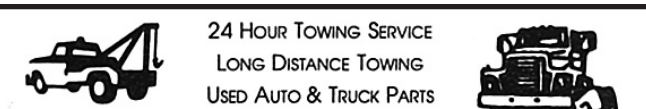

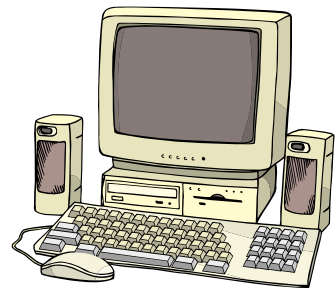

Robbins creates brooms at KY Artisan Center

On Saturday, August 23, Christopher Robbins of Brodhead will demonstrate broom making from 10:30 a.m. - 3:30 p.m. at the Kentucky Artisan Center at Berea.

At the age of 14, Chris Robbins began working in the Broom Shop at the Bittersweet Cabins in Renfro Valley, Kentucky, where he developed a love of broom making. Chris then had the good fortune of meeting master broom maker Jim Harmon, of Springfield, Kentucky. Mr. Harmon has been instrumental in teaching Chris the basics of broom making and has helped Chris refine his skills and acquire the equipment needed to produce brooms.

Chris makes all of his brooms either totally by hand or with the assistance of 100+ year old broom making equipment. Chris uses a 100-year-old winder that was constructed with wooden pegs to attach the broomcorn to the broom handle. His vice, which is used to tie the brooms, is dated September 10, 1878. Chris's Shaker-style brooms are not only works of art but are extremely durable and useful.

Broomcorn, used to make brooms, is a member of the millet family. Its botanical name is sorghum vulgare. This tall plant has little foliage and woody stocks, but looks somewhat like sweet corn. It produces bristles laden with seeds rather than an ear of seed. The bristles are processed after drying in multiple ways depending on how they will be used in producing brooms, brushes, or in floral arrangements.

Chris has continued working at his craft in a workshop at his home. He recently was given an 1860's log cabin that once belonged to his ancestors and he is restoring the cabin to one day house his broomshop and craft store. In 2002, Chris was juried into the Kentucky Crafted Marketing Program - one of the youngest craftsmen

Agricultural News

Committee meeting
The Rockcastle County Farm Service Committee (COC) will hold its monthly meeting Thursday, August 7, 2008 beginning at 8:00 a.m. The meeting will be held at the FSA office.

The COC members are vital to the day-to-day operations of FSA. The COC members help FSA at the local level by deciding the kind of program their county will have and how they will operate. FSA committees operate within official regulations designed to carry out Federal laws and applying their judgment and knowledge and knowledge to make decisions.

Deadline extended
The 2008 final crop reporting date for all crops except small grains has been extended to August 15th, for the 2008 crop year ONLY. If the crop has NAP coverage, the crop must be reported the earlier of the final reporting date or 15 calendar days before the onset of harvest or grazing of the specific crop being reported.

Direct and Counter-Cyclical Program signup
USDA's announcement for signup in the 2008 Direct and Counter-Cyclical Payment Program (DCP) helps deliver certainty for the crop year and the option of a timely advance payment. Contracts are now available at USDA Service Centers and signup will continue until September 30, 2008.

Generally, no producer on a farm that has a total of 10 base acres or less shall be eligible to receive payments on that farm, as determined by the Secretary. However, such a prohibition does not apply to a farm that is wholly owned by a socially disadvantaged or limited resource farmer or rancher. If the farm is owned by a legal entity, such as a corporation, each member of the entity must be a socially disadvantaged or limited resource farmer or rancher. Socially disadvantaged farmers and rancher and limited resource farmers and ranchers are defined as:

- (1) Socially disadvantaged farmer or rancher: a farmer or rancher who is a member of a group whose members have been subjected to racial, ethnic, or gender prejudice because of their identity as members of group without regard to their individual qualities.
- (2) Limited resource farmer or rancher: a farmer or rancher meets both of the following:
 - (a) directly or indirectly has gross farm sales not more than \$100,000 in both of the previous 2 years (to be increased starting in FY 2004 to adjust for inflation using Prices Paid by Farmer Index as compiled by NASS); and
 - (b) total household income at or below the national poverty level for a family of 4, or less than 50 percent of county median household in-

come in both of the previous 2 years (to be determined annually using Commerce Department Data). For Rockcastle County this amount is \$19,350.00.
