Local woman hurt in ATV accident Labor Day

It took rescue workers nearly two hours Monday afternoon to locate a local woman hurt in an ATV accident and get her to an awaiting helicopter for transport to the University of Kentucky Medical

Rockcastle Sheriff Mike Peters said Tiffany Frith, 28, of Hwy. 1505 Brindle Ridge, was hurt in the 2:45 p.m., accident after she fell off the back of the ATV her husband, Chris Frith, was driving.

Peters said the ATV hit Frith

in the head and chest as she was falling from the 4-wheeler.

The Sheriff said the accident occurred in a remote section of the Copper Creek area, near the Rockcastle/Garrard County line, about four miles from Copper Creek Road.

Peters said the Friths were with some other people who were four-wheeling on the log roads in the area and that someone in the group was apparently able to reach authorities

Mt. Vernon council agrees to Hanson request

During a special called meeting last Thursday night, the Mt. Vernon City Council authorized Mayor Clarice Kirby to finalize a deal with Hanson Agregates, which would give them right-of-way on less than a tenth of acre at the city park on Williams

Hanson had asked the council last month to give them the property which is located at the rear of the park and which would involve shortening the walking track.

Hanson officials said the land was needed to help them complete a \$6 million expansion project at the quarry.

That project is being done so Hanson can sell railcar loads of rock to Georgia Power.

The current CSX railroad track is being refurbished to make it easier to get the railcars in and out of the plant, with work expected to be completed in November.

Hanson officials said they needed the extra property so CSX would have enough room to move the cars in and out

In return for the right-ofway agreement, Hanson said the would do all of the work involved in the project, which included modifying the walking track and give the city 100 tons of materials from the quarry each year for the next five years.

The Mayor said Hanson's proposal did not offer any room for negotiations.

After the ordinance is published, property owners will then have 60 days to file a petition with the city, if they oppose the annexation.

At least 50 percent of the landowners, which are in the proposed annexation area, must sign any such petition for the matter to be placed on the 2010 General Election ballot. A map of the areas to be annexed is available at City Hall on Richmond Street.



Rockcastle | Memories

Let the Night Games begin When I was a youngster living with my grandparents, it was a custom to gather all the neighborhood children after dinner to play childhood games in our yard. Mommie Katie and Pop preferred an early dinner and that was alright with me it gave me more time for games

before bedtime.

In those days, we knew how to entertain ourselves. Our imaginations were limitless, but most of the games we played were common experiences to most anyone growing up during that era. For example, while it was light, we rode our bicycles and played marbles or Mumbly Peg (also called "Mumbledy" Peg by some).

Now Mumbly Peg was a boy's game for sure. I never saw a girl play the game because it involved pocket knives. We usually picked out a nice shade tree in an area where the grass was cut close to the ground; there we formed a circle of boys sitting on the ground.

The object was to toss the knives in a variety of 24 ways to make the blade stick into the dirt. If you missed one of the tosses, then it was the next person's turn. After many tries, each of us would complete the tosses and the looser had to "chew the peg."

The winner prepared a wooden peg (made with a stick) about 2 inches long and pushed it into the ground. All players took turns "whacking" at the peg with the back side of the closed knife, until it was driven down to the surface of the ground. The loser had to lie on his belly and dig the peg out of the ground with his teeth. Usually the loser spent lots of time spitting out dirt until the peg was successfully removed. (Another reason why girls didn't play this game.)

After such a competition, we were ready for a snack. Sometimes we walked up the road to the gas station to buy a small Coke and a bag of peanuts. The peanuts were poured into the soft drink, yielding a most enjoyable concoction with a salty taste. Some of my friends purchased another combination that became a standard and which endures to this day: an RC Cola and a Moon Pie.

Occasionally, we stopped at a small orchard on our way back home and literally filled our pockets with juicy June apples for something to munch on later. As the song says, "Oh, those were the days, my friends!"

When darkness set in, it was time for a game of Kick the Can. This game is much like hide and seek, in which one

player is "it" and the others run off to hide. The person who is "it" must find each of the hidden players and tag them. The tagged players then sit close to the tin can and wait for the others to be found. Any player who has not been caught can kick the can, setting all of the captured players free. If "it" catches all of the players, he or she wins. And the next go 'round continues.

On some evenings, we would take time from our games to catch June bugs. Boys would tie a string around their hind legs and watch them fly in dizzy circles above our heads. The girls usually caught fireflies, which they secured in Mason jars to light up the yard. Anyway, all of us were chasing insects all over the place. (Why is it that kids like to do that? For some reason, it is always fun.) Pop used to encourage us. He'd say, "Let them catch all of the bugs they can."

About the time we had spun ourselves out, Mommie Katie would yell, "Come and get your Kool-Aid while it is cold!" Immediately, we stopped whatever we were doing and ran to satisfy our thirsts. She served those drinks in the aluminum, brightly colored, iced tea glasses that were so popular at

Sometimes she also offered us home-made, chocolate chip cookies that she had prepared while the night games were being played. While we were enjoying our snacks, we sat on the edge of the high porch, listening to the adults tell stories. Then, all of a sudden, one of the children would yell, "It's time to play." And off we would go again!

There were also those evenings when we sat in a circle under a huge Mulberry tree in Pop's front yard to tell ghost stories. One of my friends, Kenneth Hansel, was especially good at this, and he usually managed to get us to the place where we were turning our heads to see if the "boogie man" was behind us.

That same big, old, Mulberry tree was a great tree for climbing. It had long, strong, spreading branches that we crawled upon. It was a great place to watch the other children as they played in our yard. I can't tell you how many hours I spent in that mature giant. Sometimes I climbed up in "my old friend" just to take note of the birds that shared my perch.

After our games had been in progress for quite some time, I dreaded to hear the call that would put it all to an end for the day. My mother or grandmother would yell, "David Joe, it is time to come in and get

Happiness is not just around the corner unless you have some medical help.

All of which is beside the point because I read my email late in the day on Monday, on the verge of deciding to not write a column, (it is, after all, Labor Day) when I had a missive from good friend and penpal Terry Collison.

Terry shared with me a column written in 2001, on Labor Day, by Paul Greenberg, editorial page editor of the Arkansas Democrat Gazette. The column was all about lessons learned in making shoes and the values to be learned from making and keeping up a good pair of shoes.

(You can google up the colbut it's all beside point now)

Because I got to thinking about the first pair of Bass shoes I ever owned.

I was a freshman in high school in 1963 and the most expensive pair of shoes I'd ever owned cost less than five bucks and they'd been ordered from

Spiegel catalogue. High top, Italian style, ankle boots, they were. Thin soled and fancy. The first pair of shoes I'd ever owned that needed colored shoe polish instead of mink oil to make them soft and supple.

So I'd walk out the mouth to the holler for a mile and a half to catch the school bus but I'd be packing my dress boots in a bag and wearing the old work boots on anything that involved dirt. I wore the Italian boots only in the halls of Letcher High and they lasted up till about Christmas and I took them to a shoe store there in Whitesburg to have them half soled and Mr. Back, who ran the place looked at me and said. "Sorry son. These fancy boots can't be fixed. Nothing left to sew anything onto Now let me take at look at your regular shoes".

The regular shoes were brogans. Stiff leather, durable, made to last insoles that were not really broken in until they'e had at least a new sole or two and new Cat's Paws heels hammered into the backside. And Dad used to say that the longer you wore them shoes the better they'd feel until they got to little and then you could pass them on down to brother Keeter and he wouldn't have to worry about breaking a new pair in while you strutted about in brand new shoes. And if a tack came up through the sole, Dad had a shoe last and a hammer and he could flatten it right out before it cut your heel or the ball of your foot up too bad.

So one day after I'd been in high school for about three months and my fancy mail order shoes were gone and beyond repair and I'd been duly humbled by my classmates, I was at the cobbler's where it cost 75 cents a shoe for heels and half soles and Mr. Back said to me. "How would you like to own a pair of Bass Oxfords?

And I said, "Who wouldn't " because it was a dumb question to a teenager and I thought he was just passing time? I figured he was just making talk while I sat there barefooted as he sewed on some new half soles and hammered some heels onto my old brogans and then he said, "Look at these and he handed over to me the most stunningly beautiful pair of top grain, pure black, size 9 and a half, well-repaired to like new,

Casey County woman's love story is certainly fur-fetched

Travel down Belden Avenue in Liberty and you may see a tall, red-haired man sitting on his front porch, strumming a

A good ol' boy from a local band, perhaps, or a Grand Ol' Opry wanna-be?

Hardly.

Take a closer look and you might remember him from American Bandstand or the David Letterman Show.

Maybe you were among the thousands of screaming fans at a concert venue, when he stood alongside his brother Richard and fellow band members known worldwide as the Psychedelic Furs.

When she was 13, Casey native Robyn Wesley became a fan of the group that diehard fans refer to as simply, the "Furs."

"I had friends who were into alternative music, and we loved the Furs because their music was just so different," says the now 40-year-old head bookkeeper at the Casey County

Formed in England, the Furs were part of the 1970s new wave punk scene that included such renowned performers as Blondie and Billy Idol.

Co-founders of the group that first came together in 1977 were brothers Richard (vocals) and Tim Butler (bass guitar).

After a successful debut in England, they became major players in America in the early 1980s with release of their album titled "Talk Talk Talk" and their original version of "Pretty

in Pink." This song was later used in a major motion picture by the same name, starring Molly Ringwald.

By the time she graduated from high school in 1985, tall, pretty, and blonde Robyn knew all the group's songs by heart.

Even after marriage, two children, and a divorce, her love for the group and their music never waned.

It was at a Cincinnati concert in 2000 that she got to see and meet all the band members for the first time, an encounter Tim claims he doesn't recall," says Robyn.

Over the next several years, she was in the audience when they appeared anywhere near Liberty, such as Nashville and Atlanta, standing amid other admiring fans mouthing the words to such favorites as "Love My Way." At another brief meeting in Atlanta three years later, Blondie was part of the show, and security was extra tight, leaving them little time together.

"Like a fool, I asked them for autographs at every concert," she says, laughing.

Thanks to modern technology, Robyn's connections to Tim reached a new level on January 4, 2007, at 4:45 p.m.

'That's when he sent the first My Space message to me.

"As a divorced mom with two children, My Space was my social life, but I knew I had to be careful.

"I made him go out and get a web cam to prove it was him I was talking to," she says.



I admired the shoes and held and caressed them like somebody else might have caressed a new 17 jewel watch and I said to him, "One of these days, I'm going to have a pair of shoes like these.'

And he said to me as he handed my old work shoes back, all brushed up with on his big polishing wheel and the saddle soap all polished in with the new soles and the fancy cat paw logoed into the heels so that the old shoes looked way better than when they were new, "Ike Reece. " he asked. "Do you reckon you could take good care of that pair of Bass shoes there, it if I was to let you take them home with you? I'm going to let you have them if you'll take care of them".

I don't remember speaking. But I'm sure I nodded my head up and down so rapidly that my neck came close to breaking and my heart was beating faster than anyone who has ever won the lottery.

He read my mind before I even had a chance to ask the "why are you doing this questions." And waved them off before I had a chance to ask.















Rockets win Ray Correll Bowl game, 34-23

Parkey era begins with 34-23 win at PC

The newest era in Rockcastle County High School football is underway on a very positive note, after a 34-23 win on Friday night in the Ray Correll Bowl.

First year head coach Scott Parkey's team defeated the highly touted Pulaski Maroons in a game that saw four lead changes, before the Rockets took charge in the second half.

In that second half, defensive coordinator Josh Martin's squad held the Maroons to negative yardage on the ground, while allowing only one score through the air on the first play from scrimmage in the half.

Parkey credited his team's efforts on a night that saw several PC players leave the game because of cramps.

"The heat was a factor and I appreciate the fact that our players have worked very hard

through the air.

this summer to get in shape, it showed on Friday night that we are in the best shape a Rocket team has been in several years," Parkey said.

The head coach also had praise for his special teams. "That could have been the difference in the game, because they (the special teams) played mistake free and allowed us to keep good field position all night long," he said.

But the 34-23 score was not indicative as to how close the contest was, although the Rockets took the opening kick and rammed the ball down the Maroons' throat on a 70 yard scoring drive.

That drive resulted in a 9yard touchdown pass from junior quarterback Dustin Bishop to freshman Clark Rowe.

However, the Rocket lead would not hold up.

Late in the first period, PC quarterback Chris Muse gave

the Maroons a 7-6 lead with a 23 yard touchdown pass.

And in the second quarter, PC added to their lead with another score on a 23-yard touchdown pass. They missed the extra point attempt, but led 13-

Rockcastle would fight back in the second period, when senior tailback Casey Hayes finished off a long drive with an eight yard touchdown

But the Maroons came right back, scoring on a 25 yard field goal, with about two minutes to play in the half, to take the lead again 16-13.

However, the Rockets weren't ready to head to the locker room just yet.

With just 51 seconds on the clock, Bishop hit senior Dustin Bullock on a pass that covered 58 yards and resulted in the third Rocket score of the game. Bullock made a very good adjustment on the ball and a good run into the end zone.

Bishop, who made four of

five extra point attempts on the night, added the extra point and the Rockets would take a 20-16 lead into intermission.

But the second half didn't start as the Rockets had hoped.

The Maroons returned the opening kickoff 46 yards back to the Rocket 34 yard line and on the first play from scrimmage, their backup quarterback threw a touchdown pass.

With just 16 seconds off the clock in the second half, the Rockets again found them-

selves behind, this time 23-20. But that is when the Rockets' physical condition kicked


The Rocket offense could not get much going in the second half, but the defense was relentless and the next time the Rockets took the lead it would be thanks to the special teams.

After the Rocket defense pinned the Maroons down deep into their territory, the Maroons managed only a nine yard punt, which was returned for a touchdown by sophomore John L.


That return covered 25 yards and gave the Rockets the lead for good, at 27-23.

The Rockets added another score in the fourth period on





Rockcastle County High School sopomore Sara Hammond was in the stands on Sunday as UK took on UofL in the season football opener, but it was as the guest of the University of Louisville. Sara was one of several athletes in several sports invited as a possible recruit for the Cards. Also on hand from Rockcastle was Rockcastle senior baseball standout Tanner Perkins. Both Hammond and Perkins have been offered athletic scholarships at Louisvlle.

The scholarship offer from the University of Louisville was made this past July and perhaps is the earliest athletic scholarship offered to a Rockcatle County athlete. It came after a stellar summer for the Lady Rocket sophomore, playing for the Blue Chip All-Stars 17 & Under team at the Run for The Roses tournament in Louisville with all-star teams from all over the country and hundreds of division coaches in attendance.

A week later Hammond was named MVP of the Blue Chip camp held at Bellarmine University. The camp included players from 43 states, 3 foreign countries and close to 300 players. Rockcastle County junior, Jackie Alexander also had an outstanding week and along with Hammond was named to the Top 20 All-stars.


Joining Sara for an unofficial visit to U of L this weekend were her parents, Eddie and Roxanne Hammond of Mt. Vernon. Coach Waltz told others in attendance, "she can play." He also told Sara in a recent conversation that she was one of Louisville's top recruting targets for 2011.

The Lady Cardinals came within a "eyelash" of beating top ranked Connecticut in the Big East tournament final and pushed the University of North Carolina to the brink before falling the the NCAA Sweet Sixteen. They finished the year ranked #12 and will all likely be a pre-season top 10 team this season as they return a player in Angel McCoughtry who will be in the running for Player of the Year and some predict a #1 WBNA draft choice. Louisville has made a commitment to recruit Kentucky's top athletes with three of the top players for 2008 joining the squad this year and verbal commitments from Warren East's Ashley Rainey(2009) and Christian Academy of Louisville's Antonita Slaughter (2010).





Buy-In waiver for supplemental agricultural disaster assistance programs

USDA's FSA will allow producers who would otherwise be ineligible for the new disaster assistance programs to become eligible by paying a fee as required by the Food, Conservation and Energy Act of 2008.

Under the 2008 ACT producers who wish to participate in the new disaster programs must have crop insurance or non-insured crop disaster assistance (NAP) coverage for the land for all farms in all counties in which they have an interest.

Producers who meet the definition of "Limited Resource" do not have to meet the Risk Management Purchase Requirement and therefore: are not required to ay the buy-in

The buy-in fee for 2008 eligibility only for NAP is \$100 per crop, but not more than \$300 per producer per county for a total of \$900 for all coun-

First place winners will receive a plaque.

Second place winners will

receive a plaque.

Third place winners will receive blue ribbons.

- 1. Poster must be created by a currently enrolled 4-H'er.
- 2. Well known cartoon figures cannot be used because they are copyrighted. (Examples: Looney Tunes, Sponge Bob-Square Pants, Blues Clues, Mickey Mouse, Star Wars, Spiderman, Charlie Brown, Pooh, etc.)
- 3. All posters must be designed on, or affixed to, .016 ply construction paper, poster board (solid fiber board) of 14 inch x 22 inch dimensions (onehalf a standard poster board size.) They may be horizontal or vertical. Posters may be pro-

duced by any medium... watercolor, ink, crayon, acrylic, charcoal, oils, or collage, so as long as they are not three dimensional.

- 4. 4-H is to be the topic for the poster. You can show what you think 4-H is, what you do in 4-H, what you think 4-H does for young people.

Healthy beef, healthy budget

Many consumers may make the mistake of skipping specific foods or food groups to save money. Eliminating one type of food from the diet can be a costly decision when it comes to good nutrition. Healthy foods like lean beef don't have to bust the family budget. It's all in how you count your pen-

nies – and your nutrients. When pricing food, consumers should factor in nutritional benefits and cost per serving to understand the full food value. For example, beef is priced per pound, not per serving. If you pay \$2.79 for 1 pound of ground beef, you are actually paying 69 cents per serving, because 1 pound yields four 4-oz portions.

"High food prices these days are due to lot of factors consumers can't really control. So they're looking for ideas on how to serve nutritious family meals in an economical way," said Alison Smith, director of consumer affairs for the Kentucky Beef Council. "Beef fits the bill and is always a familypleaser."

Additional "food for thought" from the Kentucky Beef Council.

•Beef is a nutrient powerhouse, providing less than 10 percent of calories to a 2,000calorie diet per 3-ounce serving, yet it's an excellent or good source of nine essential nutri-

•The 2005 Dietary Guidelines strongly encourage Americans to first choose nutrient rich foods and beverages from each of the basic food groups. These foods deliver the most nutrients in the fewest calories.

•Emerging research suggests that high-quality protein, such as lean beef, plays an increasingly important role in muscle maintenance, weight management and disease prevention.

•Not all proteins are equal. Consider that a 3-ounce serving of lean beef (179 calories) contains about the same about of protein as 1 1/2 cups of legumes (an average of 360 calories) – but in half the calories.

Some additional tips to stretch budgets and beef pur-

•Plan ahead. Shop for specials and freeze extra purchases. Roasts and steaks can be frozen for six to 12 months; ground beef can be frozen for three to four months.

•Consider cuts from the chuck, sirloin and the round for economical family beef meals.

•Know the best way to cook the beef you buy. Even less tender cuts, such as flank steak, offer a delicious eating experience when prepared properly.

•Get advice from your local meat market manager or Internet sites such as www.BeefItsWhatsForDinner.com.

•Prepare once, dine twice. For example, save roast beef leftovers and use them later in the week for beef fajitas to stretch your food dollar.

The beef council's beef promotion, research and education efforts are funded by the Beef Checkoff, a market development fund supported by beef producers and importers. Checkoff dollars are divided between state and national programs, with each level receiving 50 cents of the \$1 beef checkoff collected per-head on the sale of live domestic and imported cattle and imported beef/beef products.

Northern creates baskets at Berea Artisan Center

On Saturday, September 20, Janet Northern of Mt. Vernon will create baskets using honeysuckle vines and willow bark from 10:30 a.m. - 3:30 p.m. at the Kentucky Artisan Center at

Janet Northern has been making baskets for thirteen years and is primarily selftaught. She utilizes the wood and natural vines that she finds and gathers in the region surrounding her Rockcastle County farm to create her baskets. The Eastern Kentucky woodlands give Janet inspiration as well as material from which to work.

To prepare the honeysuckle vines, Janet boils the vines for 30 minutes and then strips off the outer bark to reveal the honey colored, pliable surface of the vine. When the vines are freshly cut they are pliable, but over time they dry out and need to be soaked in water to resoften them. Janet's smaller baskets are often made with reed and driftwood.

Starting with an interesting piece of wood, Janet begins to design her asymmetrical oneof-a-kind basket forms, often creating multiple openings. She soaks the honeysuckle vines in water, attaches them to the piece of wood chosen, and begins to weave her forms into asymmetrical and beautiful shapes.

Janet also creates baskets from the inner bark of willow trees. These are usually started with a criss-cross pattern and a square bottom. She tapers the willow bark into varying widths depending on the size and function of each basket. The bark is kept supple by soaking it in water before weaving.

Works by Janet Northern can regularly be found at the Kentucky Artisan Center at Berea, located at 975 Walnut Meadow Road, just off Interstate 75 at exit 77 (Berea). The Center's exhibits, shopping, and travel information areas are all open daily from 8 a.m. to 8 p.m. and the café from 11:00 a.m. to 7:30 p.m. Admission is free. The Center currently features works by more than 650 artisans from over 100 counties from all across the Commonwealth. 
