#### Tompkins among four indicted by Grand Jury

A Mt. Vernon man, accused of threatening the life of Circuit Judge Jeffery T. Burdette, was one of four people indicted by the Rockcastle County Grand Jury on Friday.

Steven Edward Tompkins, 36, of White Rock Road, was indicted on four counts of retaliating against a participant in a legal process, for threats he made against Burdette in August on the Internet.

The threats were posted on Topics.com, under a forum entitled, "Let's Assassanate Jeffery T. Burdette," according to a news release from the Kentucky State Police.

According to Rockcastle County Attorney Billy Reynolds, the postings on the Internet included seveal threatening comments by Tompkins, who went by the handle "Big D Daddy." At one point Tompkins asked, "who wanted

to put a bullet through Jeff Burdette's head., I do for one...." and ..."I'm thinking soon I'll begin my rampage, probably in a couple of days," said Reynolds.

Burdette is the Chief Circuit Judge of the 28th Judicial Cirwhich includes, Rockcastle, Lincoln and Pulaski and is also a former County Attorney in Rockcastle.

#### Pedestrian dies after being hit by pick-up

killed Friday evening, after being hit by a truck, while she lay on Williams Street in Mt.

According to Kentucky State Trooper Coby Smith, witsaid Frances nesses Higginbotham, 55, of Mt. Vernon Manor Apartments, was lying near the railroad tracks beside the city park, when the 6:40 p.m. accident occurred.

Trooper Smith said Travis Smith, 21, of Mullins Street, Livingston, hit Higginbotham

A Mt. Vernon woman was with his 1995 S-10 pickup truck, after he crossed over the hill crest at the railroad crossing, because he could not see her lying in the roadway.

> "There was absolutely nothing he could do to keep from hitting her, he simply did not see her," Smith said.

Eyewitnesses Doug and Sue Hamm, who were traveling south on William Street, toward the railroad track, said that Higginbotham appeared to be conscious when they first noticed her lying in the road and they attempted to warn oncoming traffic, but things happened too quickly.

"He (Smith) couldn't see her (Higginbotham), and there was no way he could stop, that is a really bad place," said Sue Hamm.

Rockcastle County Coroner Bill Dowell said that Smith's truck drug Higgonbotham approximately 90 feet before coming to a stop.

Higginbotham was taken by ambulance to the Rockcastle Hospital, after members of the

A called meeting was held last Thursday of the fiscal court, with representative of Ross, Sinclair & Associates, investment bankers who had been asked to prepare a proposal for the county for financing to build a plant facility for SourceCorp.

During that meeting, Ross,

that would obtain financing through leased money from the Kentucky Area Development District. However, this financing proposal was determined not to be feasible since Ross, Sinclaire had thought the county was pledging all the revenue from the occupational tax as collateral for the \$5.2 million loan. Several other means of financing were discussed at the meeting, including using Community Trust Bank for part of the loan. However, nothing was decided.

On Tuesday, at the regular meeting of the fiscal court, (Cont. to A14) County Judge/Executive Buzz Carloftis told the court that, after a conversation between him and Lonnie Campbell, with the state local finance office, it had been determined that the best route for financing the building would be through Industrial Revenue Bonds.

Carloftis told the court that this method would be the quickest and cheapest for the project and would not be counted against the county's debt obligation.

Jim Holton, consultant for the Rockcastle Industrial Authority, agreed with Carloftis.

#### County will participate in "The Blast" next year

A huge event is in the early planning stages for Rockcastle County for July 4, 2009.

The event, being called "The Blast" will take place at Renfro Valley and will start in early afternoon and culminate with a huge fireworks display after dark.

Alumni of Leadership Rockcastle has a tourism taskforce which came up with the idea and will be working on other tourism-related projects for Rockcastle County, over the next few year, according to Jerry Pensol, a member of the taskforce, who spoke to the fiscal court on Tuesday about their needed financial involvement in the event.

Pensol explained that the event would be free to the public and would replace the fireworks show currently being held at Lake Linville each July 4th. "We want to move the show to Renfro to be able to make it a bigger show and more accessible to the public," Pensol told the court.

Plans are for the day to begin around 2 p.m. with live music on the outdoor stage in the field adjacent to Heritage Inn. Local fire departments have also agreed to hold fish frys on the site and there will be other concession stands.

Pensol said there will be inflatables for the children and tents will be erected for shade.

Renfro Valley Entertainment will move their regular Friday night show outside to the stage for a free performance for the expected 5,000 to 7,000

A contract with the fireworks company has to be signed in November and a third of the \$17,500 fee paid at that

time, Pensol said. There was some discussion by the court but Magistrate Ralph Allen reminded the court that the county has set aside a portion of the expected revenue from the recently-imposed occupational tax for tourism and related activities and he felt this

was a good use for the money. County Judge/Executive Buzz Carloftis made a motion to participate in the event, with the understanding that the county would not be asked for their one third until they begin receiving revenue from the tax and have some idea of what that revenue will be. Allen seconded the motion and it passed.

The court also opened bids for renovation of the courthouse facade and a new roof for the old Livingston School gym-

Three bids were received for the courthouse project, ranging from \$194,000 from Larry Coffey Construction of Berea to \$358,000 from McKnight & Asso. of London. The county only has around \$60,000 from coal severance monies approved for the project so the bids were tabled.

Seven bids were received for the Livingston gymnasium roof, ranging from \$110,750 to \$188,000. The original roof was destroyed in a wind storm and insurance monies are due the county. However, Carloftis told the bidders present that the project would have to wait until it was known for certain how much the insurance company would pay on the claim.

In other business the court was told that county employees health insurance premium would rise by \$17.77 a month for the next year. The county will now be paying \$238 per month per employee. There are presently 40 employees enrolled in the program on the single plan, five couples, one family and two employees and

children. The county's financial condition remains pretty glum, even with the injection of \$500,000 in borrowed money from Community Trust and Citizens Bank.

Although the general fund showed deposits of \$59,506.11 in September, which included

#### Sheliga files as write-in candidate


40-year-old Mike Sheliga of Mt. Vernon has filed as a write-in candidate for the Mt. Vernon City Council.

Friends Reunited

Recently my wife and I were having dinner with Judge Sara Combs at her farm, Fern Hill. She had invited several couples to spend a leisurely evening at her awesome home, and the people in attendance were sitting around in small groups chatting about a variety of top-

One of those couples was Bill and Sarah Stewart. I listened carefully as he told about his freshman year living in Hagan Hall on the University of Kentucky. The longer I listened, the more I became intently curious about his narrative. Finally, at one point he mentioned that he lived on floor 4-D and a bell went off in my head. Bill and I are the same age and I also lived on Hagan

After we started to compare notes, we determined that Bill and I had been freshmen on the same dorm floor at the same time. We had many memories to share from our college days. We recounted various names and events that took place in

In those days, UK athletes who were on scholarship lived in campus dorms, and a couple of famous basketball players were also on Hagan 4-D. One day I was walking to a class in McVey Hall when I noticed a fine looking, baby blue '57 Chevy convertible with a tall young man sitting behind the wheel trying to get his classic automobile started.

He saw a couple of us coming toward his car and asked if we would give him a push. When we approached the back of his car, we saw that it was none other than Cotton Nash with his blonde girlfriend. As soon as we got the '57 rolling, it started and he waved to us as he drove away.

Bill remembered that "hot" '57 Chevy and the fact that Cotton lived on the same floor with us. He also noted that Pat Riley lived on 4-D with us at the same time. Pat owned a red '63 Chevy convertible, and you could see it in the parking lot with the top down most of the time. I often wondered if his car got rain soaked because the top

was almost always down. I imagine he simply jumped into the automobile instead of using the doors.

During the early '60s, Adolph Rupp was the head basketball coach and Charlie Bradshaw coached the football team. Bill and I spent a considerable amount of time re-living the games of our college days and the coaches and great players we knew.

Coach Bradshaw will always be remembered because his '64 team was ranked #5 in the AP poll after defeating the then #1 ranked Ole Miss Rebels on the road 27-21 as well as beating Auburn University 20-0 for a 3-0 start. That team also defeated UT in its final game. Herschel Turner, Sam Ball, Roger Bird, and quarterback Rick Norton were named First Team All Americans under Bradshaw at Kentucky.

Our dorm mates were considered two of the finest basketball players ever to attend the University of Kentucky. Cotton was named First Team All American in '62,'63, and '64. His jersey was retired after his graduation. He was a two-letter athlete, playing both basketball and baseball.

Pat Riley was also an outstanding athlete at UK. He lettered in basketball and football. Riley led the 1966 UK basketball team, coached by the legendary Adolph Rupp, to the NCAA title game, where they lost to Texas Western, a game that has recently been dramatized in the movie Glory Road.

Bill and I amused each other by telling about the times we spent at the campus restaurant, The K-Lair. Most of the students living in Hagan and Donavan Halls spent their leisure time there – downing hamburgers and Cokes while discussing life at UK. Breakfast and lunch found us sitting in a booth with other classmates. Dinner, on the other hand, was served in the campus cafeteria in the basement of Donavan Hall – with the long lines that always seem to be a part of dining at a cafeteria

I learned that Bill graduated

#### **Points East**

The reason this story is just now coming up has to do with the fact I've been working on a submission for an anthology for which contributors write about their Dads.

We are limited to just a few pages and my late Dad, Elmer Adams, is worth at least a couple of books, so what I've been doing is sitting around remembering some details of the best of good times I had with him. In the final analysis the bad times are inconsequential and hardly worth recall when I remember Dad.

Problem is that my pal, Fred Beste #3, there in Wind Gap, PA only wants a synopsis and it is proving impossible to synopsize my Dad. So what I intend to do is share a story now and again here in the column and let readers draw their own conclu-

I couldn't have been more than 7 or 8 years old when Dad came home from the Isom stock sale with what everybody on Blair Branch claimed to be the prettiest mule they'd ever seen Old Dick.

He was big, in the 1,200 pound range, and chestnut brown and the previous owner had given him a bath and curried him down so that his coat was sleek and his mane and tail without a tangle. And he wasn't old; a couple years at best.

Dad led him into the yard and he ate cornbread right out of Mom's hand. He hoisted me up on his back and Old Dick was perfectly content to be led around with a child astraddle and seemed to enjoy it as I re-

And then Dad explained the deal he'd gotten on the mule. He'd traded in a little black mare well- known for her work ethic, if not for brute strength, for this giant of a mule and come out fifty bucks ahead of the game, because my Dad, you see was the consummate trader of cars, mules and milk cows and he was always interested in trading up and coming out ahead of the game. Mom was always duly skeptical and justifiably so but she had to admit that Ole Dick had a nice demeanor and if he had nothing else going for him, he sure did take to people as long as they were just standing around admiring him.

But honest work was an altogether different matter.

It was about this time of year. Time to turn the rye and clover underground and disk the bottomland and get it ready to sleep and mellow in wait of another growing season. Time to haul the shocked corn fodder to the barn, clean out the stables and spread manure. Time to snake dead timber from the woods to heat the fireplaces. In other words, lots of strenuous pulling heavy loads of this and that for the family mule.

Dad kept draft harnesses in several sizes hanging on the walls outside the work stock stalls in our barn because he was always trying to trade up and he put one on Old Dick that seemed to be the right fit even though the mule shivered and twitched and tried to bite and kick him as he was being geared

Dad hooked him to a turning plow and, with reins in hand, headed down to the bottom there below our house to see how well his new mule knew the plow. The notion was to turn under a two or so acre stand of golden rye and make the ground rich for next year's planting.

Old Dick walled his eyes and switched his tail, turned his neck to nearly ninety degrees and glowered back at Dad. Dad raised a long plow line off the hanes and swatted him smartly across his pretty hindquarters and the mule took off like a bat out of hell. He heed and hawed and kicked his heels toward the sky. There are some pieces of that plow that may wind up in archeological digs when future generations excavate Blair Branch because my Dad never found all of them. Excavators will wonder why half a plowshare wound up buried in a clay bank way up on the side of the mountain.

Dad tried cajoling and whipping and I think he even sat down and cried but Old Dick never had any intention or inclination that he was going to be a mindful mule when it came to work even though the family loved him when work was not

Dad went back to the Isom stock sale a few weeks later. Old Dick was swapped to Mert and Dad made out like a bandit yet again. Miss Mert, 300 pounds smaller than old Dick and tame as a milk fed kitten, taught me how to plow and actually stayed with us for several years. Dad had found another sucker for Old Dick and came out on the winning side again. He claimed \$50 profit in the trade and wound up with the best mule I've ever know.

I have no idea what ever happened to Old Dick but he sure was a pretty mule. Unfortunately, being pretty doesn't count for much if you are expected to work for a living. And that's the way it ought to be.



Losing memory leads to unforgettable life for Kentucky woman

An accident erasing her memory has resulted in an unforgettable life for an eastern Kentucky native.

Nancy Aileen, the last of nine red-haired children born to Dan and Stella Combs was six when she was struck by a car near Bulan, a small coal-mining town outside Hazard.

The impact sent her tiny body careening down the roadway, leaving her unconscious.

When she awoke four days later, there were no memories of the mishap, nor was she able to recognize her parents, siblings, or anyone else visiting her Hazard Hospital room.

Now 65 and living in southern Ohio with husband Larry Davy, Nancy looks back on the accident as a life-changing

"The family of the young

man that hit me practically lived at the hospital, and I just fell in love with the father, Ott Begley.

"After nine days in the hospital, I was released, but couldn't walk. The doctors wanted to keep a close eye on me, so arrangements were made with the Begley family for me to stay with them in Hazard until they were confident of my recovery.

"The Begley home was a modern, comfortable house. Life there was wonderful and I was the only small child."

After a couple of months, doctors determined their patient could return to her home in Bulan.

"I was back in a school and a home I didn't remember, surrounded by lots of small children, a coal stove, food of a poor family, washing in a tub,

#### **Watch For Teenage Depression**

Teenage depression is more common than most people think. Teenagers have many social pressures and often other significant stresses in their lives. Changes in their personalities can not always be dismissed as "phases" they are going through.

The depression can appear similar to that of adults with symptoms of fatigue, changes in appetite, and sleep disturbances. At other times, it presents as rebelliousness or antisocial behavior with drug or alcohol abuse and sexual promiscuity. There will likely be a loss of interest in normal activities and a

drop in grades. If these changes occur in a teenager, it is important for him

to consult his doctor. Medical problems, such as an abnormal thyroid, could be the cause. Whether it turns out to be depression or a medical illness, it is very important to treat it. Teenage suicide is growing in frequency, and depression is

a major cause. Girls are far more likely to attempt suicide, but boys more frequently succeed because they often use guns. The suicide rate for white males has doubled since 1970 and it is second only to accidental deaths in teenagers. The depression can be treated with medicines which help

restore the normal levels of certain chemicals, called neurotransmitters, in the brain. The new antidepressants are very effective and are much safer than the older ones.

Helping the teenager identify and understand his stresses and conflicts also helps him cope. A caring and concerned counselor can be very helpful, and the teenager should receive close medical attention during the period of recovery.









Sarah McKinney was named MVP of the district tournament.






Friday night, two of their starters were injured.


**Emergency Conservation** Program

Farms experiencing severe drought conditions may be eligible for cost-share assistance under ECP. Rockcastle County has been approved to start a 20 day sign-up period that will begin on October 9, 2008, to implement practice ECP6, Drought Emergency Measures for damage due to drought in

the county.

The estimated cost share that will be entered for the request will be 50 percent of the amounts listed for permanent and 75 percent of the amounts for temporary measures.

Permanent measures include: pipeline installed, watering facility installed, spring developments (permanently installed) and water well deepen-

An onsite inspection must be made by FSA to collect data that will allow a practice eligibility determination to be made.

Persons requesting approval are subject to payment eligibility and limitations.

Farmers May Sign Up for Quality Loss Crop Disaster Program

The Farm Service Agency announced that eligible farmers who suffered quality losses to their crops in recent years can enroll in the Crop Disaster Program 2005-2007 (CDP) at local FSA service centers.

Only producers who obtained crop insurance coverage or coverage under the Noninsured Crop Disaster Assistance Program (NAP) for the year of loss will be eligible for CDP benefits. Producers must have suffered quality losses of at least 25 percent to be eligible for CDP Quality Loss. The payment rate is set at 65 percent of the amount of the affected crop multiplied by 42 percent of the per-unit average market value in the year in which the loss occurred.

To be eligible for Quality Losses, producers must submit receipts that contain all three of the following items: Price, Production, and Quality affected. Quality losses must be due to an eligible disaster condition.

Producers may receive assistance for both quantity and quality losses. However, the total quantity and quality assistance, together with any crop insurance or NAP payment received for the same crop and the value of the crop produc-

tion not lost, must not exceed 95 percent of the total value of the crop absent the disaster.

For more details about CDP Quality loss, contact your local FSA Office or Service Center.

#### **Motorists advised** to look out for deer

The Kentucky Transportation Cabinet is reminding motorists that deer become a greater roadway hazard this time of year as mating season arrives. Each year the mating season, which lasts from October through December, accounts for a spike in deer-related crashes in the common-

There were 2,797 deer-related crashes reported in Kentucky in 2007 – leading to three fatalities and 76 injuries. This year, 1,430 deer-related crashes have been reported thus far, resulting in one fatality and 56 injuries. Nationally, about 150 people die each year in motor vehicle accidents involving

"Many times these accidents are unavoidable, but motorists can reduce the risk by taking extra time to drive carefully and staying alert - especially during dawn and dusk when visibility is lower and when deer tend to be on the move," said Neal Shoemaker, chief engineer for the Somerset highway district office.

Highway officials attribute the increase of deer-related crashes to multiple factors:

•Mating season puts deer on

•Farmers are harvesting crops, reducing food supply and potential hiding places.

•There's an increase in hunters and hikers in the woods.

•Deer tend to move at daylight and dusk when visibility is at its poorest for motorists.

While deer tend to cross highways along regular trails most of the year, they can show up in towns, subdivisions and other unexpected places during the fall rut. The Insurance Information Institute offers several defensive driving tips to help avoid striking a deer:

•Be attentive from sunset to midnight and around sunrise.

•Watch out at deer-crossing zones, in areas known to have a large deer population, and in areas where roads divide agricultural fields from forestland.

•Use high beam headlights to better illuminate the eyes of deer on or near the roadway.

•Slow down and blow the horn with one long blast to drive deer away.

•Brake firmly if a deer is in the road, but stay in the lane. Many serious crashes occur when drivers swerve to avoid a



#### The Family Room By: Dr. Roy Don Whitehead

If the parents are unable to fulfill their roles in the family, then one of the children usually steps in. The parents may be unable to do the job of parenting for a variety of reasons: alcoholism, illness, drug abuse, physical or verbal abuse, depression, anxiety and absences from the

Often (but not always) the oldest female child will fill this role. She becomes the Designated Caretaker both for the younger children and possibly for Mom and Dad as well. While the following characters are fictitious, the stories reflect a very real situation for many children.

1. Ruth's father was very ill and had been almost from the time she was born. He was well enough to father three children, of whom Ruth was the oldest.

By the time Ruth was eight, her father was spending longer and longer periods in the hospital. Most of these stays were in Lexington, and Ruth's mother would accompany him. Ruth's aunt was supposed to look in on the children, but she seldom did. By the age of nine, Ruth was the primary caretaker for her two younger brothers.

Ruth did not complain to Mom about the lack of help, because she did not want to upset her further. "Mom already had enough to worry about," Ruth told me.

Being in charge meant getting the boys up and fed and off to school. Ruth herself missed quite a few days of school each year. Laundry and cleaning took a lot of her time. She always had something for the boys to eat at night.

Ruth did not have a childhood after the age of eight. She had to grow up in a hurry because of the situation in which she found herself. "I think I missed out on a lot," Ruth admitted. "I didn't get to do the things that other kids my age did."

When she was fourteen, her father died. One might think that at this point Mom would begin taking care of the family and that Ruth could be a normal teenager. Unfortunately this is not what happened.

Ruth's mother became seriously depressed when her husband died. She would stay in her room for hours at a time, sleeping or staring at the wall. She did little for the family or for herself, and Ruth now took care of her in addition to her younger brothers.

2. Laura was in a similar situation. Her father had left soon after she was born, and her mother was an alcoholic. Her mother would come home late at night and pass out on the couch. Laura would find her there in the morning, dirty from having thrown up. Laura would clean her up as best she could, undress her and put her to bed. Laura had performed these duties since she was six.

3. Unlike Ruth, Laura had no younger brothers or sisters. This was a good thing, because taking care of her mom was a full time job.

At fifteen Laura fell in love and got married. Her mother signed the papers for her since she was underage. Her husband was 19 with limited job skills and limited intelligence. Looking back Laura says, "I know I got married just to get away from Mom. I discovered that this is not a good reason for getting married."

Laura's husband lost his job and began drinking. She had to work two jobs to support them. She had escaped Mom but now she was taking care of her husband. She had become the Designated Caretaker for another

#### Local judges attend 2008 **District Judges College**

District Judges Scott Lawless and Katie Wood, who serve Pulaski and Rockcastle counties, participated in the 2008 District Judges College hosted Sept. 21-24 in Lexington by the Administrative Office of the Courts. District Court handles juvenile matters, city and county ordinances, misdemeanors, traffic offenses, probates of will, felony preliminary hearings, small claims and civil cases involving \$4,000 or less. District judges serve four-year terms.

"Our goal is to equip district judges with the knowledge and skills needed to handle everyday issues that affect their courtrooms," said Chief Regional District Judge Karen A. Thomas, who serves Campbell County and is president of the Kentucky District Judges Association. "This college provided excellent sessions on the latest topics and core functions."

Thomas S. Hodson, professor and director of E.W. Scripps School of Journalism at Ohio University in Athens, Ohio, taught a session on media relations that explored the tension that often exists between journalists and the courts and methods for working effectively with the media. Rita Ruggles, program administrator for the state's Department of Mental Health, Developmental Disabilities and Addiction Services, and several judges presented a session on medications associated with mental health issues.

Other sessions included a case law update, landlord and tenant law, juvenile contempt and status offenders, judicial ethics, preliminary hearings, criminal procedures and docket management. Kentucky district judges, Administrative Office of the Courts personnel and attorneys with the Justice and Public Safety Cabinet, the Department of Juvenile Justice and the Judicial Ethics Committee taught the sessions.

Chief Justice of Kentucky John D. Minton Jr. also addressed the judges during the college. This was the first District Judges College since Chief Justice Minton took office.

The Administrative Office of the Courts supports the activities of 4,000 Kentucky Court of Justice employees, including the elected justices, judges and circuit court clerks. The AOC Division of Judicial Branch Education provides regular training colleges for district judges.

the last of borrowed money (\$50,000), the balance in that fund was only \$81,363 at the end of the month. County Treasurer Joe Clontz told the court that, with three pay periods in October, \$82,000 that had to be repaid to the state that was not used to clean up the Boone Gap dump site and \$82,615 in general fund bills for October, the county needed to transfer \$150,000 from the road fund to the general fund. Also, the court voted to transfer \$25,000 to the jail from the general fund and \$10,000, if needed, from the general fund to 911, if needed.

\$26,600 of the \$82,615 is a bill to MSE Engineers for work on the new building site in the industrial park and will be repaid to the general fund from revenue from the Industrial Revenue Bonds.

The road fund had a balance of \$574,475.92 at the end of September but will receive very little more in revenue this fiscal year. The money transferred to the general fund will have to be repaid before June 30, 2009.

The general fund expects an injection of revenue from the first quarter occupational tax due October 31st and quarterly proceeds from the 4% insurance tax which usually comes in the latter part of October and first part of November.

According to police, State Trooper Coby Smith recovered the gun and the bullet fired from the gun, which traveled completely through Bingham. Cromer had been released

from jail on September 22, after he filled a \$5,000 cash or property bond, but he was rearrested last Friday, after being indicted, and placed under a much higher bond.

Cromer is now being held on a \$50,000 cash or property bond and will be arraigned on

November 14th. A McKee man was also indicted Friday for theft by unlawful taking over \$300.

Joseph Berry, 25, D & M Drive, McKee, is accused of stealing a wrecker from Town and Country Chevron in Mt. Vernon on June 17th.



grist mill had been located just below the Big Spring, which pours out of the hill side on the south bank of Copper Creek, located on Brock's farm.

There is still a partial path that runs near the Big Spring and the creek bed, which Brock said many ole timers said was the main route from Crab Orchard to Brodhead in the early 1800s.

Brock, who still gets drinking water from the spring today, said the spring was where people in the area got drinking water at the time.

Above the hill on the north side of the creek is an old grave yard, which has a lot of history itself.

Most graves are only stones without names or dates, but four graves do have homemade grave stones.

The oldest stone is that of David Moore who died on March 11, 1827 at the age of 63. This made him sevenyears-old the first time Daniel Boone came to Kentucky in

Another stone was for F.P. Allen, marked 1853 to 1874. This stone has a handmade inscription which expresses

someone's deep feelings of loss: "Say Friends, what is the charm on earth can turn deaths dart aside - It is not purity and worth - Else Pierce had not died."

The remaining two stones are for Robert L. Allen, 1866-1868, son of Granville and Theodocia Allen and Grover Cleveland son of John T. and Susan J. Allen, 1885-1887.

Brock's daughter, Judy Baker, said a woman from Illinois went to the grave yard a few years ago and told her dad that the Allens were her grandmother's brothers.

The woman said the brothers had lived in the Copper Creek area at a placed called the Adams Settlement, when a flu epidemic hit and killed many of the people living there including her great uncles.

Brock said that another man in the area had told him that at one time there was a Tradin' Post, which he believed was near the Big Spring, because there was indications of several homes being built on both sides of the creek, probably around the time when the path was the major East and West route of travel between Brodhead and Crab Orchard.

Brock, who is originally from Harlan County, bought the Copper Creek farm in 1959, with his brother, Dallas, from E.H. Saylor and has found deeds dating back to 1897 when it was owned by Fannie Parker. Proctor Brock would later trade with his brother for sole ownership of the farm where the grist mill's foundation was found.

Over the years after heavy rainfalls, Proctor would see timbers with knotches in them, washed out in the nearby fields, but he did not know where they were coming from.


In February of 1993, while getting water from the Big Spring and checking his cattle, Brock noticed the mill's foundation visible under the waters of Copper Creek, just as Mr. Hoskins had said right below the Big

Spring. Copper Creek's bed was changing by washing lower and lower and had uncovered the foundation of hand cut timbers fitted together with only wooden

Since 1993, the bed of the creek has continued to change and washed even more logs from the foundation down

Brock has been able to find most the logs, which once was the foundation for the grist mill, after they washed out of the creek bed.


He is now planning to move the remaining logs to a dry place on his farm in order to help preserve a piece of Rockcastle history.

#### Physical Activity Guidelines for Americans announced

#### Family and Consumer Sciences

Adults gain substantial health benefits from two and a half hours a week of moderate aerobic physical activity, and children benefit from an hour or more of physical activity a day, according to the new Physical Activity Guidelines for Americans. The comprehensive set of recommendations for people of all ages and physical conditions was released on Oct 10 by the U.S. Department of Health and Hu-

The guidelines are designed so people can easily fit physical activity into their daily plan and incorporate activities they

man Services.

Physical activity benefits children and adolescents. young and middle-aged adults, older adults, and those in every studied racial and ethnic group, the report said.

Regular physical activity reduces the risk in adults of early death; coronary heart disease, stroke, high blood pressure, type 2 diabetes, colon and breast cancer, and depression. It can improve thinking ability in older adults and the ability to engage in activities needed for daily living. The recommended amount of physical activity in children and adolescents improves cardiorespiratory and muscular fitness as well as bone health, and contributes to favorable body composition.

The Physical Activity Guidelines for Americans are the most comprehensive of their kind. They are based on the first thorough review of scientific research about physical activity and health in more than a decade.

Key guidelines by group

Children and Adolescents -One hour or more of moderate or vigorous aerobic physical activity a day, including vigorous intensity physical activity at least three days a week. Examples of moderate intensity aerobic activities include hiking, skateboarding, bicycle riding and brisk walking. Vigorous intensity aerobic activities include bicycle riding, jumping rope, running and sports such as soccer, basketball and ice or field hockey. Children and adolescents should incorporate musclestrengthening activities, such as rope climbing, sit-ups, and tugof war, three days a week. Bone-strengthening activities, such as jumping rope, running and skipping, are recom-

mended three days a week. Adults -- Adults gain substantial health benefits from two and one half hours a week of moderate intensity aerobic physical activity, or one hour and 15 minutes of vigorous physical activity. Walking briskly, water aerobics, ballroom dancing and general gardening are examples of moderate intensity aerobic activities. Vigorous intensity aerobic activities include racewalking, jogging or running, swimming laps, jumping rope and hiking uphill or with a heavy backpack. Aerobic activity should be performed in episodes of at least 10 minutes. For more extensive health benefits, adults should increase their aerobic physical activity to five hours a week moderate-intensity or two and one half hours a week of vigorous-intensity aerobic physical activity.

Adults should incorporate muscle strengthening activities, such as weight training, pushups, sit-ups and carrying heavy loads or heavy gardening, at least two days a week.

Older adults -- Older adults should follow the guidelines for other adults when it is within their physical capacity. If a chronic condition prohibits their ability to follow those guidelines, they should be as physically active as their abilities and conditions allow. If they are at risk of falling, they should also do exercises that

maintain or improve balance. Women during pregnancy -Healthy women should get at least two and one half hours of moderate-intensity aerobic activity a week during pregnancy and the time after delivery, preferably spread through the week. Pregnant women who habitually engage in vigorous

aerobic activity or who are highly active can continue during pregnancy and the time after delivery, provided they remain healthy and discuss with their health care provider how and when activity should be adjusted over time.

Adults with disabilities --Those who are able should get at least two and one half hours of moderate aerobic activity a week, or one hour and 15 minutes of vigorous aerobic activity a week. They should incorporate muscle-strengthening activities involving all major muscle groups two or more days a week. When they are not able to meet the guidelines,


they should engage in regular physical activity according to their abilities and should avoid inactivity.

People with chronic medical conditions -- Adults with chronic conditions get important health benefits from regu-

lar physical activity. They should do so with the guidance of a health care provider.



#### Marching Rockets travel to Grant County for "Steamy" competition

The Marching Rockets traveled to Grant County High School in Dry Ridge for competition this past weekend. The Rockets arrived at RCHS at 10 am to load the bus for what turned out to be the hottest day of the week yet again in a month filled with aboveaverage temperatures. The Rockets decided to forego the usual onehour rehearsal prior to leaving for competition since the day ahead included preliminary competition at 2:15 pm and a finals round scheduled to begin at 6:30 pm, and finals awards scheduled for 9:15 pm. The first round of competition was tough, and though the Marching Rockets placed 3rd behind Paul Blazer and East Jessamine; they were pleased to make it to the finals round. The second run of the show, NIGHTSCAPES. included improvements suggested by judges in the first round, but it wasn't enough to put the March-

ing Rockets into contention for a top spot out of the 10 bands competing.

During the break between preliminaries and finals, the band was treated to a respite from the competition, traveling just a few miles away from the Grant County High School to the home of band parent, Beth Pyles, for a barbecue party complete with terrific food and games-corn hole included. The much needed break was greatly appreciated as was the outstanding food. Thank you Mrs.

Tomorrow night, Friday, October 17th, the Marching Rockets will perform the show during halftime at the home football game. On Saturday, the Marching Rockets will travel to Powell County High School for the Pirate Invitational, the last regular season competition scheduled for the Marching Rockets before Regional Quarterfinals on October 25th at

Rowan County High School in Morehead. The competition this weekend will again be tough as the Marching Rockets go up against Boyle and Rowan County High Schools, both of which have earned distinguished ratings this season. The Rockets hope for a significant increase in scores this week as rehearsals intensify with post-season performance so close

he Marching Rockets have more than marching on their minds though, as they prepare for many other seasonal performances including Arts Night, October 23rd, at RCHS where the Marching will perform NIGHTSCAPES in concert; and the "Spooky Jamboree" at Halloween on Main, October 30th.

The Rockets are also looking ahead to a unique opportunity to perform with the Central Kentucky Concert Band in Lexington, Kentucky, on December 13th and to their annual Christmas Concert at RCHS (date tba).

Colorguard -Both sport and art

In a marching band the colorguard or auxiliary is a nonmusical section that provides additional visual aspects to the performance. The colorguard interprets the music that the marching band is playing via synchronized spinning of flags, rifles, or other pieces of equipment, or through dance. The colorguard uses different colors and styles of flags to enhance the visual effect of the marching band as a whole. Colorguards choose costumes and props that coordinate with the theme of their show. The number of members in a colorguard can vary from one to more members than the marching band.

Originally, a military color guard often traveled with a band that played patriotic songs. This continued into the civilian marching bands, and today, a marching band's colorguard will normally carry equipment descended from those of military color guard: flags, banners, mock rifles, or mock sabres. Modern color guard has evolved over the years into an athletic form of dance theater that uses props along with movement to express the dynamic passages in the music accompanying the show. During the 1970s and 1980s, the impetus for the evolution of the modern color guard came from the competitive drum & bugle corps. By the late 1970s and into the mid 1980s colorguard auxiliaries had been added to most Big Ten marching bands. Once these prominent university bands had colorguards, there was a widespread rush to include colorguards at high schools across the nation in the 1980s and 1990s.

The visual effect of spinning and shaking flags drew the attention of crowds and quickly caught on. Having visual impact for pieces played when the band stood still added a whole dimension to the performance. Members of colorguard teams march along with their fellow marching band members. Today the guard uses choreography and equipment for added visual appeal during a marching band show. Usually marching bands and colorguards perform during football games at halftime, out of tradition. During a competition the guard adds to the overall score of the band, but is also judged in its own category. The colorguard is judged on general effect, movement, ensemble analysis, and equipment. Program content and expressive efforts, including: space, timing, position, integration, showmanship, spatial awareness and accuracy are all minutely dissected by the judges and scored. Colorguard has long been considered to be both an athletic competition and an art. Due to its popularity, colorguard is under consideration for inclusion in the Olympic Games.

The Marching Rockets have nine Colorguard members this season, enhancing the visual effects of the music. Music touches the soul and the colorguard make it a feast for the eyes.

The Marching Rockets Colorguard Captain, Samantha Bullen, is a senior this year. Sam has been with the guard for the last four years. During the winter concert season she plays the flute. Her favorite part of being in the band and colorguard is "being with all my friends all the time." Her least favorite part of band is "doing it over again multiple times." When asked about this year's show NIGHTSCAPES she said, "It's my favorite one so far." She plans to major in education next year. She has enjoyed being Section Leader, "It's fun. I get to help the guard

and I get to help write routines." Johnna Ballard is Co-Captain and a junior and this is her third year in the guard. She plays clarinet in the concert band. The best part of band and the colorguard for Johnna is "performing and putting on a show for an audience." Her least preferred guard activity is "all running". NIGHTSCAPES she said, "It's one of the best shows we've come up with." Her dream is to become "an entertainer of some sort. Dancing, singing, acting I love it all." To pursue this career she would like to attend the theater program at the University of Delaware.

This is the fourth season in the colorguard for sophomore Rachel Hemsley. She is also a clarinetist in the concert band. She enjoys "the competitions because you get to experience the performance of all the other bands". And she is not fond of "band camp because we work all the time". Rachel said about NIGHTSCAPES, "I really like it." Her future plans are to become an ultrasound radiologist and she would like to perform in guard while in college.

Sophomore Catherine Hounshell is in her second year as a member of the Marching Rocket Colorguard. During the concert season she is a flutist. The best part of band for Catherine "is the competitions and being with friends. Going on the trips is also fun." Her least favorite part is "being out in the hot sun and band camp". She likes this year's show NIGHTSCAPES "I think it has good potential. I think we can go far with it if we keep up the hard work." Before performances, "I pray a lot and I stretch." She is planning to become a radiologist and would like to attend either the University of Kentucky or Somerset Community College. She also would like to continue

with guard in college. Cassie Taylor is a freshman and this is her second year in the Marching Rockets but her first year in the Colorguard. She played the alto saxophone last year in the band and will continue to play the sax this winter in the concert band. The best part of band is "the people and all the trips". And Cassie loves all parts of guard/band life "It's all fun!" She told me that NIGHTSCAPES is "a whole lot better than last year." She has not yet made any decision about a lifetime career but does "plan to stick with the guard through high school and maybe even doing guard in

college". Christa Doan is also freshman and this is her first year as a Marching Rocket. Her favorite part of being in the guard is "going to the competitions and competing." Her least favorite is "wearing gloves that turn your hands black. They are weightlifting gloves and are made out of black leather." About NIGHTSCAPES she said, "I really like it. It brings out the dark side of me." In preparation for competitions Christa listens to heavy metal. "It gets me perked up." She plans to become a pediatrician and maybe do guard in college.

Sarah Burdine is in eighth

grade and this is her first year in the colorguard. She will play percussion during concert season. Her best part of being in the Marching Rockets is "having fun with all my friends during practice." "All the marching" is her least favorite. asked When NIGHTSCAPES she said, "I like it because it has a really cool beat to it." She has some lucky clothing that she puts on and wears at every competition. Her ambition is to become a veterinarian. She would like to be involved in guard

while in college. Laiken Coffey is also in the eighth grade and this is her first season with the guard. She plays the trumpet as well and performs with the middle school band. The best part of band for Laiken is "the competitions. I really enjoy learning from the judges' comments." As for the rest of the guard/band experience she said, "I really like all of it except maybe marching; it's fun, but it can be challenging.' NIGHTSCAPES "is a really cool show. It has a lot of potential and we're doing really well with it."

To prepare for competitions Laiken said she "just practices a lot right before performing, making sure I've got all the routines down." Her ambition is to become a Pediatric Dentist and "I would really like to be in the EKU Marching Colonels guard."

This is the first year in the Marching Rockets for eighth grader Cassie Hounshell. She joins her sister Catherine in the colorguard. She also plays clarinet in the middle school band. Her favorite part is "the bus ride on the way to competitions and the competition itself. I like the excitement." Cassie's least favorite activity is the "long practices in the hot sun." About NIGHTSCAPES she said, "It's a really good theme. All the props are designed really well." In preparation for competitions she told me, "I pray as we go onto the field. 
