Berea man rescued and then arrested

A Berea man spent the weekend in jail after Rockcastle Deputy Sheriff Shannon Franklin arrested him Saturday, shortly after he was rescued from a rain swollen Clear Creek.

Franklin said he charged Chris Brinegar, 34, of Mason Lane Road, Berea with operating a motor vehicle under the influence of alcohol/drugs, after he drove his 1996 Pontiac Firebird into Clear Creek around 12:30 Saturday afternoon. He was attempting to cross the creek on Gadd Cemetery Road, which runs off Wildie Road.

Franklin said Brinegar's car stalled in the high water, which covered the hood of his car.

The Deputy said Brinegar told him he was going to finish an open beer before he would cooperate with rescue workers, who had gone to the scene to help get Brinegar and two female passengers safely out of the creek.

Franklin said when rescue workers arrived all three people, who had been riding in the car, were sitting on top of

Rescue workers used a rope to pull all three people to safety, but not before Brinegar finished his beer.

Brinegar was arrested, taken to the Rockcastle Hospital for a blood test and then lodged in the Rockcastle Detention Center where he spent Saturday and Sunday nights before posting a \$100 cash bond on Monday.

His next court date is June

His two female passengers, also from Madison County, were not charged.

Rockcastle County Judge/ Executive Buzz Carloftis' item, on last month's agenda, to include County Clerk Norma Houk's office in the county's administrative code, brought Houk to Tuesday's regular monthly meeting where she protested.

A Livingston man pled guilty to first degree wanton endangerment on April 30th in Rockcastle Circuit Court and was placed on a three year pretrial diversion program. Earl B. Harney, 33, of

McClure Street, Livington admitted to shooting into the residence of Keith and Jennifer Young on Main Street in Livington on April 20th of this year with a .22 caliber revolver.

The Youngs who live in an apartment above their motorcycle shop, identified Harney as the person who fired into their building around 2:30 p.m.

Asst. Commonwealth Attorney Jeremy Bartley, who handled Harney's case on the new Rocket Docket, said that if Harney commits any crime while on pre-trial diversion he will have to serve the entire

office was a constitutional office and she should have control over her office, as to days off, etc. "My office is completely separate," Houk said. "The people elected me to run my office and it is my duty, not yours, to run the office."

However, Carloftis disagreed, saying that all county offices were constitutional offices and "your employees are county employees, paid by county funds. All funds brought into the county clerk's office are county funds." To which, Houk retorted that funds from her office were not county funds until they became excess fees at the end of the

Houk also noted a few areas in which she felt the court was not operating its office correctly. "The law says the county is supposed to pay their bills within 30 days and I have presented claims in November and not been paid until February." Carloftis' answered that if the county had gotten the over \$40,000 in excess fees from Houk, projected in her 2008 budget, instead of the \$400 received, the court might have been able to pay the claims on

Houk also said that the judge and magistrates were violating the county's ethics code which says that every elected official must report a personal financial disclosure by February 15th of each year. "There is a \$500 fine per violation for this," Houk told the

Pensol said the ambulance service, which is presently paying on three emergency vehicles themselves, would be able to pay \$22,859 of the cost of the 2009 Chevy on which a "box," the ambulance service already has, would be mounted.

The total cost of a chassis and

box would be over \$100,000,

Pensol said.

According to the chairman, the ambulance service tries to keep three van ambulances and two box ambulances in service but had to borrow a box ambulance from Laurel County, for about a month, while one of theirs has been out of service. "The box ambulances are more

expensive than the van ambu-

lances," Pensol said, "and are

used mainly for transporting patients to other town because they are more safe and reliable." The service also has a four wheel drive emergency vehicle which is not used often, Pensol added.

County Judge/Executive Buzz Carloftis told the court that Rockcastle's ambulance service was "probably the most efficiently operated service in the state." Carloftis went on to say that other counties Rockcastle's size, without a taxing district for their service, had to pay out several hundred thousands of dollars each year to help their services meet expenses. He reminded the court that when Clay County enacted their occupational tax, several years ago, they collected \$800,000 the first year and \$300,000 of that went to their ambulance service and the remainder to their jail. "We give our service \$41,000 a year in support," Carloftis said. The court also allows the service to

After deputies located the lab, the residence was secured (Cont. to A15)



Cast-iron collectibles

A few weekends ago, I was being an ideal husband and decided to prepare breakfast for my wife. The main course was to be country ham, so I pulled my grandmother's 12-inch cast-iron skillet out of its storage place and proceeded to fill it with slices of ham.

As I stood in my kitchen listening to the sizzling sounds coming from Mommie Katie's antique skillet, I was transformed to her kitchen on our farm in Rockcastle County. She loved to fry country ham and then make her own ham gravy. As I turned the ham slices, I noticed that small pieces of the meat fell away from the larger slices and that was just what I had in mind. Those tiny particles of ham would be the flavoring for my ham gravy.

After the ham was cooked to my specifications, I placed each piece onto a small platter and covered them so they would remain warm. Then I poured milk into the hot skillet until it reached almost a third of the way up the side. As the milk began to boil, I added just the right amount of flour for

thickening. The particles of ham, milk, flour, salt, and pepper slowly turned into the most delicious gravy just like Mommie Katie taught me over 50 years ago.

I get a thrill out of using one of Mommie Katie's cast-iron pieces of cookware. When she passed away, my mother (Bee) inherited them, and she graciously gave them to me. Every time I cook any meal in one of these memorable skillets, muffin pans, or the Dutch oven, I am reminded of the wonderful times these gracious ladies prepared meals for our family. I suppose the # 9 iron skillet that they used to make cornbread is now one of my most prized possessions.

I may be remembering things through "rose colored glasses" but it was the finest cornbread ever to cross my palate. Even though I have her recipe, somehow mine just doesn't quite measure up. It must have been that magic touch of a mother's love that made it so exceptional.

Last Friday I spent half the day on Campus at Berea College engaged in studious discussion and thought about alternatives to the way we get and use energy and about our sources of food.

It came as no surprise to me that almost everyone in Kentucky depends on coal to make the lights come one and the stove burners turn bright red hot. Nor was I surprised to learn that over 90% of what we eat here is grown and processed out of state if not out of the country. Read the labels folks. I don't have anything against Mexico but if you've been eating fresh tomatoes from the grocer over the last few months, that's where they came from.

Somebody working for 50 cents an hour planted and picked them way too green. Then they were transported to a processing facility where most of the digestive enzymes were destroyed but the ripening enzymes were preserved so they'd turn pink in three weeks and then they were hauled and manhandled for at least two thousand miles in the back of an 18 wheeler. Then loaded and unloaded and reloaded and finally and fondly placed on the

produce rack at your grocery store, apparently unblemished.

These tomatoes have been bred for endurance and then washed in so many chemicals that they are immune to signs of bruising and battering and they have been handled several times before you pick one up and squeeze it there on the shelf. In which case it pops right back out to perfect ripeness

And has the nutritional

value of a dried out corn cob.

Incidentally, if I see you squeezing a tomato with your dirty little fingers and then putting it back on the rack at name your favorite grocer, I'm going to call your ass to task and I'm going to call the store manager if you don't buy it. If you can't scope out your veggies without getting personally acquainted with them, then please go out and grow your own.

Avocados are the exception to that rule because it is difficult to tell how long an avocado has been on the truck ripening up without a gentle squeeze. On the other hand, they could label them---shipped on February 1 from San Diego--- and we'd know they were ripe by the first of May after lying there on our grocers shelves for a few weeks and we wouldn't even have to squeeze to determine their readiness for guacamole. But nobody eats the peel of an avocado so what's the harm and how else are we to know?

But, as usual I'm off the point which is not unusual when I have the urge to rant. And the point is that there is finally a movement among the Bereaites to which I fully subscribe. Actually I'm all for a bunch of stuff Bereaitish that has to do with saving energy and reducing our world's dependence on burning itself up to keep on going but that's another argument for another time.

The bandwagon I'm trying to jump on (And this is sort of like a Mountain Pentecostal Preacher becoming a Priest overnight in terms of infiltrating the Bereaites) is the notion of edible landscaping coupled with the notion of planting a little stuff to eat anywhere you have room to put it. The movement right now is called "Sustainable Berea" and

Rural schools bring flood of memories

Having spent all but one of the nine years it took me to complete eight grades in a tworoom school, I consider myself an authority on the subject of old-fashioned education in Kentucky.

There probably aren't many people under age 60 who attended either a one or two room grade school, but those of us who did have a coal bucket full of memories.

I'm certainly not one of those people who would claim students got a better education in the "old days", but there were certain fun things we did back then that can't be repeated in today's modern schools.

Each month we had the much-anticipated experience of having a lady come and tell us Bible stories illustrated with flannel-back characters and objects placed on a big board.

We didn't get too many visitors from the outside world at my rural Kentucky school, so when someone did come, it created a lasting memory.

An annual visitor I recall was the candy salesman who would show up about a month or two before Christmas, urging us to sell their wares doorto-door as a fund-raiser for our school.

Usually the salesmen came in pairs, one making a sales pitch, while the other, always sharply dressed, smelling good, and with movie-star looks would walk around winking at all the girls.

When we weren't having visitors, we could always find plenty to do. Things like gathering kindling for starting fires in our coal stove.

No matter that there was enough scrap wood within 100 feet of the school to last 10 winters, we always managed to walk at least a couple miles back in the forest in search of firewood

Dusting erasers was another chore that always got plenty of volunteers. The chalk-filled tools were beaten on rocks or

on the heads of the smaller

Up until about age eight or nine, I thought this process might have had something to do with my being named White.

One thing we always made sure of was to get back from gathering firewood and dusting erasers in time for recess.

Believe it or not, we had three official times each day set aside for play.

The first, cleverly referred to as "Morning Recess," occurred from 10:30 until 11 a.m.

Lunch break was from noon until 1 p.m., followed by another break between 2 and 2:15 p.m.

To this day, I can't tell you what year Balboa discovered America, but I've never forgotten those recess hours.

Usually that first recess allowed only enough time for some of us boys to go to the back of the building for a quick smoke or chew and to settle any arguments left over from the previous day.

I recall there being fewer fights on Mondays because nobody could remember what they had been mad about the previous Friday.

At about a quarter to 12, our

teacher would let us choose up sides for our daily baseball game.

Two captains would select

their players until each had nine.

The only times I ever got to play were when I got to be captain, and when Beulah Bumgardner was absent.

Quite often these games would be tied at the end of our allotted recess time, and we could usually talk the teacher into letting us continue until the outcome was decided.

We had a lot of ties.

After noon recess came one of my favorite times of the day.

The teacher would read to us from books like Huckleberry Finn, Tom Sawyer or The Hardy Boys.

This lasted about half an

May is Arthritis Awareness Month Coping With Arthritis

A person should not learn to live with arthritis--he should learn to cope with it.

Coping with an illness means that the person actively plans ahead and carries out ways to tolerate a chronic illness.

For arthritis, this includes use of medicines, exercise, physical therapy, rest, and occasionally other modalities.

The first and often the main coping mechanism is appropriate physical activity. Since too much exercise can worsen the arthritis and too little exercise will result in muscle weakness, striving for that delicate balance is an ongoing search.



A person should exercise moderately and regularly--not too much some days and too little other days. The exercise should be followed by liberal amounts of rest.

Medicines are another useful tool. They can be used routinely to suppress any flare-ups of inflammation. The duration of stiffness, the degree of joint swelling, and the elevation of lab tests can all be used to regulate the level of medicine you use. When there is a flare-up, medicines should be started or increased as early as possible to arrest the progression of symptoms before they get out of hand.

Low doses of an antidepressant can also decrease pain, help you sleep better, and treat the depression that can occur from the stresses arthritis adds to a person's life.

Education is very important. The more you know about your illness, the better you can cope with the symptoms. You can learn many more coping strategies from your doctor and an arthritis support group.

The Judge also did not comment on the fact that David Ballinger, the ERWA president, now regularly calls Sheriff Mike Peters' deputies to arrest ERWA water users who show up to attend monthly board meetings. Hopefully our Fiscal Court Magistrates will end this abuse of County property and tax payer funds.

In Kentucky we have progressed with open meetings laws covering both government agencies and private organizations dependent on public dollars. Our County Fiscal Court Magistrates and Board of Education are examples of County organizations that honor openness at their monthly meetings, demonstrating that the best way of keeping the dark side of backroom politics at bay is with the disinfecting sunshine of public scrutiny.



As I said last week, we will resume the oral history of Orlando as remembered by Mary Stewart.

> Growing Up in Buck Lick *Holler* (Continued)

My brother and I walked three or four miles to Cooksburg School. We didn't have snow days. I remember going to school, and holding on to trees to keep from falling. I don't know how many went to school, but we had all eight grades in a one-room school. The Scotts who lived across Crooked Creek from the school, Rollie and Geneva Mullins' children, Ellie and Willie Vanzant's children, Bertha and Harry Vanzant's children, Ethel and Bill Durham's children, some Allen children from Cave Ridge, and the mayor of Livingston, J.C. Griffin and his brothers and sister, and John Henry Ballard [attended the school]. I probably got out of grade school in 1956. That's when Martin and Cressie

Vanzant went to Ohio to live, and we moved out of Buck Lick Holler to the Martin Ridge. It was a lot nicer house than the one I was raised in. We had well water, a cellar, and we even got a TV. Manley and Silvia McGuire's boys, Bobby, Doug, and Truman would come up there once or twice a week and watch TV. I even saw Dolly Parton on the Caz Walker Show. They were [on TV] one, two, or three times a week. Nobody else had TV because they wasn't high enough to get reception.

I started high school in 1956. I walked to Poplar Gap, and Willie Vanzant, who carried mail, was also the one that took us from Poplar Gap to Brush Creek to catch the bus. Mr. Vanzant drove a cloth top Jeep. Looking back, I don't see how we all got in that Jeep. There were at least nine of us. Virgil Mullins picked us up in a school bus, and took us on to Livingston. He was the only bus driver I had the four years that I went to school.

Granny moved to the Martin Ridge with us, and stayed a while, but she wasn't happy so she moved back to Buck Lick Holler, After I married, in 1960. my husband and I would go and spend the night with her. I don't know what year it was, but she fell and broke her hip, and had to have pins put in it. It didn't heal right, and she spent the last years of her life in Berea Hospital in their long-term care fa-

Aunt Bertha and Uncle Harvey moved to Burr, and built a house in the early '60s. Mom and Dad moved in a house that was on the property. My husband got a job working on construction in 1963. We lived at Chestnut Ridge. We later bought a trailer, and put it on Uncle Harvey's property. That was when I had a bathroom. We had cistern water. My mom learned how to drive a car, and got a job with Karen and David King, being a nanny to their twins, and cleaning house for them.

In 1969, we bought a house on Chestnut Ridge Road. We raised four children there, and we still live here today.

My mom and dad have done passed on. I have one uncle on my mother's side still living. Junior French, but my dad's family have done gone on, so I guess it is safe to say that we

are the older generation. (Signed) Mary Ellen McGuire Stewart, and husband, Charlie Stewart

Post Script "What We Did For Fun"

We didn't have anything to do in the way of entertainment. We lived so far back in the hills that it was a hard job to get a car or truck there, and Uncle Harvey Vanzant was the only one that I knew with a truck or

My cousins that lived close to me would come, and we would play most of the time. We would go out to the cow pasture, and there was a big rock there that was slanted, and we would slide down it. We would also make leaf dresses out of cowpow trees that grew next to the rock. To us, that was fun. We would sew the leaves together with sage grass. The leaves of a cowpow tree are at least sixteen to eighteen inches long, and six or eight inches wide.

After I got a little older, say about ten or eleven, Mommy and Daddy would take my brother and I gigging with them. That is when you go to a big water hole in the creek, when the fish are shoaling, and spear suckers and whatever else you can get, and sometimes we would gig for frogs. The Blue Hole was close to the backside of the Saltpeter Cave. I have been through it a few times, probably when I was thirteen or fourteen.

Uncle Harvey and Aunt Bertha Vanzant would take their children and me, and maybe Mom and Dad, I don't remember, to Livingston skating. I learned to skate pretty soon. It was close to where the Livingston Post Office is now.

My aunt, Eula Mullins, lived in Renfro Valley, and I got to go spend a night with them every once in a while; and her children and I would go across US 25 to their grandparents'

Mullins home, and sit on the porch and watch movies at the drive-in theater in Renfro Valley. I never got to the drive-in until I started dating when I was probably sixteen years old.

I look back now, and see all the things children do now, and they are always wanting more, but we didn't know what more was. We were just happy with what we had.


The 30 minutes or so between reading period and the 2 p.m. recess could seem like an eternity. So we sometimes livened things up by getting Odell tickled.



An encouraging word:

Encouragement is a Powerful Force By Howard Coop

After graduating from High School, I, like most graduates, faced the future with high hopes and great dreams. The college of my choice had accepted me, and I had accepted a summer job with great promise. But that summer was a bitter disappointment. Nothing went right; everything seemed to fall apart. The job that promised so much produced so little, and plans for college vanished. At the moment, the future for me was bleak and uncertain.

Tuesday, September 17 of that year remains special. That morning, my father, realizing my disappointment, spoke a few words of encouragement. I reacted to his words in a positive way, and my life was redirected. Within a week, I became the student pastor of three small churches, and I enrolled in a college I had not previously considered. Hope returned, and the future was bright. It all happened because of the encouraging words of my father that came at a time when I really needed encouragement.

Years later, I opened my Bible one morning to Paul's Letter to the Romans and, with no purpose in mind, began to read. In the first chapter, I came upon the words "that you and I may be mutually encouraged" by each other. For some reason, I looked further, and in a short time, I found a number of passages that stress the importance of encouraging one another in all kinds of situations and under all kinds of conditions. Encouragement of one another, I found, is a major theme that runs throughout the New Testament, and it places responsibility upon each individual to be a person who encourage others.

Encouragement is a powerful force. Few things in life are more powerful than encouragement. It is sufficiently strong to redirect and change life. Most people respond positively to encouragement, for they like to be encouraged. When there is so much in the world around us that is discouraging, it is important to encourage one an-







Tax deductions and credits available for fuel-efficient vehicle purchases


year. A tax credit for the purchase of a more fuel-efficient vehicle is also available to taxpayers through the Energy Policy Act of 2005.

The new vehicle purchase tax credit allows you to claim a deduction for the sales tax paid on any new car, truck, motorcycle or recreational vehicle purchased between Feb. 17 and Dec. 31. If you purchase a vehicle for less than \$49,500, you can claim the entire sales tax as a deduction. If the vehicle you purchased costs more than \$49,500, you can deduct the sales tax paid up to \$49,500.

On your 2009 tax returns, this deduction does not have to be itemized. The tax deduction can be added to your standard deduction. If you do itemize your deductions, include the new vehicle deduction with other qualifying items, such as state and local property taxes and mortgage interest.

Qualifying vehicles must be new, not used and weigh less than 8,500 pounds to be eligible for the tax credit.

While the credit is available to everyone, it phases out for taxpayers with an adjusted gross income of more than



Another way to earn tax credit toward 2009 taxes is to purchase a more fuel-efficient vehicle. Qualifying vehicles include hybrids, fuel cell, alternative fuel motor, heavy hybrids and lean-burn technology and must be purchased on or before Dec. 31, 2010.

The fuel efficient tax credits will vary by vehicle based on its make, model and year. You should understand that not all alternative motor vehicles may have a tax credit available. Once a particular year, make and model of a vehicle reaches a manufacturer sales volume of 60,000 units, taxpayers may no longer claim the vehicle tax

The Internal Revenue Service Web site has a list of vehicles that are currently eligible for the credit and the amount of credit available for each at http://www.irs.gov/businesses/ corporations/article/ 0,,id=202341,00.html. Click on the type of vehicle you are considering purchasing to see the possible tax credits.

cess for which a CDL application and Ten (10) Year History Survey is initiated will be changing. A CDL permit/license **cannot** be issued until the CDL application is received and posted to the driver's record by the Division of Driver Licensing. **This process** could take up to 48 hours.

Under 49 CFR 384.206, a driver applying for an original, renewal, upgrade/add-on or transfer CDL must provide a list of all states where the driver has held a license to operate any type motor vehicle in the last ten (10) years. The Ten (10) Year History Survey Request must be initiated **prior** to a





Effective May 18th, the pro- CDL permit/license being issued. This is a one time process. If the driver has already provided the information and has not transferred out of state since completing the process, he/she will not be required to submit the information again. Per 49 CFR 383.73 (g) if a driver fails to disclose any state in which a license was issued, that driver will be subject to a minimum suspension of sixty (60) days for falsifying an ap-

plication.

In an attempt to make the new process user friendly, the Division of Driver Licensing has made the CDL application accessible from the DDL website http:// transportation.ky.gov.drlic/. The driver will select the "Forms and Applications" option on the left and then click on TC 94-32. The form can be completed online and printed out. The driver will then have three options for submitting the application to the Division of Driver Licensing: 1) print, scan and email the application to KYTC.CDL@KY.GOV: 2) mail to: Division of Driver Licensing, 200 Mero St, Frankfort, KY 40622; 3) fax it to the CDL Section at 502-564-3250. A supply of the CDL applications is available from our Administrative Support Section at 502-564-0278 ext. 5104.

It is the responsibility of the applicant to provide the **Division of Driver Licensing** a copy of the 10 year history application prior to the issuance of the CDL.

In 2003, he retired from the trial court bench and returned to private law practice in Somerset.







The Lady Rockets, who are 9-18 on the season, will play the 21-9, Somerset Lady Briarjumpers at 8 p.m.







RCMS girls' track team wins first Middle School State Championship

The RCMS girls' track team won the KTCCCA Middle School State Championship this past Saturday in Lexington. Out of 51 middle school teams that scored and nearly 100 that competed, the RCMS girls dominated the competition, winning by 19 points over their closest competitor, North Oldham, by a score of 69-50.

This was the first outdoor state title for the RCMS girls' team after finishing as state runner-up three times and third once in the past five years.

RCMS was led by a trio of 8th graders that accounted for 60 of the team's 69 total points. Michaela Hunter led the way with 34 total points, which also led the entire state in individual scoring.

Michaela first participated in the long jump competition. She finished as state runner-up with a career best and state record leap of 16'06.5". Her mark was broken only minutes later when the eventual winner surpassed her by only one inch.

Michaela next competed in the triple jump competition. She easily won the state title in the event with an awesome career best mark of 34'10.5". She defeated her closest opponent

Next for Michaela came arguably the most difficult backto-back races in track - the 400meter dash and the 300-meter hurdles. In the 400, Michaela ran an exceptional race, finishing 3rd overall in an impressive 1:01.66. In the 100, Kira blazed her way to a 6th place finish in an impressive 13.62 seconds. She was only six hundredths of a second away from a third place finish. In the 200, Kira was even more impressive, placing 3rd overall with a great time of 28.29 sec-

Independent Auditor's Report

We have audited the accompanying financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of Rockcastle County, Kentucky, as of and for the year ended June 30, 2007, which collectively comprise the County's basic financial statements, as listed in the table of contents. These financial statements are the responsibility of the Rockcastle County Fiscal Court. Our responsibility is to express opinions on these financial statements based on

our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America, the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States, and the Audit Guide for Fiscal Court Audits issued by the Auditor of Public Accounts, Commonwealth of Kentucky. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinions.

As described in Note 1, Rockcastle County, Kentucky, prepares its financial statements on a prescribed basis of accounting that demonstrates compliance with the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of Rockcastle County, Kentucky, as of June 30, 2007, and the respective changes in financial position and, where applicable, cash flows thereof for the year then ended in conformity with the basis of accounting described in Note 1.

The management's discussion and analysis and budgetary comparison information on pages 4-11 and 53-55, respectively, are not a required part of the basic financial statements but are supplementary information required by the Governmental Accounting Standards Board (GASB). We have applied certain limited procedures, which consisted principally of inquiries of management regarding the methods of measurement and presentation of the required supplementary information. However, we did not audit the information and express no opinion on it.

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise Rockcastle County, Kentucky's basic financial statements. The accompanying supplementary information, combining fund financial statements, are presented for purposes of additional analysis and are not a required part of the basic financial statements. The combining fund financial statements have been subjected to the auditing procedures applied in the audit of the basic financial statements and, in our opinion, are fairly stated in all material respects in relation to the basic financial statements taken as a whole.

In accordance with Government Auditing Standards, we have also issued our report dated October 28, 2008, on our consideration of Rockcastle County, Kentucky's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with

Government Auditing Standards and should be considered in assessing the results of our audit. Based on the results of our audit, we present the accompanying comments and recommendations, included herein, which discusses the following report comments:

valuable these cast-iron cooking utensils have proved to be. It said that if one is inherited from a relative (so you know its background), chances are a skillet in good shape could be worth up to \$200.

I have four different sizes that Bee gave me, and I use them all the time. Guess that makes me quite rich in iron cookware.

Probably my favorite (or at least the one I am most sentimental about) is a small, #3 skillet – the memories attached to it are distinctly between my mother and me. That skillet is just big enough to hold a single

hamburger patty. Bee used to purchase hamburger and pat it into individual patties wrapped in wax paper and put them in our freezer. When I came home from a late night date, she was always up waiting for me and that was precisely when this pan was put to use.

Like most mothers, Bee knew that a teenage boy was ALWAYS hungry. So she was ready to take care of her baby boy. She would take out one patty, place it in the small castiron skillet, and make me a home-made cheese burger for a snack. It was a special time between us. Boy, I can taste that burger right now.

My Dutch oven is sometimes put to use to cook soup beans with a ham hock when I have the day to prepare a homecooked meal. The only thing I add to the meal is a fresh jar of Clausen sour kraut, a cast-iron

muffin pan filled with Bee's cornbread recipe, and a freshly sliced onion. I have often told my wife that if I can only have one last meal, that is the one I

We have also used the Dutch oven while in the woods to prepare a beef stew meal that we kept on an open fire for most of the day. Our friends who joined us commented that it was the best stew they had ever consumed. It is quite probable that long walks in the woods added to their appetites and their enjoyment of the

I have the feeling that Mommie Katie and Bee both realized what joy they were handing down in the form of that cast-iron cookware - and I feel especially blessed to be able to continue the tradition. My son loves to cook, but he has been a Yankee for some years now. I am sorry to say that it is questionable how far the tradition will flow from

funnel their loans through them so the loans can be obtained from KACo (Kentucky Association of Counties) at a much lower interest rate.

service was going to have to do something about stepping up their rotation of buying and paying for new ambulances. "We presently have a 2006 ambulance with 121,000 miles that we still owe \$25,000 on," Pensol told the court.

On question, Pensol told the court that the service averages 3,500 runs a year and had made 1,250 runs so far in 2009.

The service employees anywhere from 19 to 25 full and part time employees.

The ambulance service board is composed of Pensol, Director Harry Harmon, Dr. John Parsons and Dr. Lee Cain and all who serve without any compensation.

As to being brought under the administrative code. Houk told the court that a lot of areas in the code would not fit her office. "What am I going to do when there's a line of people at my window at 4 o'clock," Houk asked, "just close the window?"

Carloftis told Houk that the court certainly did not intend for her to shut her window at 4 o'clock with people standing in line and that he originally "wrote out and exempted the county clerk and sheriff" from the administrative code but he now felt the offices should be included to see that the nepotism laws were followed, for one

The judge then asked Houk and Sheriff Mike Peters to meet with him before next month's meeting to "fine tune" the administrative code to fit their of-

Houk also told the court that she felt "fraud was involved in her budget for this year and it isn't settled vet." Houk claims that her budget figures were changed and not brought to her for her signature before being submitted to the state. However. the changes were made in open court at a meeting at which Houk was present.

court does not have the right to change her budget, and had no control over it, was countered by Carloftis who said that "common sense" dictates that the fiscal court is in control of the finances of the county. "If the fiscal court was not, the county clerk could present a budget of whatever amount and (if the clerk's revenue was not sufficient) the fiscal court would have to come up with the dif-

In other business, the court heard a bit of good news from their KACo insurance representative who gave them their overall premium for the coming fiscal year, \$176,044, for all lines of insurance for the county, including fire, liability, workmen's comp, etc. Larry Denney told the court their premium would be around \$1,800 less than last year, the first decrease in several years, and the rate would be guaranteed for a three year period.

During the discussion, before approval, Carloftis pointed out that the county collected about \$270,000 in property taxes each year and the insurance premium is \$176,044 -almost two-thirds of the total property tax revenue.

Jim Holton, project manager for the SourceCorp gave the court an update on the construction -- construction which has been affected heavily by the rainy weather.

Holton said that the brick was 1/3 laid; electric, 80% completed, all of the tile has been set in all of the bathrooms, water is expected to the building in about 10 good working days with sewer to follow, roof top electrical units were being set Tuesday, coat of paint on almost all walls and about 50% of the framing for the drop ceiling is in place.

Holton told the court that a meeting was scheduled the SourceCorp officials on Thursday (today) to finalize their move-in plans and that while the June 1st completion date was still the aim, "if we have a certificate of occupancy by the

middle of June, I'll be tickled."

The court also received a check for \$8,573.08 from Sheriff Mike Peters for excess fees from the calendar year 2007.

The court also: approved a \$200 donation to Project Graduation; approved an extension of their contract with New Wave Cable to the year 2021; approved the 2009-10 budgets for the Rockcastle County Extension District Board and District Health Department; refused to consider lifting their ban on yard sales on county property; approved a payment of \$2,555.40 to the Energy and Environment Cabinet for the 2c per acre tax on private forest acres and approved a claim for \$15,753.39 to state auditor Crit Luallen for the county's 2007 audit.

County Treasurer Joe Clontz's monthly financial statement showed all county accounts in the black, except for the detention center which showed a negative balance of \$2,860.21. Clontz also told the court that a \$76,000 payment was due June 1st on the debt service for the jail and that a transfer of funds from the general fund would have to be made to cover the expenditure. The general fund had a balance of \$922,677.99 as of April 30th which included some of the proceeds from leased funds from Community Trust Bank for the SourceCorp project, which had already been expended from the general fund, grant money for Eastern and Western water districts and PRIDE grant funds.

The court voted to transfer up to \$100,000 into the jail fund from the general fund and \$100,000 to the road fund for repayment of funds transferred to the general fund earlier in the fiscal year.



Members of the Mt. Vernon Volunteer Fire Department were called to the mobile home of Margie Miller in Ramsey Trailer Park in Mt. Vernon around 3:50 a.m. Wednesday morning. Asst. Fire Chief Jack Weaver said a neighbor managed to extinquish most of the blaze with a fire extinguisher before fire units arrived on scene. Weaver said the hood range above the stove in the trailer shorted out causing the fire. No one was injured.

State audit for 2007 results in a few recommendations for Fiscal Court

Last Wednesday, State Auditor Crit Luallen released the audit of the financial statements of the Rockcastle County Fiscal Court for the fiscal year ended June 30, 2007. Kentucky State law requires annual audits of county Fiscal Courts.

The audit found that the county's financial statements, in all material respects, fairly present the county's assets, liabilities, and equity arising from cash transactions and revenues received and expenditures paid in conformity with the modified cash basis of ac-

As part of the audit process, the Auditor must comment on non-compliance with laws, regulations, contracts and grants. The Auditor must also comment on material weaknesses involving the internal control over financial operations and reporting.

The audit contains the fol-

lowing comments: The County lacks adequate segregation of duties. The audit recommends that a qualified office employee, independent of check writing and posting duties, match purchase orders to checks and invoices. Having this person initial the purchase orders and invoices and by making sure these invoices are marked paid can be shown as evidence of segregation of duties. Also, the audit recommends that the person opening the mail keep a listing of all checks received for that day, detailing the date received, the check amount, whom it is from, and the purpose of the check. This will help segregate the duties of the treasurer. To have better internal controls, the best practice is to keep the receipt of cash, the disbursement of cash, and the posting of cash to the ledgers delegated to separate individuals. The Rockcastle County Management responded, "Due to budget constraints, segregation of duties is not possible at this time.'

The County should promptly mail all checks when issued. As of June 30, 2007, \$11,335 of Jail Fund checks were issued and not mailed. The audit recommends that checks not be issued until funds are available. This would eliminate the need for holding checks. The Rockcastle County management responded, "This has been corrected."

The County should maintain minimum balance in their payroll account. The County's reconciled balance in the payroll account as of June 30, 2007 was \$47,588. The payroll account is a revolving account and should not at any given time have more than a minimum balance after reconciling items are taken into consideration. Payroll liabilities due from this account amounted to \$31,725, resulting in a surplus of \$15,863. The audit recommends the surplus be transferred to the General Fund. The Rockcastle County Management responded, "County agrees with this finding, however the excess funds corrected itself in the subsequent year, and as of June 30, 2008, there were not any excess

funds." The County should pay invoices within 30 working days. During the course of the audit, auditors found numerous invoices that were not paid in a timely manner. KRS 65.140 states that all bills for goods or services shall be paid within thirty (30) working days of receipt of vendor's invoice except that when payment is delayed because the purchaser has made a written disapproval of improper invoicing by the vendor or by the vendor's subcontractor. The audit recommends the county comply with KRS 65.140 by paying invoices within thirty (30) working days. The Rockcastle County Management responded, "This has been corrected."

The County should properly account for encum**brances.** The county did not properly account for encumbrances as required by the Department for Local Government. The county did not include encumbrances on the face of the Fourth Quarter Treasurer's Report. The audit recommends that the county properly maintain encumbrances as required by the Department for Local Government. The "Instructional Guide for County Budget Preparation & State Local Finance Officer Policy Manual" states, "Enter the total dollar amount of unpaid purchase orders from the purchase order journal." The audit recommends the county maintain a purchase order journal in the future and use the amounts from the journal as the encumbrances listed on the quarterly report. The Rockcastle County Management responded, "This has been corrected in future years."

The County should budget for all expenditures. According to KRS 68.300 expenditures should not exceed amounts budgeted. As of June 30, 2007, Jail Fund expenditures exceeded amounts budgeted by \$633. The audit recommends that procedures be established to ensure that expenditures do not exceed amounts budgeted. The Rockcastle County Management responded, "Due to the timing of the receipt of revenue, we did not have enough time to get a budget amendment. We will try to correct this in the future."



Thinking About Cleaning Your Carpet! Some things to think about...

What is the best way to clean my carpet, should I use the old technology of steam cleaning or the new technology of dry foam?

Option 1: Steam Cleaning-How does it work?
