**County receives Letter of Credit** for Hammonds Fork Road

A \$40,000 Letter of Credit was obtained this week by County Judge/Executive Buzz Carloftis in order to protect 6/ 10ths of a mile of Hammonds Fork Road, which the county recently blacktopped.

The Irrevocable Letter of Credit was given to the court by Feldman Lumber Co. which is using the road to conduct a logging operation in the area. The matter was discussed at a June 30th special called meeting of the Rockcastle Fiscal Court, at which time the court gave Carloftis the authority to negotiate with Feldman for financial protection for the county, in case the road was torn up by the logging trucks.

Carloftis negotiated with Feldman for the trucks to use only 6/10ths of a mile on the road in the logging operation, from the site of the operation to the state highway at Disputanta, and said the \$40,000 letter of credit would cover any damage to the recently blacktopped county

Also during the meeting, Jim Holton, RCIDA consultant and project manager for the new SourceCorp building, updated the court on the project and said that SourceCorp was expected to take possession of the building on July 17th.

Rockcastle Hospital and Respiratory Care Center Inc. announced this week that they will now be known as Rockcastle Regional, a name that more accurately describes their aggressive organization.

"The name Rockcastle Regional is a more appropriate identity for the hospital and reflects the growth and advancements we have made," said Rockcastle Regional President

and CEO Stephen Estes. "Our primary commitment is to provide the highest possible level of care to those we serve. The new name affirms our commitment to providing that care to an area that, in many cases, extends beyond our county's borders," Estes

The hospital remains a nonprofit hospital that is locally governed.

Since 1981, the Respiratory Care Center at Rockcastle Regional has been the destination for mechanically-ventilated pa-

### Residents ask for help with poor road conditions

Residents, who live along Pleasant View Drive in northern Rockcastle County, are not happy with the condition of the roads they travel, although according to deeds filed in the Rockcastle Courthouse they knew their responsibilities concerning the roads when they

bought the property. Numerous residents bought property in a new development by Garla and Linda Johnson beginning in 2003. In some of the deeds on record in the courthouse, which most current landowners signed, there are

specific regulations stating the residents knew the roads were not county roads and residents of the area would be responsible for maintaining the roads.

Resident Faye Himes says she doesn't think her deed has those requirements but, nevertheless, she thinks the county should take responsiblity for maintaining the roads because of the number of residents who live in the subdivision and who are taxpayers. "We pay property taxes for a reason and we need help out here," Himes said. Himes said landowners in the area live on Pleasant View

Drive, Brian Lane and Teresa Lane and each road is in poor condition. None of the three roads are in the county road program.

Fourth District Magistrate Jan Stevens said he was concerned about the fact that so many of the residents in the area have school-age children who have to be taken to Clay Lick Road, at the bottom of the hill, to "catch the bus."

Last week community members held a public meeting to bring attention to their

**Price announces** candidacy for office of Mayor

in Mt. Vernon

First to throw hat in 2010 political ring

Although the election for the Mt. Vernon Mayor's seat is 16 months away, one local man has already announced his candidacy for that office.

Former Mt. Vernon City Police officer and Chief Rockcastle Deputy Sheriff Nathaniel Price announced on Tuesday that he will be a candidate for the office of Mayor in the November 2nd, 2010 General Election.

Price said Tuesday that with his 13 years of public service, four of those assisting in oversight of a \$1.2 million budget in the Sheriff's office, he feels he is well qualified to serve as Mt. Vernon's Mayor.

Price outlined his platform in a statement to the Signal on Tuesday.

The 37-year-old Price basically touched on four subjects, which were: immediate repeal of the city's restaurant tax, opposition to any ordinance favoring zoning and permits, enhancement of public safety and city water.

Price said he thought the restaurant tax was harmful to citizens and to the tourism industry in Mt. Vernon. The candidate said not only would the restaurant tax be looked at, every tax the city imposes would be looked at critically to see where cuts can be made, including the occupational and net profits taxes and that spending would be curtailed heavily on his first day in office.

Last month the city committed themselves to a \$750,000 loan for the purchase of property at Renfro Valley, where the tourism commission hopes to Nathaniel Price says he will build a conference and tourist

Price also said he was against zoning and permits because they are "an excessive and underhanded method of taxation."

Price also said he would immediately begin reinstatement of the DARE Program in Rockcastle Schools and commit more resources to the city's police department so they can focus more on drug trafficking problems inside the city. He said he would also ask the council to commit all resources available to the fire department so that equipment is state of the art for effective fire protection.

Price said he would aggressively seek grant funding for both the police department and fire department so that services can be expanded without causing more burden on taxpayers.

Price also said he would attempt to create a civilian review board for the police department.

Price said his own experience in the police department has led him to believe such a board is necessary to ensure

### Educator, businessman Jim Cox dies Tuesday

James H. "Jim" Cox, 67, of a funeral parlor upstairs. Mt. Vernon, died Tuesday, at his Mt. Vernon home, after a long battle with cancer.

Mr. Cox, who was born February 6, 1942 in Mt. Vernon, was the son of the late John and Frances Brown Cox. He was a retired teacher, administrator, football coach and bus driver for the Rockcastle County School System.

Cox was also a former Mt. Vernon volunteer fireman, president of the Elmwood Cemetery Board, owner and operator of Cox Hardware and a member of First Baptist Church, where he was an Awana volunteer and member of the sanctuary choir and handbell choir.

He began his career as a teacher in 1965 and became assistant principal of Rockcastle County High School in 1990 and remained in that position until his retirement in 1997.

After his retirement, Mr. Cox worked at Cox Hardware in Mt. Vernon, a business begun in 1907 when two Cox brothers began a dry goods store on one side of the twostory building on Main Street and two other brothers operated

Since the death of his father, John, in 2001, Jim and his wife, the former Martha Sowder, operated the store which has been featured several times on KET. Through five generations, and more than 100 years, the family business has provided a comfortable atmosphere where folks sit around a coal-burning stove in the winter, sharing stories and visiting with their neighbors and friends. Mr. Cox encouraged others by working at the store until the last days

of his illness. Besides his wife, survivors include two daughters, Jennifer (Ken) Mattingly and Jamie (Chris) Cornelius, both of Mt. Vernon and five grandchildren, Katy, Kelsey and Ethan Mattingly and John Christopher and Amy Cornelius.

Funeral services for Mr. Cox will be conducted at 11 a.m. Thursday (today), July 9, 2009 at the First Baptist Church with Bro. Eddie Nation officiating. Burial will follow in Elmwood Cemetery.

My adventure with penicillin
When I was a small child
living in Mt. Vernon, my
mother often took me to Dr.
George Griffith for childhood
illnesses. During those early
years, I frequently was prescribed penicillin as a normal
antibiotic to reduce infections.
No allergic reactions occurred,
so I had no idea that my future
contained a related medical is-

sue of a serious nature.

When I graduated from Mt.
Vernon High School, the ceremony was held on a Friday night in May of 1962. As the exercise commenced, my black '58 Chevy was already packed for my entrance to UK for the summer session.

On Monday morning, I left home for my most stimulating adventure up to that time in my young life. I kissed my mother (Bee) good-bye and left home never realizing that I would never again reside in Rockcastle County.

At the time of my departure from Mt. Vernon, the city's population was 1,106. The number of students at UK during that summer semester was several thousand. Upon my arrival on campus, I was overwhelmed with the hustle and bustle of students moving into the dorms, throngs of guys playing basketball on outdoor courts, and the vast number of

girls walking throughout the campus. I felt like a "fish out of water."

I finally moved into the Hagan Hall dormitory and met my roommate. His name was Steve Stacy, and he had moved in the day before. I was glad to learn that Steve was a sophomore, so he had lots of experience that I did not have at the time. He asked if I would like to walk over to the K-Lair, which was a popular hamburger joint on campus. I said sure, and we went on an excur-

Upon entering the café, I noticed a multitude of college women sitting all over the place, and Steve began to introduce me as his roommate. Before long, I had several campus phone numbers belonging to some of the young ladies. One girl in particular struck my fancy and, when I returned to my room, I gave her a call. We made plans to attend the drivein theatre in Lexington the following Saturday evening.

I had a dental appointment that Saturday afternoon, and the dentist filled a tooth and gave me an injection of penicillin for the infection. Neither the dental work nor the "shot" caused me any discomfort, so I proceeded to pick up my date.

Twice a year, July and late December, Loretta and her siblings are blessed with a two week visit from Amy Embree, Lorettas thirty-year old niece who was in a horrible automobile accident in 1994 that claimed the life of her father. Amy miraculously survived but with severe physical and mental damage that have left her with challenges that would overcome most lesser human beings.

She communicates by sign language or, in my case, with a Sharpie and a note pad. She hears and understand every word I or anybody else has to say but I can't distinguish anything she has to say. Loretta can understand most of her vocalization because the two of them are more like mother and daughter than aunt and niece. Actually it's a combination of mind reading and understanding Amy's utterances and facial expressions.

Up until last year, Amy's mobility was limited to a wheel chair and a walker and mostly to the chair.

But for what she lacks in physical ability and emotional shortcomings, Amy makes up for in spirit and dogged determination. This year she made the trip, with a layover (first time) in Cincinnati from Newark without her wheel chair. The flight attendants used whatever portable wheelies

they keep around the airports to shuttle her about and Loretta worried herself sick until the flight had landed for fear that Amy would not make the connection.

No big deal to Amy. She is extremely adept with the steno pad and Sharpie and it never once occurred to me that she'd get lost. At this writing, Loretta is trying to figure out how to get her to Cincy and dodge the layover but Amy is having no part of it. The puddle jumper flight from Cincy, her first, was the highlight of her trip and she can't wait to get back on it. She actually looks forward to sitting in the passenger lounge and making friends with total strangers for three hours.

All the folks at the Continental desk in Lexington know her on a first name basis and by the end of the year she will be similarly acquainted in Cincinnati.

On Friday evening before the 4th we took her to a good friend's pond---actually small lake--- to fish for bluegill. Normally we spend a day fishing at Cedar Creek Lake in Lincoln County from handicapped accessible piers but I don't suppose to need to tell you about rain. The bluegill were not biting but I had rigged up an old Zebco with commercial catfish bait and after about an hour it started twitching and whining as a fish took the bait and headed for deep water.

Amy grabbed up the pole and jerked and then gave me the question mark look. "Why am I hung up when the line was moving," and then the rod nearly pulled her into the lake. Her mouth dropped open and her eyes widened in the most wonder I've ever seen on her face. She looked at me and for the fist time ever, I understood what she was saying. "Not a bluegill! Not a bluegill!"

Loretta and my friend and I took turns helping her stand without the walker as she fought the fish and I have never seen such elation in my life. I'm pretty sure I don't want to understand some of the words she was using. At times we would put our arms under the rod to keep it aloft but Amy did the fighting and after 10 or 15 minutes she got the channel cat to the edge of the bank and I netalized.

She was wet with sweat and more exhausted than the fish which weighed in at 7 pounds

### Accidental Poisonings in Children

Accidental poisonings are one of the most common causes of serious illnesses in early childhood. Many bottles and boxes of cleaners, medicines and other substances are kept under sinks, in drawers and on shelves. Even when it seems like everything is safely put away, toddlers will find something.

At this age, children learn about their environment by putting everything in their mouths. Though they usually get more of the substance on their clothes and the floor than in their mouths, a parent cannot know for sure.

Accidental poisonings are treated in different ways depending on what is swallowed by the child. Check with your doctor immediately for any accidental ingestion.

Activated charcoal has become the main treatment for a very wide variety of accidental poisonings. This is a compound which will bind most medicines and toxins. Activated charcoal is the most useful treatment if over two hours have passed since the ingestion. It can be mixed with a sorbital solution that makes the charcoal and poison pass through the gut more rapidly.

Your regional poison control center is an extremely useful source for information. Very many of the accidental poisonings, such as ingestion of berries or leaves of plants, and household items such as lipstick and cleansers, can be handled over the phone. Many ingestions are now treated with simply observing the child for a period of time, and the poison control center can also advise you how long the child must be observed for untoward symptoms.

Always keep your doctor's phone number and the poison control center number near your phone in case of emergencies. The Kentucky Regional Poison Control Center phone number is 1-800-222-1222.

#### Rockcastle and **Madison Counties** are apples and oranges...

Dear Editor,

I would like to respond to Todd Moberly's letter to the editor, regarding land management (zoning). In my response, I represent no group with whom I may be affiliated.

In his letter, he raised the issue of zoning in Madison County. He further stated that he hoped the people of Rockcastle don't make the same mistake other have made, Presumably, he was referring to the early stages of resistance that existed in Madison County.

I would suggest that the need for, or implementation of, zoning that took place in Madison County, has no similarity to the conditions that exist in Rockcastle. Madison County has Berea College, Eastern Kentucky University, Bluegrass Army Depot, many factories and a geographical proximity to Fayette County. In fact, it can be argued that Northern Madison and Richmond is an extension of Lexington, thus Fayette South. These areas of notation are the primary precipitant behind the growth in Madison that Mr.. Moberly addressed. Rockcastle has none of these similarities that exist in Madison to suggest the need for zon-

I am 60 years old and I grew up in Rockcastle County. I

would like for the people of this county to look at our county's land management that has taken place without official implementation of zoning. In the area of education, we have a modern central high school, Brodhead Elementary, Mt. Vernon Elementary, the middle school and, of course, the expanded Vo Tech school. Incidentally, Roundstone and Brodhead schools have geothermal heat. In the area of medicine and health care, we have the largest respiratory rehabilitation hospital in the southeast. We also have the medical arts building, the ER/rehabilitation building, affiliation with UK's Cancer Center and the affiliation of many physicians. In the areas of infrastructure, we have seen the development of Lake Linville, sewage treatment facilities, updating of many of the county's roads, including the 461 bypass. We certainly can't forget the vast expansion of the Renfro Valley complex. It is apparent that a great deal of thought and planning has gone into these many areas of notation, without the oppressiveness

that accompanies zoning. Mr. Moberly suggested that our thinking on land management was akin to the thinking of 1850. I would suggest that our thinking is more in tune with July 4, 1776 -- Independence. Independence from an expanding governmental bureaucracy that is not even responsible to voters by way of a voting ballot. In recent months, we have all heard the phrase "change we can believe in." We are now seeing those changing coming to fruition, bring an assault on our freedom from the federal level. I see no need to stoke the fires to reduce our rights at the local level as well.

In his letter, Mr. Moberly made mention of passing our green space to our posterity. It would seem to me that our green spaces in Rockcastle have been constant for decades. Certainly, there are some eyesores, however, in this county, we don't need to throw our freedom out with the bath water.

In closing, he made mention that we don't inherit the land from our grandfathers but borrow the land from our grandchildren. I think not. Our freedoms are inherited from documents authored by our forefathers as God gave the light. We owe a great deal to prior generations for our land and freedoms. That debt can only be paid to the generation that is gone by preserving them for the next generation.

I think the real green involved by most of the proponents of zoning, is the green that is wanted out of our wallets for government coffers.

She has certainly painted a very idyllic setting of another time and place: one in which anyone would enjoy growing up in, and having as a permanent part of their memory.

#### Poplar Gap The Roots of the Allen Family Heritage, Part 2

Not everyday was filled with such activity. (Writer's note: The activities of childhood play as recorded from last week) On sunny afternoons, when we didn't feel so adventurous, we'd take a salt shaker and a ball of twine to the garden. After eating a tomato or two, fresh off the vine-yummywe'd catch some big, shiny, green Junebugs out of the corn patch, then tie the string to their leg, and watch them fly like a kite, and listen to them sing. Poor little things were probably screaming for their lives.

On a rainy day, we might go up into the barn loft, and lie in the hay, and listen to the rain hit the tin roof. Lying there in sheer serenity, we'd watch the dirt-daubers build their mudtunnel nests in the rafters high above us. They worked so hard.

It was always church on Sunday, and Mommie's wonderful dinners afterwards. Visiting preachers and evangelists would always stay at our house, and on Sunday, Daddy would gather all other church visitors, and take them home with us for fried chicken with all the trimmings; blackberry, strawberry, or peach cobbler, and homemade ice-cream (sometimes, ice-cream).

I know this sounds ludicrous now, and is, but at that time the children would eat after the grownups. We would sit on the porch and wait, like little adults, taking an occasional peek through the window, but relinquishing all hope that the pulley-bone would be left; but there was always enough to go

At the end of the day, when Vernon Signal or at bedtime came, we would all be therootsofrockcastle@windstream.net. settled in with the lights out (except for the millions of stars shining through the window), I would hear Mommie and Daddy praying, and my own tears would start to roll down my temples filling up my ears. Then I'd pull the covers up over my head and fall asleep on my wet pillow.

The years passed by. After graduating from high school, each of us, one by one was drawn away from our beloved Poplar Gap-the place that, as children, we felt was surely created especially for the Allen clan-the place where Daddy toiled and labored as the earth soaked up his sweat-the place where, after a long day in the fields, we could always find Mommie in the kitchen singing the songs of Zion as she prepared a hot supper for her family. 
The old barns were still there. I'm sure one could go back, and looking closely, see our footprints, and see our names, birth dates, and who loves who carved on the barn

PLEASE TAKE NOTICE that on June 26, 2009, Kentucky Utilities Company ("KU") filed with the Kentucky Public Service Commission "Commission") in Case No. 2009-00197, an Application pursuant to Kentucky Revised Statute 278.183 for approval of an amended compliance plan 'KU's 2009 Environmental Compliance Plan") for the purpose of recovering the capital costs and operation and maintenance costs associated with new pollution control facilities through an environmental surcharge on customers' bills beginning February 2010, under KU's existing rate mechanism known as the environmental cost recovery surcharge or "Electric Rate Schedule ECR."

Federal, state and local environmental regulations require KU to continually build and upgrade equipment and facilities in order to operate in an environmentally sound manner. Specifically, KU is seeking Commission approval of a Certificate of Public Convenience and Necessity ("CPCN") to construct a new Selective Catalytic Reduction system ("SCR") for Brown Unit 3 at the E.W. Brown Generating Station in Burgin, Kentucky to comply with federally mandated nitrogen oxides requirements, and approval for CPCNs to construct new landfill facilities at the Ghent Generating Station in Ghent, Kentucky and at the Trimble County Generating Station near Wises Landing in Trimble County, Kentucky. Additionally, KU is seeking recovery of costs associated with these environmental projects, which are necessary for compliance with the Federal Clean Air Act, the Federal Clear Nater Act and the Federal Resource Conservation and Recovery Act. These additional projects primarily relate to installation of an SCR system or Brown Unit 3, expansion of the coal combustion byproduct ("CCP") treatment basin at the E.W. Brown Generation Station, expansion of the CCP treatment basins at the Trimble County Generating Station, construction of new landfill facilities at the Ghent and Trimble County generating stations and certain operating costs associated with the Air Quality Control System equipment necessary to operate Trimble County Unit 2 within the approved environmental limitations. The capital cost of the new pollution control facilities for which KU is seeking recovery at this time is estimated to be \$463 million. Additional operation and maintenance expense will be incurred for these facilities.

The estimated impact on a residential customer using 1,000 kilowatt hours per month is expected to be an initial monthly increase of \$0.99 for KU customers during 2010, with the maximum monthly increase expected to be \$3.73 during 2013.

The Environmental Surcharge Application described in this Notice is proposed by KU. However, the Public Service Commission may issue an order modifying or denying KU's Environmental Surcharge Application. Such action may result in an environmental surcharge for consumers other than the environmental surcharge described in this Notice.

## Planning and Zoning

Comments from County Judge-Executive Buzz Carloftis

Q: A few weeks ago, a new organization against any planning and zoning printed a partial copy of neighboring Lincoln County's ordinance. Would you be in favor of that?

A: Absolutely not. It appears that Lincoln County simply copied something from some other community – maybe from Kansas. Who knows? I just know it doesn't affect us, and I would never be for anything that looks remotely like Lincoln County's ordinance. But what they printed was not really even Lincoln County's planning and zoning, as I recall. It appeared to be a list of building 'codes' that have nothing to do with planning and zoning. I think someone has tried to play a hoax on the good people of Rockcastle County.

So before we proceed with this interview, let's get some facts straight: No member of the fiscal court is involved with planning and zoning; there is no plan or movement toward planning and zoning by the fiscal court; in fact, there has never been any movement toward planning and zoning in the 200-year history of this county.

Q: Then why all the local uproar against the Fiscal Court?

A: Well, someone has taken a statement made by a private organization – the Rockcastle Development Board, Inc. – which, by the way, has no official connection to government other than being recognized by state agencies as the official development organization for the community – and that person has taken a single statement by that board and blown it completely out of proportion. That same person has tried his best to make the people believe the fiscal court is involved with planning and zoning – and that it is going to happen. Those who know the facts realize that is quite a stretch, but those who do not know any better simply go by what they hear and actually believe it. The truth is that the Development Board, Inc., actually included some of the same language in their strategic plan over eight years ago. It still sits in their book, but no person, no group has ever acted upon it – and it has never been brought before the fiscal court.

#### Q: How would you describe the efforts to prevent any planning and zoning in Rockcastle County by the 'Concerned Citizens for Fair Government', which is how I think they have named themselves?

A: Everyone should be for fair government – it is a good name. But to describe that group's efforts...well, they approached it with the zeal of evangelism. Except that real evangelists spread truth. Not the rumors, distortions of fact, and, from what I've heard others tell me, unbelievable stories. To answer your question, I would say they have been very successful with their propaganda and fear tactics to inflame citizens. Haven't you wondered why they used an excerpt from Lincoln County to inflame Rockcastle's residents against it? Why didn't they use Atlanta's or New York City's? They wouldn't have been any more ridiculous. And I say that because every community should decide what best fits its own needs.

#### Q: How much do you personally know about planning and zoning?

A: I know very little, but after looking at this group's statements, perhaps I know more than they know. In all honesty, I have never read a document for planning and zoning from anywhere – with the exception of what that group printed in the paper from Lincoln County, and that appeared to be more of a code than planning and zoning.

#### Q: But why would the group be so against something they haven't seen? Something that doesn't even exist?

A: That's the question that kept going around and around in my head for the past month or so. I couldn't understand it. The group had to have some other agenda – some plan it was working on itself. At least, that's my conclusion.

Q: What sort of agenda could that group have other than stopping any talk about planning and zoning for Rockcastle County?

A: Well, remember what their petition says: No planning and zoning for Rockcastle County. On the surface, it looks like the thing to sign. But I have always known that you can't judge the depth of the water by just looking at its

### Q: What do you mean by that?

A: Look at it this way: This new group has zero tolerance for planning and zoning. I think that's their position according to the petitions I have seen. If there is never any planning and zoning in a community, then it means one thing – and this is very important to consider: Anything, any business, practically any activity could possibly try to skirt local ordinances in order set up their business activities here in Rockcastle.

### Q: What, exactly, are you talking about?

A: A few years ago the fiscal court took action in order to try to prevent some businesses from setting up so-called 'strip joints' or other adult-oriented businesses in this county. That action came after I received notification that Rockcastle County was being targeted by some of these businesses that were looking at this community because of its proximity to I-75. And take into consideration this very important fact: So-called 'morals' ordinances by local governments across the country are contested on a daily basis. Some of them are struck down by courts of law. Those communities that have had planning and zoning already in place, however, have made it much more difficult for those businesses to establish themselves. I've been told that planning and zoning provides just one more layer of the legal onion such businesses would have to peel, so to speak.

### Q: So what are you saying?

A: I have recently received telephone calls asking if Rockcastle County has planning and zoning ordinances in place. I can't say for sure that they were on a fishing expedition, but I have learned to become cautious.

### Q: And those who signed the petition?

A: I'm simply saying that those who signed the petition, in my opinion, have fallen into one of two categories:

1. Those who were being misled and didn't stop to get answers to any questions they might have had before signing something that could have peculiar consequences in the future;

– or –

2. Those who really don't care what comes into Rockcastle County at all. After all, that is what they signed. Q: Do you think there is a third possibility?

A: Can you think of one?

### Q: Will the fiscal court accept the petition?

A: We certainly will, and the names on the petition will be entered into the public record at its face value: They want no zoning, which means they want no local protections against what could happen without it. Ultimately, it will be the will of the people to decide what they want for Rockcastle's future generations – the type of community in which they would like their grandchildren to be able to raise their own families. Good people gravitate toward good communities. And, again, I have never advocated nor proposed planning and zoning.

### Q: Did you sign the petition?

A: No. I like to look at things more carefully before placing my name on such things. In other words, I like to know the depth of the water before jumping in.

that citizens have a greater voice in the training, methods and community relationship between the police department and the citizens they serve and protect.

Price said this review board would consist mostly of citizen members, a prosecutor and a local attorney.

Regarding city water, Price said he would look not only at what short-term fixes might be available, but also to plan longterm. Price said he would look at the creation of a secondary reservoir while Lake Linville undergoes extensive renova-

Price said he would also in-

volve the city council more in personnel decisions and would like to initiate a comprehensive employee evaluation review process to ensure that raises and promotions are based upon a fair and consistent process.

Price, the father of two sons, and the son himself of a Baptist minister, makes his home in Mt. Vernon with his wife. Gail McClure Price. He is currently an employee of RTEC.

Price said he would formally file his election papers with Rockcastle County Clerk Norma Houk in November.

Houk said Tuesday that candidates for all city and county offices can file on or after November 4th.

Houk cautioned all candidates who have not filed to keep receipts of any money

raised or spent before they file because the state requires that candidates account for all monies spent or received during their campaign, whether they have officially filed or not.

The County Clerk said those wishing to run for county offices have until the end of January 2010 to file, but those, such as Price running for a city office, have until the first week of August 2010 to file.



problem and to attempt to get help from pubic officials, something they say they have done in the past.

Stevens said residents feel helpless because they do not have the money to improve the roads and they (the residents) have apparently gotten no response to their requests for help from Johnson.

This is a bad situation for the landowners but it goes back to the lack of meaningful regulations imposed upon landowners and developers by the fiscal court. It is my opinion that most Rockcastle Countians don't want any kind of regulations by the local government and the uproar over Pleasant View Drive is a prime example of what happens without regulations on development of subdivisions and subdivided property. The fiscal court really has no authority over subdivision roads, which may or may not have been subdivided properly," County Judge Buzz Carloftis said.

Carloftis said any developer can simply knock out a roadway, sell lots, and then wait until the residents in the new development scream at the fiscal court to spend taxpayers' money to bring the roads up to state standards. Carloftis said other county taxpayers suffer at the developer's benefit when that occurs.

According to a Kentucky Attorney General's opinion concerning the maintenance of a subdivision street or county road, the road must be at least 200 feet in length, have an 18 ft. wide blacktop surface, be dedicated to public use and at least 50 percent of the lots abutting the street or road must be occupied by a resident.

"I am positive that this fis-

cal court will help these landowners anyway possible, but it is against the law to blacktop roads that are not up to state specifications and have not been accepted into the county road program," Carloftis said.

Rockcastle School System Transportation Director David Perkins said he had been contacted by landowners who want buses to pick up children on Pleasant View Drive, Brian Lane and Teresa Lane. 'I'm sure we would consider taking buses on those roads, but only if they are county roads and meet all state specifications, we have rules to follow as well for the purpose of safety," Perkins

Perkins said he had not told any resident in the area that the school system would pick up children on those roads before the roads in question were taken into the county road pro-

Magistrate Stevens and Judge Carloftis said they thought all property owners should contact developer Garla Johnson to see if he would help to bring the roads to specifica-

"We really cannot begin the process of developing roads in private subdivisions, but we can make suggestions and hope something will be done so we can take them over," Stevens

Developer Garla Johnson could not be reached for com-

### Local family will go by bicycle to state of Alaska

Bill and Amarins Harrison have always been thrill seeking and adventure loving people and that love for traveling will take them across the country, beginning in August.

However this isn't your typical trip. The Harrisons will be leaving August 1st and will set out for Alaska on their quint bike (five person tandem bicycle)

They will be joined on their trip by their three youngest children, Cheyenne, 7, Jasmine, 4 and Robin who is only

Leaving from Mt. Vernon, the Harrison family will ride to Charleston, South Carolina and from there on to the Florida Keys.

Once there, they will ride north along the Gulf coast of Florida until they reach the panhandle and then continue west toward the lower southern United States. The family's next stop will take them to Biloxi, Mississippi, from there will to Slaton Texas and then straight on to San Diego, California.

They will continue their trip by going north, up the entire coast of California, into Crescent City.

From there, the family will go on to Port Angeles, Washington, crossover into Canada and then back onto U.S. soil when they end their 7,000 mile journey in Fairbanks, Alaska in the Summer of 2010.

The family plans to live in Fairbanks for a year.

With only a small trailer behind the bike, which carries a maximum of 100 lbs., and much of it taken up by their tent, the family will be carrying only the bare necessities.

Their website (www.pedouin.org) has given them a lot of opportunities to meet people from all over the United States and many have even said they will join the Harrisons during their journey and bike with them for a few miles. They've also been in contact with people across the United States who have offered them a place to stay at night as they travel close to, or through, their neighborhood.

The Harrisons will be spending the majority of this coming winter in San Diego with people they've met online who have volunteered their time to help make this trip a success.

Riding a quint bike all over the country is a feat in itself. But, what makes this trip even more challenging, is that such a trip has never been attempted before with the Harrisons riding on a self-contained bike without a follow car or any help.

When asked what the driving force behind the trip was, Bill simply said "It's the spirit of freedom, we're going to take a chance and just live our dream. It's not going to be easy, but the American spirit goes against the odds." The Harrisons had been wanting to take a family trip together, but weren't sure where to go or what to do. However, since Bill had already been to Alaska twice "It just made sense to go" says Amarins. "Riding for two days straight and taking one day off will be very enjoyable because we'll be able to see America and the beauty it has to offer" she said.

The Harrisons figure they will be traveling 30-40 miles daily on the quint, which Bill had to have specially manufactured in Oregon.

On the quint bike, Bill is in the front and is the captain. He will be controlling the steering, gears, and braking. Behind him will be Jasmine, followed by Robin and Amarins while Cheyenne is riding in the back. To get into shape for the journey ahead, they have a 12 mile practice everyday to help improve their conditioning. The Harrison family has always done everything on their own, from living in a shed when they first moved to the county together in 2003 and building their own home, to planning this entire trip to Alaska.

Bill said the core of this trip goes beyond having fun and seeing America, but to "meet real people and value their judgments, put aside our political and/or religious differences and meet them on the same level. The experience alone will be something we will remember the rest of our lives."

The Harrisons have had mixed reactions from everyone they've come in contact with, but most have been very supportive and encouraging. The family also intends to write a book about their trip, shortly after their return to Kentucky although they haven't decided when that will be yet. Bill says if the trip up to Alaska goes well, and they don't have a lot of problems, then there's a good chance they'll bike back home. The only difference being instead of riding the same way back, they may travel east through Canada and come down south through the north-



### Steps can and should be taken to reduce stress for caregivers

Caring for someone close to you, whether it is a parent, a spouse or a close friend, can be stressful and sometimes feel like a burden. It is difficult to watch a loved one fall into a state of helplessness. Assuming responsibility as someone's caregiver is a big task, and steps can and should be taken to reduce caregivers' stress and keep things positive for all.

Stress is the result of many different factors including stepping outside your comfort zone to help, not having proper training, or losing time for other things. Stress can change your relationship with the care recipient and leave you worried and frustrated.

Stress isn't just unpleasant; it can negatively affect our health, well-being, and ability to provide care.

Many strategies and techniques can reduce, manage and even eliminate your stress. One of the most important things you can do is take care of yourself. Be sure to take care of your body by eating nutritious food and getting enough rest. If you're not already exercising, now would be a good time to start. It's important to make time for exercising, even if you have to rely on formal respite care or friends or family to provide care while you are at the gym or enjoying a needed breath of fresh air.

It's also important to take care of your mind and mental well-being too. Socializing with friends helps you be active and engaged while giving your mind a break from care giving. Friends can be a strong support network, can help out when you need them, and may provide respite care or comfort when you feel overloaded. Asking a friend to contribute in the smallest way helps you and your stress

Try taking breaks. You deserve them and shouldn't feel guilty. In fact, it's good for whoever you are taking care of to engage with others. Think about taking a vacation and getting volunteers or a health agency to fill your shoes while you're gone. After a vacation, you will come back refreshed and able to give better care. Remember to not bottle up your feelings. Let your emotions out or you could end up getting angry at the wrong person or at the wrong time. If you need someone to talk to, turn to your friends, family, physician, support group for caregivers or a professional counselor.

Stress can affect us all, but challenges a caregiver faces could cause additional stress. For more information on coping with stress as a caregiver, contact the Rockcastle Cooperative Extension Service at 256-2403.

Independent Auditor's Report

We have audited the accompanying statement of revenues, expenditures, and excess fees - regulatory basis of the Sheriff of Rockcastle County, Kentucky, for the year ended December 31, 2007. This financial statement is the responsibility of the Sheriff. Our responsibility is to express an opinion on this financial statement based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America, the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States, and the Audit Guide for County Fee Officials issued by the Auditor of Public Accounts, Commonwealth of Kentucky. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statement is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statement. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As described in Note 1, the Sheriff's office prepares the financial statement on a regulatory basis of accounting that demonstrates compliance with the laws of Kentucky, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.
