Employees with Greer Brothers Construction were busy on Tuesday putting down dense grade on the new access road into the Rockcastle Business Park South, off Hwy. 150. Officials said they hoped the road would be blacktopped by the end of the week. The new road, which runs from Hwy. 150 through the park was built by Goff Construction over the past few months. The total cost of the new road has been estimated at \$670,000. The state highway department is expected to let bids on widening Hwy. 150 to create turning lanes onto the access road by January 1st. That project will also be paid for through a \$1.3 million state grant, which was also used to pay the \$670,000.



My first UK "hoops" experience

I recently attended a UK basketball game at Rupp Arena to get a glimpse of the "new era" of college hoops under the direction of Coach John Calipari. His dribbledrive offense took me back to the fast-break style of ball that was made famous by the legendary Coach Adolph Rupp. Watching the latest edition of Wildcat basketball was exciting to say the least.

I saw my first UK basketball game at the age of seven. UK had previously won its second consecutive NCAA championship ('48 and '49) and had moved into the new Memorial Coliseum in December of 1950. The 1951 basketball season was off to a rousing start.

My uncle Charles Brown loved college sports and wanted me to experience first hand the unbelievable tradition of UK basketball. I remember him calling my mother (Bee) to see if it would

be alright if he came to Mt. Vernon to pick me up to attend the Saturday game with him. Uncle Charles assured her that he would bring me back home on Sunday after-

Saturday morning finally arrived, and I was packed and eager to spend the weekend with Aunt Ruth and Uncle Charles. I stood at the screen door with my suitcase ready at my side. My heart began to race when I saw Uncle Charles pulling up the gravel

While on our way to Lexington, Uncle Charles said that we had very good seats in the new arena. This was to be the first season of UK basketball in what some reporters were calling the "white elephant." In the beginning it had a seating capacity of 12,000, making it the largest arena in the South.

That night, when I first entered Memorial Coliseum, my

Rheumatoid Arthritis is Often Confusing Presented by Dr. Kimberly Cornelius

It used to be easy to tell when someone had rheumatism or rheumatoid arthritis. The wrists and knuckles were greatly swollen, the joints red and warm, and the fingers were bent to the side.

Doctors do not see these changes very often any more.



The illness is treated much earlier these days, usually before any of the classic signs develop and even before blood tests turn positive.

Rheumatoid arthritis starts out with soreness and aching of the joints, stiffness on arising in the morning and other variable symptoms that often make the person think of Lyme disease or other illnesses first.

The most common presentation of rheumatoid arthritis is joint pain slowly becoming worse over a few weeks or months. Then one joint becomes swollen and red, then a few more joints become involved. It is most common in women--nearly three times as common as in men.

Stiffness that lasts an hour or more in the morning is a significant sign, and the activity of the disease can actually be measured by how long this stiffness lasts each morning. It is also common for people to have weight loss, fatigue, weakness and aching muscles.

The joints that are most commonly involved are the wrists, knuckles, first finger joints, knees, shoulders and hips. It does not normally affect the back.

Symptoms can also develop away from the joints, including nodules under the skin, lung disease, inflammation around the heart and a variety of eye problems.

Do not wait for the arthritis to become obvious. Diagnose it early—during the confusing period. You will ben-

to the fifties Ever wished you could ex-

perience what life was like in the 1950s and even earlier?

There's a place in McCreary County where that's quite possible, and it doesn't even require much imagination.

A fixture along US 27 in Whitley City, the Dairy Bar, complete with carhops, is little changed from the business started by the George P. Andersons in 1933.

With its brightly lit neon sign, colorful menu offerings drawn on the windows, and smell of fresh ground beef cooking on the grill, this has been "the place" to hang out for longer than most people can remember.

Despite being damaged by fire on two different occasions, it has risen from the ashes, serving up menu items basically unchanged for over

Ironically, the last fire was in 1966, the same year the establishment's present owner was born.

Mark Sewell and wife Sherry, both McCreary County natives, took over operations just two months ago.

A banker in the county for more than 23 years and pastor of the Lower Hickory Grove Baptist Church for 20, Mark says running the restaurant is a pleasant break from the corporate world.

"I still feel like I'm on vacation," he says, noting he had "grown tired of the corporate mindset and stress."

He credits Sherry with being "the driving force behind this business. She has always had an interest in doing this, and enjoys the atmosphere and waiting on people."

Customers come from near and far, including Somerset,

Lexington, and Knoxville. "We even have one guv who makes the drive up from Oneida, Tennessee, on a regular basis," says Mark.

Prior to buying the business, the Sewells were regulars also, dining at the Dairy Bar as often as three times per week.

Mark began coming to the restaurant as a child and estimates he has eaten "hundreds" of Dixie Whoppers, a doubledecker burger with a special secret sauce "that has been the main menu item forever."

The sauce recipe isn't written down, but has been passed down from owner to owner through the years.

For many years, the business was operated by the Andersons' son and daughterin-law, the late Shoff and Pauline.

Pauline was a stickler for cleanliness, a tradition very much in evidence today with mirror-like floors, a soda fountain so shiny it gleams, and green vinyl-covered booths recently added along

The ultimate goal among amateur inventors when I was growing up was to invent a better mouse trap. The spring loaded, finger breaking harness on top of a flat piece of wood that was tripped when the mouse or rat nuzzled the bait and made the trap spring to crush its body with a mighty copper bar has been the industry standard almost as long as I have been alive.

The problem with these traps is that they are almost as dangerous to the setter as to the vermin for which they are intended. I have at least three broken finger bones and Heaven knows how many blood blisters on the index finger of my left hand all attained from trying to set that little bar on the bait bucket and turn it loose without getting snapped.

Consider yourself a mouse. Would you rather be caught in the cheese there on the bait spring with a single snap of the trap that broke your neck and rendered instant death, or would you rather suffer, glued

hauled out into a field, set loose with glue on all four feet and be chomped on by the next coy-

If I'm a mouse, I'm going for the trap every time. If I'm a mouse and I'm going to be trapped for my nuisance, then get it over with and put my carcass in the garbage.

One night, last winter, I was up late reading and I heard the most pitiful squall— MEOOOOWWWWERRRR and then a pounding WHAP WHAP WHAPPP WHAPP and then an "oh help me God, death is uon me" meow and a rattle from the kitchen.

And then more whap, whap, whap, whaps against the kitchen floor.

Our cat had found a way to open the pantry closet door and stuck her foot into one of Loretta's glue based mouse traps and she was terrified. She had glue halfway up her pointing paw and after I washed if off, she avoids the pantry.

But there is a better mouse trap and that's what I wanted to tell you in the first place.

And, as inventions go, this one is the best to come along in decades.

I purchased four mini trex, spring loaded traps just weeks ago and so far I have not had a miss. You fill the bait bowl with cheese or peanut butter and literally cock them like a pistol and set them wherever mice are prone to feed.

No mashed fingers. Instant death. And ample proof that a new and effective mouse trap has been invented.







Recently, I interviewed Willis A. Mullins of Richmond, Indiana, where he relocated to in 1945 following a tour in the Army. The following is a collection of his memories of Livingston and the surrounding areas. He had been born and raised in Rockcastle County, and lived in the areas of Gauley Branch near Red Hill, Crooked Creek, and Piney Branch. Deller and Floie Allen-Mullins were his parents, who had roots in Virginia. They lived for a time on the Biggie Mullins farm, which belonged to his grandfather, across from the Great Saltpeter Cave. In 1934, they lived on the Charlie Mod farm in Piney Branch.

In 1929, when Willis was nine years old, the family moved to Livingston, where his father worked helping to build the old Old Highway 25. From pictures I've seen taken prior to 1929, the local roads were dry and dusty during droughts, or nothing but pure 490 was being done.

Willis went to school at Livingston in a three-room

heart was once again racing with excitement. Uncle Charles purchased Cokes and popcorn before we went to our seats. I cannot remember exactly what row our seats were on, but it was very close to the floor. I do remember him saying over and over, "You'd better eat your popcorn." But I was just too excited to eat. There was too much to see!

As many recall, this was going to be a very memorable year in UK basketball history. When the team lined up for the "tip-off," All-American center Bill Spivey joined Shelby Linville, Bobby Watson, Frank Ramsey, and Walter Hirsch to round out the five starters. Little did I know at the time, but two members of this team would play important roles in my future.

Years later as I began my teaching tenure at George Rogers Clark High School, I discovered that one of my fellow science teachers, Jimmi Castle, is the son of Wildcat Lindle Castle. We became life-long friends. Also joining the staff at GRC when I first came on board was then-assistant principal Guy Strong, who also was a member of the 1951 team.

While recently discussing Memorial Coliseum with Guy, he shared a humorous anecdote on Coach Rupp's thoughts about the new arena. According to Guy, "When we were playing Auburn, Coach Rupp commented to the Cats: 'These boys have never seen a place this big before – by the time they figure how many bales of hay this place will hold, we'll have a 20 point lead!""

I'm afraid that I have no idea who UK's opponent was on the night that I experienced as a young boy; it was just too long ago. However, it remains one of my most thrilling moments as a sports spectator. Ever the benefactor, Uncle Charles used the evening to teach me, giving instruction about the game, keeping track of which players were the leading scorers. He kept those statistics in his head. By the end of the game, Spivey had over 20 points.

Uncle Charles could not have known, but that game continued to influence me as a teen-ager and as an adult my love of UK basketball had its beginnings that eventful night. All the way back to his house, we discussed the finer points of the game. Neither did we realize, but UK was on its way to a third National Championship title.

Memorial Coliseum became the eventual site of NCAA Basketball Tournament ten times – four as a regional site and six more as sub-regional sites. Overall from 1951 until 1976, UK had a winning margin of 306 wins and only 38 loses in the arena, yielding an unbelievable .890 winning percent-

That year UK won 32 of its games, losing only two. The Cats played in the NCAA Championship on March 27, 1951 in Minneapolis, defeating Kansas State 68-58. In that final game, Bill Spivey scored 22 points, leading the Cats to their third NCAA title.

From that night to this day, I have been a dedicated UK basketball fan. Thankfully, as a grown man I told Uncle Charles just how much I was influenced by his generosity and kindness. (That evening was just the beginning of several excursions together.) For the rest of his life, he and I shared a special bond. And I certainly could not have loved or respected him more. What a splendid gift.

Important facts about extended **First-Time Homebuyer Credit**

If you are in the market for a new home, you may still be able to claim the First-Time Homebuyer Credit. Congress recently passed The Worker, Homeownership and Business Assistance Act Of 2009, extending the First-Time Homebuyer Credit and expanding who qualifies.

Here are the top 10 things the IRS wants you to know about the expanded credit and the qualifications you must meet in order to qualify for

1. You must buy – or enter into a binding contract to buy a principal residence - on or before April 30, 2010.

2. If you enter into a binding contract by April 30, 2010 you must close on the home on or before June 30, 2010.

3. For qualifying purchases in 2010, you will have the option of claiming the credit on either your 2009 or

2010 return. 4. A long-time resident of the same home can now qualify for a reduced credit. You can qualify for the credit if you've lived in the same principal residence for any five-consecutive year period during the eight-year period that ended on the date the new home is purchased and the settlement date is after November 6, 2009.

5. The maximum credit for long-time residents is \$6,500. However, married individuals filing separately are limited to \$3,250.

6. People with higher in-

income limits for homes purchased after November 6, 2009. The full credit is available to taxpayers with modified adjusted gross incomes up to \$125,000, or \$225,000 for joint filers.

7. The IRS will issue a December 2009 revision of Form 5405 to claim this credit. The December 2009 form must be used for homes purchased after November 6. 2009 – whether the credit is claimed for 2008 or for 2009 - and for all home purchases that are claimed on 2009 re-

8. No credit is available if the purchase price of the home exceeds \$800,000.

9. The purchaser must be at least 18 years old on the date of purchase. For a married couple, only one spouse must meet this age require-

10. A dependent is not eligible to claim the credit.

Coal, cross-ties, and logs were shipped on the trains, all very important exports of the area. O. P. Mullins, Willis' brother, delivered freight in Livingston and the nearby vicinity.

There was a dam near the bridge that allowed loggers to float logs down the river, and the logs were pulled out of the river by horses or oxen. The bridge was an old wooden structure built by the county.

There were several private residences in Livingston at the time. There was a population of about 200 or more living within the city limits.

Other than the trains, there was a local bus service that offered transportation to the residents of Livingston. The bus ran to local towns, such as Mount Vernon, London, and Corbin or other towns not far away.

The worst disaster that Willis could remember was the Great Flood of 1937. He could remember seeing furniture floating down the Rockcastle River, and two coal cars full of coal were used to anchor the old wooden bridge in order to

December 7, 2009 is the Deadline to Vote!

The election of agricultural producers to Farm Service Agency (FSA) county committees is important to ALL farmers and ranchers with large or small operations. It is crucial that every eligible producer participate in these elections because FSA county committees are a link between the agricultural community and the U.S. Department of Agriculture (USDA).

Committee members are a critical component of the operations of FSA. They help deliver FSA farm programs at the local level. Farmers and ranchers who serve on committees help with the decisions necessary to administer the programs in their counties. They work to make FSA agricultural programs serve the needs of local producers.

Agricultural producers of legal voting age can vote if they participate or cooperate in any FSA program.

Ballots were mailed to voters of LAA-2 (Southeastern part of the county bound by Hwy 70, Hwy 150 and Hwy 25) by Nov. 6, 2009, and must be returned to the FSA county office or postmarked by Dec. 7, 2009. Eligible voters may contact their local FSA county office before the final date to return ballots if they do not

receive a ballot. FSA announces Livestock Forage Disaster Program

(LFP) On October 2, Secretary Vilsack announced the eligible counties for the LFP Program where producers can receive disaster payments for forage losses due to severe drought. Producers are reminded that LFP sign up for 2008 losses began on September 14, 2009, and ends Dec. 10, 2009, and Jan. 30, 2010, for 2009 losses.

LFP provides payments to eligible livestock producers that have suffered livestock grazing losses due to qualifying drought or fire. For drought, the losses must have occurred on land that is native or improved pastureland with permanent vegetative cover or a crop planted specifically for grazing for covered livestock due to a qualifying drought during the normal grazing period for the specific type of grazing land in the county. For fire, LFP provides payments to eligible livestock producers that have suffered grazing losses on rangeland managed by a federal agency if the eligible livestock producer is prohibited by the federal agency from grazing the normal permitted livestock on the managed rangeland due to





The Lady Rockets jumped out to an early lead and never looked back.










RCMS 6th grader Zach McGuire attempts to go around a North Laurel player on Tuesday night. The 6th grade

A Resolution of Support was passed unanimously by the court on a motion by Carloftis, seconded by Magistrate Jan Stevens.

Craig also told the court that Greer Bros. was the low bidder for blacktopping of the new access road at Business Park South and that the blacktopping was scheduled to begin Tuesday of this week.

In other action, during the special meeting, the court granted a \$2,500 annual pay raise to 911 Director Bonnie Roark, on the recommendation of the 911 board. The increase will bring Roark's salary to around \$30,000 per year.

That item brought a comment from Magistrate Ralph Allen who noted that the Livingston Fire Department recently asked for \$5,000 for new hose but the court only granted \$2,500. "I just want us to be fair to all of them," Allen said.





Economy Tis the season for apple festivals, honey festivals, and numerous other local and regional festivals for both fun and for making local purchases from local growers and producers. Also, farmers markets contribute to the local community in numerous ways; dollars spent locally recirculate locally. Dollars spent with huge chain stores, dollars spent on items imported or from places far away are not helpful to our local economy.

Why make this a landscape issue? Well, first, you may want to grow some of your own food in your landscape. Further, you may have friends or family who farm, and buying their produce that is both fresher and generally cheaper helps them, and again recirculates the dollars locally. Or if you're a service contractor or a merchant, you know the local economy affects your income, and what you can afford. That swimming pool or patio or pond or sunroom may not get to happen if the local economy sours too much. That real estate saleslady may close fewer sales at reduced fees. How many people stop to realize (or look at the labels at the store) to see where the item they're about to buy is coming from? The bottom line I want to draw your attention to in today's column is that when those profits go to foreigners (or even distant American cities), it drags down the livelihoods of almost all the local citizenry.

Growing some yourself, be it from a blueberry bush, a pawpaw tree, or a farm pond stocked with fish is a really sensible activity. Not to mention the exercise and relief from mental stresses we are


bombarded with these days. Even the computer and tv can get us all wound up-back when kids walked to the creek with a pole over their shoulder, we had a much more decent country. And back when families grew all or part of what they ate, they had a greater appreciation for their bounteous blessings. And the local economy afforded kids out of school for the summer a chance to make some spending money picking berries, housing tobacco, hauling in bales of hay, and so forth. Today the local economy is about drug growing or making, and that's a real shame. But, did anyone think or have the foresight to know buying California strawberries, Washington apples, Mexican tomatoes and peppers, or Chilean grapes had anything

to do with that? Helping your neighbor who has a few veggies by the highway for sale, or at a local farmers market, or buying some eggs from a coworker at the office can yield some mighty fine vittles. It can also make our communities more prosperous—and that ain't too shabby for just a little inconvenience.

Not to even mention how much tastier fresh local produce is. And, local apples may have a few bumps and not have any wax to make them shine, but do you really want to know what is on those peels or what the wax is made out of? If it comes from someone you know, you can simply inquire if you have concerns-most farmers are the most honest folks around.

As you see pumpkins, apples, honey and a variety of other local produce for sale, consider stopping and spending some of that grocery money with a neighbor. You'll receive excellent product for a fair price, and you'll feel good about helping keep the local growers and the local economy stimulated.





Rockets returning four starters for 2009-10 season

The Rockcastle County High School boy's varsity basketball team is ranked 9th in the 12th region, but head coach Benny Blanton thinks they can do much better.

Coming off a district championship and returning four starters, Blanton thinks his team can improve on their 13-17 season from a year ago.

"Its not like these kids don't have plenty of varsity experience and I think they all know that it takes teamwork to win," the fifth year head coach said this week.

"This is probably the best team I have had since I took over as head coach," Blanton added

Four of the Rocket's seven seniors on this year's team started as juniors. Those starters were Derek Thacker, Matt Bullens, Jamie Todd and Dustin Reynolds.

Thacker has been ranked the 10th best player in the 12th region by the Courier-Journal.

Blanton said it was very important for the Rockets to finish as the number one seed in the 47th district tournament.

The tournament is being held this season at Casey County, where it can be very difficult to knock off the homestanding Rebels.

"If we are seeded second in the district, we will very likely have to play Casey County before the championship game and they have a pretty good team this year," he said.

But, Blanton's squad has

experience in defeating the host team in the district.

In the first round of the district last season, the Rockets knocked off the Somerset Briarjumpers, before defeating Casey County in the district finals 76-63.

Blanton said that although he has several seniors on this year's team, he also has some young players who should contribute.

"I promise you we will not hesitate to play different players if we think anybody is giving less than one hundred percent - it is just a matter who practices the hardest and puts out the most effort in games. It will be up to our players who is on the court," Blanton said.

The Rockets opened their season on Tuesday night at home against Wayne County. Wayne County defeated them in the first round of the 12th region tournament a year ago.

Blanton expected a tough game. "This may be one of the best teams on our schedule this season," Blanton said.

Results from that game are inside this week's Signal.

On Friday night the Rockets will travel to Lincoln County for another double-header with the Lady Rockets and on Saturday the Rockets will play at Berea College where they will take on Grant County. That game is scheduled for 10 a.m.

Over the Christmas Holidays, the Rockets are scheduled to play in two tourna-



RCHS Lady Rockets ranked 15th in state, third in 12th region

Expectations are always high for the Rockcastle County High School girl's basketball program and this year is no exception.

In last week's Courier-Journal pre-season poll, the Lady Rockets were ranked 15th in the state and third in the 12th region.

Casey County and Lincoln County were both ranked ahead of the Lady Rockets in the state and region.

Last season, the Lady Rebels defeated RCHS in the district finals 62-54 and Lincoln County took down the Lady Rockets second round action of the region, 50-49.

It was the first time that the Lady Rockets had not won the 47th district title since joining the 12th region five years ago.

"Rankings don't mean anything to me - sometimes they're a distraction. What really matters is the way you finish the season in the district and region and we have emphasized to our players that we are going to work harder than ever to do just that - finish," said head coach Chrysti Noble who is in her 20th year as head coach of the girls team.

"Everyone agrees that anything less than another regional title is unacceptable," she added.

The Lady Rockets were 25-7 last year, even though they had a very tough schedule, and this year's schedule is not any easier.

Besides two games with district rival Casey County, and one with Lincoln County on Friday night, the Lady Rockets play Scott County twice. Scott County is considered one of the better teams in girl's basketball in the state.

Other notable opponents include Green County, Shelby County, Louisville Male and Louisville Butler.

Although the Lady Rockets lost seven seniors and three starters from a year ago, the Lady Rockets have a lot of talented players who are returning to this year's squad.

Junior Sara Hammond is quite possibly the most heavily-recruited RCHS athlete ever. Jody Deming, a writer for the Courier-Journal says Hammond, who is 6 foot one inches tall, is a "sensational athlete and might turn out to be the best college prospect in the state in 2011 because of her versatility."

Hammond is ranked as the number one player in the 12th region and second in the state. Some ESPN analysts have said that Hammond may rank as high as the 32nd best player in the nation.

Hammond has already received college scholarship offers from Louisville, Western Kentucky, Vanderbilt, Austin Peay, Indiana State, and Eastern Kentucky.

But, Hammond is not the only division one player on the Lady Rocket team.

Senior Jackie Alexander is ranked the fourth best player in the 12th region and has already committed to play at the West Point Military Acad-
