Mt. Vernon council votes in closed session

Former Mayor to be paid for vacation time

There was very little on the agenda for Monday night's regular meeting of the Mt. Vernon City Council but the main item of business came in a closed session.

During the session, the council went into a closed session to discuss a personnel issue. After the session, the council came back into open session and did not comment on their closed session issue.

On Tuesday, the *Signal* learned from Councilman Don Jones that the session concerned former mayor Clarice Kirby's request for 50 days vacation pay. A portion of that pay, reportedly \$3,000, was approved by the council, on a vote of 4-1.

However, on question to Mayor Gary Cromer on Wednesday, Cromer said that he could not, by law and on the advice of the Kentucky League of Cities, divulge any of the information as to the vacation pay and that the motion would not be a part of the council's regular minutes but would instead be covered by "special minutes" that would not be open to the public but only to councilmembers and the mayor. Cromer also said that if he did make public personnel action, he or any councilmember could be held liable.

An e-mail to Cromer, dated April 19th, from Andrea Shindlebower, legal services analyst for the Kentucky League of Cities, states "The ordinance establishing the compensation for the mayor states that it is \$3000 per month and that they will work 35 hours per week and be in the retirement system and

provide medical insurance. There is nothing about any other benefits." The e-mail went on to say that "it would seem as if vacation time was to be given it would have been included ... this is considered compensation and the mayor cannot be given any compensation outside of what is in that ordinance."

The council originally set the mayor's salary by ordinance in the last year of Mayor Karen King's term in office.

On Wednesday, the *Signal* contacted the Kentucky League of Cities and spoke with Laura Ross, a Legal Services Counselor, which defined one of the reasons for going into closed session concerning personnel was for the discussion of an appointment, disciplinary action or dismissal only. And, she said that discussion of vacation pay for a former mayor would not qualify for a

Judge lifts burning ban

Rockcastle County Judge-Executive Buzz Carloftis announced on Wednesday morning that he had lifted the 24 hour burning ban in Rockcastle County.

Carloftis said he had talked to officials with the U.S. Forestry Service, and because of Tuesday's rainfall in the county, they recommended lifting the ban.

Tuesday, .20 inches of rain was recorded in the county. During the first 21 days of April, only .52 inches of rain has been recorded at the Cox Funeral

School board agrees to sell city property for turn lanes

At last week's meeting of the Rockcastle County School Board, the school board voted to sell 12/100ths of an acre on School Street, in front of Newcomb Avenue to the city of Mt. Vernon, for turn lanes.

Rockcastle County School Superintendent Larry Hammond said the property, which lies next to Snack Shack on Richmond Street, will be appraised to determine its value.

The city has been working on the project for the past couple of years to help traffic congestion at the intersection of School Street, which runs alongside Mt. Vernon Elementary School and Newcomb Av-

enue, which leads to the Rockcastle Regional Hospital.

The Kentucky General Assembly put \$200,000 in their 2009-10 budget for the project at the request of local State Representative Danny Ford. Ford said this week that State Senator Ed Worley has requested another \$100,000 for the project so that it could be completed.

However Worley's request is on hold for now because the state did not pass a budget earlier this month.

Ford said on Wednesday that Worley's request for the funding would likely be funded because of the very worthwhile project, when the Kentucky General Assembly meets again, probably in May.

Gentry runs away from District Court

A Rockcastle County man, who ran from district court last Wednesday, was arrested on Tuesday evening by Rockcastle Sheriff Mike Peters on an arrest warrant for second degree escape and fleeing or evading police second

degree. According to Rockcastle County Attorney Billy Reynolds, Eddie Dean Gentry, 33, of Floyd Street, Mt. Vernon, escaped from custody by fleeing on foot while being detained by a court bailiff

in regard to a felony warrant for forgery, first degree.

Reynolds said the bailiff put Gentry in a jury room across the hall from the district courtroom around 10:30 last Wednesday morning and went into the district courtroom. When the bailiff left the jury room, Gentry fled on foot down the hallway.

Reynolds said the bailiff commanded Gentry to stop but that he continued to run.

Reynolds said Gentry is a convicted felon with convictions for burglary, criminal possession of a forged instrument (12 counts), third degree burglary and theft by unlawful taking under \$300.

Gentry is being held in the Rockcastle Detention Center without bond. He is due back in court on May 3rd.

Lambert Rd. to get needed road repairs

According to County Judge/Executive Buzz Carloftis, work has begun on mapping buried water and utility lines on Lambert Road so that the road can be widened and paved where the county has easements from landowners.

In areas where an easement has not been signed by a landowner, the county will work to improve the road within the bounds of the existing roadway, the Judge said.

Carloftis said Tuesday that about 80% of the easements from property owners on the road had been signed and the county was going to begin work when

Blacksmith's daughter helps hammer out healthcare reform

The daughter of a Kentucky blacksmith played a key role in helping hammer home legislation allowing for passage of the Health Care Reform Bill.

Louise McIntosh Slaughter has served 12 terms as representative of the 28th Congressional District of New York State.

Her position as chair of the House Committee on Rules allowed her to take a leading role in drawing up the Reconciliation Act of 2010.

Last month, she proposed that a House rule be passed to expedite the passage of legislation allowing for health care reform.

Critics called her strategy, which allows the House to deem the Senate version of the bill "already passed" by the House without the House holding a recorded vote on the bill the "Slaughter Solution".

It was an amazing show of force by a woman born 80 years ago in the coal mining town of Lynch, where her father served as blacksmith for a coal mine.

But in a bit of irony, her

actions were forecast in the 1947 edition of Homespun, the Somerset High School yearbook.

In the Class Prophecy, it was noted that pretty senior Louise McIntosh would likely become a press agent due to having "learned in government class how to disagree amiably."

Another irony of Slaughter's life is that her old high school is located next door to the residence of one of the stronger opponents of health care reform, powerful republican congressman Hal Rogers.

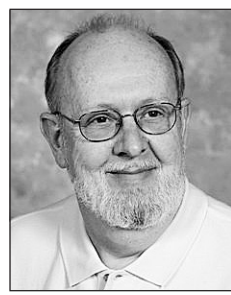
Rogers is a native of Wayne County, the place where Slaughter got her early schooling before the family moved to Somerset just before the start of her senior year.

She went on to study microbiology at the University of Kentucky, and earned a master's degree in public health from UK.

Through her travels as representative of a major chemical manufacturer, she met her husband, Bob, in Texas.

The newlyweds re-located to Fairport, New York where

Rockcastle Memories

Hamm's Drive-In Restaurant

Warm summer evenings, cruising Hamm's Drive-in – the memory of this gathering place for Rockcastle County teenagers lingers in my mind. It was a great place for guys to meet chicks, exchange phone numbers, or to set up dates for the following weekend. Having a smiling carhop bring burgers, fries, and a Coke to your car was also very cool. Hamm's was one of the best places around to hang out and listen to good old rock and roll music.

A few days ago, my good friend Bud Cox and I were discussing the days when we frequented Hamm's while we were teenagers attending Mt. Vernon High School in the early '60's. One of the memories that stands out for both of us was the fine-looking automobiles that could be seen on any given weekend in the parking lot.

Buddy recalled, "Because the parking lot was gravel, you had to look out for mud holes if you had just washed your car." I distinctly remember the parking lot and agreed that finding just the right parking spot was critical. In those days, I washed my black '58 Chevy at least twice a week in order to attract the female persuasion when cruising Hamm's and other teenage attractions in the county.

Bud usually drove his 1960 Plymouth Valiant or a 1955 Ford at that time. I remember helping Bud put black electrical tape on the grill of that Valiant to give it a customized look. The two of us were together a lot during those magical days.

Bud also reminisced about the jukebox inside Hamm's Drive In. "You had to go inside to play the jukebox, but the speakers were outside so you could sit in your car and listen to the music," he said. I cannot begin to count the times that Bud and I drove out US 150 toward Brodhead to visit Hamm's to check out who was there and to sample that fine cuisine known as burgers and fries.

Hamm's was owned by Harris and Ruby Hiatt Hamm, who were also the uncle and aunt of my friend, Jerry Hamm. Jerry was a few years older than me, but we both loved old cars and driving all over Rockcastle County. Jerry was lucky enough to marry one of the cutest cheerleaders that ever attended Mt. Vernon High School. Carol Jean Owens and I were also friends and hung out together when she did not have a date with Jerry.

In those days, most teenagers took their dates to Hamm's on the weekend. One of my memories includes how neat it was to have bench seats in our cars, allowing us to cuddle in the front seat. When the car hop came to take your

order, she only had to visit the driver's window, because the girls were usually sitting next to the boys who were driving. Of course, none of us had air conditioning in our cars, and the windows were always rolled down. Having the windows down also made it possible to hear sounds of the jukebox inside.

Inside Hamm's were tables in case you did not want to dine in your car. There was also a counter with bar stools lining one wall. In addition to the jukebox, there were pinball machines to play (if you did not have a date).

Next door to Hamm's was a building that housed a pool room where guys without dates congregated on Saturday night. As you can imagine, that part of US 150 was very popular with the teens of Rockcastle County, plus it was only approximately three miles from Brodhead and Mt. Vernon. Teens from both high schools gathered at the drive-

This family upon arrival, and in years to come, has come in contact with and have interacted with many other families in the area. The small communities where the Cooks settled are noted as well. It also reflects a portion of daily life in the infancy of

Rockcastle. I have edited where necessary from the original due to length and accounts not being relative to local history.

Memoirs and History of the Cook Family

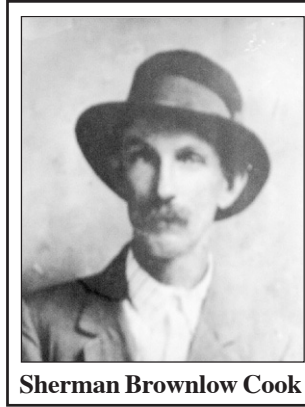

My story of the Cook family begins as far back in time as I have been able to research, and includes my personal memories as well as what my father, Sherman B. Cook, and others have told me.

Beginning with my great-grandfather, William (Bill) Cook, we find him a place called Watauga, in the extreme western part of Tennessee. Watauga is situated on a little river by the same name a tributary of the Holston River which carries the watershed from the Blue Ridge Mountains to the Tennessee River.

Watauga began as a camp at the eastern terminus of the Daniel Boone Trail (the "Wilderness Road"). It was about the year 1820 that my great-

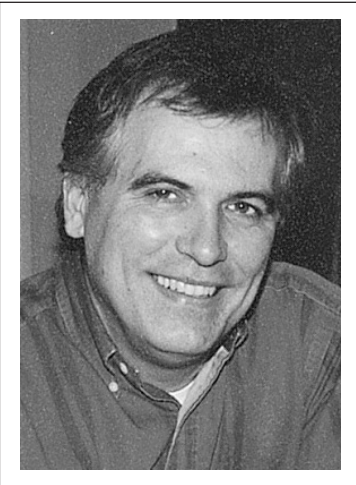

Dust, Mites, and Molds

Presented by Dr. David Bullock

When people find out that they are allergic to a tiny mite that lives off of human cells, they usually say, "Yuck." Unfortunately, mites are the main allergen in the house dust that causes trouble for many people each fall.

The mites do not live on a person's body. They are very tiny organisms which thrive on the skin cells we shed every day. They become most troublesome in the fall of the year for a couple reasons. First, they multiply when it is warm and humid, so summer and fall are when their numbers increase.

Also, starting the furnace and circulating air blows around the dust that has accumulated over the summer months which is full of the mites, as well as molds and other allergens. Their next stop is at our eyes and noses causing the symptoms of allergies.

As with mites, molds also will increase when it is warm and humid, so late summer and fall are common times to have trouble with them, as well. Symptoms from molds are variable and can increase and decrease according to the weather and other factors.

The most important thing to do to control mite allergies is to enclose your mattress and pillow with vinyl covers to separate the mites from your nose and airways during sleep. The bedroom is the most important room in the house to keep clean and dust-free. You spend about a third of your life there.

It is important to vacuum and dust frequently, and try to limit dust-catchers such as carpeting, blinds, curtains, knick-knacks and racks of clothing. Finally, mites and molds can be reduced by air-conditioning which keeps the house cooler and dryer in the summer months.

he had been offered a job, and they became the parents of three daughters.

Early involvement with groups such as Girl Scouts and the League of Women Voters led to election to her county legislature.

Deeper involvement in politics came when she accepted an offer from Mario Cuomo to served as his regional coordinator in the Rochester area. When Cuomo was elected Lt. governor of New York, she remained as his coordinator.

She was elected to the state assembly, serving four years before successfully seeking the Democratic nomination in New York's 30th Congressional District.

She became the first woman to represent the district since 1910.

The political leader made history when she became the first female to chair the influential House Committee on Rules.

As a member of the House Democratic leadership, she also is a member of the prestigious Democratic Steering

and Policy Committee.

She continues to lead the fight against sexual assault in the military, and has been in the forefront of winning historic increases in funding for women's health.

Although she seldom returns to her home state (her last visit to Somerset was some 10 or 12 years ago to attend the funeral of a brother) she still speaks with a strong Kentucky accent and credits lessons learned in life with influencing her actions in the national arena.

She realizes her decisions aren't popular with all, including an individual responsible for throwing a brick through the window of her office in Niagara Falls two days before the health care vote.

In the face of such adversity, she tries to follow advice laid out by her father many years ago in the hills of Kentucky.

She recently told a reporter for her hometown newspaper, the Somerset Commonwealth-Journal, that her father "was known as an honest man and always told us it is easier to keep your integrity than try to get it back."

in restaurant to chat, check out the fine cars, look for girls, and feast on the latest fast food.

After the carhops came to the window to take our orders, they returned in about fifteen minutes with our hot burgers and fries. The food was delivered on a special tray that fit on the door of our cars; the food was wrapped in paper and extremely hot and tasty. There was just something special about the taste of food delivered by a carhop - another marker in my mind of the early '60's. "Those were the days," as Nat King Cole sang through our drive-in speakers. My wife, Kathy, and I love

to visit the Smoky Mountains several times each year, and we have found our own version of a drive-in restaurant in Pigeon Forge, Tennessee. It is called Mel's Drive-In, and we go there as often as we can. Although it does not actually have car service, the food is very 1960's and so is the atmosphere. Hanging on the walls are "golden records" of many of the singers I listened to at Hamm's when I was in high school. One of the best parts of Mel's is the jukebox that belts out a variety of "oldies but goodies" - with a sign hanging nearby proclaiming that if the music is too loud, you are in the wrong place.

Many of the menu items at Mel's are named for celebrities from the '50's and '60's, such as Marilyn Monroe burger or some Chubby Checker fries. Even the waitresses remind me of my Hamm's Drive-in days. They wear tee-shirts like we did, and they are always extremely friendly. The place takes me back to the days when Bud and I were hang-

ing out at Hamm's.

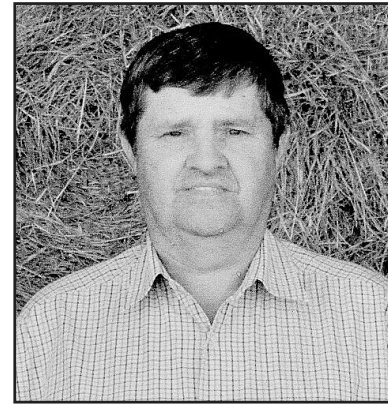

grandfather and his brother, Marcus Cook, came to Watauga. How long they stayed there I have no knowledge. The movement was on, and people were coming to Watauga over trails through the Blue Ridge Mountains and down the Holston River from Virginia. The Cook boys had come from North Carolina; their ancestors had come from Europe in the 1700s. Cumberland Gap was the only known route to reach Kentucky. Pioneers gathered at Watauga and waited until there was a sufficient number to travel together in safety, as the Indians often attacked and massacred small groups. Daniel Boone's family had lived at Watauga while he blazed the Wilderness Trail; his son was killed by the Indians on Wallen Ridge, only a few miles from my grandfather's place.

Great-grandfather Bill Cook had four children whose birth dates I have not been able to find. Their names were: Martha Cook, Tennison Cook, Claiborne Cook (my grandfather), and Susan Cook. Tennison's and Claiborne's lives and families were closely linked. I have no knowledge of them before the year 1850. In or about that year, Tenny married a fifteen year old girl, Emily Whitaker (born Nov. 25, 1835). They secured about 200 acres not far up the creek from Great-grandfather's place. The boundaries of their land extended from the top of Powell Mountain down to and across from Little Sycamore Creek. I understand that the first house they built was a log cabin, which was common to those times. To Tenny and Emily (Whitaker) Cook were born: Margaret Jane (January 25, 1851), William Calvin (September 4, 1855), Susan E. (December 21, 1856), Claiborne C. (July 10, 1858),

Elbert R. (November 21, 1860), and Helen L. (October 4, 1862).

Helen was born after her father left for the war. We all know of the turmoil of the 1850s and '60s. Although Tennessee was a southern state, it was split in loyalty (for or against slavery). The Confederate army was conscripting everyone big enough to carry a gun, and to avoid fighting for the southern cause (the Cooks were against slavery), Tennison and Claiborne enlisted in the First Tennessee Cavalry of the Union army. There, within their division, they were separated-Tenny in the scouts and Claiborne in the supply section (he was supply sergeant).

I understand that the two boys were close-knit, so to speak. Knowing that their chances of returning home were slim, they worried about the future for Tenny's young wife and family. I understand that they discussed the problem and that Tenny asked Claiborne, who was unmarried, to take care of his family if anything happened to him, and if by chance Claiborne returned home after the war. Being a scout, Tenny's chance for survival seemed to them less than Claiborne's.

Later on, Tenny and his troop were captured by the Confederates and taken to the infamous Andersonville Prison in Georgia. Tenny died there of malnutrition, disease, and starvation. There were no official records; information about the time and circumstances of his death came to his family by word of mouth. We learned from history of the terrible hardships endured by the Civil War soldiers, and of the survivors' return home, crippled and sick. Their families also suffered and endured.

Next week, I'll continue with the story of the Cook family during the Civil War era and Claiborne's return home. These events led to the family's migration north by way of the Wilderness Trail, as so many families did, during that era.

On its annual journey northward, the sun had just crossed the equator, and the vernal equinox had just occurred. The days and the nights were about equal in length, and spring was only two days old. It was a good day to be out, and many were taking advantage of the opportunity.

On that special day, it became necessary for me to go to the store to get just one item that we needed. When I arrived at the store, I knew where the item was located, so I started directly to the rear of the store where it was on display. About half way through the store, I passed a display of ordinary plaques that caught my attention. 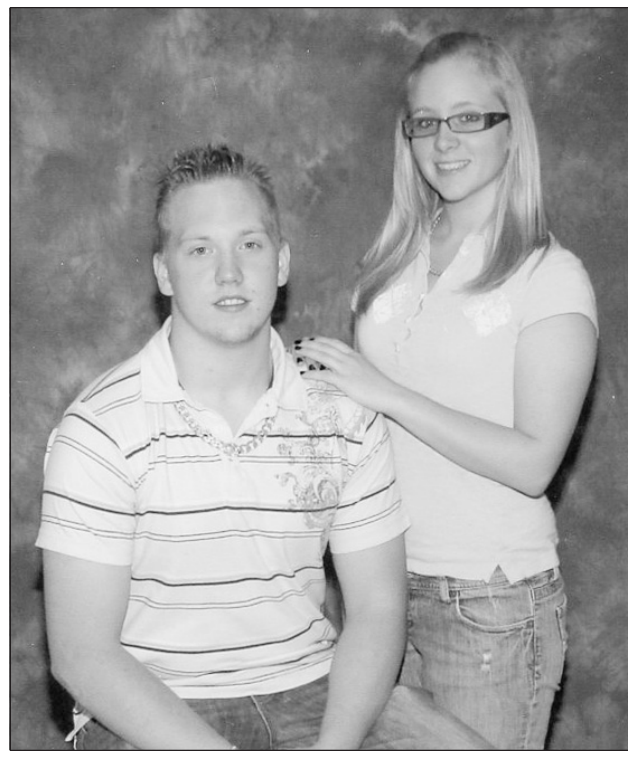

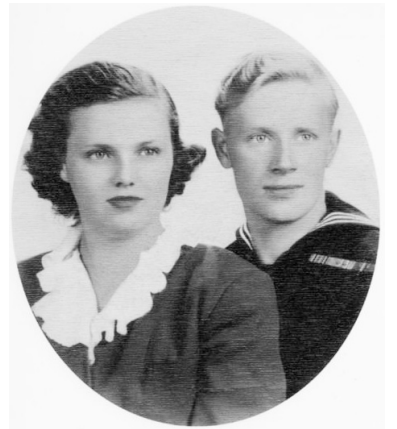

88th Birthday

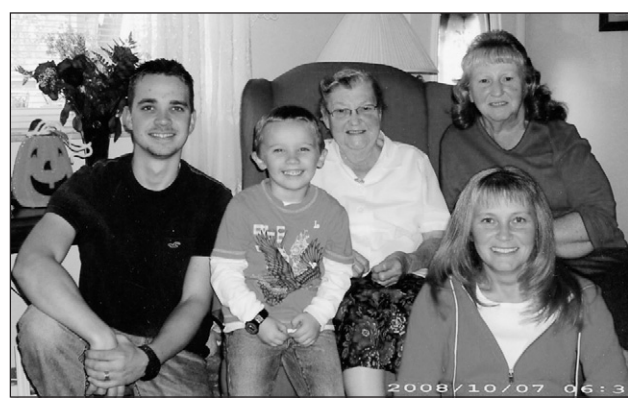

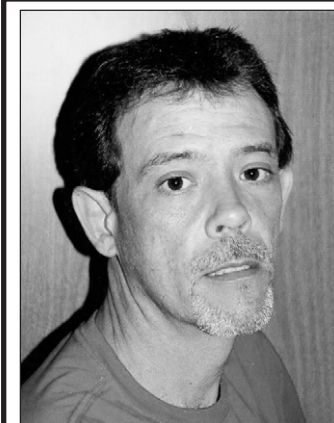

AAH, GO AHEAD AND BREAK KENTUCKY LAWS, IT'S ALL RIGHT!

Did I really read that in last week's Signal?

I think so—Mr. Buzz Carloftis directed the Rockcastle County Fiscal Court in making a VERY questionable decision.

Some people in the county seem to want to regulate citizens' property through "land use and planning" and now the county is permitting the infringement on land owners' rights by ATVs. This may be an unintended consequence, but it will still happen. If the riders would stay where they are allowed, everything would be fine, but often after one or two ATVs goes off trail, others follow. Whether they are on private property does not seem to hinder their progress.

Another problem would seem to be the liability of the county in case someone is killed while riding on the specified county roads. Since the ATV riders often do not abide with the speed limits and are riding for the thrill of it, the danger on these roads is greatly increased for those who live on or near them.

The County Attorney said in his opinion, "the forest service could still write the citations under the 'supremacy law' i.e., that the forest service would have the final say in the matter." So all this legal/illegal commotion will not stop the inconvenience to the ATV riders.

The Kentucky ATV Statistics site states that ATVs are not made for use on roadways, and it is against the law to ride ATVs on Kentucky roadways. The site also states that the only time it is legal to use ATVs on roadways is for agriculture reasons.

ATVs should have a safe place to ride that neither infringes on the rights of property owners nor breaks Kentucky laws by being on open roadways.

Ranked #1 among all three state classes RCHS girls' track team wins invitational

The RCHS girls' track team is ranked #1 in the entire state including Class A, AA, and AAA according to the latest KyTrackXC.com Power Poll released this week. RCHS senior Samantha Smith and freshman Michaela Hunter accounted for 45 points for RCHS in the poll. The rankings are determined by

rankings, seven are Class 3A schools.

RCHS competed in two meets this past week including the Pulaski Southwestern Invitational and the Christian Academy of Louisville Invitational.

The girls' team picked up an easy win at Pulaski Southwestern, winning the twelve team meet by an impressive 38 points over 2nd place Green County. Michaela Hunter claimed the meet MVP award scoring a perfect 40 points in the competition. The 3200-meter relay

team of Laura Dollins, Deana Gabbard, Alyssa Cox, and Rachel Cain began the meet finishing 3rd overall with a season's best time of 11:15.20.

In the 100-meter hurdles, Alyssa Allen placed 1st with a great effort of 18.53 seconds, while Jessica Albright placed a close 2nd with a terrific time of 18.67 seconds.

In the 100-meter dash, Samantha Smith overcame a slight pulled muscle in her thigh that sidelined her at the end of last week and placed 4th overall with a great time of 13.18 seconds. Teammate Bryonna Cromer placed 21st overall in 14.81 seconds.

The 800-meter relay squad of Jessica, Holly Bradley, Tanika Chasteen, and Bryonna placed 8th overall in 2:03.07.

Laura ran an awesome new season's best time in the 1600-meter run finishing 3rd overall with a very impressive time of 5:43.41. Deana also ran a season's best time of 6:00.71 and placed an impressive 6th overall.

The 400-meter relay team of Bryonna, Holly, Alyssa, and Tanika ran a great race and placed 8th overall in 58.64 seconds.

In the 400-meter dash, Michaela Hunter cruised her way to the easy win with an exceptional effort of 1:00.61 seconds. Michaela ranks 1st overall in the state in the event among all three state classes.

Jessica dominated the 300-meter hurdles, easily winning with a sensational season's best effort of 51.59. Alyssa also ran very well finishing

3rd overall in a personal best time of 53.06.

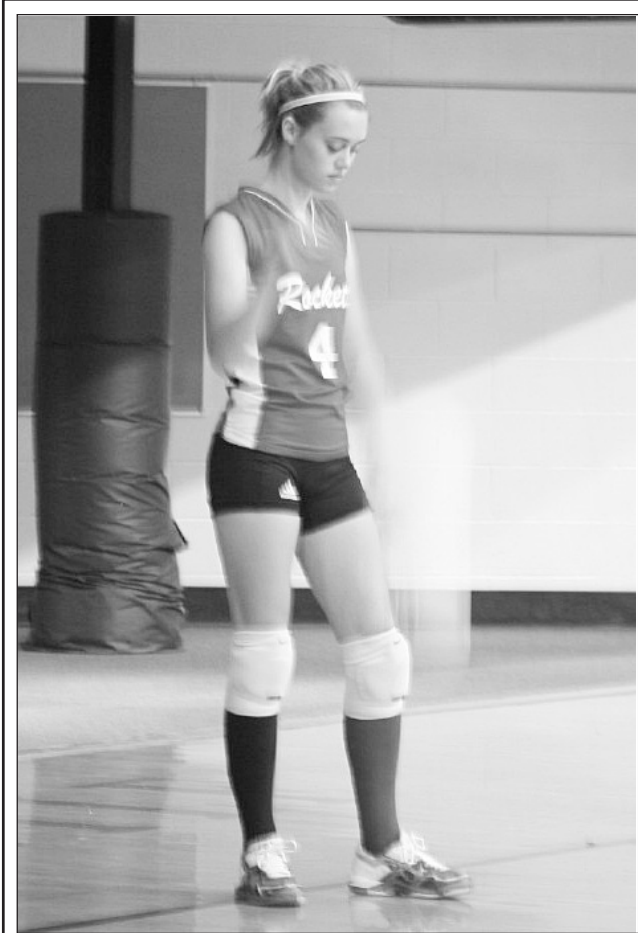
Michaela and Samantha dominated the field in the 200-meter dash. Michaela broke the meet record, as well as the RCHS record in the

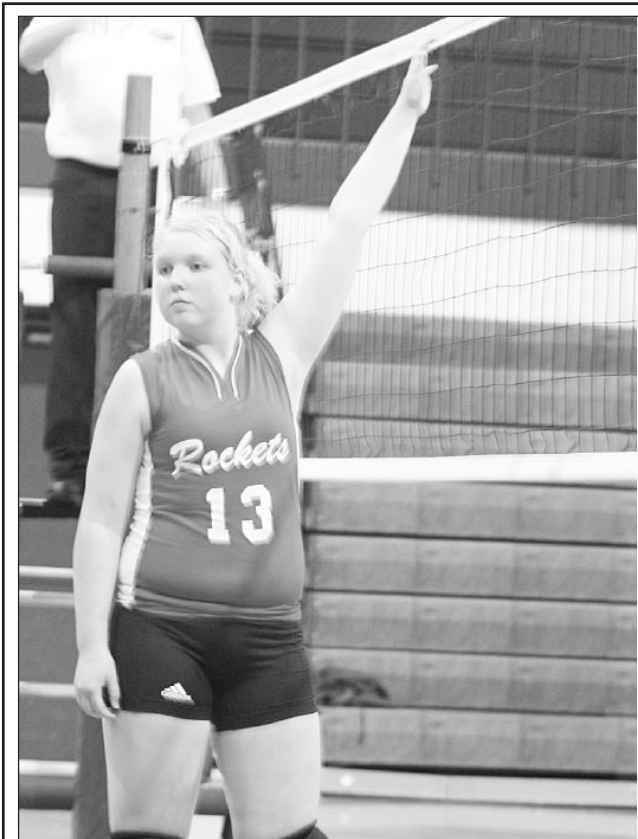
8th grader Lyndsey Abel prepares to serve in action against Casey County Tuesday night.

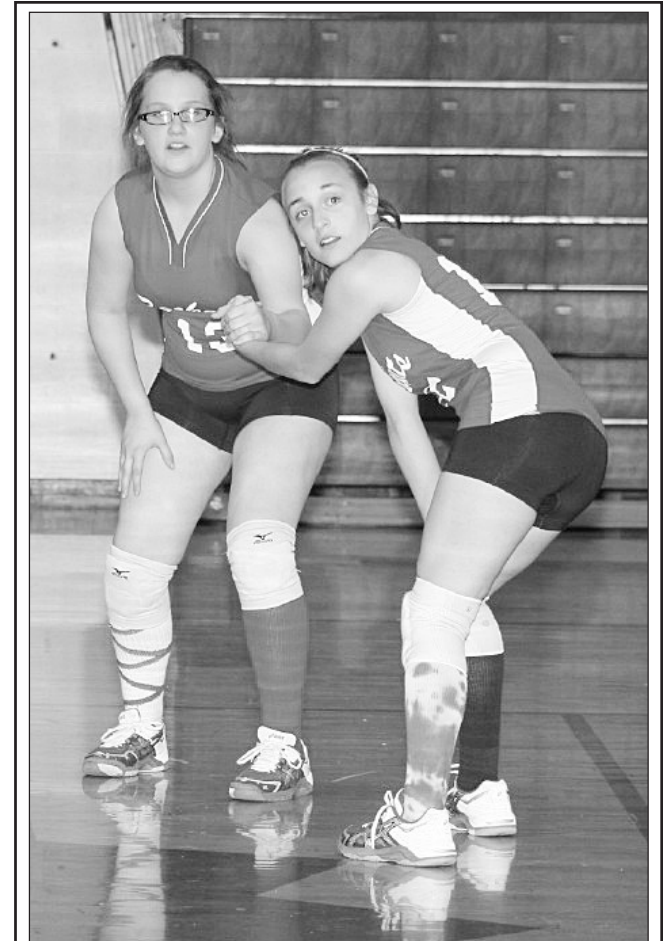
8th grader Cassidy Daugherty covers the net in action against Casey County Tuesday night. The 8th grade lost 2-1.

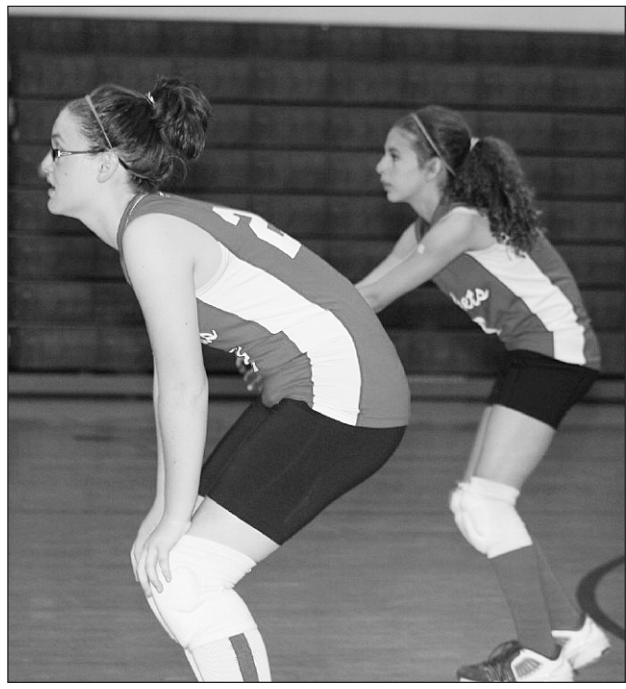

During basic military training, the trainee received instruction in drill and cer-

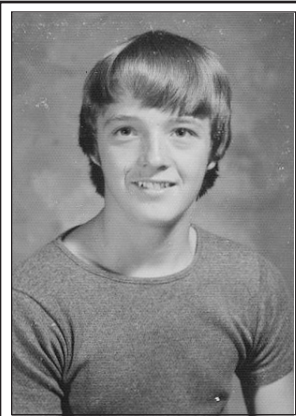
emony, weapons qualification, map reading, tactics, military courtesy, military justice, physical fitness, first aid, and Army doctrine, history, principles and traditions.

Mt. Vernon Mayor Gary R. Cromer said this Wednesday that he worked out the details of the purchase of property from the Rockcastle Regional Hospital at the entrance to Newcomb Avenue and that he was meeting with engineers this week to begin getting the specifications on the project.

Cromer said he hoped that the project could be completed by the beginning of next school year.

the project was approved by the fiscal court.

In order to save thousands of dollars on engineering fees, Carloftis said that, according to the Department of Local Government, he did not have the authority to piece-meal the work out to stay under the \$20,000 limit on projects without taking bids. However, the Judge said he had been told that he did have the authority to declare a state of emergency, thereby eliminating the \$20,000 limit. An emergency can be declared, Carloftis said, where danger to citizens is involved because of the narrow and dangerous roadway. The emergency declaration will also enable more than one contractor to be hired so the work can be done more quickly.

Carloftis can declare the emergency but the court must approve the expenditure of funds for the project.

The project will entail widening the road where needed and where possible by digging down to a solid base, laying a rock bed and then paving and building up the sides of the road.

The county has \$174,000 in funds to be expended on roads in the county and Lambert Road was the first approved by the state for using the money. However the funds cannot be used for new

construction (paving) and the vast majority of the funds for the project will have to come from occupational tax revenue, Carloftis said.

The other two roads approved for the \$174,000 in additional funds were, listed in order, repaving Copper Creek Road and Lower River Road.

closed session. Ross also went on to say that no action could be taken in closed session on any issue.

The Legal Services Counselor said that Mayor Cromer's interpretation of the closed meeting law may have been a misunderstanding on his part.

On Wednesday, Jones, in an e-mail to Mayor Cromer, said that he believed “we, as a council, have erred by going into executive session Monday night.. The error we have committed must be rectified immediately.” Jones asked Cromer in the e-mail to set a special public meeting to rectify our mistake and to inform the public of its business.

However, Cromer said on Wednesday that he could not comply with Jones' request because it would require private personnel action by the council.

In other action, the council voted to pay one-third of the cost of the 2010 Blast Budget, along with the Rockcastle County Fiscal Court and the Mt. Vernon/Rockcastle County Tourist Commission.

The amount of \$10,000 was approved, an amount down from \$12,000 last year.

The council also approved the use of the city's parking lot for a yard sale for Relay for Life.

During the meeting, Police Chief Terry Jackson presented his department's activity report for March. The report also recognized officers Jeff Parker and Brian Maupin for their recent arrest involving the armed robbery and active meth lab uncovered at Days Inn.

Jackson's report detailed: 9 operating motor vehicle under the influence arrests; 8 drug-related arrests; 8 other traffic offenses; 9 other criminal offenses; four arrests for alcohol/public intoxication; 39 warrants served; one speeding ticket; two child restraint violations for a total of 61 arrests made and 76 total citations issued. 184 arrests have been made since January 1st.

The report also said that 15 investigations were opened with 9 of them being cleared by arrests. 10 traffic collisions were also reported with no injuries involved.

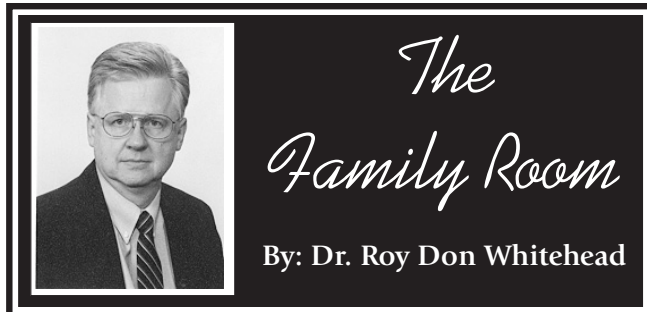
Fire Chief David Bales also reported to the council that 19 fire runs were made (mostly brush fires) during March and 5,000 gallons of water was used.

In his book Dare to Forgive, Edward Hallowell says:

Forgiving someone is at least as beneficial for your health as wearing a seatbelt or taking vitamins or losing weight. Walking around with anger and resentment raises your blood pressure and heart rate. It reduces the potency of your immune system.

If it is so good for us, then why is forgiveness so hard? The answer is partly due to the way we look at forgiveness. We see it as “letting the offender off the hook.” We want him or her to suffer as we have, and we are afraid that forgiving him means being too easy on him. It is ironic that not forgiving is harder on us than it is on the one we refuse to forgive. In actuality we are hurting ourselves by not forgiving.

Someone recently told me, “I won't forgive him until he asks for it.” Most of us would like to see remorse in the person who hurt us. We want him to feel bad and ask us to forgive him. When this does not happen, we believe that “he does not deserve to be forgiven,” so we withhold forgiveness, again hurting ourselves more than the one who has wronged us.

“But I can't forget what she did to me,” another told me. Of course we cannot totally put the incident out of our minds. Luckily, forgetting is not a prerequisite to forgiving. The old saying about “forgiving and forgetting” has confused us. Not forgetting can be very important if it keeps us from placing ourselves in a position where that person can hurt us again. I may forgive someone for swindling me in a business deal, but if I remember what he has done to me, I can avoid business deal-

ings with him in the future.

There is also the mistaken belief that “forgiveness means reestablishing the relationship.” Abusive relationships are an example. When the victim leaves and the abuser says he is sorry, she may choose to forgive, but that does not mean she has to return to the relationship. Returning could be, at best, premature and, at worst, foolish.

What does forgiveness mean? We turn again to Dr. Hallowell:

Most people would say forgiveness means turning the other cheek, or letting the other person get off scot-free. But it means none of these things. For me, forgiveness means re-

nouncing the hold that anger and resentment have over you. Not that you cease to feel anger and resentment, but you don't allow them to rule your life.

Forgiveness liberates the one who forgives! It frees the forgiver from carrying around the baggage of anger and resentment. It frees the forgiver from the pain of feeling that anger over and over again. It frees the forgiver from the control that the anger has over him.

Forgiveness also has particular physical benefits. Why would we deny to ourselves these benefits? Why not work as hard to forgive as we do to lose weight, stop smoking or lower our blood pressure? The benefits of forgiveness can be just as great as the benefits from these.

REGISTRATION & SCREENING

Program Options

There are two programs in Rockcastle County that offer free preschool education services to three and four year old children. The program includes: The Rockcastle County Public School Preschool and Kentucky River Foothills Head Start Preschool.

Rockcastle County Schools offers these services through a blended Early Childhood Program that meets both state and federal guidelines.

What to Bring for Registration

Please bring your child's state birth certificate, social security card, immunization certificate, proof of income and proof of medical coverage (i.e. medical card or insurance card) to register. Call your school with any questions and to make an appointment to register your child.

Health Requirements

The following health requirements must be met in order to enroll in the early childhood program and kindergarten.

- Physical exam
- Blood pressure and lead screening (early childhood only)
- Dental exam
- Vision exam
- Immunizations

Eligibility

To be eligible for Head Start, your child must be 3 or 4 years old by October 1st and meet one of the following requirements:

1. Meet Federal Income Guidelines
2. Have a disability
3. Be eligible for Public Assistance (SSI, K-TAP, Child Care Subsidy)
4. Meet guidelines for being considered a homeless family
5. Reside in a foster home

To be eligible for Rockcastle County Public Preschool, your child must be 4 years old by October 1st and meet one of the following requirements:

1. Be eligible for Free Lunch
2. Have a disability
3. Three year olds may be eligible with an identified disability
4. Non-qualifying 4 year olds may attend the Early Childhood program as space allows

What is a disability?

A delay in one or more of the following areas is considered a disability:

1. Speech and language
2. Large and fine motor
3. Cognitive skills
4. Social and emotional
5. Self-help skills
