## Fiscal Court opens roof bids; reaffirms actions in called meetings

Bids were opened for a new roof for the Livingston School gymnasium roof and for work on Lambert Road for one mile.

The low bid of \$14,316.75 from Newcomb Construction of Mt. Vernon was accepted for installation of the gym roof and Carpenter's Custom Bulldozing was the low bidder for grade and drain work, shoulder repair, etc. on Lambert Road at \$45,900. There were only two bids received on each project with Keith Bullock Construction of Orlando submitting a \$27,720 bid on the gym roof project and Goff Excavating a bid of \$105,200 for the Lambert Road project.

The court awarded Newcomb Construction the bid for the Livingston School gym roof installation and the total project cost will be around \$33,000 for materials and installation. The court received a \$20,000 insurance settlement for damages to the roof and will have to pay the \$13,000 from county funds.

The court did not award the Lambert Road project. That bid is contingent on having all easements along the one mile stretch signed

and, to date, the court lacks easements from nine property owners along the road.

Mrs. Mamie Gregory, a resident of Lambert Road, was at the meeting to find out the status of the project and to tell the court that she had been told that Wesley and Dorothy Williams did not own the property that is primarily holding up the one mile stretch project. Mrs. Gregory said that Tommy Cope was the landowner of the strip needed. County Attorney Billy Reynolds is currently in the process of searching titles to the property needed for easements along the road, and Mrs. Gregory's information was referred to him by the court. Condemnation suits will be filed when all necessary preparatory work is completed, Reynolds said.

During the meeting, the court also heard a request from Rick Branham, Captain of the Brodhead Fire Department. Branham told the court that the department was in dire need of a new rescue vehicle to replace their 1992 vehicle, which was obtained from the Lexington Fire Department and which has become unreliable for service.

Branham told the court that the cost of a new vehicle would be \$100,000 and the fire department could finance \$60,000, through the Kentucky Fire Commission, to be repaid from part of their yearly allotment of \$8,500 from state aid. The captain pointed out to the court that Brodhead's fire protection area encompasses 60-65 square miles and provides primary rescue for that area in addition to

"This means the fiscal court was able to make appropriate expenditures to

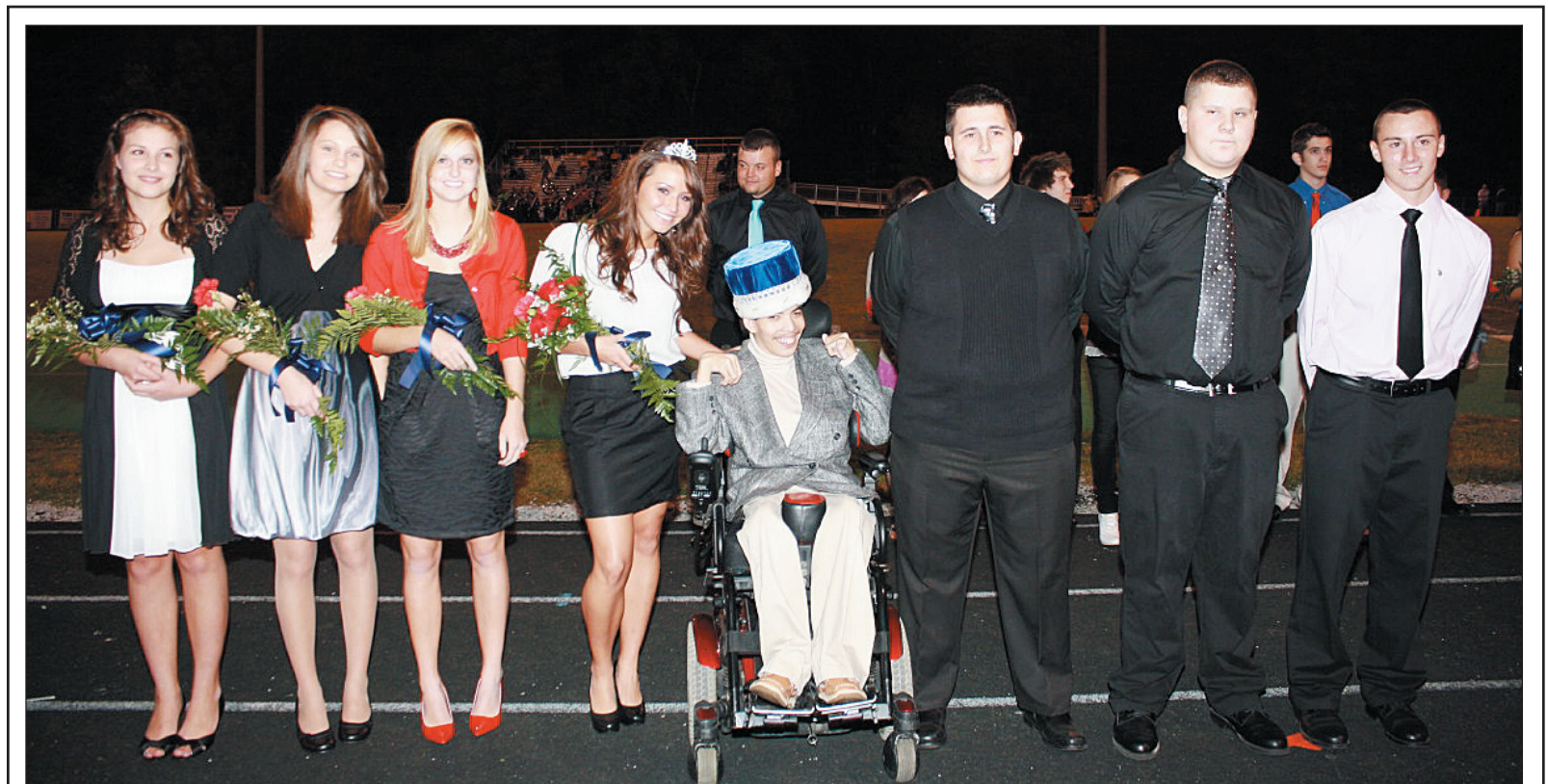

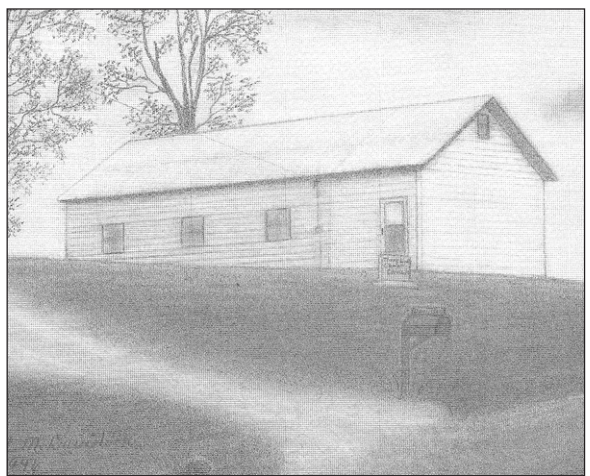
Three Links: One of Rockcastle's Oldest Communities

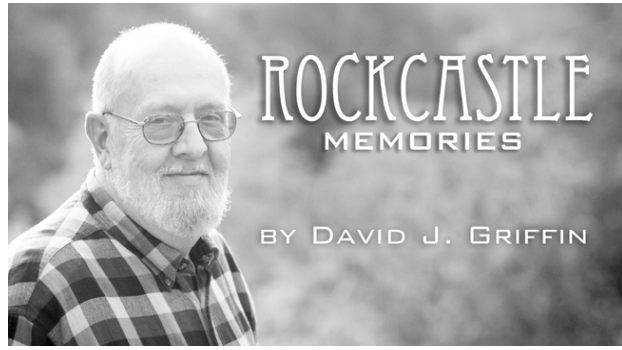
original Wilderness Road winds its way through the mountains.

### Reuniting with the Great Blue Heron

Last week my wife and I made our annual trek to the northeastern shores of Virginia in pursuit of sand, sun, and the Atlantic Ocean. For the past six years we have visited our favorite spot on the Atlantic coast, lodged at the Hampton Inn on famous Chincoteague Island. We always find the service and hospitality of their staff to be quite above par. Tom Derrickson, general manager of hotel, again greeted us with his smile and friendly demeanor: "When I came to work this morning, I noticed that black Tahoe with the MTNMAN license plate. Good to have you back with us again. Let me know if you need anything."

This trip always provides me with the opportunity to view a wide array of shore birds—but my thrills come from watching the Great Blue Herons. They are abundant and can be seen every day. But first, a backdrop.

This area that we find so perfect for us consists of two islands situated next to each other and surrounded by the salty waters of the Atlantic Ocean. Chincoteague Island is positioned near the mainland and is home to several quaint shops, the finest seafood restaurants, and several nice hotels and bed-and-breakfast homes.

Assateague Island serves as a barrier island to Chincoteague and has been designated as a National Wildlife Refuge. It is home to a herd of wild horses, which have been there for over 300 years. It is also a favorite stop-over for countless shore birds that thrive on the fish located in both fresh water and salty sea water. It would take a very long list to name all the different wildlife that can be viewed on Assateague; it is quite remarkable.

Because of an extreme tropical storm that was passing up the coast of North America, our first few days were cloudy—but the rain held off until late night. We spent a lot of time driving around the island watching the numerous birds feeding near the narrow highway winding through Assateague Island. One afternoon we ventured onto the beach, where the wind was almost biting cold—but the view of the rough sea with its tall, breaking waves was really worth it. We then decided to go looking for one of our fa-

vorite shorebirds, the Great Blue Heron.

The heron is a very large shore bird with a wingspan of up to 79 inches. It feeds on small fish, shrimp, crabs, insects, rodents, reptiles, and small birds. This large bird is usually found wading near the shore watching for small fish in the water.



If you are not familiar with the species, it might seem that the bird is asleep since it stands motionless for long periods of time, waiting for just the right opportunity to catch whatever it is after. If you are patient, you will see its head dip into the water and arise with a small fish in its mouth, which we have observed on several occasions.

One cool, sunny afternoon I decided to attempt to photograph one of these stately birds so I grabbed my digital camera and walked near a small inlet where I had witnessed them before. As I slowly strolled by the water, I came upon one of the largest herons I had ever witnessed. He did not seem to notice me, and I followed him for sometime. All at once the Great Blue took flight, and I was able to capture the image of him leaving the surface of the water. The incident reminded me of the first heron that I ever saw in the wild.

When I was about 10 years old, my best friend was Kenneth Hansel, who lived just across the road from my grandparents' home in the Pine Grove sec-

Five different places we lived during those two decades and all of them have graves and tombstones of lost pets. We even had a funeral for a chicken when we lived on Harmon's Lick.

It's a long story but let me tell you for sure that you have not lived and felt true guilt and ultimate sorrow until I you have accidentally killed a chicken and then knelt and prayed with your son over a bantam rooster's grave. That was over 25 years ago and I still cry when I think about it.

So, anyway, some several months ago in the wee hours of the morning, Loretta and I were awakened by a very shrill barking dog on our front porch. A dog we didn't know was out there and sounded like he had taken possession and was protecting the place. Our regular old Lab went "woof, woof" a couple of

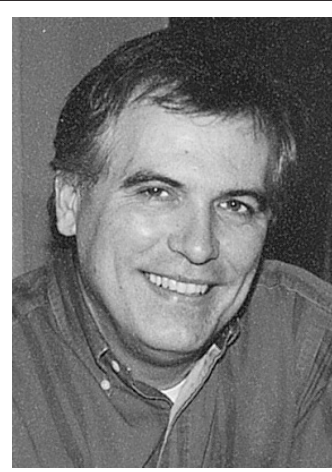

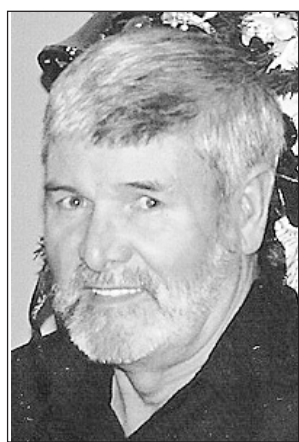

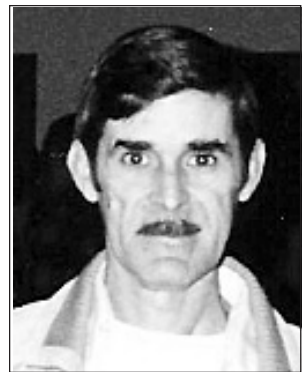

During my first terms as Mayor, there was no payroll or restaurant tax and the position of Mayor was part time and paid a salary of \$50 per month.  
During my 1 1/2 years, the city's budgets were balanced and the audits were always clean.  
Through cooperation with various funding agencies, state and federal grants and low interest loans, the city's operations were maintained and modest growth was accomplished. Maintaining a good working relationship with all state and local agencies is a must to secure improvements for the city and this was accomplished during my service to this community.

**Following is a partial list of my accomplishments:**

- 1) Required all police officers to attend and pass the police academy at Eastern Kentucky University and updated police department equipment to state-of-the-art technology.

- 4) Added left turning lane on Main Street and on School Street to Richmond Street.
- 5) Prohibited parking on Richmond Street and added center turning lane.

- 8) Continuing education required for all necessary department heads.
- 9) Established retirement system for employees.
- 10) Purchased vehicles, tractors and other equipment with grants and low interest loans.
- 11) Renovated City Hall and expanded fire department space at City Hall.
- 12) Built new park on former Thrifty Lumber Co. property.
- 13) Purchased lot between Cox Law office and railroad and between courthouse and former Sears building.

county can trace our heritage to various communities in Rockcastle.

For the next few weeks, the Roots series will focus on the little community of Three Links. To begin the introduction is a piece of writing about the community by Mable Davidson from September 21, 1994.

Where In the World Is Three Links?

If you have ever lived in Three Links, Kentucky, the term, "Where in the world is Three Links", may sound familiar. Three Links is a small community located on the Jackson and Rockcastle county line in the beautiful foot hills of Eastern Kentucky where the sun rises early and the last of the magnificent sunsets can be seen until the shadows of night creep in to hide them from view.

The post office was named about 1918 for the Odd Fellows Lodge #354 that was located where the church now stands. Their official symbol was three links of a chain in each link was a word which was said to have been Friendship, Love, and Trust. (Correction note added August 2007. After doing more extensive research on the words that were in the three links of chain that was the official symbol of the Odd Fellows Lodge, I found that the words were Friendship, Love and Trust.) The old building was a two story multiple purpose structure. The Sycamore (Three Links) Christian Church occupied the first floor, and was also used as a school during the week. The Odd Fellows Lodge occupied the second floor.

The majority of the people who live here are direct descendants of people who lived here before the Civil War days. Many of our ancestors lost their lives fighting for our freedom. There have been good times and hard times; joyful times and times of sadness and heartache, but though it all, the Good Lord has blessed. People in almost all professions have emerged from this tiny community in the hills of Kentucky-people who take pride in their work and work very hard to reach the goals they have set.

Being located in the "far side" of both counties with the road as the dividing county line, for many years it seemed that all the county money got used up for roads and other modern conveniences such as electricity, telephones, and etc., before it reached Three Links. But the folks here did not sit idle and complain of their lot. In 1946, they decided that they would have a road, so they band together and raised \$2,800 among themselves to hire a bulldozer and two men. With the help of the bulldozer and men that were hired, they constructed a graveled road where once was a wagon road. We are talking about the mid-forties when times were hard and money was scarce that these people reached into their pockets and gave a portion of their meager supply of

money to improve their community. The men worked with the road crew, the ladies cooked food for the crew and put it into buckets and the children carried the buckets of food a mile-two miles-or until they caught up with the crew to give them their dinner. This was not the end of the work and road problems, but the beginning of a better road that, bit by bit, was eventually black topped. The last bit of black topping was finished in 1991.

Approximately twenty miles from McKee and seventeen miles from Mt. Vernon, it seems that everything took a little more effort here than in most parts of the counties. In 1947 the electricity came after many years of waiting and many trips to McKee. Needless to say, there was much excitement in Three Links the day the "lights were turned on"—a day we will never forget!

Education has always been important to folks in Three Links. Many children walked up to five miles and more each day to attend one room elementary schools. And in spite of the weather, flooding creeks, snakes and hornets that were encountered along the way, there were ways to have a little fun to make the walk enjoyable.

Prior to 1950 children had to leave home and stay at boarding schools or with relatives to attend high school. However, there were few exceptions in the mid to late forties when some children left home as early as 4:30 AM and walked or rode a mule to Climax to meet the school bus that went to Mt. Vernon High School. After years of waiting and much persuasion by parents, a school bus was sent to Three Links for the first time in 1950.

All the work that was done to this point was complicated by the fact that there was no telephone service in this area. The people had tried unsuccessfully for many years to get telephone service from Rockcastle County. It wasn't until 1957 that Peoples Rural Telephone Company in Jackson County came to our rescue. Telephone service was made available to all residents in Three Links even though many lived on the Rockcastle County side of the road. We will be forever grateful to the folks at Peoples Rural Telephone Company, REA (RECC) and all who had any part in making our community a better place to live.

Even though the Three Links Post Office was closed 2/28/1957, the community remains alive and well. If you go for a scenic drive and happen to end up in this area, you will be greeted by a "WELCOME TO THREE LINKS" sign constructed with contributions from present and former residents. The sign was completed 9/20/1994, at a cost of \$1,050.00.

At the present time two more projects are nearing completion in this tiny community on the "far side" of Jackson and Rockcastle Counties. City Water will soon be running from our faucets and a new Church building is almost ready for dedication. Yes—the Good

Lord has blessed and we thank Him for it!

Three Links is different things to different people-To most folks it is a place they have never heard of; To some folks it is "the middle of nowhere"; To some it is the "Boonies"; To many politicians it is a place where very few votes are counted on election day; To our ancestors it is a place that was working to improve and keep alive; To God it is His creation with people who are just as important to Him as those living in the most prominent places in the world; But to most of us who have roots here and many of those who have transplanted here from other communities it is "HOME"!

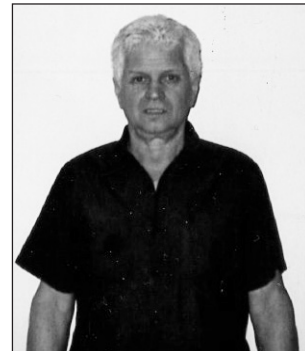
We never heard a bark on Sunday night. Tired dogs go to sleep.

# Battling for Camp Wildcat again this weekend, Oct. 15-17

Blue-clad Infantry soldiers standing side by side in formation lift their rifled muskets to their shoulders. A commander yells "Fire!" Puffs of smoke drift up from the rifle barrels. Across the pasture along side the Little Rockcastle River, scores of gray and butternut soldiers fall to the ground, while their fellow soldiers return fire. Along the flanks of the infantry formations, cavalry troopers ride back and forth, probing for weakness in the enemy formations. Meanwhile at the rear, cannons belch fire. The echoes can be heard for miles around this pastoral farmland.

The brave boys in blue and gray will clash at the foot of Wildcat Mountain this Friday, Saturday and Sunday [Oct 15th-17th], reenacting the 1861 Civil War Battle of Camp Wildcat that helped secure Kentucky for the Union.

Camp Wildcat has estab-

lished a strong tradition as one of the best Living History Events in Kentucky in recent years as evident from the numbers of reenactors and spectators that attend the annual event. "This event just gets bigger and better each year," stated Jim Lawless, a Union reenactor from Indianapolis. Long time Confederate reenactor Les Williamson, from Corbin, stated, "Maybe we can whup them Yankees this year and drive them out of Kentucky."

This is a fun event for the whole family that is very educational and free. So come on down to the Camp Wildcat Reenactment. Camp Wildcat is located on the Laurel and Rockcastle border just below Livingston on U.S. 25 South Wilderness Road.

## 1,000 attend Horse Whisperer event held at Fairgrounds

Approximately 1,000 people gathered at the Brodhead Fairgrounds in Rockcastle County September 23 to watch Paul Daily train a six-year-old horse that had never been ridden. Twelve people accepted Christ and at least 20 dedicated their lives after the demonstration sponsored by the Rockcastle Baptist Association.

A horse trainer and founder of the Wild Horse Ministries, Daily has held the demonstrations since 1997 to explain the "Round Pen of Life." As he trains horses, he points out similarities between man's relationship with God and a horse's relationship with his trainer. Last year, he held 147 demonstrations in 23 states for 30,000 people.

Daily began holding the demonstrations after God spoke to him one day while he was training a horse. "Do you see what this horse is doing?" God asked. "Running," he answered. "That's what you're doing—running from me." "What is your purpose with this horse?" God asked. "I want to train him and make something valuable." "That's what I want to do with you." God's message was so powerful, Daily accepted Christ. His first demonstration was for a Sunday School class at his home near Jena, Louisiana. For

the next three years, he presented his training techniques to almost 15,000 people in Louisiana and Texas. Then, he quit his job after working twenty-plus years in the Louisiana oil fields. In 2000, he and his wife, Joana, began traveling the country to present demonstrations. Their children, Lenora and Dan, traveled with them and were homeschooled during their high school years.

Daily is not a licensed preacher, yet he and Joana have traveled more than 500,000 miles to share the demonstrations at fairs, rodeos, festivals, prisons and nursing homes. His techniques in training horses have earned him the label, "Horse Whisperer." The horses he uses are completely untrained and are provided by people in the area.

He explains he does not break horses, but "gentles them" with words and pats until they let him bridle, saddle and ride them—all within two hours. "During the training, the horse is exposed to all kinds of new things like ropes, blankets and saddles to help him learn to cope and work things out," he said. "God prepares us for our tomorrows by helping us through our trials and troubles today."

As Daily trains the horses, his black lab, Who, darts in and out of the round


pen. "We call him Satan," he said, "because he runs around, barking and nipping at the horses—exactly how the devil tries to distract us." Daily said that about 95% of the time, after the horse has been bridled, saddled and ridden, he totally submits by lying down during the demonstration. "As the horse submits to the trainer, people must submit to God," he said. "We must release all—our life of sin—and accept God as our guiding hand and take God's free gift of eternal life with Him."

Admission to the demonstrations is free, yet last year Wild Horse Ministries gave away \$18,000 worth of Bibles and spent over \$33,000 for diesel fuel. "God provides for us through donation buckets, free-will offerings and t-shirt and cap sales," Daily said. "I'd rather have your prayers than anything."

"This event was so successful because of the 21 Days of Prayer for Spiritual Awakening in August," said Bro. Randy McPheron, Director of Missions for the Rockcastle Co. Baptist Assn. "I was proud of how our churches worked together to bring this demonstration to our people. This was the greatest illustration of the gospel I have witnessed during my ministry."

## What are "Superfoods"

Family and Consumer Sciences

"Superfoods" is a word you hear often in the media. These are foods that go beyond meeting basic nutritional needs, such as calories or vitamins or proteins, to help protect us from the risk of many chronic diseases. Many of these superfoods are grown in Kentucky including nuts, blueberries, broccoli, spinach, tomatoes and whole grains.

Nuts, such as black walnuts, have a concentration of omega-3s. A quarter-cup

provides 90.8 percent of the daily value for these essential fats. Black walnuts have many potential health benefits ranging from cardiovascular protection to the promotion of better cognitive function to anti-inflammatory benefits helpful in asthma, rheumatoid arthritis and inflammatory skin diseases such as eczema and psoriasis. In addition, walnuts contain an antioxidant compound called ellagic acid that supports the immune system and appears to

have several anticancer properties.

Blueberries with their rich vibrant color are antioxidant rich and may help prevent age-related diseases, including Alzheimer's and some forms of cancer. They also contain fiber and vitamin C. Broccoli contains sulforaphane, a cancer-preventive phytochemical shown to reduce cancer in laboratory and animal studies.

Dark green spinach has a high lutein content. Studies show that this antioxidant protects against eye diseases, such as age-related macular degeneration and cataracts. You can think of this as sort of sunglasses for

your retinas.

The same pigment that gives tomatoes their appealing color also appears to help lower the risk of certain types of cancer, especially prostate, lung and stomach. The nutrient is called lycopene. Many Kentuckians grow tomatoes in their own yard and enjoy their flavor right off the vine. They can also be grown hydroponically all winter.

Whole grains—which include wheat, corn, oats, barley, quinoa, sorghum, spelt and rye—are also good for weight management because they help stave off hunger. In countless studies,

## National Pharmacy Week is Oct. 17-23 Pharmacists help make your medications work

Medicine can save your life—but it can also hurt you if it is not taken the right way. During your stay at Rockcastle Regional Hospital and Respiratory Care Center, the pharmacy staff is here to make sure that your medications are safe and effective.

Pharmacists are experts on the thousands of medications available today, how each one works in the body, and the best ways to use them so that you will feel better. Pharmacists work with doctors and nurses to find the medication that treats your specific condition. They help keep you safe from harmful drug interactions, reactions, or mistakes.

The hospital's pharmacists are also available to talk to you about your medications. They can help you understand why your medicines were prescribed and what they are supposed to do. They will also let you know if your medicine causes problems like sleepiness or a dry throat. The pharmacists can also help you take your medicines safely at home. You can ask your pharmacist how to

store and take your medication, what foods or activities to stay away from, and what to do if you forget to take your medicine.

Here are some tips from the pharmacy department on safe medication use while you are in the hospital:

- Bring a list of all the medicines you take, including medicines prescribed by your doctor, medicines you purchased at a drug or grocery store like pain relievers or cold medicine, vitamins, and herbal and nutritional supplements.

- Tell your doctor or nurse about any medicines you aren't supposed to take and why.

- When you check in to the hospital, ask how to contact the on-site pharmacist.

- Ask the names of the medicines you are receiving while in the hospital.

- Ask if there are any foods, drinks, other medicines, or activities that you should stay away from, such as driving, while taking the medicine.

- Ask about anything that the medicine might cause, like sleepiness, an upset stomach, or a dry throat.

- Keep any written infor-

mation you are given about the medicine.

- Ask questions about anything that you don't understand or that doesn't seem right.

- Watch out for unexpected changes in your medicines, such as a change in color or shape.

- Ask a friend or relative to help you follow these suggestions if you need help.

If you have any questions about your medicines while you are in the hospital, ask to speak with the pharmacist.

they have been associated with reducing the risk of heart disease and cancer and reducing blood glucose levels, which contributes to diabetes.

In general, people who are looking to change their diets should make small changes and make them gradually.

Nuts, for example, in general are high in calories, so moderation is the key. The best goal is to reap the health benefits of eating walnuts but not add excessive calories to your daily intake. Instead of just adding walnuts to your current diet, eat them in replacement of foods that are high in saturated fats, such as cheese or meat. Even though walnuts have health benefits, you still need to limit your intake to the recommended 1.5 ounces per day or about 20 walnut halves.

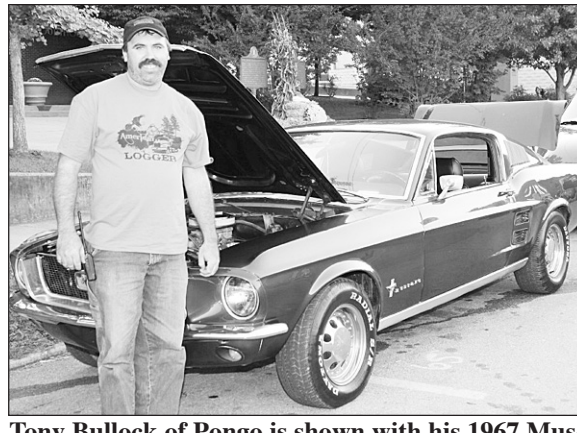

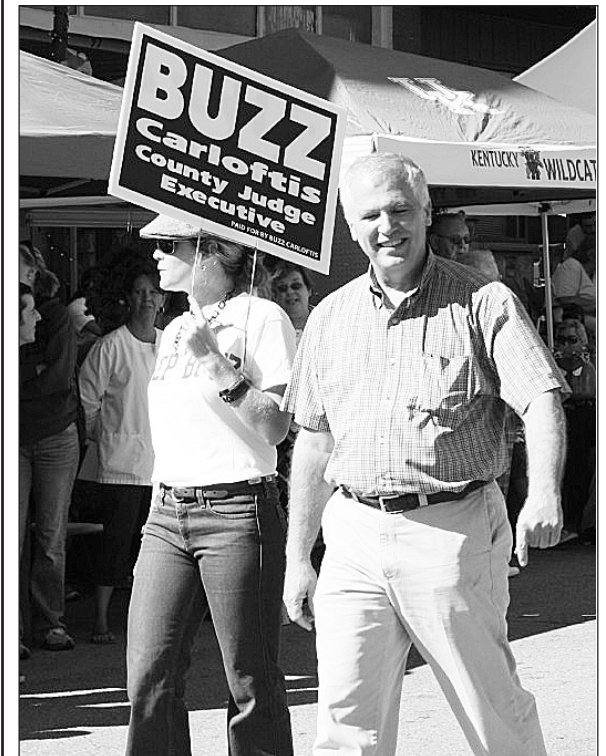

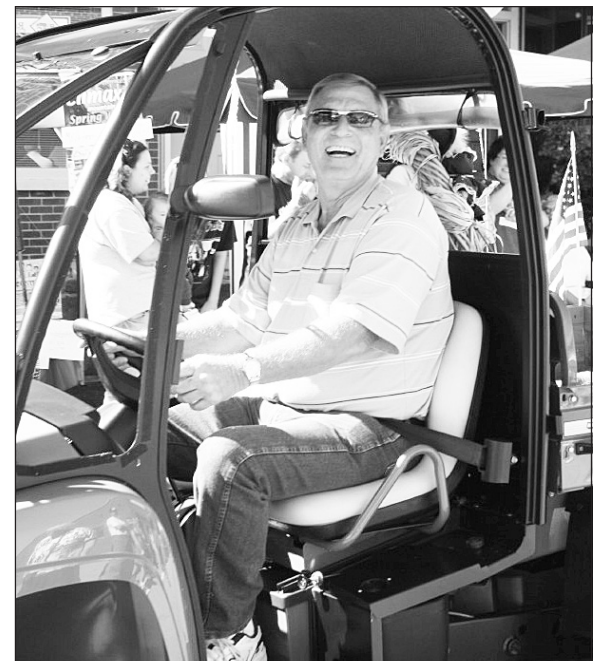

## NRCS extends sign-up to Jan. 7, 2011 for CSP

Natural Resources Conservation Service (NRCS) Chief Dave White today announced the ranking period cut-off date for producer applications in NRCS's Conservation Stewardship Program (CSP) has been extended to January 7, 2011.

"We're extending the deadline for applications to CSP to provide agricultural producers more time to complete their applications," said White. "This will help farmers, ranchers, and forestry producers by giving them more time and hopefully allow even more producers to participate in this program."

CSP is offered in all 50 states, District of Columbia, and the Pacific and Caribbean areas through continuous sign-ups with announced cut-off dates for ranking periods. The program provides many conservation benefits including improvement of water and soil quality, wildlife habitat enhancement and adoption of conservation activities that address the effects of climate change.

All producers are encouraged to apply for CSP. The program, authorized in the 2008 Farm Bill, offers payments to producers who maintain a high level of conservation on their land and who agree to adopt higher levels of stewardship. Eligible lands include cropland, pastureland,

rangeland and non-industrial forestland.

A CSP self-screening checklist is available to help producers determine if CSP is suitable for their operation. Mrs. Burdett has brought to her classroom an exciting hands on learning experience by using 'teaching trunks.'

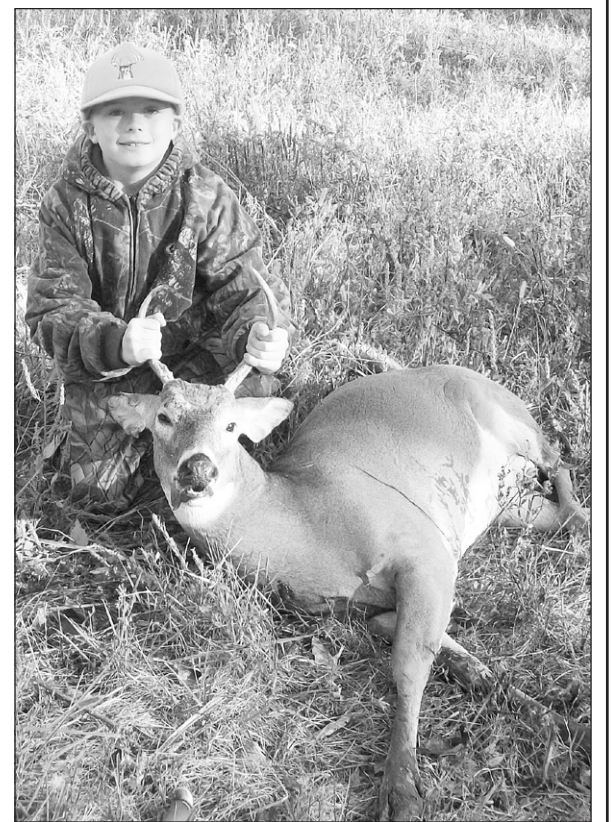
Through the use of teaching trunks students have several trunks to explore throughout the year that relate to social studies themes being taught in the classroom.

Mrs. Burdett was able to compile the trunks through a Federal Grant obtained by the Harlan County School System.

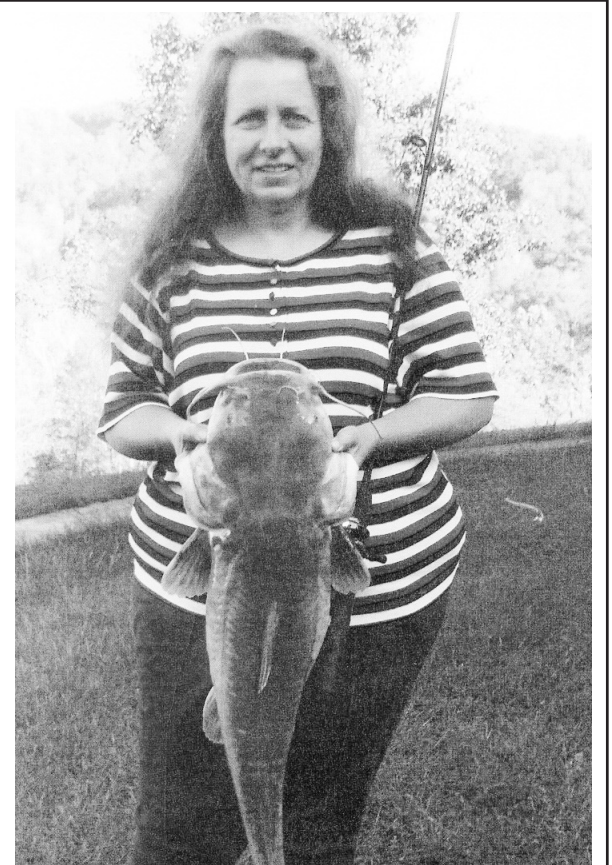
This grant was designed to improve the knowledge base of social studies teachers in several eastern Kentucky counties.

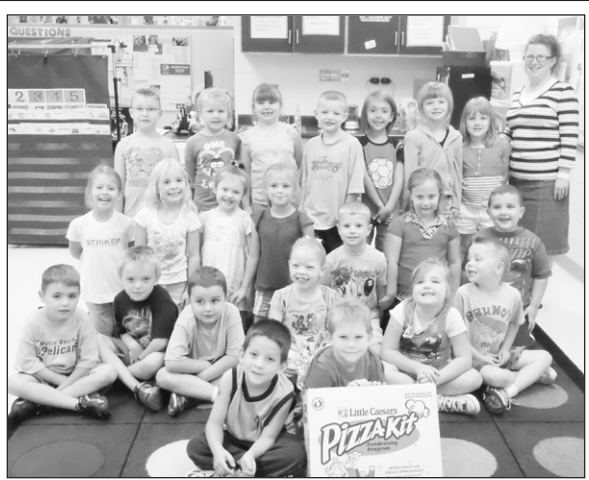

## PRIDE awards \$11,500 to Rockcastle for education

PRIDE recently awarded a total of \$11,500 for environmental education in Rockcastle County. The three local award recipients estimated that the funds will serve 350 students during this school year.

Mt. Vernon Elementary School will serve 120 students with its \$4,000 award to maintain its outdoor classroom, buy greenhouse materials and buy educational materials.

Roundstone Elementary received \$4,000 to improve its greenhouse and buy educational materials, which will benefit 132 students.

The Rockcastle Regional Child Development Center was awarded \$3,500 to build a greenhouse, which will be used by 98 students this year.

Each award includes \$500 to operate a service-oriented PRIDE Club.

"We are proud to partner with educators who are changing how our students look at the world, starting with their own backyards," said Karen Kelly, PRIDE Director. "With these funds, teachers can build facilities and buy resources to bring their lessons to life. These fun, hands-on activities will give students a life-long love

and respect for nature, especially in their own community."

The PRIDE funds support projects that help young people understand the importance of a clean environment, personal responsibility, and community pride. The one-year funding contracts are available through an application process to schools, nonprofit organizations, and other education providers in the 38 counties served by PRIDE.

This year, a total of \$346,514 was awarded region-wide. The funds will benefit 40,000 students during this school year, and many of the projects will create resources, such as nature trails, that will be used for years to come.

Since 1998, the region-wide results of PRIDE's investment in environmental education include 390 outdoor classrooms, 126 greenhouses, 55 wetlands and rain gardens, and 45 recycling programs.

This year, PRIDE's environmental education funds were made possible by a grant to PRIDE from the U.S. Department of Education.

Eastern Kentucky PRIDE, Inc., (PRIDE) is a nonprofit organization that advances environmental cleanup and education in southern and eastern Kentucky. ### How the Fiscal Court Stepped Up To Protect Taxpayers

When I took the Oath of Office as County Judge-Executive, one of my burdens was to accept the fiducial obligations to both the local taxpayers and the state – a serious obligation. In addition, I have always considered the County Clerk as my personal friend, and I do not think the Fiscal Court had ever denied the clerk's office a single request brought before the magistrates. The Clerk has served well.

The clerk questioned the Fiscal Court's ability to set her budget at a special meeting. She did not question it in '09. Every year the magistrates meet to establish a budget for the clerk's office and set the maximum amount that can be paid to deputies and assistants. This determines how much of the taxpayers' money can be used to operate that office. While the Fiscal Court determines only the total amount the clerk can pay to employees during a calendar year, it is the clerk who determines how much each individual employee will receive from that total amount. For example, if the magistrates approve \$100,000 for the clerk to expend on deputies' salaries, the clerk could pay one employee \$70,000 while paying two others \$15,000 each.

In January of '09, when the Fiscal Court realized the clerk was paying two family members at a much great rate than the other deputies, the Court stepped up and lowered her maximum salaries.

According to monthly retirement reports, the gross payroll for the clerk's deputies was \$174,874 in '06; \$195,188 in '07; \$237,369 in '08 and \$174,621 in '09. Of these wages her husband received \$36,400 in '06; \$39,300 in '07; \$47,200 in '08 and \$39,000 in '09. Her daughter's wages were \$29,530 in '06; \$35,275 in '07; \$44,214 in '08 and \$38,282 in '09.

The Fiscal Court acted unanimously this year to provide enough funding for the clerk's office and deputies and assistants while acting in a prudent manner to protect the taxpayers' money. Funds that are not used on the operations of the clerk's office are returned back to the Fiscal Court that can then be used for roads, parks, bridges, buildings, etc. This is why the Fiscal Court was compelled to act in order to protect the taxpayers of Rockcastle County.

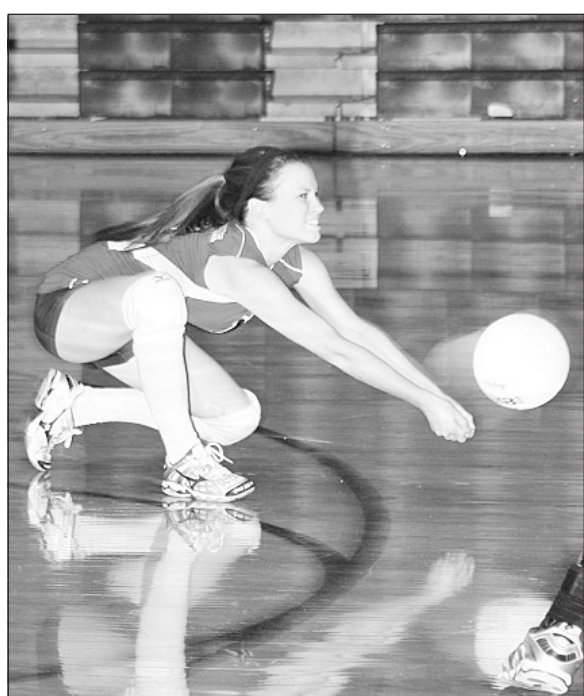

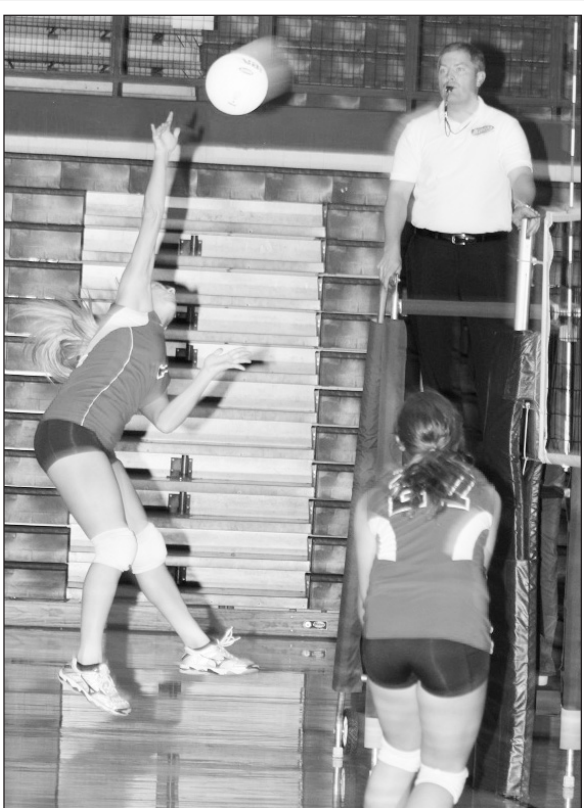


Casey Hunt gets a dig in the district tournament win against Pulaski.

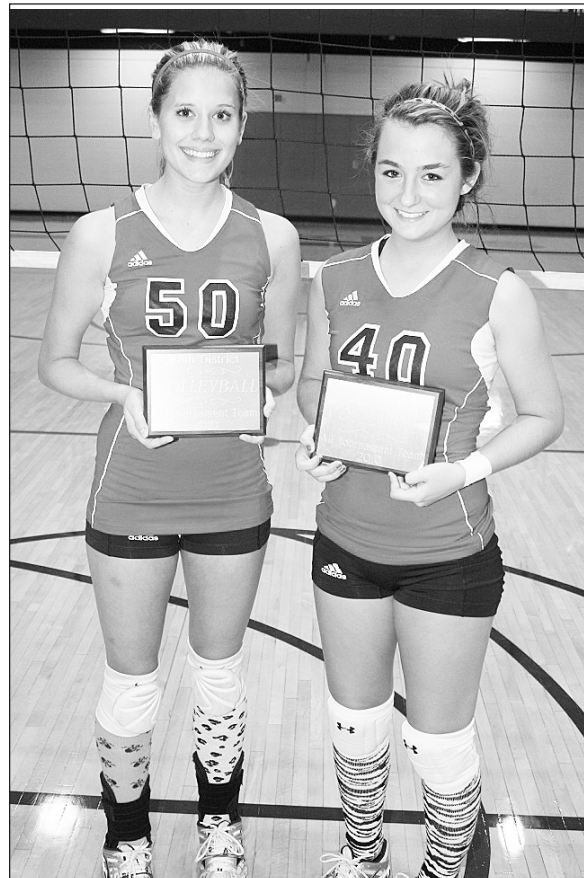


### Lady Rockets advance to region play at Lincoln Co.

## Rockets lose to Knox; fall to 1-2 in district

Fans love nothing better than to compare scores, so when Knox Central held the high-powered Bell County Bobcats offense to only 21 points, a lot of folks took notice.

A chance to play homecoming spoiler, and the fact that a first round home play-off game was at stake, gave more than enough fuel for Knox Central to come in feeling confident. But it was Rockcastle that played inspired, hard-nosed football.

The Rockets had some great opportunities but, once again, unforced fumbles and key penalties cost Coach Parkey's squad. The result was a 28-8 loss in a game that was much closer than what the score indicated.

Rockcastle showed on their opening drive that they could move the ball on the Panthers, twice converting on third and long. But the Rocket's drive stalled on the

Knox Central 31 where the Panthers took over on downs.

Knox Central then marched the ball down the field in a drive that ended with a Johnathan Barger one yard touchdown run and, with the extra point, made it a 7-0 lead with 3:48 left in the first quarter.

The teams traded possessions until the Rockets had a costly fumble that gave Knox Central the ball at the Rockcastle 42 yard line. The Panthers took advantage and converted the turnover into six points, courtesy of another Barger touchdown run of 24 yards.

Another good drive by Rockcastle late in the second quarter was foiled by a holding call, followed by a delay of game penalty that took the Rockets out of Knox Central territory.

Knox Central got the ball

back and added a seven yard touchdown pass from Barger to Jeffery Canady, giving the Panthers a 21-0 lead at the half.

Things got interesting in the fourth quarter when Rockcastle's quarterback Jadon Brock, who was six for eleven with no interceptions, hit Zach Reams who somehow stayed in bounds, and sprinted down the sidelines with a 58 yard touchdown pass. The two point conversion pass from Brock to a wide open John L. Saylor cut the lead to 21-8.

The Panthers' Barger hooked up with Canady again for another touchdown pass to seal the victory and will now force the Rockets to be on the road in their first round play-off game the first Friday in November.

Coach Parkey, who started the fourth different offensive line combination this season, was pleased with his team's overall effort. The line helped spring Clark Rowe to gain 112 yards on 27 carries.

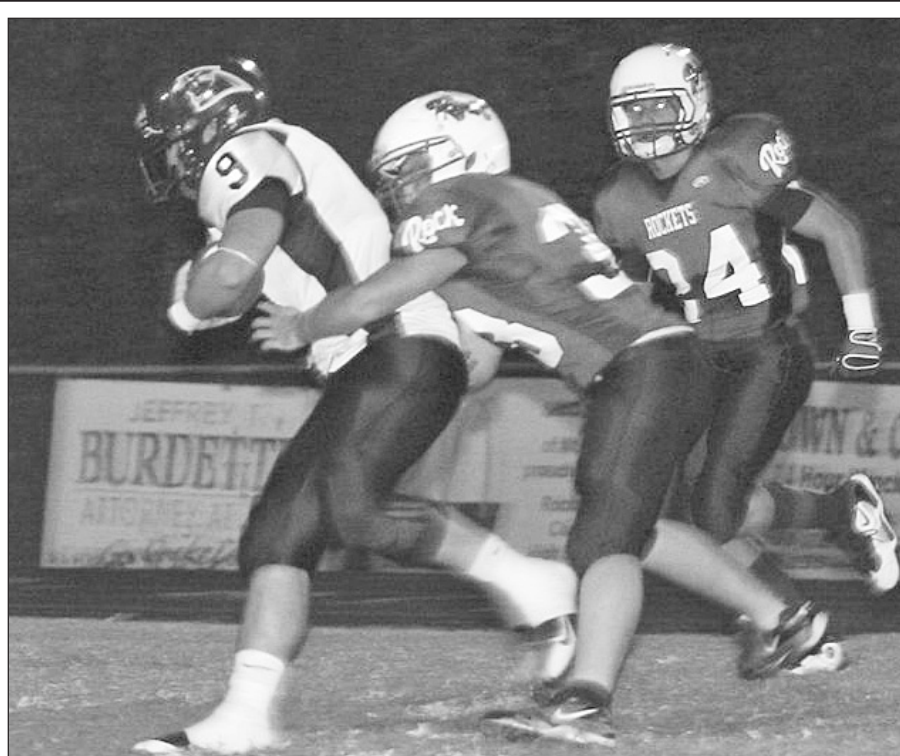
"We felt that we blocked (Knox Central) better than any team so far this season. We have spent a lot of extra attention on blocking schemes and the fundamentals that go with each. It has made the entire group of linemen better by doing that," Parkey said.

Parkey knew that Knox Central's offense would be difficult to stop but the Rocket defense held the Panthers to just one touchdown drive in the second half and several three and out possessions during the game.

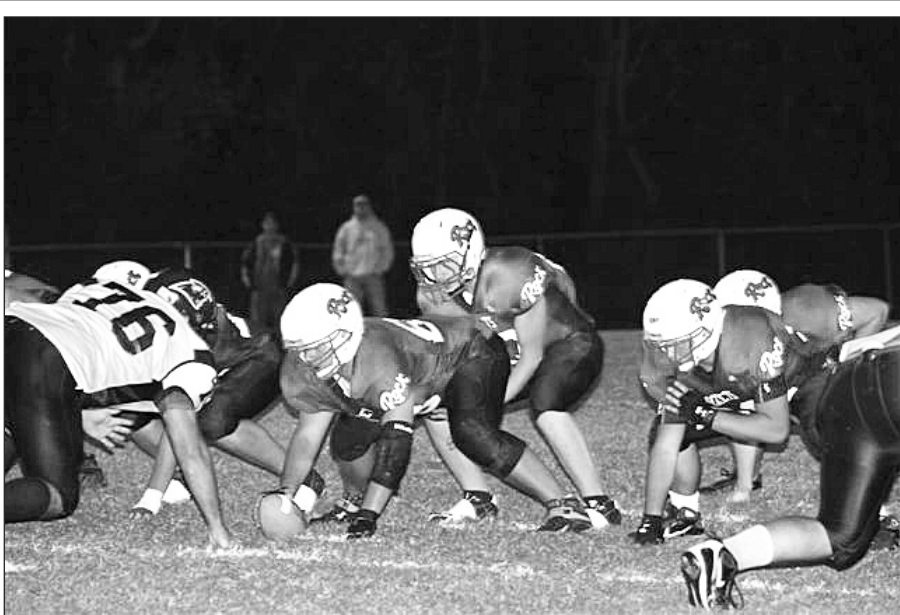
"We knew they had some real athletic guys in the skilled positions who would be hard to contain. For the most part, we made them work for every point they got. The defense did a good job of flying to the ball to get two, three and four guys in on a tackle," Parkey noted.

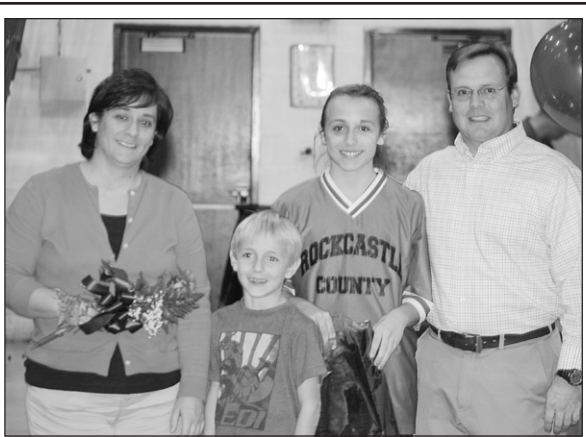

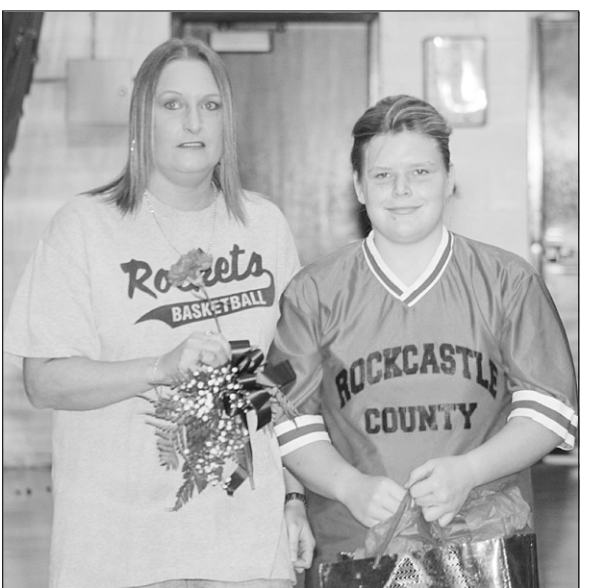

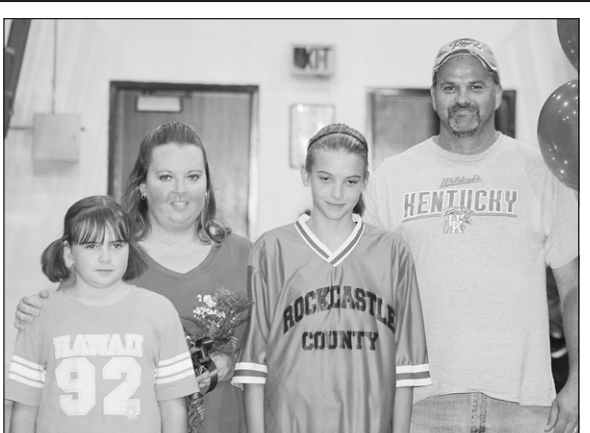

## INVESTIGATION INTO COUNTY FINANCIAL REPORTING

---is near an end. The letter at the right is a copy of the findings of an independent Certified Public Accountant pertaining to the August 19, 2010 Rockcastle County Fiscal Court Financial Summary as reported by the County Treasurer.

(State auditors or representatives of them came to the County Judge's office to begin an audit on Wednesday after the Monday I called them.)

### LOOK:

1. If the 15 errors mentioned in my *Signal* report were not true, I could have been sued. Since this has not happened, the 15 errors mentioned are true.
2. When I met with the County Attorney, he stated that when he called the Treasurer's or Judge's office about the CPA report (also sent to him), he was told that "It had already been taken care of." He also asked about reprinting the Financial Summary in the *Signal* and was told that since it cost so much, it was not thought to be a good use of county money. (paraphrased)
3. A (\$250) half page ad in the *Signal*, instead of the four full pages, could take ownership of the incorrect Fiscal Court Financial reporting and would illustrate respect for the citizens of Rockcastle County by acknowledging they deserve the complete truth from their elected officials.

Concerning the Governmental Liabilities principle amount owed of \$8,898,845 (plus the interest of approximately \$3 million) addressed by the County Treasurer, he stated that a large portion of the amount owed "will be paid off by the state and federal government through reimbursements".

Anyone who listens to national news even 30 minutes a day knows that the **Federal Government is broke**. Also, **Kentucky was just named the "worst run state in the nation"** according to a recently published comprehensive *Wall Street* study.

Per your request during our meeting on Monday, September 20, 2010, I have reviewed the Financial Statement of Rockcastle County Fiscal Court published in *The Mount Vernon Signal* on August 19, 2010.

What I found is that the Summary totals for the Jail Fund and LEPC do not match the Statement of Appropriations. There is a \$200 difference in the Jail Fund and \$60.00 in LEPC. This creates a difference of \$260 in the Summary Totals Vs. Appropriations Grand Total.

In comparing General Fund Statement of Appropriations to General Fund claims under the Statement of Vendor Claims Totals, it is out of balance by \$1,294.96. This is also reflected when comparing the "Claims Statement" to the Summary. The road fund appears to have a similar error in the amount of \$45.00. The \$200 error in the Jail Fund reappears in the Vendor Claim totals as does the LEPC \$60 error. The CSEPP claims do not match the Summary nor the Total Appropriations.

As we discussed, this does not represent and audit of these accounts. It is simply a comparison of what has been published Revenues, Claims and Summaries. An error on one line will follow through to create other discrepancies, which is the case here. This review is not intended to imply that any wrongdoing has taken place but simply that the numbers published are out of balance and should be further reviewed for accuracy.

assistance when needed by the Rockcastle Rescue Squad which covers the whole county.

This year, BFD made the final payment on a 1998 model fire engine that serves as the department’s primary response fire apparatus.

Branham pointed out to the court that with the new 150 being built, the potential for more accidents was a concern and that BFD’s main objective was to make the citizens as safe as possible.

The court was receptive to the proposal but asked Branham to review several options for the county to pay their \$40,000 share, including financing it with the company selling the fire department the vehicle.

In other action, because of a recent Attorney General’s Opinion which called into question County Judge/Executive Buzz Carloftis’s procedure for notifying magistrates and the *Signal* about called meeting, the court reaffirmed all actions taken in the special called meetings. County Attorney Billy Reynolds said he was “okay” with this action, noting that the procedure used by the county is the same one used by most counties in the state and that the court was in “substantial compliance” with the open meetings law. Carloftis also told the court that the chief legal counsel for the state’s Department of Local Government agreed that the procedure used fulfilled the “spirit” of the law.

The court also approved the posting of “Slow” signs on Shady Lane, JoNance and Little Hurricane Branch

Road and, additionally a “Hidden Entrance” sign on Little Hurricane Branch road. A speed limit of 35 mph for the Fuzzy Duck Road was approved by the court.

The court tabled a request by Sheriff Mike Peters for \$27,320 to match a grant of \$81,962 to purchase three Ford Expeditions. Peters was unable to be at the meeting to discuss the matter with the court.

The court also approved a \$1,300 to the Cub Scout program in the county; approved a donation of \$1,500 to the local World Equestrian Games committee (one-half of their budget shortfall); approved a claim of \$1,524.15 from County Clerk Norma Houk for preparation of tax bills and approved a Resolution and Agreement with the State Transportation Cabinet for replacement of the bridge on Piney Branch Road. The court also reappointed Ann Taylor to the 911 board.

A Resolution of Support was approved for the newly formed Rockcastle Recreation Committee. The committee is working to expand indoor and outdoor recreation facilities in the county. Co-Chaired by Regina Crawford and Sam Hamilton, the committee is made up of: Twila Burdette, Mike Jones, Barry Noble, Doug Proctor, Doug Hamm, Mt. Vernon Mayor Gary Cromer, J.D. Bussell, Howell Holbrook, Jr., Jennifer Goff and Corey Craig.

The group is currently identifying land parcels, as centrally located as possible, that might be available and are working on drawing up a master plan for development.

Steven N. Forsythe, 30, of Berea was indicted on two counts—one of possession of a controlled substance and one for possession of drug paraphernalia. His bond was set at \$10,000 cash or property.

There were two indictments handed down for flagrant non-support of a child. Darwin D. McGuire, 30, of Brodhead and Gregory S. Horn, 40, of New Paris, Ohio were both indicted for failing to provide for a minor child/children.

pay local contractors within this period of time and is now awaiting reimbursement from the federal government,” Car-loftis said.

Work on four slips on Old Dixie, Buffalo Branch, Mt. Zion and Maret Cemetery roads have not been started by the contractor, although a contract has been signed for each project.

Total dollar value of the damages to Rockcastle

County’s roads, according to FEMA (including the four slips), was \$810,000, Carloftis said. The county has already expended over \$600,000 for repairs and will be reimbursed 98% by the federal government.

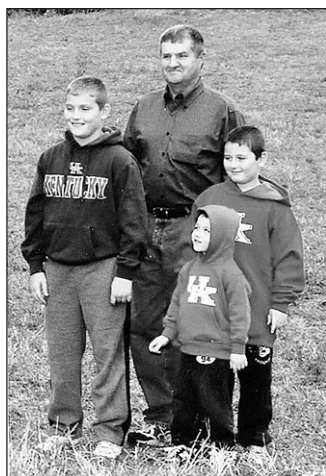

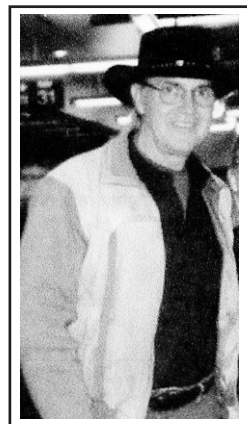

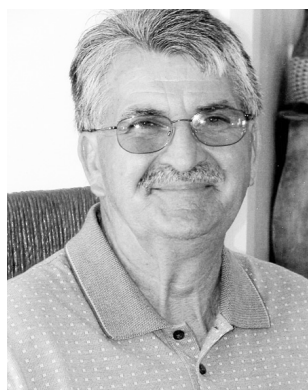
**Some of the reasons are:**

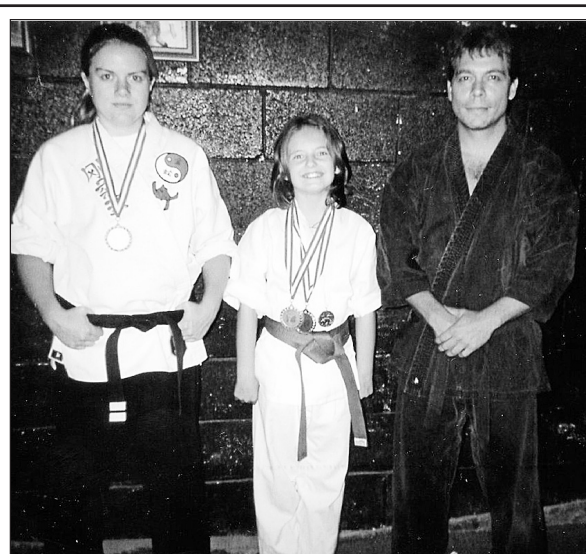

## Mamaw's Kitchen

Growing up we called an ear of corn "roashen ears". I was in my teens before I realized they were really roasting ears. Once when cousin Joyce was visiting, we ate at a restaurant that had corn on the cob. She ordered her meal with an "ear of cob" as her vegetable. The waitress asked, very politely, if she meant an ear of corn. All Joyce could do was nod her head in agreement.

**CORN PUDDING**  
Most of time we just had the home made creamed corn that we had put in the freezer over the summer. Occasionally we would use store bought canned corn and make a pudding out of it to give it more flavor.  
4 tablespoons flour  
1 teaspoon salt  
2 teaspoons sugar  
2 cans (14 ounce each) whole kernel corn  
2 beaten eggs  
2 tablespoons melted butter  
2 cups milk  
Preheat oven to 350°. Mix flour, salt, sugar, and corn. Combine eggs, melted butter, and milk. Mix with corn

mixture. Pour into greased baking dish. Bake for one hour. Stir from bottom 2 or 3 times during the first 30 minutes of baking.

**CORN PUDDING SQUARES**  
This is sister Rhonda's favorite way to fix corn.  
1 can (15 ounce) whole kernel corn, undrained  
1 can (14 ounce) cream style corn  
1 cup sour cream  
1/2 cup butter, melted  
1 box (8 ounce) Jiffy® cornbread/muffin mix  
2 eggs  
Preheat oven to 350°. In a large mixing bowl, combine all ingredients; stir just until combined. Pour into greased 9 x 13 baking dish. Bake for 40 to 45 minutes or until wooden toothpick inserted near the center comes out clean. Cool slightly before cutting into squares to serve.

**SOUR CREAM CORNBREAD**  
Rhonda's sister-in-law Rita gave us this recipe, one of her favorites.  
1/2 can (14 ounce) cream style corn

1 cup self-rising cornmeal mix  
1 container (8 ounce) sour cream  
2 eggs  
1/2 cup oil  
Preheat oven to 400°. In a

large mixing bowl, combine all ingredients; beat just until combined. Pour into greased 8 inch baking dish or iron skillet. Bake for about 30 minutes or until golden brown.

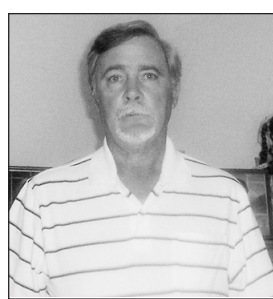

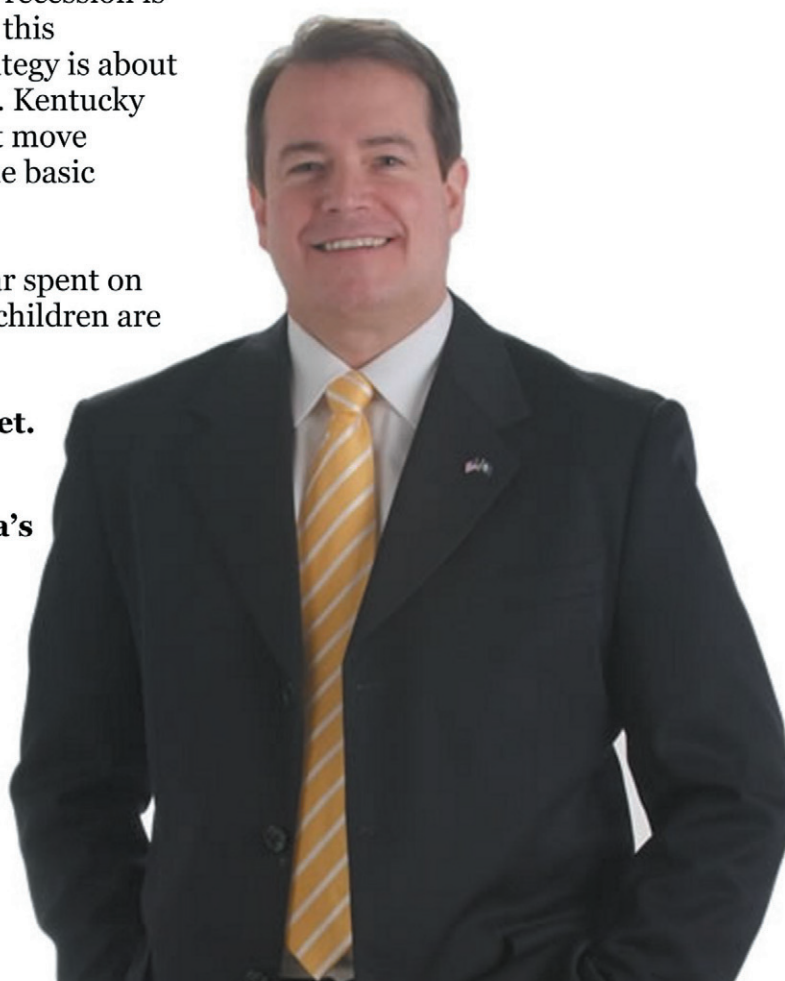

30 years. "Having an indigenous background, my message is also that no one is excluded from God's creation," he added. "God loves us no matter who we are or where we came from."

"We are musicians who are Christians," said Leah Thomas, leader of the Blue Flamingo Jazz Band and a graduate of the prestigious King's College in London, England. "Since the World Games began in Lexington, we have performed in 9 or 10 shows. "Renfro Valley is a special place because we were inspired by the Grand Ole Opry in Nashville."

When "Blue Flamingo" was joined on stage by the other artists to sing "We are Marching" during the finale, the audience stood and cheered. The artists received another standing ovation when "Blue Flamingo" ended with an English rendition of Stephen Foster's "My Old Kentucky Home."

"The incredible diversity and quality of the entertainment made an unforgettable memory for everyone," said Dr. Larry Martin, Director of AIM. "Renfro Valley Welcomes the World" represented the spirit of AIM. Young Adults from five countries—four continents—shared their God-given talents in the spirit of Christ's love."

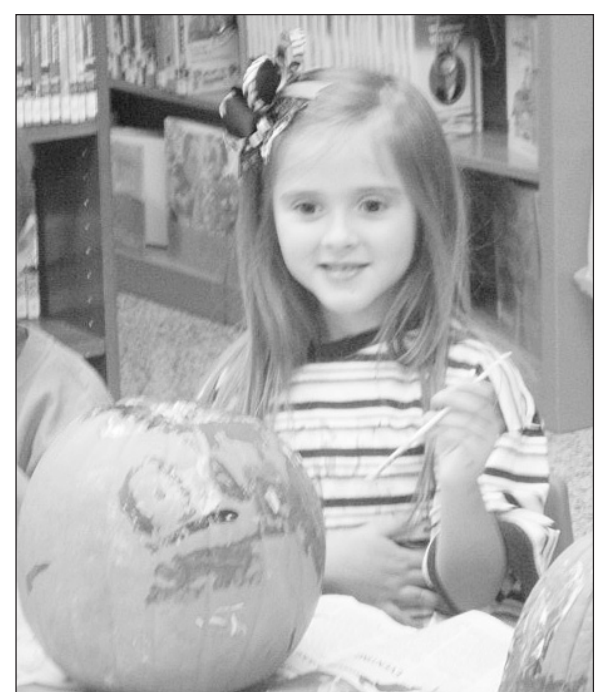

## Friendship Leads to Sharing

The doorbell rang one hot afternoon in mid-summer. When I opened the door, a friend that we have known for a long time was there. Recently, she had lost her job and was looking for work, but that was not the reason for her visit. With a broad smile on her face and a warm greeting, she presented us with a loaf of her homemade bread for which she is known. Instead of lamenting the loss of a job, she went to her kitchen on a hot August day and baked loaves of bread and shared them with her friends. As she handed that loaf to us, joy radiated from her face.

Later, I went to my desk and began to read. In a moment, a sentence, almost two thousand years old, caught and held my attention: "Yet it was good of you to share in my troubles." For days, that statement lingered in my mind, and it became, what might be called, food for thought.

Tuesday, March 16,

1937 was one of the gloomiest days of my life. It will be forever indelibly etched upon my mind. I was a small boy, but I remember that deep trouble had come to our household, and I vividly remember something else. Neighbors came from every direction. They filled the house and gathered in small groups in the yard. All of them came to share in that trouble and offered to help in any way they could. As need arose, they went to work. At that time, we share to give comfort, support, and help.

In the Christian tradition of which most of us are a part, sharing does not end at that point. That hot August day, we received that loaf of bread from a friend not because of trouble we experienced but because of genuine friendship that had developed over the years. In all of the situations of everyday life, friendship leads to sharing, and we are blessed by it.



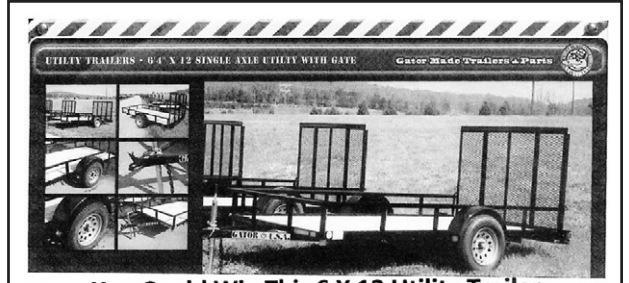

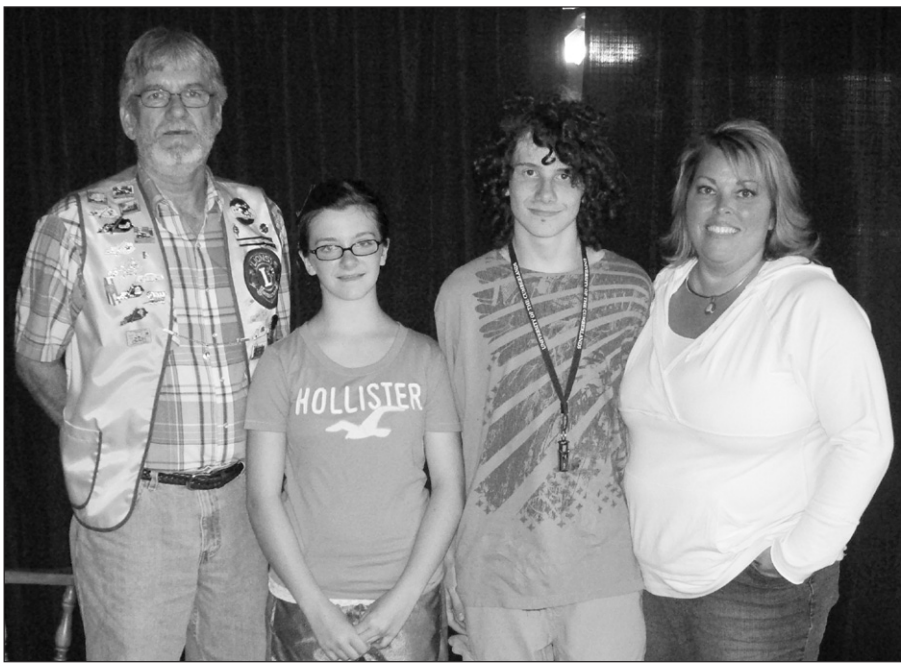
