Mt. Vernon Fire and Rescue responded to a tractor trailer fire Tuesday afternoon on Hwy. 461. Authorities say a Tennessee man hauling steel noticed fire while sitting at the intersection of Hwy. 150 and 461. He managed to drive the trailer through the intersection before pulling off the side of the roadway. Traffic was blocked both ways on 461 for approximately an hour.

Wet/dry vote is March 31st

A local election has been set for Saturday, March 31st for voters to decide if they are in favor of the sale of alcohol in Rockcastle County.

Supporters of the measure gathered 1411 signatures and turned them in to County Clerk Danetta Allen January 27th. Those signatures then had to be verified against voter registration cards by the clerk's office and 816 were certified on February 3rd as valid. Besides a signature, information required on the petition included, a complete address, a social security number or date of birth and the date signed. 595 signatures were invalidated because of various reasons, Allen said.

727 valid signatures were required, Allen said, since 2,907 voters voted in the last general election and 25% of that number was needed to force the local vote on the issue.

It was the job of County Judge/Executive Buzz Carloftis to set a date for the local option wet/dry election and, according to KRS 242.030, the election had to be held not earlier than sixty nor later than ninety days after the date the petition was filed with the county clerk making the window March 28th through April 21st.

Carloftis said he considered the problem that a number of the 14 precincts in the county now vote in the schools. "I did not want to interfere with the school calendar," he said "al-

Commissioner's Sale date set for Plasticware property, machinery

Friday, February 24th should see the end of an ongoing saga involving a local manufacturer when their property and machinery will be sold at a Master Commissioner's Sale in Mt. Vernon.

Plasticware, who bought the Alcoa property in July, 2007 in the Rockcastle Industrial Park, quit operation in April 2011 putting approximately 120 people out of work. The company manufactured lids and con-

tainers for deli packaging.

The two main lenders, Citizens Bank and Valley National Bank out of New York, received Summary Judgments authorizing the sale. Together, the two banks have almost \$5,000,000 in outstanding loans to the company. Other suits have been filed by Plasticware vendors.

Corey Craig, president and CEO of Citizens Bank and a board member of the Rockcastle County Industrial Authority, said Tuesday that the upcoming process had been delayed about four months after Plasticware succeeded in getting the case into federal court. However, it was then returned to state court from which the Summary Judgment was issued.

As to the future of the facility for Rockcastle County, Craig said he had had 15-20 inquiries and 7-10 site visits from interested parties. Two of the more serious inquiries, Craig said, have been from manufacturers of a different type of plastics and two from manufacturers of something else entirely. "I am cautiously optimistic that one or more of these inquiries will result into something productive

settle for a job I dreaded getting out of bed for and going to every morning. If I was going to change something, right now was the time to do it!

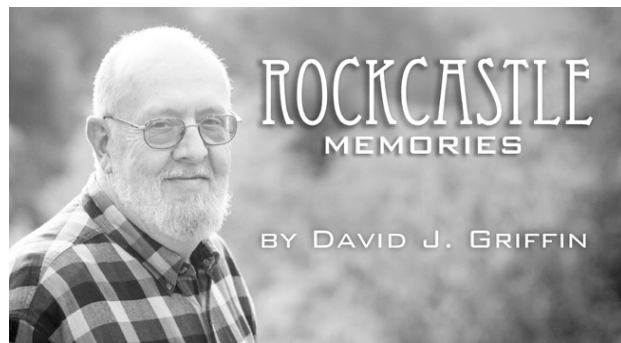

"A White Sport Coat"

In 1958 I was in the eighth grade at Mt. Vernon Elementary School, and Marty Robbins had just previously released his crossover hit "A White Sport Coat." The song was originally intended to be another country single, but it also sold well in the new genre called rock and roll. The hit began its climb up the Top 40 charts, eventually becoming one of Robbins' biggest hits. I had no idea how this song set the stage for a part of my own life in high school. The lyrics are:

A white sports coat and a pink carnation

I'm all dressed up for the dance

A white sports coat and a pink carnation

I'm all alone in romance

Once you told me long ago

To the prom with me you'd go

Now you've changed your mind it seems

Someone else will hold my dreams

A white sports coat and a pink carnation

I'm in a blue, blue mood.

My experience, however, did not include any blue moods. On the contrary, the memories that this song brings back to me are happy ones. When I entered my freshman year at Mt. Vernon High School (MVHS), little did I know that I, along with Joyce Aylett, would be elected to represent my class in the annual Halloween Carnival.

To my surprise, we were elected MVHS King and Queen for the year 1959. It was a real thrill to be chosen, particularly when we were merely freshmen. Joyce and I were overjoyed when Principal William Landrum announced that we had won. Walking in the spotlight up the gym floor to the stage felt awesome to a young man such as I, especially with Joyce on my arm looking quite elegant in her long, pink evening gown.

That week, my mother (Bee) had taken me to all the way to Richmond to purchase a new grey suit for the occasion. In those days, I did not have any real reason to purchase a suit, let alone one for my days in high school.

That night, as the event was winding down, Mr. Landrum took Joyce and me aside and explained to us that we would be expected to crown the new King and Queen the following year. As soon as he told us this, my mind started to race – would it be possible that I could purchase a "white sport coat" for the 1960 event? When I asked Bee, she thought the idea was great because I could take the outfit to college with me.

When my sophomore year rolled around, Darrell Stepp and Jewell Anderkin

were selected to represent our class in the Halloween Carnival. My class was ecstatic when Darrell and Jewell were chosen as King and Queen. Again, Joyce and I strolled up the aisle toward the stage in order to crown the new royalty. Even though I am not sure that it was because of Marty Robbins, it is a fact that over half of the young men at the Carnival were wearing "white sport coats," including me and Darrell Stepp. The fad had spread across America, including Rockcastle County.

As a side note, my class ended up winning the King and Queen Carnival contest three out of our four years in high school. We did not win our junior year, but Marion Whitehouse and Joann Cummins won our senior year – 1962.

And I did take my "white sport coat" with me to the

Points East

As long time readers of this column know, I have moaned and groaned over the last two years about personal health issues, related to my lack of balance and then, late last summer, I began losing almost all use of my right arm. I couldn't type with my right hand, hold a cup of coffee, or even sign my name and the mobility problem worsened.

I had been treated for Meiners's Disease, various other inner-ear complications, vitamin and mineral deficiencies, diabetes complications, diet changes, and I had even undergone physical therapy, all to no avail. But when the arm problem started getting worse, my family physician literally insisted that he didn't want to hear anymore about it until I had seen a neurologist and got over my denial. So, late last fall, I asked him to refer me to one.

The first week of December found me sitting in a neurologist's examining

room and, after two hours of poking, probing, questioning, MRI reviews, etc. etc. the good doctor told me that he was more than 90% sure that I had Parkinson's Disease and that there was a way to confirm his suspicion. He asked me to try a medication called Sinemet and come back in 30 days. He also advised that it would take some time to take effect but if it worked, I had Parkinson's.

Still, Christmas found me unable to wrap a present. I had been on the med for over two weeks and, quite frankly, I was feeling relieved that it wasn't working. Between Christmas and New Year's, however, I found myself, out of habit reaching for the keyboard with my right arm and thinking hey, what's going on. Not only that, but I found myself, however slowly, able to get my fingers on the correct keys. I had been unable to do this for months.

January 5th, my birthday, found me back in the neurologist's office for another round of tests. He nodded up and down. He told me that the bad news was that I had Parkinson's Disease and that it was incurable but the good news was that it was treatable. He also told me that the difference between my first visits and this one was like darkness and daylight. And he is correct. The metaphor could not be more on target.

I have come to grips with the fact that I will always be a little out of balance, that mobility will always be a bit

Visiting Jepp Hill

The small community of Jepp Hill will be revisited through the memories of one-time resident Tony Smith this week.

Jepp Hill is located off Red Hill Road near the Jackson County line in the southeastern portion of Rockcastle County. It became known as Jepp Hill due to a resident of the community, Jepp French. He lived there in the 1920s and before.

Although small, it was a thriving community with little family farms scattered throughout the countryside. These families raised corn, hay, and tobacco primarily along with vegetable gardens. The area is said to have produced quite a bit of moonshine as well.

There was, as was the case in most communities, a combination general store and post office. It was run by Ben Ponder. His daughter was one of a series of teachers at White Oak school, where the local children were educated. Other residents of the area that

came to mind were Elihu Hurley and his brother Pete, Bill Gibbons, Sheridan Jones, and Virgil Winn.

When the need arose to go to town, they went to Livingston, or to Mount Vernon if they needed to see a doctor. Some people even

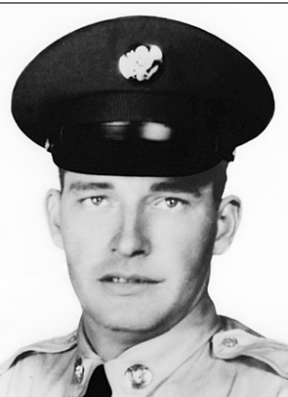

Edith M. Thompson

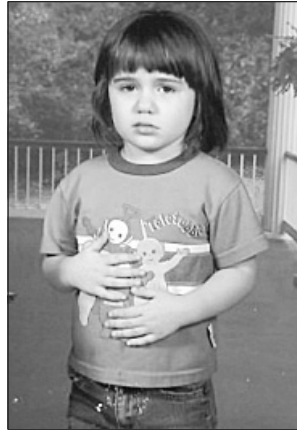

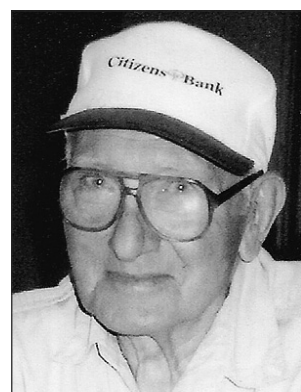

"Keep the Rock Dry"...

Dear Editor,
I write this letter to the wonderful citizens of Rockcastle County. I was born and raised in this outstanding community. I left for a brief time to go to college, then worked outside the county for a few years, and joyfully returned three years ago. I've traveled across the country - from Seattle to the Florida Keys, from San Diego to Maine, as well as Canada and Mexico - and I boastfully say that Rockcastle County is the greatest place to live and raise a family. There is no greater place for hospitality and decency than here at the "Rock."

However, I am troubled by an attack launched on the wholesomeness of the county I love. The attack comes in the form of a proposed vote for alcohol sales throughout Rockcastle County. I am displeased in the deceitful manner that it has been launched. Last fall's election was one of the lowest turnouts ever for Rockcastle. As a result, only a few hundred signatures were required to file a petition to vote for alcohol sales.

Furthermore, the haste to bring the issue to a vote prior to the normal election cycle in May, thus disrupting the school calendar, reveals the deception of those pushing for this vote. In any issue, I prefer to have adequate time to consider how to make an informed, intelligent vote. This speedy vote is akin to a shady car salesman trying to make a quick sale in order to dump a "lemon" on an impulse buyer.

The facts need to be exposed. Alcohol sales will damage this wonderful county in many ways. According to a report prepared by The National Center for Alcohol Law Enforcement for the Bureau of Justice Assistance states:

Almost one in four victims of violent crime report that the perpetrator had been drinking prior to committing the violence;

Over one-third of victims of rapes or sexual assaults

report that the offender was drinking at the time of the act;

It is estimated that 32 to 50 percent of homicides are preceded by alcohol consumption by the perpetrator;

Between 31 percent and 36 percent of prisoners convicted of a violent crime against an inmate reported that they were drinking alcohol at the time of the offense. (These figures rise to approximately 50 percent when reports from those who were consuming both alcohol and drugs at the time of the offense are considered);

Two-thirds of the victims of intimate violence reported that the offender was using alcohol at the time of the act;

Between 27 percent and 47 percent of all homicides and acts of purposeful injury are attributable to the use of alcohol (2006 report).

These staggering statistics make it blatantly obvious that the "Rock" will suffer as a result of alcohol sales.

Some will say that alcohol sales will boost the economy. I say again, let the facts be exposed. Will some people profit from alcohol sales? The answer is yes. There will be a handful of business owners making money while the rest of us pay into their pockets and we suffer the consequences. According to a Reuter's article dated July 15, 2010, the US federal government in 2009 collected \$20.6 billion in taxes on alcohol, tobacco, and firearms sales. That sounds like a wonderful profit doesn't it? However, a report by the Center for Disease Control on October 17, 2011 states that \$223.5 billion dollars were spent because of alcohol related crimes, injuries, and health issues. On average, that costs each person \$746! Researchers found the costs largely resulted from losses in workplace productivity, health care expenses, law enforcement, other criminal justice expenses, and motor vehicle crash costs from impaired driving. This is not economic growth, but economic suicide.

I ask that every citizen consider this vote from a logical and wholesome standpoint. I believe in my fellow citizens to maintain the beauty of this county by voting "NO" on this upcoming, deceptive, and destructive alcohol issue. Let's "Keep the Rock Dry."

Crawford looks to "Take Flight"

A Brodhead man is launching a new program called "Take Flight Coaching" for Rockcastle County middle school and high school students.

According to Robert Crawford, 25, the program is designed to help students make a better transition into college or the work force and direct them to a more successful future into the real world through personal coaching, launched events, and social media.

Crawford, a student at EKV, created the program as a result of experiences he had in his own life after graduating high school.

"I started college and dropped out after one semester." Crawford said. I didn't know what to expect and I had no idea what I wanted to do so I just went to work."

The first event for students and parents was held Thursday, February 2nd, at the Rockcastle County High School auditorium. The guest speaker at the event was Circuit Court Judge Jeff Burdette.

Burdette spoke to the crowd about a past case that was presented to him in court where he reached out and mentored a young man who was convicted of a crime in his community.

Years later, Burdette said, he saw the young man again and found out he now had a successful career in the military.

"The impact a person can have on a young person's life, by taking interest in them and paying attention to them is a good lesson for us all." Burdette said.

The event also included a Skype interview with Mixed Martial Arts fighter Shay Taylor. Taylor, the son of Coy and Linda Taylor of Quail, had his leg amputated after a motorcycle accident in July 2010.

However, Taylor didn't let the loss of his leg stop him from living his dream of becoming a MMA fighter. With the help of a prosthetic leg and a positive attitude, he was still able to fight. Taylor credits his source of motivation to his former high school baseball coach Jesse Mahaffey.

"It really struck a chord in me and it has stayed with me throughout my entire life." Taylor said.

Following the speakers, there was an open discus-

sion with Crawford for those in attendance.

Jared Brown, 24, of Brodhead, shared his college experience with the crowd during the open discussion.

"We go into college with a general idea of what we want to do, but we don't really have it completely figured out yet." Brown said. "I just went to college because that's what we're supposed to do."

Hollie Barnett, 23, of Mount Vernon, also liked the idea of having someone to help and inspire people to be successful in life.

"I think everyone could use a life coach, no matter what age. Everyone could use a mentor," Barnett said.

Following the open discussion, Crawford shared his objectives and goals of the program with the crowd. He indicated that he would direct each individual differently according to their own interests, passions and desires.

The program will include life coaching in either individual or class room group settings.

Crawford says he expects big things out of the program and is hoping to make a positive impact on many people's lives.

"I have always known I wanted to help the youth in our community." Crawford said. "Everything starts with a vision, it is up to us to create it or let it die."



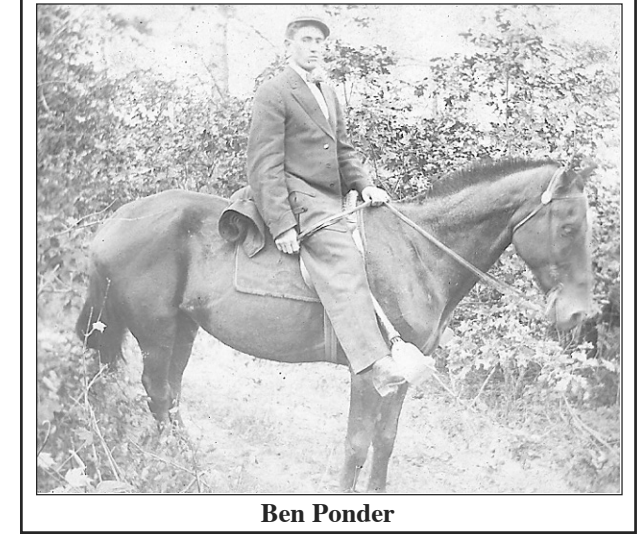

Somerset native makes a difference for Kentucky veterans through writing

Somerset native Travis Martin is all too familiar with the challenges faced by veterans who choose to further their education after serving our country

Martin, a former U.S. Army Sergeant who served two tours in Iraq, faced those challenges when he returned from the service. He has since committed himself to making a difference for other veterans by giving them a place to turn for help, as well as an outlet for their stories about war and the service.

Martin, the son of Timothy Martin and the grandson of Brownie and Carol Martin, all of Brodhead, lived most of his life in Somerset and graduated from Pulaski County High School in 2002. He enrolled in Somerset Community College, but lasted only two weeks. After dropping out, he served in the Army until 2006. After his discharge, Martin re-enrolled at SCC and received his associate's degree before transferring to Eastern Kentucky University.

At ECU, Martin received his bachelor's degree in English and his master's degree in English Literature. He is now working on a Ph.D. in English at the University of Kentucky. "I was really focused on school after I got out of the Army, said Martin. "I looked at it as a choice, either excel or go back to the service. I was lucky to have great professors at SCC who mentored me and made sure I stayed on track. I knew I wanted to study English, but I didn't

know what I would do with an English degree. I figured I'd probably end up homeless one day; but at least I would be able to study something I loved. Now, I've found a new passion in teaching. I figure if I can go from being a college dropout to a Ph.D. student, so can others with the proper help."

Martin said two English professors - Lynn Shearer and Wanda Fries - were essential to his success as a student at SCC. When he got to Eastern Kentucky University, though, he noticed that veterans didn't have a place dedicated to help them face the obstacles he had overcome as a student. So, he sought to create change.

"Being a veteran and returning to school can be difficult," Martin said. "A lot of vets come out of war zones that are intense, requiring life and death decisions on a daily basis. Writing a paper or taking a test often seems unimportant to these veterans after what they've faced in the field. Many have emotional issues and post-traumatic stress they're dealing with. They have the skills and experience needed to excel, but they need the time and resources to readjust."

During his undergraduate work, Martin and a few others started talking about the need for a space where veterans could be together. Those conversations eventually led to the creation of the ECU Veterans Education and Transition Support (VETS) organization, a branch of Student Veterans of America. Martin served as the founding president of the group, coordinating with

school officials as they instituted the Student Outreach and Transition Office (SOTO), a one-stop-shop for non-traditional students and veterans.

Student veterans at ECU can now be found studying and conversing in SOTO's "Vets Lounge" on any given day.

While working on his master's degree, Martin taught a veterans introduction to college course and English as a second language. He tailored his orientation course specifically to the needs of returning veterans, providing information about how to succeed in college, but also about how to succeed in civilian life.

It was while teaching his fellow vets that Martin founded *The Journal of Military Experience*, which is now an award-winning publication.

The journal, honored in December by the Student Veterans of America, is a 35 page book, filled with 29 stories, poems and artwork from 19 ECU students who served in the military.

"I thought something like this could be inspirational, educational and a good outlet for vets," said Martin. "I started shopping the idea around and got it funded through the College of Justice and Safety and the Student Government Association."

Martin is now working on the second volume of the JME - funded by the proceeds from the first volume and one of 14 national literacy grants awarded by the Honor Society of Phi Kappa Phi - which he projects will be released in July.

"Everyone has a story to tell," Martin said. "This is an outreach program. Veterans can come to us and we'll help them tell their stories in a way that makes sense to them and to the general public. We want our veteran authors to put their bet foot forward in our publication."

Although he's short on time, due to his teaching and Ph.D. responsibilities, Martin still serves as the editor for the project.

Wanda Fries, one of Martin's former mentors and current SCC English professor, serves as the JME's poetry editor.

"I want to do this as long as I can," Martin said. "It goes along with my research interests in trauma, autobiography and war memoirs and I feel doing this one way I can give back."

In addition to the journal, Martin is also working with ECU to create the first annual Military Experience and the Arts Symposium. The event, expected to take place in July, will bring in up to 100 veterans from Kentucky and surrounding regions to the campus for three days of workshops, camaraderie and free events open to the public.

"Universities, nonprofit organizations and veterans throughout the country have discovered an age-old tactic for dealing with the hardships of military service -- conceptualizing them through the arts," Martin writes in the proposal for the event. "There is something about artistic expression - written or visual - that goes hand-in-hand with healing. After 10 years of sustained conflict, this cathartic outlet is receiving more attention than ever before."

According to Martin, The Military Experience and the Arts Symposium will help educate the nation about the sacrifices and benefits of military service through the works produced. Among the events already lined up are art exhibitions featuring 90 pieces of conflict art collected from Iraq and Afghanistan by the group, Graffiti of War, and a public reading of stories and poems by military veterans.

The event would feature authors and artists, as well as others who could offer support for veterans in numerous areas. To find out more about the project, or to donate to the cause, contact Martin at travis.martin@eky.edu.

Martin currently resides in Richmond with his wife, Annegrat and his dogs, Buddy and Katie.

Yards to Paradise

Sometimes a homeowner finds an antique or unusual item which they want to put on display. They're not sure how to make it "belong" rather than being an eye-sore. Maybe it's a large clay urn, a cast iron kettle, or perhaps an old-fashioned well pump. Some even like to park on the lawn some horse-drawn implements from days gone by. These kinds of lawn accessories are more common in rural areas, but that's not the only place you'll find them.

More "natural" ornamental decorations often include a large piece of driftwood, especially a stump from a river or lake bank. Sea shells or a carved wooden life-like animal (chain saw art for example)--maybe even a totem pole--are brought back from a vacation and frequently put on display.

When building on a wooded lot sometimes stumps or fallen logs are left to retain a natural element. This is considerably more likely with a custom home built where the owner buys a lot and hires a builder.

A clump of stumps, a fallen log, or a rocky ledge or a huge boulder are often left with intent to create a naturalized area by adding flowering perennials, maybe some azaleas or blueberry, currant or gooseberry bushes.

Planting a new tree or several shrubs in proximity to these natural beginnings can really restore that woody look before the lot was cleared to build. Usually some good soil aids in planting these features. Dressing with mulch and watering often the first year can be all that's needed to complete the picture.

For those who would love to have that wooded lot with stumps, but have a new home with a bare lot, let's discuss what may be possible.

A large boulder, or a grouping of them, may be brought in and dumped then placed with a Bobcat or backhoe.

Smaller rocks can be placed by hand and added to a raised bed or set to be the border for a bed. Even a stump or a section of unsplit firewood can be "planted" to look like a tree has just been cut. A few trouble-free hosta, iris or black-eyed-susans can be planted to give the "established look" or sense of belonging.

Taking this concept on to a more complete naturalization of one's landscape, the creative homeowner or landscaper can create a meandering mountain stream or a trickling brook to run through these other natural looking elements. If water is not your choice, then maybe a little intimate spot with stones for seating? Or some comfortable outdoor chairs or benches that will mesh with the scenery.

Maybe a sunken garden or a "council circle" with a firepit in the middle would be your preference. There

should be a destination, a "go-to" spot among the new "natural" landscape.

Certainly, there are everything from gazing balls to wind chimes and birdbaths and wild life feeders that may be added to the yard. This article is not meant to put down any of these popular objects. But I set about to get your imagination geared to dreaming of what could be done should you find the concept

fascinating enough to want to "naturalize" your home.

If you stayed with me to the end, then I bet you have some of these natural elements already at your place. Or, you're already dreaming of naturalizing your place a bit.

Redrawn legislative boundaries thrown out by Circuit Court

It's back to the drawing board for candidates for the State House of Representatives after Franklin Circuit Judge Phillip Shepherd tossed out boundaries that lawmakers approved in House Bill 1 and Gov. Steve Beshear signed into law last month.

The ruling came Tuesday after House Republicans and State Sen. Kathy Stein of Lexington challenged the constitutionality of House Bill 1.

Under Shepherd's ruling the "elections for House and Senate shall be conducted with the legislative district

boundaries in effect immediately prior to the enactment of House Bill 1 for both the House of Representatives and the Senate." Shepherd also extended the filing deadline for legislative candidates to 4 p.m. Friday, which gives legislative leaders time to decide whether to appeal to the Kentucky Supreme Court.

The ruling said HB 1 is unconstitutional because it allows some districts to vary by more than 5 percent from the ideal population size and divides more counties into separate legislative districts than necessary.

"An agreement has not yet been reached, but we will not vote on anything that won't keep Rockcastle in the 5th and 34th districts," Ford said.

Both Ford and Carpenter are pleased with the new proposals in the house and senate.

"We are confident Rockcastle will stay in the 5th and 34th districts," Carpenter said.

Another issue brought up at the forum was the drug problem still present in our county.

Michael Sheliga of Rockcastle County believes there is not enough being done to keep drugs off the streets. "If we want to see changes we need to get the judges to hold them in jail longer," Sheliga said.

"Once you catch them and take them to jail, they are right back out in four hours," he added.

Claretta Hodges, Mt. Vernon, concurred saying drugs are not only in our streets but in our jail as well.

"Parents tell me their kids go into jail sober and come out of jail high," Hodges said.

Ford and Carpenter both agreed more could be done in Frankfort to fight the battle against drugs. They assured the crowd the issue of drug abuse is still of high importance in the state legislature.

House bill 4, would expand the reach of the Kentucky All-Schedule Prescription Electronic Reporting (KASPER), a system used to track controlled substance prescriptions dispensed within Kentucky.

The new bill would require all prescription providers to register and use the system in hopes of preventing doctors from giving out unnecessary prescriptions.

"Everyone understands we have a drug epidemic from meth to pill addiction," Carpenter said. "I like the idea of all doctors having to comply with drugs by being registered through KASPER."

Brodhead mayor, Walter Cash brought up the issue of no caution lights or turning lanes on the new Hwy. 150 at the Mareburg and Hwy. 70 intersections.

Ford told the crowd that he has already approached engineer Steve Waddle with the Kentucky Transportation Cabinet about it and they have been down there looking it over.

Cash specifically talked about the intersection at Hwy. 70 and how he has had many people tell him how dangerous it has been for them traveling through the area.

Ford said the Dept. of Transportation had given him no timeline but that turning lanes and caution lights are in the works.

Tuesday night, Ford told the *Signal* that funds had now been allocated for the turn lanes on the new Hwy. 150.

Holly Hopkins, Executive Director, Rockcastle County Industrial Development reported that two more companies had shown an interest in locating in the industrial park but that their names could not be disclosed at this time.

Many of those in attendance were unhappy with the county's job growth compared to the amount of costs that has gone into building the industrial park.

County Judge/Executive Buzz Carloftis, said the fact that "we have someone recruiting for industry is a step ahead of what we used to be."

"Without this industrial park we wouldn't have an opportunity," Carloftis said. "If we are going to have anything, we need resources."

Another factor, according to Carloftis, was that Kentuckiana Election Service, the company that sets up and oversees the new voting machines, had requested the date be set no later than April 3rd in order for them to do the necessary 'cleaning' of the machines and accompanying records for the May primary.

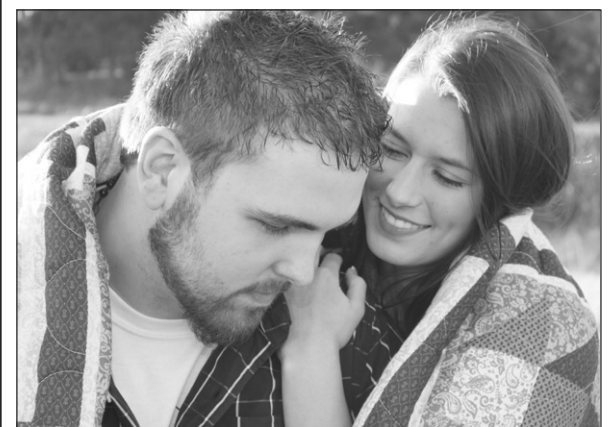
The judge said he settled on the March 31st date after reviewing the limited number of possible dates and recognizing the county's obligation to cause as little disruption as possible to other agencies.

On the ballot, voters will be asked to vote yes or no to the question "Are you in favor of the sale of alcohol in Rockcastle County, Kentucky."

Should the measure pass, restaurants which can seat 50 patrons, will be allowed to sell beer and wine, after certification by the Alcohol Beverage Control (ABC). Also, any grocery store or convenience store will be permitted to sell beer.

Package liquor stores will also be allowed, based on the county's population. Speculation is that Rockcastle would qualify for four stores. A license to operate a package store is granted by the ABC following an involved application process.

A spirited opposition to the issue is expected to be mounted and began this week with a Letter to the Editor from a local minister quoting statistics which point to increased crime and increased costs to taxpayers should the issue be approved.

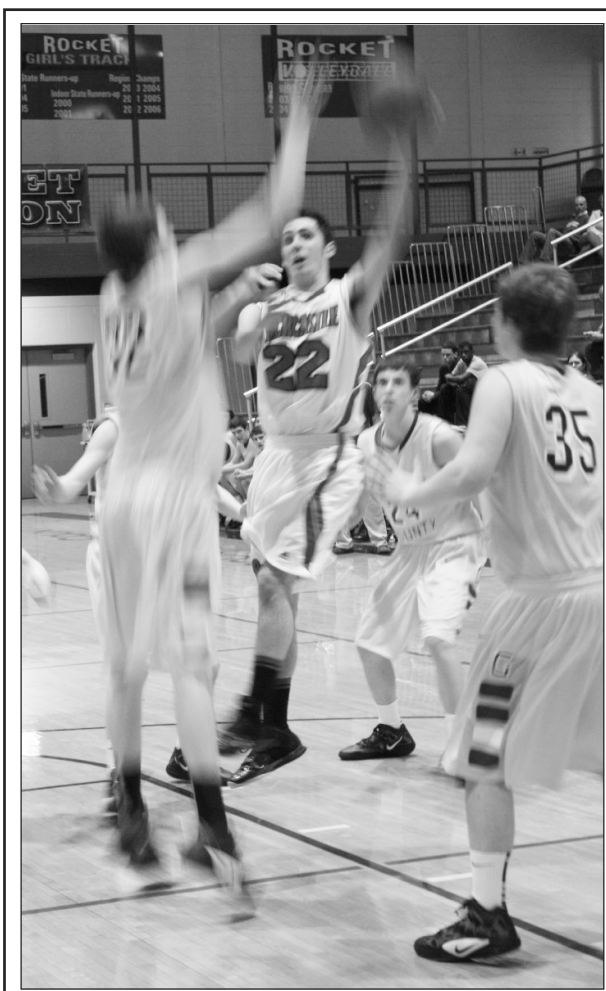

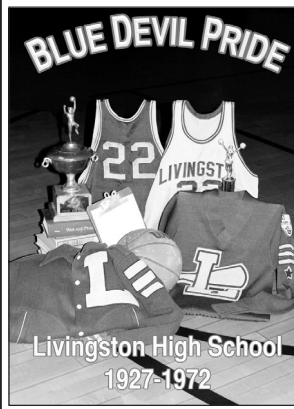

Mamaw's Kitchen

BUTTERSCOTCH TRIFLE

One of the holiday desserts Aunt Nita made was a butterscotch trifle. She also made a lemon one and a chocolate one, but the butterscotch one was my favorite. She must have cooked all day just making those three desserts. I could not imagine she had the time to cook anything else, but she always did. Then I found out her secret! I had to sit around the kitchen most of the morning waiting for her to prepare the trifle. I was beginning to be afraid she wasn't going to fix the dish. Then she started making the instant puddings and tearing the store bought angel food cake into small pieces. It was so simple.

2 boxes (3.4 ounces each) instant butterscotch pudding and pie filling
4 cups cold milk
1 store-bought angel food cake (already prepared and baked)

Break cake up into bite-sized pieces or slice into 1/4-inch pieces. Prepare pudding according to package instructions. Starting with the cake, layer the cake and pudding in a glass serving dish. End with layer of pudding. If you have more cake

than pudding, place cake along sides of bowl or crumble into smaller pieces and sprinkle over top layer of pudding. Let chill for about an hour so the pudding can soak into some of the cake.

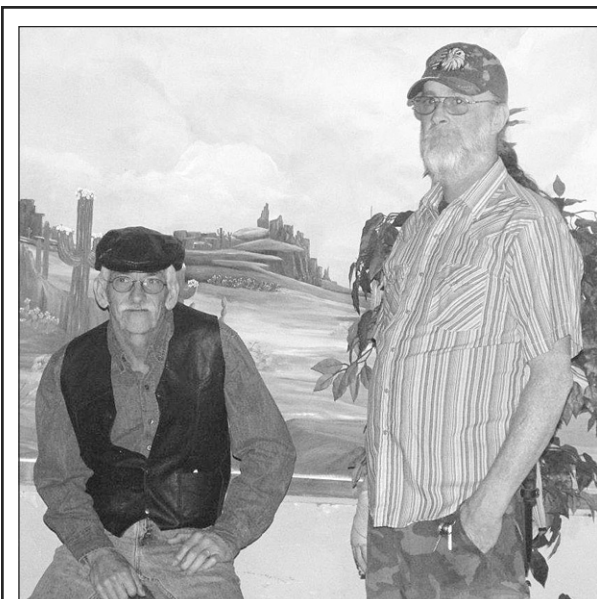
STRAWBERRY CHEESECAKE TRIFLE

1 box (8 ounce) cream cheese, softened
1 cups sour cream
1/2 cup cold milk
1 box (3.4 ounce) instant vanilla pudding mix
1 tub (12 ounce) frozen whipped topping, thawed
1 and 1/2 cups crushed butter-flavored crackers
1/4 cup melted butter
2 can (21 ounces each) strawberry pie filling
In a large mixing bowl, beat cream cheese until smooth. Beat in sour cream; mix well.

In a small mixing bowl, beat milk and pudding mix on low speed for 2 minutes. Stir into cream cheese mixture. Fold in whipped topping.

In a small bowl, combine crackers and butter.

In a 2-to-3-quart clear glass bowl, layer half of the cream cheese mixture, crumbs, and pie filling. Repeat layers. Refrigerate until serving.

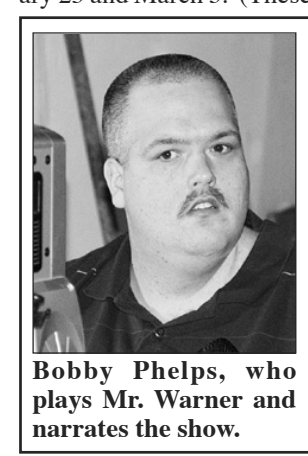

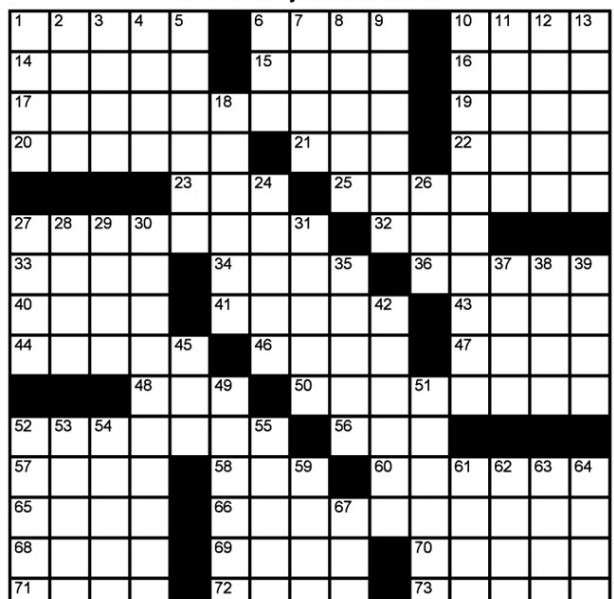

Thinking About Cleaning Your Carpet!

Some things to think about...

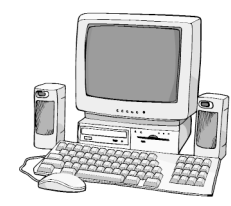

Frankfort Report...

The Senate passed several bills this week. Of these bills, three education bills are of particular importance.



Many students feel bored with the pace of high school during their senior year. Senate Bill 86, passed with bipartisan support, helps focus our students on the higher challenges required of them. It provides an early graduation option to high school students who meet course requirements, grade point average, and college readiness standards. A student who completes an early graduation program will receive an "Early Graduation Scholarship Certificate" with the ap-

proximate value of 24 credit hours at KCTCS, and may be utilized at any 2 year or 4 year SACS accredited postsecondary institution in Kentucky.

Conversely, our children who are intellectually and/or developmentally challenged also work hard in their way to reach certain academic standards. Senate Bill 43 recognizes the course work of these students by providing an alternative diploma. These special children who continue their studies at the high school level are dedicated young people who should take pride in their achievements.

As many of us with children have experienced, schools are closed during elections because some schools are also used as places where people can

vote. But what happens if there is no polling place there? Senate Bill 21 permits school districts where no schools are used as a polling place to adjust their calendar to keep schools open during a regular, special, or primary election. It would also allow a district to schedule election days as instructional or make-up days. This is a more efficient use of space and allows for greater continuity in our children's education.

Finally, the Right to Life Rally was on Wednesday. As usual, the Capitol Rotunda was packed with families and single people; all of them concerned folk. The pro-life platform is one I have championed since the beginning. I had the honor of speaking to the crowd about my dedication to the cause. I spoke about the perseverance and efforts of the activists. They are an inspiration to us in the Legislature. This year, as in years past, the Senate will vote through a bill to direct a doctor to have a face-to-face meeting with the woman who is considering an abortion. Right now, these "meetings" are sometimes done through a recorded phone message which is disrespectful to the woman. As with any medical procedure, a patient deserves to have the opportunity to get information directly from a medical professional and have the opportunity to ask questions. I will write more about this bill and other pro-life bills that will be introduced at a later date.

Save energy and save money. According to the United States Department of Energy, 46% of your utility bill goes for heating and cooling your home. As we prepare for colder weather, there are a few easy steps you can take to save money on your winter energy bills. To cut your energy use for heating and cooling set your thermostat as high as it comfortable in the summer and as low as it comfortable in the winter. You may also want to consider a programmable thermostat. A programmable thermostat allows you to automatically set your thermostat to turn up and down the heat or air when you are not home. By turning back the temperature during the day while you are at work, the Department of Energy estimates a 10% savings in your utility bills.

Proper maintenance is also a key to keep your heating and cooling system running efficiently. Don't forget to clean or replace filters on furnaces once a month, you may want to check your filters more often if you have pets at home. Make sure air-registers are not blocked by furniture, carpeting, or drapes. Finally, do not underestimate the value of natural sunlight, during cold weather, keep the window coverings on south facing windows open during the day to allow the sunlight to warm the house, but remember to close drapes and shades in the evening. For long term savings consider energy-efficient products when you buy new heating and cooling equipment. Home appliances with the Energy Star label meet the US Department of Energy's efficiency guidelines and will add up to savings in long-term.
