## Rockcastle Grand Jury indicts five

Five indictments were handed down by a Rockcastle Grand Jury on Friday, Feb. 10th to four residents of Mt. Vernon and one from Somerset.

Three were indicted on several charges in connection with the death of Jackie M. Bullock in December of 2011.

Indicted were: Gary Lee Kirby, 19 and Bobby Wayne Peters, 34, both of Mt. Vernon and Jessica Hailey Robinson, 20, of Somerset. All three were indicted for murder in the death of Bullock; first-degree robbery, in

the course of committing theft from Bullock and of manufacture of methamphetamine while in possession of a firearm.

Robinson was also indicted on the offense of second-degree persistent felony. Her probation was revoked and she is now serving a two year sentence on a prior drug charge while awaiting trial on the charges named in the indictment.

Kirby and Peters remain in jail on a \$500,000 cash property bond.

## Rockcastle stays in 5th Congressional District

State lawmakers approved a congressional redistricting plan for Kentucky on Friday, Feb. 10th which leaves Rockcastle, and all of Pulaski County, in the 5th Congressional District. The House voted 58-26 for the plan, shortly after the Senate passed it 29-7. The heavily-debated measure was immediately signed into law by Gov. Steve Beshear.

The plan could help incumbent Republican congressmen, including U.S. Hal Rogers. He would keep some key counties that he wanted in the 5th District that he has represented for more than 30 years.

The first redistricting plan had Rockcastle, and about half of Pulaski County, being moved to the 2nd District. This drew a storm of protest from UNITE and Rogers' Scholars supporters in the form of a petition drive which was presented to Frankfort lawmakers.

A population summary of the districts shows that the populations of the congressional districts are unequal. The ideal population for each district is 723,228. The largely rural 5th District has 50,000 fewer residents than it should while Central Kentucky's more urban 6th District has 35,000 more people than ideal.

Meanwhile, a court battle is still raging over new district lines for the state legislature.

The Legislative Research Commission has officially filed an intent to appeal a judge's ruling that found newly-drawn legislative districts to be unconstitutional.

Franklin County Circuit Judge Phillip Shepherd ordered the Secretary of State not to recognize newly-drawn legislative districts. That move forced several lawmakers, who are up for

## Livingston preparing to become a "Trail Town"

The city of Livingston is looking to officially become one of the first Trail Towns in Kentucky.

The Trail Town program was created by the Kentucky Office of Tourism for towns along the Shelton Trace and Daniel Boone National Forest in order to increase tourism and economic development for each town in the area.

Livingston was one of the first of four towns in Kentucky to be selected as a possible Trail Town by the Tourism Office.

To become a Trail Town, communities must complete an application and have trails in place that begin and end in town.

The city of Livingston and the Rockcastle County Development Board formed a revitalization committee that meets at least once a week to facilitate community projects. The Revitalization Committee is already in the process of creating numerous hiking, horseback riding and mountain bike riding trails.

In order to accommodate all the visiting tourists, the Revitalization Committee is planning many new projects in 2012.

J.C. Griffin, Livingston Mayor, was successful in getting a transportation grant that will be used for new sidewalks and street lights along Main Street. Griffin said the city hopes to get started on the project this spring.

The City of Livingston also recently received an

Appalachian Region Commission (ARC) grant. Many projects are underway through funding from the grant, including a new monument and water fountain.

The monument will be placed in Livingston's Memorial Park. It will commemorate three early pioneer trails, which all played a part in the success and founding of Livingston.

The first trail is Skaggs Trace, which was made by longhunters in the early 1700s. The second trail is Boone's Trace, which was paved by famous Kentuckian, Daniel Boone, as he led settlers through the area to Fort Boonesborough.

The last trail is the renowned "Wilderness Road" which goes through Livingston. The Wilderness Road got its popularity by being the first all-weather wagon trail road. The road

was upgraded as a result of Kentucky's first Governor, Isaac Shelby, requiring an accessible wagon trail road for safer travel for incoming settlers.

Across from Memorial Park, a two layered fountain is being built by stone ma-

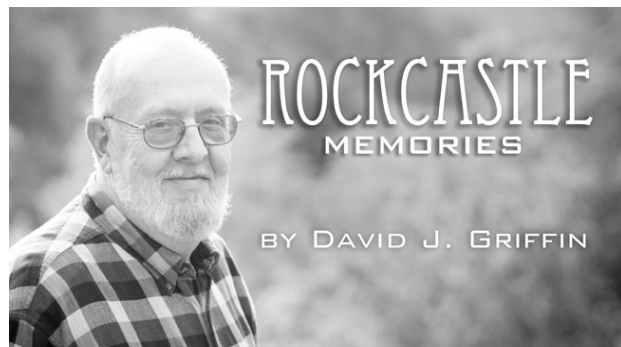

**1968 Pontiac Grand Prix**  
I was traveling from Stanton to Richmond on the back roads through Estill County a few weeks ago. Just outside of Irvine, I rounded a curve and saw an Alpine Blue Metallic, 1968 Pontiac Grand Prix sitting in the front yard of a farmhouse. Upon seeing it, I immediately pulled off the road in order to really take in the beauty of this vintage automobile. More than 43 years ago, I had ordered one just like it when I was teaching at Campbellsville High School (CHS) in Taylor County.



My first new car had been a 1963 Chevrolet Impala Super Sport which I purchased when I was a freshman in college at the University of Kentucky. That "ride" had been one of my favorite cars, and I had babied it for five years. When I took it to the dealership at Beard Pontiac/Oldsmobile, the owner completed his appraisal of my Chevy saying, "I have never seen a five-year-old car that has been treated as well as this vehicle." Following a few hours of deliberation, I eventually placed an order for the 1968 Grand Prix. I waited, albeit impatiently, for weeks before my new car arrived. At long last, Mr. Beard called and told me to come pick up my new Pontiac. My new automobile had a 400-cubic-inch, 350-horsepower engine with a four-barrel carburetor, position rear end, and a four-speed transmission, with the shifting lever in the floor. I had specifically ordered leather seats but had opted for a bench seat instead of bucket seats. (I had already had my fill of bucket seats while dating in my '63 Super Sport!) It was music to my ears to hear Mr. Beard called it "a very capable beast."

In addition to the powertrain and leather interior, it had fender skirts, AM/FM radio with a reverberation unit built into the dash, chrome wheel covers, pencil-thin whitewall tires, and dual exhausts. When I slid in behind the wheel and drove my new 350-horsepower Grand Prix down Lebanon Avenue in Campbellsville, I could not believe how powerful it was. People along the street were noticeably gazing at my new ride. I was ecstatic. I loved how General Motors had designed the front end of the car. That Grand Prix had a new front bumper and a massive, pointed nose dividing a split, cross-hatched grill. It had "hid-

den" headlamps and impressive parking lights at the bottom corners of the gravel pan under the front bumper. There was just such a "sleek" look to it, and I ate up the attention it received. That weekend I picked up three of my coaching friends, loaded my trunk with our golf clubs, and headed to Lake Cumberland State Resort Park to try our skills with its par-three golf course. The guys were quite impressed with my new ride and were filled with questions about the engine and its obvious power. I loved my new Pontiac. The following Monday when I entered the parking lot at CHS, the students -- especially the boys of course -- gathered around my new, polished-to-a-shine, metallic blue car and bombarded me with questions. I was only 22 at the time, and their attention made me feel proud. Every time the high school staff had to attend an educational conference, I was asked to drive one of the cars. That was alright with me because I loved to drive my new automobile. That next summer I was offered a teaching/coaching position at Mt. Sterling High School. The faculty and staff at my new job loved my new car as much as I did; however, I soon traded it for a 1969 Pontiac LeMans convertible. As you can see, I was young and immature when it came to trading cars. (Some would say that I still am.)

New cars have always been a temptation for me, and I guess they probably always will. That new car smell is absolutely intoxicating as far as I am concerned. I have wondered if that Estill County Gran Prix was the one that I traded in Mt. Sterling. If I ever see it again, I plan to ask about its origin. That would be so cool if it was originally mine. Last Friday morning, February 17th, I saw, for the first time in over 25 years, a snowy owl and it was here on Charlie Brown Road. I had heard it a couple of times earlier in the week in the woods across the way, snapping its beak and more or less barking, late in the day, like a curious little dog in the top of one of the trees. Letting the squirrels know who was boss for the time being, I suppose. When we lived on Harmon's Lick, here in Garrard County, back in the early 80's, a snowy owl more or less spent the winter with us in 85-86 and dined, far more often than we wanted, on some our kids' bantam chickens that had the run of the place. At first an exciting novelty, the big bird became a nuisance but it went away about this time of year. I figure this one is simply passing through and taking a break on its journey to northern Canada and maybe taking a gander at next door neighbor, Katie Rollins', laying hens. Not a wise thing to do if you are predator and want to keep on living.

I'd been looking for it for a couple of days. Unlike Kentucky native owls, the snowy is not nocturnal. You may chance upon them anytime of day but they are somewhat skittish when it comes to people. But the back 40 behind my place probably extends more than a mile deep and almost as wide without human habitation. Pasture land with cattle year round that make plops from their bowels all over the farm and when they dry and harden, said plops become ready-made, rain-re-

pellant homes, stocked with a generous food supply and warmth for field mice who come out, from time to time, to get a salad from the green fescue that sprouts year round and stays fresh all winter. Hawks, red tails and cooper's, and my favorite, most beautiful, killer bird of all time, American Kestrels, light on fence posts and tree limbs for a mile or so around our place and I am happy for them and feel no pity for the mice. I just love a glimpse at what is going on out back, and marvel before I feed the jays and cardinals and all their little buddies in the front yard. But sighting a snowy owl is way beyond extra. I make a habit of looking at the back 40 through our kitchen window almost every morning and staring for a few minutes while the coffee brews. We also have 4 bird houses less than ten feet behind the house and I am always interested in seeing who is going to nest first. Anyway, just as I glanced out the window, I saw it gliding across the pasture, no more than ten feet off the ground and I instantly recognized it as a snowy. My heartbeat probably doubled.

The owl made a wide, graceful swoop across the pasture then sailed past our house and I stumbled to the front door just in time to see it disappear into the woods across the way. I placed binoculars on the front porch and beside the kitchen window and watched all weekend but I never saw the giant bird again. I figure it was on its way to northern

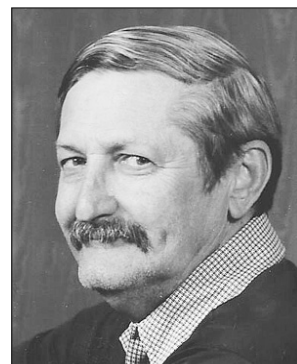

## Wet/dry debate should remain civil...

Dear Editor,  
As the issue of the whether Rockcastle County should sell alcohol is debated among individuals, it is my hope that these debates will remain civil. The

outcome will be decided at the polls on April 3, 2012 and we will all have to live together following the decision that is made by the citizens of the county. The privilege of allowing our citizens the right to vote is something I feel strongly about, as I demonstrated by my service to this country, serving multiple combat deployments and earning a Purple Heart.

There are some statements made in last week's Letter to the Editor that I would like to address. First, there was nothing deceitful in the way the Local Option Petition was brought to the people of Rockcastle County. A petition is allowed to circulate for six months before it is certified by the County Clerk. The petition was submitted to the Clerk's office and stamped on the back with the date of September 01, 2011, two months prior to the November elections. The number of required signatures was met based on KRS 242.020 (1); "equal to twenty-five (25%) of the votes cast in the territory of the last preceding general election."

Second, the date set for the Local Option Election was addressed in the Mt. Vernon Signal article on February 9, 2012. The date has changed to April 3, 2012 since that article due to the Secretary of State's office requesting that the election be held on a Tuesday. The date also meets criteria by KRS 242.030 (2); "The local option election shall be held not earlier than sixty (60) nor later than ninety (90) days after the date the petition is filed with the county clerk." It should also be noted that the election for Local Options may not be held in conjunction with General Elections as explained in KRS 242.030 (3) "The local option shall not be held on the same day that a primary or general election is held in the territory or any part of the territory, nor within thirty (30) days next preceding or following a regular political election."

The facts are important in this debate and should be delivered with all of the data, so, informed decisions can be made. Reports filed by Alcohol Beverage Control (ABC) Officers have shown that DUIs and public

intoxication arrests decreased in communities that have voted YES to the sale of alcohol. Cities like Radcliff and Danville can attest to these facts.

The economic effects are vitally important in this issue and can be witnessed in Danville, Lancaster, and countless other communities that have taken this step. There is a reality that new businesses will be created and these new businesses will create new jobs, new capital investment, new tax revenues, and new momentum for the county. We will have more to offer to tourists, visitors, and business travelers. And, local dollars will be spent locally to benefit our economy, rather than lost to neighboring communities.

I want the citizens of Rockcastle County to take the time to truly examine the benefits that will come with voting YES on April 3, 2010. There is still time to register to vote giving you an opportunity to stop your vote count. Let by the county clerk's office and pick up a voter registration card by March 5, 2012.

## A look at facts about the sale of alcohol...

Dear Editor,

I understand that the issue of Mount Vernon voting on going wet is on the cards again and the arguments that I am hearing for remaining a dry county got me to investigate a little deeper and I would like to share my findings with the readers of the *Signal*. There is no smoke and mirrors in my findings and the sources can easily be found online.

First I would like to address the issue of DWI's. One of the arguments that I am hearing is that if we go moist or wet that DWI's will rise. On kcdb.com, the local news channel for Lubbock Texas, they investigated this claim between wet and dry counties and found that there was no real basis for this argument and the numbers swung both ways.

Secondly, I'll address the issue of poverty. On breahittonline.com, it lists Owsley, Lee and Breathitt counties as the three poorest counties in the United States with Magoffin County at number five meaning that four out of five poorest counties in the United States are right here in Kentucky and all four of those counties are dry. Thirdly, the issue of domestic violence being

caused by alcohol. It is easy to jump to the conclusion that alcohol does trigger domestic violence, but there is actually no evidence to indicate this. The general consensus that I have found on this issue is that those that abuse alcohol are more likely to be abusive to their spouse and family. The domestic violence is not the cause of the alcohol, but rather that addiction in one form or another is a part of abusive psychology.

# Ky. gets No Child Left Behind waiver

President Barack Obama will waive central provisions of the No Child Left Behind federal education law for 10 state, including Kentucky, that have embraced his educational agenda and promised to raise standards and to improve accountability and teacher effectiveness, the White House announced last week.

Since 2001, Kentucky has been using a two-tiered approach for accountability to meet state and federal performance requirements. Now that the federal government has given flexibility from the mandates of the No Child Left Behind Act, Kentucky has developed a new system of accountability. Senate Bill 1 called for a system that would provide a single means of accountability to meet both state and federal requirements.

toward the ultimate goal of preparing our students for college and the work force," Pensol said.

The first release of data related to the new accountability model will occur in late summer/early fall 2012. For the 2011-12 school year, schools and districts will be gauged on test scores, achievement gap reduction, student academic growth, college/career readiness percentages and graduation rates. Schools and districts will have annual measurable objectives to reach in all of these areas.

In addition to Kentucky, the waivers were given to Colorado, Florida, Georgia, Indiana, Massachusetts, Minnesota, Oklahoma, New Jersey and Tennessee. New Mexico was the only state that applied for and did not receive a waiver, but it is working with administrative officials to secure approval, the White House said.

Twenty-eight other states, as well as the District of Columbia and Puerto Rico, have signaled that they plan to seek waivers.

In a statement, the White House press office said Obama believes that No Child Left Behind "is driving the wrong behaviors, from teaching to the test to federally determined, one-size-fits-all interventions" and will call on Congress to join his efforts to fix the law. No Child Left Behind was passed a decade ago with bipartisan support and has been up for renewal since 2007.

re-election this year, to file candidacy papers in districts that had been in place for the past decade.

Rockcastle had been placed in a district with all of Casey County and a very narrow portion in the north end of Pulaski Co. which apparently fulfilled the law that counties in a district must be contiguous by linking Rockcastle and Casey.

However, now that districts will revert to their original make-up, Rockcastle is back with Lincoln County and four candidates, all Republicans, two in each county, have filed as candidates for the seat created by the retirement of incumbent Danny Ford (R-Mt. Vernon).

## Prescription Bill gets by committee

The Senate Judiciary Committee narrowly approved a bill last Thursday that would require a prescription for most cold medicines containing pseudoephedrine. The vote was 6-5.

Kentuckians still could purchase gel caps that contain pseudoephedrine - a key ingredient needed to make meth - without a prescription. It is more difficult to make meth with pseudoephedrine from a gel cap.

Proponents of the bill think it will cut the burgeoning number of meth labs in the state. State Police said Kentucky recorded nearly 1,200 meth-lab incidents last year - an increase of more than 100 from the 1,080 in 2010.

Makers of remedies containing pseudoephedrine strongly oppose requiring a prescription for the products, which reportedly generate billions in sales annually in the United States.

The sponsor of Senate Bill 50, Majority Leader Robert Stivers, R-Manchester, said he didn't know the bill's chances in the full Senate. The legislation died in the Senate last year.

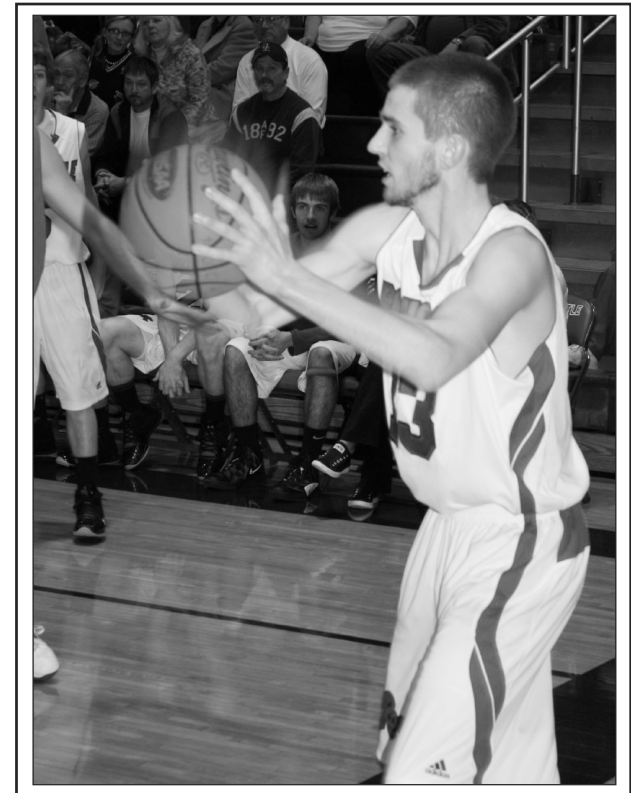

# Local educators attend regional training session

It is no secret that school systems in Southern and Eastern Kentucky continue to fight rising high school dropout rates.

But educators now have a new weapon at their disposal in that battle that can encourage more students to stay in school and use education as a stepping stone to pursue successful career goals.

Rockcastle County educators Janice Miller, Rebecca Isaacs, and Jessie Mahaffey were introduced to the "Stay in School Toolkit" dropout prevention video and discussion guide just released by Forward in the Fifth and The Center for Rural Development at a regional training session on Tuesday, Feb. 7, at The Center in Somerset.

During the session, Laura Kamperman, community education specialist for Forward in the Fifth, presented the video project and shared some of the real-life stories recorded by individuals in the video.

The "Stay in School Toolkit" contains personal testimonies from eight individuals from rural Appalachia and how choices they made positively—and in

some cases negatively—impacted their education and future.

A discussion guide also is included with the resource that encourages students to freely discuss messages in the video sessions and how those situations apply to their lives.

"It is critical to provide our young people with relevant examples of the value an education has today," said Jim Tackett, executive director of Forward in the Fifth. "As educators and community leaders alike, we must understand the multiple issues our students deal with in pursuit of a high school education."

Forward in the Fifth, a nonprofit organization and affiliate of The Center, was created by U.S. Congressman Harold "Hal" Rogers (KY-05) and other leaders in 1986 to help advance educational attainment levels in Southern and Eastern Kentucky.

The "Stay in School Toolkit" is being released across the region and beyond, in conjunction with training, to assist in discussion and problem-solving of boosting high school gradu-

ation rates.

Other upcoming training sessions are planned for:

- Feb. 16 at The Forum at The Harold Rogers Center (in front of Hazard High School in Hazard)

- Feb. 24, University of the Cumberlands, Williamsburg

- Feb. 28, Mountain Arts Center, Prestonsburg

- March 20, Morehead State University, Morehead

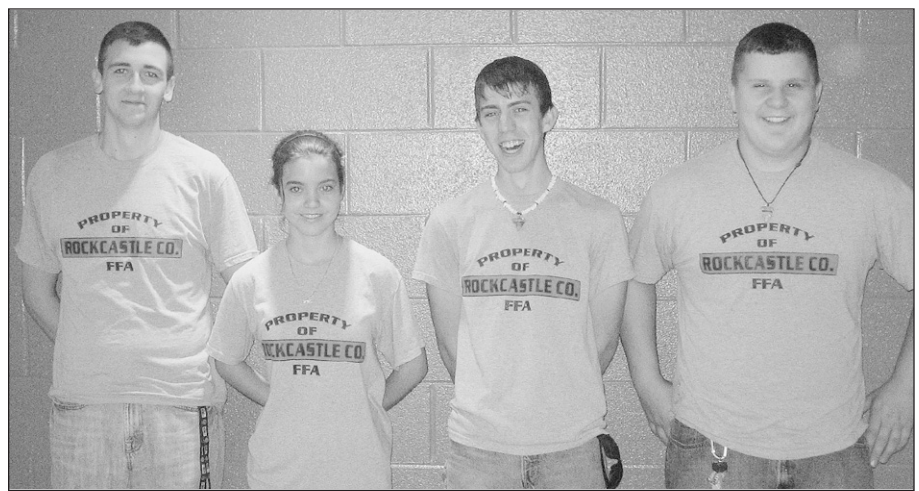

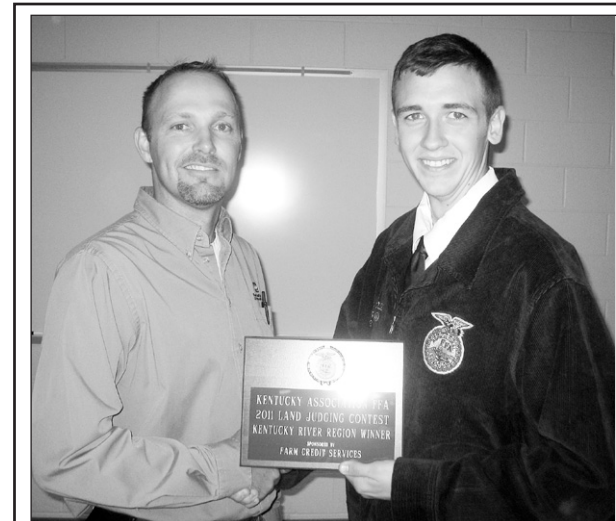
