Court okays long-term financing for Plasticware building

County Judge/Executive Buzz Carloftis was given the authority to put in place short-term financing for the former Plasticware building at the regular meeting of the fiscal court last Tuesday. The authority was given in an effort to speed up purchase of the building until long-term financing could be obtained.

However, after conversations with officials of the Department of Local Government (DOLG), Carloftis was told by the officials that the county would not be able to procure short term financing of \$3,000,000 because, disregarding obtaining long-term financing, the county did not have available county funds to repay the short-term loan by June 30th of this year.

The DLG has expedited acquiring of the long-term financing by scheduling a public hearing on Thursday, March 29th at 9 a.m., which will be followed by a special meeting of the fiscal court at 10:30 a.m. on the same date, primarily for a second reading of the ordinance authorizing the lease of the needed funds.

This was all decided at a special meeting of the court, held on Monday of this week when the first reading of the ordinance was held.

It is expected that process, allowing the county to take ownership of the building, will be completed by April 2nd.

"This project is a major priority for the Department of Local Government," Carloftis told the magistrates. "It's a big deal with them."

The variable interest rate on the long term financing is expected to come in at 4.6% Carloftis told the magistrates. However, later in the week, the judge/executive told the *Signal* that, after talking further with KACo, who is arranging the financing, the rate will actually be 4.5%.

The loan will be set up at that rate for a 10 year period but payments will be amortized over 20 years. Of course, the court will have the option of switching to a fixed rate at anytime. The fixed rate is higher (4.9%) and there is an

City will take over operation of Lake Linville boat dock

At the regular meeting of the Mt. Vernon City Council Monday night, council members discussed at length what action should be taken concerning the

boat dock at Lake Linville. Tommy Mullins, who has leased the facility from the city for a number of years, had expressed an interest in continuing the yearly lease. His current

lease expired January 1st of this year.

Mayor Mike Bryant told the council that three options were available to them: renewing Mullins' lease, advertising to rebid the lease or direct employment which would involve the city hiring personnel to operate the dock.

Bryant said there had been "some complaints of the boat dock area not being taken care of" and that

Mullins was delinquent somewhat on his lease payments, although he had made a payment recently.

Council member Adam Bales expressed the thought that the city should hire someone to operate the dock. "We can try running it for a year and if it doesn't work out we can lease it again," Bales said. Bryant added that the city had been providing most of the maintenance of the area anyway.

Adams put this in the form of a motion and it passed 3-1 with council member Wayne Bullock abstaining saying he and Tommy "were good friends and I don't want to vote on it."

More than likely, Mt. Vernon Water Dept's. customers will see the 36% rate increase on their April bill, according to Torsha Lear, water department clerk, if she receives the necessary documentation in time.

This change ties into the audit report for the city, ending June 30, 2011, which was presented at Monday night's meeting by John

I often hear people who have loved ones pass away say "I wish I would have spent more time with them."

But I can safely say I have no regrets as I have hun-

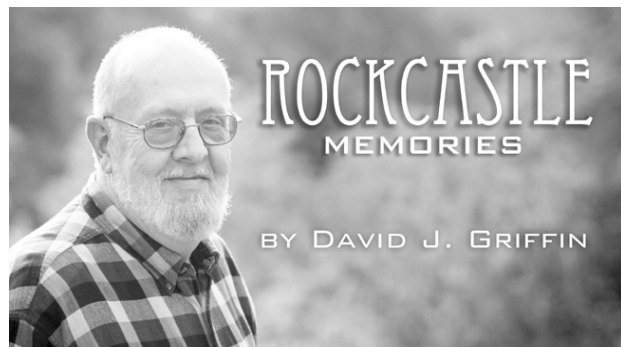
dreeds of precious memories of times my granny and I spent together.

Dime Store Soldiers

In the days of my youth, war was an on-going concern to my family and to my small-town community. One of the primary forms of entertainment for young boys was playing "army." It was a backdrop that was conducive to both playing with other kids and to playing alone, so it was a rather common form of recreation. Dime-store soldiers were the only possessions necessary for a lone boy to conduct his battles.

Of course, the reason that war was on a boy's mind was caused by all of the focus on the Korean War, which began when I was a mere six years of age. Officially, the conflict began on June 25, 1950, when the Cold War suddenly became

hot, bloody and costly. (The government didn't recognize it was a real war - it was called a "police action.") The Republics of North and South Korea were pitted against one another, with the South supported by the U.S. and the North by China. Communist versus capitalist regimes. The 38th parallel became a political border between the two Korean states, and, when the war ended, the agreement created a demilitarized zone, a 2.5 mile-wide buffer zone between the two. Minor outbreaks continued over the years.

Because of the frequency of radio newscasts and the articles in the Courier-Journal, even as a child I was constantly reminded of the conflict being fought on the other side of my world. Many Rockcastle men and even some of our family members served in this dreadful military encounter.

One of our closest family friends was Clinton Helton. His family lived across old US 25 from our small hillside farm. Once when Clinton was home on leave, he gave me some of his older military hats and belts. I thought it was so awesome that I had some real military equipment. I added my own guns and holsters and became a soldier on my own.

In addition to playing "army" with many of my friends, I began to collect plastic army men, which were posed in a variety of military positions. Some were firing rifles, others were tossing grenades, some had bazookas resting on their shoulders, and a few held handguns. Each and every time my family visited

Last week's column concluded with my being deposited in room 544 of the neurological ward at St. Joseph's Hospital in Lexington several hours after suffering a stroke on Friday morning March 9th. I was rapidly attended by a neurologist and his entourage. In short order it was determined that I'd had a stroke. This was not news to me I'd had it figured out for hours.

Loretta and I were advised that MRI's and other test were soon to be forthcoming. In the meantime, a bevy of nurses and technicians patted my chest and torso with little electronic connectors that were subsequently wired into a little box that wirelessly broadcast all sorts of information into a conglomeration of monitoring devices.

Meanwhile, lunchtime had come and gone. Of course, I had missed breakfast and I figured the fact that I was hungry had to be a good sign of something. But, sign or no sign, they told me I couldn't have food until the MRI's were done. So I lay there while staffers incessantly came and went checking such things as blood pressure, blood sugar, temperature, etc.

Finally, at around 4:30 p.m. a fellow came into the room, rolled me onto yet another gurney and advised

that we were headed downstairs to wherever they did MRI's. Upon arrival I was rolled onto what I believe was the eighth bed I had occupied in about as many hours.

Two very nice, personable women began strapping me into the narrow, mattress-covered platform that would carry me into and out of the MRI machine. They plugged my ears and placed on a thick mask and helmet that completely engulfed my head. Finally, they gave me a little balloon-like thing to squeeze in case I needed them.

Suffice to say, that upon entering the chamber I felt an immediate "need" for them because I suddenly had the sensation that I was in a submarine being bombarded by torpedoes and depth charges. Alarm bells were ringing loudly combined with honks, whistles, bangs and thuds. I was, in a word, horrified! Still, I stayed in enough control to refrain from squeezing the balloon until I sensed that the carriage had stopped. I had been in the thing for about 25 minutes but it felt like many hours. That's when I began squeezing the balloon for all that I was worth.

I know that I was yelling help while the nurses hast-

Alcohol, or No Alcohol, That Is The Question...

The ugly question has reared its head here in Rockcastle County. It is ugly because it causes so much division, as much if not more than the other ugly question...zoning. Someone called my house the other day to inquire as to how I was going to vote in the upcoming special election. I thought it rather intrusive and started to tell them it was none of their business but rather, I answered the question. This started me on a quest to find out more about the subject of alcohol and Prohibition.

It states that Prohibition in the United States was a national ban on the sale, manufacture, and transportation of alcohol that was in place from 1919 until 1933. 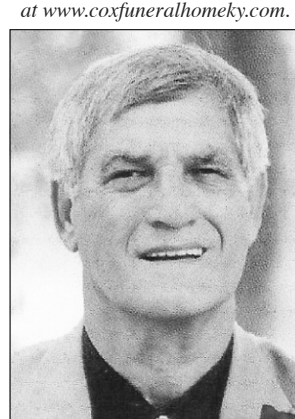
Faye Parrett Elam

Urgent-Storm Damage

The USDA Farm Service Agency is requesting all producers who suffered severe farm or farm related damage from the storm on Friday, March 2, 2012, to please contact us at 606-256-2525. The Farm Service Agency is only collecting damage information at this time. The damage must be of such magnitude that it would be too costly for the producer to rehabilitate without Federal assistance.

An established minimum loss of \$2,500 for non limited resource producers and a \$250 minimum loss for limited resource producers is required."

Conservation Reserve Program Signup

The Kentucky Farm Service Agency has announced that the Conservation Reserve Program (CRP) general signup will begin March 12 and will end April 6.

Land that is not currently enrolled in CRP can be offered during signup if all eligibility requirements are met. Also, CRP participants with contracts expiring this fall can make new contract offers during the signup period. Contracts awarded during this general signup period will become effective Oct. 1.

CRP is probably one of FSA's most recognizable programs. The various CRP practices help improve water and air quality, increase wildlife habitat and prevent soil erosion, which benefits us all. Landowners enrolled in CRP receive annual payments and cost-share assistance to establish long-term, resourceconserving covers on eligible farmland. Contract duration is from 10 to 15 years.

All CRP offers are evaluated and ranked using an Environmental Benefits Index that indicates the environmental benefits of enrolling the land in CRP. The environmental factors that make up the EBI are wildlife, water, soil, air, enduring benefits and cost. CRP is a voluntary program that helps agricultural producers use environmentally sensitive land for conservation benefits.

In addition to this general CRP signup, the continuous CRP signup remains ongoing. In the continuous CRP signup, producers can enroll the most environmentally sensitive land.

Crop Acreage Reporting

To remain eligible for disaster assistance; producers participating in the Non-Insured Crop Disaster Assistance Program (NAP) are required to report acreage for which NAP assistance may be paid. The timeline for reporting such crops is as follows:

The earlier of:

The established acreage reporting date which is July 15th for all crops except small grains and value loss crops 15 calendar days before the onset of harvest or grazing of the specific crop acreage being reported.

As a reminder, the final date for reporting of hay and/or pasture land is April 1st. For crops that were intended to be planted and a NAP policy was purchased but was not planted, a zero acreage report is required.

Committee meeting

The next Rockcastle County Farm Service Committee (COC) will hold its monthly meeting Thursday, April 5, 2012 beginning at 8:00 a.m. The meeting will be held at the FSA office.

COC members are vital to the day-to-day operations of FSA. The COC members help FSA at the local level by deciding the kind of program their county will have and how they will operate. FSA committees operate within official regulations designed to carry out Federal laws and applying their judgment and knowledge to make decisions.

Woolworths in downtown Lexington, I used my allowance to purchase more army men. After several months, I had a box of "dime store treasures" that enabled me to pose them just as I thought it would be on the warfront in Korea.

There was a small hill near our well in the yard that made a great place to position my plastic soldiers. This hill had it all: grass in which they could hide, holes in the dirt that became caves, and bare spots for driving my army trucks. The area resembled a true-to-life war zone.

On occasion, I would get far away in the yard and toss dirt balls into the war region to simulate bombs. When I returned to the area, many of the plastic soldiers looked as if they had been killed or wounded in the conflict. This was realistic play for a young boy.

When I turned eight years old, my grandfather (Pop) purchased a BB gun for me. I came up with the bright idea to use my BB gun to simulate rockets attacking my plastic soldiers from across the yard. I carefully placed my soldiers as if they were meeting a front in the war zone. Then I would load my BB gun and sit in the yard as far away from the war as I could and then fire on my army men.

Many of the combatants were lost when the rockets began to rain down on the front. Upon closer inspection, some of the toy soldiers were wounded so badly that they had to be buried. Some were injured but could continue to fight for a peaceable end to the conflict.

Now that I am a senior citizen, I am amazed at the forms of pretend play that children of our day came up with. Because we did not have the electronic games that are now available, we had to devise our own forms of entertainment. Some of our ideas came from the comic books that we read in those days. Of course, one

particular comic that I loved was G.I. Joe, which is how I came up with the BB gun idea to simulate rockets.

It is my opinion that the creativity that we developed as children made for a far superior childhood than the "high tech" games that are used by today's young people. I am extremely glad that I was a child of the 50's, that we almost always played outside, and that the only thing that we really needed to entertain ourselves was our own imaginations.

paraphrase.

Some argue that alcohol sales in the county would produce increased revenue. Can they be right? I find it particularly interesting that the Great Depression fell at the height of the Prohibition Era in October of 1929, only ten years into Prohibition.

"The Senate proposed the Eighteenth Amendment in December 18, 1917, having been approved by 36 states (of the then 48 states)...It originated also in part due to the "temporary" Wartime Prohibition Act intended to save grain for the (World War I) war effort. Congress passed the Volstead Act, the popular name for the "National Prohibition Act" over President Woodrow Wilson's veto on October 28, 1919.

On March 22, 1933, President Franklin Roosevelt signed into law an amendment to the Volstead Act known as the Cullen-Harrison Act, allowing the sale of certain kinds of alcoholic beverages. On December 5, 1933, the ratification of the Twenty-first Amendment repealed the Eighteenth Amendment.

Next week, I hope to look further into the history of alcohol and eventually into its history here in the county.

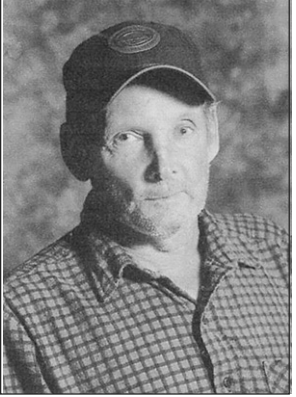

Newspapers w/inserts, magazines, books & catalogs, office paper, junk mail, phone books, plastic bottles & jugs (#1-7) (any size soda and water bottles, laundry detergent jugs, bleach and fabric softener jugs, milk and water jugs, cooking oil bottles and jugs, shampoo bottles, dish liquid and alcohol bottles (please rinse out jugs), metal cans (rinsed), empty aerosol cans, aluminum cans, glass bottles and jars, sheet glass, ceramics, computers, radios, phones, vacuum cleaners, clocks, cameras, camcorders, vcr/dvd players and satellite boxes.
Rechargeable batteries such as those found in: cordless power tools, cellular phones (the whole phone can be recycled), cordless phones, laptop computers, digital cameras, two-way radios, camcorders and remote control toys. If it says rechargeable on it, then it's recyclable!

Frankfort Report...

We are entering the home-stretch of the 2012 General Assembly with the attendant rush of bills as legislators feel the urgency of the dwindling days. The Senate had a very full week with legislation, committee meetings, and we received the budget proposal from the House as well as the state's road plan. Visits from groups ranging from the homeschoolers to the AARP to 4H also came to the capitol to see their legislator and press for their causes.



Let's look at the legislation. Senate Bill 158, the Religious Freedom Act, is a constitutional amendment that will protect religious freedom from an overbearing government. If approved by the House of Representatives and not vetoed by the Governor, Kentuckians will have the opportunity to vote on whether or not the government has the right to infringe on religious beliefs except in a case of a compelling government interest and only then, using the least

burdensome means. Courts would have more ammunition in the cases of, for example, the jailing of Amish who refused to highlight their buggies and people in Bell County who wanted to pray before football games. SB 158 takes us back to a traditional, more reasonable, standard.

When the Governor issues administrative regulations to implement laws, the regulations are reviewed by the Senate through the Administrative Regulations Review Subcommittee. The House has a similar committee. However, the problem with the current system is that even if the committee does not approve the regulation, the Governor can still implement it. Senate Bill 10 makes sure that your duly-elected representative or senator who know and are a part of your communities have a say on what can be very burdensome rules.

As administrative regulations can outlive their usefulness, so also can boards and commissions. Boards and commissions are smaller government entities that the Governor appoints. Many are obviously important such as the Public Service

Commission that regulates utility rates or the Parole Board. There are others, however, that may be holding on – and costing tax-dollars – often because they have such a low profile. A comprehensive look is needed to evaluate what Kentucky can afford to have and what we can afford to do without. Senate Bill 8 sunsets all boards and commissions 180 days after the end of a governor's term. This offers a brand new opportunity every four years to review the value of each board and commission.

Diabetes is one of the leading chronic diseases in Kentucky. While there are many dedicated medical professionals who can assist those with diabetes to manage the disease, there also happens to be those who want to take advantage of the situation. Senate Bill 198 establishes minimal quality standards by directing that diabetes educators be certified. Families confronting the disease have enough to worry about. They should have the peace of mind to know they are receiving correct information from a knowledgeable source.

Finally, Senate Bill 110 invites the community to use our local schools for non-school activities such as book clubs or intramural sports during non-school hours while protecting school district employees from unreasonable lawsuits. It is unfortunate but understandable, that many school districts are nervous about opening their facilities to neighborhood groups. SB 110 will help relieve some of that anxiety while at the same time encouraging community unity and healthy families through artistic, civic, literary and other activities in addition to recreational and sports usage.

Money tips for students

Understand contracts before you sign them

A contract is a written agreement between two or more parties in which an offer is made and accepted. The Kentucky Higher Education Assistance Authority (KHEAA) advises that if you are thinking about signing a contract, make sure you fully understand it first. If you rent an apartment or have your own cell phone plan, you have probably signed a contract. If you have taken out a federal student loan, you entered a contract when you signed your Master Promissory Note.

Since a contract sets out in detail what each party is obligated to do for the other party, you should read each contract thoroughly and ask questions. If one of the parties agrees to make a change in the contract, make sure the change is in writing. Get all of your questions answered before you sign the contract, and keep a copy after you have signed. In some cases, you may want to have an attorney review the contract before you sign it.

Consumer protection laws let you cancel some contracts within three days of signing. Before you sign any contract, find out if you

have that option. If you do not, your options of getting out of the contract are limited.

If someone uses high-pressure tactics to get you to sign a contract, consider that a warning sign and consider walking away from the agreement.

KHEAA is the state agency that administers Kentucky's grant and schol-

arship programs, including the Kentucky Educational Excellence Scholarship (KEES).

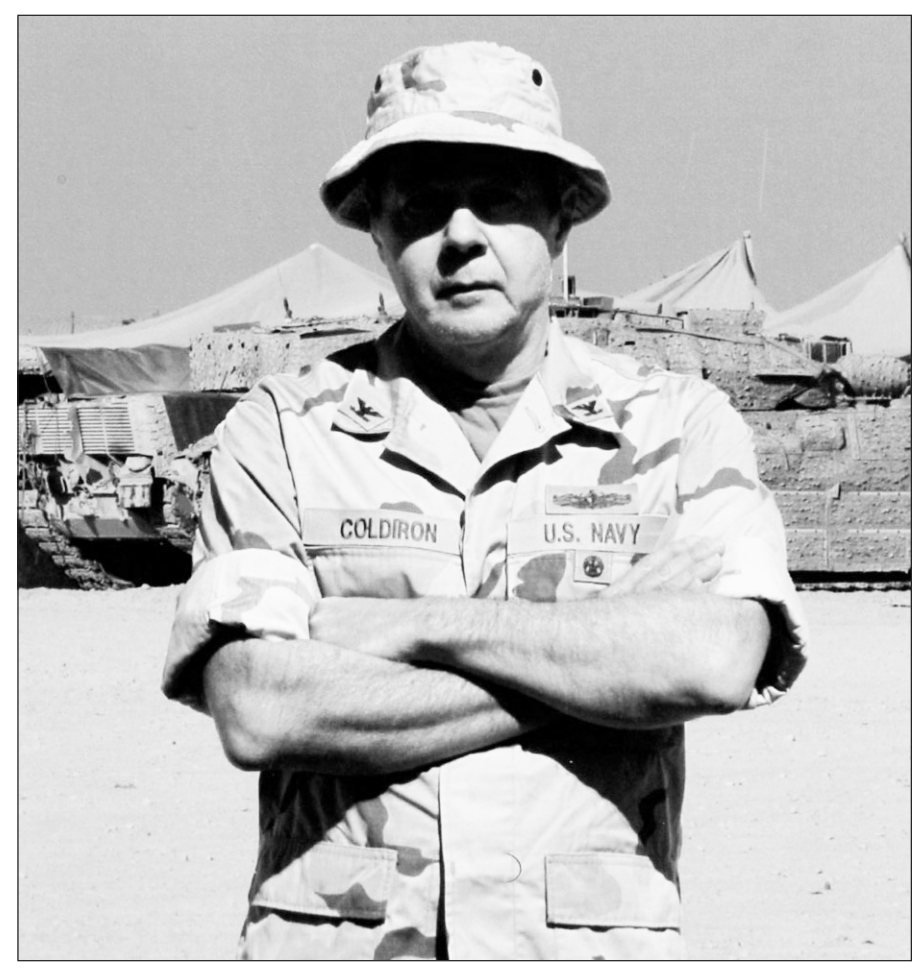

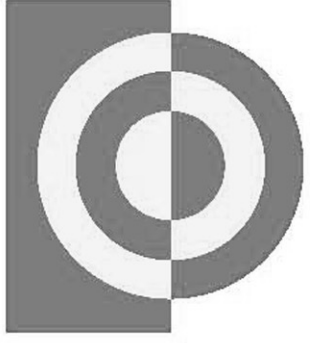

Threat of budget cuts may affect local resource centers

As the threat of subsequent budget cuts increases, so too does the number of Kentucky children that Family Resource and Youth Service Centers across the state work to reach.

The Kentucky Family Resource and Youth Services Centers (FRYSC) were established under the historic 1990 Kentucky Education Reform Act with the mission to help academically at-risk students succeed in school by helping to minimize or eliminate non-cognitive barriers to learning.

Currently, there are 819 Family Resource and Youth Services Centers in 1,160 schools, serving 619,541 students throughout Kentucky.

The needs of Kentucky's families and students continue to grow. The resources that FRYSC have to meet those needs continue to shrink. "Because of recent economic pressures on

the national, state, and local levels, our centers are doing more with fewer resources in their communities and shrinking funds in the FRYSC budgets," said Michael Flynn, President of the Kentucky FRYSC Coalition and coordinator of the Estill County Youth Services Center. "For instance in Fiscal Year (FY) 08 Centers were receiving \$210.00 per free lunch student and currently receive \$177.05 during FY 12." The trend of growing free lunch eligible students has continued. In the past year alone, there are 3,846 more students eligible for free lunch meals.

The accompanying chart shows that FY 12 had an additional reduction of 1.7% reducing the per student allocation to approximately \$177.05. The proposed FY 13 reduction of 4.5% (HB265) will produce even further significant reduction to the per student amount.

"The ability for FRYSC to support families and students is in danger," said Betty Marshall, FRYSC Coalition President-Elect and coordinator of the Hand In Hand Family Resource Center in Bullitt County. "Many of the supports that help students succeed in school will no longer be available."

What is the value of these centers to the Bluegrass state? The Family Resource and Youth Services Centers Coalition of Kentucky invited advisory council members, community partners, parents, grandparents, students,

board of education members, teachers, classified support staff, superintendents, administrators, and many other related stakeholders to participate in the 2012 FRYSCy Coalition Survey to determine the impact of these centers.

There was an overwhelming response with over 16,000 participants. 61.3% of respondents identified themselves as teachers or classified support staff. "It's telling that so many of our survey participants identify themselves as teachers and classified support staff since they are working daily with our centers in the school environment," said Tana Jones, FRYSC Coalition Public Policy and coordinator at the Wingo Family Resource Center in Graves County.

The 2012 survey listed services or referrals provided by Family Resource and Youth Services Centers. The graph below indicates areas that were top priorities for Kentucky's youth and families to succeed according to respondents. It is evident based on this data that the work of FRYSC in the areas of family assistance, graduation/dropout prevention, health/wellness/nutrition, and family crisis intervention are keys in student success.

Survey results indicated that 94.8% of all people surveyed agree and strongly agree the support and protection of FRYSC funding will help strengthen and stabilize students and families in our Commonwealth.

"It's clear that Family Resource and Youth Services Centers are making a difference in the daily lives of children," said Rebial Reynolds, FRYSC Coalition Public Policy and coordinator of the Prestonsburg Elementary Family Resource Center. "Continued reductions in funding will have a significant impact on FRYSC and the programming offered in schools that so many people in this state rely on and value."

Mamaw's Kitchen

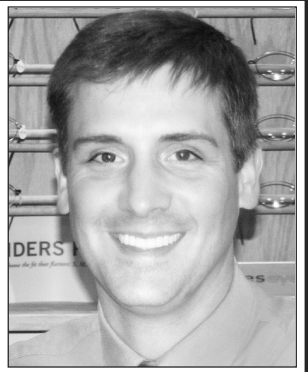
DEBBIE'S CHEESE SQUARES

We met Debbie, Tony and their family at one of Loretta's parties and quickly became friends. They were all such great help to us many times while we lived in Pennsylvania.
 1 cup of sugar, divided for cheese mix and for topping
 1/4 cup of cinnamon
 2 boxes (8 ounces each) cream cheese, very soft
 1 egg, separated
 1 teaspoon vanilla extract
 2 rolls of crescent dough
 Preheat oven to 325° degrees. Mix together 1/4 cup of sugar and 1/4 cup of cinnamon – set aside for topping. (I like a little less cinnamon because it can get too

harsh). Microwave cream cheese for 1 minute, stir. Repeat to get soft enough. Mix together softened cream cheese, remaining sugar, egg yolk, and vanilla until smooth.
 Grease a 9 x 13 pan (I prefer glass, I also use cooking spray to grease the pan because it's easy) Roll out 1 package of crescent dough smooth to the edges of the pan. Pour in cheese mixture and spread smoothly over dough. Roll out remaining package of crescent dough over top of the cheese mixture. It will be too small but only stretch it a little to almost fit to the edges of the pan without disturbing the cheese mixture.

Take the separated egg white and beat it with a basting brush for 1 minute or until slightly frothy. Brush over the top of crescent dough. This will make the dough soft and now you can stretch the dough to the edges of the pan using the basting brush without messing up the cheese mixture underneath.
 Take the sugar and cinnamon topping and sprinkle evenly over the top of your cheese squares. Cook for 25 minutes at 325°. Cool and slice into squares.
OLD-FASHIONED TEA CAKES
 3 cups sugar
 1 cup butter
 5 eggs
 2 teaspoons vanilla
 4 cups all-purpose flour
 1 teaspoon baking powder
 1/2 teaspoon salt
 Cream sugar and butter; add eggs and beat well. Add vanilla, flour, baking powder, and salt. Add additional flour if needed to make a stiff dough. Turn out onto a floured board. Roll and cut into desired shapes. Bake at 375° for 10 to 15 minutes.

“Meth”

Deputy Sheriff Matt Bryant reportedly received an anonymous tip that Spoonamore and Kirby were manufacturing meth at the residence which, Bryant said, is commonly referred to as “The Hole” by those in the local drug culture.

Once officers arrived at the scene, they found a glass quart jar on the kitchen counter that contained a small amount of lighter fluid at the bottom which is often used as a solvent for cleansing meth.

A search of a barn on the property where Spoonamore and Hopkins were when officers arrived, turned up a Mason jar sitting on the railing in the barn that appeared to contain lithium metal strips and crushed up red and white pseudoephedrine tablets in a liquid form.

The Mason jar was later confirmed by UNITE Detective Chris Lyons to be an active meth lab.

Spoonamore stated he didn't know where the jar came from. He also told officers he had manufactured meth in the past but had been trying to quit due to the recent meth busts that were occurring in the county and knew that it was only a matter of time before he would be arrested.

Hopkins then reportedly told Bryant that Kirby was at the residence and fled on foot up the hill behind the barn once he saw officers arriving.

Spoonamore and Hopkins were both charged with manufacturing methamphetamine and conspiracy to manufacture methamphetamine.

Spoonamore remains lodged in the Rockcastle County Detention Center on a \$25,000 cash/property bond.

According to Bryant, All charges on Hopkins were later dismissed due to medical and safety reasons.

Later Sunday night, Mt. Vernon Assistant Chief Adams received a tip that Kirby was at Marty and Ruthie Bussell's residence on Brindle Ridge Road in Brodhead approximately a mile up the road from the

Spoonamore residence. Once officers arrived, they found Kirby in the kitchen. Officers say that the tread of the bottom of Kirby's boots matched one of the treads identified in the barn at the Spoonamore residence. Officers also observed that Kirby's clothing was very dirty and his pants legs were wet up to his knees.

Kirby was arrested at the scene and charged with manufacturing methamphetamine and conspiracy to manufacture methamphetamine.

Kirby remains lodged in the Rockcastle County Detention Center on a \$25,000 cash/property bond.

In the second incident, a Brodhead man was arrested Tuesday morning for manufacturing and possession of methamphetamine after Mt. Vernon Police made a traffic stop on Higher Ground Road in Mt. Vernon.

Arrested at the scene was Jason M. Bullock, 30, of Brodhead.

According to a police report, Bullock was traveling south on Hwy 25 in Mt. Vernon when he veered into the northbound lane and into the path of Mt. Vernon Assistant Police Chief Barry Adams, running Adams off the roadway and into a ditch, before turning left onto Higher Ground Road.

Adams pursued Bullock and after being stopped, Adams noticed a strong chemical odor coming from inside the vehicle and exposed plastic baggies in Bullock's shorts pockets. Adams asked Bullock if he could search the vehicle and Bullock replied “you might as well go ahead, I'm on parole.”

Adams found a blue duffel bag, inside a black garbage bag in the trunk of the vehicle, that contained two working methamphetamine reaction vessels inside Powerade bottles which contained Coleman Camp fuel, lithium strips and crushed pseudoephedrine tablets.

Adams also found various other items used in methamphetamine manufacturing, including a half-gallon glass jar with a white residue inside, one pint Mason jar containing a white powder residue, an empty Powerade bottle, a50 pound

bag of Warnco brand fertilizer, electric power outlet strip, heating pad and a Proud Craft brand electric burner inside the trunk of the vehicle.

Adams also found a brown cloth zippered bag between the driver's seat and console containing a plastic baggie of marijuana, a plastic baggie of synthetic marijuana, two packs of J Diamond B 1.5 and 1.25 rolling papers, two small plastic baggies containing suspected methamphet-

amine, four Xanax tablets and one meloxicam tablet.

Bullock was charged with reckless driving, manufacturing methamphetamine, possession of marijuana, possession of synthetic piperazines, trafficking a controlled substance, three counts of possession of a controlled substance and parole violation.

Bullock remains lodged in the Rockcastle County Detention Center on a \$50,000 cash/property bond.

Corey Craig, representing Rockcastle County Industrial Authority, has been working closely with Anchor Packaging and is negotiating the lease on behalf of the county, was at the meeting. He told the court that he expected Anchor Packaging to purchase the building within a short period of time because officials of the

company had told him they “didn't like to be a tenant.”

The county will have to supplement Anchor's \$200,000 annual lease payment with \$27,750 a year from occupational tax funds but that amount will be more than offset by an increase in revenue from the occupational tax from employees hired by the company, Joe Clontz, county treasurer, told the court.

ORDINANCE NO. 3-19-12

AN ORDINANCE APPROVING A LEASE IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$3,000,000 FOR THE FINANCING OF A PROJECT; PROVIDING FOR THE PAYMENT AND SECURITY OF THE LEASE; CREATING A SINKING FUND; AND AUTHORIZING THE EXECUTION OF VARIOUS DOCUMENTS RELATED TO SUCH LEASE.

WHEREAS, the Fiscal Court of the County of Rockcastle, Kentucky (the "County") has the power, pursuant to Section 65.940 et seq. of the Kentucky Revised Statutes to enter into lease agreements with or without the option to purchase in order to provide for the use of the property for public purposes;

WHEREAS, the Fiscal Court of the County of Rockcastle, Kentucky (the "Fiscal Court") has previously determined, and hereby further determines, that the County is in need of the Project, as defined in the Lease hereinafter described;

WHEREAS, the Fiscal Court has previously determined, and hereby further determines, that the Project constitutes an economic development project, that the Project will contribute to employment in Rockcastle County, and that such economic development and employment will advance the public purposes of the County; and

WHEREAS, the Fiscal Court has determined and hereby determines that it is in the best interests of the County that the County enter into a Lease Agreement (the "Lease") with an aggregate principal amount not to exceed \$3,000,000, funded by the bank, financial institution or finance corporation offering the best interest rate and terms (the "Lessor"), as selected by the Judge/Executive, for the leasing by the County from the Lessor of the Project.

NOW THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF ROCKCASTLE, KENTUCKY, AS FOLLOWS:

Section 1. Recitals and Authorization. The County hereby approves the Lease Agreement (the "Lease"), in substantially the form presented to this Fiscal Court. The recitals to this Ordinance are incorporated herein as if set forth in this Section in their entirety and are hereby found and determined to be true and correct. It is further found and determined that the Project identified in the Lease is public property to be used for public purposes, that it is necessary and desirable and in the best interests of the County to enter into the Lease for the purposes therein specified, and the execution and delivery of the Lease and all representations, certifications and other matters contained in the closing memorandum with respect to the Lease, or as may be required by the Lessor prior to delivery of the Lease, are hereby approved, ratified and confirmed. The Judge/Executive and Fiscal Court Clerk of the County are hereby authorized to execute the Lease, together with such other agreements or certifications which may be necessary to accomplish the transaction contemplated by the Lease.

Section 2. General Obligation Pledge. Pursuant to the Constitution of the Commonwealth and Chapter 66 of the Kentucky Revised Statutes, as amended (the "General Obligation Statutes"), the obligation of the County created by the Lease shall be a full general obligation of the County and, for the prompt payment of the Lease Payments, the full faith, credit and revenue of the County are hereby pledged. During the period the Lease is outstanding, there shall be and there hereby is levied on all the taxable property in the County, in addition to all

other taxes, without limitation as to rate, a direct tax annually in an amount sufficient to pay the Lease Payments on the Lease when and as due, it being hereby found and determined that current tax rates are within all applicable limitations. Said tax shall be and is hereby ordered computed, certified, levied and extended upon the tax duplicate and collected by the same officers in the same manner and at the same time that taxes for general purposes for each of said years are certified, extended and collected. Said tax shall be placed before and in preference to all other items and for the full amount thereof; provided, however, that in each year to the extent that the other taxes of the County are available for the payment of the Lease Payments and are appropriated for such purpose, the amount of such direct tax upon all of the taxable property in the County shall be reduced by the amount of such other taxes so available and appropriated.

There is hereby established, or it is acknowledged that there has heretofore been established, with the County a sinking fund (the "Sinking Fund"). The funds derived from said tax levy hereby required or other available taxes shall be placed in the Sinking Fund and, together with interest collected on the same, are irrevocably pledged for the payment of all obligations issued under the General Obligation Statutes and all Tax Supported Leases, as defined in the General Obligation Statutes, including the Lease herein authorized, when and as the same fall due. Amounts shall be transferred from the Sinking Fund to the Lessor at the times and in the amounts required by the Lease.


Section 3. Severability. If any Section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

Section 4. Open Meetings Law. This Fiscal Court hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Fiscal Court, and that all deliberations of this Fiscal Court and of its committees, if any, which resulted in formal action, were in meetings open to the public, in full compliance with applicable legal requirements.

Section 5. Conflicts. All ordinances, resolutions, orders or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed and the provisions of this Ordinance shall prevail and be given effect.

Section 6. Effective Date. This Ordinance shall take effect from and after its passage and publication of a summary thereof, as provided by law.

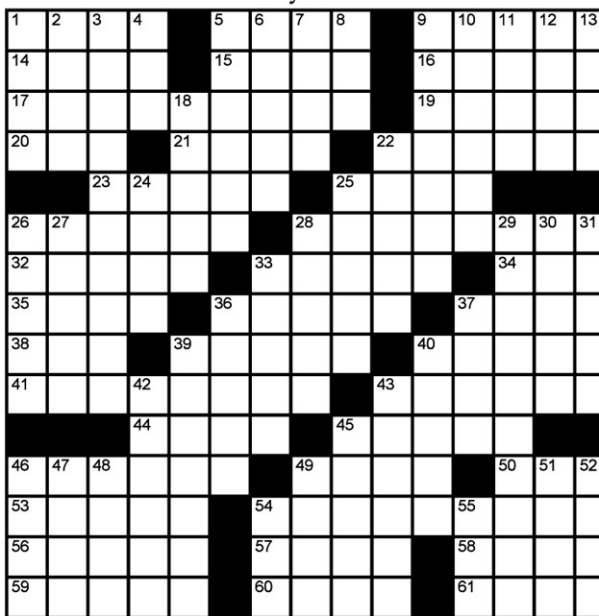

Allow me to introduce you to some of the members of the Girls Cross-Country, Track & Field team along with Coach Mark Brummett. Every day after school you will find these girls training hard to compete in events such as sprints and long-distance runs, hurdles, long-jump, high-jump, discus and shot-put. To say these girls excel at what they do is an understatement. To watch them perform, one would think they have been doing this their entire lives; it's hard to believe that most of these athletes are just getting started.

Rhaki Patel is a freshman, a small-framed girl at 4 feet 11 inches. She decided to give this sport a try when she was in 6th grade. Not finding her niche in the short-distant races, she was encouraged by teammate and friend Alyssa Cox to run Cross-Country in the 8th grade. It proved to be a good match for her endurance level. Her first 5k (3.2-mile) time was 34:36, not bad for her first race. Her confidence grew and being dedicated to the practice of the sport, her time dropped 8 minutes at her next race. Just last year at the Bittersweet 5K, she won the Overall Female runner with a time of 21 minutes! Now her goal is to run less than 20 minutes before graduating high school.

Rachel Cain, a freshman and long-distance runner has been in this sport since 2nd grade. She says she didn't like any other sport besides running and swimming. Some of her competitive edge might be inherited from her Dad, who is also an avid long-distance runner. She is proud to say that she finally beat him in a 2-mile race just a few months ago. Other accomplishments include, winning overall female runner in the Bittersweet 5k in 2010 and achieving her best time in the mile of less than 6 minutes. Rachel contributes her success to lots of practice and running year-round.

Alyssa Cox, who is also a freshman, runs long-distance and makes it look easy. She has had the fastest time in 1-mile run 3 years in a row. Coach Noble knew what he was doing when he recommended that she give track a try. She has been running since 3rd grade and has received many accomplishments, one being an Athletics award.

Lyndsey Abel has been performing the long-jump since 7th grade. She actually won the middle school state championship in 8th grade for longest jump at 13.5 feet. She has come a long way since then, increasing that distance to 15 feet 6 inches. She is a top contender for another state championship title this year as a sophomore. Coach Brummett's encouragement and confidence that she can win this year motivates her to practice and strive to be better.

Alyssa Allen, who is a sophomore, is in her fifth year of running. This sport was actually her second choice, but with much encouragement from her parents who saw her potential she stuck with it. As a 7th grader with a

competitive spirit, she started winning races and became good at the sport. Her confidence grew and she learned to love it. Because of her best performances, she became the middle school track athlete of the week during this year. If you watch her complete hurdles, perform the long-jump, or sprint, you can see why her parents were optimistic of her capabilities. Her grace and speed shine through.

Amy Johnson is a junior this year and already an impending recruit for UK. Come to a practice or a meet and you will find Amy doing what she does best, throwing the shot-put or discus. She started this sport after a teacher reported her potential to Coach Brummett. At first, she wanted to quit, mainly because she never had done a sport before and running just wasn't her "thing." She continued to show up for practice with her mom's support and encouragement. In 2009, she became athlete of the year. The awards kept coming. She won the outdoor state championship in middle school for shot-put and discus and won indoor state championship as a freshman for shot-put. She is in the top 10 for outdoor and indoor state every year. After training at an Olympic camp this summer, she is hoping to be state champion in both shot-put and discus this season. Her current distance in the shot-put is 33 feet. No doubt, these records she has achieved are impressive.

Breanna Cromer is a dedicated athlete who manages to work long shifts at her evening job and continues to make practice a priority. She started running when she was in 6th grade. She improved in all areas of running and developed lasting friendships on the team. She placed 3rd in the region in the 800m run. Her other specialties include cross-country, relays, and long jump. Her goal is to improve her times and qualify to go to State.

Championship titles in both region and state are nothing new to Coach Mark Brummett. He has been coaching for 18 years and has coached some of the best athletes in the field, including Heather Hammond, Morgan Thacker, Samantha Smith, and Michaela Hunter, all who have been named Athlete of the Year at least once and were all nationally ranked athletes when they competed in high school. Coach Brummett has been honored as Overall Kentucky Girls' Track Coach of the Year in 2001, 2005, as well as Central Kentucky Conference Coach of the Year in 2009, 2010, among other numerous awards and honors. Continued success is promising, considering the talent of the members of this outstanding team.

Yes for Economic Success

Rockcastle County has the opportunity to take a progressive step forward with the election that will take place on April 3, 2012. The opportunities that will be afforded with a vote of YES to sell alcohol throughout the county are vast. Those opportunities will include an increase in revenue for the county and cities, new businesses, new jobs, new tourism opportunities, and economic development opportunities.

We do not have to look far to see the benefits that come with this decision. Danville has seen a significant increase in revenue, \$19 million in liquor sales, since they voted to go wet on March 10, 2010. Danville had been 'moist' for the seven previous years, allowing by-the-drink sales in restaurants that seated 100 people, which brought in \$3 million in revenue yearly. Three new restaurants and other retail shops have also opened in the downtown area in the past eighteen months. A newly opened 30,000 square-foot Liquor Barn is now occupying an abandoned Kmart building.

It was estimated, by the Governor's Senior Economist Thomas Jones, Rockcastle County conservatively missed out on \$7.5 million in revenue in fiscal year 2010 when compared to a county that is of similar size that allows the sale of alcohol. The estimate did not take into account that Rockcastle is located on I-75 or the increased tourism traffic that comes south to access Lake Cumberland. In a study conducted by Dr. Ray Perryman, with the population of Rockcastle County we could expect to see an increase of \$12.5 million in revenue and 125 new jobs. It is a vital component to our economic future, when recruiting industry and tourism to our county it is one of the determining factors of whether those dollars will be invested in Rockcastle County.

There are concerns that should be addressed when the discussion of the sale of alcohol comes up in a community. People fear DUI's will increase dramatically, however, these fears can be put to rest. The Kentucky State Police have shown in their annual reports that there has been a decrease in areas that have gone wet. They have attributed this to the decrease in driving time to where the alcohol is purchased. Danville Assistant Chief Tom Bustle, who is the Alcohol Beverage Control administrator, reported "We've not seen an increase in crime or DUI arrests since the alcohol sales began." As is the same story in other communities that have chosen to allow the sale of alcohol.

The time has come to allow Rockcastle County to have the amenities and quality of life issues that we see in the counties that surround us. The time has come to move forward. The time has come to make a difference in our community. The time has come to invest in our future, vote YES on April 3, 2012.

Local lady basketball stars in national tournaments

2011 Miss Basketball from Rockcastle County High School Sara Hammond, a freshman at the University of Louisville and Angie Lawrence, a freshman at Georgetown, have both been involved in national tournaments of their own -- Hammond in the NCAA Women's Tournament and Lawrence in the NAIA Division I Women's Basketball National Championship, being held in Frankfort's Convention Center.

Both players were members of last year 2011 State Basketball Championship Team for Rockcastle County High School, the first in the county's history of girls

basketball. Hammond's Lady Cardinals defeated Michigan State 67-52 Saturday, in first round action of the women's NCAA tournament.

The 6-foot-2 Hammond turned in her best outing of the season, scoring seven points and pulling down nine rebounds as the Cardinals used her muscle to help put away Michigan State.

"That's the kind of play we need from her," Coach Jeff Walz said. "She had been practicing really, really well the past few days. She's aggressive and can be strong. We just have to make sure she keeps playing strong."

Hammond had four offensive rebounds, three that led to points in the second half, as the Cards won the rebounding battle over Michigan State 40-34.

Hammond's rebound total was her best since she grabbed nine against Tennessee-Martin 16 games ago. Her high was 13 in the opener at Missouri State.

"I was pretty confident in myself today," she said. "Coach had the confidence in me to score down low and I got a few offensive rebounds."

However, the Cardinals tournament came to an abrupt end Monday night when they were defeated by Maryland 72-68 at College Park, Maryland.

Lawrence, who made the winning shot in the state championship game against Manual last year, came off the bench to score 13 points for her Georgetown Lady Tigers in their first round 70-68 win over Vanguard (Calif.) in the first game of the NAIA Division I Tournament.

In the second game, Lawrence was again in double digits with 12 points in the 80-71 win over Avila (Mo.).

Then, she saved her best for last, scoring a career high 27 points -- 20 in the second half -- against Rogers State (Okla.) to lead her team to their first-ever trip to the Fab Four with the 70-63 victory.

It was a big night for Lawrence as she shot 7 for 8 from the field and had an 11 for 13 night at the foul line, both career-bests. She owns a team-high 52 point in Georgetown's three tournament games. Lawrence averaged only 4.7 points per game during the regular season.

The game was tied at 45 when a Tiger surge, highlighted by seven points from Lawrence, pushed her team's advantage out to nine points 56-47. Rogers State made one final run, pulling to within one, 58-57, late in the half but the Tigers proved too strong down the stretch, making 7 of 9 free throws over the last four minutes to seal the victory.

The Tigers first trip to the NAIA Final Four came to an end Monday night with a 62-50 loss to Union (Tenn.).

The Lady Tigers rallied from an eight point half-time deficit to take a 47-44 lead when Lawrence made a spin move on the baseline and laid the ball in with 6:33 left. Then the roof fell in on the 19th ranked Tigers who were down 55-50 and Union scored the last seven points of the game.

Craft told the council that “all the numbers are healthy except for the water/sewer department.” Craft said.

According to the Management’s Discussion

and Analysis Financial Highlights, the total net assets of the City of Mt. Vernon (total assets less total liabilities) at the fiscal year end of June 30, 2011 were \$10,816,903 and the City’s total net assets increased in the last fiscal year by \$486,091.

The statement of activities for the year showed a negative of \$217,024 for the water and sewer department’s operation which seems to validate the need for the recent increase in water rates.

Mayor Bryant gave the council an update on the Rose Hill Sewer Project. Bryant said the project should be completed within a couple of months or so. “It’s a little messy but that that’s a sign of progress.”

The council gave permission for Doug Proctor to use the Lake Linville Ball Park for the Hot Rods program and Cynthia Chestnut permission to use the volleyball field at Lake Linville Park.

Council member Cliff Mullins reported that he had received complaints of older children using the playground equipment at the

city park which is for use by children age 12 and under. Mayor Bryant added that vandalism had again occurred at the bathrooms at the park “the one place where there are no surveillance cameras.”

Bryant told Mullins that he appreciated his bringing the complaints to the council’s attention and making the police department aware of the problem so that more attention can be paid to the park.

The police report for February was presented by Asst. Chief Barry Adams who told the council, that since February 20th, 10 meth labs had been taken down in the city and county. Adams said his department was interacting with the Sheriff’s office in this effort.

Adams report to the council showed: 521 total calls for service; 28 motor vehicle accidents, consisting of 16 non-injury accidents and 12 accidents with injury; 66 total arrests; 49 warrants served; 4 DUI arrests; 18 drug charges; two meth labs taken down; 32 traffic citations, 2 theft charges and 12 other criminal charges.

Mt. Vernon Fire Chief David Bales reported to the council that, during February, Mt. Vernon fire and Rescue was paged to: 6 accidents with injuries and possible entrapment; 8 accident with injuries; one structure fire; 5 vehicle fires (tractors and trailers); one brush and grass fires; two control burns; one smoke investigation; one false alarm; four fire and smoke alarm activation; one assist law enforcement w/forcible entry at meth lab; one assist law enforcement at meth lab with evacuation and standby and two special details (taking down Christmas banners).

Renner’s bond was set at \$50,000 cash/property. McGuire’s and Mobley’s bond was set at \$25,000 cash/property.

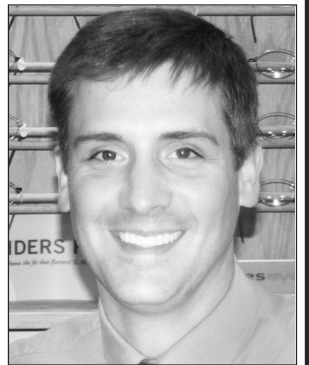

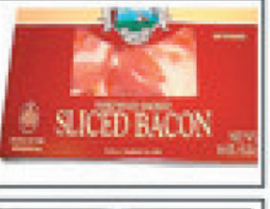

"While we're enjoying basketball in March, local PRIDE Coordinators also are drawing up game plans and recruiting volunteers for a hometown victory against litter in April," said Tammie Wilson of PRIDE, the nonprofit organization that coordinates the annual Spring Cleanup across 38 counties.

Rockcastle County's Spring Cleanup team will be led by James Renner, who is the county's Solid Waste, Recycling and PRIDE Coordinator. In Mt. Vernon, PRIDE Coordinator Jill Medley will take the lead. In Livingston, Mayor J.C. Griffin is the PRIDE Coordinator.

"Volunteering is important because it is up to us, the citizens, to take care of our world," Renner said. "We can make a difference in our world by picking up one piece of trash at a time."

"Please come out and help clean up our roadsides," Medley said.

"Livingston is scheduled to be the first Trail Town in Kentucky, so this cleanup is very important to the city this year," Griffin said.

"Last April was a record-breaking Spring Cleanup, with 33,409 Spring Cleanup volunteers who netted 36,445 bags of trash and an additional 27,513 tons of trash across our region," Wilson said.

"It all starts with one cleanup and one volunteer - you - so please plan to volunteer for your local Spring Cleanup activities," Wilson said. "To learn about volunteer opportuni-

ties, stay tuned to your local media and www.kypride.org."

"You will be 'Saving Our World, One Cleanup at a Time,' just like it says on the free T-shirts that will be given to Spring Cleanup volunteers while supplies last," Wilson added.

PRIDE Coordinators are volunteers who are appointed by mayors and judge-executives. They work with the PRIDE staff to organize cleanup activities, recruit volunteers and track cleanup results.

PRIDE Coordinators now are planning each community's Spring Cleanup activities. They will recruit volunteers for

events they schedule and assist volunteers who want to plan their own cleanups. Some communities also will offer free trash disposal events or clean up illegal dumps during the Spring Cleanup. PRIDE will provide volunteer T-shirts, cleanup supplies and funding assistance for local governments.

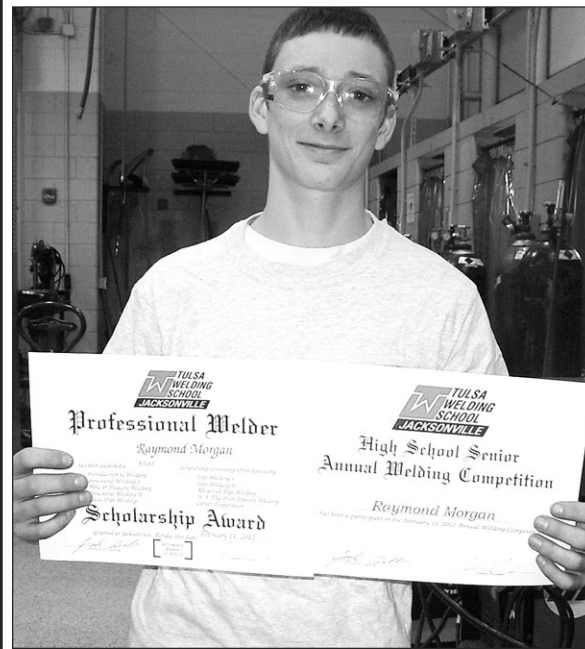

Financial aid tip of the month

Federal student aid can help pay college costs

The federal government sponsors numerous financial aid programs that can help students and their parents pay college expenses. Below is a brief summary from the Kentucky Higher Education Assistance Authority (KHEAA) that describes some of the more common federal grant and loan programs. Grants generally do not have to be repaid, but loans do.

- Federal Pell Grant: Pell Grants provide up to \$5,550 per year for undergraduates with financial need.
- Federal Supplemental Educational Opportunity Grant: grants that provide up to \$4,000 per year for undergraduate students who have exceptional financial need.
- Federal Perkins Loan: loans for students with exceptional financial need. Undergraduates can get up to \$5,500 per year, while graduate students can get up to \$8,000 per year.
- Federal Stafford Loan: Stafford Loans are available to undergraduate, graduate and professional students. The amount students may borrow varies depending upon their year in school.
- Federal PLUS Loan: Parents of dependent undergraduate students may qualify for PLUS Loans, depending on the parents' credit ratings. The amount available depends on how much other financial aid the

student receives. Graduate students may apply for PLUS Loans if they have exhausted all of their Stafford Loan eligibility. The Free Application for Federal Student Aid (FAFSA) is used to apply for all of these programs. Families seeking a PLUS Loan must also submit a separate application.

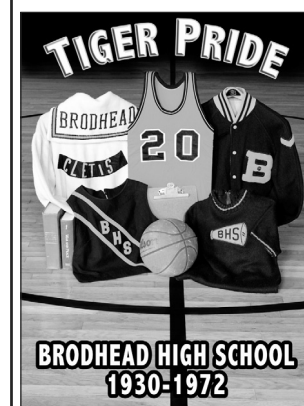

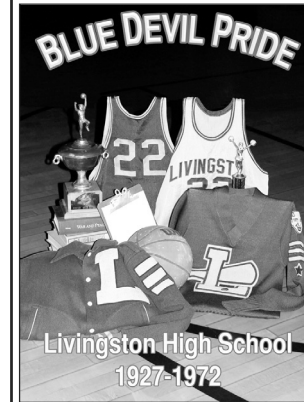

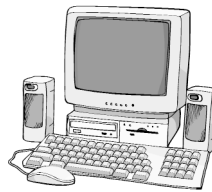

The 4-H Variety Show will take place at MVES on Thursday, March 22 at 6:30. Please make plans to attend. Many students display their talents at this event.

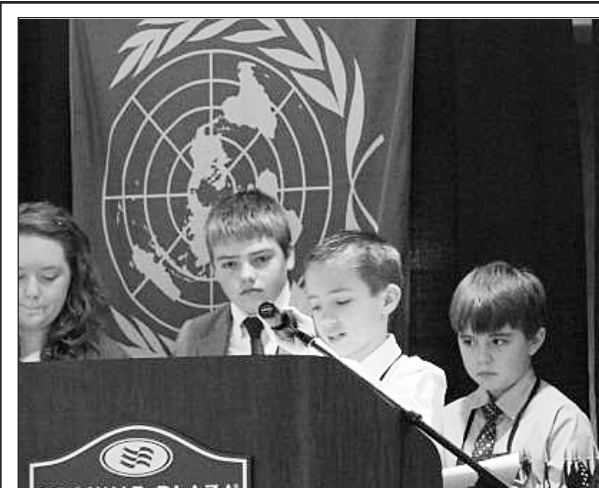
