WWII Vet honors life of fallen comrade he saved during war

As people go to decorate their loved ones graves on Memorial Day, one Stanford man will also use the day to remember and honor the life of his fellow World War II comrade whose life he saved during the war, almost 67 years ago.
George Garrison, 93, of

Stanford served in the same unit alongside the late Earl Ponder of Livingston and is credited with saving his life during the Battle of Luzon Island in the Philippines on June 6, 1945.
Ponder was one of the first to be drafted in WWII from Rockcastle County and Garrison, who lived in Boyle County before the

war, was in the first group to be drafted out of his home county as well.
"They drafted 50 people and I was number 49," Garrison said. "I just barely made the cut."
Garrison and Ponder both served in Company B of the 149th infantry regiment, a part of the 38th division in the sixth U.S. Army. Garrison said he was a squad leader and Ponder was a platoon sergeant.

"Earl had three squads to take care of and I just had one," Garrison said. "I guess you can say I had it easier than he did."
Their unit saw fighting in numerous battles within New Guinea, the southern Philippines and Luzon.
Garrison said they remained in the same unit throughout the whole war and that he became close

York is new Circuit Clerk; Meade wins Ford's seat

It turned out to be something of a runaway for newcomer to politics Eliza Jane York in her bid for the Circuit Clerk's office.
York outpolled her two opponents 1563 to 1152 and more than doubled up the next one to her, Brenda McKnight, 1563 to 765.
Both York and McKnight had spent the last 14 years in the Circuit Clerk's office under retiring clerk Teresa Vanzant. When both took and passed the qualifying test for candidates for the office, York had to resign her position but McKnight was able, by state statute, to retain her job because of her Chief Deputy Clerk status.
York carried 12 of the 14 precincts and tied with McKnight in the West Livingston and Roundstone precincts.
The third candidate for the office, retiring Rockcastle County Schools Superintendent Larry Hammond was a

Mt. Vernon Council passes first reading of 2012-13 budget

The Mt. Vernon City Council heard the first reading of the budget for fiscal year 2012-13 and an amended personnel manual for employees at Monday night's regular meeting.
The council approved the budget which shows expected receipts of \$6.4 million against \$5.1 million in appropriations. The budget includes a 5% pay raise for employees.
The budget is down from last year's \$8.8 million but that budget included over \$4 million for the Rose Hill project. \$882,015 remain to be expended in this year's budget for that project.
General fund receipts are expected to be up only slightly, from \$1,633,336 to \$1,637,065 but water department receipts are expected to rise from \$1,578,811 to \$2,210,111 because of the water rate increase which went into effect recently to repay the loans for renovation of the city's water storage system and for increased expenses in water department operations. Those funds have not been received and are not re-

flected in the budget.
Sewer fund receipts show \$639,811 expected for sewer charges as compared to \$618,811. This fund contains the last of the unexpended funds for the Rose Hill Project.
Other funds receipts include \$60,600 from Municipal Aid, \$12,800 from LGEA funds and \$2,600 from UDAG funds.
General fund appropriations include: \$553,175 for administrative salaries and

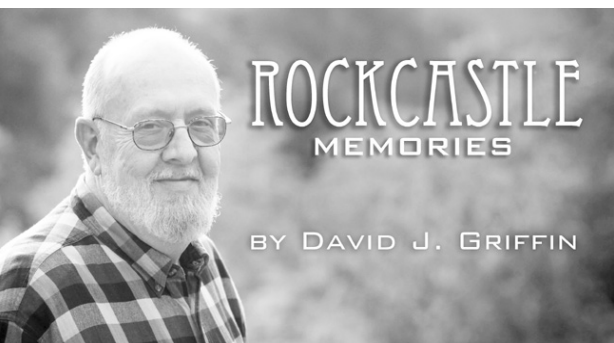
Memorial service to honor fallen soldiers Monday

ROCKCASTLE MEMORIES

The Dairy Queen "Cruise-In"

I happened to be driving past the Stanton Dairy Queen on April 28, 2012, and was taken back to the '60s when I saw the parking lot filled with classic dream machines and the sounds of rock and roll filling the air. I was not dreaming – it was all real. The space was filled with hot cars from yesteryear's teens. The atmosphere was captivating. Even the aroma of burgers, fries, and milkshakes enticed passersby to pull into the lot and be taken back to another era.

Pete Thomas, owner of the Stanton and Clay City Dairy Queens, hosts four "cruise-ins" each year in Powell County. The Stanton car shows are in April and October; June and August are set aside for Clay City. When asked how the yearly shindigs began, Thomas replied, "I have always enjoyed going to car shows, so I started 'cruise-ins' at my two Dairy Queens several years ago. We give trophies and dash plaques to the entrants. We had approximately twenty five cars for the April show in Stanton. We also have lots of door prizes for the individuals who come to see the automobiles."

One of the outstanding vehicles in this show was a 1952 Chevy pickup that was originally owned by Thomas' father, Roger Thomas. He passed away three years ago, and Pete restored the truck in memory of his dad.

Many of the vintage automobiles were dazzling, demonstrating the vast amount of work that it took to restore them to their original form. The overall winner of the April show was a 1963 Chevy Impala Super Sport owned by Charles Hobbs of Lexington. The blue Chevy was certainly the center of a lot of attention. Other outstanding restored automobiles included: a 1950 brown Ford Club Coupe belonging to Jerry Chaney from Irvine, a 1955 Chevy owned by Phillip Todd of Stanton, Glenn Townsend's 1970 Chevelle Super Sport, and Matthew Lee's 1967 Camaro from Clay City.

While walking though the parking lot dreaming about the cars of yesteryear, one could not ignore the sounds of the past era. Charlie Napier, operating out of his music trailer, played the top tunes of bygone days. Napier is originally from Rockcastle County and currently works for radio station WRVK in Renfro Valley. He hosts vintage car shows throughout central Kentucky, playing requests for the car-loving crowds. Buddy Holly, Roy Orbison, Elvis Presley, Sam Cooke and Ricky Nelson were among the many performers who provided the appropriate environment and atmosphere. Napier approached me and requested that I appear on his radio show one day soon so we

that we could discuss rock and roll, old cars, and my column for the *Mt. Vernon Signal*. I enthusiastically accepted his offer.

One of the onlookers observed, "There are plenty of guys who get goose bumps upon seeing an old restored, classic automobile. There is just something about the smell of the leather seats, the sound of a V8 engine, Lakes pipes, continental kits, shaved hoods and trunks, porta-wall tires, tuck and roll upholstery, and AM radios playing the tunes of the times."

Several of the nostalgic automobile accessories that could be observed at the "cruise-in" have been gradually forgotten by present car owners. One of these customized parts could be heard all around the parking lot: "glass-pack mufflers," which I had installed in some of my cars of the '50's and '60's. That familiar sound could not be duplicated by any other muffler of the times. Glasspacks were an old, simple, and relatively inexpensive design. They were effective at reducing the back pressure, but not very effective at muffling noise. They preserved more of the engine's power while sounding louder than conventional mufflers. That sound was – and is – very distinctive.

Another accessory found in earlier cars that we noticed at the cruise-in were floorboard headlight dimmers. If you were driving in the early '50's, you can remember having to step on a metal switch located on the left side of the driver's floor every time you met an oncoming automobile. If your car had a standard transmission with a clutch, it was sometimes difficult to quickly dim the lights if you were also changing gears.

And who remembers the "curb feelers" that were installed on the curb side of many customized cars of our youth? One of the cars in the car show had a pair, and I overheard a couple asking what was their purpose. They were installed so that we could hear when pulling close to a curb while parking so that we did not scuff our white-wall tires.

Almost all early automobiles of our youth had fender skirts, which partially hid the tires and wheels on the rear. These body-colored accessories were the in thing if we determined to customize our rides. I had them on my '58 Chevy and on my '63 Super Sport. They made our cars look more sleek and lower to the ground.

Some other vintage, customized accessories that we noticed at the DQ included fuzzy dice hanging from the rear-view mirrors, painted flames coming from under the hoods of hot cars, and Lakes pipes installed on the manifolds.

Every time I attend a show of old automobiles, I take a trip back in time. If

This statement left an impression on me and stopped me in my tracks for a few seconds.

Garrison then went on to tell me that if it hadn't been for the veterans who fought in WWII, we would all be speaking Japanese today!

On Memorial Day and Veterans Day, we can all sympathize with veterans and their families. We can use words like honor, courage and bravery when we talk about them in remembrance. But the truth is we can never repay any veteran for sacrifices they've made in fighting for the freedoms

and safety we enjoy everyday.

I can't speak for everyone, but I am thankful for what our veterans have done for us since our country was first created.

I am thankful for the fact that I can go home this afternoon and swim in my pool without having to worry about foreigners shooting at me from the woods next to my house.

As a reporter, I am also thankful for being able to exercise my First Amendment right of free speech and freedom of the press by being able to report on decisions that are made in government meetings without having to worry about being executed by public officials for something I publish in the newspaper.

Our safety, freedoms and rights could've easily been taken away from any of us if it weren't for our veterans who fought to protect them for us.

There in the head of Blair Branch when I was growing up in the fifties and sixties, we always took our weekly baths, during cold weather, every Sunday night, whether we needed one not.

One of the same tubs used to put out a clothes washing doubled as a bath tub which we placed behind the big wood and coal burning Warm Morning heater that stood catty-cornered in our big back room.

Bath water was heated both on the wood and coal cook stove in our kitchen as well as on top of the big heater. We did usually change water between individual baths and heating said water was the responsibility of each individual bather.

Being the eldest of four boys, I had the honor of going first. But if Keeter, who was next in line, decided that I hadn't dirtied up my water too badly, he would simply add a kettle of hot water to it and follow suit. Andy, who was third in line, would not, even at a very early age, consider bathing in used water, nor would baby brother, Steve.

Mom and Dad had other bathing arrangements. Dad had to have a bath every night because he was a coal miner and worked mostly in

mines that did not have bath houses. He literally had to be scrubbed down and rinsed off a couple of times each night to keep from turning the bed clothing black. Suffice to say that nobody ever thought about reusing Dad's bath water but Mom usually bathed in his first tub, and her water provided his pre-wash.

We boys stayed much cleaner in warm weather. We dammed up a "swimming hole" with sand, gravel and big rocks in Blair Branch in front of the house. It was slate lined, sides and bottom, about fifteen feet long, eight or so feet wide and about three feet deep in the middle. It wasn't deep enough to do any swimming but it was the ultimate bath tub. I know people who would shell out big bucks to have a carbon copy of their homes today.

We kept bars of soap in a coffee can at the base of a tree trunk beside the water hole and kept towels and wash cloths hung to dry on its lower limbs. From late April until mid October, that's where we took our baths. The only downside was that a big crawdad might latch onto our toes or a big chub minnow might go

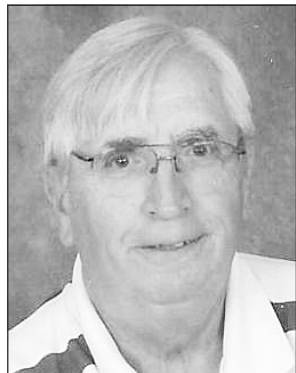
Mildred I. Bales

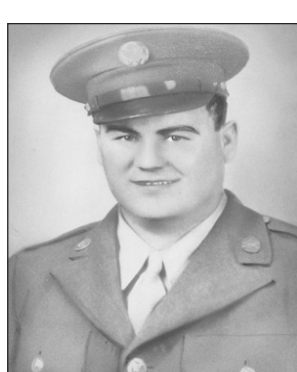

The Roots of Rockcastle

Rockcastle's Civil War Hospitals

As we know, the Civil War was fought in areas very close to Rockcastle County, such as the battle at Wildcat Mountain and the Battle of Richmond farther north. It has been said that there have been smaller skirmishes here in the county, such as in the Red Hill area, where bits and pieces of a long ago fight may be found, according to locals in the area.

As the battles raged, many soldiers were killed on the field. Many others were

wounded and required life-saving medical treatment. Therefore it became necessary to receive medical treatment as soon as possible. Many "field hospitals" popped up throughout the county to provide their services. Some of them were here in Rockcastle County.

I certainly want to focus on these historic sites and structures, but first let's take a look at the field hospitals in general.

According to the letters of Civil War surgeon, James D. Benton in "A Surgeon's Tale: The Civil War Letters

of Surgeon James D. Benton" by Christopher E. Loperfido, the "hospitals were crude, doctors and surgeons were few, and women were called upon to help with the wounded. Clara Barton, Amelia Hancock, and Dorothea Dix were among those who began their healing here."

Other than the battlefield hospitals, "there were over 160 other field hospitals which included houses, churches (remember the scene from Gone With the Wind), schools, public buildings, barns, sheds, cow stalls, and open fields." In some cases, 5,200 severely wounded men were gathered and treated at the same hospital, and of that number, 1,200 would die.

"Alcohol played an important role with medicine at this time in our history...Camp Letterman would only have two breweries in operation, but the Union Army would ship in 2.5 million gallons of whiskey following the battle, for the wounded..." according to Gregory A. Coco in his book, "A Vast Sea of Misery: A History and Guide to the Union and Confederate Field Hospitals at Gettysburg, July 1-November 20, 1863".

According to Valerie Little-Vaughn, there were approximately 187 permanent hospitals. They were located near railroads to allow easy transport of the wounded. One such hospital was in Lexington, with 463 beds, Ashland, with 275 beds, Bowling Green, with 146 beds, Covington, with 218 beds in one hospital and 402 beds in another, Jeffersonville with 980 beds, and Louisville had a total of 5 hospitals having 200, 203, and 360 beds, and 2 having 700 beds each.

We'll take another look at Civil War field hospitals next week.

Mamaw's Kitchen

SHRIMP AND CHEESE GRITS

Friend Mel created this recipe after eating this dish at a restaurant they often visit. Here is his version.

NOTE: I like my roux mixture to be a little thick so I don't use as much liquid. Adjust to your liking. The roux or flour and butter mixture is a timing thing. It may take 10 minutes and it may take a halfhour. It is like the first part of gravy: drippings and flour. But most important, never stop stirring till it is done. If you burn it, you have to start over.

This recipe makes a lot of food. You may want to cut it in half.
3 tablespoons butter
3 tablespoons olive oil
3 to 5 tablespoons of flour
1 cup of chopped onions
1/2 cup of chopped bell peppers, your color
1/2 teaspoon of salt
1 teaspoon of pepper
Dash of cayenne pepper
1 pound andouille sausage sliced 1/4 inch thick
1 to 2 cups of clam or chicken broth
1 bunch green onions use all parts
2 pounds shrimp peeled and deveined then cut in half
6 cups cooked instant grits, check the box for recipe
12 ounces sharp cheddar cheese or your favorite

In a medium sauce pan or pot, melt the butter and oil together; add flour to make a loose paste. Cook and stir constantly over medium-heat till a medium peanut color is made. Add onions, peppers, salt, and black pepper. Cook about 6 minutes till the vegetables are starting to soften. Add sausage and cook about 5 minutes. Add broth in parts and increase heat to bring to a boil so thickening will happen. When roux coats a spoon

turn to low and add shrimp. This will be done in minutes. When the shrimp turn pink, take off heat. Make grits as per instructions of box. When done add cheese and stir till melted.

To serve put a big spoon full of grits in the middle of a plate then add spoonful of shrimp mixture over it. Enjoy

for something else.

The bathing alternative to the swimming hole happened any time it rained. Our big house was L shaped so the roof drained from the eaves in deep, 45 degree channels. If the "swimming hole" was the ultimate bath tub, the roof drains made the ultimate showers. Even a light drizzle would send a steady stream tumbling twenty five feet from the house top. If the rain was heavy, the downpour would literally knock us over.

In addition to bathing, we frequently caught enough water in the big wash tubs to put out an entire washing, thereby saving the hour or so of labor required to draw it from the well one bucket at a time.

For whatever reason, clothing washed in pure rain-water felt much better and looked brighter than it did when the washing was done with well water. And bathing in rain water simply made me feel much better all over.

To this day, If you are driving along Charlie Brown Road and see me standing in the lawn out in the rain with a bar of soap and a wash cloth in my hands, don't be surprised. I'm simply taking a bath. However, unlike my days of youth on Blair Branch, Loretta now insists that I wear swim trunks to lessen her embarrassment.

Water - Essential for Life

This report is designed to inform the public about the quality of water and services provided on a daily basis. Our commitment is to provide our customers with a safe, clean, and reliable supply of drinking water. We want to assure that we will continue to monitor, improve, and protect the water system and deliver a high quality product. Water is the most indispensable product in every home and we ask everyone to be conservative and help us in our efforts to protect the water source and the water system.

Livingston Municipal Water Works purchases your drinking water from the Wood Creek Water District. The Wood Creek Water Plant treats surface water supplied from Wood Creek Lake. A source water assessment that addresses the water supply's susceptibility to potential sources of contamination has been prepared. The susceptibility rating for Wood Creek Lake is considered high. Activities that have a potential to affect water quality and the cost of treating the water include: agricultural, transportation, landfill/dumps, and human/animal activities. The presence of excessive nutrients is of particular concern. Two general sources of nutrients in Wood Creek's water supply are from natural and man-made sources. Nutrients are either dumped directly into waterways or swept through the areas when rain washes over the land. Wood Creek Water District is taking steps to install sanitary sewer lines in the watershed in order to eliminate nutrient & bacteriological contaminant sources. The complete source water assessment is available for review at the Cumberland Valley Area Development District.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects may be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and may pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants, such as viruses and bacteria, (sewage plants, septic systems, livestock operations, or wildlife). Inorganic contaminants, such as salts and metals, (naturally occurring or from stormwater runoff, wastewater discharges, oil and gas production, mining, or farming). Pesticides and herbicides, (stormwater runoff, agriculture or residential uses). Organic chemical contaminants, including synthetic and volatile organic chemicals, (by-products of industrial processes and petroleum production, or from gas stations, stormwater runoff, or septic systems). Radioactive contaminants, (naturally occurring or from oil and gas production or mining activities). In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water to provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Some or all of these definitions may be found in this report:

- Maximum Contaminant Level (MCL)** - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG)** - the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Residual Disinfectant Level (MRDL)** - the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

We have since reviewed the regulations in order to comply with the CCR Rule as required by the Safe Drinking Water Act.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 07/01/2011 - 07/31/2011 and 08/01/2011 - 08/31/2011 we did not complete all monitoring or testing for Chlorine and therefore cannot be sure of the quality of our drinking water during that time. Residual chlorine samples are to be collected on a daily basis, however during the compliance period we failed to submit adequate sampling results to meet the chlorine summary requirements. We reported 10 out of 31 samples during the July 2011 and 17 out of 31 samples during the August 2011 compliance periods.

On 09/28/2011 we became aware that our system recently failed to collect the correct number of drinking water samples. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we did (are doing) to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 01/02/2010 we did not complete all monitoring or testing for Stage 2 Disinfection By-products and therefore cannot be sure of the quality of our drinking water during that time. This violation is for failure to submit Sage 2 IDSE Report for disinfection by-products by the scheduled deadline of 01/02/2010.

What should I do?

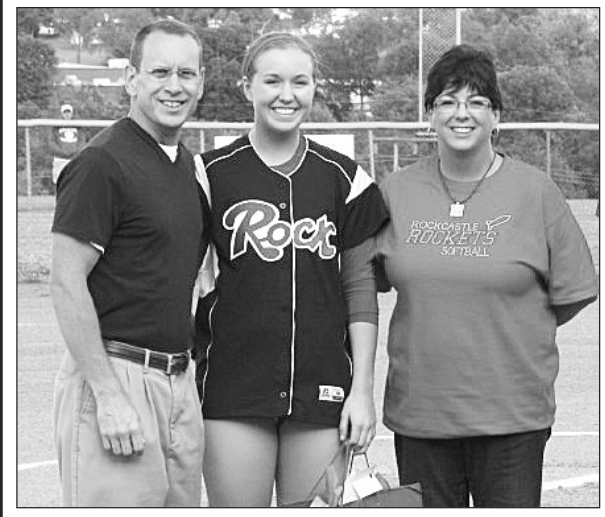
There is nothing you need to do. You do not need to boil your water or take other corrective actions. You may continue to drink the water. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours. We will announce any emergencies on WRVK-AM 1460 or WKYT-TV Channel 27.

What is being done?

Chlorine Violation: We have reviewed the regulations and made provisions that allow daily chlorine samples to be collected and recorded when our certified operator is away. Since receiving these violations, the city has contracted with another certified drinking water operator to fill-in as needed.

Stage 2 DBPR Report: Compliance with the Stage 2 rule required the city to collect DBP (HAA5 & TTHM) samples from two sites on a quarterly basis for one year. Any missing samples must be collected during the same quarter the following year. We failed to collect the fourth quarter 2009 sample, then again in 2010 which meant that the Stage 2 DBPR Report could not be completed by the deadline. We have since collected the DBP samples on 11/09/2011 and completed the Stage 2 Report.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

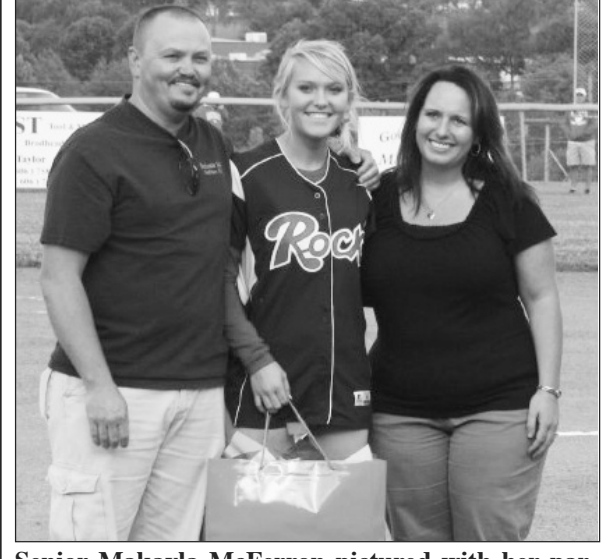

friends with Ponder during their service together.

“We became good friends.” Garrison said. “Earl was the kind of fellow that would grow on you.”

It was during the Battle of Luzon on June 6, 1945 that Ponder was shot in the arm and the foot by Japanese machine gunners who were hidden in the woods.

Garrison said they were out in an open field when they first came under fire and Ponder went down with his injuries. Garrison said Ponder was in some tall grass and was being pinned down by constant fire from the Japanese soldiers.

As bullets were buzzing through the air, Garrison took two of his squad members with him to rescue Ponder and get him to safety. Once they reached him, Garrison carried his head and another boy carried his feet while the other boy walked in front providing them with cover fire.

“The whole time I could see bullets spraying the ground between me and the boy in front of us.” Garrison said.

After the rescue, Ponder recommended Garrison for a citation for saving his life while under fire. But with the war ending a short three months after the Battle of Luzon Island, the Army overlooked the citation while they were busy sending thousands of troops back home.

Ponder had told Garrison about recommending him for the medal after the war but neither one of them followed up on the citation.

It wasn't until years later that Garrison mentioned the rescue to one of his nephews who got the Army to reopen the case. 58 years later, Garrison was awarded a Bronze Star for the bravery he shown while rescuing Ponder.

Garrison said he and Ponder remained friends long after the war. He said they would often see each other at least once a year and would often talk on the phone with each other as well.

“Earl hauled coal to Danville before the war and knew the country where I lived really well.” Garrison said. “He knew how to get here to visit me and would always stop if he was passing through.”

In 2009 Ponder passed away at the Rockcastle Regional Hospital. Garrison said he often thinks about Ponder and all the other WWII veterans who have passed away over the years, especially on Memorial Day and Veterans Day.

WWII soldiers are often credited with saving the world and the United States from a global evil that was spreading throughout Europe. Garrison said he couldn't agree more.

“We all knew this was something we had to do for everyone back home. If it wasn't for all of us, we could possibly all be speaking Japanese today,” Garrison said.

distant third to York and McKnight, polling 387 votes.

York will assume her duties as Rockcastle Circuit Clerk in January of 2013.

Meade wins State Representative seat

For the first time in 31 years, Rockcastle will not be represented in the State House of Representatives by a native son.

David Meade, a Lincoln County realtor, won the race to fill the seat of retiring Danny Ford over Mark Eaton and Roger Coldiron from Rockcastle and Jerry

Shelton from Lincoln County. There was not a Democrat challenger for the office.

Meade polled second in 13 of the 14 county precincts and won the Brown precinct 126-122.

Eaton won the Rockcastle vote 1478 to Meade's 835, Coldiron got 311 and Shelton 53. However, Lincoln County, with a much smaller total vote, gave their native son the heavy nod 867 to 89 for Meade and, in the four precincts in Pulaski County, Meade won 141-75 for a final victory margin for Meade of 201 votes.

24% of Rockcastle voters came out in the election, easily besting the state's 14% turnout.

Only 168 Democrats voted in the primary and, of those, 88 voted “uncommitted” instead of for President Barack Obama who polled 80 votes. Michael Ackerman beat his opponent Kenneth Stepp 85-66 in the Democrat primary for United States Representative.

Romney won the county and state in his bid to obtain the Republican nomination to face off with President Obama in November.

Statewide, Romney carried the day with 66.8% of the vote. Obama got 57.9% statewide but 42.1% of Democrat voters opted for “uncommitted” in that race.

Wednesday, Travis Burton, chairman of the Rockcastle County Republican Party, expressed his appreciation for those who took the time to vote in Tuesday's election. Burton noted that voter turnout was much higher here than in many other counties throughout the state. He also thanked all of the candidates who placed their name on the ballot. “Running for public office is no easy task and we are grateful that so many quality individuals stepped forward to lead the discussion about issues important to our community,” Burton said.

He also congratulated David Meade and Eliza York on their winning campaigns.

operation; \$660,575 for police department salaries and operation expenses; \$104,227 fire department chief and assistant chief salaries and operation expenses; \$42,343 debt service and \$25,000 project development.

The budget shows \$75,000 being expended for street maintenance, \$1,665,700 for water department operation and maintenance, \$326,801 for water department debt service and \$30,000 for miscellaneous expense. Appropriations from the sewer fund are \$730,100 for sewer department operation and maintenance, \$39,897 for debt service, the \$882,015 for the Rose Hill Project and \$12,000 in miscellaneous expense. And, \$2,400 will come from UDAG funds for the fire station loan.

Josh Bray, occupational tax administrator for the city, presented the ordinance amending the personnel manual to the council and noted the changes and additions made to the manual.

The addition to the policy concerns compensatory time and allows employees compensatory time off of work instead of payment for overtime hours. According to the policy, time will be accrued at the rate of one and a half hours per one hour worked over 40 hours.

Administrative and water and sewer employees may accrue up to 240 hours of compensatory time while police and maintenance employees may accrue up to 480 hours of compensatory time.

Payment for “comp time” may be requested in 25 hour blocks and the employees current rate of pay.

Two paid holidays were added to the policy -- the third Monday in February

(President's Day) and the 26th of December. In addition, employees are given up to four hours off on Election day with pay, to vote. Employees are also given eight hours with pay for the presidential general election.

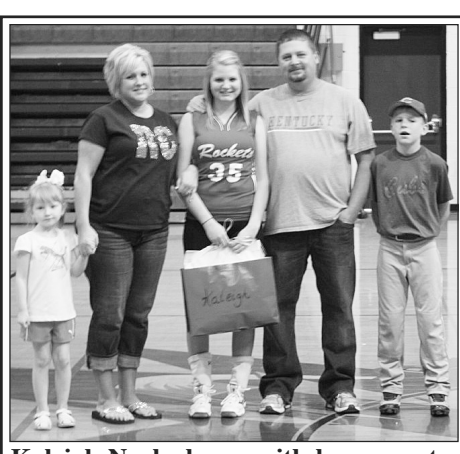

Teams places sixth

Johnson and Hunter win state track titles in Class 2A State Championships

The RCHS Girls' track team placed 6th at the Class 2A State Championships this past Friday at the University of Louisville. In a very close meet throughout, RCHS finished only 7 points away from a 3rd place finish and missed 5th by less than 1 point. Western Hills won the team title and Louisville Central placed 2nd. Former RCHS multiple state track champion Heather Hamilton, now the head coach at Paducah Tilghman, guided her team to a 3rd place overall finish. Boyle County placed 4th, only 6 points ahead of RCHS, and North Oldham was 5th.

Junior Michaela Hunter, a six-time outdoor state champion in track, won the triple jump state championship title this past Friday, defending her state title in the event from a year ago. Michaela's incredible jump of 38'3.25" shattered the previous Class 2A state record of 37'8" and also broke the Class 3A record mark of 38'2". Her jump was over 3' farther than her nearest competitor. This marked the third time this season that Michaela had surpassed the Class 2A state record; however, it had to be done at state to count as an official record. She will be an automatic 1st team all-state selection for her win in the event.

Michaela also finished as state runner-up in long jump with an awesome jump of 17'2.75". She won the state title in the event last year and had hoped for the state record in this event as well. Earlier this season, she tied the state record mark of 18'4" at Rockcastle's home invitational.

Michaela also placed 5th in both the 200 and 400-meter dashes. Last season, Michaela finished as state runner-up in the 200 and won her

third straight 400-meter dash. Hampered by a foot injury for most of this season, Michaela had difficulty finishing most of her races this season in her normal fashion. She still posted great times at state finishing the 200 in 26.78 seconds. She also ran well in the 400 finishing with a fast time of 1:00.97.

Junior Amy Johnson overcame a nearly season ending ankle injury to capture her first outdoor state title in the discus competition. Amy easily outdistanced the competition throwing an amazing 108', over 4' better than the state runner-up. Amy will be an automatic first team all-state selection in the event due to her state title win. Amy just missed scoring in the shot put competition, placing 9th with a great throw of 30'10.25". Amy is currently being recruited by the University of Kentucky and has been

invited by the throws coach at UK for a visit sometime in the near future.

Sophomore Lacey Gastineau scored an 8th place finish in the 400-meter dash at state with an awesome performance. Lacey blazed her way to a personal best time of 1:01.44. She also placed 14th in the 200-meter dash with an exceptional effort of 27.35 seconds.

Sophomore Alyssa Allen took a hard fall only days before state while practicing the 100-meter hurdles, but still managed some very impressive performances. She scored a 7th place finish in the triple jump competition at state with an awesome jump of 33'0.25". Alyssa also placed 12th in the 100-meter hurdles with an impressive time of 17.25 seconds.

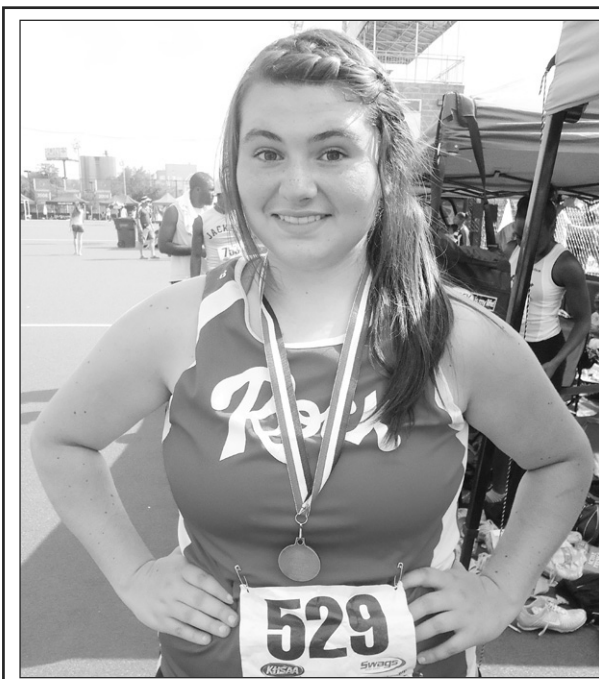
The RCHS girls' 3200-meter relay team of freshman Alyssa Cox, freshman Rachel Cain, 7th grader Sierra Mercer, and junior Bryonna Cromer finished 15th at state with an excellent season's best time of 10:51.98. The team finished only four seconds away from their season's best time achieved at region a week before. The team was also one of the youngest to compete in the event with two freshman and a 7th grader.

The RCHS girls' 800-meter relay team of 7th graders Jennifer Mercer, Arie-anna Lawson, and Katelynn Hensley, along with sophomore anchor Lacey Gastineau, finished 18th at state with an amazing season's best time of 1:53.57. The girls' fielded the youngest relay team in the competition. No other relay team had more than one middle schooler competing and only three other 7th graders ran in the relay at all.

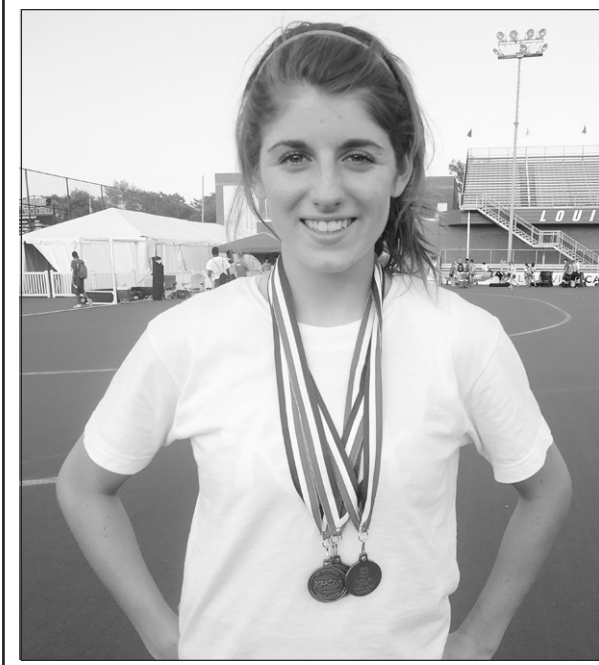

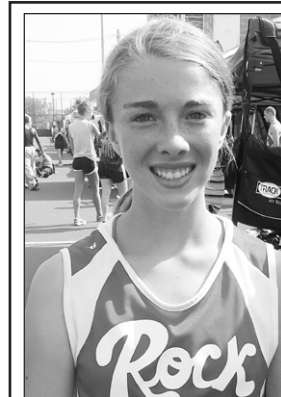

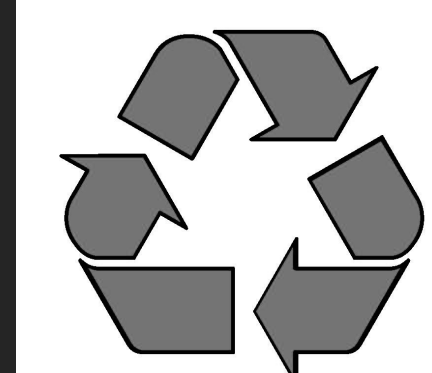

The following items may be recycled:
Newspapers w/inserts, magazines, books & catalogs, office paper, junk mail, phone books, plastic bottles & jugs (#1-7) (any size soda and water bottles, laundry detergent jugs, bleach and fabric softener jugs, milk and water jugs, cooking oil bottles and jugs, shampoo bottles, dish liquid and alcohol bottles (please rinse out jugs), metal cans (rinsed), empty aerosol cans, aluminum cans, glass bottles and jars, sheet glass, ceramics, computers, radios, phones, vacuum cleaners, clocks, cameras, camcorders, vcr/dvd players and satellite boxes.



Rechargeable batteries such as those found in: cordless power tools, cellular phones (the whole phone can be recycled), cordless phones, laptop computers, digital cameras, two-way radios, camcorders and remote control toys. If its says rechargeable on it, then it's recyclable!

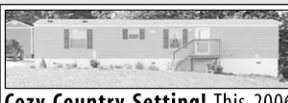

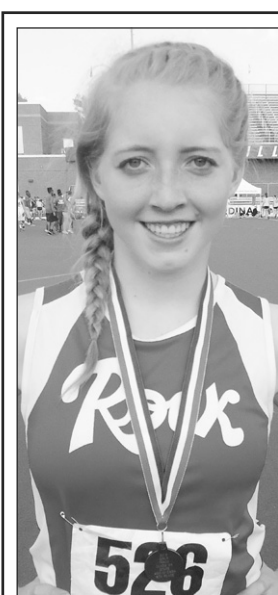

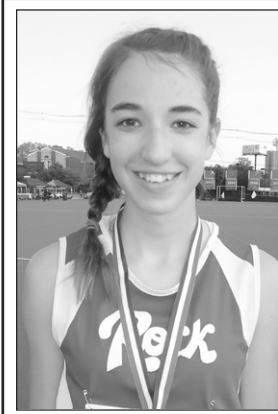

AN ORDINANCE AMENDING THE CITY OF LIVINGSTON WATER RATE AND SEWER RATE ORDINANCE, AS AMENDED

Whereas, the City of Livingston in order to meet its present obligations, as well as meet the increased cost of operating and maintaining the water and sewer systems, the City recognizes the necessity to adjust customer service rate and charges;

Now, Therefore, be it ordained by the City of Livingston as follows:

Section One: The Water and Sewer Rate Ordinance, as amended, is amended as follows:

A. Water Rates:

Sewer Rates

The former sewer rate was calculated on the basis of a \$14.00 minimum bill plus 80% of the water bill above 2,500 gallon usage

B. Connection Charges: The charge for a 5/8x3/4 inch water connection shall be \$500. Will be assessed for each sewer connection

C. Deposits: All applicants for service shall pay a \$150 deposit before installation of any water meter. Deposits are refundable after service has been disconnected and the final balance is paid in full. If the final balance is not paid in full or disconnection has taken place for nonpayment, the deposit amount will first be used to pay the delinquent amount and the difference shall be refunded to the customer. Another deposit must then be paid in order for reconnection. Disconnection will take place if delinquent accounts are not paid in full after one month, and reconnection fees will be charged.

D. Re-Connection Fees: Where the water supply to the customer has been disconnected for non-payment of delinquent bills, or where a meter is to be reinstalled for new customer at the location where one existed previously, a charge of \$50 will be assessed for reconnection of water service. The reconnection of service will not be made until all delinquent bills and other charges, if any, owed by the customer to the city have been paid. Anyone unable to pay there bill in full may sign a repayment contract in order to continue water and/or sewer service.

E. Leak Adjustment: The city will allow one leak adjustment per customer on an annual basis. In making a leak adjustment, the city will determine the customer's average monthly usage for the past 12 months. The city will bill the customer for their average usage at the current rates. All usage in excess of the average monthly usage will be charged at the current per 1,000 gallon rate the city pays for its purchase water plus an additional \$0.10 per 1,000 gallons to pay for the transmission cost.

F. Special Charges: Special charges shall be assessed to the customer in the following instances:

- A. \$25.00 will be charged on all return checks
- B. \$20.00 will be charged to reread a meter at the customer's request unless such reread reveals that the initial reading was erroneous. No charge will be made if the initial was incorrect.
- C. \$30.00 will be charged for a meter test when test is made at the customer's written request unless the meter is found to be faulty. No charge shall be made for testing a faulty meter and appropriate adjustments will be made in accordance with test results.
- D. A 10 percent late payment penalty will be assessed if bills are not paid by the due date.
- G. **Individual Fire Hydrant:** For each fire hydrant contracted for by a city, county, state or federal governmental agency or institution, private customer, private industry, or private institution, the connection and installation charge shall be \$2,000.
- H. **Multi-Unit:** The monthly charge for customers who have requested water service through a master meter for multi-unit service shall be the number of housing units times the minimum water charge per unit, based on the city's standard service meter minimum charge.
- I. All customers are required to sign a Water User Agreement. All new taps are required to purchase a plumbing permit. All business must be conducted at City Hall.

Section Two: All provisions of the Water and Sewer Rate Ordinance not specifically amended in this Ordinance, are hereby reenacted and reaffirmed and made a part hereof as if copied in full herein.

Section Three: All Ordinances, Orders, Resolutions or similar instruments in conflict with this Ordinance are hereby suspended and deemed null and void upon adoption of this Ordinance.

Section Four: The effective date of all rates and charges herein given shall coincide with the date of adoption of this Ordinance and shall be reflected in charges for services rendered on and after April 28, 2006

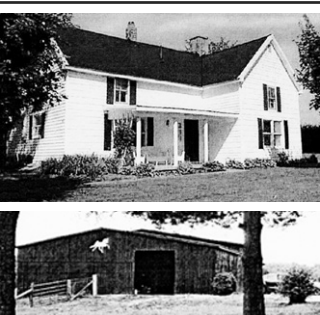

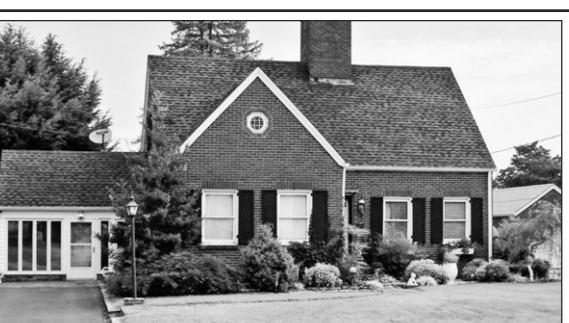

Thinking About Cleaning Your Carpet! Some things to think about...
What is the best way to clean my carpet, should I use the old technology of steam cleaning or the new technology of dry foam?

Option 1: Steam Cleaning-How does it work?

DAR daughter honors her patriot ancestor

With the help of his 5th great granddaughter, John Evans, an American Revolutionary War Patriot and War of 1812 Veteran is finally presented with his long awaited military headstone. On April 14, 2012, Rockcastle DAR member, Karen Adams, along with other family members escorted John's headstone to the family graveyard, at the Harrison Bustle Cemetery, located on Cromer Ridge in Laurel Co. Descendants that were on hand for the setting of the stone were: DAR members Karen Adams with husband, Mark; Tonya Cook with husband and descendant, Stanley Cook; 6th great grandson, Donald Hamm and son in law, Greg Hammons.

John Evans was born in 1765 in Caroline Co. VA. He enlisted in Henry Co. VA on February 1781 and served 5 months as a private in Captain Headspeth's Company under Col. Phillip's VA Regiment. He enlisted in August 1781 and served four months in Captain James Poteete's Company under Col. Tucker's VA Regiment. He was also at the siege of York. He stated in his pension papers that his service was on horseback called rangers or mounted infantry.

After the war, John came to Kentucky and lived in Lincoln Co. for awhile. There he met and married his wife, Mary Price in 1791. In 1798, they were living in Hawkins Co. TN and by 1804 eventually settled in Kentucky in the Cromer Ridge area of Laurel Co.

John again served his country during the War of 1812. He served as a Second Corporal in Captain Johnston Dycart's company under Col. William William's 11th Regiment KY Volunteers alongside his future son in law, First Corporal, John Bustle, who would later marry John's daughter, Sallie in 1825. Both were in the Battle of the Thames on October 5, 1813.

He died May 23, 1837 in Laurel Co. and was placed in the oldest section of the family cemetery. For one hundred seventy five years, John has been at rest with

only a rock for a headstone. No markings of his military service and sacrifice to his country to be known by future generations. Basically, forgotten in history. It was not until his 5th great granddaughter was researching the family tree for patriots did she discover his service in both wars. A request for a military headstone was made to Veterans Affairs in March of this year and it was approved and delivered shortly after that. The government will supply a military headstone free of charge if the veteran has an unmarked grave. The headstone was set in April and hopefully, once the paperwork is approved from NSDAR Headquarters; there can be a DAR marking ceremony for John and his daughter, Sarah Sallie (Evans) Bustle, sometime in the fall.

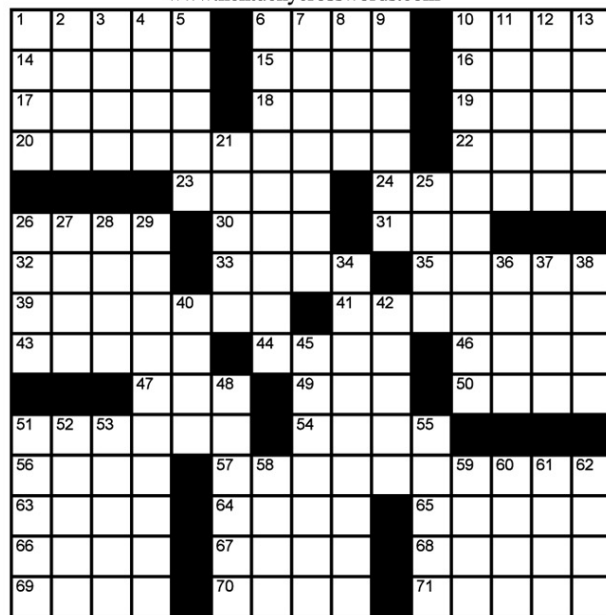
Mrs. Adams has been working on getting other military headstones for her ancestors as well. In June, she and her family will be heading to Harrogate, TN to set a military headstone for another American Revolutionary War patriot, Matthew Bussell (Anyone Bustle in the Rockcastle area descends from him).

"I think it is my duty not only as a descendant but as a DAR member, to honor my ancestors and their military service. If they had not made the decision to defend this newly named country, I might not be experiencing the freedoms today that so many people take for granted. So, anything I can do to bring light to the sacrifices and service made by veterans of all wars, is just a small token of the honor and respect they deserve from every citizen of this country."

All historical facts came from John Evans' Pension Application.

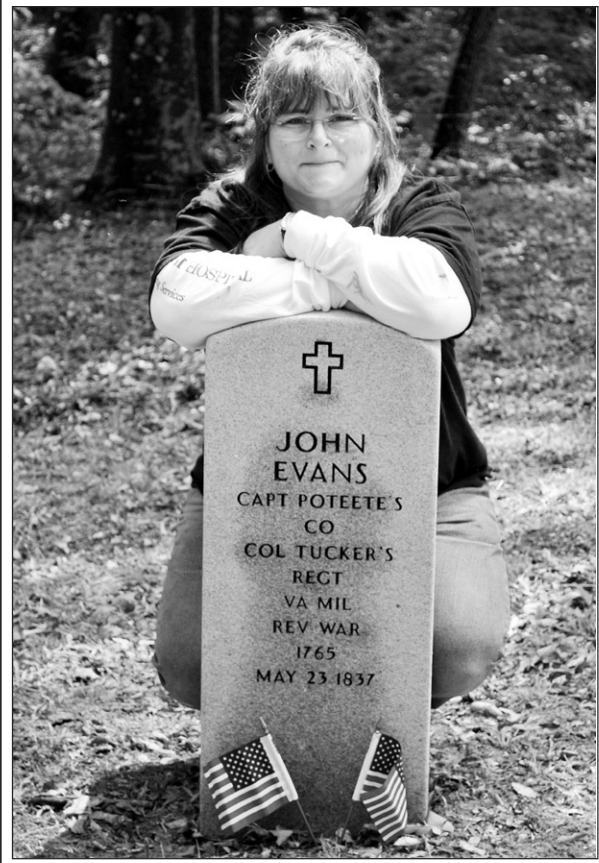
