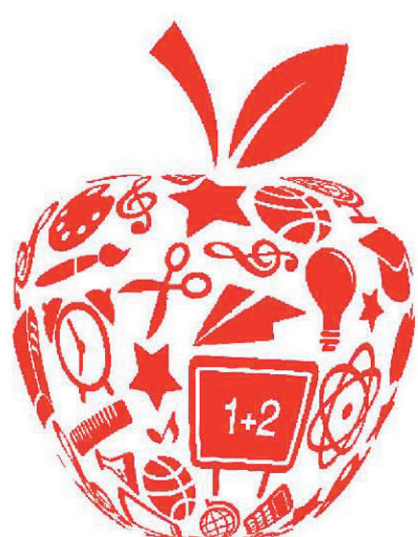

## Court gets \$31K health insurance premium cut; adds life insurance

Following on the heels of a \$60,000 cut in insurance premiums for employees last fiscal year, the

Rockcastle County Fiscal Court got some more good news this year -- a \$31,000 premium reduction and a return to Anthem Blue

Cross/Blue Shield as providers of the coverage. The decrease in premium costs apparently was attributed to fewer claims by employees, according to County Treasurer Joe Clontz.

Renewing the coverage was discussed at a special called meeting of the court Thursday. The magistrates decided not to decrease the employee portion of the premium since, for several years, the county absorbed hefty increases in the premium without raising the amount of employees contributions. Employees pay \$55.33, per pay period, for the high coverage and \$36.19 for the low coverage. The county pays \$308.60 for employees with the lower coverage and \$287.96 for employees with the higher coverage as their

One South Carolina couple visited Mt. Vernon last Tuesday, marking Rockcastle County off as the 2,739th county they've visited in the United States.

Ted and Jane Tofari of Port Royal, South Carolina, have made it their goal to visit all 3,142 counties in the United States. So far the couple has visited every county in 36 states and logged over 150,000 miles.

Their trip started in October, 1994 when the Tofaris said they began to get bored with the normal American life and decided to plan a trip.

"We used to work hard to pay for our house, cars, furniture, etc.," Jane said "But we never had any time for fun because we were always working."

So the Tofari's journey began when they decided to buy a 1988 Winnebago RV and take a cross country road trip. In 1994 they decided to quit their jobs and rent out their house in order to complete their goal of visiting each county before they die.

The Tofaris travel to every county seeking out the local courthouse and going through their own individual routines. Jane said she takes a picture of every courthouse and then heads inside to get an official seal stamped on a page in her scrapbook. Meanwhile, Jane, 73 said Ted, 75 remains

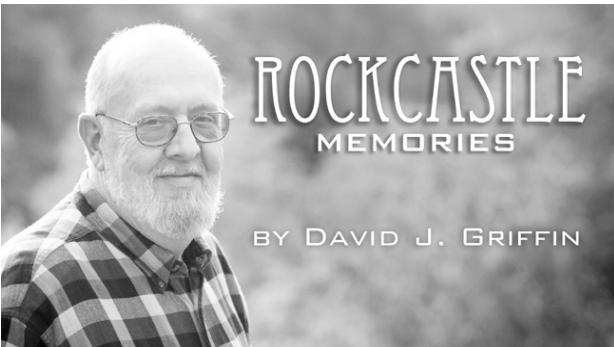

# ROCKCASTLE MEMORIES

## August Football Recollections

While a student at Mt. Vernon High School, I was captivated by the football team and the work that was involved with the game. That fascination carried over to the Rockcastle "Rockets" when the schools merged and I have been following them ever since.

When the first week of August rolls around, I can't help but recall my days of coaching high school football and the excitement of starting a new season. The air was filled with the popping of pads, the enthusiasm of experienced players, the anxiety of the younger players, and the determination of the coaches. My coaching experiences were at two very small schools in Kentucky - Campbellsville High School and the now defunct Mt. Sterling High School. Both had enrollments of approximately 350 students, and only 30-35 players would try out for the team.

We launched the year with "two-a-day" sessions, the first at 8:00 a.m. and then again at 4:00 p.m. Due to the heat, the first week of practice would be in shorts and helmets with no contact, just lots of running and conditioning.

By the end of the first week, only the true football players with honest desire and talent would remain, and the intense focus was getting down to the basics of the game. The coaches divided the team into four groups for individual learning sessions: the linemen, offensive backs, ends and linebackers, and the defensive backs. Coaches assigned to each group would fine tune the skills of the individual players in order for them to play their respective positions.

After mastering the drills, the groups were merged in order to learn the offense and defense. This lasted several days before the actual scrimmages began. Many of my former players have told me that this was the part of August that they found the most fun and memorable. It is worth noting that, due to injuries or the loss of players, we occasionally had to practice with half-line scrimmages because we could not dress 22 players at the same time.

Each of these schools had traditions that had been established over many years of success. For that reason, we were able to compete effectively against schools with larger enrollments and greater numbers of players on their teams.

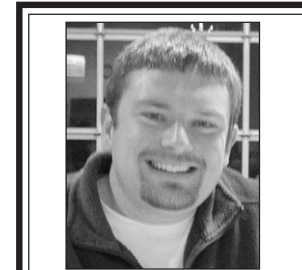
A good example is Mt. Sterling High School. We once defeated a Lexington school (Henry Clay) which had more than 100 players - while we had a mere 33 players dressed to play. At the beginning of that game, the opposing coach had his team members come out of the dressing room running in single file through the goal posts in order to intimidate our team. When lined up on the side line, they looked like an army. But MSHS wasn't about to roll over for them. We won with a score of 8-0. Because of heart and tradition, our players believed they could beat any team they faced. They proved themselves true to the task many times.

My most outstanding memory of coaching came during the 1969 season at Mt. Sterling. The Trojans had 38 players who made the team. We may have lost the first game when we played Tompkinsville in the long-established Recreation Bowl, but we only lost one other game that entire season. Never before had I witnessed such desire and performance from such a small

group of die-hard football players. We entered the State Playoffs with a record of 8-2-1, with a Class A Courier-Journal ranking of number 4 in the state.

The first Playoff game was against Dayton on Jones Field in Mt. Sterling. Our team got to use the new field house for first time at

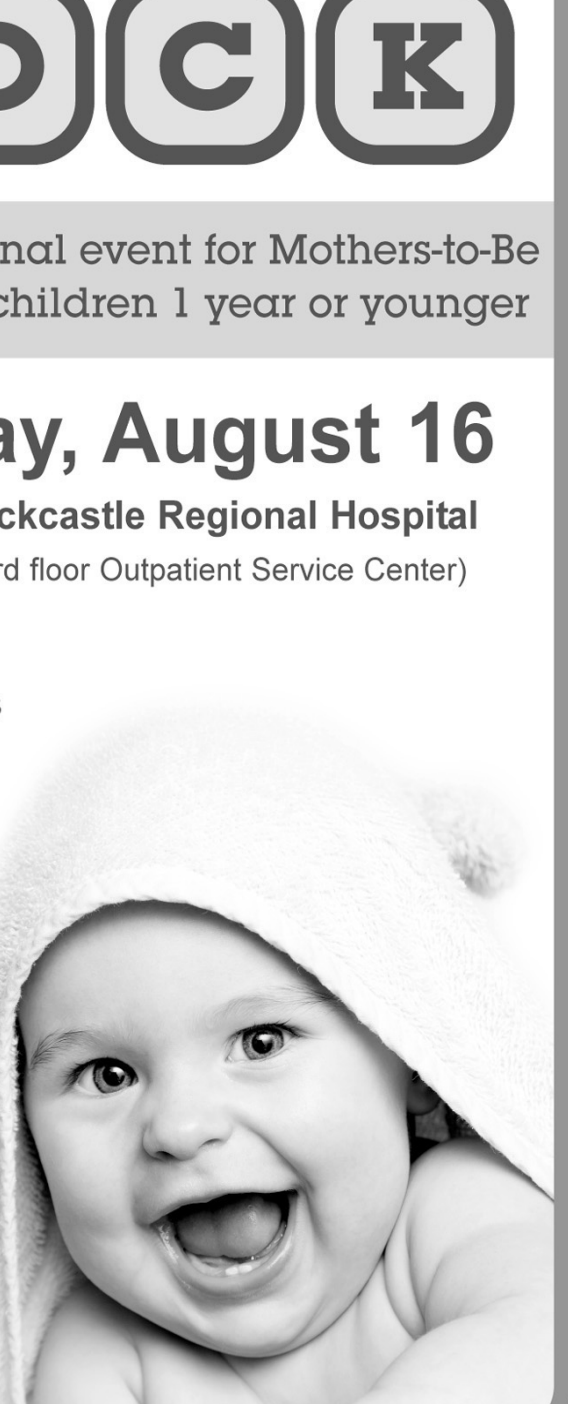

group of prestigious coaches and administrators turn a blind eye and allow this to continue to happen over a thirteen year period?

To me the whole situation could not have been handled any worse by Head Coach Joe Paterno. He had substantial evidence from many different sources that the child abuse was actually happening and he still never took the moral responsibility of notifying the police.

Now everything Paterno worked for during his 45 year tenure as Penn State head coach will be forever overshadowed by the child sex abuse scandal.

Don't get me wrong, the real victims here are the child abuse victims and not the Penn State football program. To me, it's a shame that Paterno and other administrators stood by and chose to do nothing to prevent further abuse from happening.

In my opinion, this scandal would have been avoided if Paterno and other administrators would have recalled one simple childhood lesson. When you lie and try to cover things up, it will always come back to catch you. It may be days, months or years but the truth

is always guaranteed to eventually come out.

The report stated that Paterno first began receiving complaints in 2002, the same year one of his assistant coaches even came forward saying he witnessed Sandusky abusing a young boy in the showers.

In 2002, it was clear that these numerous complaints were not just rumors and Paterno should have immediately notified police. In my opinion, Paterno should have also cut all ties to Sandusky and deny him any access to the football facilities.

pened. The kinship was, apparently, just one of those natural things that happen like the weather or perhaps it was simply meant to be.

But, by 1984, we were fast friends, Junior and me, and we had discovered that we had much in common. We both loved to fish and hunt and work in the garden. And Loretta and our kids, by then, actually thought that Molly Helton had hung the moon. Loretta was as bonded to Molly as I was to Junior and everybody, the entire Helton Clan and us were bonded to Molly's chicken and dumplings—

her pot roasts and corn bread and God-given talent to make anything, absolutely anything, taste just so that you knew that Molly Helton had prepared the dish.

Junior is the only person I've ever known who could make his eyes twinkle on the phone. His sense of humor was such that he was always pulling the legs of anybody around him but the dead give-away was that his eyes twinkled while he tried to hide his grin.

He'd call me at the office, this time of year, and ask what I was doing. Then he'd tell me about someone who knew someone who'd caught a big mess of catfish out of the Kentucky River, Or he'd heard tell that you couldn't fight the bass off in the lower end of Silver Creek. Or he knew a man who knew a man who'd let us drive right down to the creek on a Godforsaken place on Paint Lick, that hadn't been fished in 20 years. I could hear, if not see, his eyes twinkling, as he reeled me in but he knew I was a sucker.

I'd sneak off right after lunch and we'd catch bait with a minnow seine on Fall Lick, Back Creek, or some other little watershed with a knee-deep hole full of chubs and crowdads and, invariably, we'd come home with heavy strings of small mouth bass or catfish or white perch. It may have happened, but of the hundreds of times that Junior Helton and I fished together, I can't remember ever coming home empty handed.

On week-ends we'd tow my bass boat, sometimes over a hundred miles, way down the River, or to Laurel River, Woods Creek, Herrington, Green River, or Cumberland Lakes or even into Tennessee to fish after whatever was biting. But more often we just sneaked off to someplace close to home on hot July and August evenings where the

shade was deep and dark under the willows and the water was still and deep out there in the creek where we fished off the bank..

I would listen as Junior told me a "One time me and-----" tale and know that I would one day be telling "One time me and Junior----" tales to another younger generation.

I just wish that generation would hurry along. I have hundreds of fish tales to share with a kid or young person willing to catch the bait and dozens of places we can go where the fish are always biting.

"One time me and Junior were sitting right here and he tossed out a big hard crowdad. Last one in the bucket and so mean it could pinch you and bring the blood. He threw it right over yonder under the roots of that old sycamore and it never slowed down. Something grabbed it and kept right on going and Junior set the hook!!"

It would take me all the space in this paper to tell you that whole story but Junior caught that flathead catfish on that old hard shell and it weighed over fifteen pounds.

Junior Helton has been on the other side for nearly five years now. And my summers just turn more and more into melancholy. I desperately need a fishing buddy.

that game. The date was November 17, 1969, and this was the third game for the Trojans in only three weeks. The first half was scoreless, but the Trojans scored first in the third quarter when Eddie Miller hit Charlie Bill Owens for a 34 yard pass. We prevailed with a final score was 24-0, and the Trojans moved on to the second round.

On Friday, November 21, 1969, Mt. Sterling met the defending State Champions from Lynch in Harlan County. The temperature was bitterly cold, and fires were burning in large barrels on each side of the playing field. The Trojans scored first on a Miller-to-Robert Brooks pass in the first quarter, and Owens then ran the ball for a two point conversion. The half ended with a score of 8-0. In the third quarter, Lynch scored and added two points for an 8-8 tie.

During the fourth quarter, Lynch scored again to make the score 14-8, and their home town fans went crazy. With time running out, Coach Ishmael called a time-out and sent in a special play. Miller again passed the ball, but this time it was to Doug Cunningham in the end zone for the touchdown with only 46 seconds left to play. The game was tied 14-14. Ishmael decided to run the ball, and Charlie Bill succeeded by literally dragging two Lynch players into the end zone. The score was now 16-14. In the final few seconds of the game, Owens intercepted a pass and held on to run out the clock.

The climax of that sea-

son came on Thanksgiving Day at UK's Stoll Field when we defeated Bardstown 20-12 to capture the Class A State Championship. The Trojans scored first on a 20 yard pass to George Calico (who happens to now be my brother-in-law).

One of the most often discussed plays of the game came when Coach Ishmael called a tackle-eligible pass play. Tackle Perry Colliver lined up as the last man on the left side of the field, making him eligible to receive a pass. Miller passed to Coliver on the one yard line and Colliver made his way into the end zone. Later, it was noted that this was the only time in the season that we had used this special play.

That season established a bond among those young

men and their coaches which continues until this day, more than 40 years later. This is the best example that I know of the saying, "It is not the size of the dog in the fight, but the size of the fight in the dog!"

I still admire those guys for their heart and undeniably will to win. I remain proud of each of them and of my association with that team. And just as surely as August rolls around every year, I will continue to recall those players with great affection and that season with tremendous pride. There remains a bond between me and those boys that truly is worth more than gold.

# The Roots of Rockcastle

The Rockcastle River, the namesake of the county, is a most beautiful river that winds, twists, and turns its way through a large portion of the eastern and southern portions of the county. As most of us know, the source of the river is in the mountains of Jackson County with several contributing creeks and small streams along its meandering path. The largest and best known of these is Roundstone Creek that runs into the river

in the area of Livingston. The river, in the era before the first white men came to the area, served as a route for the native tribes to travel as they followed the game that was necessary for their survival. The natives, mostly Shawnee, sailed canoes in its water, fished from its banks, and hunted the animals that gathered near the banks to drink. As you can see, it was vital to the existence of these tribes. Later, the white men, fol-

lowing the Shawnee trails, used the river much the same way. However, their ultimate purpose was slightly different. They used the river as a route to a new land to settle and raise their families. The natives used it more for a hunting route. Daniel Boone forded the river near Livingston. Several noted long-hunters used the river, as well, so the Rockcastle River has quite a historical significance.

One of the mysterious qualities about the river is its unusual green color. It may be described as emerald or jade, with an almost transparency at times. I've never really spoken with anyone who knew for sure the source of the color, but I personally believe it may be contributed to the abundance of limestone rock along its route.

The other mysteries are what is known as "the sinks" and "the boils". "The sinks" are actually located in the Roundstone Creek in the vicinity of Mullins Station, about four miles north of Livingston. "The boils" is just south of Livingston. At some point, students from Eastern Kentucky University came to study the natural occurrence. They put a dye into "the sinks" and it came up in "the boils", proving it is the same stream of water.

According to a local resident, Ann Senters, whose property borders Roundstone Creek, there was a blast set off by the railroad in April of 1984 or 1985 that left a hole in the back of her property. The same occurrence, "the sinks" now is literally in her

backyard. At one time, there was a pump located at "the boils". It supplied water for the city of Livingston for many years. Even through droughts, "the boils" never ran dry.

The Rockcastle River has played many roles for many people who have forged their way through Rockcastle County, and to those who have settled here. I'm sure these occurrences were just as mysterious generations ago as they are today, perhaps even more so. They just add to the mystery and mystique of the "roots" of Rockcastle.

This column has not been documented or researched in any way.

## MAPLE WHISKEY GLAZED BEEF BRISKET

I have also cooked a rump roast and chuck steak using these two recipes. Just about any cut of beef is good cooked this way. If you are worried about the amount of alcohol in these recipes, you can use beef broth instead. The alcohol does evaporate during the cooking process. 2 tablespoons coarse salt 1 teaspoon freshly ground black pepper 4 to 6 pound beef brisket, scored with a knife on both sides 1/4 cup olive oil 1 cup real maple syrup 1/2 cup Jack Daniel's, or other whiskey 1/4 cup brown sugar 2 tablespoons tomato paste 2 oranges, zested and then juiced 4 cloves garlic smashed 8 slices fresh ginger, sliced thinly

Combine salt and ground black pepper. Rub all over beef and place in a plastic re-sealable bag or other container. Combine olive oil, maple syrup, whiskey, brown sugar, tomato paste,

orange juice, orange zest, garlic, and ginger; blend to mix. Pour over beef. Marinate for 2 hours or overnight. Transfer to slow cooker and cook on low 8 to 9 hours, turning once or twice. Thinly slice across the grain and serve with liquid spooned over beef.

## BEER BEEF BRISKET

3/4 cup firmly packed dark brown sugar 3/4 cup chili sauce 3/4 cup ketchup 1 pack (1.4 ounce) dry onion soup mix 1 bottle (12 ounce) beer 3 to 4 pound beef brisket 15 small red potatoes 1 to 2 pounds baby carrots Stir together first 4 ingredients; gently stir in beer. Place beef, fat side up, in a large crock pot or slow cooker; pierce several times with a fork. Arrange potatoes and carrots evenly around beef; pour beer mixture over beef, potatoes, and carrots. Cook on low for 6 to 7 hours. Remove beef from pan, and let meat stand uncovered for 20 minutes. Cut into slices and surround by potatoes and carrots.

It occurred many years ago when I was in the first grade. But after all of those years have passed, I have not forgotten it; I still remember it vividly.

Encouraging a group of elementary students in a one roomed country school, a good teacher reminded those of us who were her students that we could grow up to be whatever we desired to be. The key to that accomplishment, she told us, was simple. It involved living in readiness to seize opportunities for growth and development whenever those opportunities knocked. That important lesson was not from a textbook or from a lesson plan that the teacher had prepared. It came from her heart, for she often went beyond textbooks and lesson plans to remind those of us who were her students of that and other important lessons about life she thought we needed.

Through the years, I remembered the encouraging words and the sound advice of that good teacher, and her words encouraged me and helped me to move ahead in the right direction in life. Then, one day I was pleasantly surprised; her words became even more meaningful to me. I was reading a letter, an old one that is almost two thousand years old, that had been written to a small group of people living in Ephesus, a large commercial seaport city in the Roman province of Asia. In that letter, the author, a good friend and trusted leader, urged those to whom he wrote to "Be very careful, then, how you live---not as

unwise but as wise." Then, he admonished them to make "the most of every opportunity" that presented itself to them. In the difficult times and under the trying circumstances in which they lived, such living would give stability and bring needed direction to their lives.

An anonymous individual said that we do not have to "wait for opportunity to come; it's already here." But another anonymous individual said that it "is often lost by deliberation." Therefore, seize it and use it.

### SCHOOL BUS RULES AND REGULATIONS

The privilege of any pupil to ride a school bus is conditioned upon their good behavior and observance of the following rules and regulations. Pupils violating these rules and regulations shall be reported to the principal of the school which the pupil attends for necessary corrective action. Safety is the primary concern in the transportation of pupils. In order to assure proper safety, it is vital that pupils and parents understand the rules and regulations of school bus riding. Following is a list of basic rules and regulations adopted by the Rockcastle County Board of Education and the Kentucky Department of Education:

1. Arrive at a bus stop on time. The bus has many scheduled stops and cannot be delayed.
2. Never stand in the road while waiting for the bus. Parents should encourage safety measures for pupils as they wait for the bus and walk home from the bus.
3. Cross a safe distance (10 feet) in front of the bus so the driver can see you.
4. Take a seat upon boarding the bus and do not change seats while the bus is in motion.
5. The driver is in charge of the bus and pupils and has the authority to assign seating arrangements.
6. Keep noise to a minimum so that the driver's attention can be devoted to driving.
7. Do not extend arms, legs or head out the bus windows.
8. Obey the rules posted on each bus.
9. Do not block aisles in any way.
10. Knives/other sharp instruments are not permitted on the bus.
11. Never run toward the bus. Always load and unload when the bus has come to a complete stop.
12. Apply the above rule (No. 11) when transferring buses.
13. Never use the rear exit unless an emergency exists.
14. Ride only your assigned bus unless you have a signed note from the principal. Parents must write or call the principal to obtain permission for pupil to ride another bus or to exit at a different stop.
15. Report any damages to the bus.
16. Do not occupy more space in a seat than required.
17. Open and close windows in compliance with the driver's instructions.
18. Pupils and parents are to accept the responsibility of listening for dismissal announcements on the radio on days when inclement weather disrupts the regular schedule.
19. The following rules are of particular concern and the activities mentioned are prohibited at all times:
  - a. Use of profane/foul language.
  - b. Smoking or other use of tobacco on the bus.
  - c. Fighting on the bus.
  - d. Destruction of bus property.
  - e. Defiance of driver's authority.
  - f. Throwing objects on or from the bus.
20. **Disciplinary Action:** Violations of the above stated rules and regulations shall be reported to the appropriate school principal. The principal shall record the incident and determine the appropriate disciplinary action. Should any pupil persist in violating any of these regulations, it shall be the duty of the driver to notify the principal and, after due warning has been given to the pupil and such violation persists, the principal and/or board of education shall then forbid such disobedient pupil the privilege of riding the bus. Written notice of the action of the principal shall be furnished to the parents and the superintendent.

**Ride only your assigned bus unless you have a signed note from the Principal.**

Parents must write or call the principal to obtain permission for pupil to ride another bus or to exit at a different stop.

# Parents & Teachers School Bus Safety Alert

A child's clothing can be dangerous when getting off the bus. A number of children have been injured or killed when their clothing became caught when exiting the bus.

**Dangerous clothing that can get caught in handrails, doors or other areas include:**

- Jackets or sweatshirts with drawstrings
- Backpack straps
- Scarves or other loose clothing

**Please talk with your children about these Safety Rules:**

- Stay away from Danger Zones around the bus
- If you drop something near the bus, don't pick it up. The driver may not see you. Tell the driver and follow his/her instructions.
- Remember that motorists don't always stop for the school bus.
- Use extreme caution when getting on or off the bus.

To can or to freeze?

Soon, many vegetables and fruits will be ready for harvesting, and many gardeners will have more produce than they can readily eat. Those who want to preserve fresh, summer foods for later consumption will consider either freezing or canning the harvest. But is one way of preservation better than the other? The answer depends on the type of food you want to preserve. If proper techniques and correct temperatures are used, frozen foods retain greater amounts of their vitamin content, natural color, flavor and texture.

Freezing is perhaps the easiest food preservation method, but not all foods freeze well. Some vegetables with high water content are not well suited for use as raw vegetables after freezing, but work well as ingredients in cooked dishes, like soups. Green, leafy vegetables like lettuce, cabbage and celery can become limp and watery. They may also develop an oxidized flavor when frozen. Foods containing eggs or milk may separate water from solids or become tough, frothy or watery depending on the other ingredients. Freezing fried foods can cause them to lose their crispness and become soggy.

Freezing foods preserves them by stopping or slowing the growth of microorganisms that cause food-borne illnesses and spoilage.

Like freezing, canning, when done correctly, can stop the growth of microorganisms that cause food-borne illnesses and spoilage. Canning is a safe and cost-effective way to preserve foods. Many fruits and vegetables begin losing their nutritive value once harvested, so it's best to can foods at the peak of freshness. This is usually within six to 12 hours after harvest-

ing or purchasing from a farmers market.

You should know the acidity of the food you are canning. Foods high in acid can be prepared in a boiling water canner while low-acid foods must be preserved using a pressure canner to minimize food-borne illnesses.

If you're canning for the first time or have previous experience but want to can a new food, check that the food has recommended canning guidelines from the U.S. Department of Agriculture. These guidelines can be found in USDA's Complete Guide to Home Canning available online at [http://nchfp.uga.edu/publications\\_usda.html](http://nchfp.uga.edu/publications_usda.html). Do not can foods that do not have USDA guidelines, as the absence of guidelines for a particular food is likely due to a safety or quality

concern. The amount of freezer space or access to canning supplies and equipment are additional factors to consider when choosing the best way to preserve fresh summer produce. As food consumers become more familiar with food preservation, the question of freezing or canning becomes a choice based on taste, food preferences, convenience and available resources.

The University of Kentucky offers extension publications on the correct way to freeze and can foods. For more information on food preservation, contact the Rockcastle County Cooperative Extension Service at 256-2403.

## Yards to Paradise

Stepping out the kitchen door to a small garden where garnishes and salad items and herbs grow, that used to be the norm in bygone years. So did a backyard orchard to supply some apples for frying or cherries for a pie. I remember strawberry preserves, blackberry jelly and plum butter, too. Stores stocked more fruit and vegetable items this year, so I am not the only one thinking these thoughts. (And food from the landscape does not have to mean you let the landscape become the shame of the neighborhood.)

"Green, Green Grass of Home" used to be a fine country song (still is actually), but big green lawns with a tree or two are on their way out of favor. I am not advocating a radical jumping in with the "green" movement; but, how green or how natural is a sterile grass lawn with no weeds, no bugs, no worms for the robins (who can't survive on just seeds at the feeders), no ants, etc. A mixed landscape that includes naturalized areas, flowering bushes, fruit and nut bearing trees, a garden area—that's the trend, and it's sensible.

Apples, peaches, pears, cherries, pawpaws, serviceberries, and many other trees produce fruit and could be incorporated into a nice landscape. Sunflower

ers, peanuts, pecans—you'd be surprised what you could grow. Tomatoes are easy, but thornless blackberries, blueberries, rhubarb, and asparagus are other fine choices to add to the landscape and augment your meals and save on groceries. Strawberries are a natural for a raised bed somewhere in the yard...25 plants that bear for 3 years or more can produce quite a lot of desserts and fresh eating. Mature blueberry bushes can produce 20 pints or more each year. (What's a pint or half pint of them cost at the grocers?) Currants, gooseberries, honeyberries, cranberries—all worthy of a meal from the yard.

Dogwood trees among landscape favorites, but you can have your dogwood tree and eat it too. You just have to venture out and get a Kousa dogwood or a cornelian cherry dogwood, rather than the Florida dogwood most people plant. Other small trees that bear edible fruit and also work in the landscape might include serviceberry, persimmon, mulberry, elderberry, pawpaw, blackhaw viburnum and hazel nuts.

A grapevine that also has good fall color? A hops plant for the arbor? Vitamin C from your own rose hips? Add flowering cabbage,

flowering kale, edible pansies, violas and nasturtiums. Even the dandelions can make a fine dish for the table.

With some ideas on how to actually landscape with edibles, has it become obvious you can also save on the grocery bill for years with a little investment in fruit bearing landscape plants? Let's see, how about some purple pole beans or a bed full of pink half runners? Beans work fine on my plate, and I bet they would yours. And, planting a few dozen seeds in a flower bed might produce bean plants that look surprisingly attractive as well.

If you could put \$5 in the bank and draw out \$30 at the end of summer I bet you'd do it. How about putting in a pound of seeds and getting 30 pounds of food with just a tad of effort—what smart business persons wouldn't love those return rates on their investments?

Fitting a few thyme, fennel, sage, basil and chives plants into a crevice or niche would be so easy. There is more to this growing story on what the landscape can furnish to the table. We will do more chapters in the future on this subject. Here's to turning the yard into a vegetable and fruit paradise!

net told the committee that the governor had filed an executive order to create the exchange. “In fact, the executive order was not filed with the Secretary of State’s Office until after the meeting had started and obviously this unleashed many more questions,” Carpenter said.

“I learned that the facility would accommodate 210 employees and asked the representatives if these would be new hires and, if so, would they enter our already strained public pension system,” Carpenter recounted. He also reported that another senator asked if these planned health insurance proposals would cover abortion services and another asked what the budget was for the administration of the exchange.

“Many on the committee were stunned that there simply were no answers to these questions and we were told that they were still developing the plans and couldn’t tell us what they would or would not contain or how much they or the program would cost the state.”

In the end, the committee voted down the lease but the governor announced later that afternoon that the Secretary of Finance would override legislative wishes and continue on with the lease. “Let me be clear, there has been no legislative approval of the Governor’s actions regarding Obamacare’s health insurance exchanges,” Carpenter said.

According to Carpenter, Senate staff is researching what the options for the Senate are. “You can be sure I stand committed to protecting your rights and your tax dollars. share of each employee’s monthly premium. The county also furnishes a \$500 flex card which can be used to cover the policy deductible and for medical expenses not covered by the health insurance policy.

The court did decide to add a \$25,000 life insurance policy for every county employee at a cost of \$5,111 a year. Elected officials will also receive a life insurance policy, however it is limited to \$10,000.

In other business, during the special called meeting, the court once again held off on awarding the bid for construction of the Livingston Volunteer Fire Department’s new building.

Bids were opened at the regular meeting in July and the low bid of \$25,700 did not include labor for the concrete footer and slab. The next highest bid, of \$29,200 did so the court decided to contact the low bidder, Keith Bullock of Orlando, to get his price for labor for the concrete footers and slab to compare with the next low bid from Tim Sizemore which included the labor.

On Monday, July 23rd, another special meeting was held at which time, the court accepted the bid of Tim Sizemore for labor to construct the new Livingston Fire Department.

County Judge/Executive Buzz Carloftis told the court that he had contacted Bullock and got his labor cost for the concrete footer and slab and these were slightly higher than Sizemore’s who had included these costs in his bid. “It was the consensus of the court that, while both builders are known for very good and comparable workmanship, we elected to give Sizemore the bid,” Carloftis said after the meeting. Sizemore was the builder for the Pongo Fire Department building.

As part of the bid, all materials which will be paid for by the county, with an estimated cost of over \$70,000, have to be purchased in Rockcastle county and the county will provide purchase orders for the materials. Under this method, the county can save the costs of sales tax on the materials.

The project is expected to be started within three weeks, Carloftis said.

In other business Monday, the court also transferred \$60,000 from the occupational tax fund to the general fund.

With the support of Mayor J.C. Griffin and County Judge Exec Buzz Carloftis, committee members and partners such as the Healthy Community Committee and ARC Flex E Grants, Livingston has beautified the downtown area and gateways to the city. The focus now is creating an infrastructure that will support outdoor activities and marketing to bring tourists into the area.

Long range projects such as the development of Little Egypt into a recreational area with horse, bike and hiking trails and the desire to create a bike lane from south of Livingston to Hazel Patch Road are being discussed with individuals from the State Highway Department and a consultant from the National Park System.

“It takes a vision and people willing to take a vision and make it a reality. Let’s show the Governor and First Lady that Rockcastle dreams big and come to the August 22nd event in Livingston,” Tatum said.

Fairgoers will then be treated to the mud run starting at 7 p.m. on Saturday, August 11th.

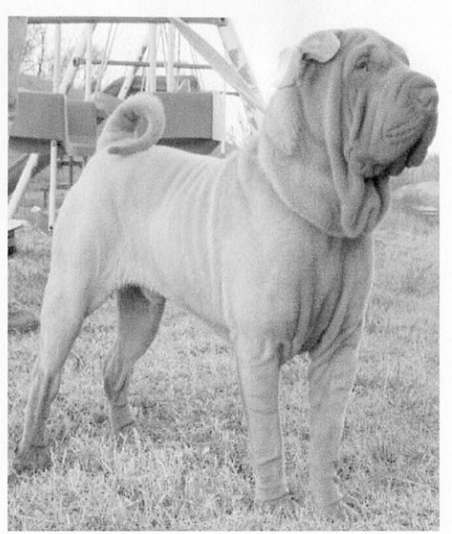

## Two local students help Habitat for Humanity

On July 14, Louisville Mayor Greg Fischer joined Habitat for Humanity of Metro Louisville at 2609 West Madison Street in the Russell neighborhood to celebrate construction of the organization's 377th home in the Louisville area.

Local High school students from the Governor's Scholars Program constructed the home in four weeks. Established in 1983, the Governor's Scholars Program celebrated its 30th summer in Kentucky by partnering with Habitat for Humanity to build the home as a service project.

Local RCHS students participating were Garrett Hasty of Brodhead and Jacob Houk of Mt. Vernon.

"This collaboration between Habitat for Humanity and these young Governor's Scholars is something our entire city and state should celebrate," Fischer said. "Two of our top goals are for Louisville to be a city of lifelong learning and to make it an even more compassionate com-

munity than it already is by encouraging community service. It's exciting that Habitat gave these students an opportunity to learn the value of service and continuous learning, and carry that spirit back to their hometowns across the Commonwealth."

This project supports the Governor's Scholars Program's mission to nurture Kentucky's future civic and economic leaders. This summer, 360 Governor's Scholars lived and studied on Bellarmine University's campus. The students, representing 93 Kentucky counties, joined the 50 members of the program's faculty and staff to volunteer 2,025 hours to build the house.

"This great achievement demonstrates that the Governor's Scholars Program continues to achieve its goal of building Kentucky's future, not only by enhancing the leadership skills of our Commonwealth's future generation, but most importantly by helping others achieve their goals," said Aris Cedeño, the program's executive director.

The new homeowners, Omar Muse and Ubah Adan, are originally from Somalia. They completed more than 400 sweat equity hours by working on their home and the homes of oth-

ers as a requirement for becoming Habitat homeowners. On Saturday, project leader Chuck Sgro presented the family with keys to their new home, after which Muse and Adan invited visitors inside for a tour of the home.

"Our new home will make it possible to gain the freedom we lost when we started living in rental housing," Adan said. "We also plan to continue volunteering with Habitat from now on. Our greatest accomplishment will be helping others who are less fortunate. One day, we will establish our own organization, whether it's building houses or doing relief work locally and internationally."

"We thank God for this opportunity, and for all the people who make it possible, for the homeowner program, and for the volunteers who contribute their time, money and sweat to Habitat in order to build affordable homes," Muse said.

Through donations of money, materials and volunteer labor, Habitat for Humanity was able to build the home in four weeks and sell it at an affordable price. Muse and Adan purchased the home with a zero interest loan, and their monthly mortgage payments will be used to build more Habitat houses.

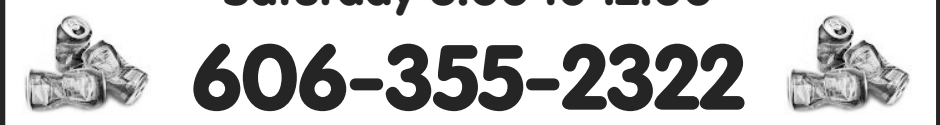

# Agricultural News

## Reporting 2012 Losses

Hot, dry and drought conditions across states have damaged some crops and slowed development of others. USDA reminds producers faced with questions on crop losses to contact their crop insurance companies and local USDA Farm Service Agency Service Centers, as applicable, to report damages to crops or livestock loss, and not to destroy or discontinue care for your crops.

Farmers and ranchers who participate in the federal crop insurance program (FCIC) are reminded to please contact your agent or company as soon as you experience any failing crops.

Producers who have purchased NAP insurance from the local Farm Service Agency are to report losses within 15 days of apparent damage.

USDA reminds livestock producers to keep thorough records of losses, including additional expenses for such things as food purchased due to lost supplies.

## 2012 County Committee Election

The election of agricultural producers to the Farm Service Agency (FSA) county committees is important to all farmers and ranchers, whether beginning or long-established, large or small operation. It is crucial that every eligible producer participate in these elections because FSA county committees are a link between the agricultural community

and the U.S. Department of Agriculture.

County Committee (COC) members are a critical component of FSA operations. The intent is to have the COC reflect the makeup of the producers and to represent all constituents. This means wherever possible, minorities, women or lower income producers need to be on the committee to speak for these underrepresented groups.

County Committee members provide local input for FSA programs, and operate within official regulations designed to carry out federal laws. County committee members apply their judgment and knowledge to make local decisions.

On June 15, 2012 - Nomination period begins for the 2012 COC Election.

To become a nominee, eligible individuals must sign nomination form FSA-669A. The form includes a statement that the nominee agrees to serve if elected. This form is available at [http://www.fsa.usda.gov/Internet/FSA\\_File/fsa669a\\_committeelectionform.pdf](http://www.fsa.usda.gov/Internet/FSA_File/fsa669a_committeelectionform.pdf)

Nomination forms for the 2012 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 1, 2012.

Agricultural producers who participate or cooperate in an FSA program may be nominated for candidacy for the county committee. Individuals may nominate themselves or others as a candidate. Additionally, organizations representing minority and women farmers or ranchers may nomi-

nate candidates. Nomination forms are filed for the county committee of the office that administers a producer's farm records.

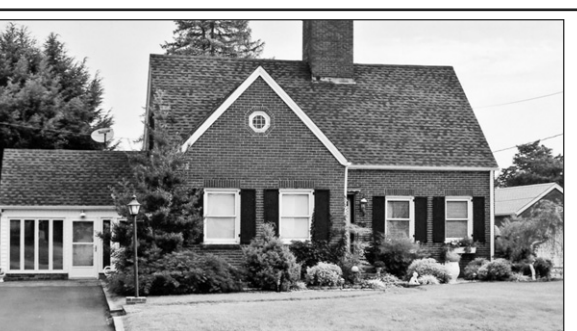
