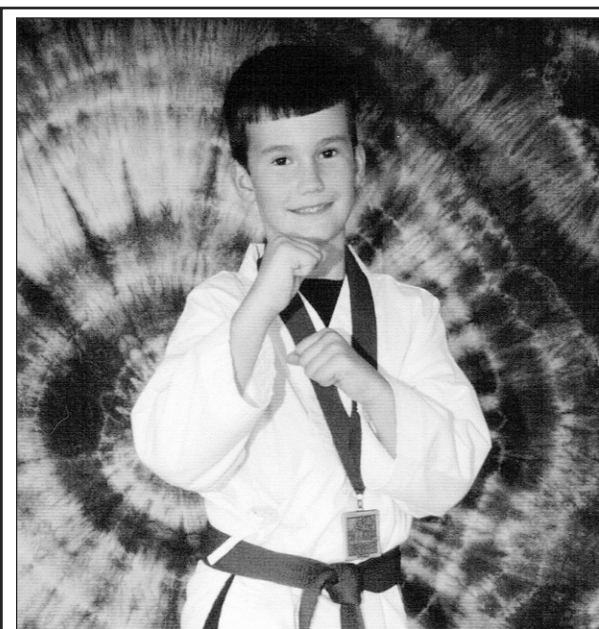

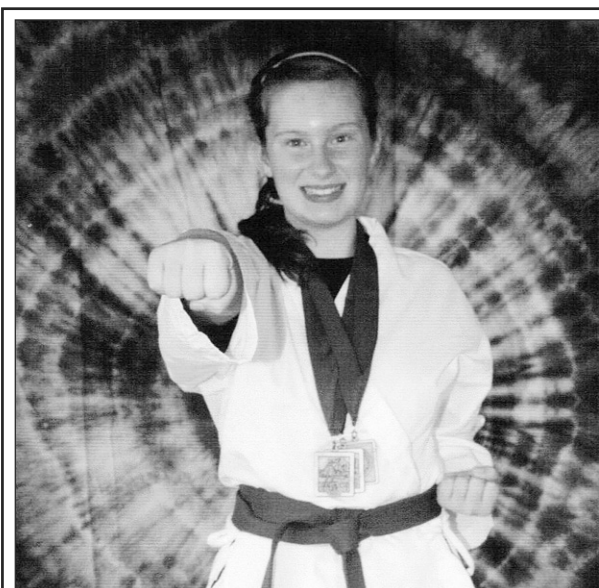

"If the home has a swimming pool we can pump water out of it to use on the fire," Dyehouse said. "The homeowner might not like having an empty pool to fill back up but if it saves their house then they usually don't mind."

Dyehouse said all the fire departments that attended will be able to serve their community better after having the countywide rural water supply training.

"It's important that fire departments know how to follow these procedures," Dyehouse said. "This has been proven to save structures and also save lives. After all, that's what we're all about as a fire department."

Kirby pleads guilty to murder

A Rockcastle man recently became the fourth person to be convicted in the January, 2012 shooting death of Jackie Bullock.

In July, Gary D. Kirby, 20, of Mt. Vernon pled guilty to Murder and Facilitation to Manufacture Methamphetamines. Sentencing has been set for August 10th.

Assistant Commonwealth Attorney Jeremy A. Bartley has asked for a 25 year sentence on the murder charge and five years for the facilitation charge to run concurrently.

Four others were charged in connection with the case and three have already been sentenced: Joshua Cameron and Bobby Peters are both serving 25 year sentences for their involvement and Hannah Hunsucker was sentenced to 20 years for complicity to murder.

The fifth defendant charged in the case, Haley Robinson's, aka Jessica Gibson, case remains pending before Judge Jeffrey T. Burdett. She is currently serving a four year sentence on unrelated charges.

"These are the most harsh sentences handed down in a shooting death in Rockcastle County in a couple of decades. We have met extensively with the family and, while no one can feel completely at ease when a loved one is killed, we are confident that these sentences will keep these individuals off the streets for a long, long time," said Eddy Montgomery, Commonwealth Attorney.

Bartley noted that all of the sentences involved violent time which means that the defendants must serve at least 85% of their sentence prior to being eligible for parole.

Mt. Vernon man arrested for wanton endangerment and terroristic threatening

But, back to the Olympics. I prefer the Summer Games, mainly because of

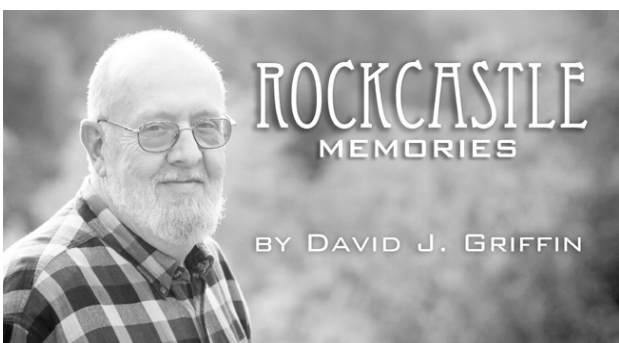
swimming, track and field and gymnastics.

"Rock Around the Clock"

I wonder how many of you can remember going to the Vernon Theater on Main Street in Mt. Vernon to watch the controversial movie entitled Blackboard Jungle. It played on the big screen in the spring of 1955, and it caused quite a stir in a number of communities. Many adults were concerned with the racial provocation, the language, and the violent nature of the film. My friends and I had already heard the music from the movie on the radio and were excited to see what all the commotion was about.

Personally, I was just getting ready to turn the corner on my teen years and could not wait to see the movie and determine on my own if the uproar was valid. Radio stations were already playing Bill Haley and The Comets and their hit song.

The plot of the movie revolves around a new teacher in an inner city boy's school. War veteran Rick Dadier (Glenn Ford) has just been hired at North Manual High School, his first teaching assignment. Dadier quickly learned that rumors of student discipline problems at the school were indeed true.

When he tried without success to exert discipline in his class, it provoked a violent response from one of the students' leaders, Artie West (Vic Morrow). The other problem child was Gregory Miller, a role played by Sidney Poitier. Dadier used various attempts to engage his students in classroom instruction, finally coming to the point that he either had to leave and teach at a "real" school or stay and commit himself to getting through to his class - which, of course, he did.

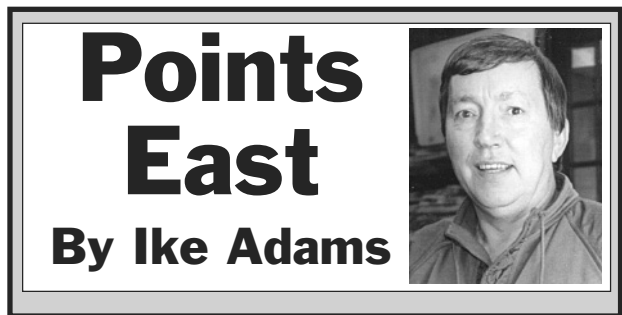
The film introduced rock and roll in its music soundtrack with Bill Haley and His Comets singing

"Rock Around The Clock" at the beginning of the film. The music led to a large teenage audience for the movie, who then bumped the song into the Top 40 charts to reach the number one spot. It remained there for eight weeks. This was the first rock song ever used in a Hollywood feature.

Teens flocked to the film, sometimes dancing in the aisles as the song played over the opening credits. "Rock Around the Clock" eventually sold 25 million copies, making it the second highest selling single of all time, after Bing Crosby's "White Christmas." Dick Clark labeled the song as "The National Anthem of Rock and Roll."

Billboard Magazine calls the song, "The most identifiable song ever. When people hear the song, they instantly think of the 50's." Journalist Alex Frazer-Harrison wrote about the song saying, "Before it became a hit in the summer of 1955 - more than a year after it was recorded - rock n' roll was virtually an underground movement, something kids listened to on the sly. This changed after 'Rock Around The Clock,' the music was everywhere."

As a result, Bill Haley has been called by some as



For the first ten years or thereabouts that we lived on Charlie Brown Road, Loretta kept an asparagus fern sitting on the front porch from early spring until mid-October. Potted in an old churn, it never bloomed but it was one of those plants that stay green year round and require almost no maintenance other than a pint of water when one of us thought about.

Ben Wren (I named them Hen and Ben) never came about while the eggs were incubating. He roosted in the trees in a fence row beside our

lawn. Every morning at the crack of dawn he would be gustily singing "sweet-tater, sweet-tater, sweet-tater" over and over at the top of his lungs. (My pal, Tom Miller, maintains that the lyrics are "cheese-burger, cheese-burger, cheese-burger" but my mom taught me that it was "sweet-tater" and that's what it sounds like to me). Anyway it's the happiest birdsong I've ever heard.

About three weeks after Hen went on the nest, both she and Ben could be observed flying to and from the garden and the surrounding pastures from daylight till dark returning within minutes with mouths full of crushed bug or dangling worm that they placed in a gaping mouth before repeating the process many times each day. In rainy weather, Hen would stay on the nest while Ben shouldered all the hunter-gather responsibility.

By mid-July the babies would start practicing flight from the fern to our porch swing and then from the swing to the huge azalea bush in the front yard and back to the nest in spite of much fussing and scolding from Mom and Dad. Three or four days later the entire family would make it into the tree line and they would

Restaurant chain Chick-fil-A has recently re-entered the political limelight after an interview with their president appeared in the Baptist Press on July 16th.

"the father of rock and roll" and rock and roll's first star. Haley said, "We premiered it. We put country and western together with rhythm and blues, that was rock. The first three years were ours, all ours, until Presley came along."

I vividly remember seeing the movie for the first time with several of my friends. As soon as the song began, many of the teenagers in the theater jumped out of their seats and headed for the isles in order to "jitterbug" to the sounds of Bill Haley and His Comets. Keep in mind that this was the first rock and roll song to be part of the soundtrack of a movie. We went crazy. Check out the lyrics and see if you too are transformed

back to the 50's.
One, two, three o'clock, four o'clock, rock
Five, six, seven o'clock, eight o'clock, rock
Nine, ten, eleven o'clock, twelve o'clock rock
We're gonna rock around the clock tonight
Put your glad rags on, join me, hon
We'll have some fun when the clock strikes one
When the clock strikes two, three and four
If the band slows down, we'll yell for more
When the chimes ring five, six and seven
We'll be right in seventh heaven
Oh, when it's eight, nine, ten, eleven too
I'll be goin' strong and so would you
When the clock strikes twelve, we'll cool off then

Start rockin' round the clock again
We're gonna rock around the clock tonight
We're gonna rock, rock, rock 'til broad daylight
We're gonna rock, gonna rock around the clock tonight
It is hard to believe that almost half of a century has passed since the song became the "flag bearer" of the new rock and roll music of the 50's. It is even harder sometimes to appreciate the full impact that the song has made on music history. John Lennon said, "I had no idea about doing music as a way of life until rock and roll hit me. It was 'Rock Around The Clock' that specifically hit me!"

There has been some dispute as to what qualifies as the first rock song ever recorded, but "Rock Around The Clock" was the first rock song to top the charts, and it is generally considered the beginning of the Rock Era. No matter which song was first, Haley's recording will always be the beginning of rock and roll as far as this Boomer is concerned. I was there, and there was no song as significant as the original Bill Haley's "Rock Around the Clock."

"Points East"

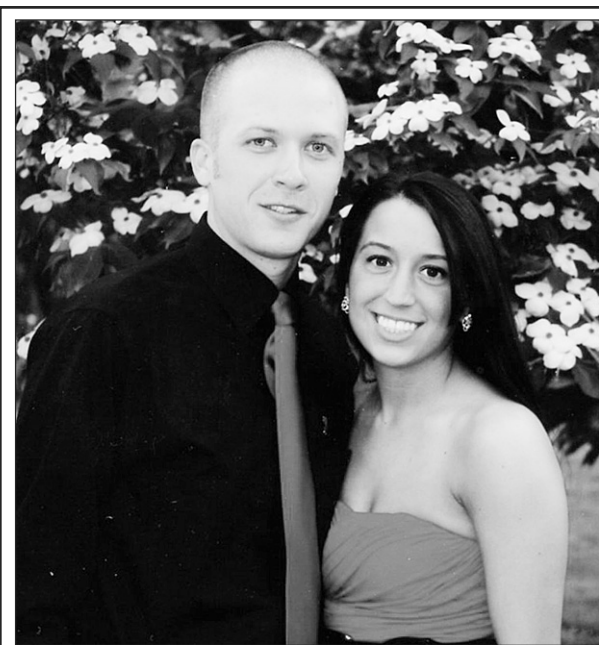

Our first scheduled stop was at the Old Stave Church at Borgund. This church dates back to about 1150 A.D., and it is one of the better-preserved medieval

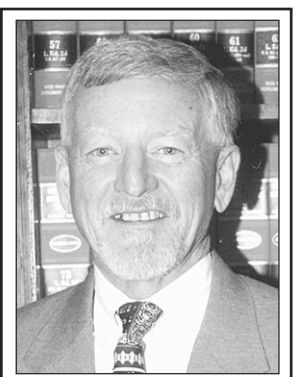

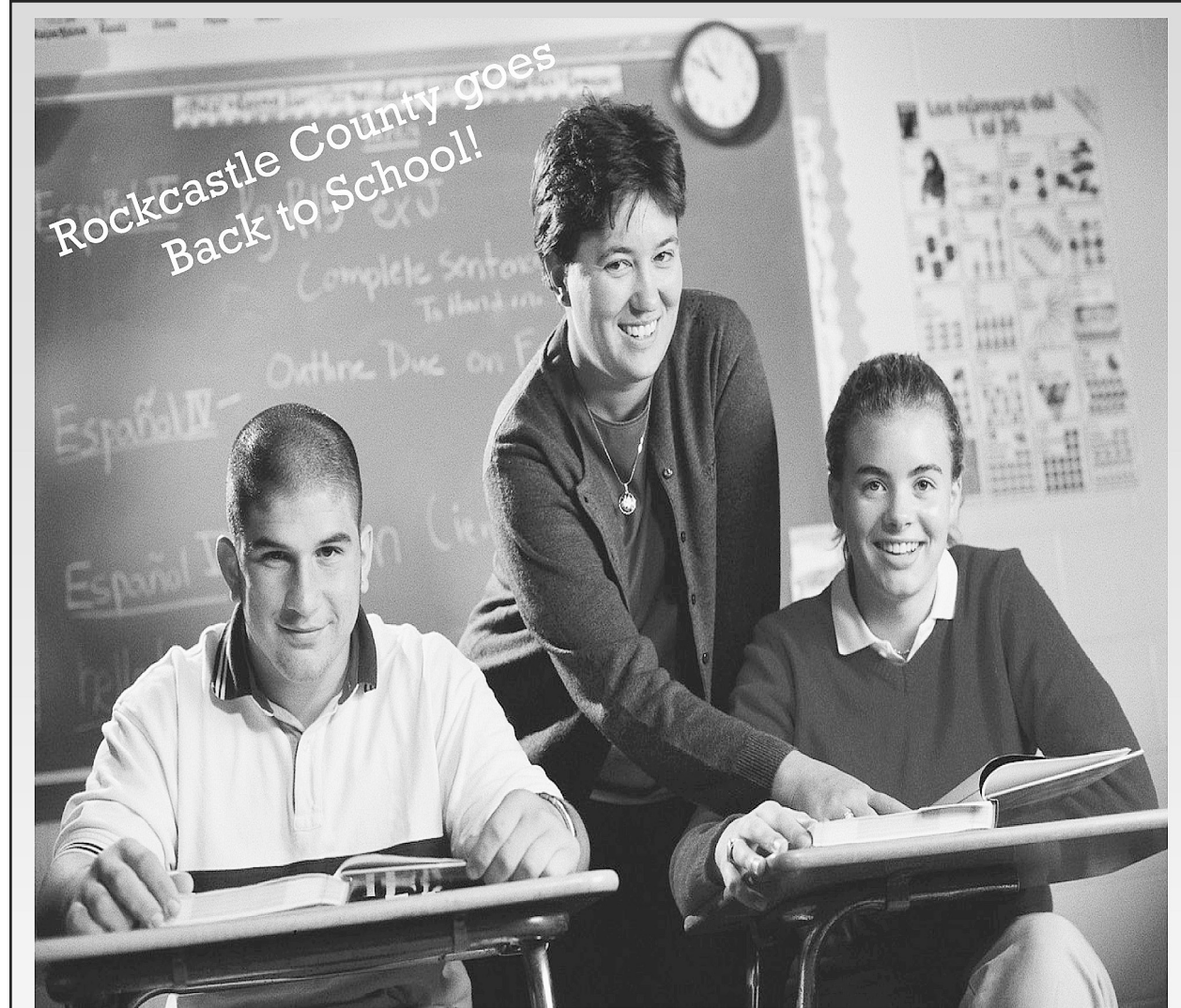

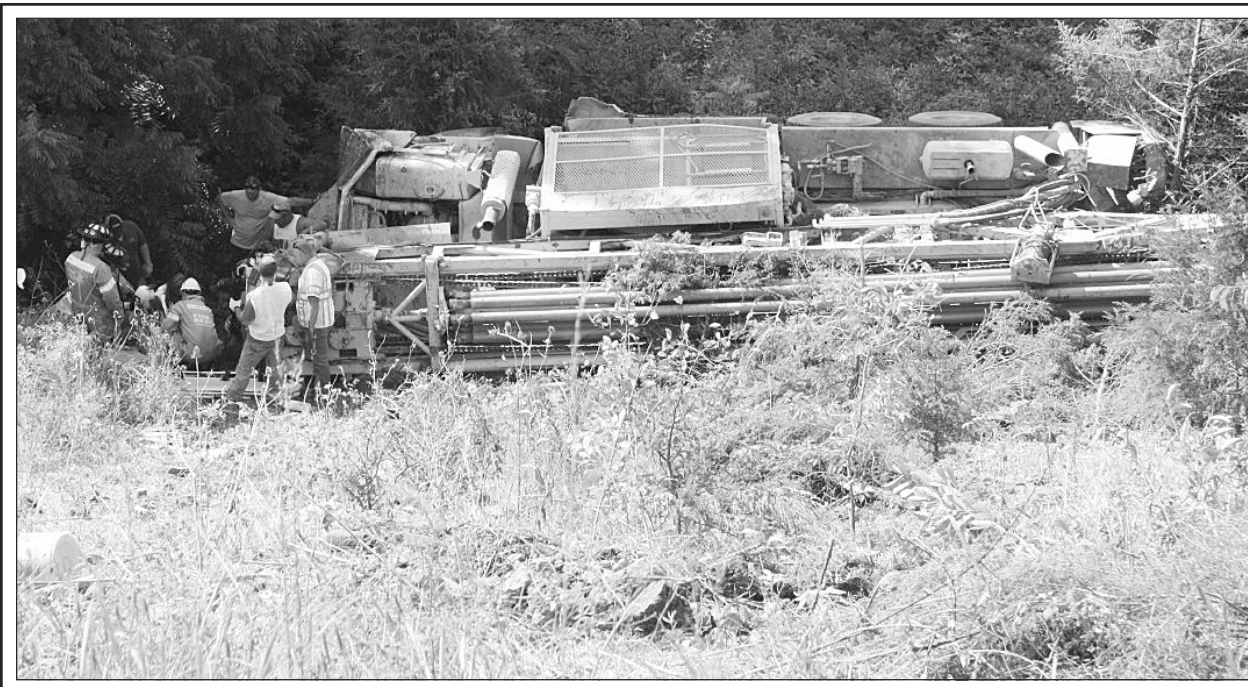

Since his grandma’s birthday party, Stallsworth said he wanted to try and raise money for a new piano since the residents enjoyed listening to music.

“They do love listening to people play music down there,” Stallsworth said. “It allows everyone there to relax and gives them something to do as well.”

Stallsworth said it would also be a huge benefit to the community as many school and church groups also come to the rehabilitation center to play for the residents.

Stallsworth said he has prepared a budget for a new Kawai upright piano that would cost around \$5,000. He said he plans to collect donations by dividing the full amount by the number of keys on the piano which is 88. The cost of each key comes out to \$56.82. Stallsworth said he plans on putting up a banner in the nursing home of a piano with 88 keys to show their progress on how many keys have been donated.

Stallsworth is a Robinson Scholar recipient who will attend the University of Kentucky next fall and plans on majoring in Computer Engineering.

Even though he will be busy with school, Stallsworth said he still plans on working out a schedule with the rehabili-

tation center so he can come back and play the piano for his grandma and the other residents.

Homeless man arrested for manufacturing meth

A homeless man was arrested last Tuesday night for manufacturing methamphetamine after police made a traffic stop on Williams Street in Mt. Vernon.

Arrested at the scene was Franklin D. Bland Jr., 40, (listed as homeless.)

According to Mt. Vernon police reports, Assistant Chief Barry Adams made the stop after observing Franklin’s vehicle swerving back and forth across the center line on West Main Street before turning onto Williams Street.

Upon receiving consent to search the vehicle, officers found multiple items that are frequently used to manufacture meth including a box of pseudoephedrine tablets, a pack of coffee filters, one 32 ounce bottle of Liquid Lightning drain cleaner and one HCL gas generator with attached tubing.

Inside the trunk, officers found a milk crate containing a partially empty one gallon can of Coleman fuel with a small white funnel inside. Officers also found a nylon cooler containing a zip-lock bag of ammonia

nitrate and a small measuring glass.

Bland was charged with manufacturing methamphetamine and remains lodged at the Rockcastle County Detention Center on \$25,000 cash bond.

Highly Erodible Land Initiative

Farm Service Agency announces HEL sign-up under CRP

John W. McCauley, State Executive Director for the Kentucky USDA Farm Service Agency (FSA), announced that continuous sign-up for the Highly Erodible Land (HEL) Initiative under the Conservation Reserve Program (CRP) started on July 23, 2012.

Kentucky received a total allocation of 39,400 acres to enroll in the HEL CRP program. Offers will be accepted until either the state acreage allocation limit is reached or September 30, 2012 whichever occurs first.

"CRP is a voluntary program that has protected environmentally sensitive land for more than 25 years," said McCauley. "This initiative

will accept offers with an erosion rate of at least 20 tons per acre per year for new cropland or CRP acres that expire on September 30, 2012; however, existing grass stands that are not considered expiring CRP will not be considered eligible," he said.

Producers can stop by the local County FSA office to determine if their land qualifies for the Highly Erodible Land Initiative and to receive additional location-specific details.

Landowners enrolled in CRP receive annual rental payments and cost-share assistance to establish long-term, resource conserving covers on eligible farmland.

Incentive payments are not authorized under this initiative.

New land contracts approved during this continuous sign-up initiative will become effective the first day of the month following the month of approval and are valid for 10 years.

CRP contracts set to expire on September 30, 2012, may be offered for consideration and approved contracts will become effective October 1, 2012, and are also valid for 10 years.

Mamaw's Kitchen

SWEET SKILLET BREAD
2 eggs, lightly beaten
1 1/2 cups of milk
1 teaspoon vanilla
1/4 cup of packed brown sugar
2 cups of flour
1 1/2 teaspoons of baking powder
1/4 teaspoon of salt
2 cups corn oil for deep-frying
Confectioner's sugar or cinnamon sugar - for dusting (syrup or honey) optional
In a bowl, beat eggs, add milk, and brown sugar. Sift together flour, baking powder, and salt; fold into egg

mixture until smooth. In an electric skillet or medium size cast iron skillet, preheat 1 inch of oil to 375 degrees.

Snip a corner from a heavy, plastic zip lock freezer bag to fill with a small amount of batter (about 1/2 cup at a time) and squeeze gently. Squeeze batter pancake shaped into heated oil...can also squeeze into figure 8 shape, coil shape, or circle shape.

Fry for 2 minutes on each side or until golden brown. When brown remove from skillet with a large spatula

to a plate. While still hot, sprinkle with confectioner's sugar or cinnamon sugar (can shake in a plastic or brown lunch bag). Drain on paper towels.

SWEET GREEN TOMATO CORNMEAL MUFFINS

2 cups seeded, diced green tomatoes
1/2 cup sugar, divided
1/2 cup butter, melted and divided
2 cups self-rising white cornmeal mix
2 teaspoon lemon zest
5 large eggs
1 container (16 ounce) sour cream
Cooking spray
Preheat oven to 450°. Sauté tomatoes and 2 tablespoons sugar in 2 tablespoons melted butter in large skillet over medium-high heat for 10 to 12 minutes or until tomatoes begin to caramelize and turn light brown. Stir together cornmeal mix, lemon zest, and remaining sugar in a large bowl; make a well in center of mixture. Whisk together eggs, sour cream, and remaining melted butter; add to cornmeal mixture, stirring just until dry ingredients are moistened. Fold in tomatoes.

Generously coat muffin pans with cooking spray; spoon batter into molds, filling two-thirds full. Bake at 450° for 15 to 17 minutes or until wooden pick inserted in center comes out clean.

Though many areas of life are recovering from the economic downturn, domestic violence shelters throughout the United States report that the economy continues to significantly affect battered women and children. While shelters shine a spotlight on the widespread increase in domestic violence survivors seeking help nationwide, they also highlight a substantial decrease in shelter services, funding sources and prevention efforts to assist victims. In addition, shelters report that the abuse is getting more severe, survivors are staying in abusive relationships longer and shelters expect the situation will only stay the same or get worse in light of the economy – according to the fourth national “Mary Kay Truth About Abuse Survey.”

More than 730 domestic violence shelters across the country were recently surveyed. Detailed national findings from the 2012 “Mary Kay Truth About Abuse Survey” reveal alarming trends in light of the economy’s decline since 2008, including:

Unfortunately, the economy has had a devastating impact on local domestic violence shelters. Many have had to reduce their capacity, reduce services and, in some instances, have closed their doors.”

Exhibits will be entered in Monday, August 6, 2012 at the Rockcastle County High School FFA Department from 9:00am-12:00pm. Exhibits will be picked up same day after judging.

AGRICULTURAL FAIR RULES & REGULATIONS

1. The Brodhead Fair is planned and conducted according to Kentucky Department of Agriculture regulations for use of State Funds.

2. All entries must be on grounds and remain on display to conform with regulations.

3. All exhibits (except open livestock shows) are limited to residents of Rockcastle County.

4. 4-H and FFA members are eligible to show in all open division classes with the same animals as shown in 4-H and FFA departments. All entries must be made prior to the show.

5. The Fair Board reserves the right to combine classes when a class has fewer than three entries and/or two exhibitors.

6. All livestock must be accompanied by an official health certificate in keeping with the State Department of Agriculture health regulations.

7. No individual may take more than one entry in any one class, except that two may be entered in livestock classes.

8. The Fair Executive Committee reserves the right to interpret and resolve all matters connected with or incident to the fair.

9. The Fair Board will not be responsible for losses, accidents, injury to persons, animals or other exhibits, but will take precautions to prevent any losses.

10. Money not used in one division may be transferred to another division on the Danish system.

11. Foods, fruits and vegetable entries are to be made on paper plates. Canned foods are to be exhibited in standard canning jars. Jars that are not sealed will be disqualified.

12. When there is only one entry in a class, it is the discretion of the judges to determine the ribbon received.

Firefighters train to use bodies of water as source for house fires

Members from five Rockcastle County volunteer fire departments met at Lake Linville last Tuesday for rural water supply training.

Members from the Brodhead, Mt. Vernon, Livingston, Western and Brindle Ridge fire departments were trained on how to use bodies of water as a water source to extinguish large structure fires in rural areas of the county.

Brodhead Assistant Fire Chief John Dyehouse said that every fire engine and tanker is loaded with water while it is parked in the station. However, he said when they are called out to a structure fire, if its fully involved that it will take a lot more water to put the fire out.

"On small fires we usually don't need to pump water from a hydrant or body of water but if it is a large fire we have to," Dyehouse said.

However, Dyehouse said, 80 to 90 percent of the county does not have a hydrant available since they are mainly only in the city limits. He said the rural water supply training teaches firefighters how to save houses in rural areas of the county where a hydrant isn't available to them.

"If we make a run to a large structure fire in a secluded section of the county, we can use a nearby river or creek as a water source as opposed to driving miles away to the nearest hydrant," Dyehouse said.

Dyehouse said that by using nearby bodies of water, firefighters have a quicker response time in fighting structure fires.

"In firefighting, time is everything," Dyehouse said. "By the amount of time it takes to pump water from the nearest hydrant miles away, the structure could become fully involved and be a total loss."

Officer Rogers receives 2012 Governor Award

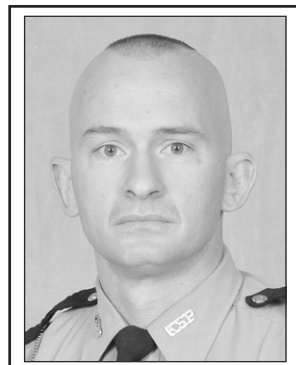

from inside the cave of the Renfro Valley Barn Dance on station WHAS. Mr. Lair, originally from Rockcastle County, was a musician, DJ, musical promoter, and entrepreneur. Lair worked at radio stations WLS in Chicago and WLW in Cincinnati before he moved back to Kentucky in 1939 and became part owner of Great Saltpetre Cave.

Later, after acquiring the cave from his partners, he set out to develop a tourist attraction to share the history of the region with visitors. Lair transformed Great Saltpetre Cave from an abandoned saltpetre mine into a tourist cave complete with trails, stairs, bridges, electric lights, a museum area, and even a stage for entertainment. Over the years, Echo Auditorium, the largest room in the cave, has been the setting for music shows, church services, weddings and a movie, among other things.

For the past seven years the 306 acres that make up The Great Saltpetre Cave Preserve has been owned by The Rockcastle Karst Conservancy (RKC), a non-profit organization. This is the only community based non-profit organization in Kentucky dedicated to protecting cave and karst environments and is made up of the same group of volunteers who have managed Great Saltpetre Cave Preserve for 25 years. RKC's mission is to protect caves through wise stewardship and ownership.

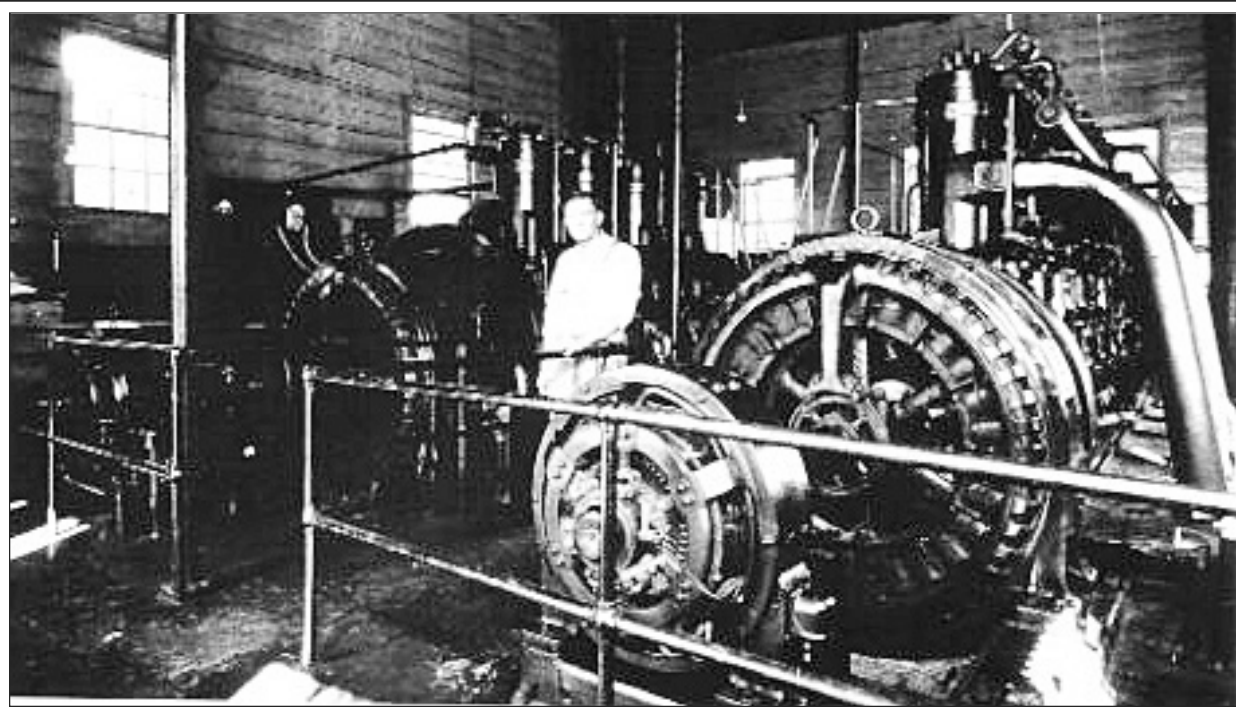

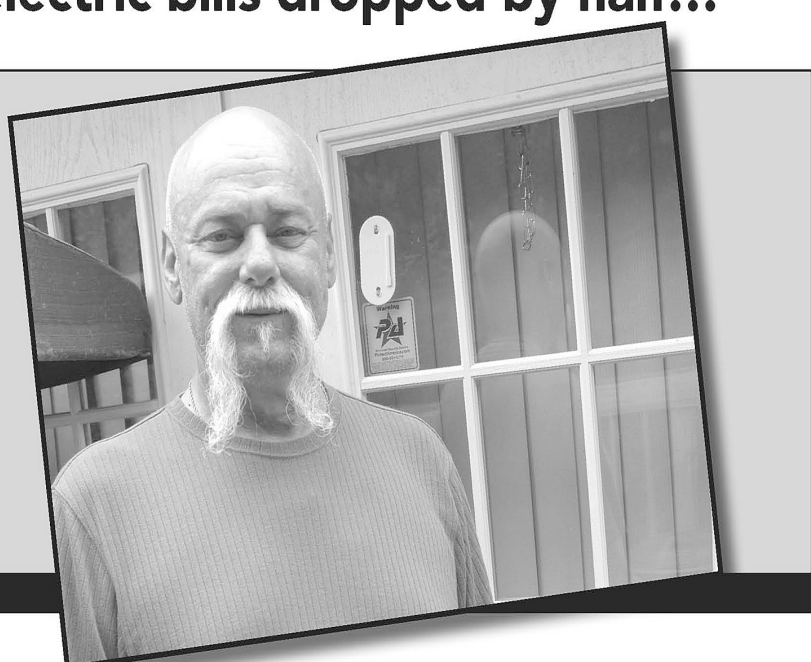

Forest Service closes two campgrounds due to bears

Two campgrounds are currently closed in the Daniel Boone National Forest due to black bears. New regulations are in place for campers.

Holly Bay Campground at Laurel River Lake was closed on Saturday after a bear approached campers and raided a cooler for food. Great Meadows Campground in McCreary County was also closed on Saturday after a bear closely approached visitors. Hemlock Grove was temporarily closed on Sunday but reopened on Monday.

Biologists with the Kentucky Department of Fish and Wildlife Resources are attempting to capture and move the bears away from the campgrounds.

The campgrounds will remain closed until the bears are captured and moved or until officials determine that the bears have moved outside of the campgrounds.

"Due to the drought, this year's berry crop was lost much earlier than normal in most parts of eastern Kentucky," said Steven Dobey, Bear Biologist with KDFWR. "Berries are a primary important food source in mid-summer and without them, bears roam widely in search for food.

"Bears are coming to campgrounds because their numbers in Kentucky are naturally increasing, and because they are hungry. They're simply looking for food in areas where people are not accustomed to seeing bears," added Dobey.

Forest Service officials are reminding visitors that food storage orders are in

place at several locations to help prevent conflict with bears. A new food storage order was issued last Friday for the London Ranger District of the Daniel Boone National Forest. An order to include all national forest lands is being considered.

When camping or picnicking in the Red River Gorge, Stearns Ranger District and London Ranger District, visitors must store food inside their vehicle or in a bear-resistant container when not cooking or eating. Burning or burying food, trash or any other bear attractant is also prohibited.

Backcountry campers, outside of developed campsites, must suspend food and garbage at least 10 feet off the ground and four feet away from the tree or pole used for suspension.

A bear attractant is defined as any substance having an odor that may attract bears. Food, cooking grease, toothpaste, soap and garbage are considered attractants.

"The intent of the food storage orders is to promote visitor safety and prevent bears from expecting food handouts from people," said Sandie Kilpatrick, Forest Biologist with the Daniel Boone National Forest. "Once bears lose their natural fear of people, the chance of negative encounters is increased and puts bears at risk of having to be euthanized.

"The food storage requirement is a big change for visitors who are used to camping in developed recreation areas and keeping their food nearby, but the

increasing bear population calls for increased safety measures.

"In Kentucky, the bears are back, and they're here to stay," said Kilpatrick. "Kentucky is now bear country, and we all need to become more 'bear aware' for our safety and theirs."

Some safety tips on how to avoid human-bear conflicts are:

- Never feed a bear. This causes bears to associate food with humans. In Kentucky, feeding bears intentionally or unintentionally is illegal.

- When camping or picnicking, follow food storage restriction policies where they apply. In remote locations, suspend food and garbage off the ground and away from the supporting tree or pole.

- Never store food or other potential bear attractants inside your tent. Cook food and eat in locations away from your sleeping area. Store food and garbage up to 100 yards away from your campsite.

- Never approach a bear. If you accidentally come upon a bear, back away slowly. Do not run; this could prompt a chase.

- If a bear approaches you, make lots of noise. Remain standing upright. Never lay down to play dead or turn your back on an approaching black bear.

Bear encounters on national forest lands should be reported to the nearest U.S. Forest Service office or to the Kentucky Department of Fish and Wildlife Resources. In an emergency, call 911.

Volunteers needed to assist children in foster care

Citizen Foster Care Review Boards in Clay, Knox, Lincoln, Madison and Rockcastle counties are seeking volunteers to make a difference in the lives of local children in foster care. Volunteers are needed to review cases of children placed in foster care because of abuse, dependency and neglect to ensure these children are placed in safe, permanent homes as quickly as possible.

Volunteers are not required to reside in the county where a board meets.

The Kentucky General Assembly created the Citizen Foster Care Review Board, or CFCRB, in 1982 as a way to decrease the time children spend in foster care. CFCRB volunteers review Cabinet for Health and Family Services files on children placed in out-of-home care and work with the cabinet and courts on behalf of the state's foster children. The volunteer reviewers help ensure that children receive

the necessary services while in foster care and are ultimately placed in permanent homes.

All volunteers must complete a six-hour initial training session and consent to a criminal record and central registry check. A recommendation is then made to the chief judge of the District Court or Family Court for appointment. The meeting schedules for the CFCRBs in need of volunteers are:

Clay County: Meets on the fourth Thursday of every month, 10 a.m. local time at the Clay County Department for Community Based Services in Manchester

Knox County: Meets quarterly on the fourth Friday of the meeting month, 10 a.m. local time at the Knox County Department for Community Based Services in Barbourville

Lincoln County: Meets quarterly on the second Monday of the meeting month, 1 p.m. local time at the Lincoln County Department for Community

Based Services in Stanford

Madison County: One of the Madison County CFCRBs in need of volunteers meets at 5 p.m. local time on the second Thursday of every month at the Madison County Department for Community Based Services in Berea. Volunteers are also needed for a new Madison County CFCRB. Volunteers for the new board will determine its meeting day and time.

Rockcastle County: Meets on the fourth Monday of every month, 3 p.m. local time at the Rockcastle County Department for Community Based Services in Mount Vernon.

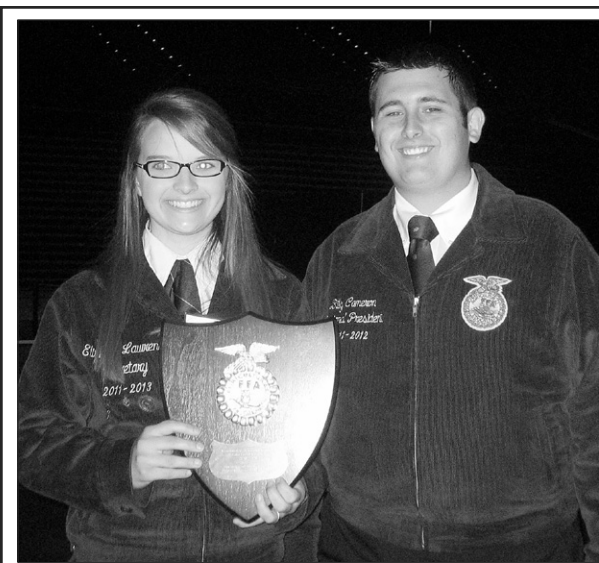
