## Many fair events changed because of Sunday storm

A severe thunderstorm, packing high winds and heavy rains, rolled through Rockcastle County on Sunday causing many events at the Little World's Fair in Brodhead to be changed.

Brodhead Fire Chief Larry Taylor said because of the heavy rainfall from the storm, the fire truck show was cancelled, the cornhole tournament was moved to the pavilion and the beauty pageant was moved to Brodhead Elementary School.

"The fairgrounds were simply in too poor of a condition for Sunday's scheduled events," Taylor said.

The weather forecast calls for storms and rain on both Thursday and Friday but Taylor said he is hoping the meteorologists decide to change their predictions before tomorrow.

"I hope the meteorologists miss that forecast," Taylor said. "Those are two of our biggest money-making days during the fair."

The Brodhead Volunteer Fire Department is now in their seventh year of sponsoring the fair. Taylor said although the fair has started off slow, they are still hopeful the carnival and weekend brings in more people.

"This is the best carnival and most rides we have had since we started sponsoring the fair," the chief said. "We're all crossing our fingers that it really picks up as the week goes on."

Taylor said the profits the volunteer fire department make from the fair will go to pay for the new tanker at the Brodhead Fire Department which they plan on having in service by the end of August.

## Mt. Vernon man arrested for drug possession

A Mt. Vernon man was arrested for drug possession last Tuesday after officers from the Rockcastle County Sheriff's Department and Mt. Vernon Police Department made a traffic stop on Davis Street in Mt. Vernon.

Arrested at the scene was Ricky Allen Sandusky, 25, of Mt. Vernon.

According to Mt. Vernon Police reports, Assistant Chief Barry Adams had received information that Sandusky was in possession of methamphetamine and that he was attempting to sell it.

While officers were on another traffic stop, Deputy Sheriff Matt Bryant observed Sandusky walking on Davis Street and turning on Lower Drive.

Once Sandusky spotted the officers, he started running and cut through a yard before disappearing out of sight. A few minutes later, officers saw Sandusky walk back out of the same yard and begin walking again on Lower Drive.

When officers approached Sandusky, they noticed he

## School lunch prices have risen this year

Students in the Rockcastle County School System, and across the state, are going to be paying more for lunch this year.

A price boost of 15c per lunch was put into effect

because of a mandate to bring school districts into compliance with the 2010 Health Hunger-Free Kids Act, a law designed to ensure that students receive health, nutritional school

meals that include fresh fruit and vegetables, according to Jeannine Parsons, Food Services Director for Rockcastle County Schools.

The increase applies only to students who pay full price for their lunches. Students who receive free or reduced-cost lunches, based on their family's income, will not be affected.

A portion of the act requires that the lunch prices schools charge to paying student must roughly equal the amount of government reimbursement the schools receive for students on free and reduced lunch.

To meet that requirement, many public schools in Kentucky, and other states, have to raise their lunch fees this year to bring them closer to reimbursement levels.

For Rockcastle County students, the basic cost of a cafeteria lunch at the high school and middle school

will be \$1.75. The cost will be \$1.50 at the elementary schools and \$1.25 for preschoolers. Teachers will pay \$2.75 for lunch and the cost of breakfast to all students will remain at \$1.00.

Parsons said that federal guidelines now state that regular white milk has to be low fat while flavored milk must be fat-free. And, 51% of all grains offered must be whole grain, she added.

Schools must also provide a 1/2 cup weekly of dark greens such as broccoli, romaine, greens, etc. and 3/4 cups weekly of red/orange vegetables such as tomatoes, carrots, pumpkin, etc.

"We started with the milk and vegetable requirements last year," Parsons said "but this year it is mandated."

Parents can apply for free and reduced lunch. The paperwork is available through the school office.

## Police arrest five in two separate meth busts

Five people were arrested in two separate meth busts this past week.

Three people were arrested Tuesday night for manufacturing methamphetamine after the Kentucky State Police raided a home on Bent Oak Court in northern Rockcastle County.

Arrested at the scene were Lewis Allen Bishop, 41, of Nicholasville, Freddy Joe Durham, 47 and Michael Cecil Stamper, 25, both of Berea.

According to State Police reports, troopers responded to the home after receiving

information that meth was being manufactured at the residence.

Once officers arrived at the residence, they noticed someone fleeing on foot out the back of the home. Officers pursued him but the male escaped and has not been found.

Upon further investigation, officers found four one-step meth labs behind the house and one one-step meth lab inside the residence.

All three were charged with manufacturing methamphetamine. Durham was also separately charged with possession of a controlled substance and trafficking in a controlled substance.

All three remain lodged in the Rockcastle County Detention Center on a \$25,000 cash/property

## Man arrested for trafficking meth during traffic stop

A Georgia man was arrested for trafficking methamphetamine last Wednesday after State Police made a traffic stop on I-75 northbound at the 56 mile marker in Rockcastle County.

Arrested at the scene was Sheldon Scott Edwards, 28, of Carrollton, Georgia.

According to state police reports, officers pulled over Edwards for following too closely behind a tractor trailer. When officers approached the vehicle, they asked Edwards to exit after they noticed a large hunting knife lying in the passenger seat.

Inside the vehicle, officers found 3 grams of crystal meth, two drug pipes, a

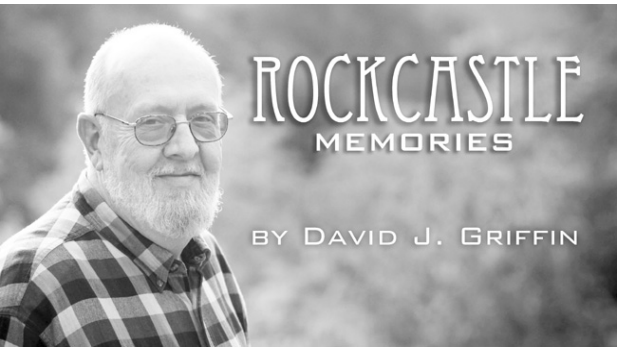

My wife and I recently attended the Randy Travis concert being held in the New Barn in the Valley. For the past several years, we

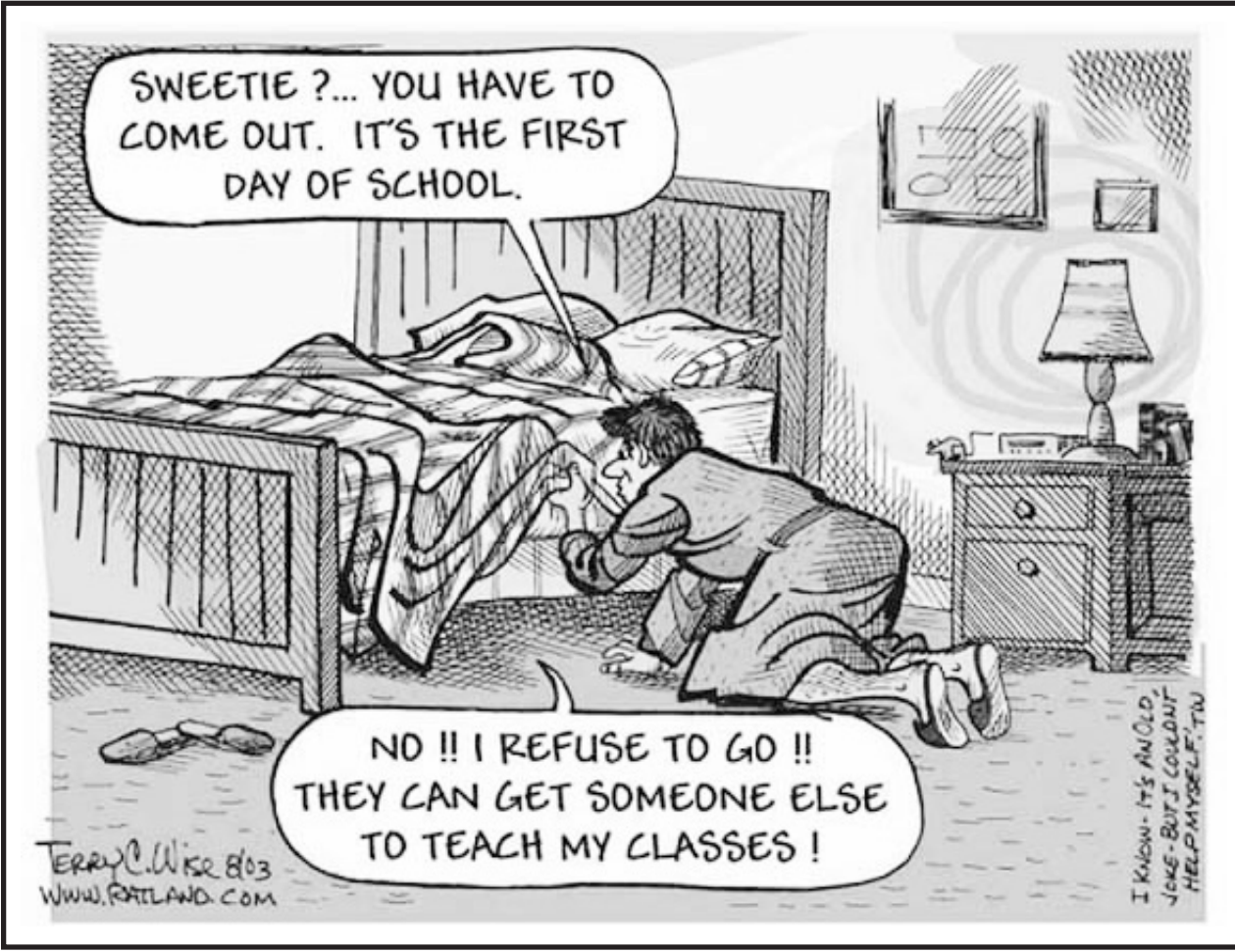

### Recipes for the Historical Palate

As I'm sure you know, I have a "taste" for history, and about a year ago I discovered some historic cookbooks for sale. One of the two books I bought was a collection of recipes from the personal cookbook of Thomas Jefferson, former president and signer of the Declaration of Independence.

Jefferson himself penned many of the recipes in his cookbook. From 1784 until 1788, about the time Mount Vernon was being settled, he spent time in Paris, France, as Minister to the Court of Louis XVI. While there, he interviewed cooks and servants, writing down many of the delicious recipes.

Upon Thomas Jefferson's return to Monticello, he gave these recipes to his granddaughters to compile as a collection into a cookbook. They included the French recipes and many from Monticello, as well as some collected from Jefferson's years in the White House.

The cookbook, when completed, was handed down through the generations. In 1949, Mrs. Fiske Kimball, wife of the Director of the Philadelphia Museum of Art, edited the recipes into modern terms (which in my opinion, ruined the "flavor" of the authenticity) and practical portions. Originally, the recipes were intended to include enough to feed the servants and plantation hands.

I have selected two of these recipes to share with you. They will be especially

appropriate for this time of year and as the fall approaches: Brandied Peaches and Pumpkin Soup. I hope you will enjoy these recipes as I'm sure one of our founding fathers did. Allow them to transport you to another era, about the time our ancestors were putting down their first "roots" here in the county.

**Brandied Peaches**  
Wipe off the peaches to remove the down. Prick them in four or five places with a fork. Drop them into boiling water for a moment, remove, and place immediately in cold water. Remove and let them drain. Make a syrup of sugar and a little water, using one pound of sugar to four pounds of peaches. Boil until, when you dip two fingers into it, they will stick together. (I

guess it is at this point he burned his fingers!!!) Let cool. Add the peaches and let stand for twenty-four hours. Bring the syrup to a boil again and add 1 pint of brandy. Do not leave the syrup on the fire while you are doing this. You will burn your face if you do not take this precaution. Let the syrup cool again and add the peaches. The following day remove the peaches again, bring syrup to a boil and add as much brandy as you wish. Put in the peaches and let simmer until tender. Let them cool, then remove gently and put in jars. Strain the syrup over them through a cheesecloth.

#### Pumpkin Soup

Take half a small pumpkin, peel, cut in small pieces and put on the stove with half a glass of water. When the pumpkin is tender, drain, and pass through a colander. Add 3 tablespoons of butter; sugar, salt, and pepper to taste. Let it simmer for fifteen minutes. Add 4 cups boiling milk, stirring well while pouring it in. When well mixed, pour over croissants, made by cutting three slices of bread in small cubes and browning well in butter.

# Mamaws Kitchen

## PARMESAN COUSCOUS SALAD

I first made this dish when we went to Loretta's and Jim's for a dinner. When another guest tasted the salad he responded "I don't know what this is, but it is fantastic." I was glad I had made a double batch. He took home the leftover salad.

1 box (5.9 ounce) Parmesan Couscous  
1 cup black olives, quartered  
1 cup grape tomatoes, quartered  
1/4 cup fresh parsley, chopped  
1/4 cup sweet or green onion, chopped  
2/3 cup feta cheese, crumbled  
1/4 cup olive oil  
1/4 cup fresh lemon juice  
Salt and Pepper  
1 clove garlic, minced

Cook couscous according to package directions. After fluffing with a fork, add tomatoes, olives, onions and parsley. In a small bowl, whisk the olive oil into the lemon juice. Add salt, pepper; and garlic. Pour over couscous mixture; stir to mix well. Sprinkle with feta cheese. Serve warm or chilled.

## CRUNCHY ROMAINE SALAD

This is another recipe from Mary Hoskins. She makes only half the recipe for the salad dressing, and it is plenty.

1 cup sugar  
3/4 cup canola oil  
1/2 cup red wine vinegar  
1 tablespoon soy sauce  
Salt  
Pepper  
1 package (3 ounce) ramen noodles (discard flavor packet)  
1 cup chopped pecans  
1/4 cup unsalted butter  
1 bunch broccoli, coarsely chopped  
1 head romaine lettuce, in bite-sized pieces  
4 green onions, thinly sliced  
Blend sugar, oil, vinegar, soy sauce, salt and pepper with a wire whisk in a medium bowl. Set aside.  
Break ramen noodles into small pieces. Brown noodles and pecans in butter in a skillet. Drain on paper towels and let stand till cool.  
Combine noodles, pecans, and broccoli, lettuce and green onions in salad bowl and mix gently. Add salad dressing to coat.

"Why do I get men like this?" she asked. She had been in three relationships and all three of the men were abusive addicts. She had been miserable with all of them.

"They seem so nice at first," she added, "but then they turn into monsters. I don't understand why this keeps happening to me."

No victim consciously goes looking for someone to abuse her. She is looking for love, affirmation, affection and kindness, but not abuse.

Abusers know how to play upon the feelings of vulnerable women. Abusers are men who can be charming and wonderful for several months or longer. The victim is showered with more attention and kindness than she has ever felt before. It is only after she falls in love, moves in with and/or marries the abuser, that he becomes controlling and abusive. At this point it is very difficult for her to escape from the abusive relationship.

There are many reasons a woman may be vulnerable. 1) Her prior relationship may have just ended, and she may be feeling lost and alone. 2) The previous relationship may have been abusive, and she may not have felt loved in a long time. 3) An unhappy, dysfunctional childhood may have crushed her self-esteem and left her feeling unloved. Her childhood may have involved abuse and addictions. She continues to seek love as an adult and may be "looking for love in all the wrong places." 4) She may have just gone through a traumatic experience such as the death of her husband.

A woman who is vulnerable may miss the warning signs that her new love will become controlling and abusive. She may be so desperate for love and affection that she overlooks indica-

tions that he has a temper or drinks too much.

One reason the victim may miss these signs is that the abuser often rushes her into a commitment. He encourages her to move in with him or to get married before she really has a chance to get to know him. This means she does not have time to see any of the warning signs.

What can a victim do to break the cycle of relationships with abusers?

1) She can take a "vacation from men." It takes time to heal from the breakup of a relationship and jumping into another relationship too quickly may mean that she does not have time to heal. A one year vacation from men is a good idea.

2) She can spend time trying to understand herself and working to change herself. This can happen through reading or keeping a journal of her thoughts and feelings. She may also be helped by seeing a counselor who can help her understand why she has made certain choices in her life. She may benefit from participating in a group with other victims and learning from their wisdom. Domestic violence shelters provide these kinds of opportunities.





3) She can work to improve her life by going back to school, making new friends or joining groups that interest her. She can take classes in parenting or other topics that would help her in her daily life.

4) She can stop focusing on a relationship and focus on herself. As she works on herself and becomes more self-confident, she becomes less vulnerable to the abusers of this world.

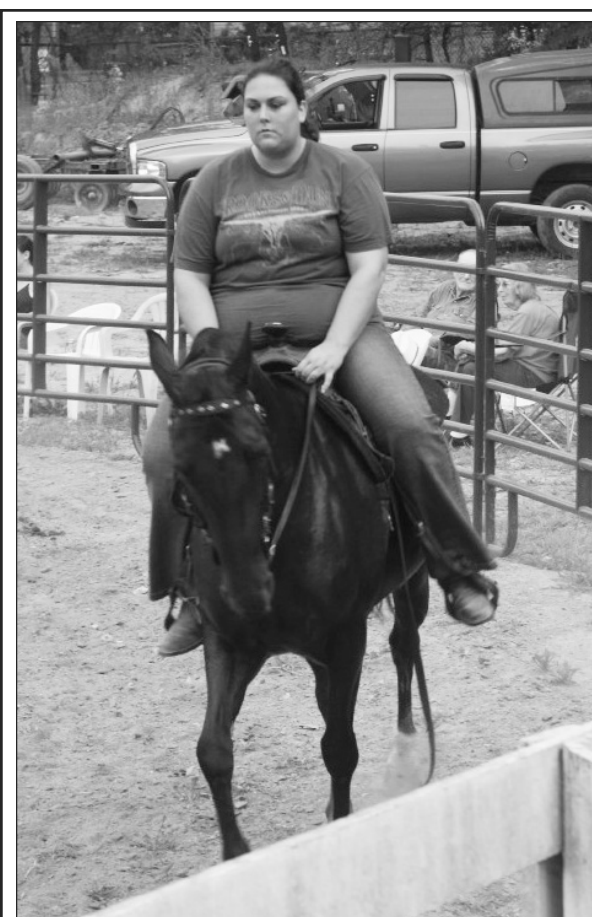

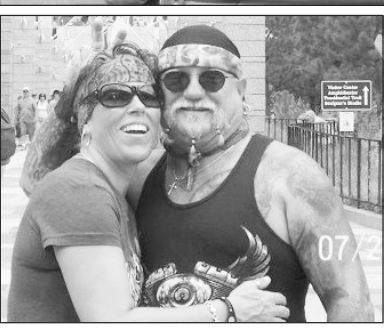

# Yards to Paradise

*Specimen: Special Plant for Specific Reasons*

Over the years, I've read numerous discussions on specimen trees and other plants. Way too often, it seems, the topic is pushed by nurseries who have some unusual plants suitable for "specimen" (translation: rare/high priced) use in the landscape. But, there is a legitimate definition (see Mr. Webster) for a specimen plant. Basically it is that one plant you put in a place where it will receive lots of attention and "shine" as something "special"!

I think the term is over-used but underutilized. I don't recall having addressed this subject before, so let's discuss specimen plant usage in today's column. A specimen is like a statue that epitomizes a perfect player of a sport, or the statue of "Atlas" or something. Well, in the plant kingdom, a specimen is one that is so outstanding in some amazing way as to be praise worthy and placed in a prominent spot for purposes of attention-grabbing. Before I go farther, don't be one of those foolhardy people who think they will splurge and buy a bunch of "specimen" plants and have the best yard in the neighborhood! Several specimen quality plants located together or near each other just become ordinary. And a

waste of money since rare specimen type plants usually cost quite a lot. By very definition, a specimen is that one plant you put "on a pedestal" so to speak. It may be tall, it may be weeping, it may be orange when other trees are green or it may be blue when most are deep green. It may be contorted in a strange way. It may be a giant or a midget. It may be a new cultivar ('cultivated variety') that normally only grew farther south, but now can be grown locally. Whatever it's claim to fame, it is very unusual or is very noticeable. Hopefully in a pleasant and positive manner. Special plants can draw attention to a yard. Maybe to a house. Maybe to an outdoor oasis. Or they can draw attention to themselves, replacing the eyes from noticing the less attractive things in the landscape. Even somewhat ordinary plants can become specimens. This is done by framing them with contrasting plants...like putting a Thomas Kincaid painting in a large ornate dark frame...letting the light shine. A tree with pink fall color can be a specimen when everyone else has yellows and reds. A blue cedar or spruce or fir tree can be a specimen in front of a dark green background...or in a neigh-

borhood where it's the only one of it's kind. A specimen plant in one yard may completely be out of character in someone else's yard. So, figure what you want to emphasize, and then how. You can still have several unusual trees, I enjoy planting unusual things myself, but you need to have only one (or one cluster or group possibly) of the special plant. Let any other plants that might have a story or a purpose be 'special' only upon close inspection. Select just one "specimen" tree or plant that you want to get attention or to lead the eyes to a certain spot. Even a sugar maple, a ginkgo, a beech or a pear tree can be a specimen if it's special and if it's framed correctly with other background plants or building. (What I would not call a specimen is putting one pretty callery pear—Bradford pear-- in the front yard. Every yard in 3000 miles is doing the same thing it seems! I don't care how pretty it is in bloom, it is at most an ordinary tree because everybody else has one too. Let's say you lived in Buenos Aires or Moscow or Wellington. A Bradford pear could very well be a cheap and beautiful specimen tree. Because it might be the only one on your side of town. And a palm tree in Washington might be a specimen...but it really has to be one special palm tree if it is used as a specimen in Florida! Japanese maples, rare cedar trees, exotic trees from far away places, hybrids that have different bloom times or new colors—these are some of the sorts of trees and shrubs that one might very well use successfully as a specimen in his or her landscape. I know of a large Crytomeria in Laurel County, Kentucky that is a specimen. I've seen a mature scarlet oak in full color in a yard...the only one in the subdivision...that's a specimen. A weeping Blue Atlas cedar, though unusual, may not be such a good choice if three other homes on your block have one. And I've seen a white forsythia when scores of dozens of yellow ones were in bloom: that's a specimen. Whether the plant or it's placement is what's unusual; let's see if we can do a specimen planting sometime soon. Wise choice and placement of a SPECIMEN can make a regular yard into an outstanding one. Best wishes as you develop your own paradise. The author is a landscaper. www.mountainwaterfalls.net

# Be a good sport at State Fair

The Kentucky State Fair is quickly approaching, and it will be time for 4-H'ers to compete for state livestock awards. The 4-H livestock shows are some of the most widely recognized and anticipated events of the fair. While these competitions are meant to be a fun, learning experience for 4-H'ers, some get caught up in the competitive spirit of the event, which can cause anger and disappointment if a young person or animal doesn't place as high as expected.

Judging is not an exact science. Judges are chosen because they have very extensive background in their specific species. They are breeders, producers and industry professionals. However, there is no "perfect" way to judge a livestock show. Judges have criteria to follow for each show, but some judges may emphasize certain criteria over others. The important thing is for the judge to remain consistent. Youth must be "good sports" and gracefully accept the judge's decision.

Judges look for different things in showmanship and non-showmanship livestock classes. In showmanship classes, judges focus on the appearance of the animal and the 4-H'er, the animal's behavior and the youth's ability to control the animal. In the non-showmanship classes, emphasis is placed solely on the animal and how close it comes to its

species' standard. Showmanship classes are a chance for youth to exhibit all the hard work they have put into getting an animal prepared for the show. Young people compete against other 4-H'ers that are around their same age. This competition is not based on who has the most impressive animal physically, but if the animal is clean and properly groomed. Judges also evaluate the animal's behavior, and in dairy and beef, if it demonstrates the correct demeanor and how well the youth is able to lead or control the animal in the show ring.

Judges for non-showmanship classes focus solely on the animal's physical conformation. In the breeding animal classes, animals are grouped based on the animal's age or weight. Breeding animals are judged according to how close they mirror the breed or species standards. Standard specifications are spelled out by the breed and species' associations. In market animal classes, animals are typically grouped based on weight and judged according to how closely they match the "ideal" market animal for that species. The criteria typically evaluated in market animals include muscling, leanness, growth and feet and leg structure.

Educational programs of the Cooperative Extension Service serve all people regardless of race, color, sex, religion, disability or national origin.

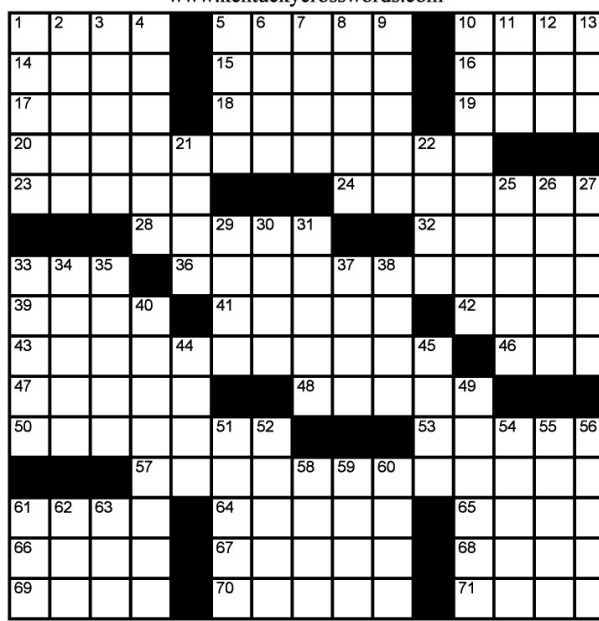

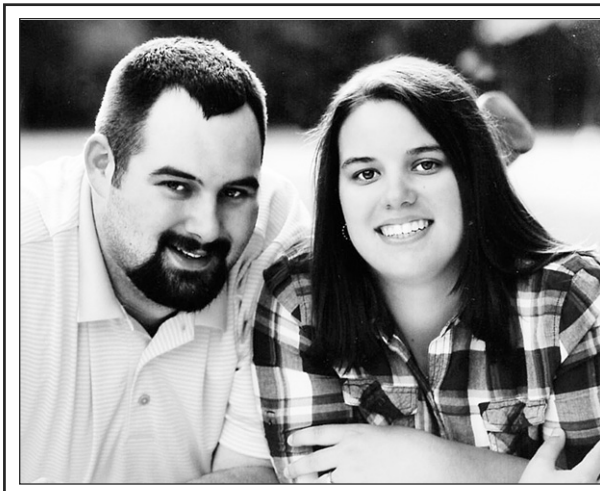
