## Mullins is new principal at RES; Phillips gets asst. principal's job at RCMS

The resignation this year of long-time superintendent Larry Hammond caused a ripple effect through the school system and two more pieces fell into place this week with the announcement of a new principal at Roundstone Elementary and an assistant principal at Rockcastle Middle School.

Kevin Mullins, 38, an alumni of Roundstone Elementary, began teaching in 1988 at Brodhead Elementary as a collaborating special education teacher for five years and a 5th grade teacher for one year. He then moved to Mt. Vernon Elementary where he taught an FMD unit for one year, physical education for one year and the 5th grade for six years.

After graduation from RCHS, Mullins attended EKVU where he received his bachelor's, master's and Rank 1 degrees. He is married to Angela Mullins, a speech pathologist at MVES and they have three children: Spencer, 21, a senior at EKVU; Hannah, 11 and Daniel, 9.

Commenting on his appointment, Mullins said "I am honored and humbled to be the principal of Roundstone Elementary. I have lived in the community for 38 years and it is good to be home. My goal is to make RES a great place to learn and work."

Robert E. "Robbie" Phillips, 40, was named assistant principal at RCMS Tuesday night, following a meeting of the SBDM Council.

## Reynolds presents motion to revoke bond Clifford arrested for meth possession

A Mt. Vernon man was arrested Monday afternoon for meth possession after the Kentucky State Police made a traffic stop on McHargue Branch Road in Mt. Vernon.

Arrested at the scene was Dallas Ray Clifford, 39, of Mt. Vernon.

According to State Police reports, officers made the traffic stop after noticing Clifford was not wearing his seat belt and appeared to be slumped over the steering wheel.

Once officers approached the vehicle, they observed Clifford was moving around a lot inside.

When officers asked Clifford to step out of the vehicle, he put his hands in his jean pockets and attempted to flee. Officers then apprehended Clifford and placed him inside the police cruiser.

Upon further investigation, officers found a small plastic bag containing a white powder substance on the ground where Clifford was previously standing.

Clifford told officers the plastic bag contained methamphetamine and that he was driving back after using meth with some friends.

Clifford was charged with possession of a controlled substance (methamphetamine), tampering with physical evidence and operating a motor vehicle under the influence of drugs.

Clifford remains lodged in the Rockcastle County Detention Center on a \$7,500 cash/property bond.

However, Rockcastle County Attorney Billy Reynolds has made a motion for the court to amend Clifford's bond from \$7,500 cash/property to \$50,000 cash.

The court date for Clifford's bond amendment is set for August 27th in the district courtroom in Mt. Vernon

## Indictments handed down by Grand Jury

Indictments were handed down Friday, August 10th against 14 persons with the majority of the charges involving trafficking in a controlled substance.

Indicted were: Earnest Danny Johnson, 49, 590 Sayre School Road, Mt. Vernon, on two counts of trafficking in a controlled substance, first degree, possessing and selling oxycodone on two separate dates in August of 2011. He was also indicted on two counts of persistent felony offender, second degree.

Johnson's bond was set at \$50,000 cash/property.

Andre L. Barnett, 47, of 24 Chestnut Grove Road, Brodhead and Julia L. Bailey, 27, of 30 McFerron St., Mt. Vernon, were named in a joint indictment. Both were indicted for trafficking in a controlled substance, second degree, on August 11th and Barnett was indicted for one count of trafficking in a controlled substance on August 26, 2011.

Both Barnett's and Bailey's bond was set at

\$25,000 cash/property.

Jonathan D. Olinger, 31 and Janet R. Lewis, 33, both of 83 Castle Village Drive in Brodhead, were also charged in a joint indictment on two counts of trafficking in a controlled substance, first degree and third degree.

Their bond was set at \$25,000 cash/property.

Jamie Ray Tuttle, 34, of 3533 Harmons Lick Road, Crab Orchard, was indicted for trafficking in a controlled substance, first degree, involving the sale of 10 units of Oxycodone on August 12, 2011. His bond was also set at \$25,000 cash/property.

Three Livingston residents were charged in a joint indictment over an August 20, 2011 offense of trafficking in a controlled substance, first degree, involving ten units of Oxycodone.

Named in the indictment were: William J. Fletcher, 21 and Bonnie L. Johnson, 42, both of 311 McClure St., Livingston and Michelle L.

Fletcher, 20, with a P.O. Box address in Livingston.

All three defendants' bond was set at \$25,000 cash/property.

Melinda A. Powell, 40 of 269 Old Somerset Road, Mt. Vernon was indicted on

two counts of possession of a controlled substance, involving possession of morphine, hydromorphone and alprazolam, in August of 2011, one in the first degree

## Health Department will reduce hours

Because of budget cuts, the Rockcastle County Health Department has announced revised hours of operation, effective Monday, August 27th.

Beginning on that date, the department will be open from 8 a.m. to 5:30 p.m. Monday thru Thursday. The department will be closed on Fridays.

Patrons are asked to call 256-2242 to make an appointment for WIC, Well Child exams, immunizations and family planning.

The local health department is a member of the Cumberland Valley District Health Department which is presently the target of an ongoing investigation by officials from the Kentucky Auditor of Public Accounts.

According to a recent news release, after a state audit was requested for the CVDHD, a pre-termination conference was held to see if Director Kathy Fields would keep her job. Fields has been placed on paid administrative leave and is in a 14 day period before a pre-termination hearing before the CVDHD board.

Lynette Renner was named interim director for the department.

The district is comprised of Clay, Jackson, Rockcastle and Harlan Counties.

Graveside services were conducted Friday, July 27, 2012 at the Providence Cemetery with Bro. Shelby Reynolds officiating.

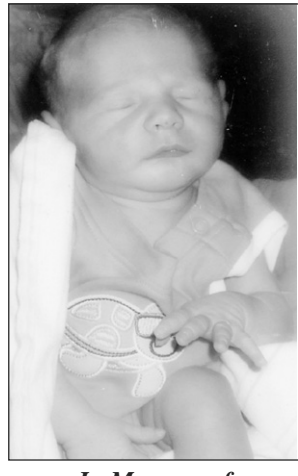

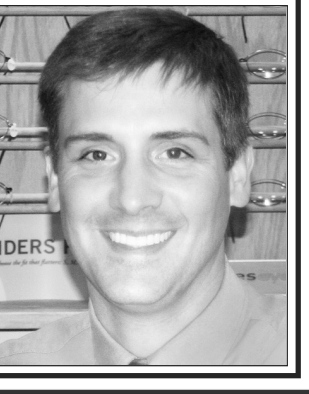

not solely lie with the police busting meth labs or arresting people for drug trafficking and possession.

Although the police do a good job and it does put a dent in the drug problem, it will never fully clean our county of drugs. As long as there is a demand for drugs, then dealers will keep finding new ways to supply and feed those demands.

The UNITE Coalition and the Rockcastle County Drug Court has played a huge role in our community by helping drug users get off their highly addictive drugs so they can turn their lives around and become productive members in society. However, they cant fight the

battle against drugs all by themselves either.

In my opinion, the true answer to solving our drug problem lies with community activism and raising awareness.

When I first started working here at the Signal I had to report on the infamous wet/dry vote that was being heavily debated in our county.

I particularly remember being amazed at the amount of time and effort the "no" voters put into their campaign in order to prevent alcohol from being sold in Rockcastle County.

There were "no" voters volunteering their time to go door to door at homes and also make phone calls. There were even some of our churches having "no" voter meetings and events as well.

There were also some preachers delivering sermons on Sunday morning about how alcohol ruins lives and how it doesn't need to be sold in our county.

All of this made me feel like I was living in a modern day temperance movement similar to the prohibition-era of the 1920's.

In the end, the time and effort they put toward the "no" campaign worked as Rockcastle County voters chose not to permit the sale of alcohol in the county.

Simply put, the "no" campaign promoted community activism and raised awareness about what they considered "the horrors of alcohol" and it worked.

However, the drug problem still exists in our county and is just as rampant as it ever was.

One of my hopes after the wet/dry vote was to see the same full-fledged community activism and awareness of the "no" campaign carried over to fight the battle against drugs. But unfortunately, that passion just faded away and dissipated into the wind once the wet/dry vote was over.

## Reduce grocery costs

You have probably heard that the cost of food is expected to rise next year. You can do several things to reduce your current grocery expenses and hopefully prepare yourself for the expected price increase.

One of the easiest things to do is to plan ahead. That includes making a meal plan for the week and making a shopping list based on the ingredients you need to fulfill your plan. Check weekly store sale ads and product coupons in the newspaper and online to find the best prices for the items you need. However, don't buy something you don't have plans for just because it's on sale. Make sure sale items ring up with the correct price at checkout.

Avoid shopping hungry, in a hurry or with your kids, as all can increase impulse spending.

Wisely choose your shopping destination. For many rural consumers, convenience stores are the most accessible places to shop; however, they typically are one of the most expensive. You might find it is more cost-effective to go to a larger store in a nearby community once month to stock-up on commonly used non-perishable items.

Instead of increasing prices, some companies are reducing their packaging sizes. This can increase your spending, as you will need to replace these items more often. When at the grocery store, check the item's price per unit found on the shelf tag. The price per unit allows you to easily compare the costs of the product based on size. The price may be cheaper in a different size or brand. If your grocery store does not display a product's price per unit, you can easily calculate it by taking the cost of the product and dividing it by its packaging size. Bringing a small calculator may be helpful.

Review your grocery purchases at least monthly to determine total monthly grocery expenses and individual product prices. You may be able to further reduce spending by eliminating things that aren't necessities. Cheaper alternatives may be available for some of the more costly items.

complish our goal by purchasing as many keys as they can," Stallworth said. "I know we can pull this off if we all work together."

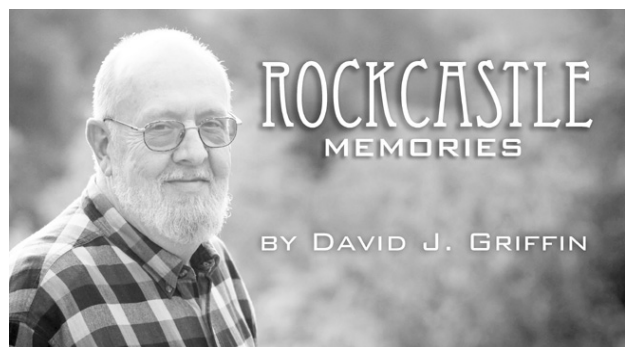

It was a treat to sit at Mommie Katie's kitchen table and spend the afternoon trying to out-smart the adult members of my family.

I remember my first attempt at playing Clue. On a Sunday afternoon in the early 50's, my Aunt Ruth and Uncle Charles came to Mt. Vernon to visit. Their daughter, Janis, had just received a Clue game, and we decided to challenge the adults to a match. Because none of us had played the game before, Janis had to explain the rules. As you recall, the game requires players to move around the board by toss of a pair of dice. The characters are: Miss Scarlett, Colonel Mustard, Mrs. White, Reverend Green, Mrs. Peacock, and Professor Plumb. The weapons available are a candlestick, a dagger, a lead pipe, a revolver, a rope, and a Monkey wrench. The board is divided into several rooms, including: ballroom, kitchen, conservatory, dining room, cellar, billiard room, library, hall, lounge, and finally the study.

At the beginning of the game, three cards – one suspect, one weapon, and one room – are chosen and placed into a special envelope so that no one can determine which cards were hidden. The remainder of the cards is distributed

among the players. The object is to deduce the details of the murder; that is, to identify the cards in the envelope.

All throughout my early development, I can remember seeing Pop and Mommie Katie sitting around a small table playing checkers. Sometimes, if one of them was being defeated soundly, sparks would fly. I still have their old Masonite checker board with a corner missing – because Mommie Katie knocked the board clear across the room when Pop was bantering her with his success.

I vividly recall my mother joining several of my friends at that old

kitchen dinette in a game of Monopoly. For those who remember Bee, you will recall that she was very intelligent and presented us with quite a challenge. For hours on end, the game progressed as some of the players acquired multiple properties and charged rent to those who landed on their spaces. Bee quietly accumulated hotel after hotel on expensive plots of land. In the end, she sent us all to the "poor house." I can still see the smile on her face as we acknowledged her victory. She had chosen the thimble as her "piece," and she held it high into the air when we all accepted her triumph.

Because my wife, Kathy, and I spent a lot of time camping, we played of kinds of games. One of our favorites was Yahtzee, and we had some ferocious contests while rolling the five dice and marking our score sheets. The object of the game is to score the most points by rolling five dice to make certain combinations. Since we both can be quite competitive, our games

sometimes lasted into the early morning hours, all the while listening to rock and roll music. I don't think we ever crowned a champion because we split pretty equally on who won.

The other board game that we still play is Scrabble. I am sometimes hesitant to play this game with Kathy. She is a graduate of Western Kentucky University with a degree in English. My degree is in Chemistry. Need I say more?

Sometimes – especially when the electricity goes off – she convinces me to get out the Scrabble board. The object of the game is to select tiles with letters on them to form words on the board. The winner is the one who scores more points by playing the tiles you have been dealt to create words. If my tiles had anything to do with science, then the playing field would be on more equal grounds. That is, of course, not the case, and she often gives me a sound whipping. On a rare occa-

## Mamaw's Kitchen

### BAKED TURTLE

Turtle meat  
Salt  
Vinegar  
Lemon juice  
Egg  
Pepper  
Flour  
Cornmeal  
Bacon grease, lard, or vegetable oil for frying  
Cut up turtle meat into serving sized pieces and soak for several hours in water containing a little salt and vinegar. Preheat oven to 350°. Wash in clear water; drain and dip each piece in lemon juice, then in beaten egg. Salt and pepper and roll them in a mixture of equal parts flour and cornmeal. Heat fat in an ovenproof skillet. Carefully add turtle pieces to hot fat and brown well on all sides. Add 1/2 cup hot water; place skillet in oven. Cover and bake slowly until meat is tender. Add a little water at intervals, if necessary.

### LIVER AND ONIONS

2 tablespoons bacon grease  
2 large onions, thinly sliced  
1 pound beef liver slices  
All-purpose flour  
Salt and pepper to taste  
Additional grease or oil, if needed  
Heat the bacon grease in a large skillet over medium-high heat. Add the onions;

reduce heat to medium and cook until lightly browned, about 15 to 20 minutes. While onions are cooking, wash liver with cold water. Lay slices on a sheet of plastic wrap. Using the edge of a saucer, pound the liver lightly. (Not enough to cut it to pieces, just enough to tenderize.) Lightly coat the liver with flour; sprinkle with salt and pepper. Remove onions from pan. Add more grease or oil to the pan if needed and heat over medium-high heat. Add the liver and fry until brown and cooked through, about 8 minutes per side. Return the onions to the pan to reheat. Serve with onions over liver pieces.

# Rockets beat Grant Co. 29-14

The Rockcastle County Rockets defeated the Grant County Braves last Saturday night 29-14 for the Thoroughbred Bowl trophy.

This was the Rockets first game of the year making them 1-0 on the season.

In the first quarter, the Rockets scored on their first two plays with a 65 yard drive that was set up by a 59 yard run by running back Damien McDaniel.

Running back Jacob Bussell then scored from six yards out and the extra point was good by kicker Tyler McCormick, giving the Rockets an early 7-0 lead.

The Rockets struck again late in the first quarter when Bussell scored on a 10 yard run. The scoring drive was kept alive on a third and eight when fullback Tommy Shafer broke free for a 45 yard run to get the Rockets on the Braves' 10 yard line.

The Braves got on the board by forcing a Rocket safety when quarterback Corey McPhetridge tried to

advance a fumble recovery out of the end zone.

The Braves took advantage of the momentum swing by scoring on two pass plays of 31 yards and 50 yards to go into halftime tied at 14-14.

The Rockets returned in the second half to score on an impressive 96 yard drive that took 6:26 off the clock in the third quarter and ended with a two yard run by McDaniel.

McDaniel also added the two point conversion and the Rockets regained the lead 22-14 with 6:26 left in the third quarter.

Bussell would then rush for his third touchdown of the game in the fourth quarter to put the Rockets ahead 29-14.

Offensive leaders for the game were McDaniel with 32 rush attempts for 334 yards and one touchdown. Bussell also rushed for 64 yards and three touchdowns.

Defensive leaders for the game were defensive back

Tyler Smith with two interceptions and three tackles. Linebacker Chance Ansardi led the defense with 11 total tackles.

Head Coach Scott Parkey said that he was satisfied with the defense's ability to get pressure on the Braves quarterback but was disappointed with the mistakes and penalties they had on offense.

"They really cost us, not only in yards but also in momentum and points," Parkey said.

Parkey said by playing the first game of the year that he expected some mistakes, but not the same mistakes over and over again.

"We must put together four quarters of good clean football if we plan to beat a lot of the teams on our schedule this year," Parkey said.

The Rockets will play in the 22nd annual Renfro Valley Jamboree Bowl against the Frankfort Panthers at home this Friday night at 7:30.

## Three arrested in two large drug trafficking busts

Three people were arrested for drug trafficking this past week after police found 343 prescription pills in two separate drug busts.

Two were arrested for drug trafficking Sunday night after the Kentucky State Police made a traffic stop on I-75 northbound near the 72 mile marker.

Arrested at the scene were Jonathan Lamont Brown, 29 and Antjuan Lyron Elzy, 36, both of Lexington.

According to State Police reports, officers made the traffic stop after observing a 2012 Toyota Avalon following another vehicle too closely.

Once officers approached the vehicle, a State Police K-9 unit alerted them to a backpack in the back seat.

Inside the backpack, officers found a pill bottle containing 149 oxycodone pills and a ziplock bag containing 159 oxycodone pills.

Brown and Elzy were both charged with trafficking in a controlled substance, first degree. Brown was also separately charged with following another vehicle too closely.

Both Brown and Elzy were later released from the Rockcastle County Detention Center on a \$15,000 unsecured surety bond.

A Mt. Vernon man was arrested for drug trafficking last Wednesday night after

officers from the Mt. Vernon Police Department raided a home on Locust Street in Mt. Vernon.

Arrested at the scene was Brian Heath Yauger, 28, of Mt. Vernon.

According to Mt. Vernon Police reports, Assistant Chief Barry Adams received an anonymous phone call from someone who was witnessing a drug transaction on Locust Street and saw a bald headed male, who participated in the drug transaction, go inside a house on the same street.

Once officers arrived at the residence, Adams identified Yauger as the bald headed male and saw him standing on the front porch of the residence. When Yauger noticed the officers, he attempted to flee inside the home.

Adams pursued Yauger inside the house and apprehended him at the scene after noticing him attempting to conceal a small plastic bag inside the waistband of his pants.

Inside the plastic bag, officers found 35 Opana tablets and upon further questioning, Yauger told officers he had sold two Opana tablets in the drug transaction moments earlier.

Yauger was charged with trafficking in a controlled substance, first degree and was later released from the Rockcastle County Detention Center on a \$15,000 surety bond.

some of the inmates.

Miller said jail CIO Nathan Carter found the marijuana in the clothes that were brought into the jail by Payne and Haight.

Miller said jail employees search all clothing and supplies brought in to make sure no drugs get passed into the jail.

“We search all supplies and items for drugs constantly to make sure nothing is getting passed on to the inmates,” Miller said. “It is something we do regularly and on a daily basis.”

Miller said the reason why the jail doesn’t supply inmates with uniforms is because it saves Rockcastle County money.

“We would have to pay to have the uniforms constantly washed and replaced,” Miller said. “We save the county money by just searching the clothes people bring into the jail.”

Both Haight and Payne were charged with promoting contraband, first degree.

Haight remains lodged in the Rockcastle County Detention Center on a \$25,000 cash/property bond while Payne was released Sunday on a \$5,000 surety bond.

Both Haight and Payne were recently indicted by a Rockcastle County Grand Jury for promoting contraband. Also indicted was Shawn Haight for complicity to promote contraband.

The motion is in relation to Clifford’s prior arrest on July 11th after escaping from a meth lab bust on June 28th at a home on Lime Plant Hollow Road in Mt. Vernon.

In his previous arrest, Clifford was charged with two counts of manufacturing meth, resisting arrest, assault on a police officer and escape. Clifford was later released on July 25th from the Rockcastle County Detention Center on a property bond.

Reynolds motion calls for Mattie Kirby, who put up property to secure Clifford’s bond, to have to

forfeit her property.

Reynolds said Clifford was released on bond with the condition that no new arrests or violations would be made. However, Reynolds said when Clifford was arrested on Monday for possession of meth he violated the previous bond’s conditions.

“People who sign property bonds need to be made aware that there are consequences if the person they sign a property bond for reoffends,” Reynolds said.

A hearing to revoke and the forfeiture of Clifford’s original bond has been set for September 5th. Until then, Clifford will remain lodged in the Rockcastle County Detention Center without bond.

## Going to the movies in Rockcastle County

Now that summer vacation is over and school has begun, we look forward to the fall movie releases. This is the season of the big blockbuster movies. Now the latest movies are shot in 3-D digital with surround sound effects. Recently I took my eight year old grandson Jacob to the Richmond Movie Theater; watching this face light up when the

film started suddenly whisked me back to my childhood days. I saw my first movie at The Grand Combs Theater in Mt. Vernon.

I guess some would find it strange that at one time Mt. Vernon, Brodhead, and Livingston all had state of the art, top of the line, movie theaters. They were the Vernon Theater in Mt. Vernon, the Gray Theater in

Brodhead, and the Webb Theater in Livingston. There was also the Valley Drive-In at Renfro Valley.

Before the oncoming event of television, local movie theaters were prevalent in small communities like Rockcastle County. Certainly memories have their place in everyone's psyche and movie theaters were often the places where young couples experienced their first kiss and hold a special place in patrons' hearts.

In the 1940s three first class state of the art theaters were built in Rockcastle County. At that time the railroad was booming in the county and created a need for leisure time enjoyment.

Willetta Kirby Owens remembers as a child, going on Saturdays, catching the train at Pine Hill to Mt. Vernon. The kids prices were .10 cents for admission and they were given an inexpensive toy. The program started with the people standing up with a picture of a waving American flag and the playing of the national anthem. Then they would have a singalong and you had to follow the bouncing ball and sing along with the screen.

After that they would play three cartoons, usually Pop Eye or Mighty Mouse, and a serial. I remember The Iron Claw; the foolish thing nearly scared me to death.

A movie short, usually the Three Stooges and the main features of two movies that had intermission breaks to go to the bathroom and concession stand. Candy bars cost 5 cents and were larger than they are now. Later as a young adult and dating her future husband, Clyde Owens Willetta said that on weekends they would go to all three of the county's theaters.

Movie theaters trace their origins back to ancient Greece where crowds of sometimes 15,000 people gathered to see a play. Theatre was so important to the ancient Greeks that prisoners would be released from jail temporarily so they could attend. The Greeks built huge outdoor amphitheaters and the seating section was called the theatron, which is the origin of our

word "theater."

All three of Rockcastle's theaters were built in the classic Samuel Roxy Rothafel impresario architecture style. They consisted of a single auditorium with rows of comfortable seats on an elevated floor, as well as a foyer area containing a box office and snack counter with stairs going up to the projection room. They had one large screen with a stage and a balcony. The screen and stage were draped with decorative, hand painted, thematic curtains with quaint metal-covered ceilings, art deco furnishings with boldly patterned carpet that was trimmed with small aisle lights.

Before television, Rockcastle citizens listened to radio shows at home and went out to see movies. The

movies arrived by Greyhound bus then. The reels came in leather suitcases that contained the movie cans, usually four per movie, and promotion posters, usually two, and a set of lobby cards tucked in a pouch on the outside of the container.

These theaters, often called picture shows, provided a world of escapism for many Rockcastle countians after a hard week of work. In 1950 the average ticket price was 50 cents for adults and 25 cents for children, the equivalent of around \$4 in today's currency. In 1950, despite the Korean War, Americans were spending 25.7 percent of their recreation budget in movie theaters, by 1960 that had dropped to 5.2 percent.

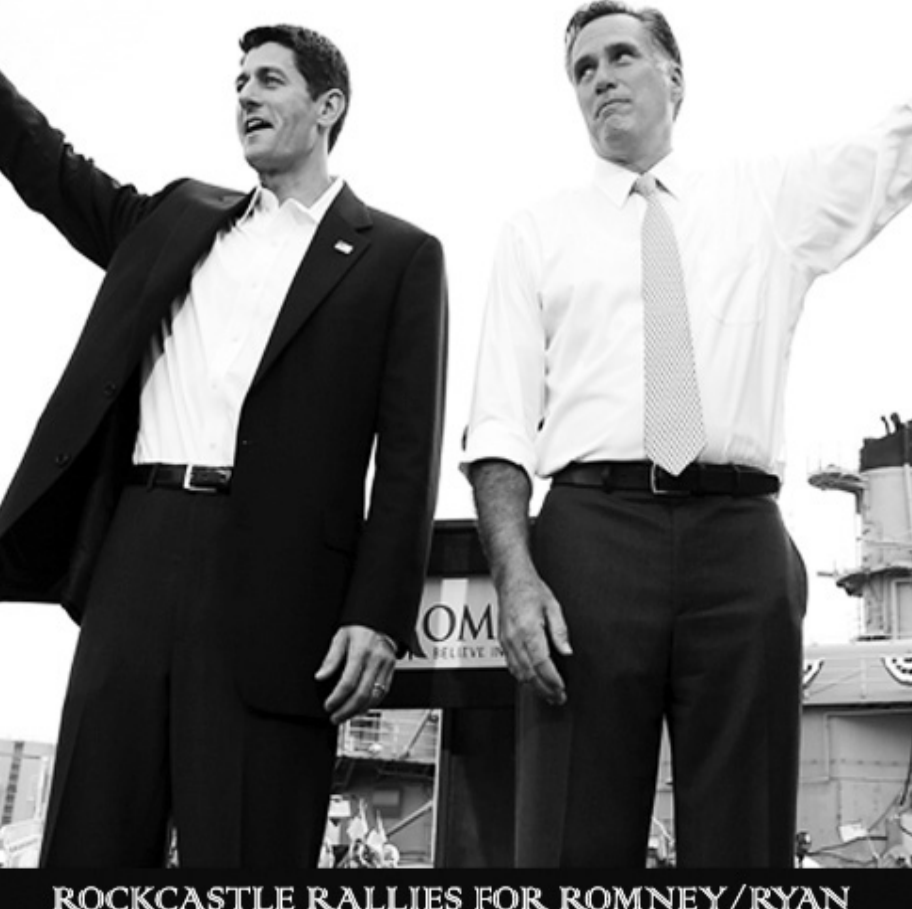

# Hayes educating youth at Kentucky State Fair

Hayes' mobile science activity center is a 42-foot-long trailer where students can learn science and the importance of agriculture through hands-on activities and demonstrations. The state fair display also includes the winning entries from this year's Poster and Essay Contest.

Hayes and his wife and children live and farm in Brodhead. He grew up on a farm, and his family has shown registered Guernsey dairy cattle at the state fair for 25 years.

## CRP Participants May Request Authorization to Conduct Emergency Haying or Grazing of CRP Acres

The USDA Farm Service Agency (FSA) announces the opportunity for Conservation Reserve Program (CRP) participants to request authorization to conduct emergency haying or grazing on specific CRP acres. Eligible producers who are interested in applying for approval to conduct Emergency Haying or Grazing of CRP land located in Kentucky must request and obtain individual written approval from FSA before any haying or grazing starts. Participants will be assessed a 10 percent payment reduction on their annual rental payment for the acres actually hayed or grazed.

Interested CRP participants are required to submit a request to FSA and obtain a modified conservation plan to hay and/or graze under emergency provisions. The same acres may not be hayed and grazed under the same emergency designation. Emergency haying or grazing is not allowed within 120 feet of any stream or water body. Specified portions of each field or contiguous fields must be left or grazed with limited stock for wildlife purposes. Emergency haying or grazing is restricted to specific practices that are 12 months past being determined as fully established by the agency. Participants shall not start any haying or grazing activity until individual written approval is received for the CRP contract request. Approved haying authorization will end not later than August 31st. Approved grazing authorization will end not later than September 30th.

To take advantage of the emergency haying and grazing provisions, approved participants can use the CRP acreage for their own livestock or may grant another livestock producer use of the CRP acreage for the purpose of haying or grazing. For more information and to request approval for emergency haying or grazing of CRP acres, contact the local FSA Service Center that administers the CRP contract.

### Opportunity for Continuous CRP Enrollment of Highly Erodible Cropland

The USDA Farm Service Agency (FSA) announced that continuous sign-up for the Highly Erodible Land (HEL) Initiative under the Conservation Reserve Program (CRP) started on July 23, 2012. Kentucky received a total allocation of 39,400 acres to enroll in the HELI CRP program. Offers will be accepted until either the state acreage allocation limit is reached or September 30, 2012 whichever occurs first.

This initiative will accept offers with an erosion rate of at least 20 tons per acre per year for new cropland or CRP acres that expire on September 30, 2012; however, existing grass stands that are not considered expiring CRP will not be considered eligible for enrollment. Eligible cropland must also have a history of being cropped 4 out of 6 years, 2002 through 2007. Eligible CRP contracts set to expire on September 30, 2012, may be offered for consideration and approved contracts will become effective October 1, 2012. The contract duration is also 10 years.

## "Movies"

When black and white television became available to win audiences the movie industry promoted color, better sound and bigger screens to enhance the emotional power of the theater experience, even to the point of inventing new formats like Cinerama, cinemascope, the wide screen spectaculars like the *Ten Commandments*, *Ben Hur*, *The Robe*, that were all top money making films of the 1950s.

The western movies were very popular with Rockcastle audiences. For many audience members the western echoed themes of good vs evil in the struggle between capitalism and communism during the Cold War. Movies like, *How the West was Won*, *The Magnificent Seven*, *The Wild Bunch*, and *The Man who shot Liberty Valence* were just a few that became classics.

The 1950s was a time of great affluence after the depression years and the world wars, consumerism took off in a big way which in turn created jobs and wealth and a circle of growth. This led to not only movies being shown at the theaters but troops of vaudeville artists traveled from town to town to perform live on the stages situated in front of the screens.

While we can no longer go to the movies in Rockcastle County, technology has provided for a rebirth of old movies. Many older citizens prefer the old movies. What is it that makes some prefer them? Is it that old movies were from a time of innocence? That is, actors spoke without using foul language. Also they contained none of today's gratuitous gore, obligatory chase scenes and special effects that blow up whole city blocks. Or did those old movies actually contain better acting? Did the absence of special effects and technology necessitate actors to be better at their job. Most all the old movie stars could sing and dance, master comical timing as well as act. Or is it about nostalgia? Do old

timers enjoy seeing city streets filled with Fords, Chevys, and Dodges instead of foreign vehicles? Or that a secretary instead of using a laptop is composing a letter on a typewriter that makes a "click, click, click" sound or actors' dressed distinguished instead of having their bodies covered in tattoos and their underpants hanging half way down their butt?

### Vernon Theater also called The Town Theater

The Vernon Theater was opened in 1927 by Floyd and Daisy Fish Miller and in 1970 was rented to Bert Combs as the Grand Combs Theater. It closed in 1972. It was not the first theater in town. The Boone Way Opera House run by George Owens was the first. The Vernon Theater was located where Joe Clontz has his office now. The Opera House was located where Lindia's Variety Store currently sits.

### Gray Theater

Opened August 6th, 1940 by Brodhead Pharmacy's Dan Gray and Elnora Frith Gray in downtown Brodhead. Later sold to a chain operation. Mrs Gray rode a train to Cincinnati to book movies. There were two shows each day, one at seven and one at nine.

Mr. Gray ran the theater until 1950 when he leased to a Mr. Hughes. The first ushers were Marian Owens and Elizabeth Delaney. Jean Roberts operated the snack stand.

### Webb Theater

The Webb Theater was opened in 1941 by Dr. R.G. Webb in downtown Livingston. Bobby Wilson, who still resides in Livingston, was the projectionist there at one time. Prior to the Webb Theater opening Dr. Webb showed movies in the school gym. The first theater in Livingston was the Livingston Opera House operated by Emmett Quinn, and was located on the lower end of town across from the Eight Gables Hotel. That was during the Silent Movie era.

### Valley Drive-In

The Valley Drive-In was owned by Bill and Arletta Norton. It was located in Renfro Valley where the current Derby City Truck Stop stands.
