## Senator McConnell discusses Obamacare at Town Hall Meeting

Senate Minority Leader Mitch McConnell was the guest speaker at a town meeting held at Rockcastle Regional Hospital Tuesday.

Several Rockcastle County officials, citizens and hospital employees attended the meeting to hear the senator's update on healthcare reform.

McConnell visited Rockcastle Regional Hospital as part of his tour of hospitals in the state where he holds town hall meetings to discuss healthcare reform with hospital employees.

During the meeting, McConnell said he believed Obamacare was not the answer for healthcare reform and that the democratic plan would not fix the overall healthcare problem in our country.

Although, McConnell said he did agree with the basic motivation of Obamacare which is making health insurance available to more people.

"Democrat or republican, I think we can all agree that everyone being insured would be a great idea."

However, McConnell said that the idea of insuring more people proved to be more complicated than it first appeared. He said the government would have to come up with money to provide insurance for Americans who can't afford it.

McConnell said to provide for the funding shortfall of providing insurance, Obamacare requires \$716 billion in cuts to medicare providers including hospitals, nursing homes, etc.

"Instead of taking the \$716 billion out of healthcare providers I would have left that alone," McConnell said.

McConnell instead proposed adjusting the eligibility for entitlement programs to fit the demographics of our country. He said the demographics have changed since the 1930s when Social Security was enacted and with the upcoming baby boom generation, the eligibility age needs to be raised.

"Until you adjust the demographics of this country to match the eligibility re-

## Local police bust meth supply ring

Local police say they have busted a significant methamphetamine supply ring that was operating throughout Rockcastle County over recent months.

Stacey Dwayne Durham, 48, of Paint Lick and Tracey Susan Bullock, 43, of Brodhead are believed to be the leaders in the suspected meth ring.

According to Mt. Vernon Police reports, Assistant Chief Barry Adams learned through investigation in July that Durham was receiving packages in the mail from California that contained methamphetamine. He said Durham would get various people to use their own mailing address to receive the packages so he could insulate himself from being caught by law enforcement.

Adams said he knows Durham's source in California is a white male who was also recently arrested on

meth charges and has posted a \$50,000 cash bond.

Adams said that Bullock was Durham's girlfriend and that she was sending money to California via

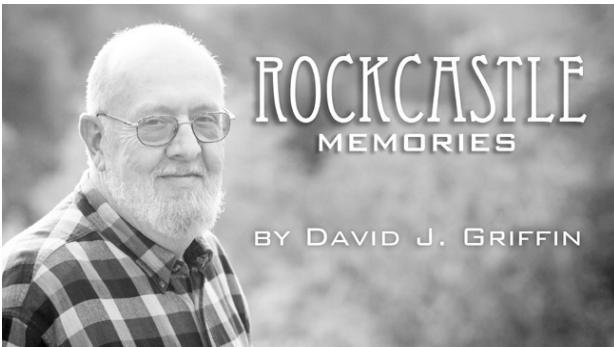

## ROCKCASTLE MEMORIES

### Remembering the "Good Old Days"

I dropped my wife off at work and decided afterwards to stop at a local farmer's market location in order to visit with some friends. After a few minutes, Phillip Wells joined Gary Bowen and me as we discussed how great it was to have been boys in a small town growing up in the 50's. It was so refreshing for me to be on the listening side of things and to hear the gentlemen talk about how they were raised on farms in the county. Over and over, we each expressed how we wish we could go back to those times when we were young and innocent.

Phillip spoke of how his grandfather grew or raised almost everything they needed to get through the winter. We talked about the variety of vegetables that were produced on our individual farms, and how our grandparents canned or preserved the items that we would need in the coming winter months.

The discussion reminded me of a conversation that my wife and I once had years ago. She was listening to me tell some of our friends about the food that my grandmother brought to the table when I lived on our small farm in Rockcastle County. She heard me explain that we served country ham, half-runner beans, sliced tomatoes, corn on the cob, cucumbers, radishes, onions – and especially, a "pone" of cornbread from an old iron skillet, which had baked in the wood-burning stove in the kitchen. Finally, Kathy remarked, "You always tell that your family was poor when you were a child; it can't possibly be true. Fried chicken for

breakfast? I never saw any poor people who had those kinds of meals on the table!" My reply was that what I meant was that we did not have a lot of money. That was true, but we were blessed to have a farm that allowed us to produce almost everything we needed. Our wealth was in our land – and in our ability to labor to provide ourselves with practically all of our needs.

Gary was regretful that those days are "gone forever!" Phillip and I agreed. Almost everything about our lives has changed in ways that will prevent us from ever returning to those times that were so satisfying when we were youngsters.

We also discussed hunting game when we were just boys. Immediately, we each piped up, almost in unison, "But we never killed anything that we were not going to eat." That, of course, took me back to a moment in time that I had with my grandfather when I was only ten years old. He had just purchased my first shotgun, which was a Stevens' single-shot 20-gauge firearm. The first time we ventured into the woods, Pop began teaching: "David Joe, I want you to remember one important thing about hunting. You never shoot anything that you are not going to eat." I never forgot the lessons that he taught me that day.

I also lamented the fact that my grandchildren will never know the satisfaction they could experience by hunting small game in the woods of Kentucky. It saddens me that this is the case. Some of my most wonderful experiences involve being with Pop in the woods with our shotguns, stalking small game in order for my

## The Roots of Rockcastle

### The Life and Times of Dr. Robert Gladstone Webb in Livingston, Part II

Last week, we looked at the personal life of Dr. Webb and his influence in the area of southern Rockcastle. In the following weeks, the Roots series will explore the daily logs of Dr. Webb. They will not be in any certain order. We will begin with his log of 1951.

Evidently, Dr. Webb was open for business even on holidays. He had entries for Christmas, New Years Day, and Thanksgiving. The first entry is on Monday, January 1, 1951; Jasper Poynter visited the office to get some medicine for his daughter, and paid in full the amount of \$2.00. A little later in the week, between the 4th and 5th days of the month's recordings, there were two pressed four leaf clovers. On the 8th of January, a "passenger man" (possibly a traveler on the railroad) who had fallen ill visited the office and paid \$5.00 for services. The total cash received for January was \$446.75, total expenses were \$157.17, leaving a profit of \$289.57.

In February, some of the patients he saw were Tom Renner, Lewis Mink, (the only patient he saw on the 4th was Asa Mink, who paid \$1.00) Ed Smith, Ott Mink, Jean Smith, Ben Ponder, the school athletic department (which paid \$25.00), Burt Mullins, Sherman Ponder, Herman Mize, Henry Griffin, and Green Howard.

As I paged through this log, I've noticed that some of the names are quite re-

petitive. I suppose they or their family suffered with extensive illnesses. I've also noticed that the family names written in 1951 are still common to the area today.

March 15th, he was called to the school to treat a boy's injured arm, and charged \$2.00. On the 27th, he was called back to the school to treat an injured chin and charged \$1.00. There must have been a round of the flu at the Pike house. Mr. Clell Pike and wife were to the doctor's office almost every day of the week at the close of March.

In March, Dr. Webb owed the Columbus Pharmaceutical Company the sums of \$42.56 and \$16.80, and Kentucky Utilities \$12.63. His auto upkeep was listed as \$2.00. The pool room rent was \$15.00 and neon repair at the theater was \$11.50.

Dr. Webb cared for the employees of the L&N Railroad and Kentucky Stone Company. These businesses paid \$3.00 for each of their employees who saw the doctor.

There was a page for narcotics dispensed. The first narcotic entry of the year was to a Mrs. Overbey for gallbladder problems, who received morphine. This was in April.

Dr. Webb made house calls as well as office visits. His car expense for the month of May was \$36.26, and his electric bill for the

grandmother to prepare for our dinner meal.

Mommie Katie could cook a squirrel better than anyone I ever knew. I am not sure how she accomplished this feat, but I do remember that she boiled the whole squirrel until it was tender, then she removed them from the water and completed the process by frying them in an old iron skillet. That was a feast for sure.

Gary also reminded us about how safe we felt in those days and times. He said, “When we went to bed at night, we simply hooked the screen door and went to sleep confident that all was well with the world.” That was exactly how I felt as a boy. I can remember my bedroom having wooden-framed screens placed in my two windows, allowing the cool night air to breeze lightly across my bed. And our front door, too, was secured only by that proverbial screen door hook. Not one time do I recall fearing that someone would break into our house. Heck, the screens were only there to keep the insects and the animals out!

In light of our fond memories of growing up, the three of us expressed concern about the future of society in America. Neither one of us could remember a time when the future seemed so bleak. Phillip commented

on the television news presentations that are broadcast every night. “We never hear about anything positive on the world’s front any more. There seems to be only trouble wherever we look, and it is getting worse all the time.” Gary and I nodded in agreement.

I suppose the last topic we hit upon is the price of trucks and automobiles in the United States today. I reminded them of my first new car, which was a 1963 Chevrolet Impala Super Sport. office was \$6.89. In June, there was an auto accident and a man was injured and charged \$3.00. Another man from Knoxville, Robert Porter, was sent to the hospital and charged \$15.00. July brought a profit of \$50.00 from the rent on Livingston Motors.

On Saturday, August 11, was Mrs. Pace’s last day, as she went to work at the T. B. Hospital. (She evidently was his nurse/secretary, and the T.B. Hospital was in London, Kentucky). On Sunday the 19th, he saw three patients and had a birthday celebration.

On September 11, he saw two patients and went to London for the afternoon, and on the 12th went to Louisville for the day. On the 13th, Dr. Webb treated a lady, Annlia Barnes, from Chicago for an auto accident. She had a broken leg, and was charged \$5.00.

On Sunday, October 7, Dr. Webb traveled to Nicholasville for the day. On Monday, November 5, he went to Stanford. The Courier (Courier-Journal, I presume) bill was due; it was \$2.00. On Thanksgiving, he saw one patient, Jimmy Lambert, and then went to Lexington to have dinner with a Dr. Preston. On Christmas, he saw two patients and admitted one to the hospital.

As you can see, Dr. Webb stayed quite busy in 1951 with office visits and house calls. This is intended to shine a light on the daily life of a country doctor and his connections to the daily life in the little town of Livingston.

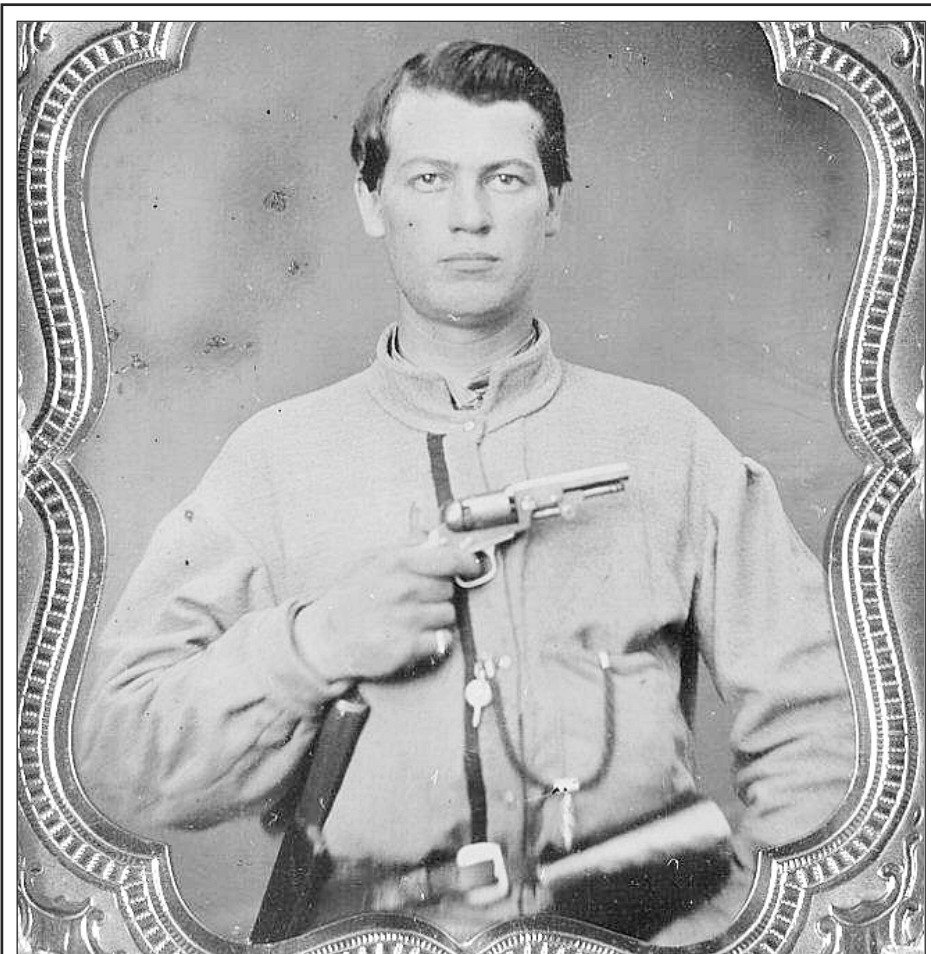

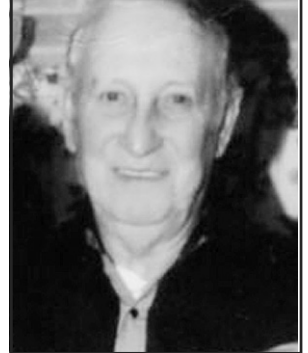

## Bible Talk

Today we would like to discuss some of the things the Bible has to say about worship. This is a very important theme for us to consider as we open the word of God. Let's notice that there are 4 different kinds of worship described in the New Testament.

**Will Worship** - In Colossians 2:23, "Which things have indeed a show of wisdom in will worship, and humility, and neglecting of the body; not in any honour to the satisfying of the flesh." This would certainly not be the kind of worship that God would desire from us, worship that emanates from human wisdom and will.

**Ignorant Worship** - Observe in Acts 17:23, "For as I passed by, and beheld your devotions, I found an altar with this inscription, TO THE UNKNOWN GOD. Whom therefore ye ignorantly worship, him declare I unto you." Now God would not request that we worship him ignorantly, as did those philosophers in the city of Athens.

**Vain Worship** - Consider Matthew 15:9, "But in vain they do worship me, teaching for doctrines the commandments of men." The word "vain" means "useless, empty, void, without value." Thus the Lord is saying, that there are men who worship God, but it is in vain. God does not want this type of worship either. Sadly our religious world today is filled with this type of worship.

**True Worship** - Now let's look in John 4:23-24, "But the hour cometh, and now is, when the true worshippers shall worship the Father in spirit and in truth: for the Father seeketh such to worship him. God is a Spirit: and they that worship him must worship him in spirit and in truth." Yes indeed, this is the kind of worship that God desires! God is seeking people to worship him in spirit and in truth. Now notice the 2 things necessary to be a true worshiper, our worship must be in spirit and in truth. To be in spirit, is to worship with the right attitude, disposition, frame of mind, or feelings. The Bible describes the kind of spirit or attitude we must have in the various acts of worship. Secondly, we must worship in truth, that is, according to the word of truth. "Sanctify them through thy truth: thy word is truth," (John 17:17). What we do in worship must be as the Bible teaches. We can do the right things in worship, but not have a right attitude this is unacceptable. We can have the right attitudes in worship, but do the wrong things, this also is unacceptable. Both the right attitude, and the right things must be done to be a true worshiper. If I want to please God the Father, I "must worship him in spirit and in truth." Now notice that word "must" found in our text. This word "must" means "need be, ought, should be compelled, have to, a moral obligation." It is not something optional. That same word "must" is found in John 3:7, "Marvel not that I said unto thee, Ye must be born again." If we are going to be forgiven, we must be born again. In the very same way, we must worship God in the way he has instructed and we must do it with the right attitude.

assault on a police officer and escape.

Clifford was later released on July 25th from the Rockcastle County Detention Center on a \$40,000 property bond signed by Kirby.

Reynolds' motion called for the \$40,000 property bond to be forfeited after Clifford was again arrested August 20th for possession of meth a violation of the bond's condition.

However, on Monday Reynolds agreed to withdraw his forfeiture motion in exchange for a cash payment to the court of \$1,000 by Kirby.

"I just wanted to send a message that you are responsible for any bond you sign -- secured, unsecured, property, etc." Reynolds said.

Durham manufactures methamphetamine twice a week from various motels around Danville and surrounding towns.

Last Thursday, Deputy Sheriff Matt Bryant received an anonymous tip that Durham, Bullock, and Freddie D. Denney, 42, of Mt. Vernon were manufacturing meth in a rental cabin on Lower River Road in Livingston.

The three were arrested at the scene.

Upon receiving consent from Bullock to search the cabin, officers found a Mason jar inside the freezer containing a clear pink liquid which was identified by Durham as a "pull" from a meth lab.

Inside a kitchen cabinet, officers found a large glass bowl containing an off-white powder which was later identified as methamphetamine. Officers found another small glass bowl inside the cabinet containing meth as well.

Inside the master bedroom, Officers found a small zip-lock bag containing suspected methamphetamine lying on a night stand.

Other various items used to manufacture meth were located throughout the cabin, including ephedrine, iodine crystals, lighter fluid, camping fuel, lithium batteries and hydrochloric acid.

All three were charged with manufacturing methamphetamine. Durham was also separately charged with possession of a controlled substance, first degree.

All three remain lodged in the Rockcastle County Detention Center. Bullock's and Denney's bonds were set at \$50,000 cash/property

while Durham's was set at \$75,000 cash/property.

Bryant said he believes a lot of recent arrests he made for meth possession in June, July and August came from Durham selling them the meth. He said this is the largest meth supply ring they have busted in Rockcastle County since he has been working for the sheriff's department.

"I have been doing this a long time and I can't recall us busting a meth supply ring of this magnitude," Bryant said. "With Durham behind bars, our county will definitely be safer and more drug free."

All three were arraigned Wednesday morning where their bond was left the same. A preliminary hearing was scheduled for next Wednesday at 9:30 a.m.

## Two more arrested for manufacturing meth

Two more people were arrested Monday morning for manufacturing methamphetamine after police raided a home on North Wilderness Road in Conway.

Arrested at the scene were Anthony James Mayes, 27 and Whitney Lee Lewis, 26, both of Hillsboro, Kentucky.

According to Kentucky State Police reports, Trooper Scottie Pennington had received several complaints that Mayes and Lewis were "cooking meth" at the residence.

After arriving at the residence, officers could smell a strong chemical odor coming from inside the home.

Upon receiving consent from Lewis to search the residence, officers found a one-step meth lab in the bathroom along with a smoked marijuana cigarette.

Officers also found several other items used to manufacture meth, including rock salt, drain cleaner, lithium batteries, Coleman fuel, coffee filters and a burned piece of aluminum foil.

Officers also found a four-year-old girl living inside the residence with Mayes and Lewis.

Mayes and Lewis were charged with manufacturing methamphetamine, drug paraphernalia, tampering with physical evidence, possession of marijuana, controlled substance endangerment to a child and wanton endangerment, first degree.

Both Mayes and Lewis remain lodged in the Rockcastle County Detention Center without bond.

## Three arrested for trafficking

Three people were arrested last Wednesday for drug trafficking after officers from the Kentucky State Police made a traffic stop on I-75 at the 73 mile marker in Rockcastle County.

Arrested at the scene was Kweita Mosi Anderson, 38, of Springfield, Ohio, Myron Eugene Colvin, 37 and James Coran Jr., 38, both of Reynoldsburg, Ohio.

According to state police reports, officers pulled over Anderson's 2012 Mazda car after observing the vehicle swerve back and forth, almost hitting a tractor trailer.

During the traffic stop, officers developed a reasonable suspicion of unlawful activity after Anderson and both passengers gave different statements about why they were travelling from Ohio to Georgia.

After receiving consent from Anderson to search the vehicle, officers found a purple Crown Royal bag under the hood which contained eight ounces of cocaine and two ounces of crack cocaine.

Officers also found two small bags of marijuana inside Anderson's purse at the time of her arrest.

All three were charged with possession of marijuana and two counts trafficking in controlled substance, first degree.

Both Colvin and Coran Jr. remain lodged in the Rockcastle County Detention Center on a \$15,000 cash/property bond while Anderson was later released on a \$15,000 surety bond.

### David M. Smith Livingston's Hometown Hero By: David W. Owens

Nestled in a small valley in southeastern Rockcastle County lies the sleepy hamlet of Livingston where Roundstone Creek empties into the winding river that gives the county its name. During pioneer days, it was first known as Fish Point where the Wilderness Road

forded the river and continued onto Mt. Vernon. Later, with the coming of the railroad, the community grew into a thriving town and was named Livingston after James Livingston, the local hotel keeper and telegraph operator.

In post WWII days, the town was at its zenith. The small town developed several businesses and boasted a roller rink and theater. The Livingston High School Blue Devils had a reputation for pretty girls and outstanding basketball teams. One of the students there was a quiet, shy boy named David Monroe Smith. Smith, considered a swell guy that never caused trouble by the boys and handsome by the girls, was the typical hometown American boy. He was born November 10, 1926 in Livingston to David and Lou Moore Smith and had two sisters, Nellie and Mable and three brothers, Eugene, James and George.

Smith was drafted into the United States Army during the Korean War and became a soldier in Echo Company, 9th Infantry Regiment, 2nd Infantry Division. After basic training, he was shipped to Korea. He was a good soldier and became a gunner in a mortar section and was quickly promoted to Private First Class but he was on a journey that would never allow him to return to his beloved Livingston.

Engaged in heavy action on September 1, 1950, while facing a numerically superior foe near the village of Yongsan, his element's position was being overrun. The bitter fighting soon rendered his section's position untenable and their perimeter was infiltrated. They were ordered to withdraw, but it was too late. The enemy had flanked their position and encircled them. Soon a grenade was lobbed into their foxhole. Then, doing what makes American soldiers the greatest fighting force on earth, he chose to protect his fellow soldiers. First

shouting the alarm, "Grenade!" he flung himself onto the grenade and smothered the explosion with his body. Although mortally wounded in this display of valor, his intrepid act allowed the section to survive the blast and, while the enemy was under cover, to retreat to the main body of the regiment and withdraw safely.

Upon returning to base, Pfc Smith's commander submitted a recommendation for him to receive the Medal of Honor. President Harry S. Truman later authorized the recommendation on August 21, 1952 by General Order.

Pfc David Monroe Smith's body was returned home where he now rests on a knoll overlooking his beloved Livingston -- his grave adorned with a military stone denoting a Medal of Honor winner sleeps there. Later Clayton Ponder, and other veterans remembering their hometown hero, placed a historical marker honoring Smith in Livingston. Still later, his native county named the 461 bypass off the Mt. Vernon and Renfro Valley I-75 exit in his honor.

So, in these present days of war as our troops continue to defend the cause of freedom, let's not forget those who gave their lives for freedom -- to those who gave it all!

quirements, we can never solve the problem," McConnell said.

McConnell said instead of starting new programs like Obamacare that our government can't afford, the age for eligibility for entitlement programs such as Social Security, Medicare and Medicaid needs to be adjusted.

"Instead of starting new programs we can't afford and trying to pay for them out of something that is going busted, I would raise the eligibility for these entitlement programs."

McConnell said this would keep the U.S. from becoming similar to western European countries where the benefits are so enormous but there is not many people left to pay them.

"You have people pulling the wagon and people riding in the wagon. If you put too many people in the wagon it won't be long before the wagon can't move anymore," McConnell said. "This is the dilemma we have, how much can we afford to do."

McConnell said Obamacare was passed on a 100% partisan basis unlike the Social Security act in the 1930's which was enacted on a bi-partisan basis. He said if we want to solve the real healthcare problem, then we must follow those same bi-partisan steps.

"We have to act like grownups if we want our kids and grandkids to have the kind of country we had growing up," McConnell said "As parents and grandparents, that's what we would want to leave behind."

Toward the end of the meeting, McConnell reaffirmed that he would not have taken \$716 billion out of healthcare reimbursement to providers and said the providers are the real reason why our country has the best healthcare in the world.

"We have the best healthcare system in the world right now and I would hate to see us making it worse," McConnell said.



# Rockets shutout by Whitley County for second loss of season

The Rockcastle County Rockets dropped to one and two on the season, following a 28-0 loss at Whitley County last Friday night.

The amount of yards on offense and the inability to get the ball into the end zone would prove to be the deciding factor in the Rocket's loss as they were shut out by Whitley County and only gained 129 total yards with 57 rushing yards and 72 passing yards.

Head Coach Scott Parkey said last Friday

night's loss was the worst offensive performance the team has had all year.

"Yardage wise, it was the worst overall performance on offense we have had in a while," Parkey said.

Parkey said although they couldn't get their running game going, he was still pleased at the progress of their play action passing game.

"Our play action passing was good but it seemed like we couldn't break free to get the big yards after the catch," Parkey said.

Unlike the Rockets, Whitley County had a great night offensively as they gained a total of 355 yards on the night with 279 yards on the ground and 76 yards through the air.

Parkey said his staff had a good defensive plan going into the game and that he thought the players did a good job executing the plan. However, Parkey said the broken and missed tackles on defense allowed Whitley County to break lose for a lot of yards.

"They were able to break

a couple of tackles and get lose a couple of times," Parkey said. "This is going to happen with any good option offense."

Offensively, the Rockets were led by Junior quarterback Corey McPhetridge who was 10 of 19 for 72 yards with one interception.

McDaniel led the ground attack for the Rockets rushing for 58 yards. Running backs Tommy Shaffer and Austin Spoonamore both tallied rushes for 3 yards each.

Wide Receiver Eli Haddix had the best night of the receiving corps grabbing three passes for 24 yards. Shaffer also caught three passes for 17 yards. Boone Saylor caught one pass for 13 yards, Tyler Smith caught one pass for 10 yards, Tyler Harper caught one pass for 6 yards and McDaniel caught one pass for 2 yards.

On the defensive side of the football, lineman Jared Lake led the way for the Rockets with one fumble recovery and seven tackles as well as an assisted sack.

Defensive back Tyler Smith also had a big night defensively with two tackles and one interception.

Other Rockets picking up tackles were Chance Ansardi with seven, McDaniel and Saylor with five, Jacob Bussell with four, McPhetridge, Shaffer, Chris Wren and Brandon Jones were all credited with two tackles.

Saylor led the Rockets in sacks with one. Wren also had an assisted sack as well.

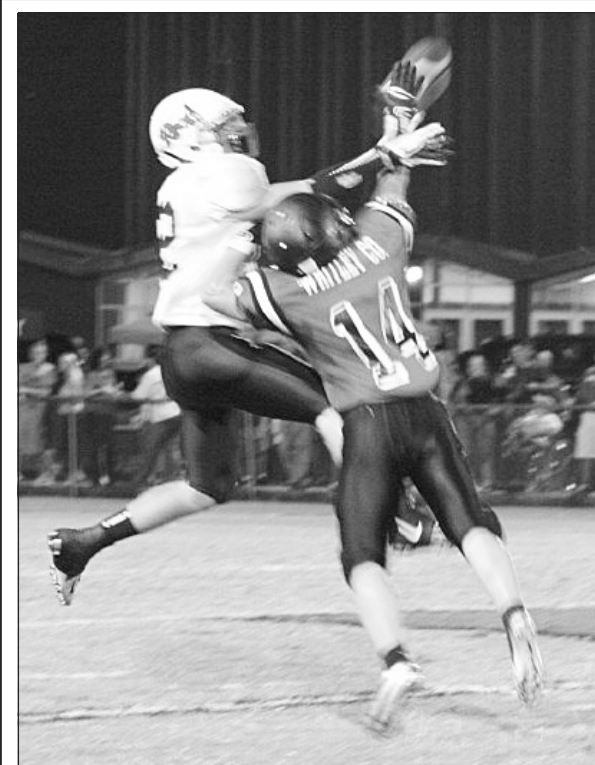
Parkey said the team has now moved on from the Whitley County loss and is focusing on Friday night's game against Estill County.

The Rockets will play against the Estill County Engineers at home this Friday night at 7:30 p.m.



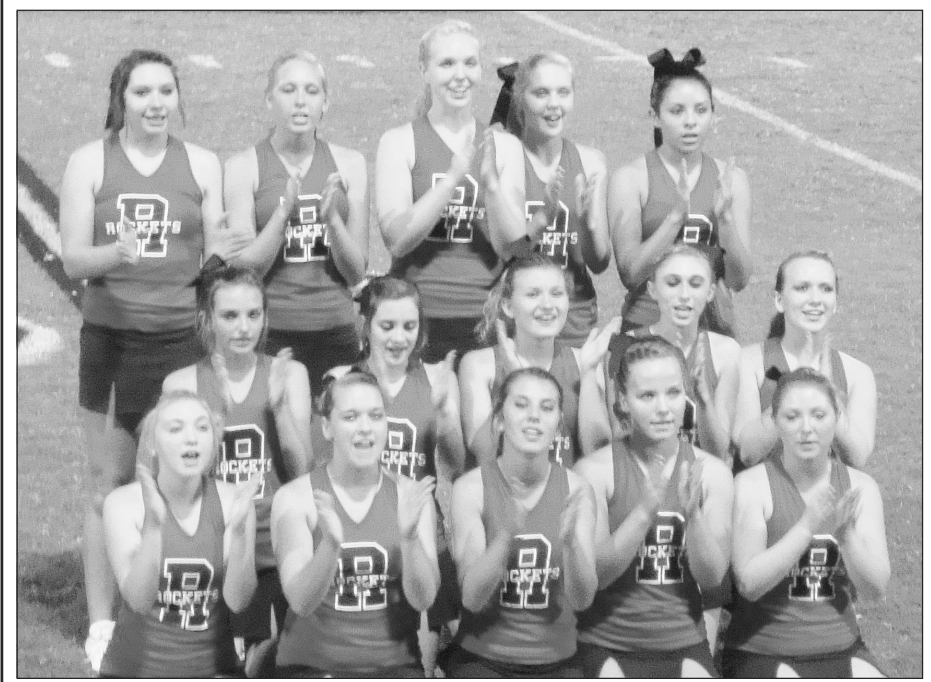
Rocket sophomore punter Layne Jasper gets a punt away against Whitley County. The Rockets punted the ball six times during the game.



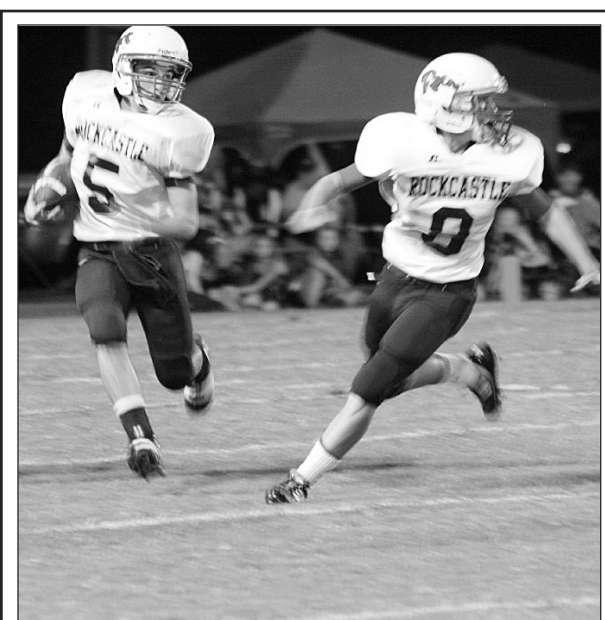

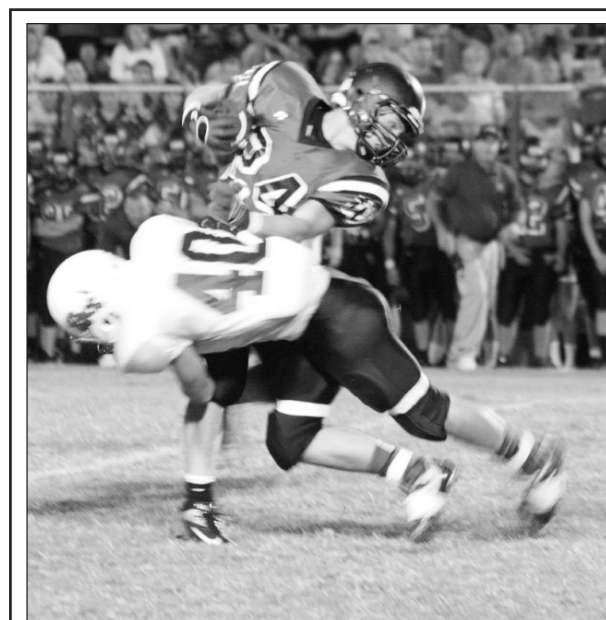

## 8th grade students Gear Up for College

Rockcastle County 8th grade students joined 5,000 of their peers from across south-eastern Kentucky on Wednesday to officially kick off the Berea College GEAR UP CFES Scholar's program. The two-hour kick off included greetings from Lyle Roelofs, Berea College President, and Hasan Davis, Commissioner of Juvenile Justice, as well as musical performances by Breathitt County native and Nashville recording artist Chad Warrix and Perry County 8th grader and GEAR UP student Kennedy

Bailey. Warrix was the first in his family to attend college and he told students "college prepares you. High school is not enough anymore, guys. It used to be, but things are changing rapidly and you have to be prepared...so you can have a chance of getting a great job." Warrix volunteers his time to visit schools in Kentucky as part of the Kentucky Music Hall of Fame Stars Over Appalachia program, working to encourage students to stay in school and go to college. After the

event, Kennedy Bailey shared her thoughts on why the event is important. "GEAR UP is about getting you ready to get up and do your best in whatever you do," she said, "whether it's performing or applying to college or just being in middle school."

Hasan Davis, Commissioner for the Kentucky Department of Juvenile Justice, reminded the students that they are Berea College CFES Scholars and they are expected to graduate high school and attend college. He closed the event by leading the students in chanting, "I commit not to quit!" Davis shared with students that Berea College will bring them back together in the Spring of 2017 to celebrate their high school graduation and college going.

GEAR UP is a U.S. Department of Education college readiness program and the Berea College program works in seventeen Kentucky counties. The goal of the Berea College GEAR UP program is to increase high school graduation and college-going rates in these counties. Dreama Gentry, of Berea College, explains "Without interventions like our GEAR UP CFES Scholars program, more than 1,000 of these 5,000 8th graders will drop out of highschool, and less than 2,200 of these students will go on to college. It is critical to the economic success of our region that we increase the number of students who graduate from high school and attend college."

The event was a partnership between Berea College, the Kentucky Music Hall of Fame and College for Every Student (CFES). The Kentucky Music Hall of Fame sponsors the Stars Over Appalachia program, which connects artists like Warrix to educational programs across Kentucky. CFES is a nonprofit organization with a national network of middle and high school Scholars that commit to academic success, high school graduation and college going.
